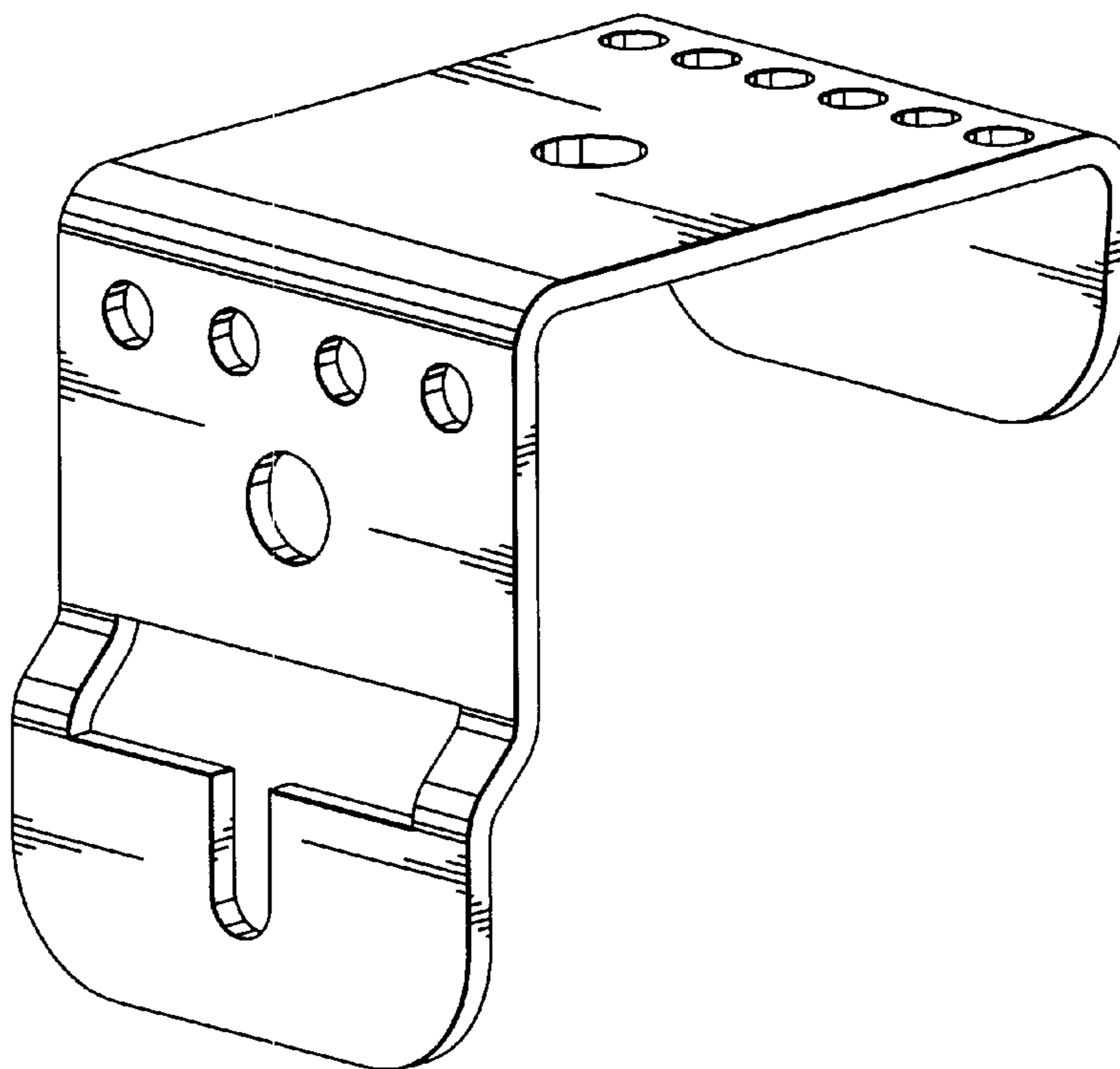

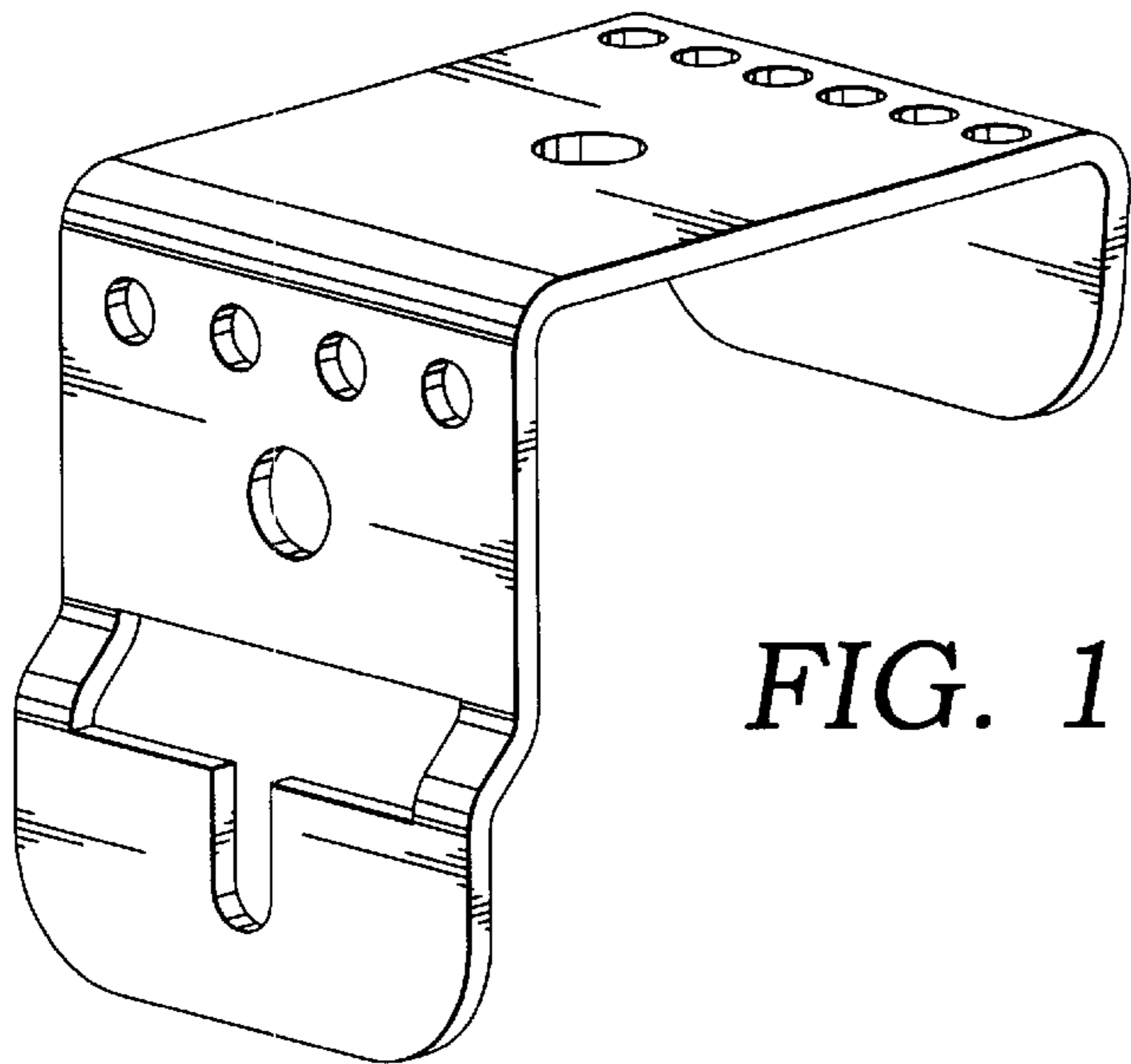
The ornamental design for a hanger bracket for hanging shoe racks, as shown and described.

**DESCRIPTION**

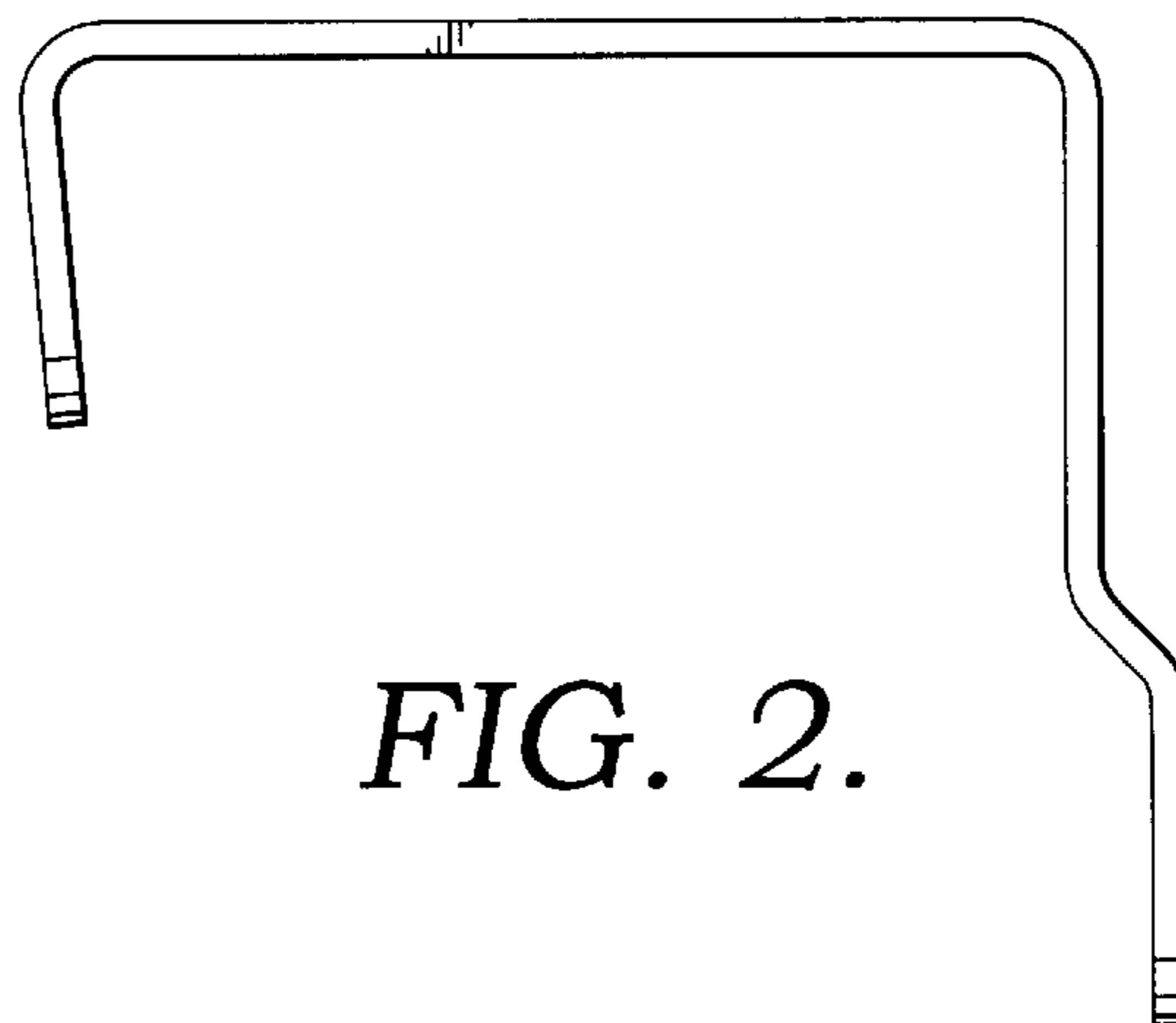

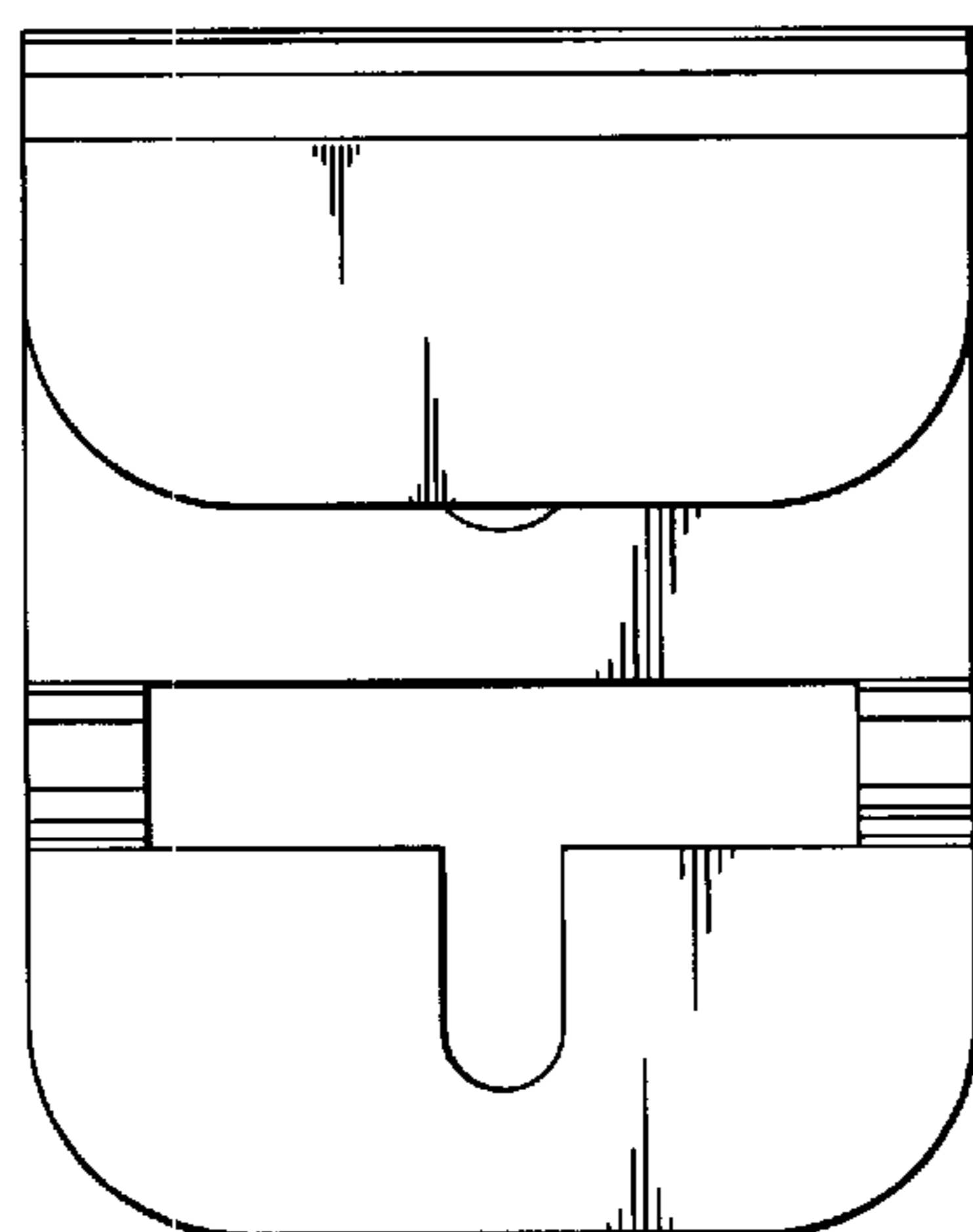

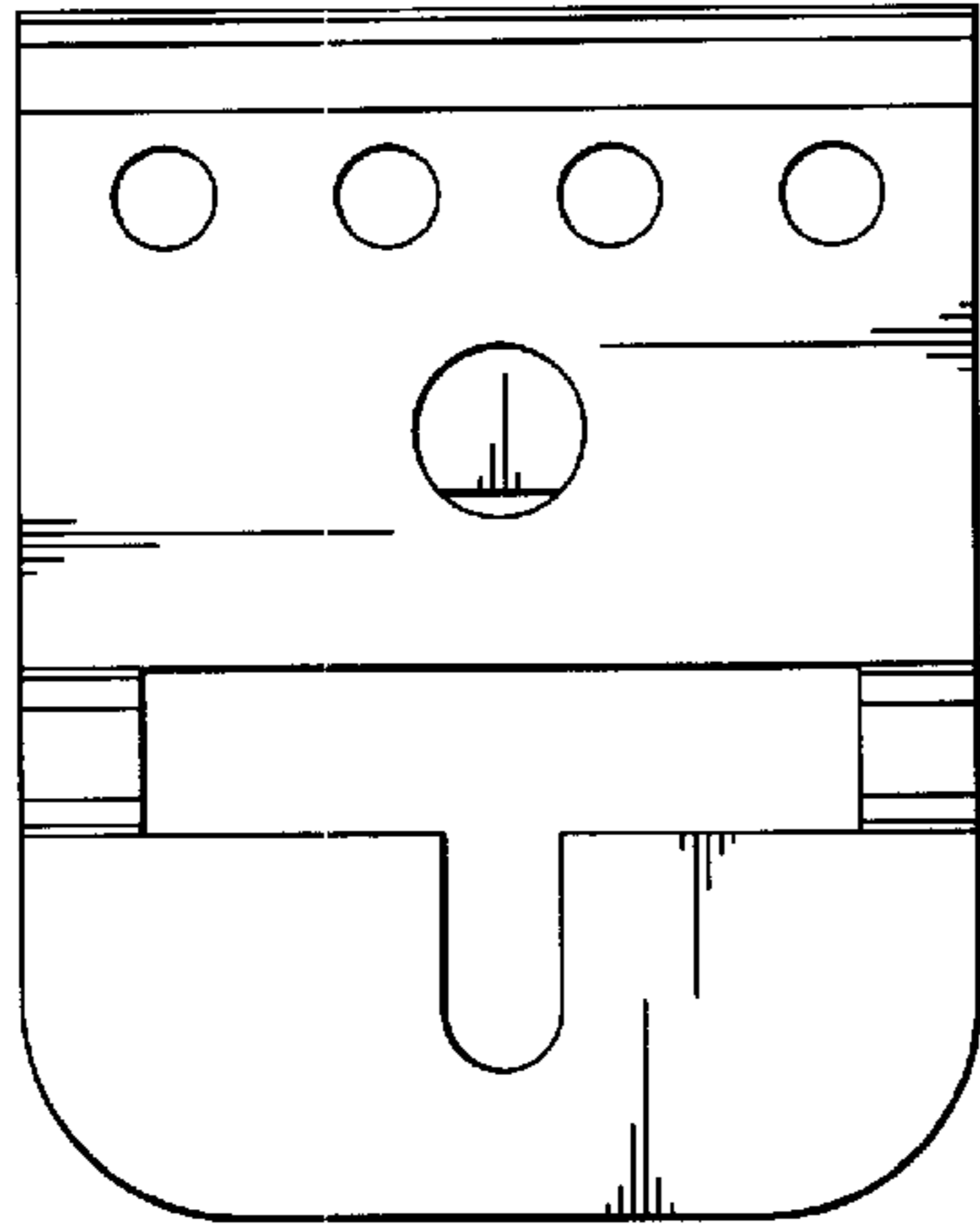

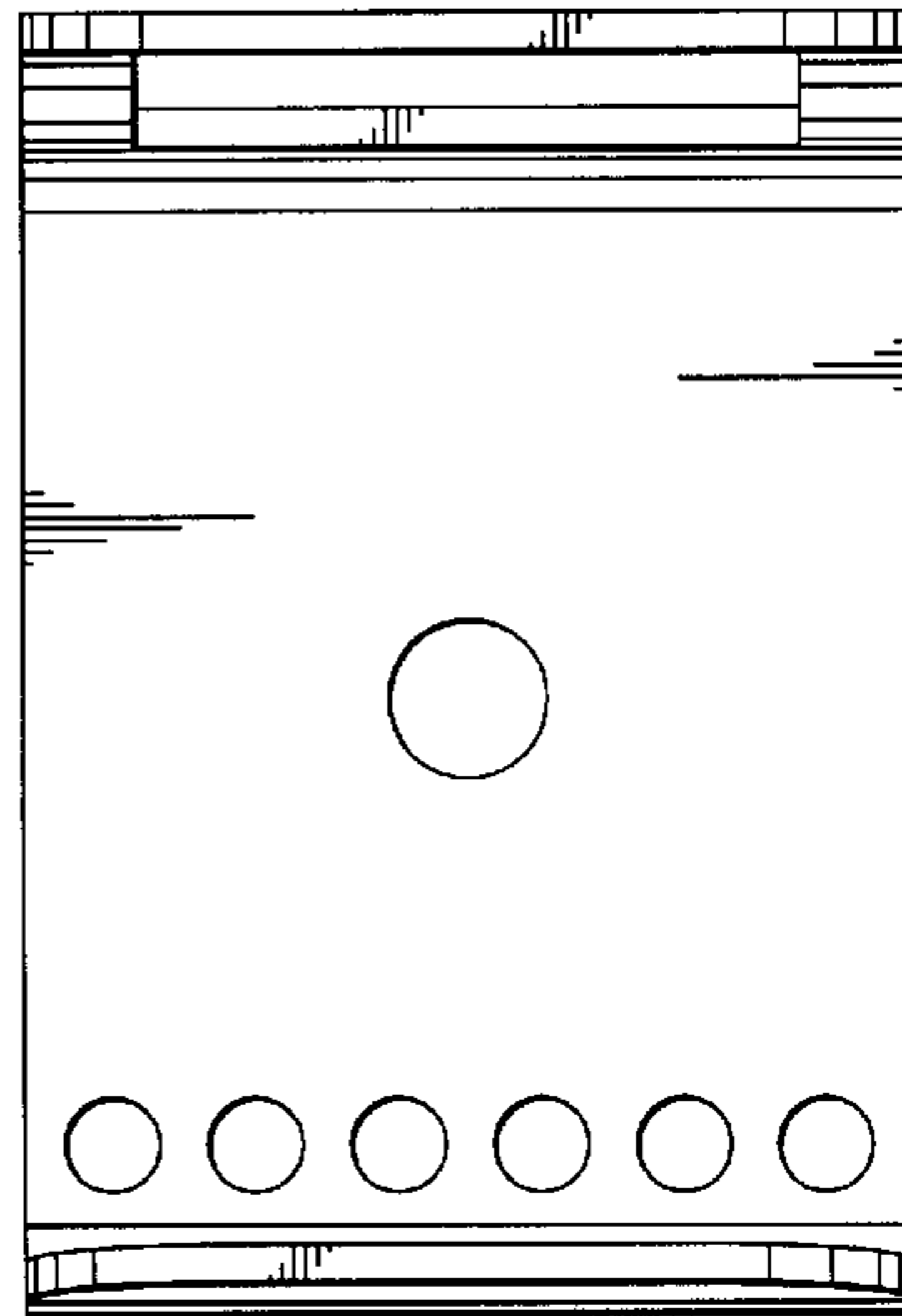

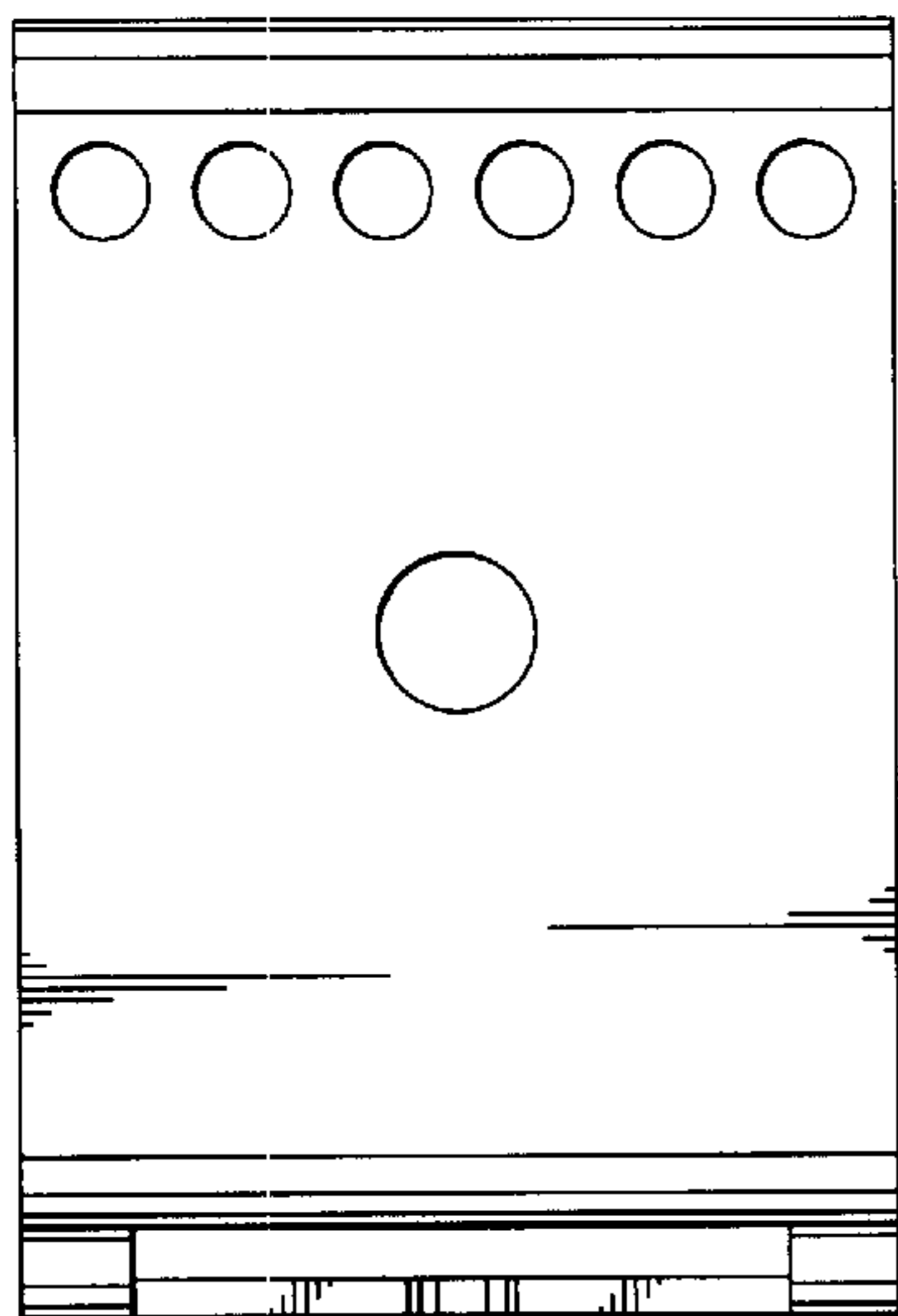
