FIG. 1 is a perspective view of a container with lid showing our new design;

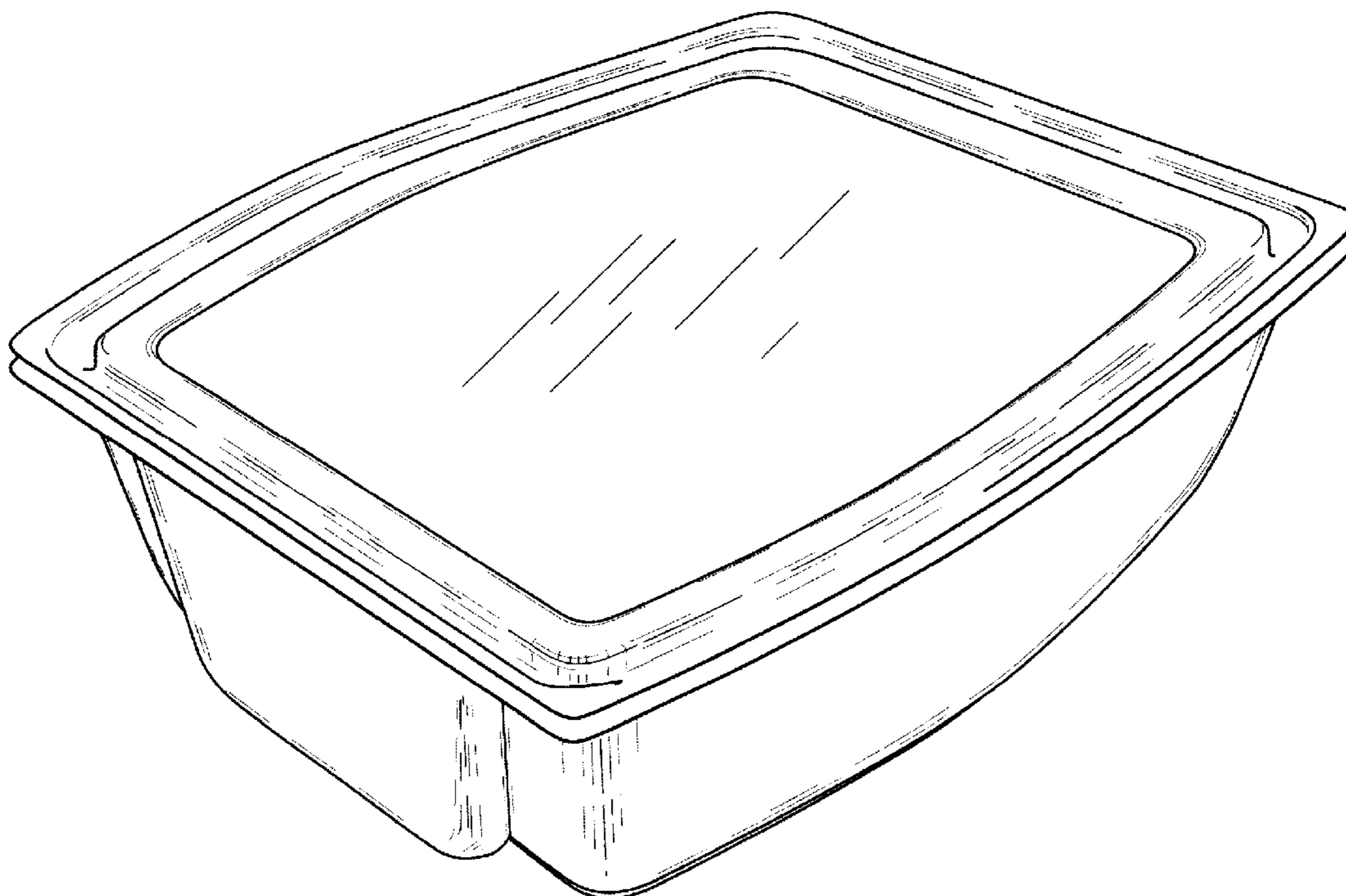
FIG. 2 is a side view thereof, the opposite side being a mirror image;

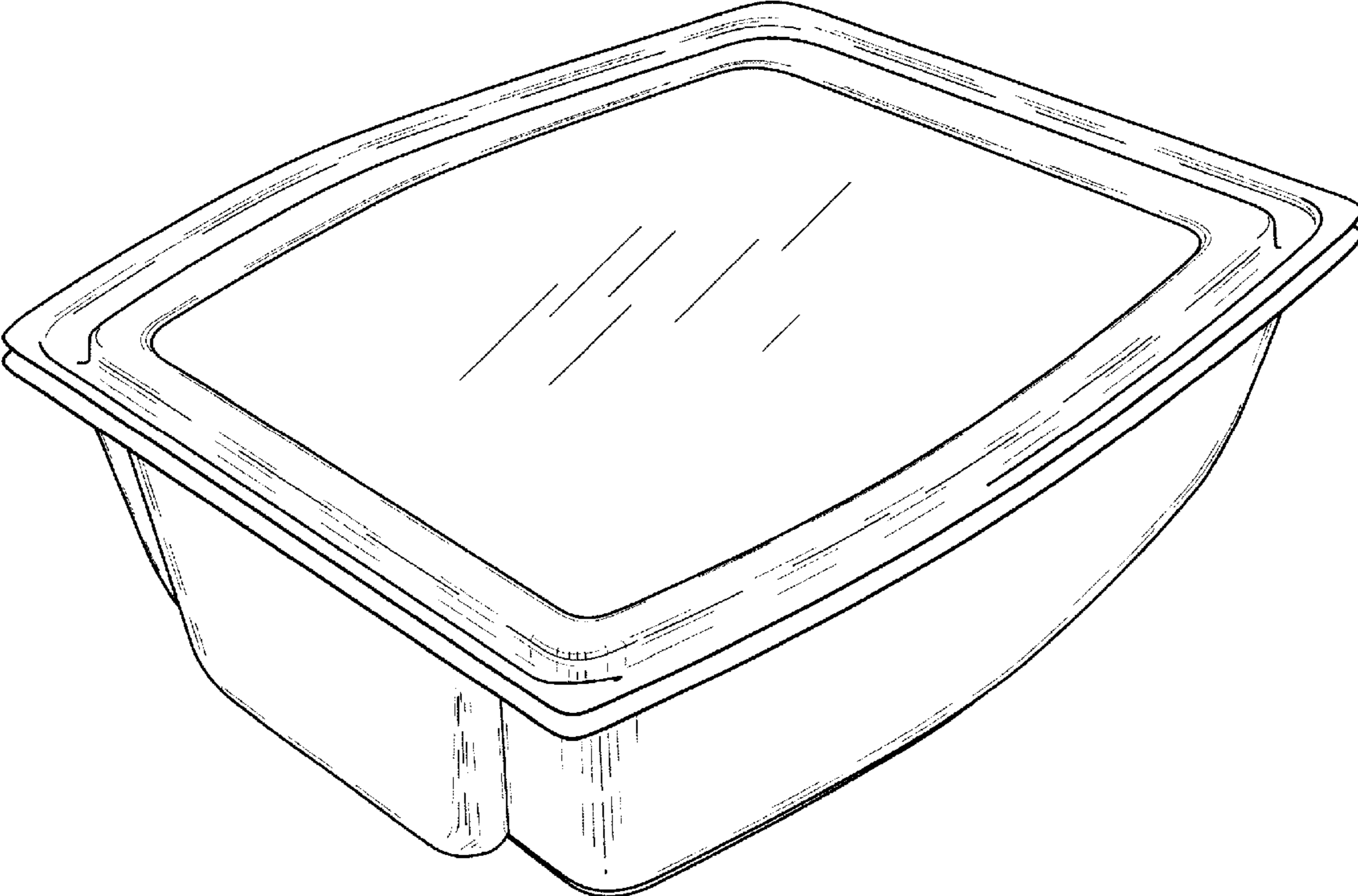

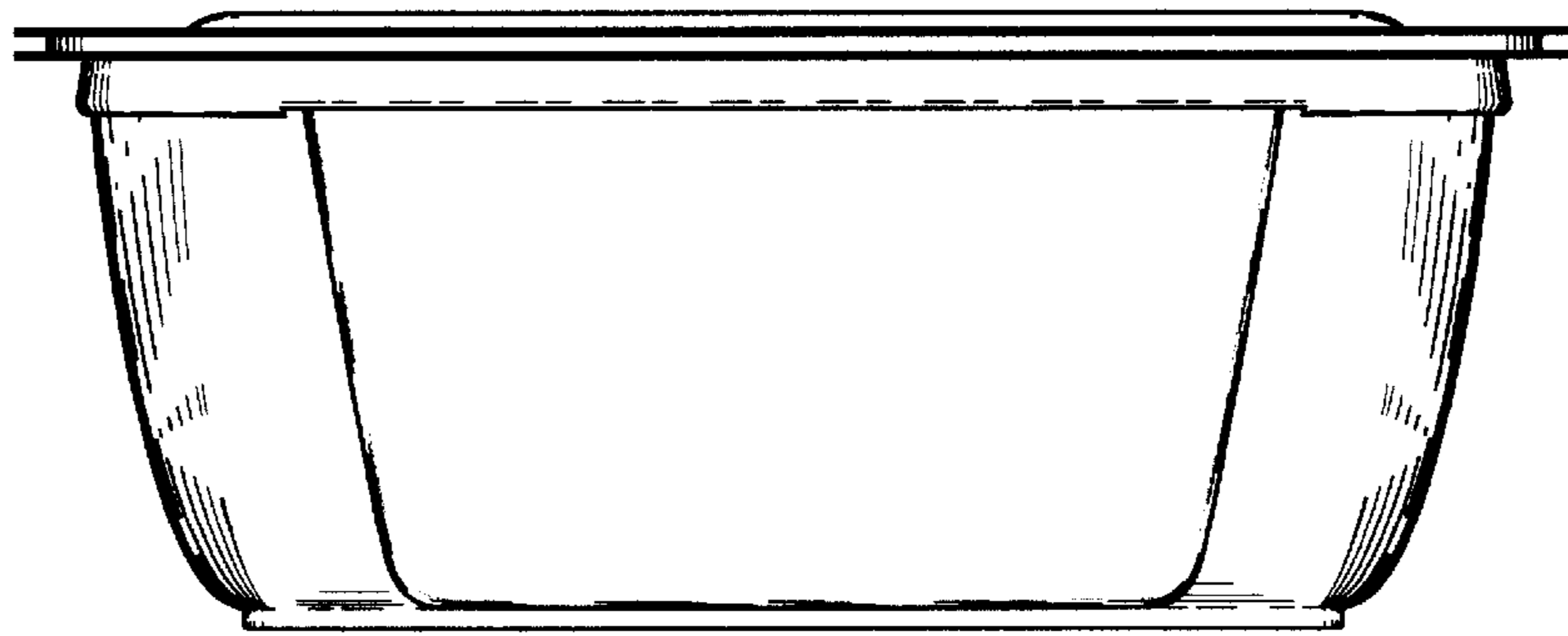

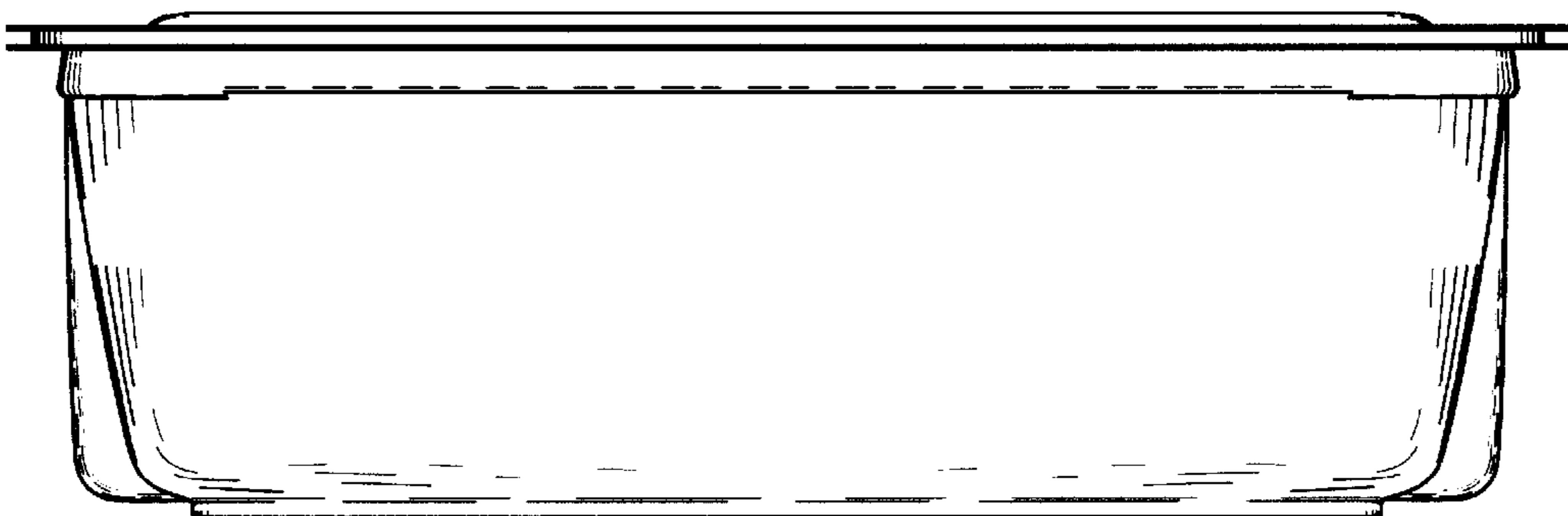

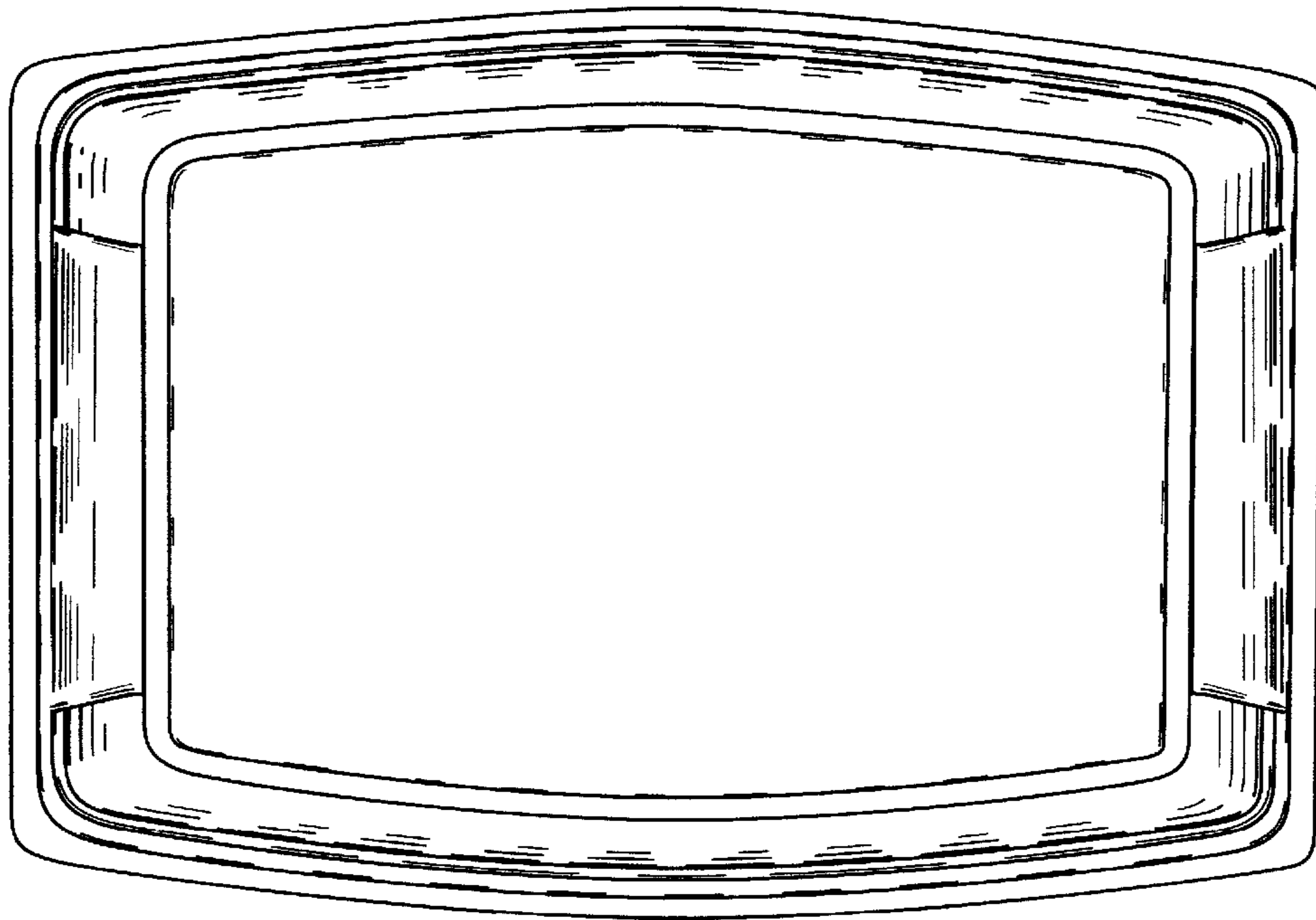

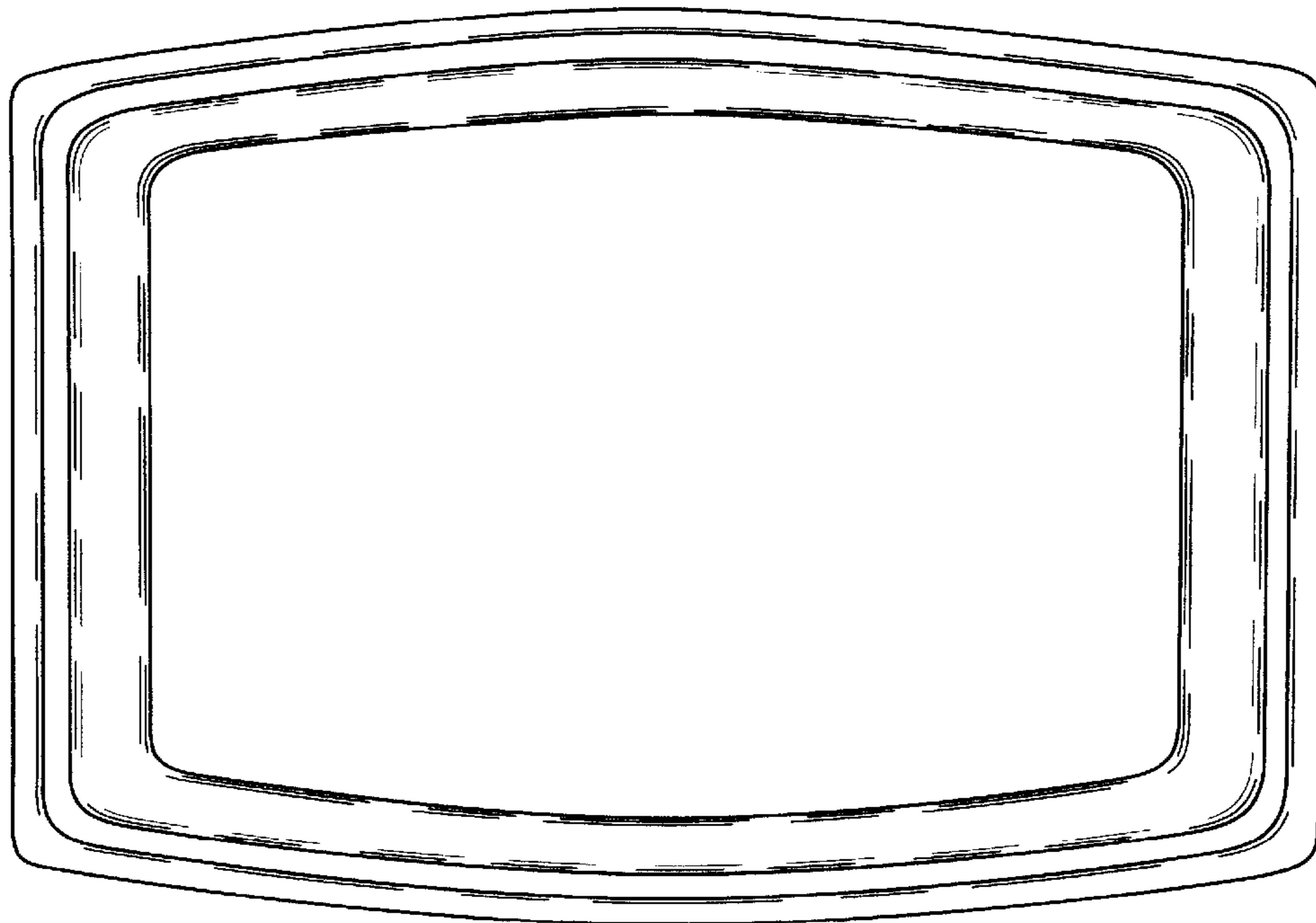
