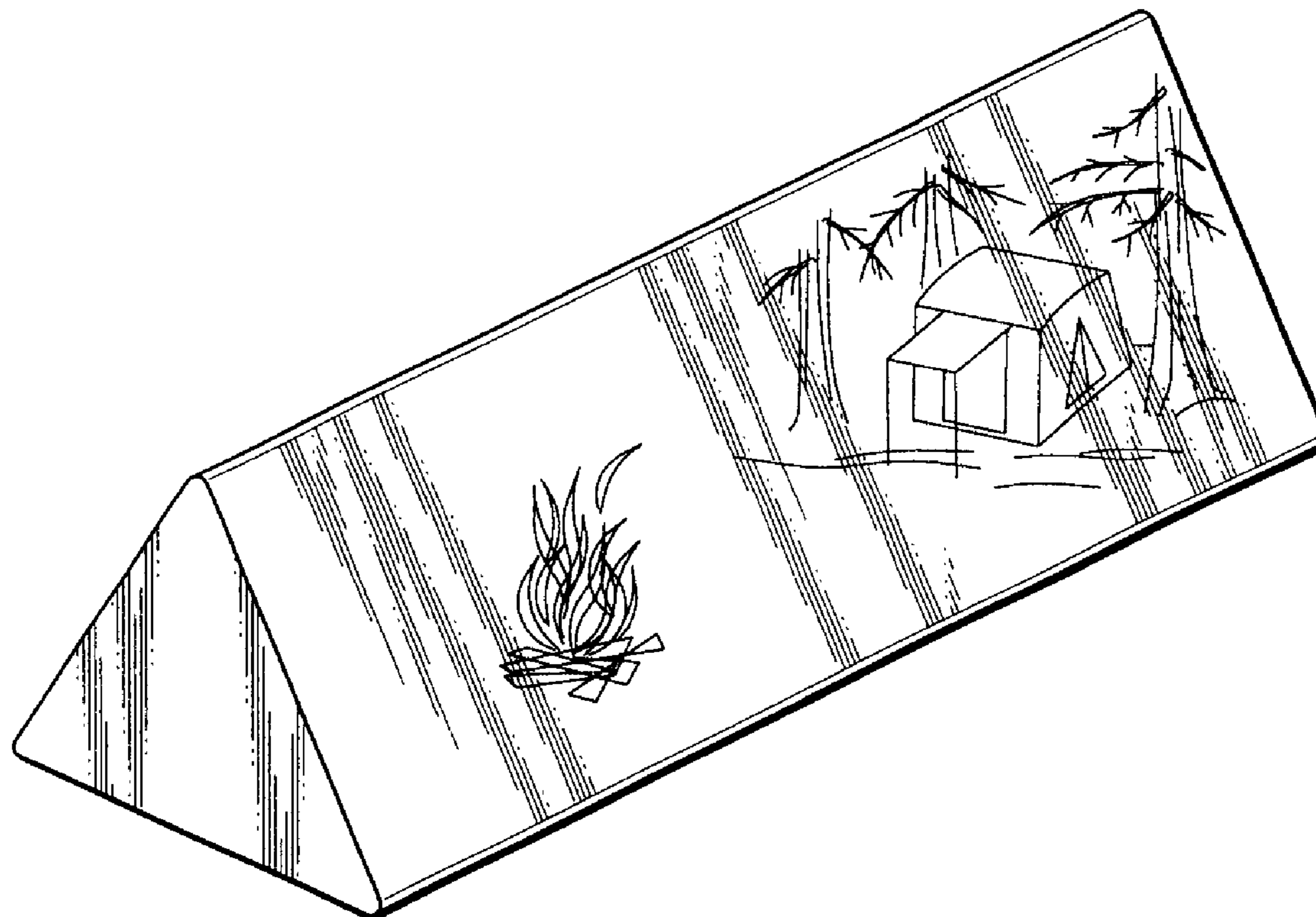
(57) **CLAIM**

We claim the ornamental design for a carton for artificial camping log, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a carton for artificial camping log showing our new design; FIG. 2 is a front elevational view thereof, the rear elevational and bottom plan views being optionally identical thereto; FIG. 3 is an end elevational view thereof, the elevational view being identical thereto; and, FIG. 4 is a perspective view showing the carton for artificial camping log in use; the broken lines depict environmental structure for illustrative purposes only and form no part of the claimed design.

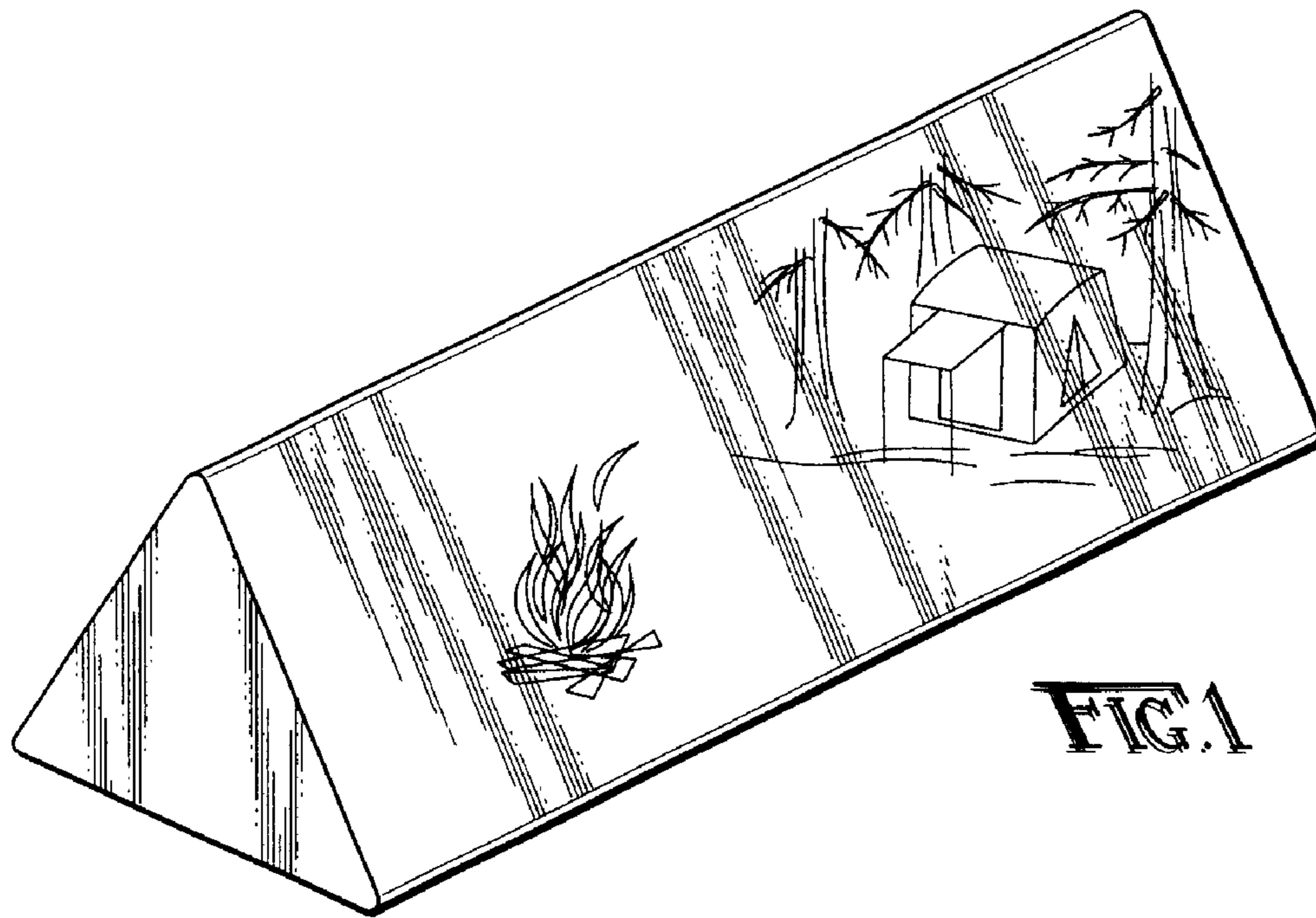

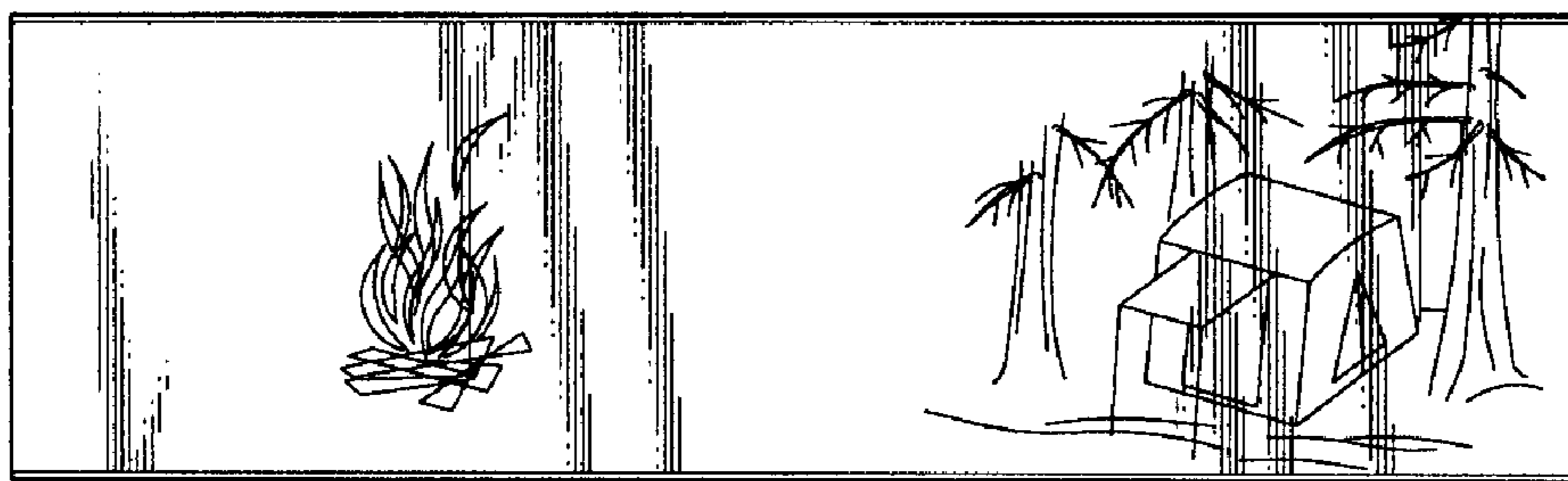

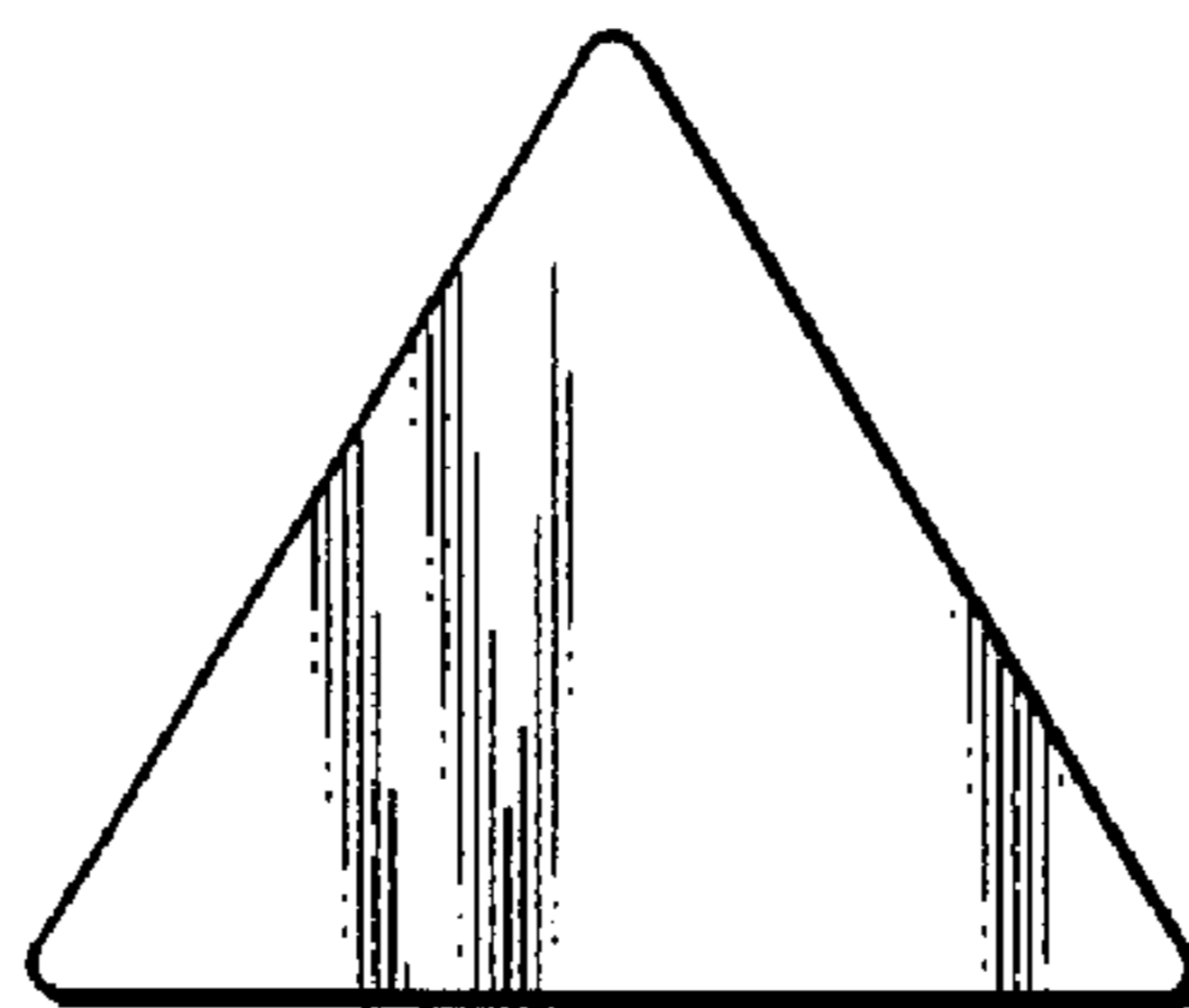

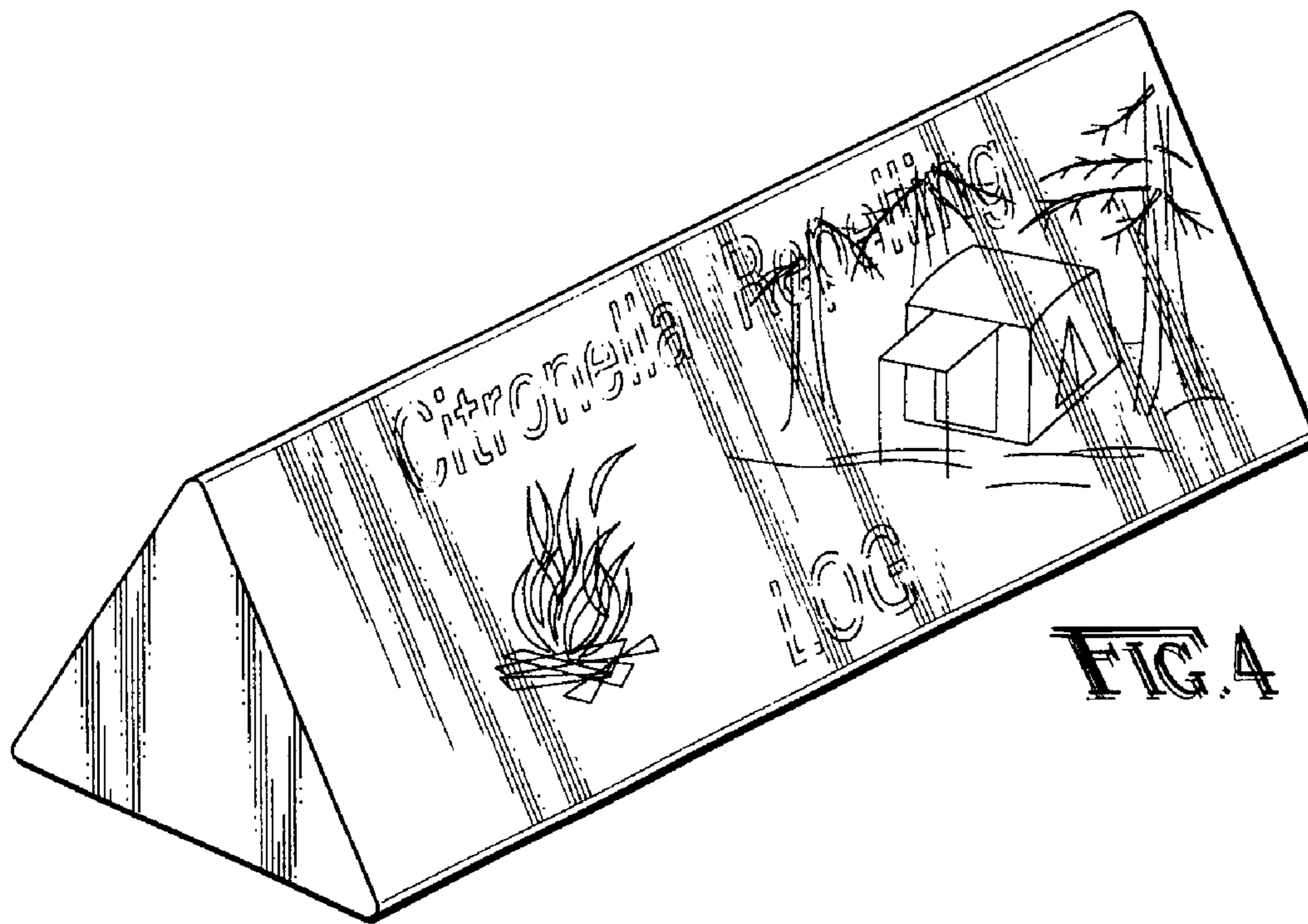
