(57) **CLAIM**

The ornamental design for a fluid dispenser, as shown and described.

**DESCRIPTION**

FIG. 1 is an exploded perspective view of a fluid dispenser, showing our new design;

FIG. 2 is a perspective view of the assembled cap, casing and fluid insert of the fluid dispenser;

FIG. 3 is a front elevational view thereof, the rear elevational view, top and bottom plan views being identical thereto;

FIG. 4 is an enlarged left side elevational view thereof;

FIG. 5 is an enlarged right side elevational view thereof;

FIG. 6 is a front elevational view of the assembled casing and fluid insert, the rear elevational view, top and bottom plan views being identical thereto;

FIG. 7 is an enlarged left side elevational view thereof;

FIG. 8 is an enlarged right side elevational view thereof;

FIG. 9 is a front elevational view of the fluid insert, the rear elevational view being identical thereto;

FIG. 10 is a top plan view thereof, the bottom plan view being identical thereto;

FIG. 11 is an enlarged left side elevational view thereof;

FIG. 12 is an enlarged right side elevational view thereof;

FIG. 13 is a front elevational view of the casing of the fluid dispenser, the rear elevational view, top and bottom plan views being identical thereto;

FIG. 14 is an enlarged left side elevational view thereof; and,

FIG. 15 is an enlarged right side elevational view thereof.

The broken lines shown in the drawings are for illustration purpose only and form no part of the claimed design.

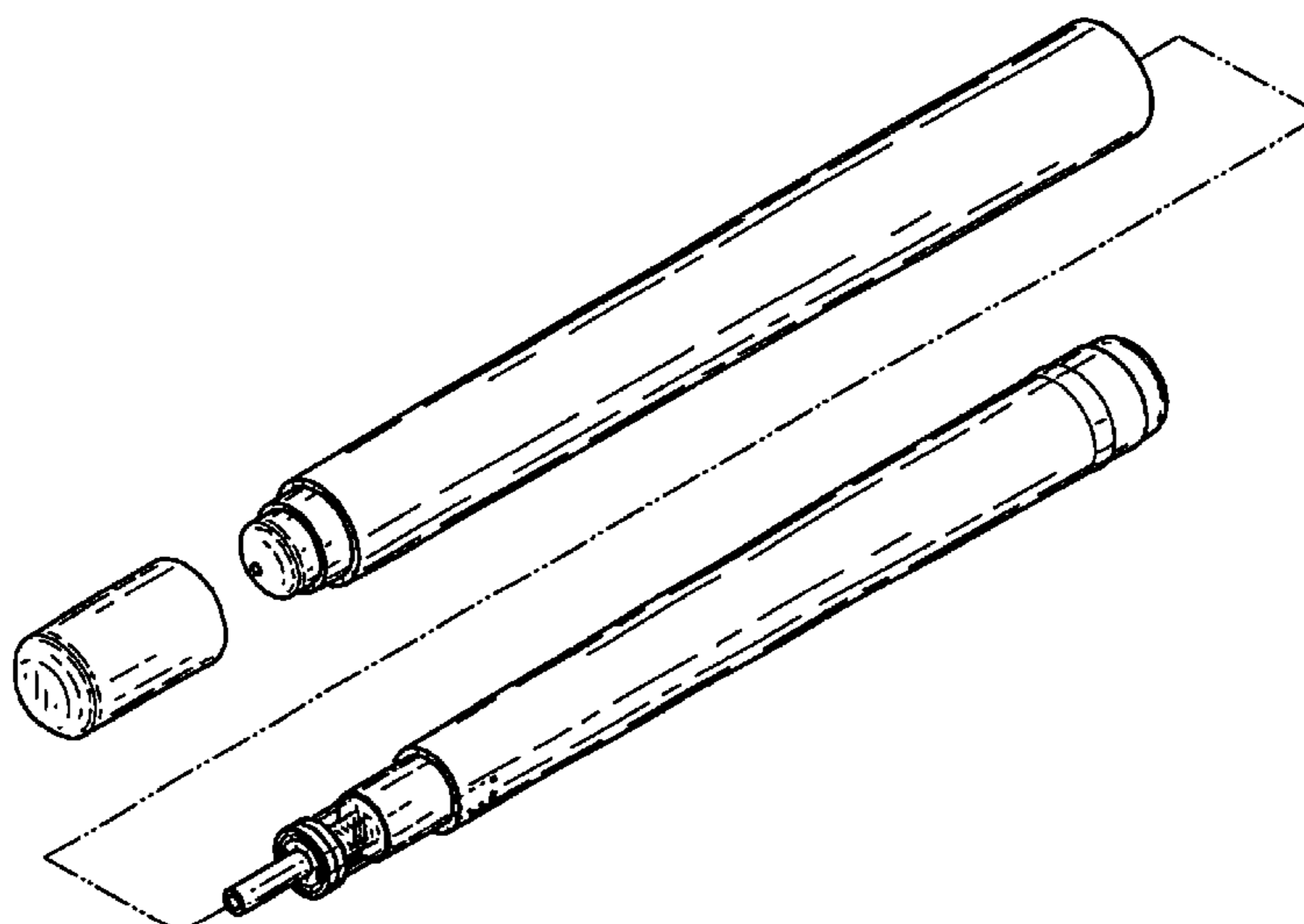

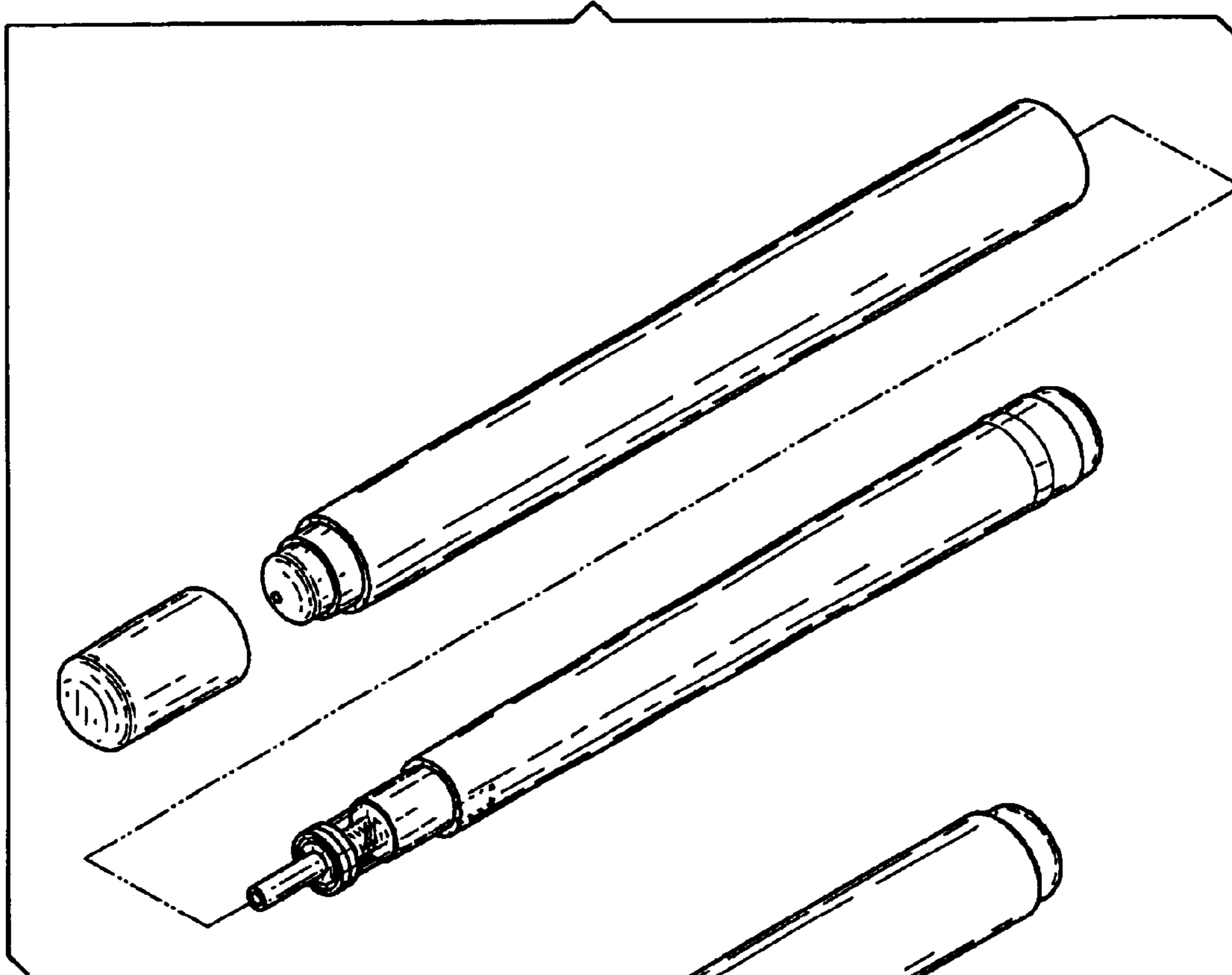

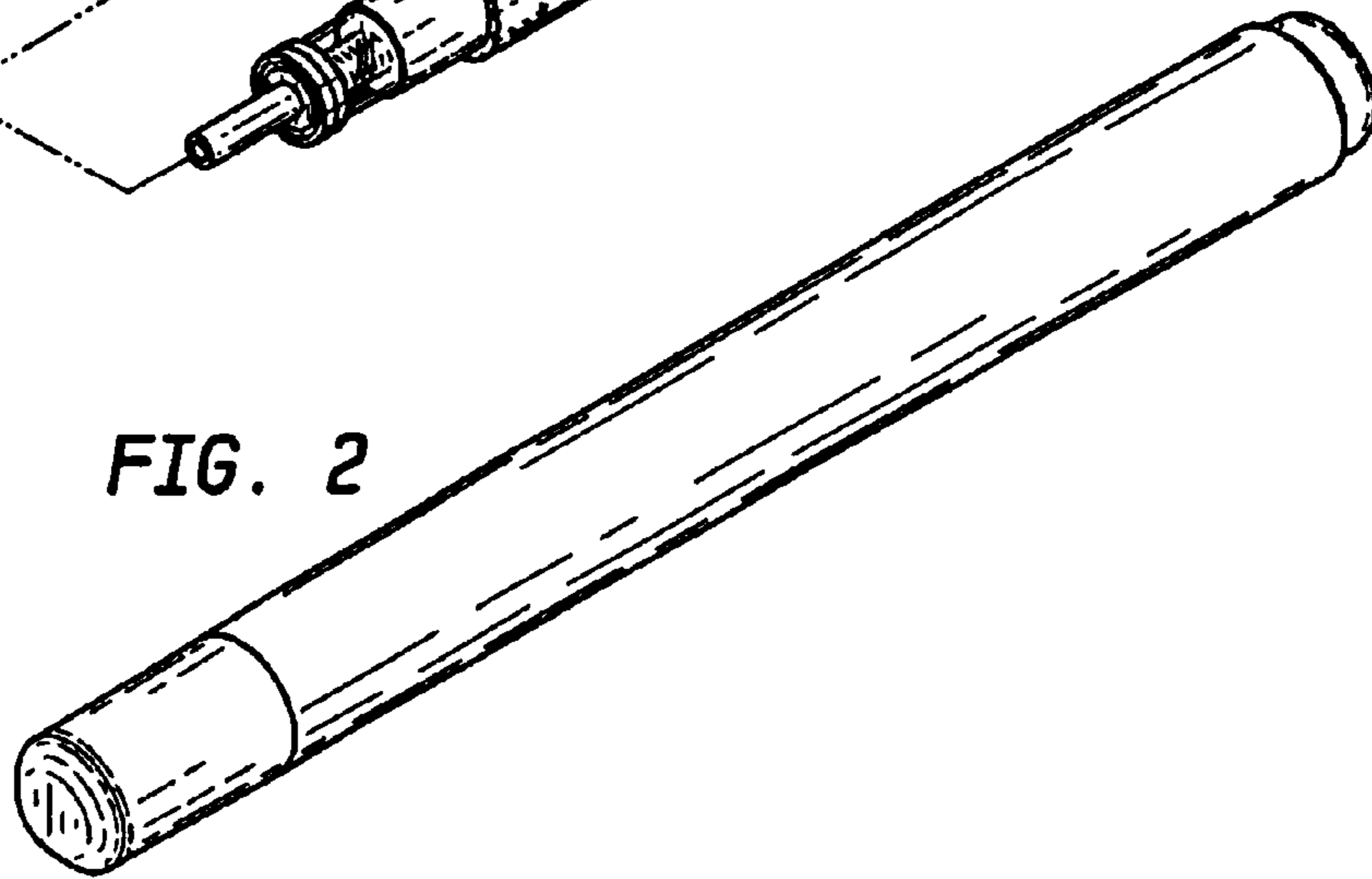

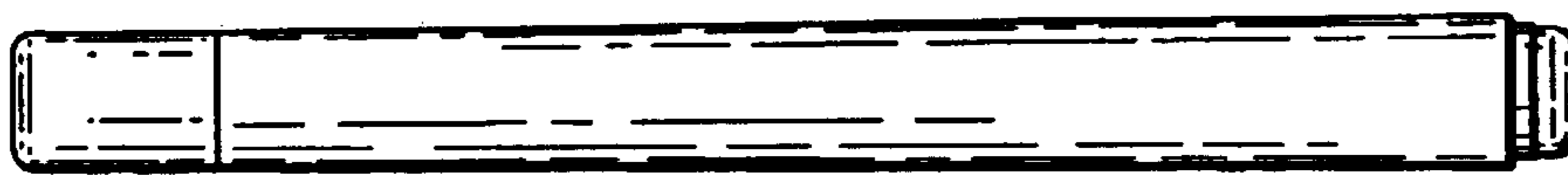

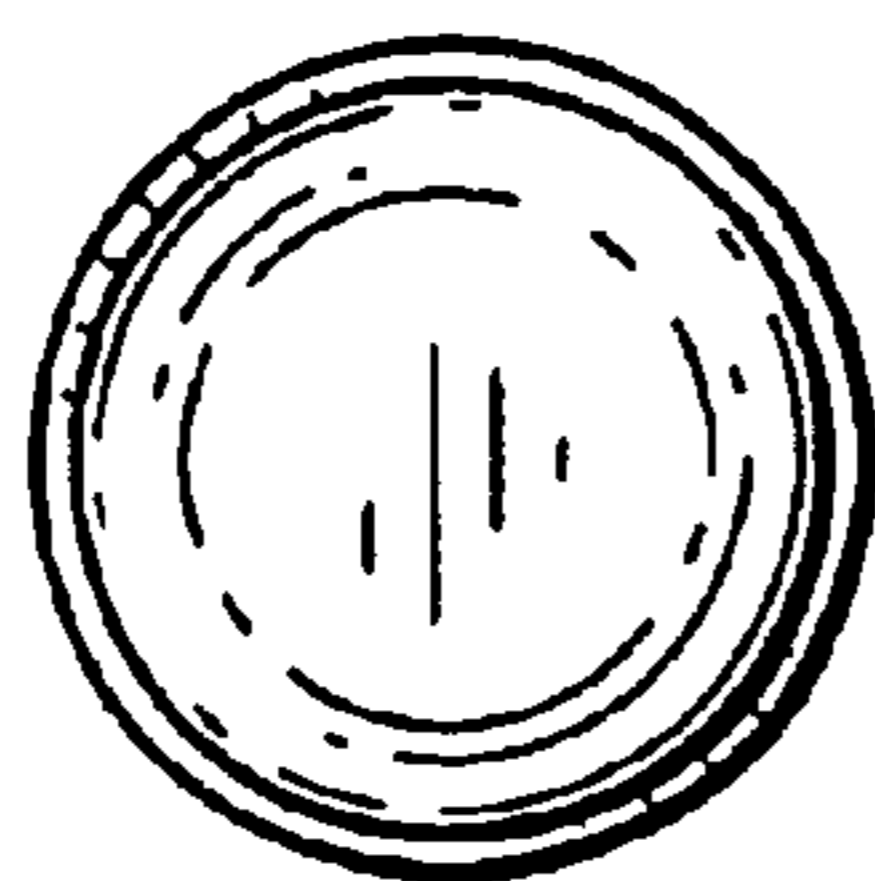
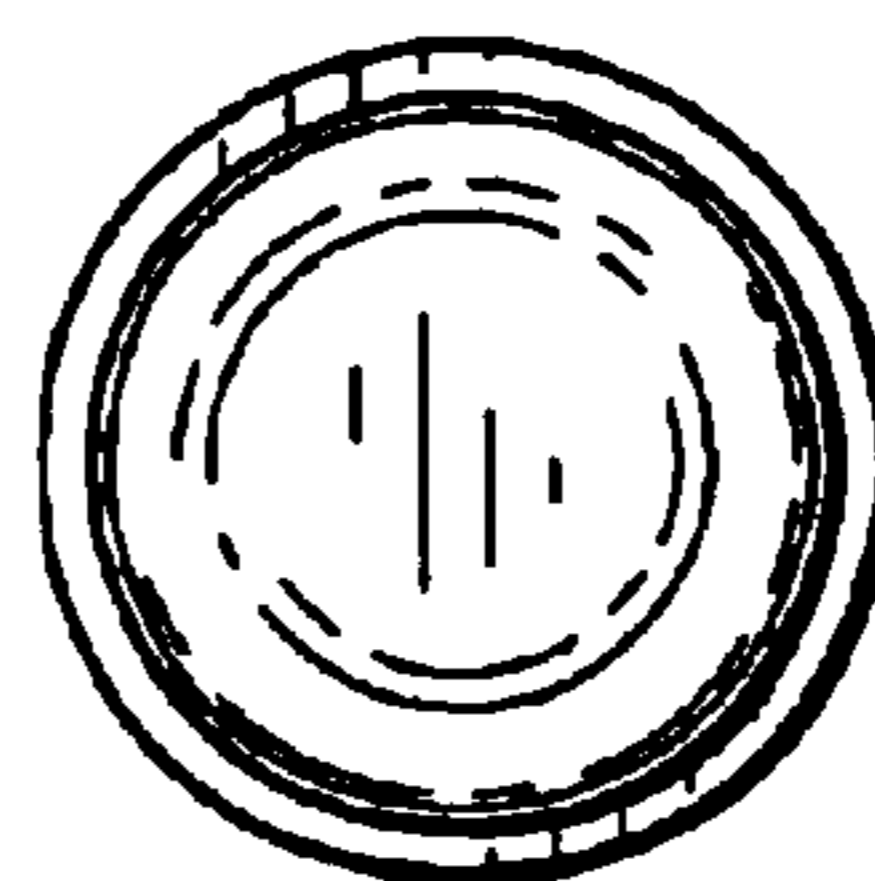
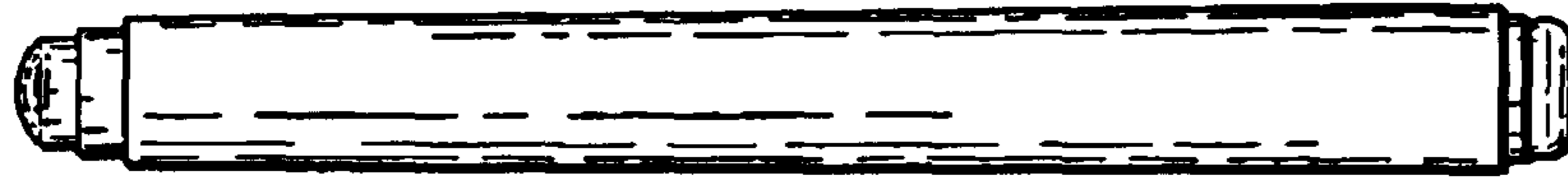


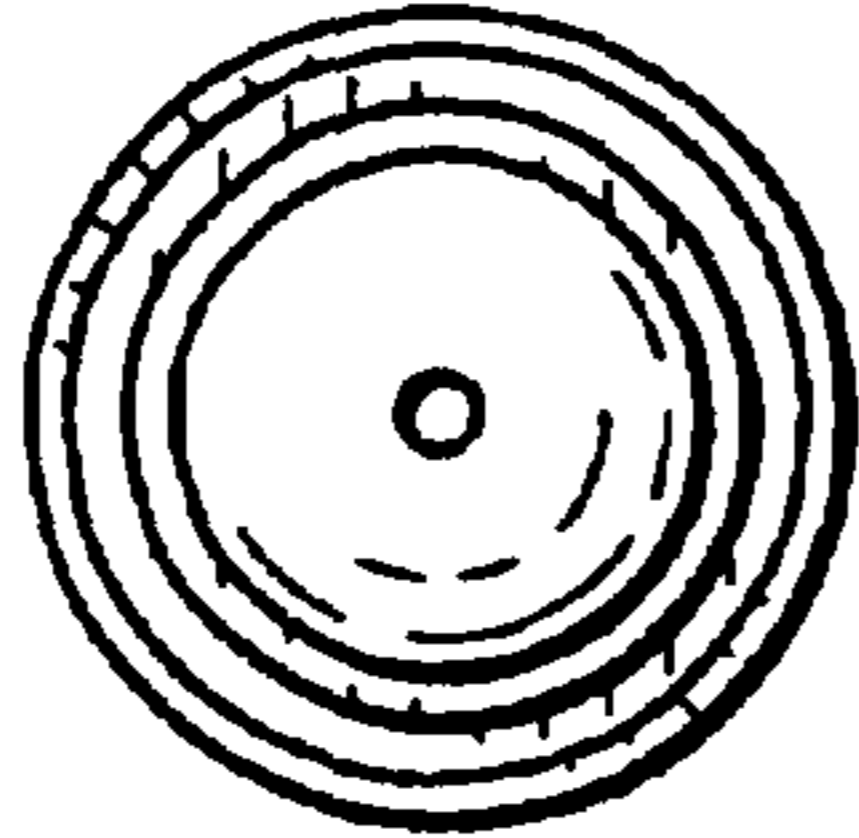

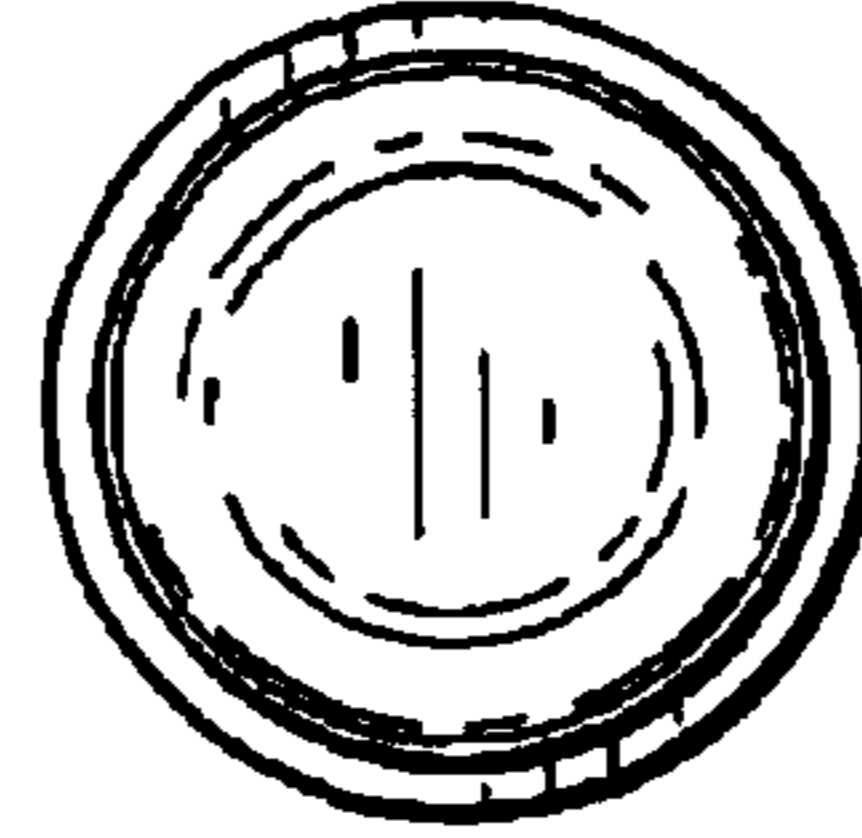

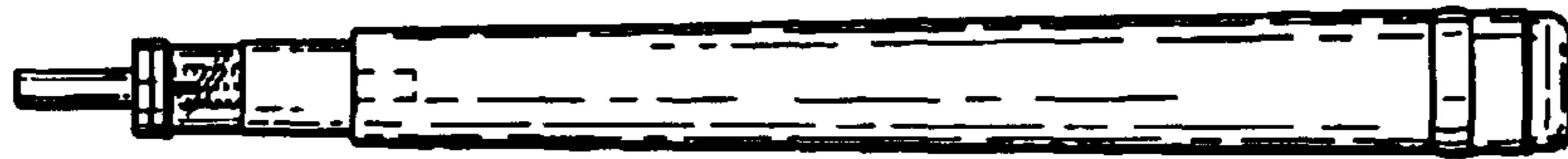

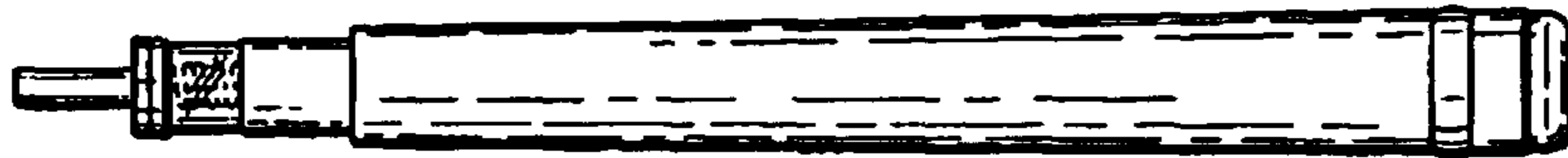

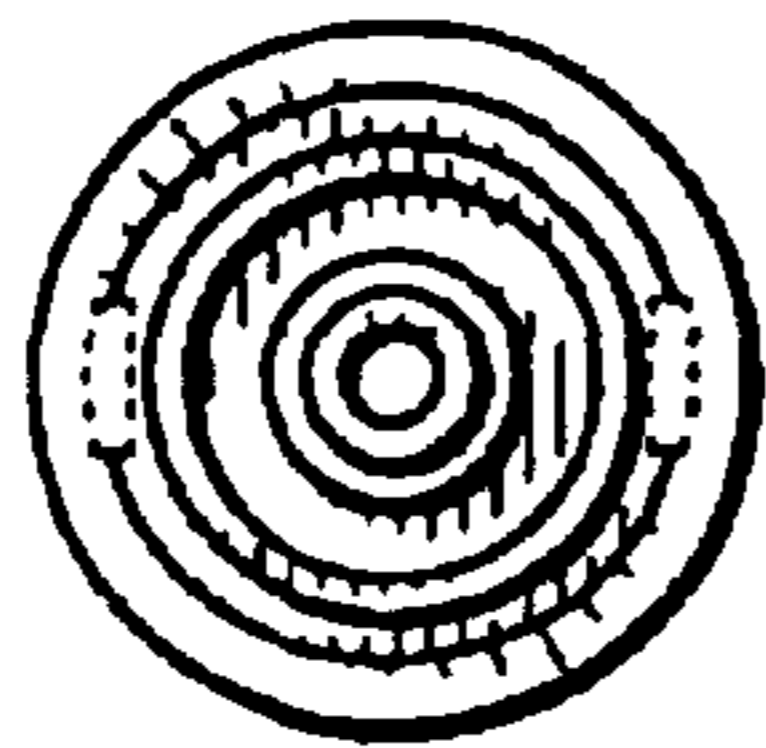

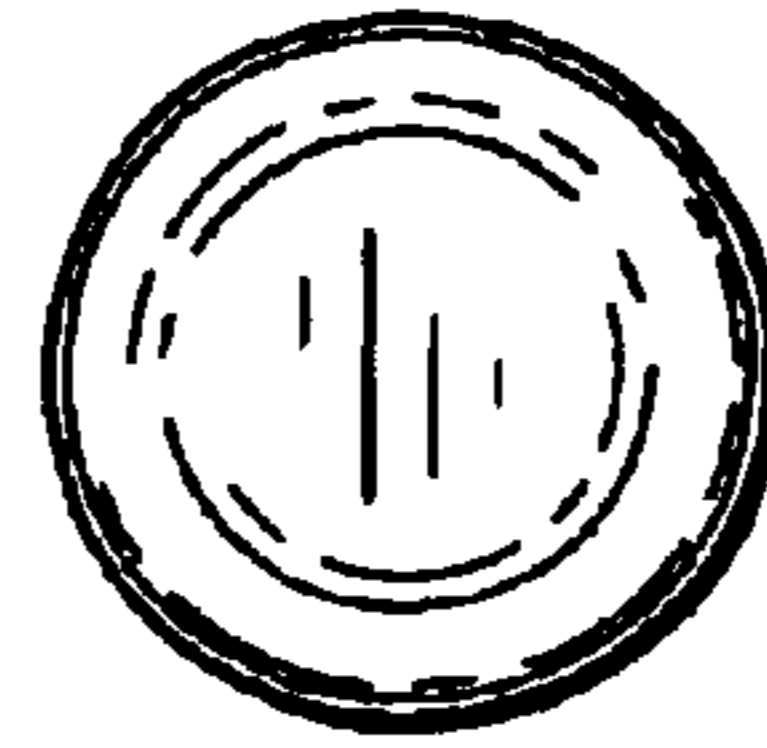

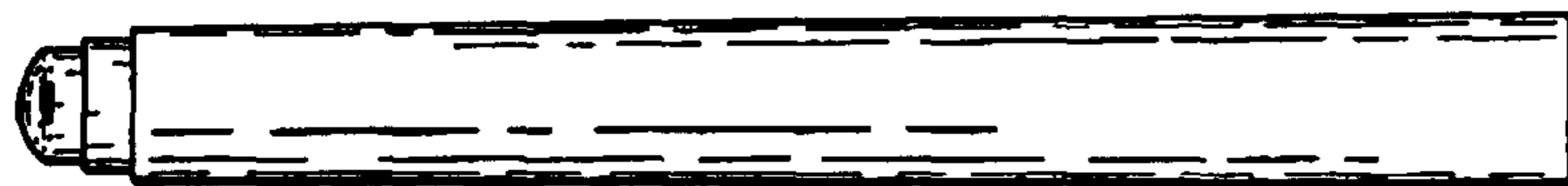

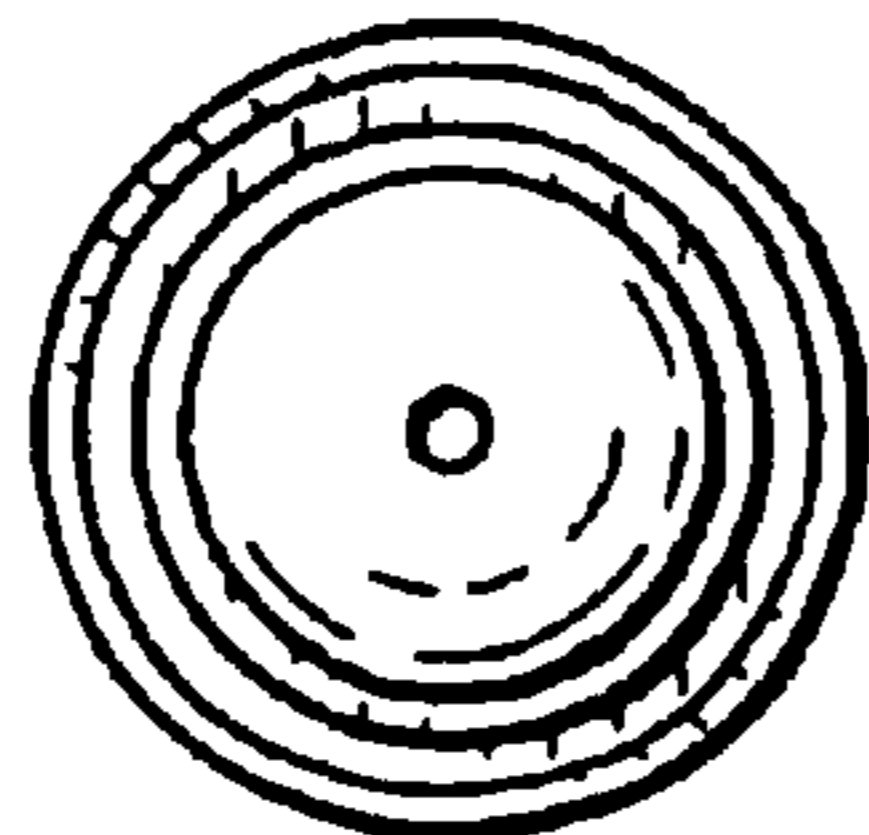
