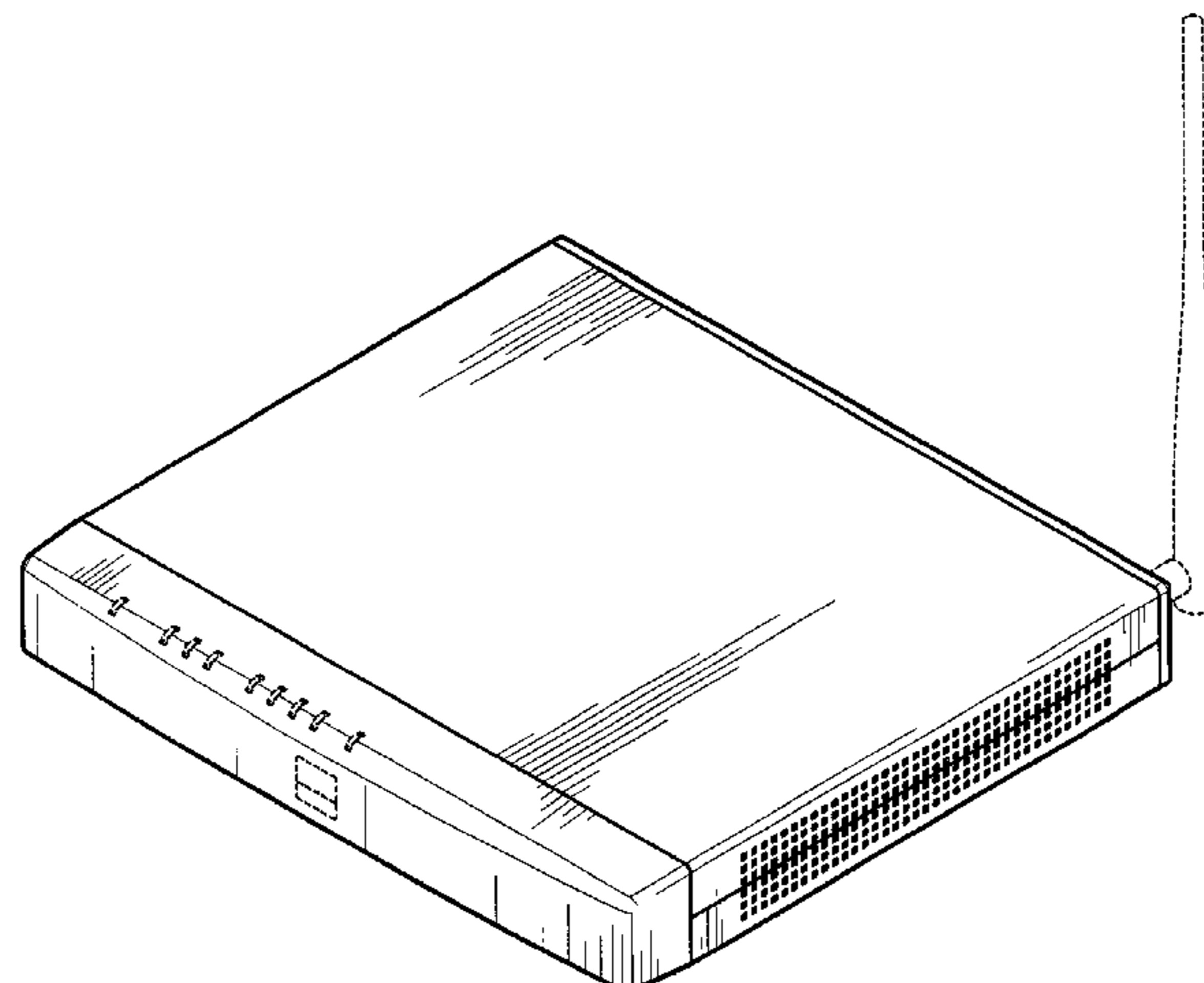
The ornamental design for a gateway housing, as shown and described.

DESCRIPTION

FIG. 1 is a top and front perspective view of a gateway housing showing our new design;
FIG. 2 is a top and rear perspective view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a front elevation thereof;
FIG. 6 is a rear elevation thereof;
FIG. 7 is a side elevation thereof; and,
FIG. 8 is a side elevation of the side opposite that shown in FIG. 7.

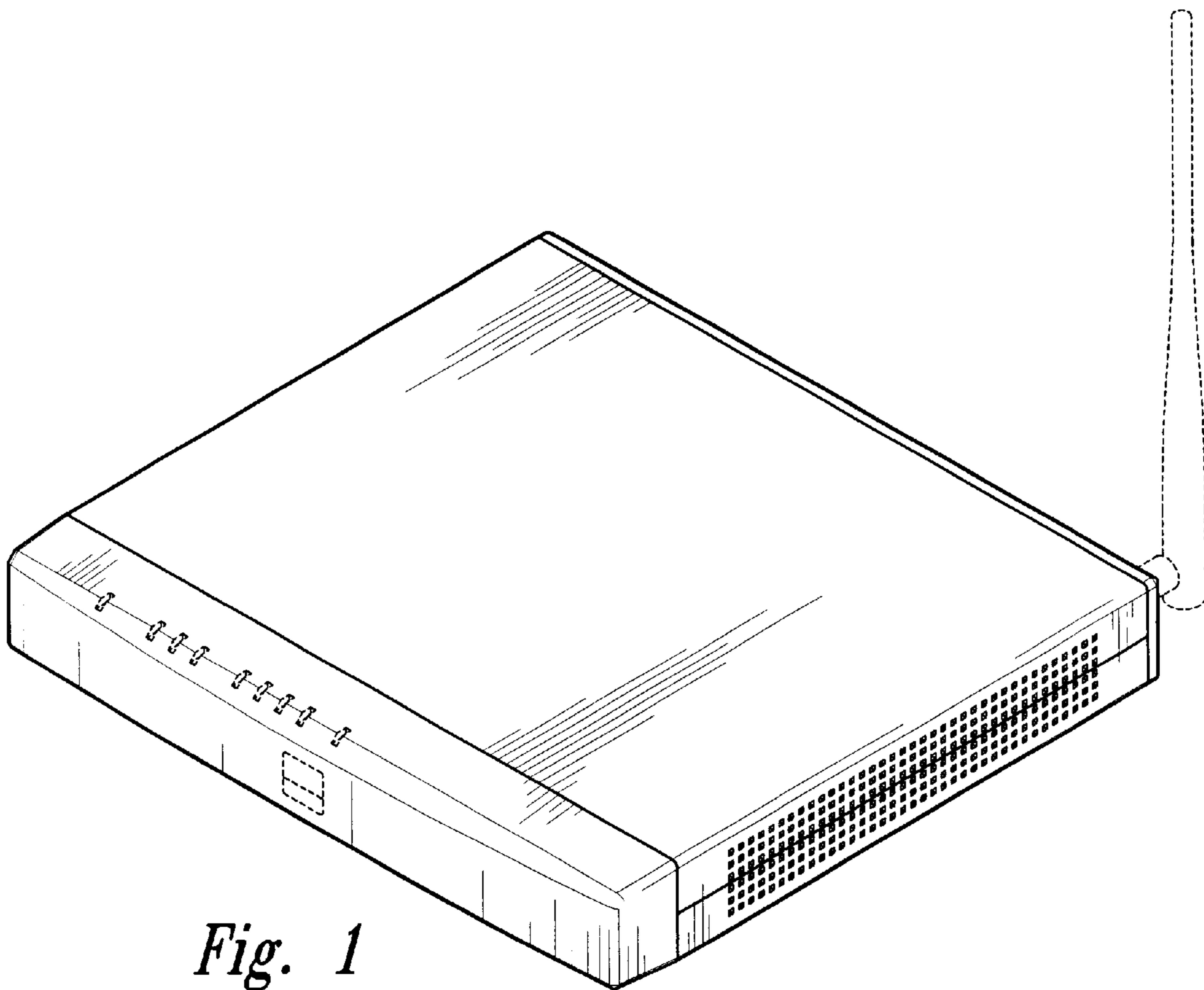

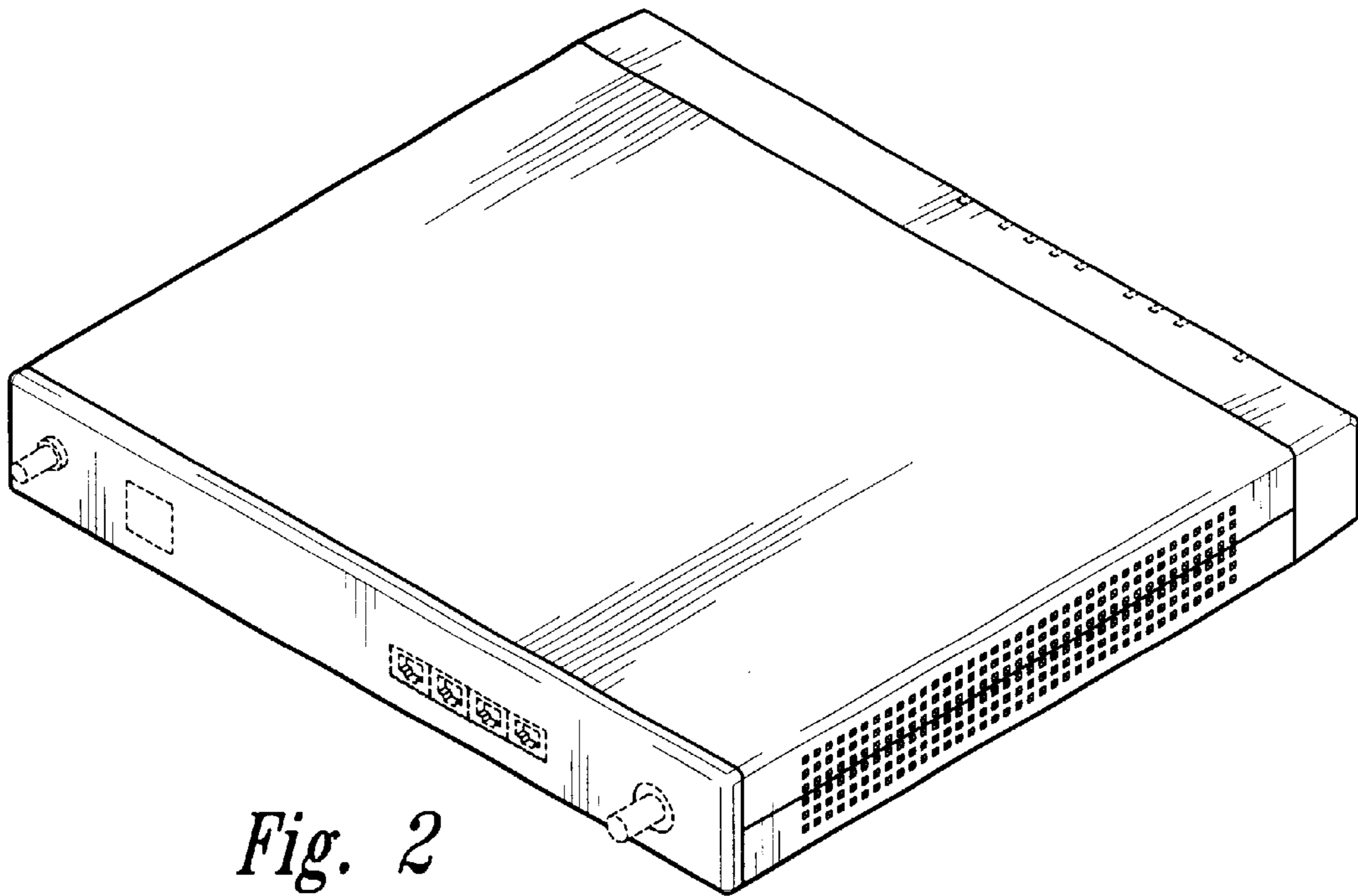

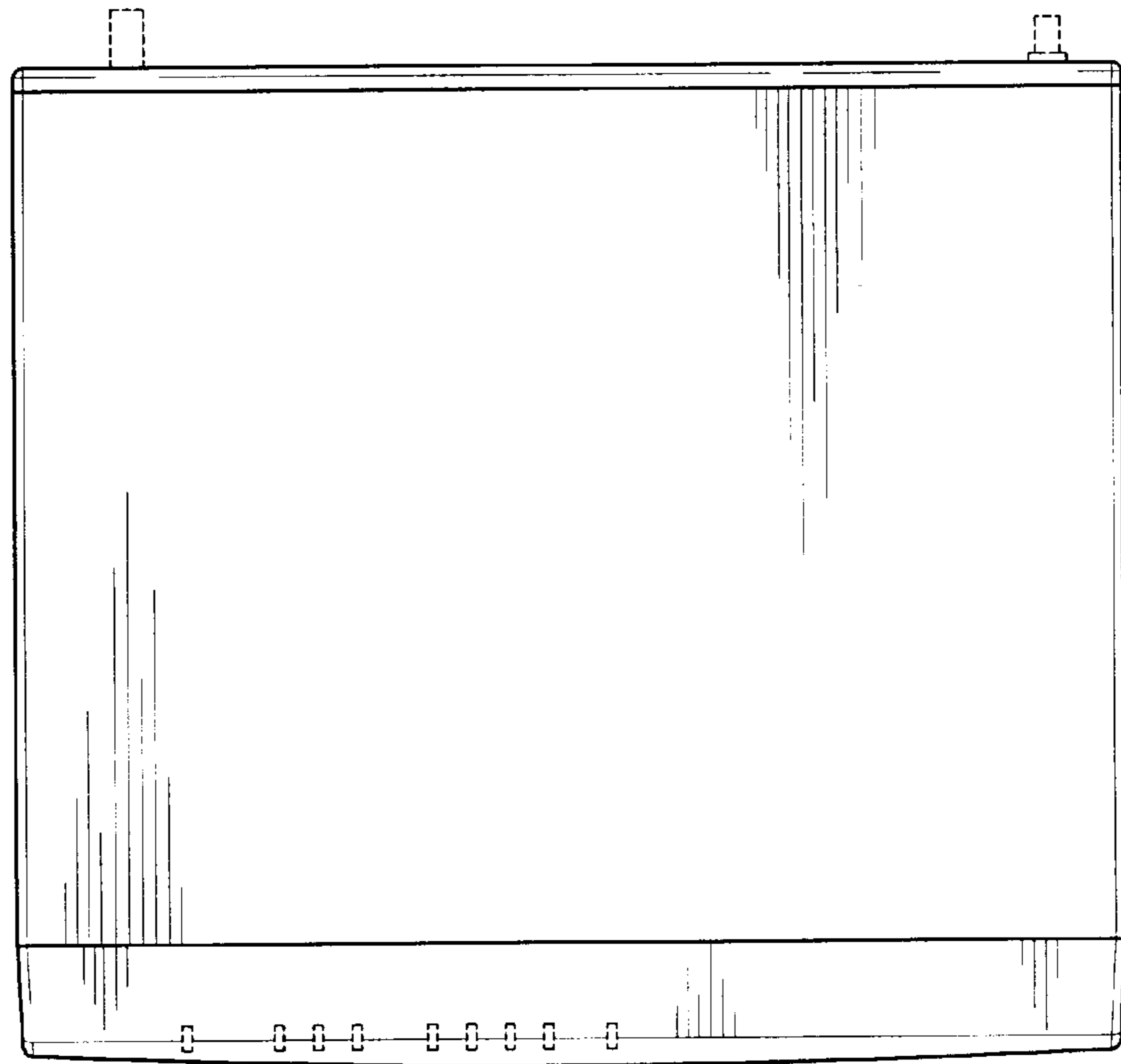

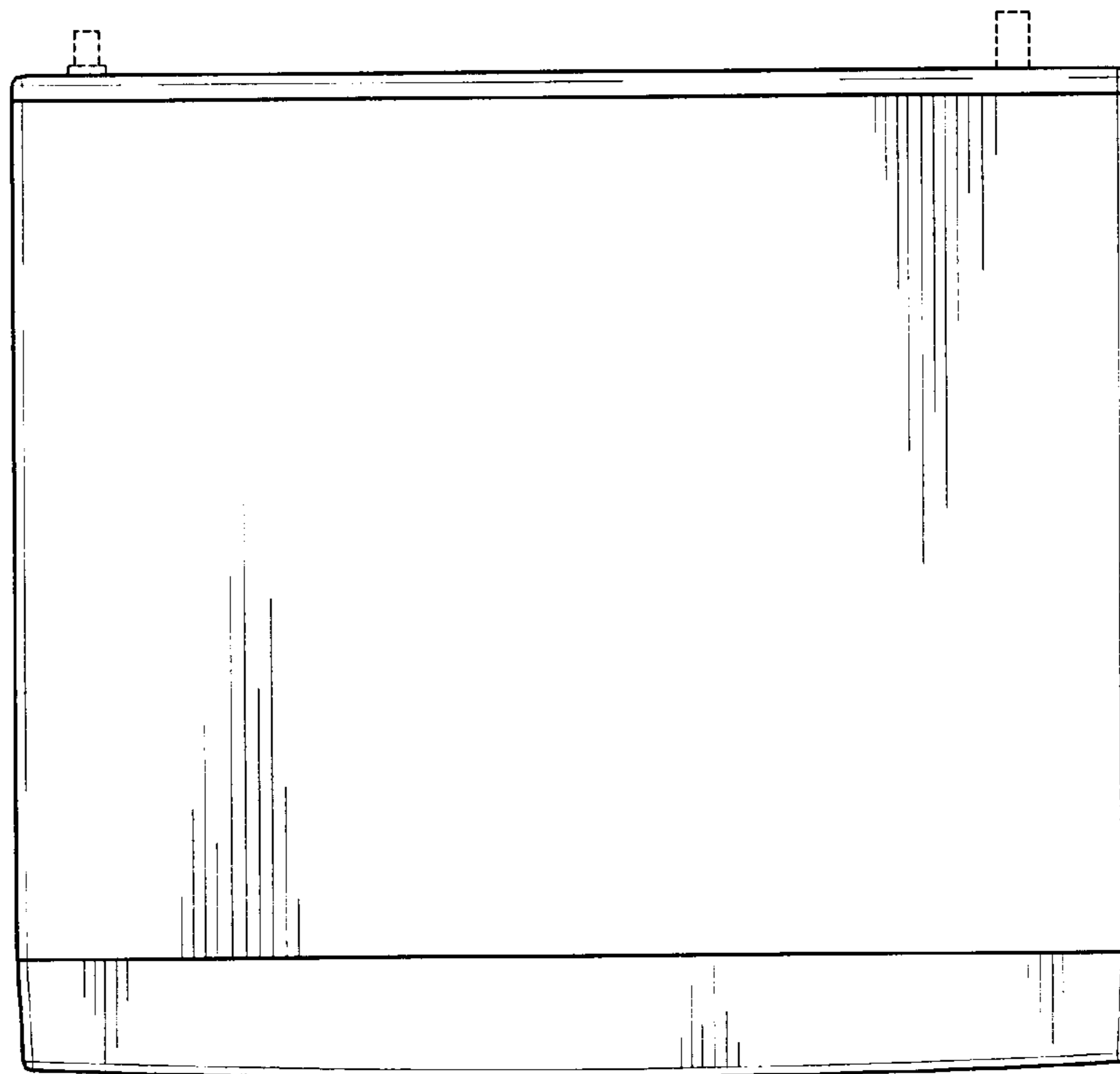

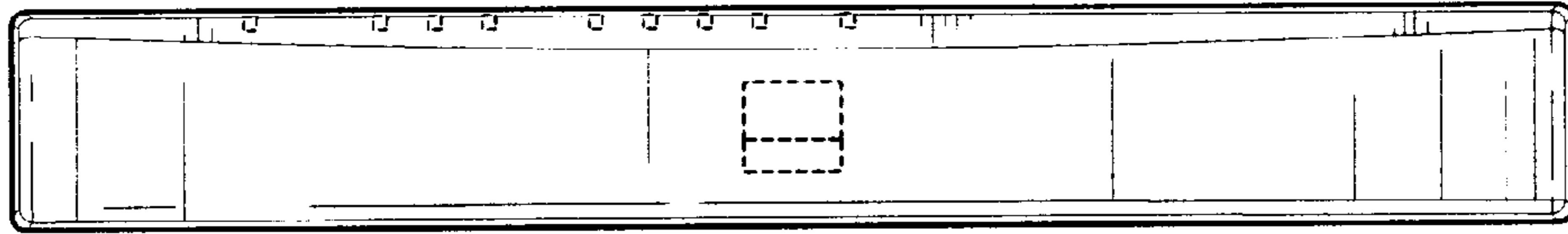

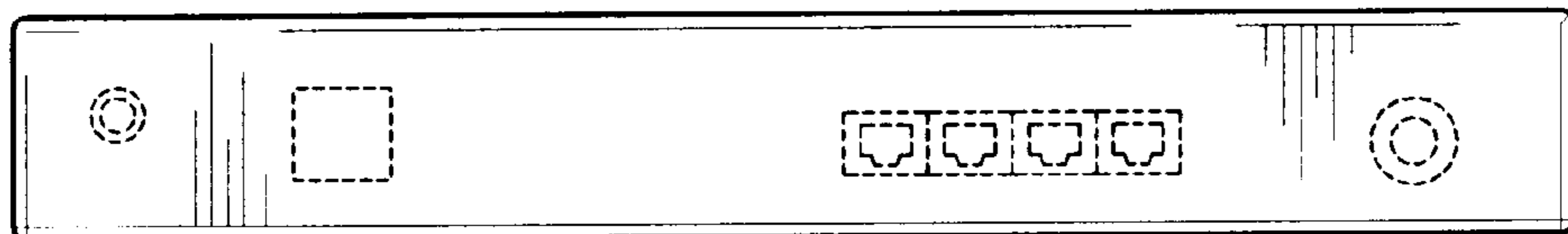

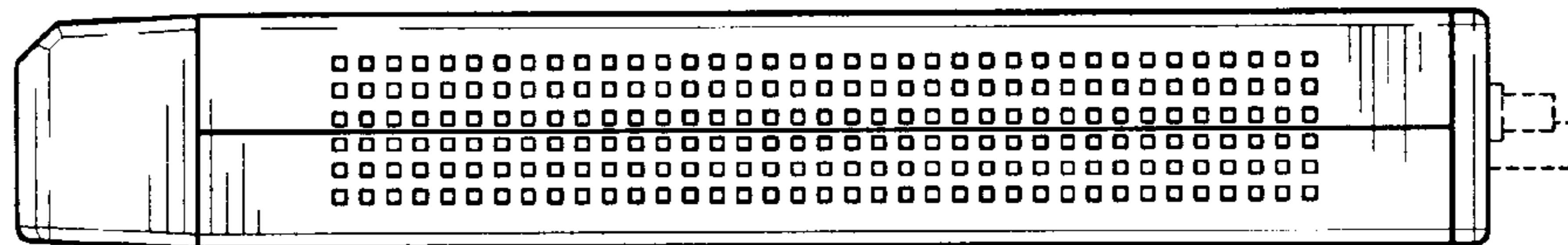

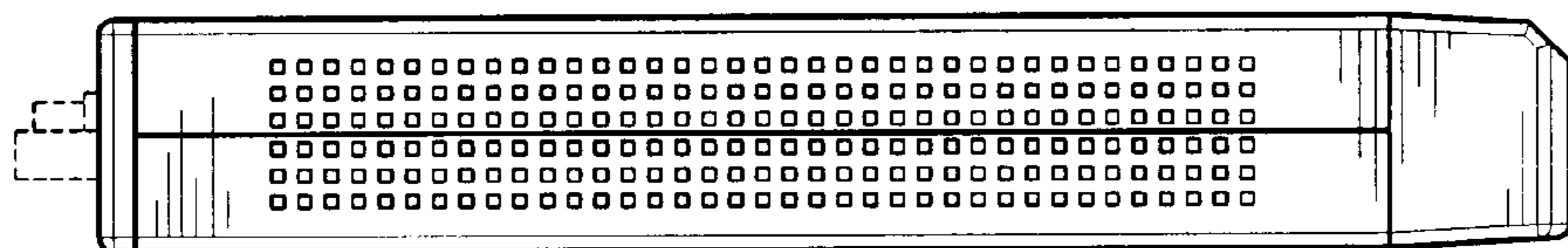
