(57) **CLAIM**

The ornamental design for a Nordic ski, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the Nordic ski.

FIG. 2 is a right side elevational view of the Nordic ski, the left side being a mirror image.

FIG. 3 is a top plan view of the Nordic ski.

FIG. 4 is a bottom plan view of the Nordic ski.

FIG. 5 is an enlarged partial top plan view of the mid portion of the Nordic ski taken from FIG. 3; and,

FIG. 6 is an enlarged partial side elevational view of the mid portion of the Nordic ski taken from FIG. 2.

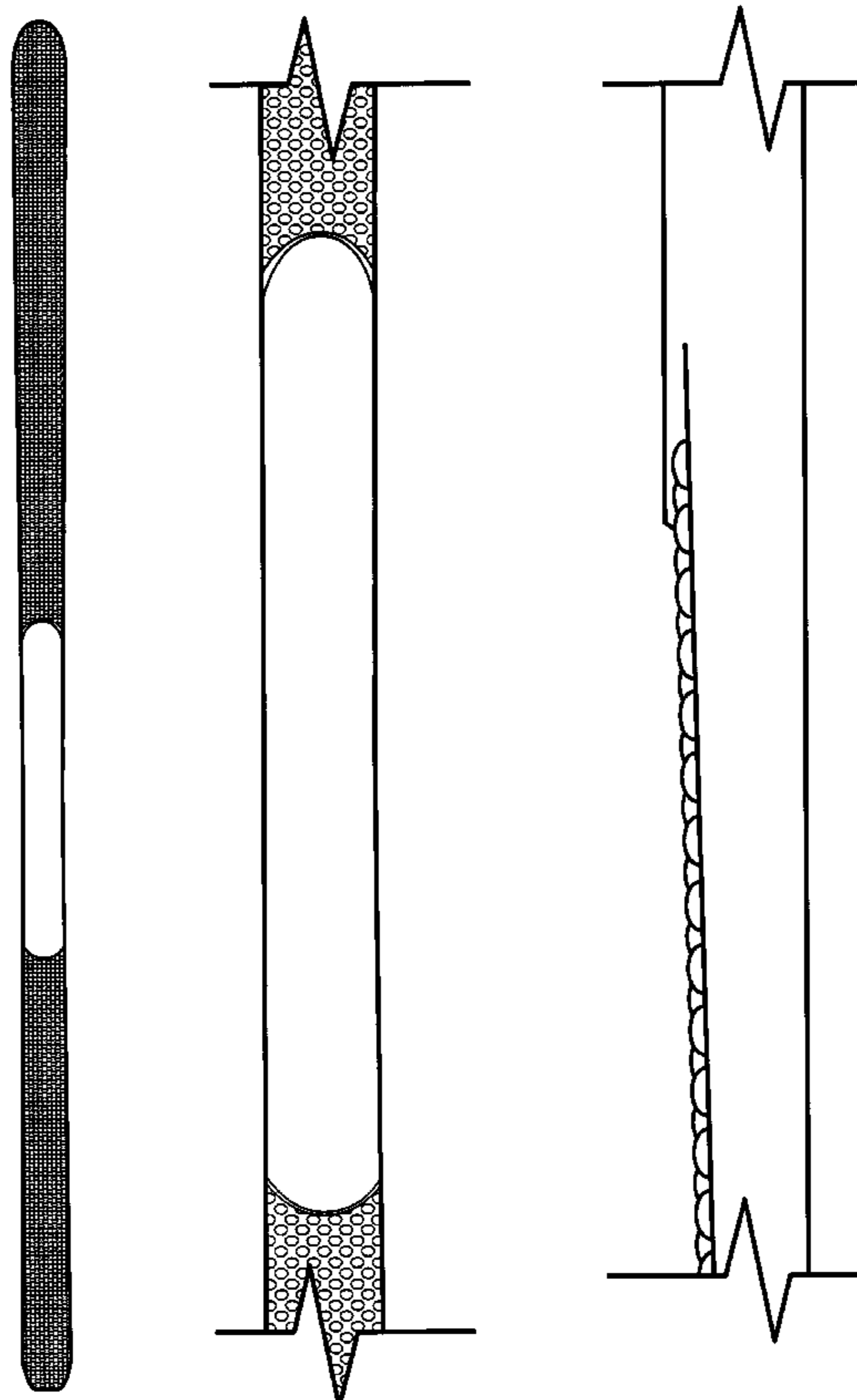

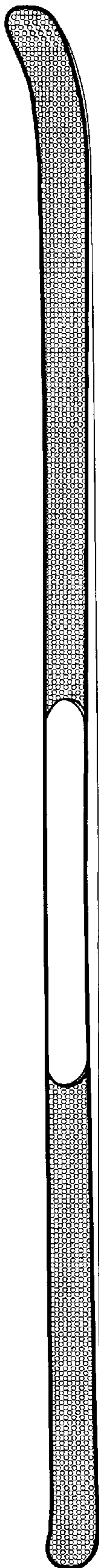

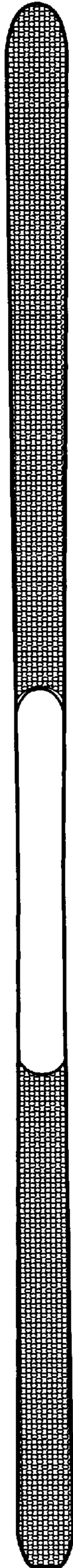

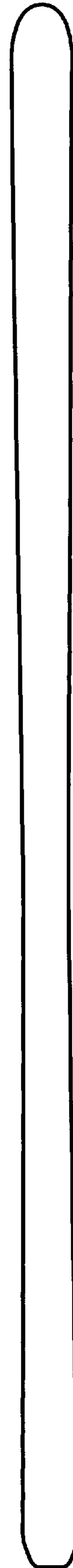

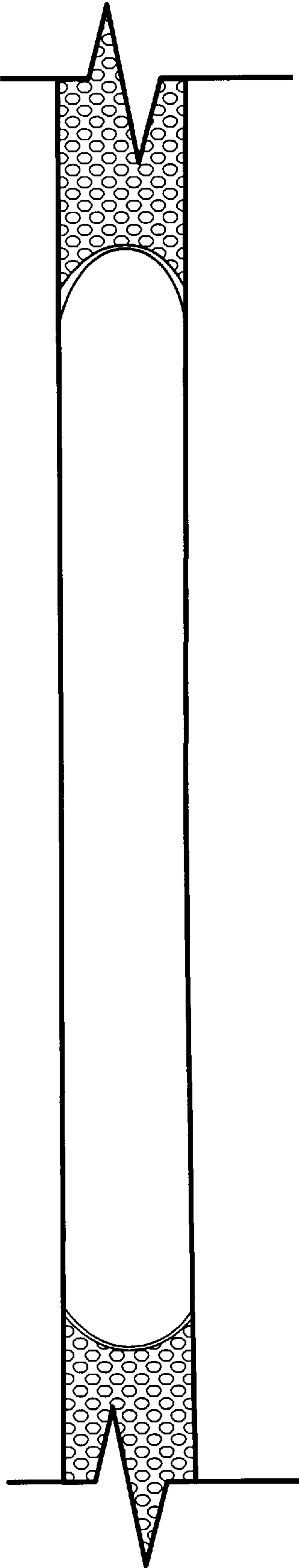
