(57) **CLAIM**

I claim the ornamental design for a golf club holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a side elevational view showing the gold club holder as being used on a green; the broken line showing is for illustrative purposes only and forms no part of the claimed design.

FIG. 2 is an enlarged perspective view;

FIG. 3 is a front elevational view of FIG. 2, the undisclosed opposite side being a mirror image;

FIG. 4 is a left side elevational view of FIG. 2, the undisclosed opposite side being identical;

FIG. 5 is a top plan view of FIG. 2; and,

FIG. 6 is a bottom plan view of FIG. 2.

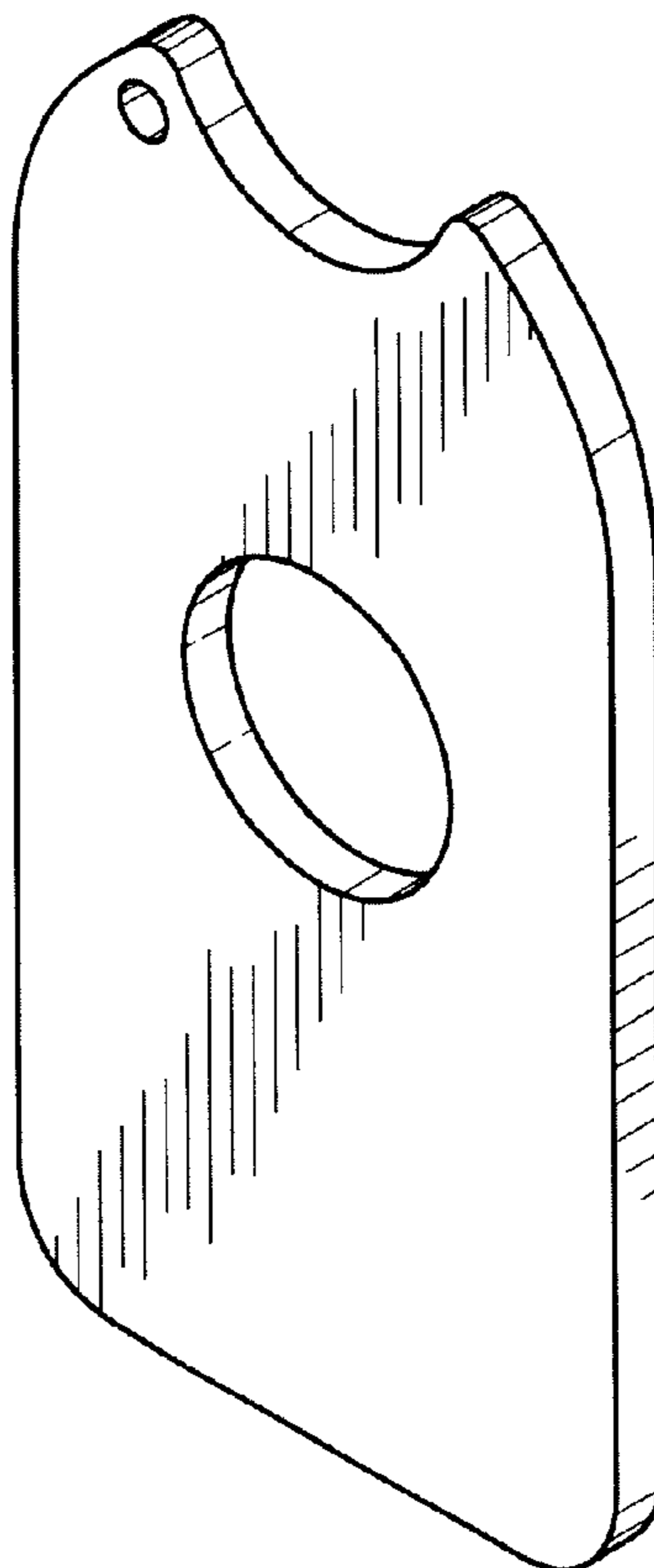

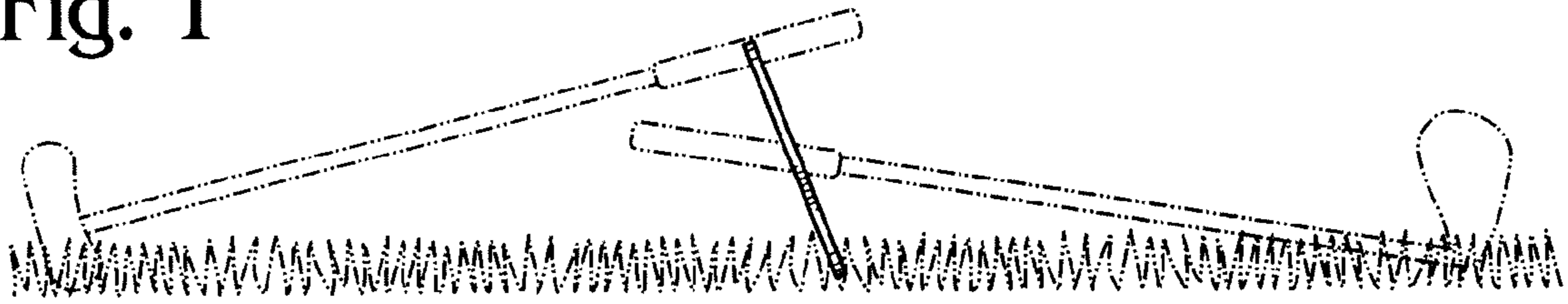

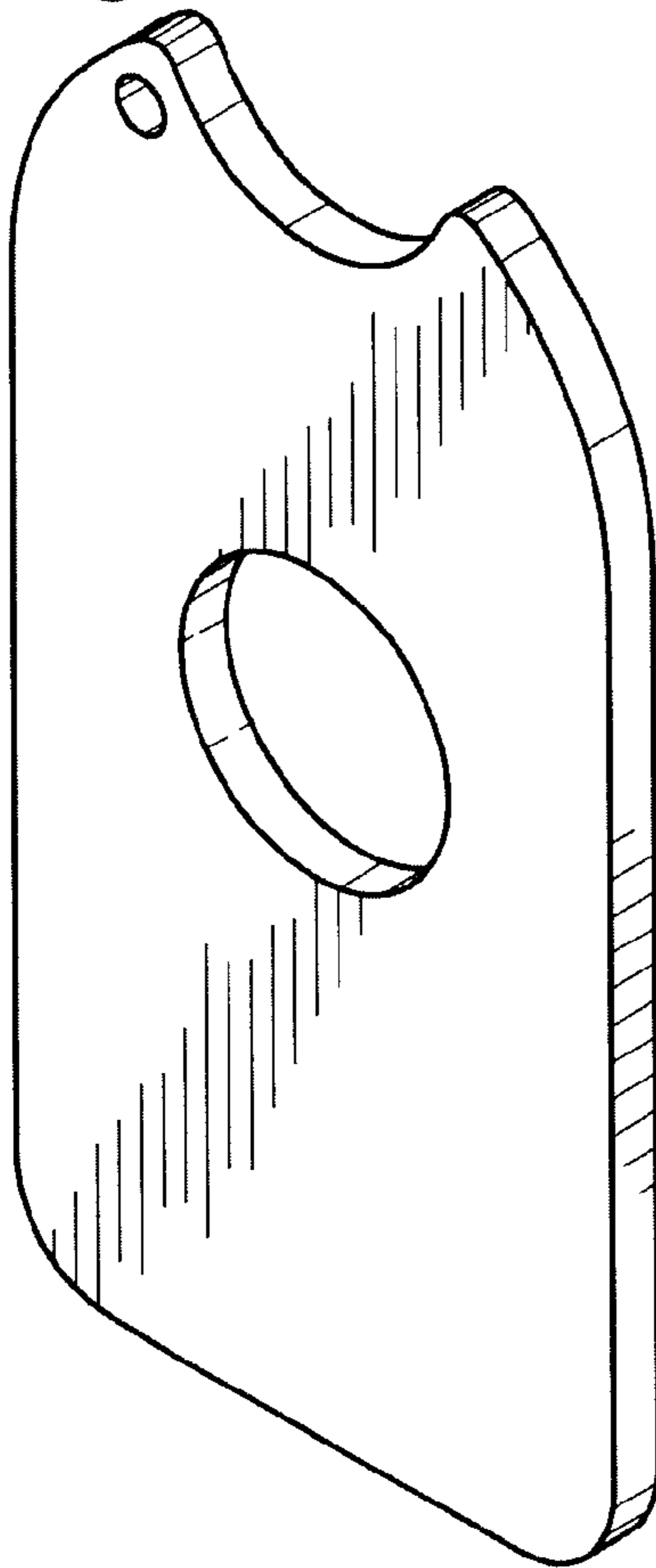

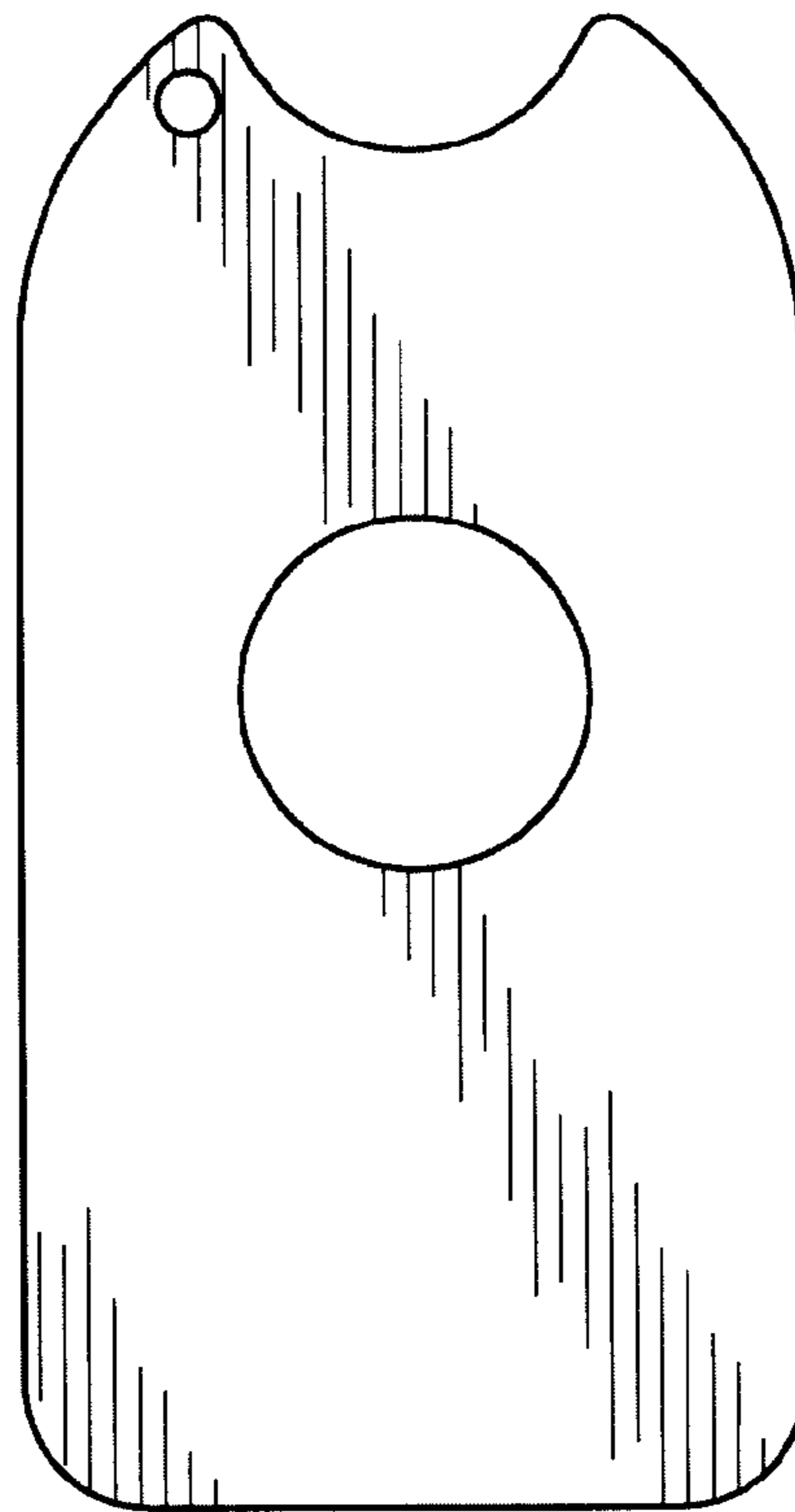
