The ornamental design for an inflatable canopy lounge, as shown and described.

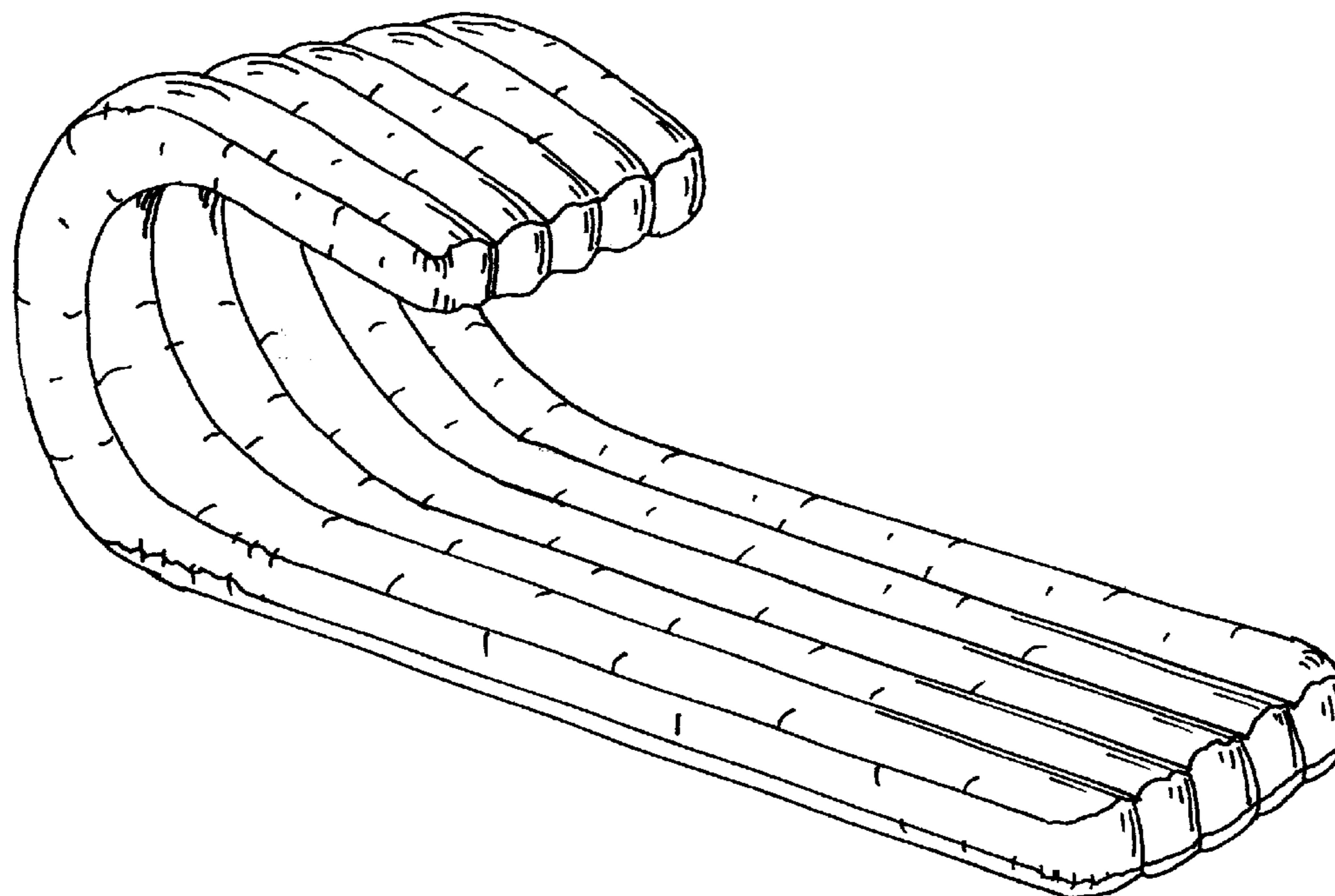
DESCRIPTION

FIG. 1 is a perspective view of the inflatable canopy lounge showing my new design;
FIG. 2 is a left side elevational view thereof, the right side elevational view being a mirror image of FIG. 2;

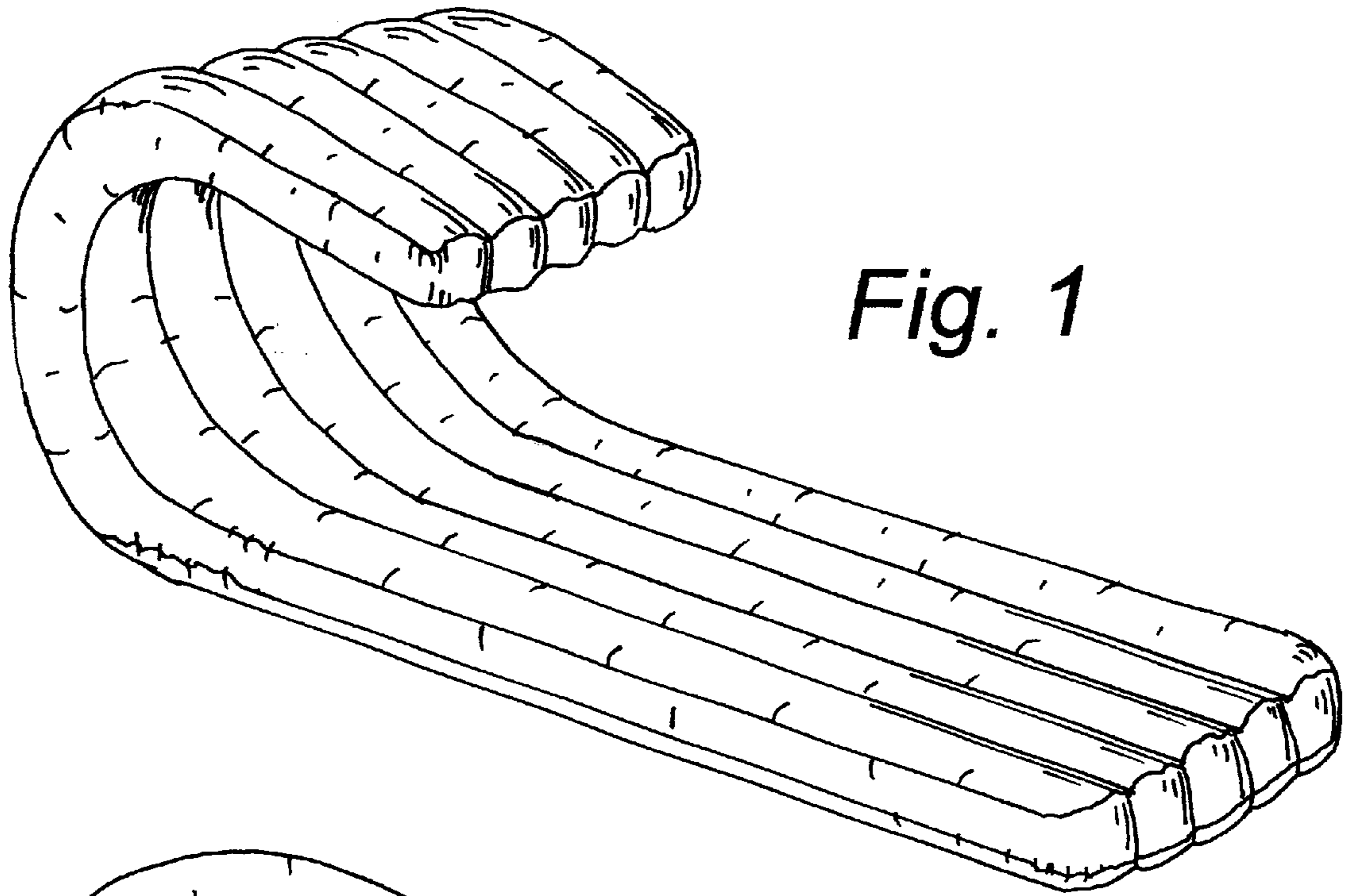

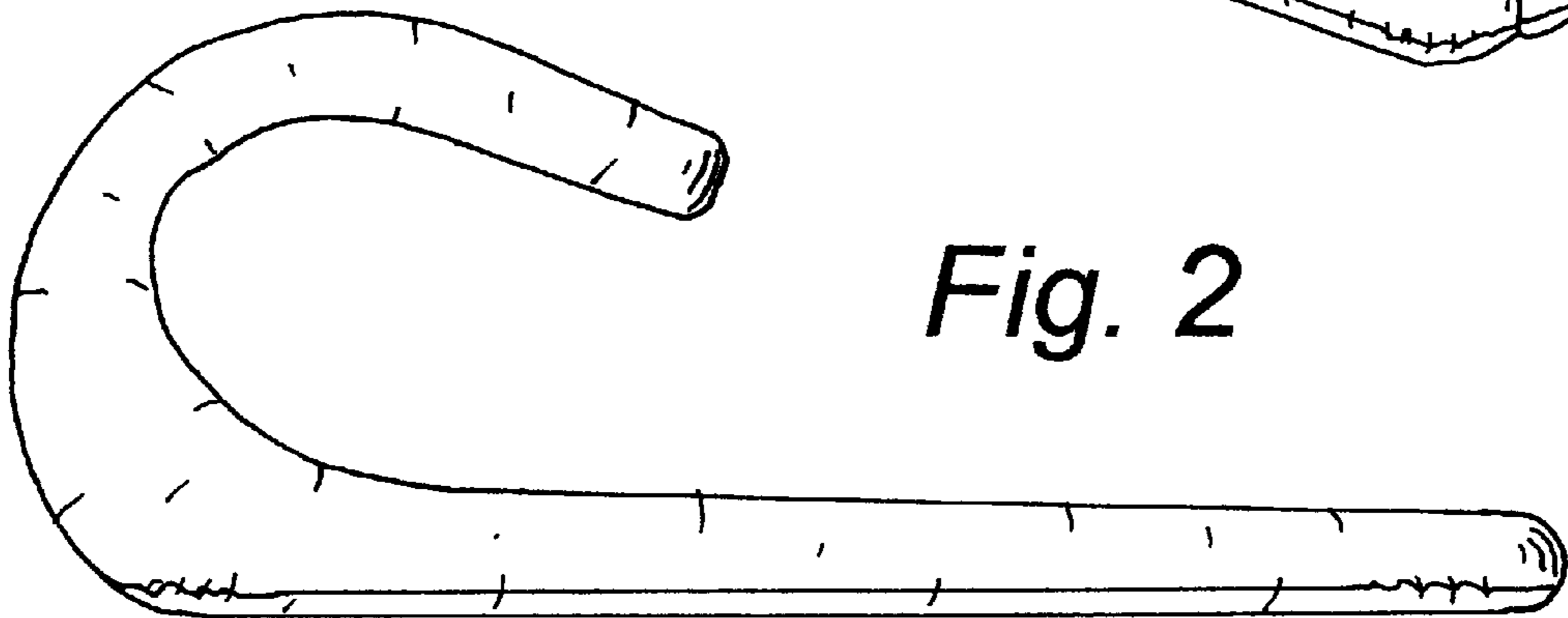

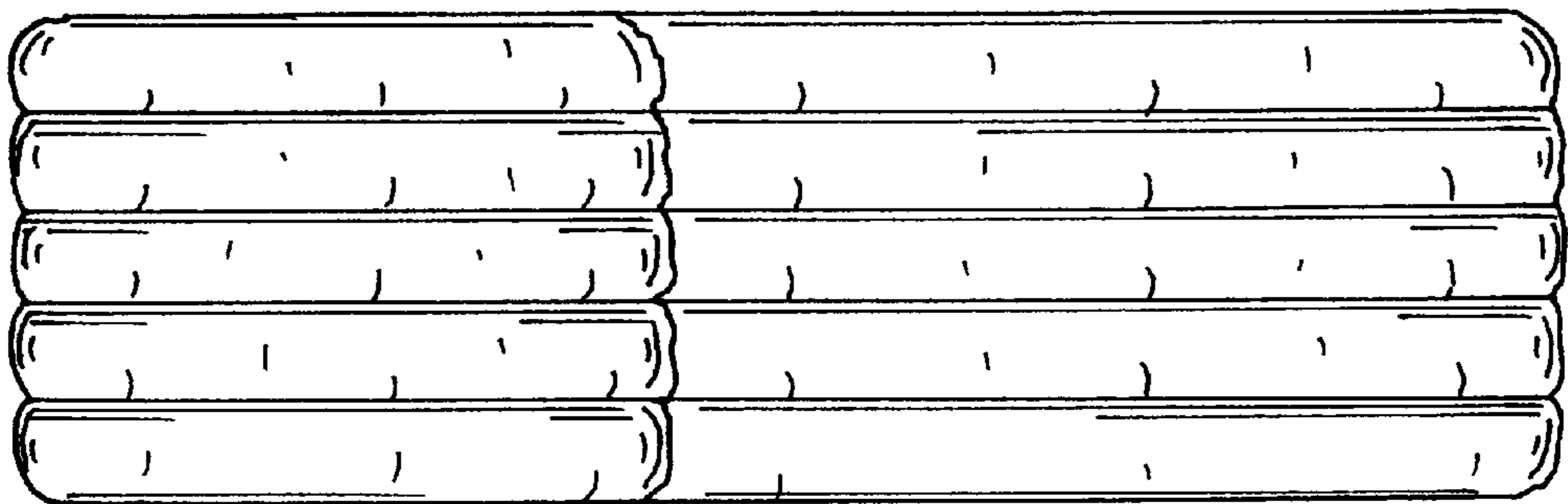

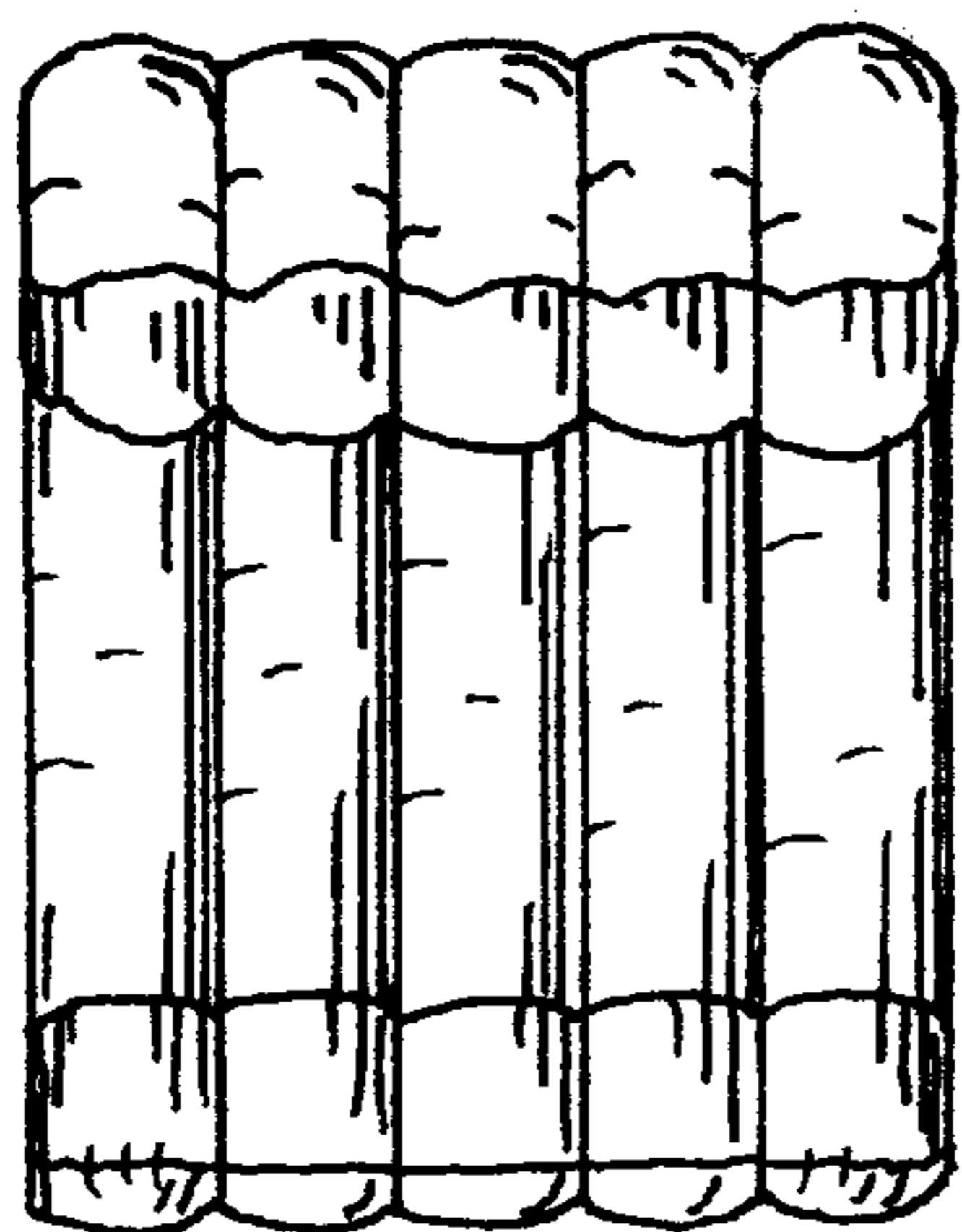

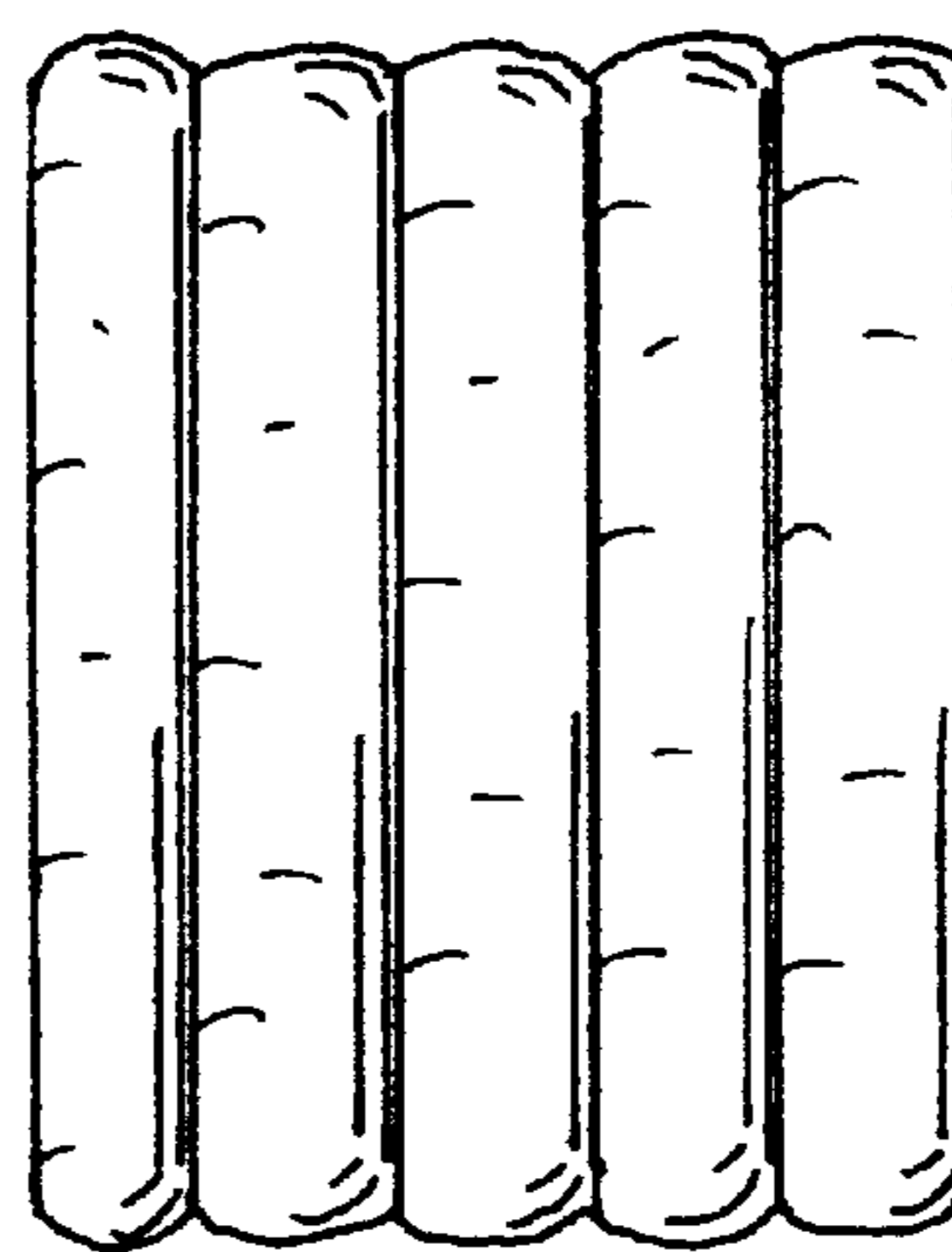

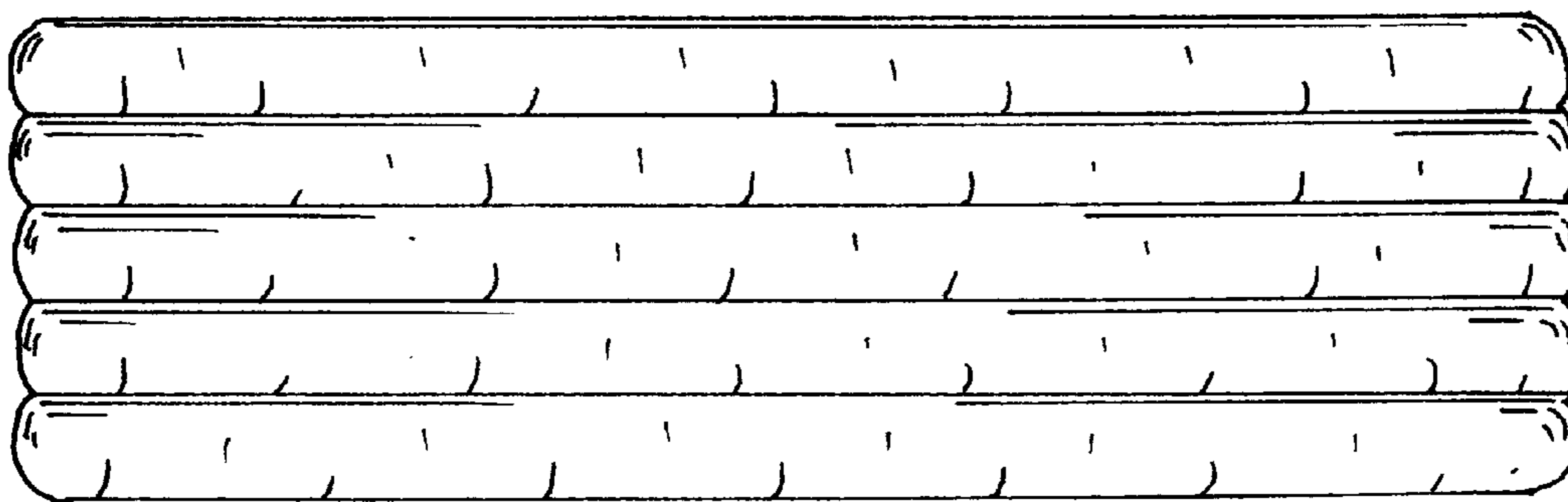
