The ornamental design for a spiral slide, as shown and described.

**DESCRIPTION**

FIG. 4 is an elevation view of the front side thereof;

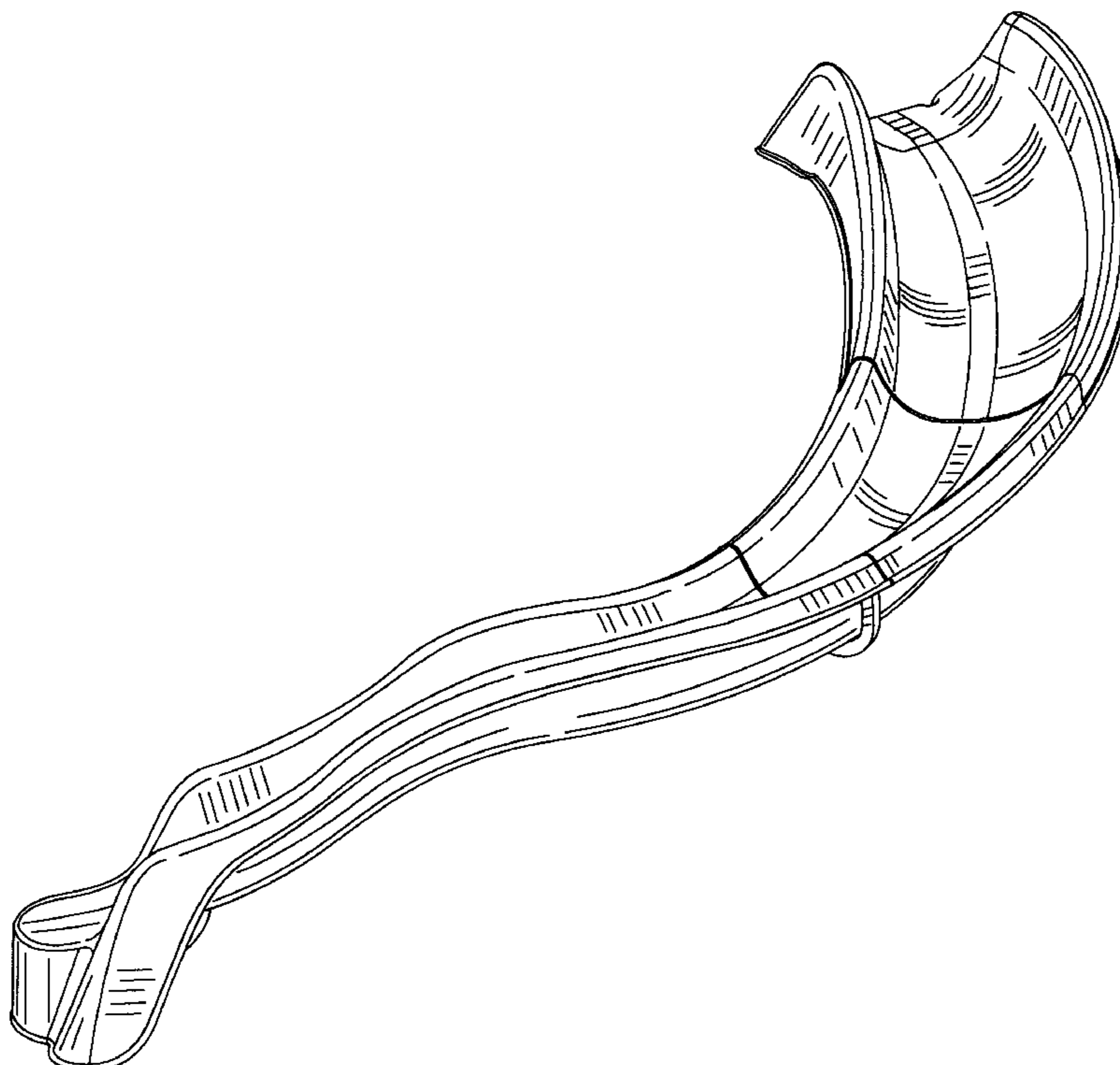
FIG. 5 is an elevation view of the left side thereof;

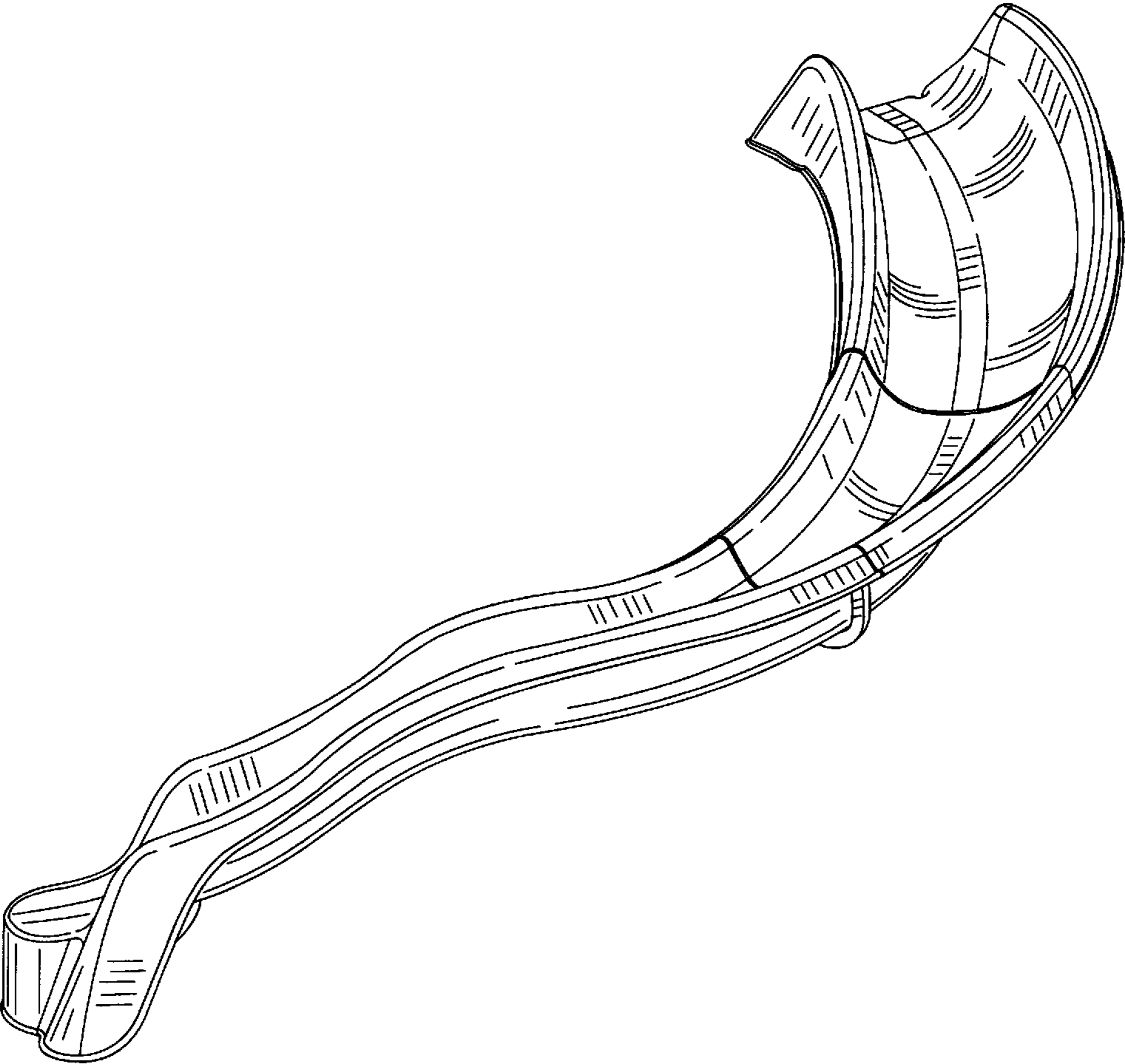
FIG. 6 is an elevation view of the rear side thereof;

FIG. 7 is a top view thereof; and,

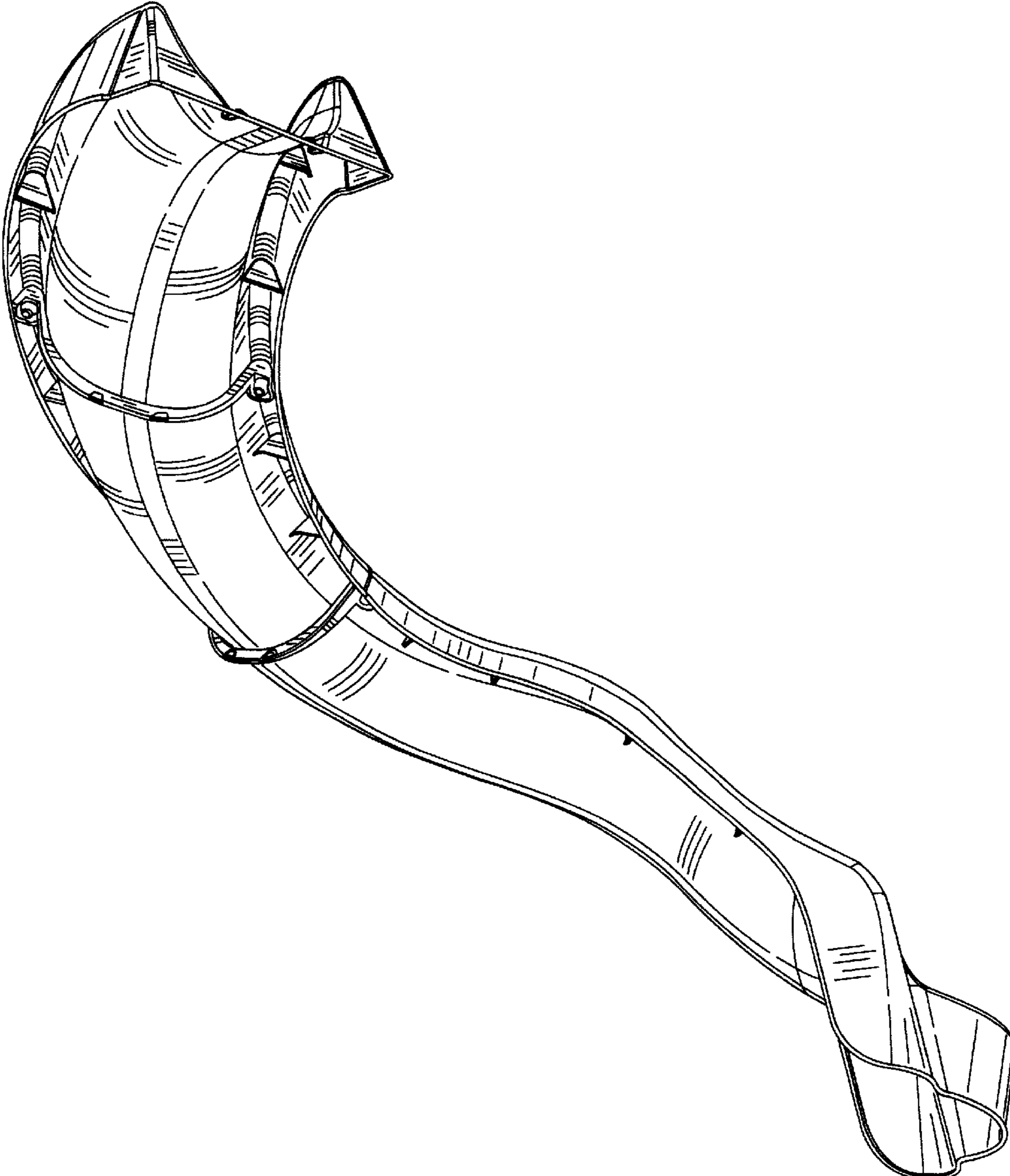
FIG. 8 is a bottom view thereof.

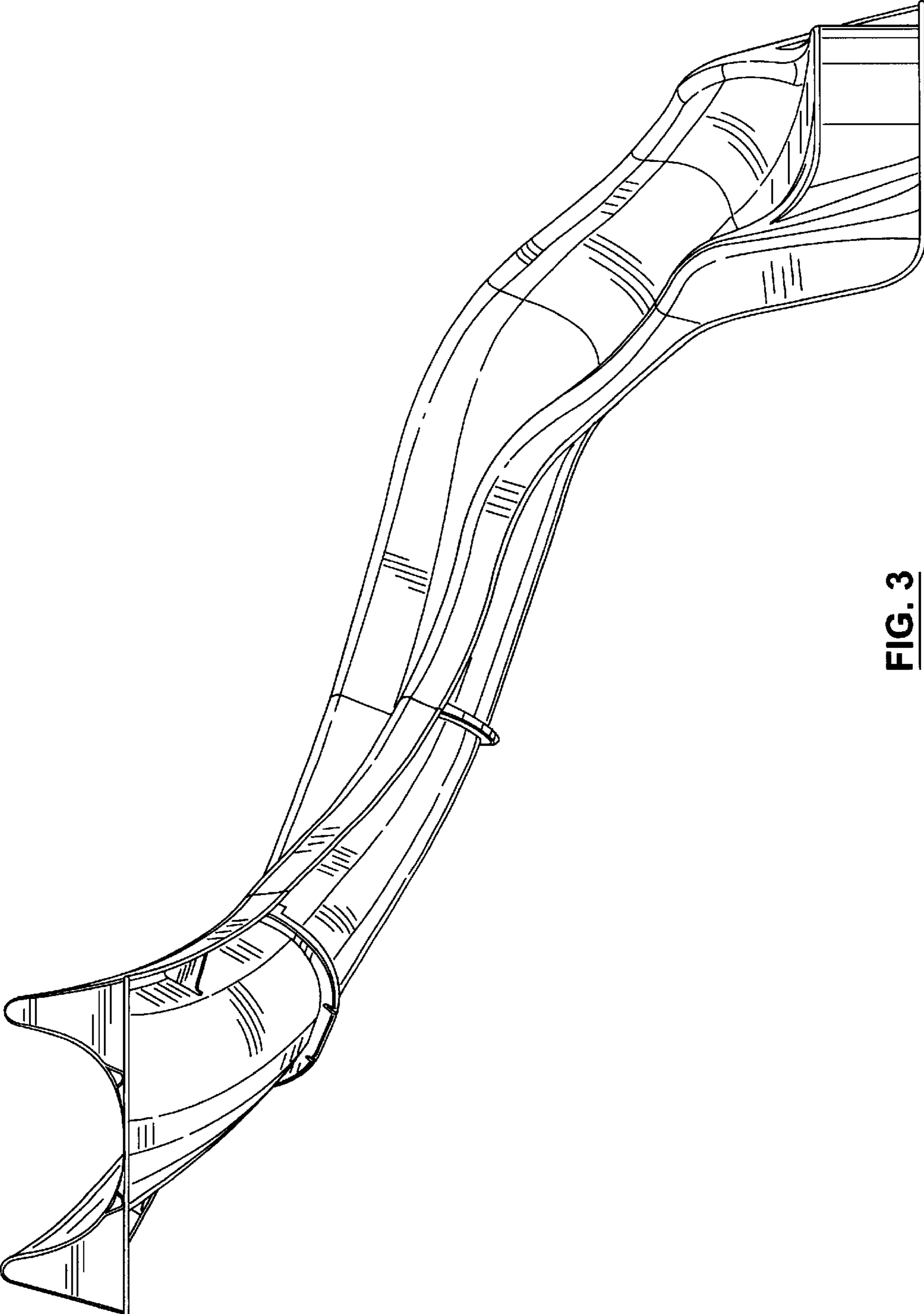




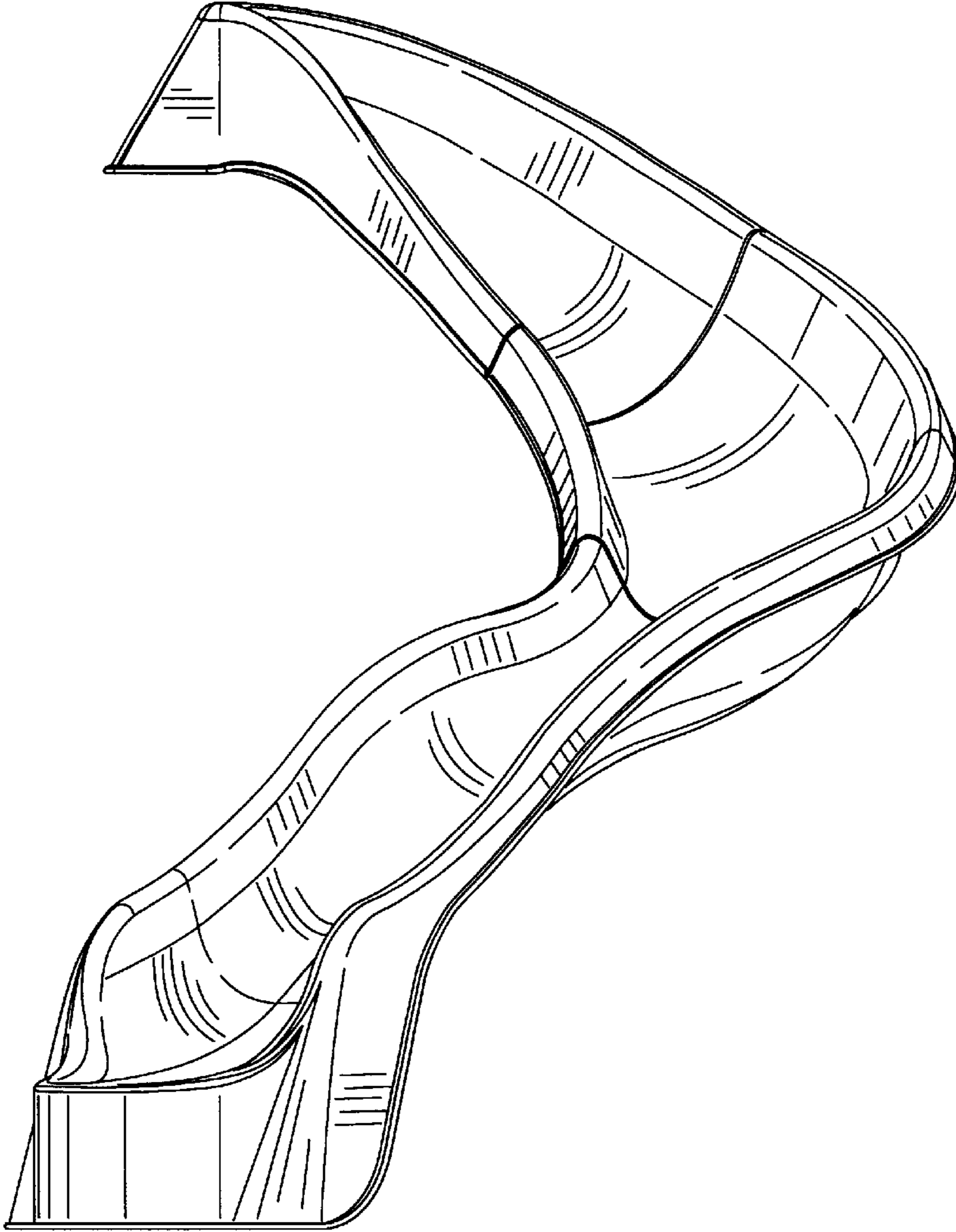

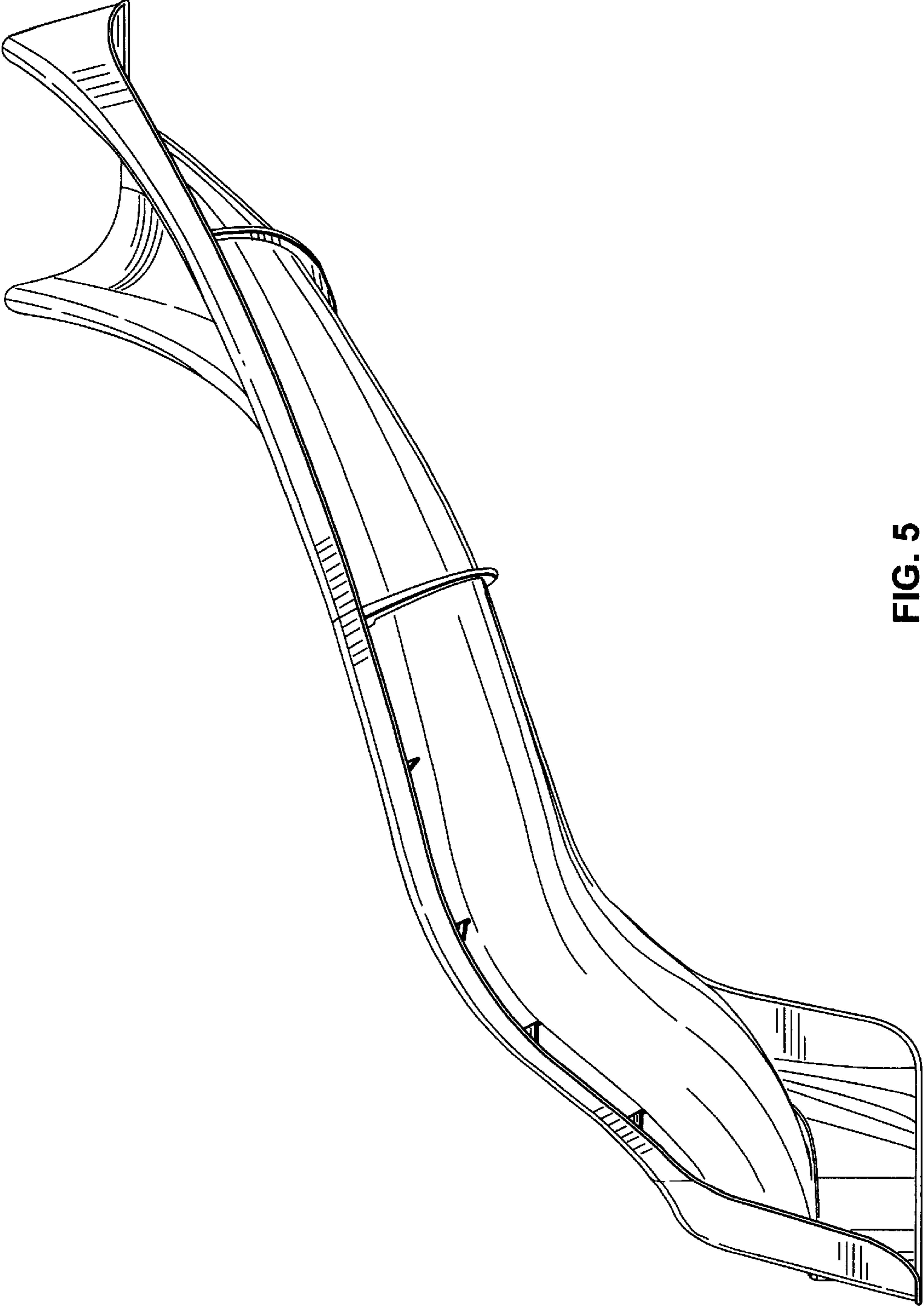

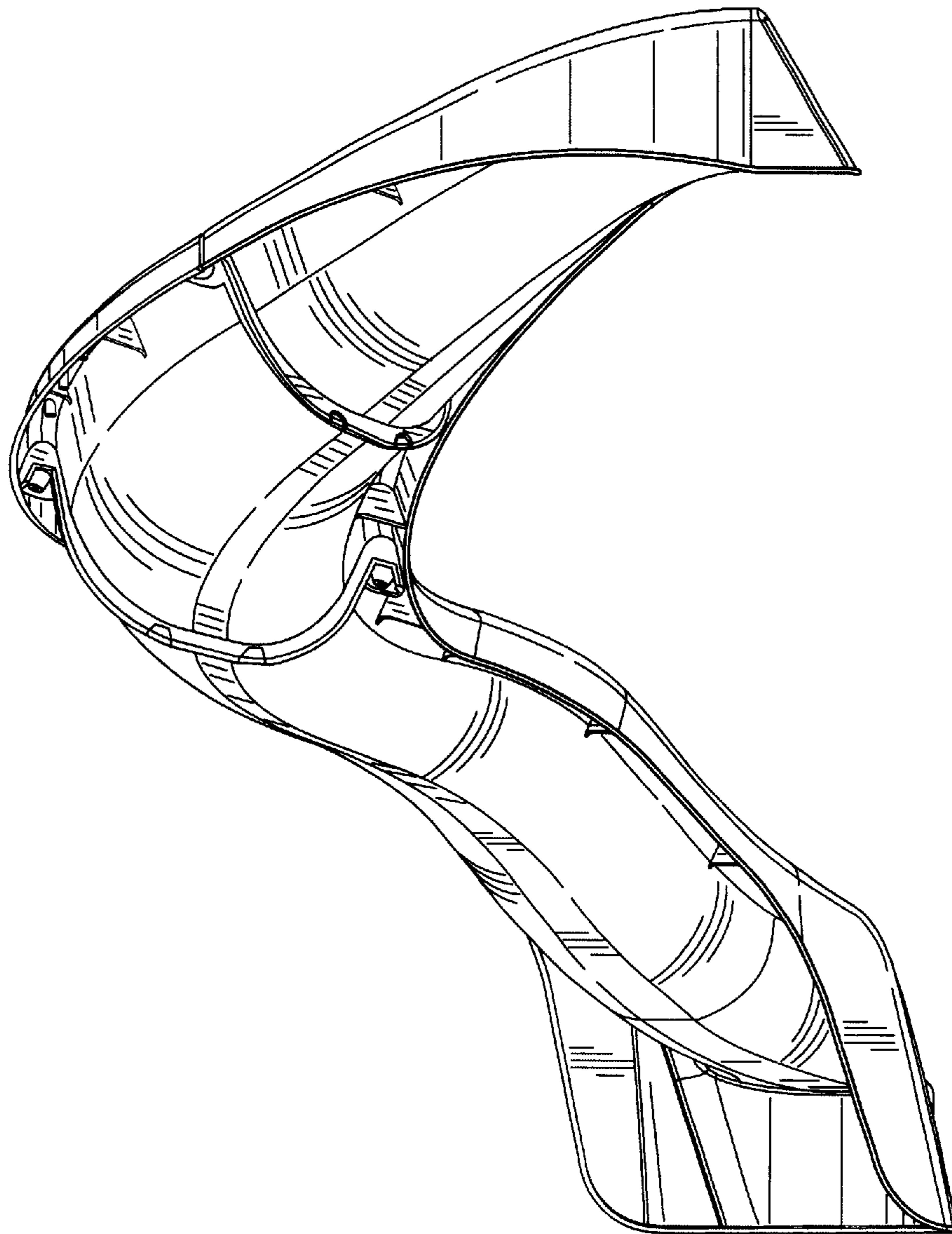

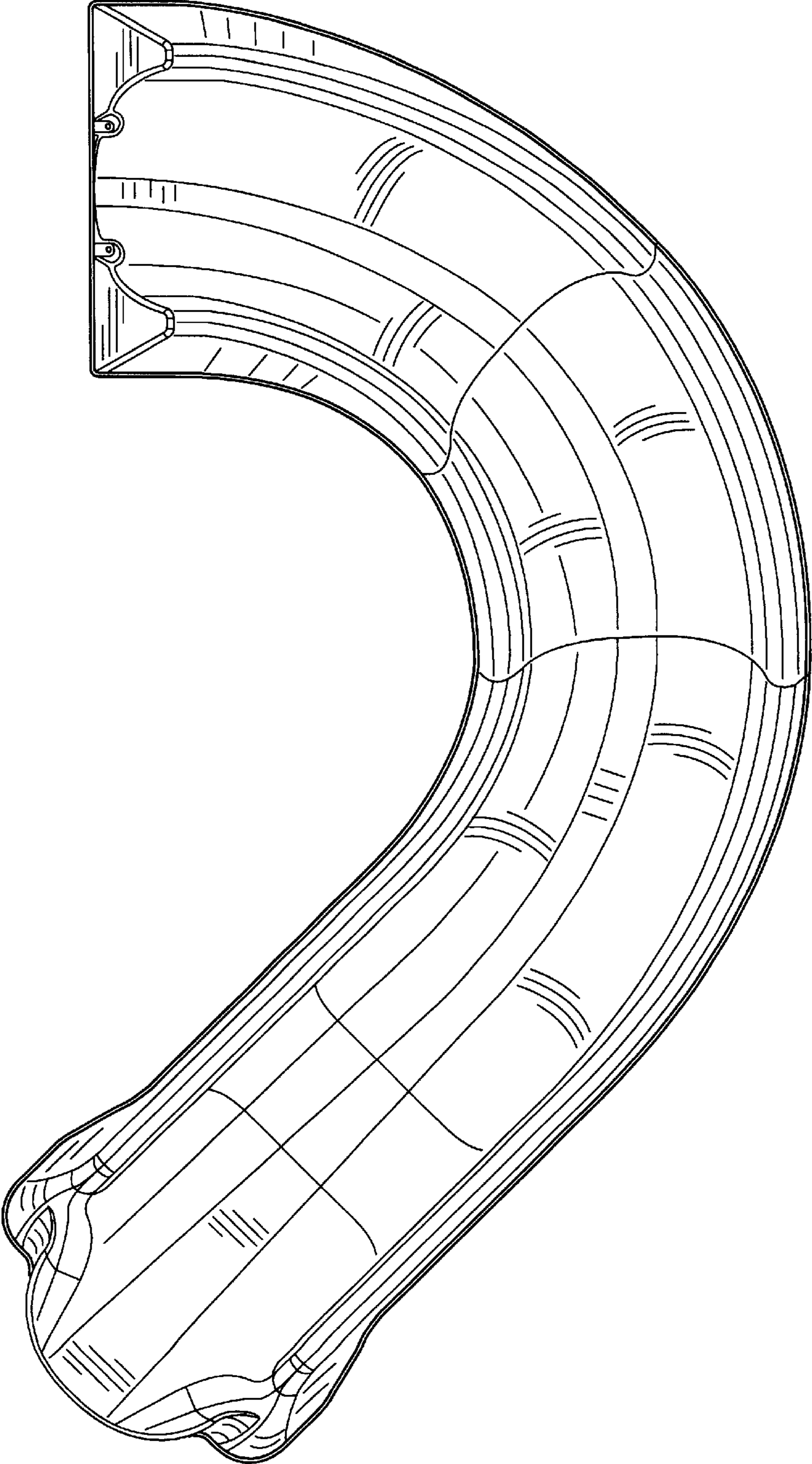

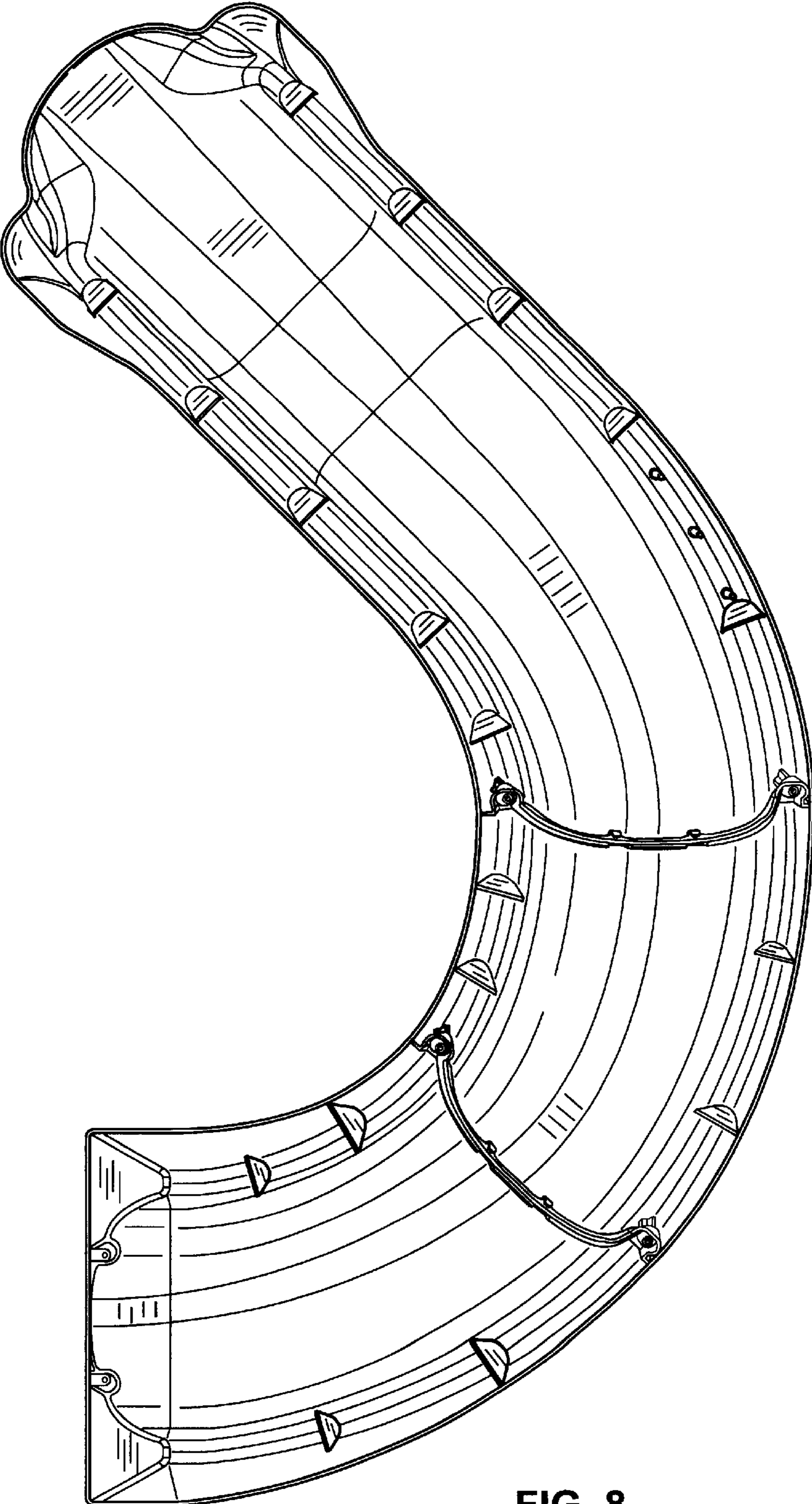
