DESCRIPTION

FIG. 1 is a top perspective view of a gun magazine entrance guide showing my new design;

FIG. 2 is a top plan view of the gun magazine entrance guide shown in FIG. 1;

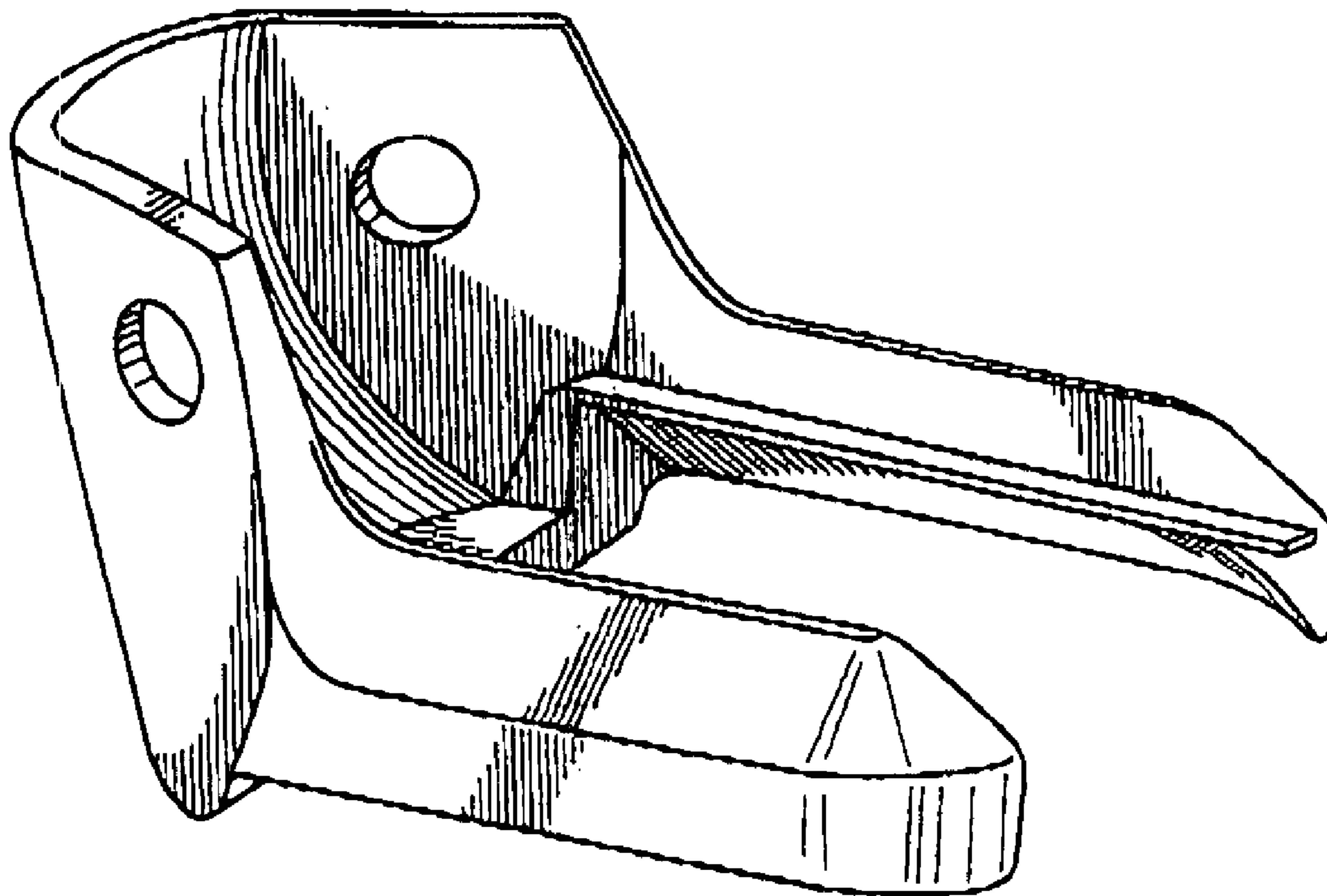
FIG. 3 is a bottom plan view of the gun magazine entrance guide shown in FIG. 1;

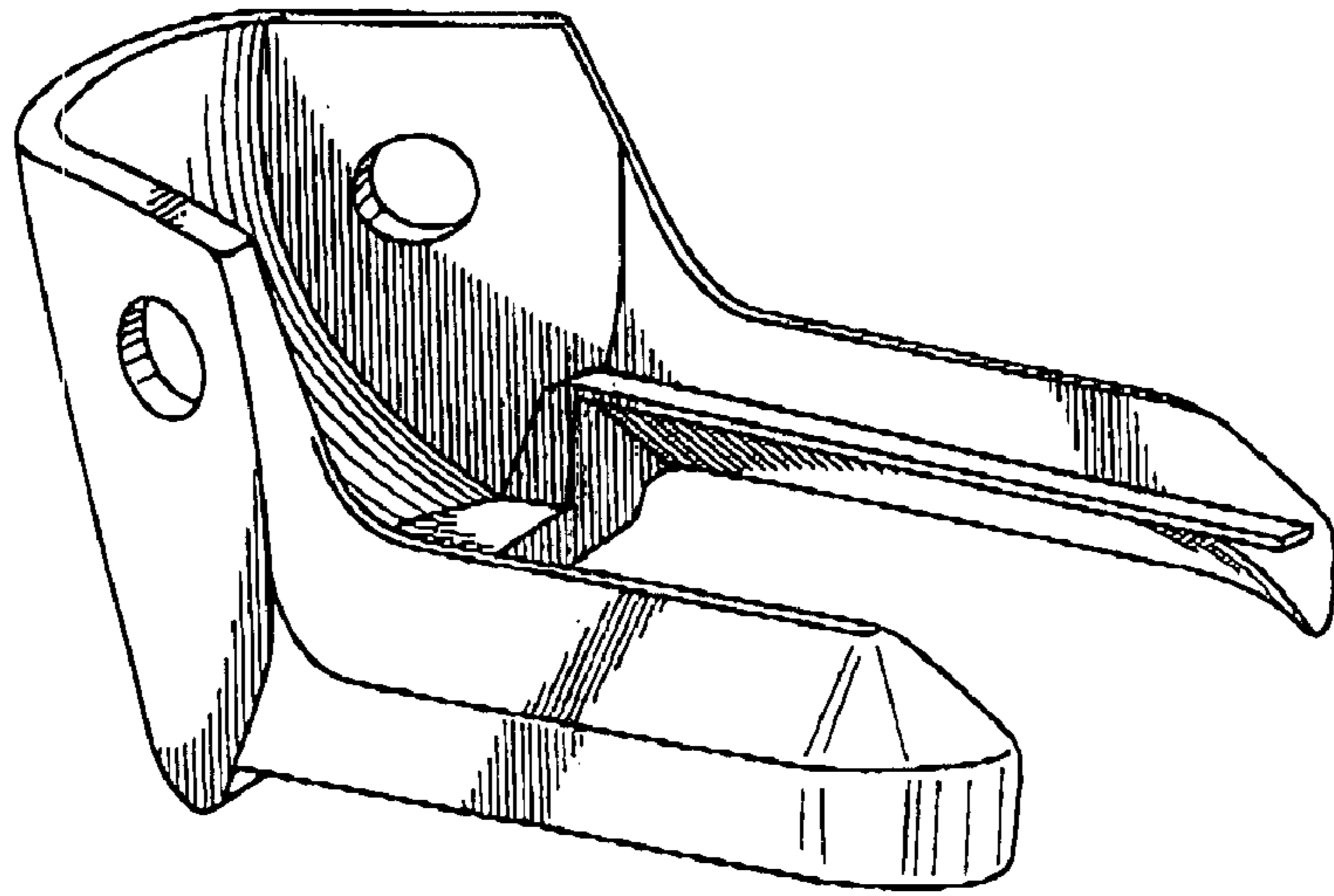

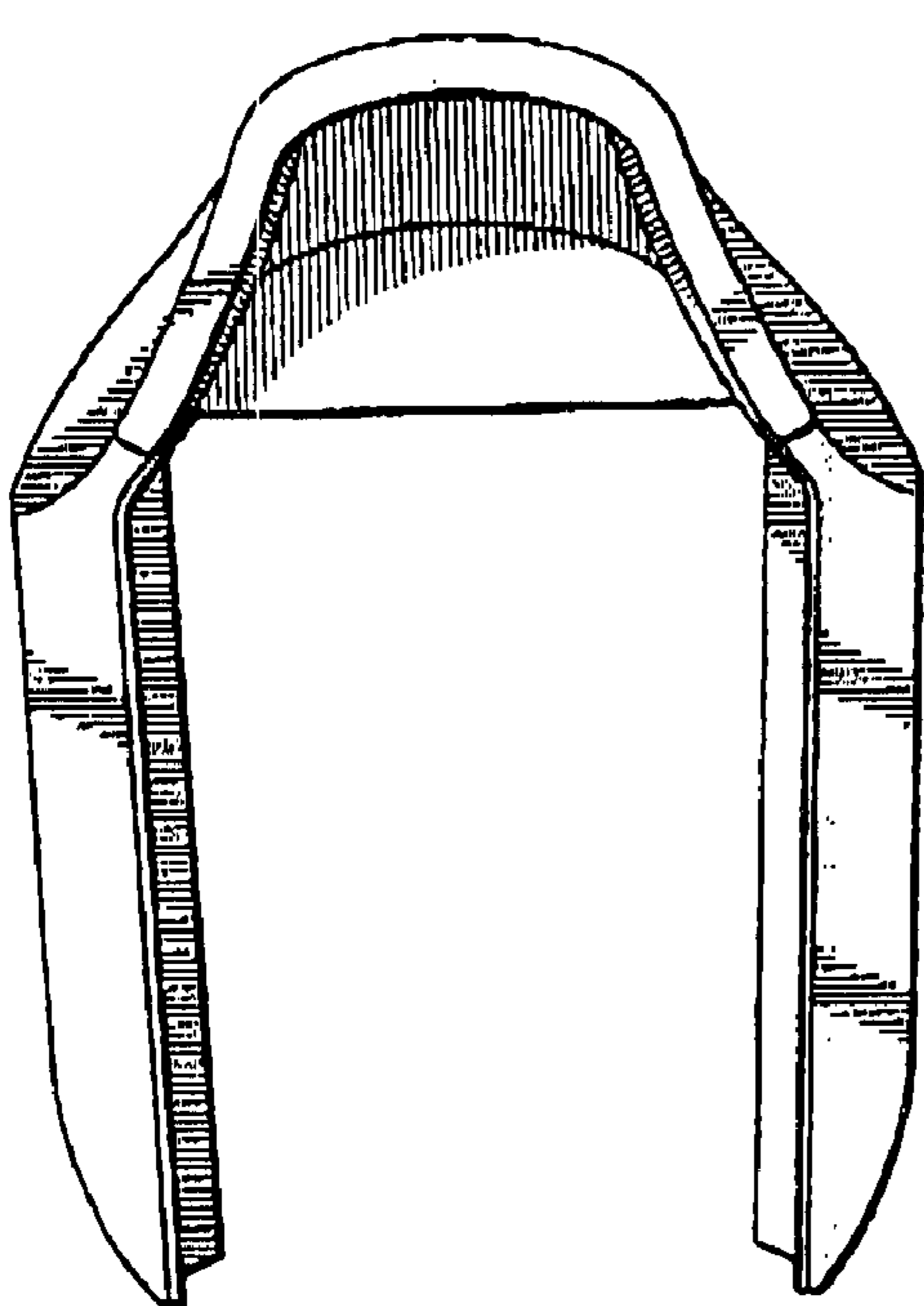

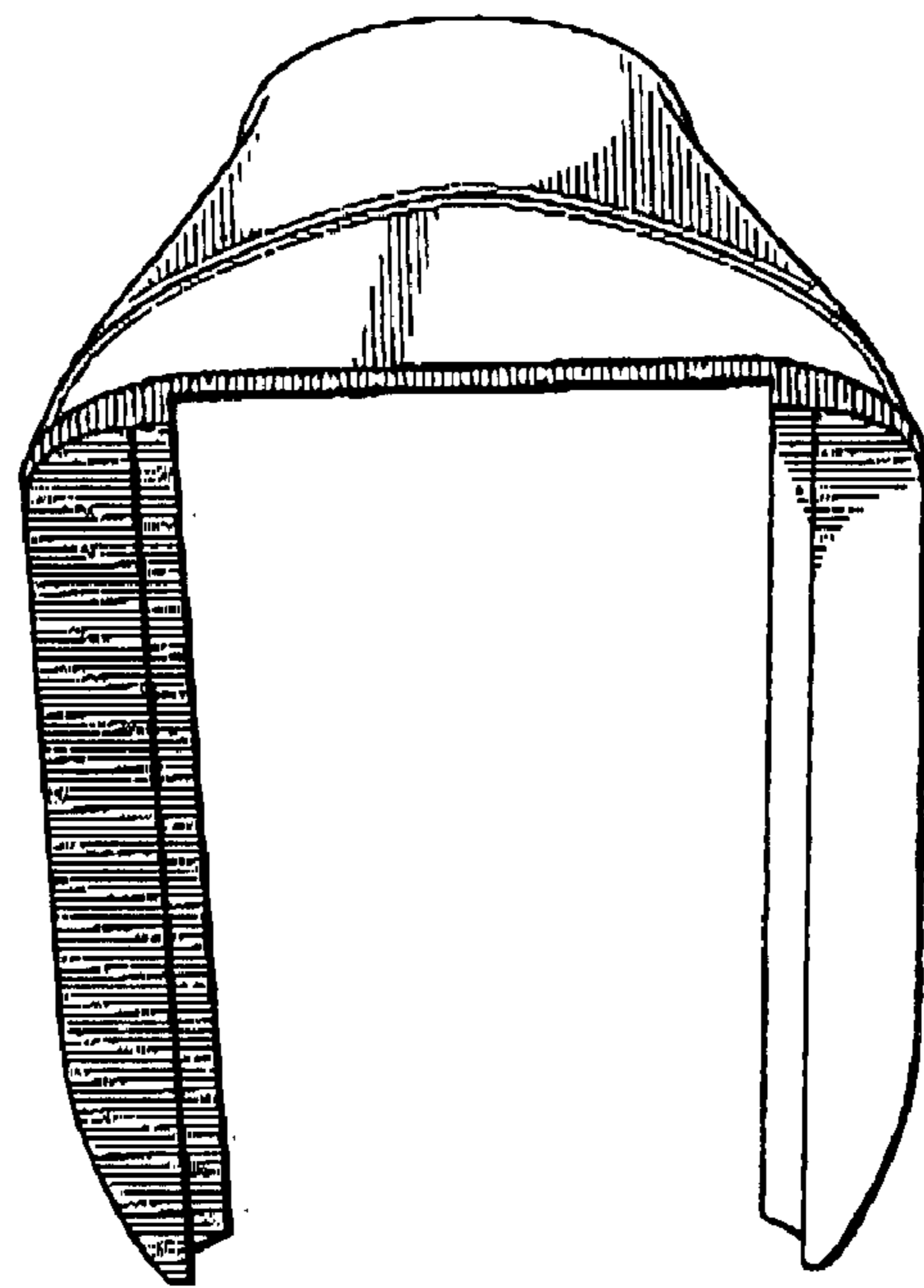

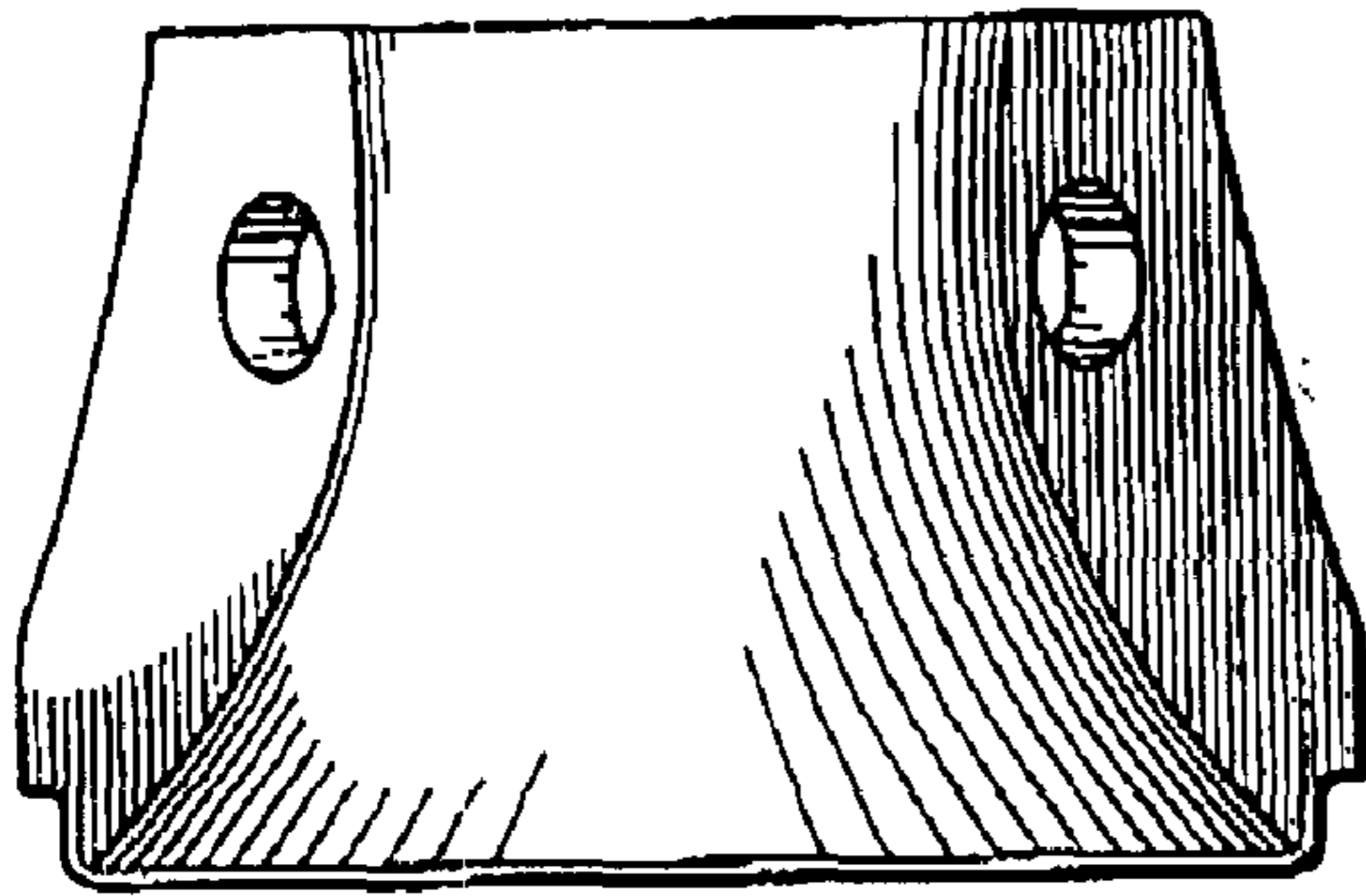

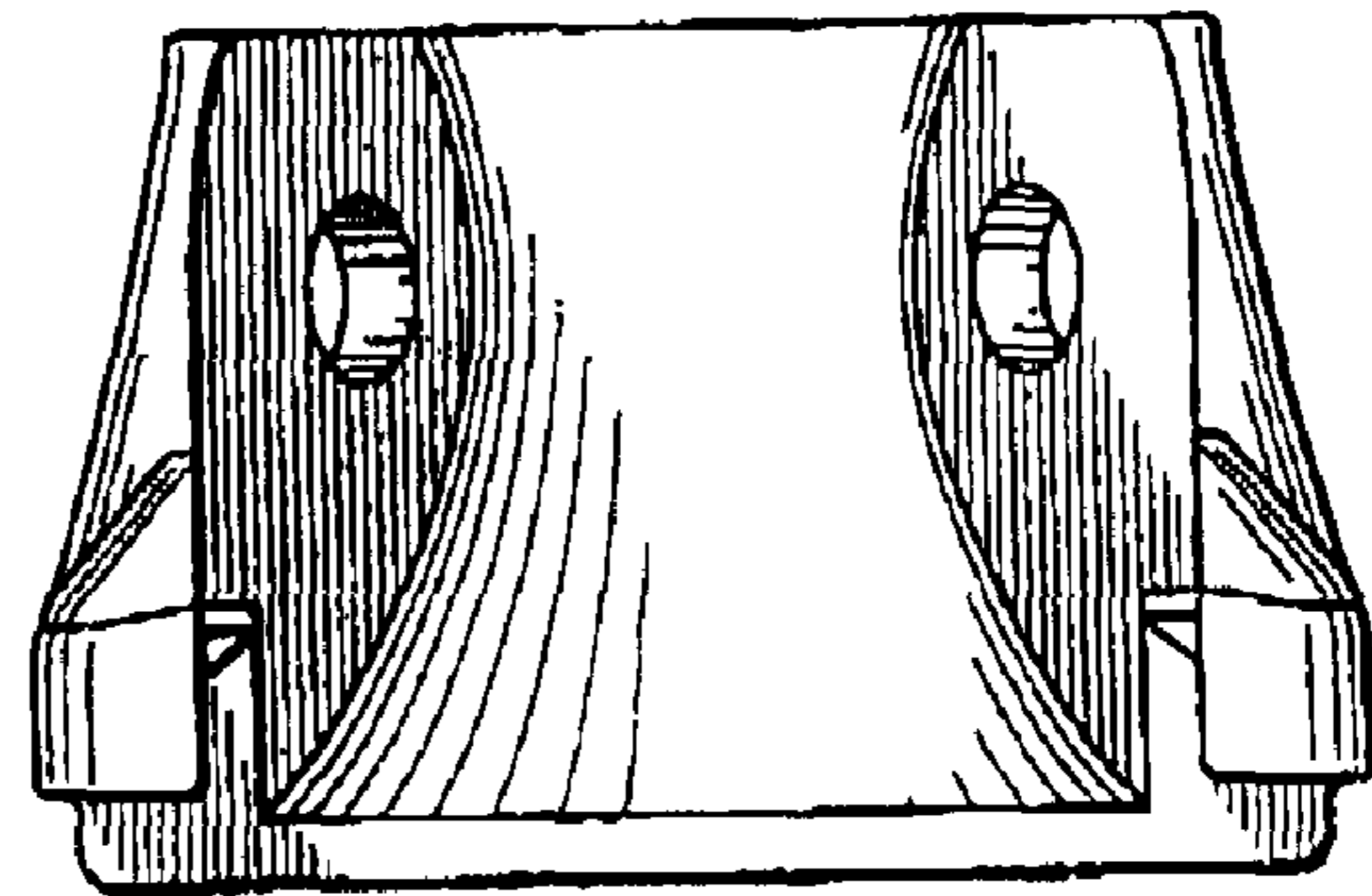

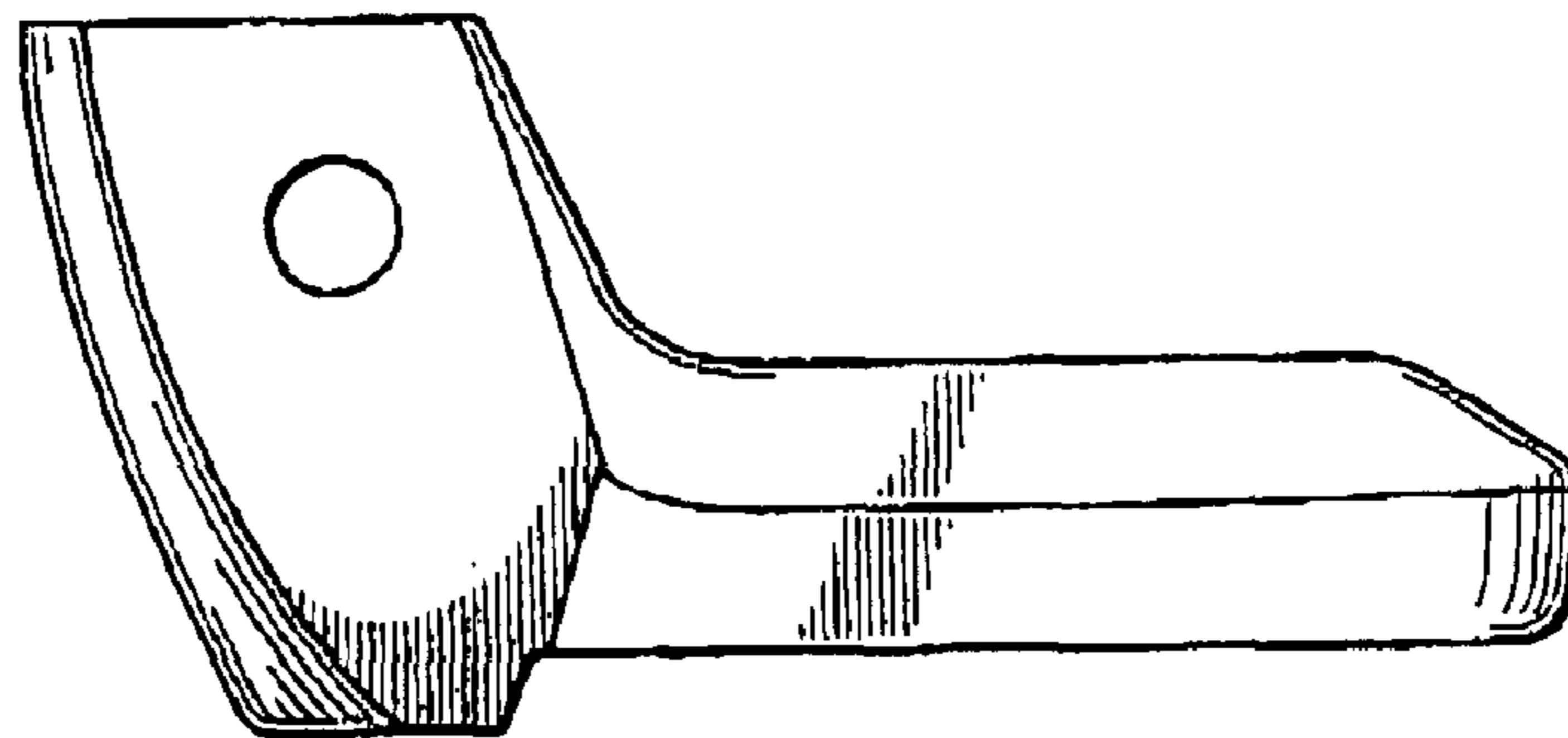
