(57) **CLAIM**

The ornamental design for a sphygmomanometer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view illustrating a first embodiment of our new design for a sphygmomanometer;

FIG. 2 is a front elevational view of the sphygmomanometer of FIG. 1;

FIG. 3 is a rear elevational view of the sphygmomanometer of FIG. 1;

FIG. 4 is a top plan view of the sphygmomanometer of FIG. 1;

FIG. 5 is a bottom plan view of the sphygmomanometer of FIG. 1;

FIG. 6 is a right side elevational view of the sphygmomanometer of FIG. 1;

FIG. 7 is a left side elevational view of the sphygmomanometer of FIG. 1;

FIG. 8 is a top plan view of the sphygmomanometer of FIG. 6 according to reference arrow 8 of FIG. 6;

FIG. 9 is a front perspective view of the sphygmomanometer of FIG. 1 with the armband opened;

FIG. 10 is a rear perspective view of the sphygmomanometer of FIG. 1 with the armband opened;

FIG. 11 is a front elevational view of the sphygmomanometer of FIG. 1 with the armband opened;

FIG. 12 is a rear elevational view of the sphygmomanometer of FIG. 1 with the armband opened;

FIG. 13 is a top plan view of the sphygmomanometer of FIG. 1 with the armband opened;

FIG. 14 is a bottom plan view of the sphygmomanometer of FIG. 1 with the armband opened;

FIG. 15 is a right side elevational view of the sphygmomanometer of FIG. 1 with the armband opened;

FIG. 16 is a left side elevational view of the sphygmomanometer of FIG. 1 with the armband opened; and,

FIG. 17 is a rear view of the sphygmomanometer of FIG. 15 according to reference arrow 15 of FIG. 15.

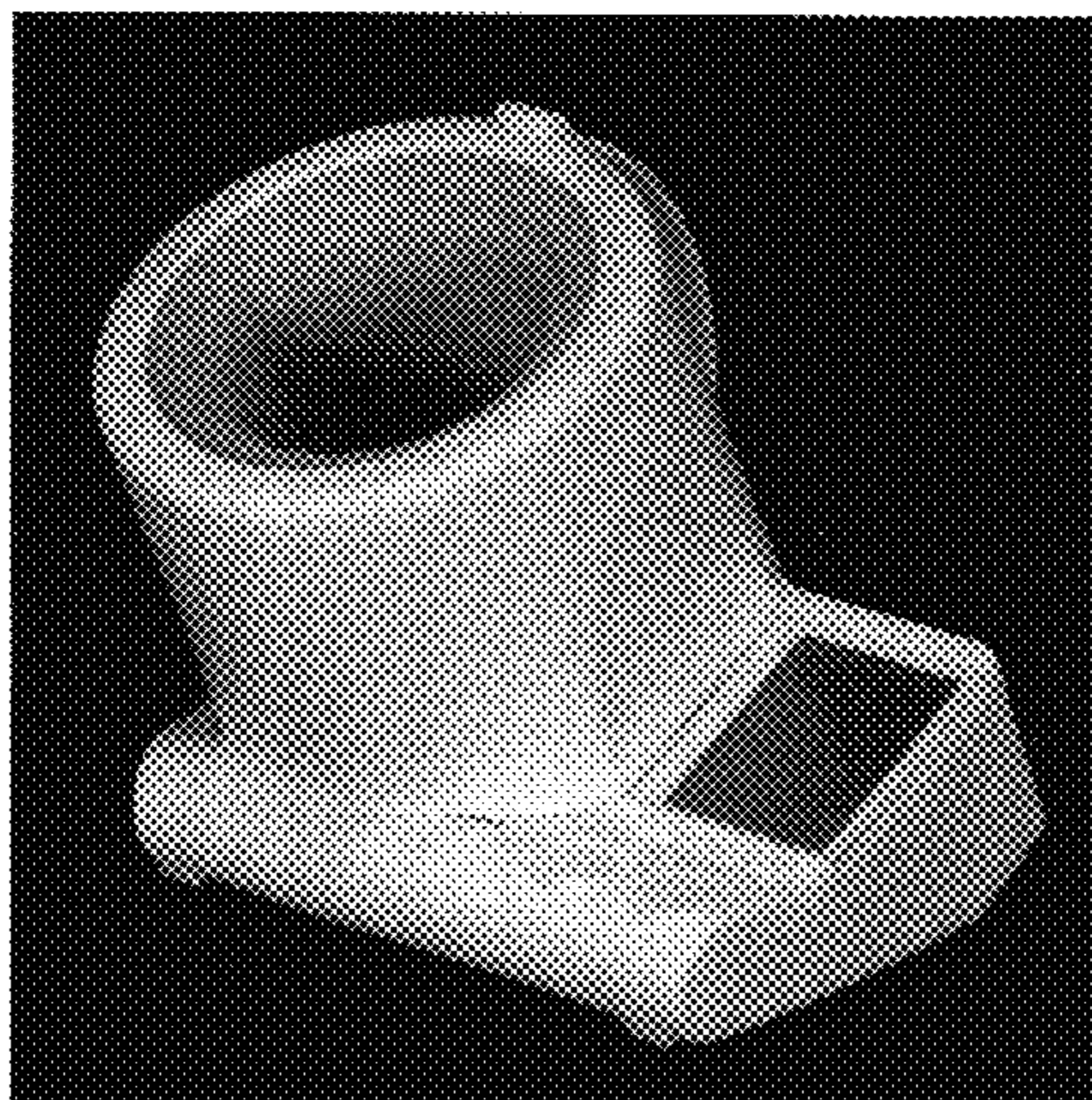

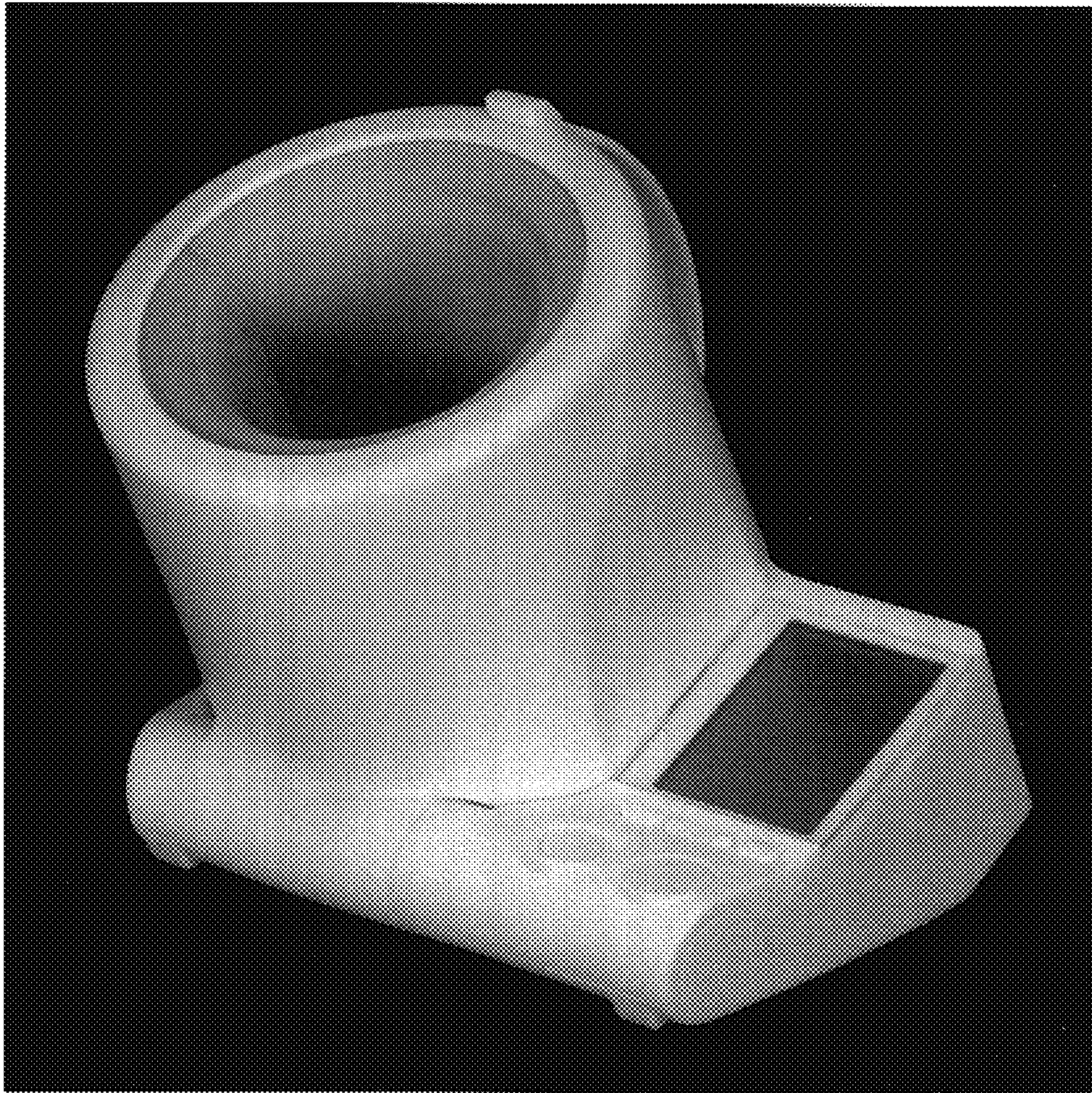

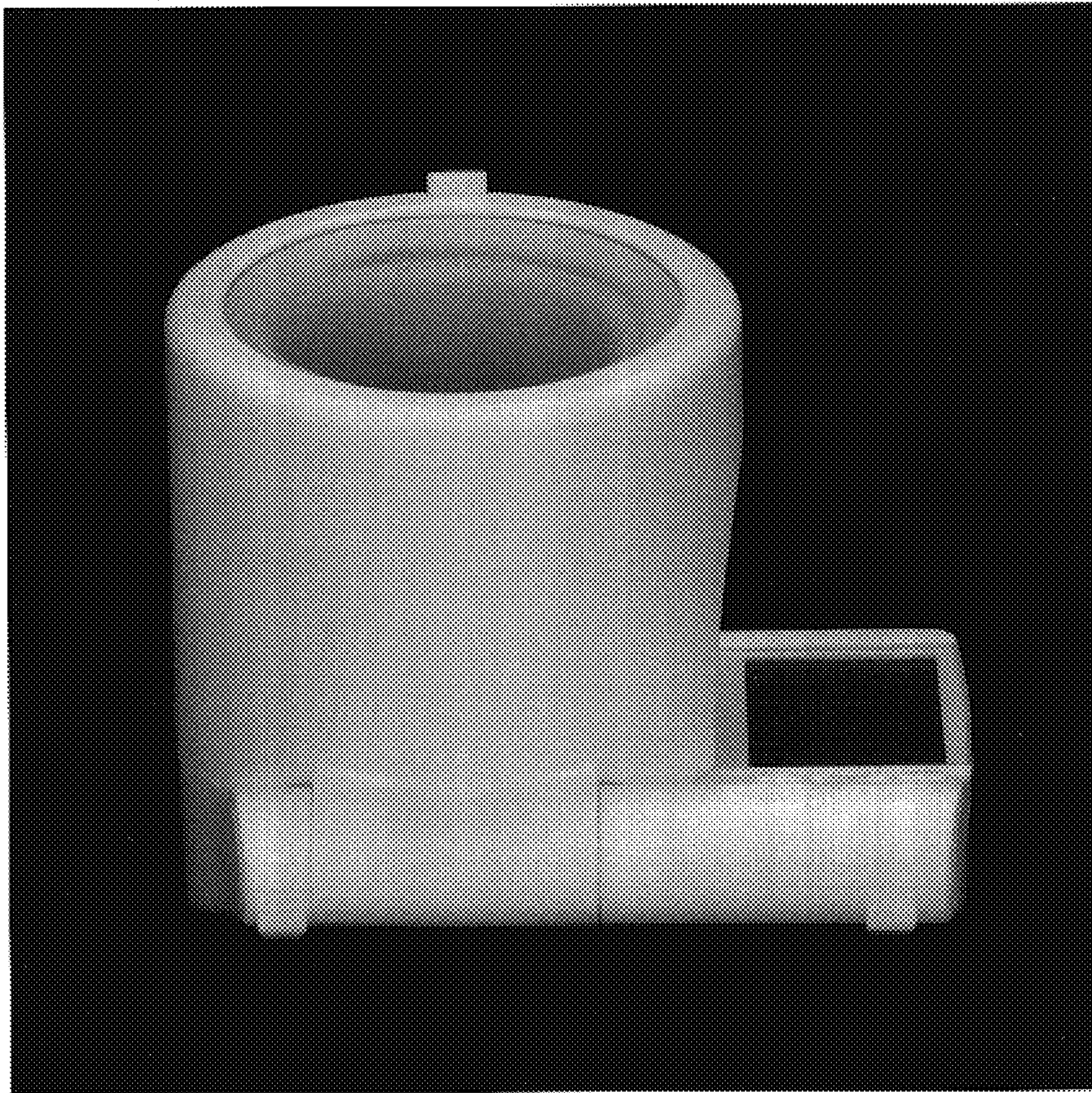

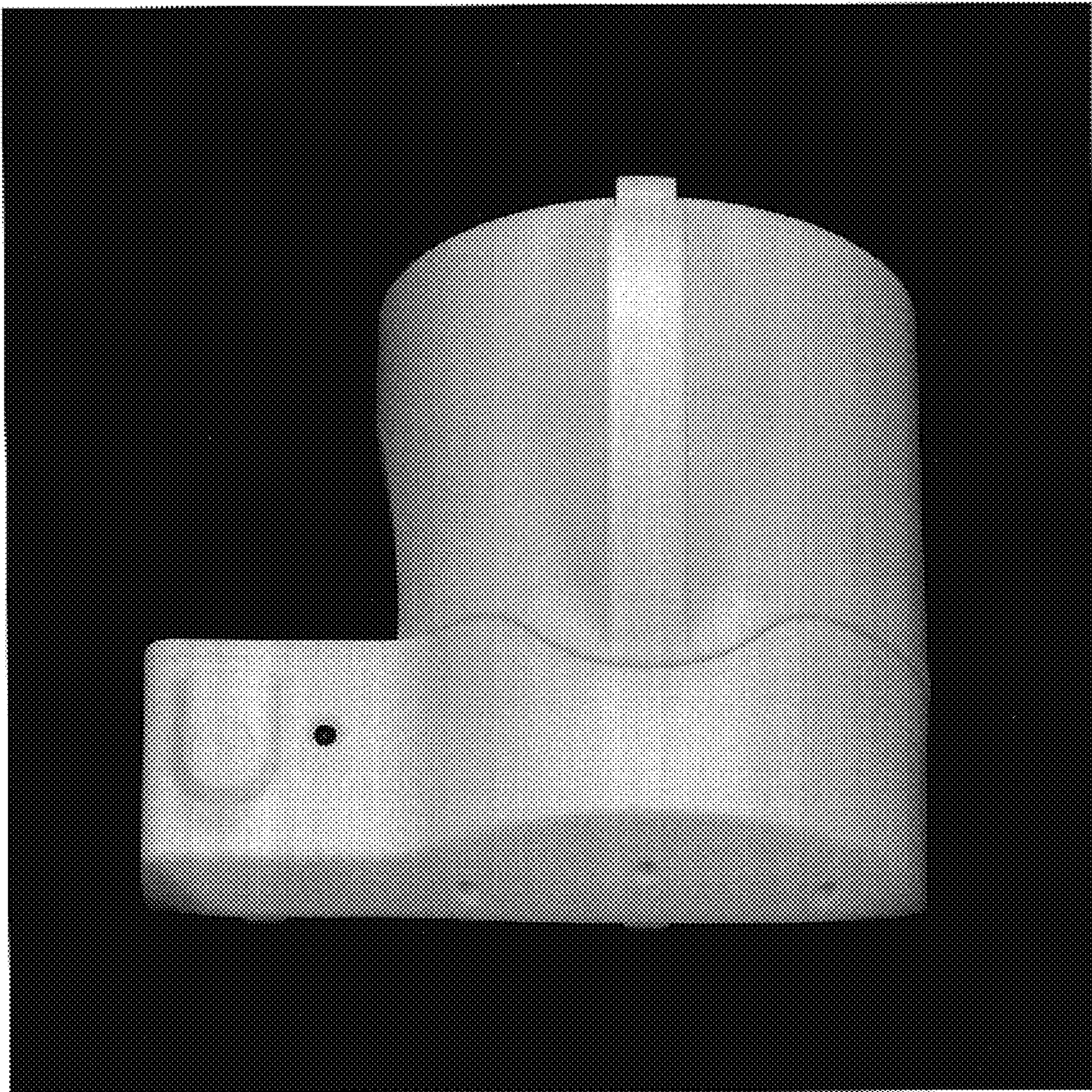

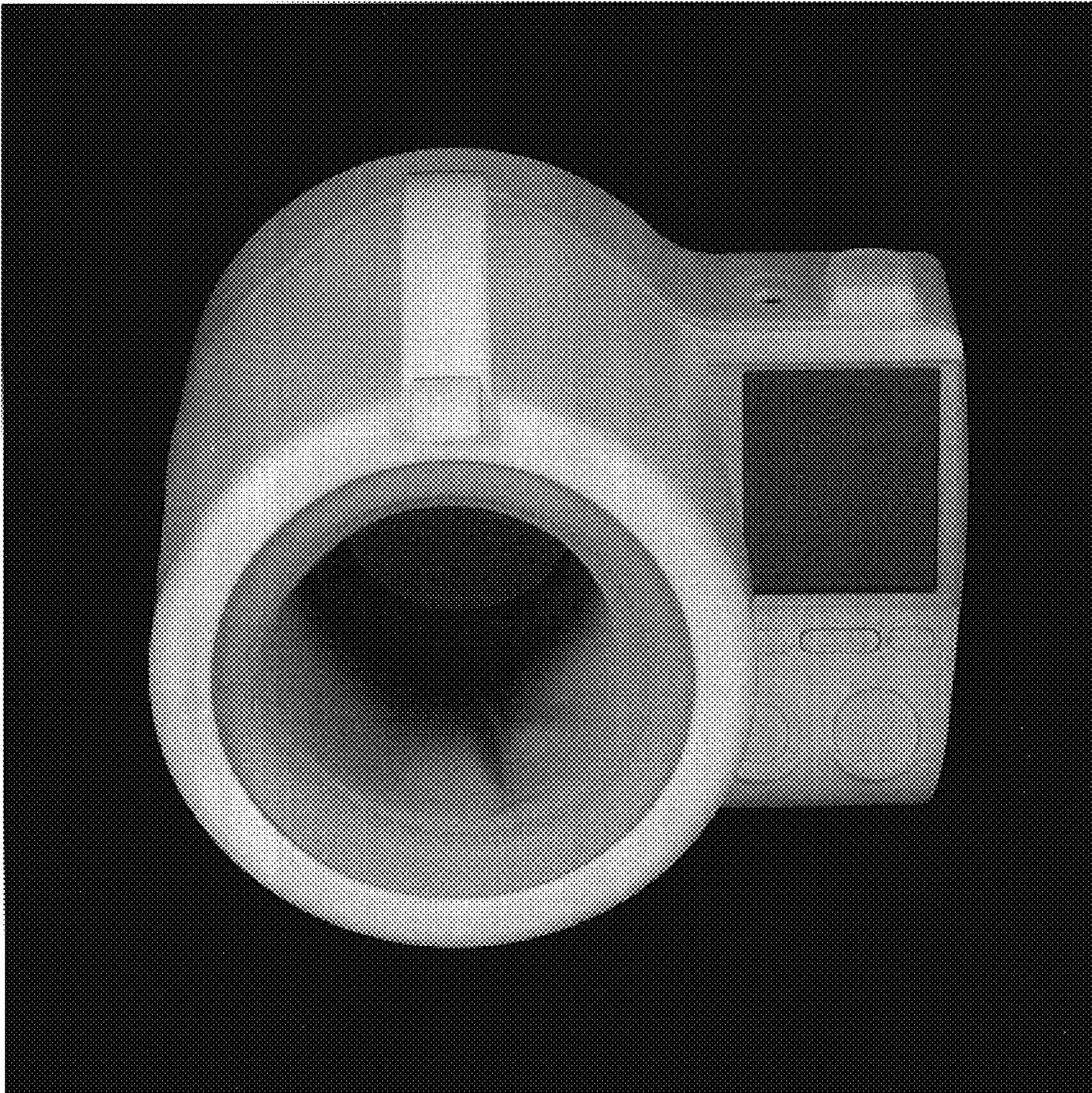

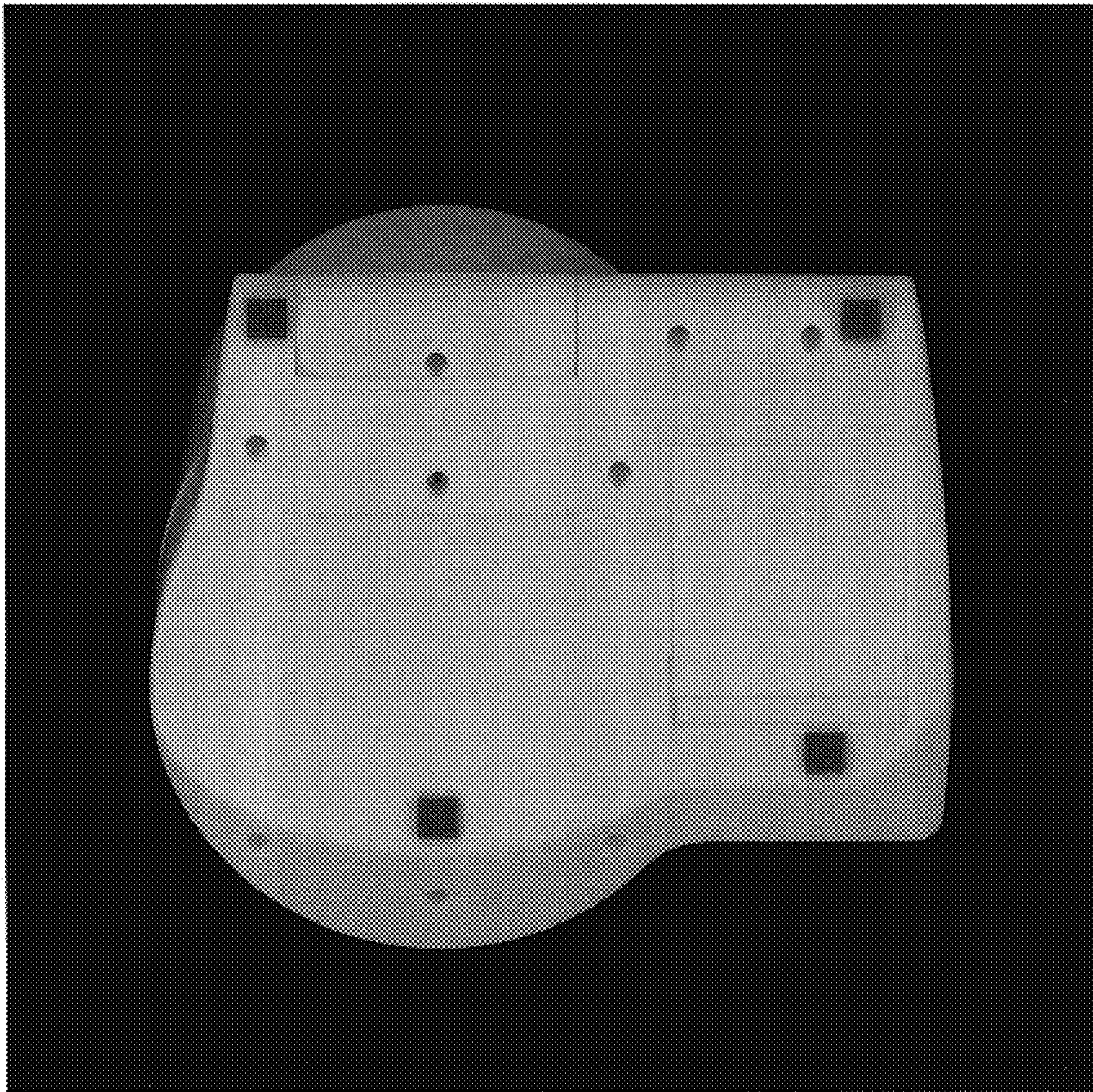

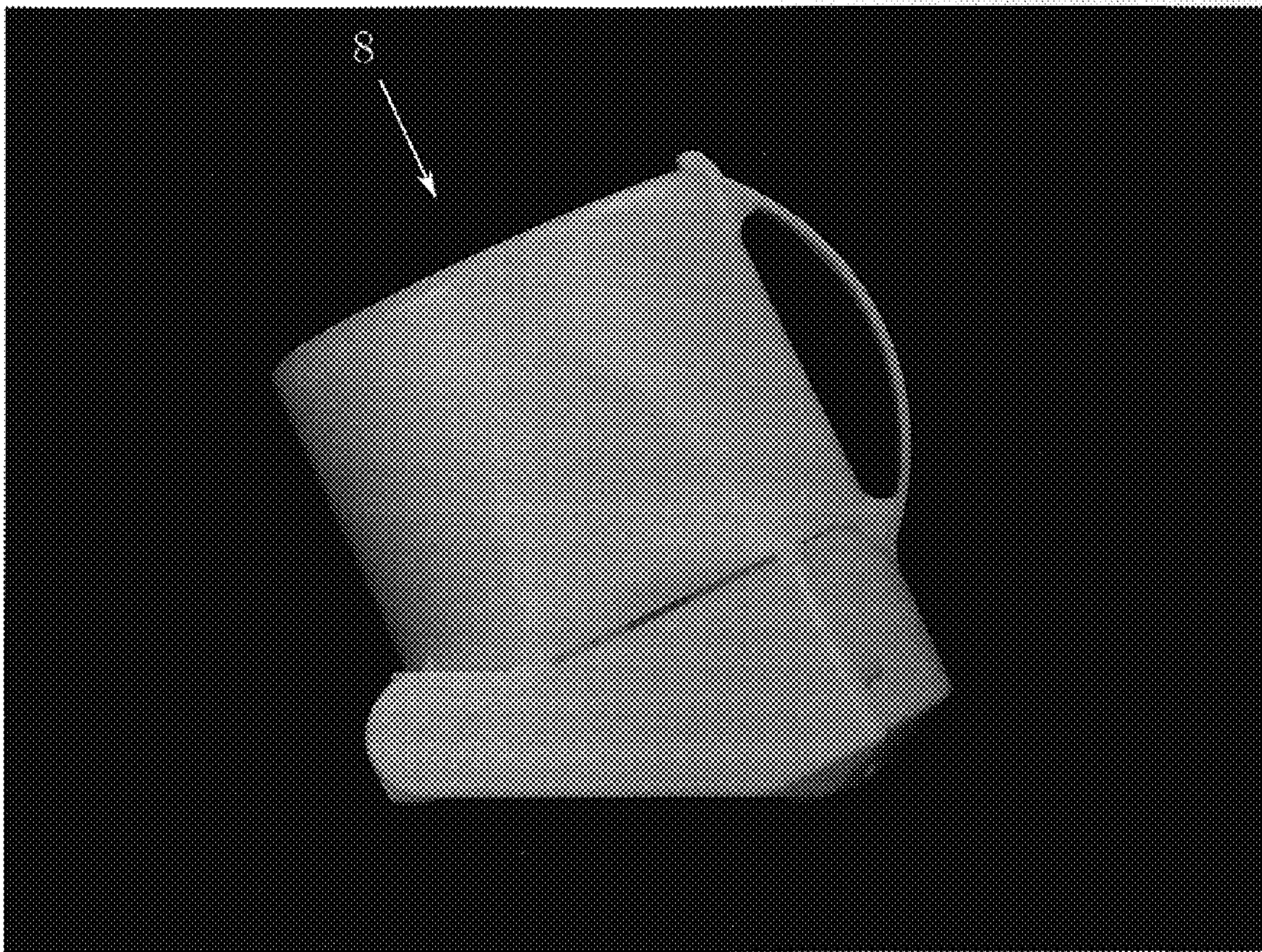

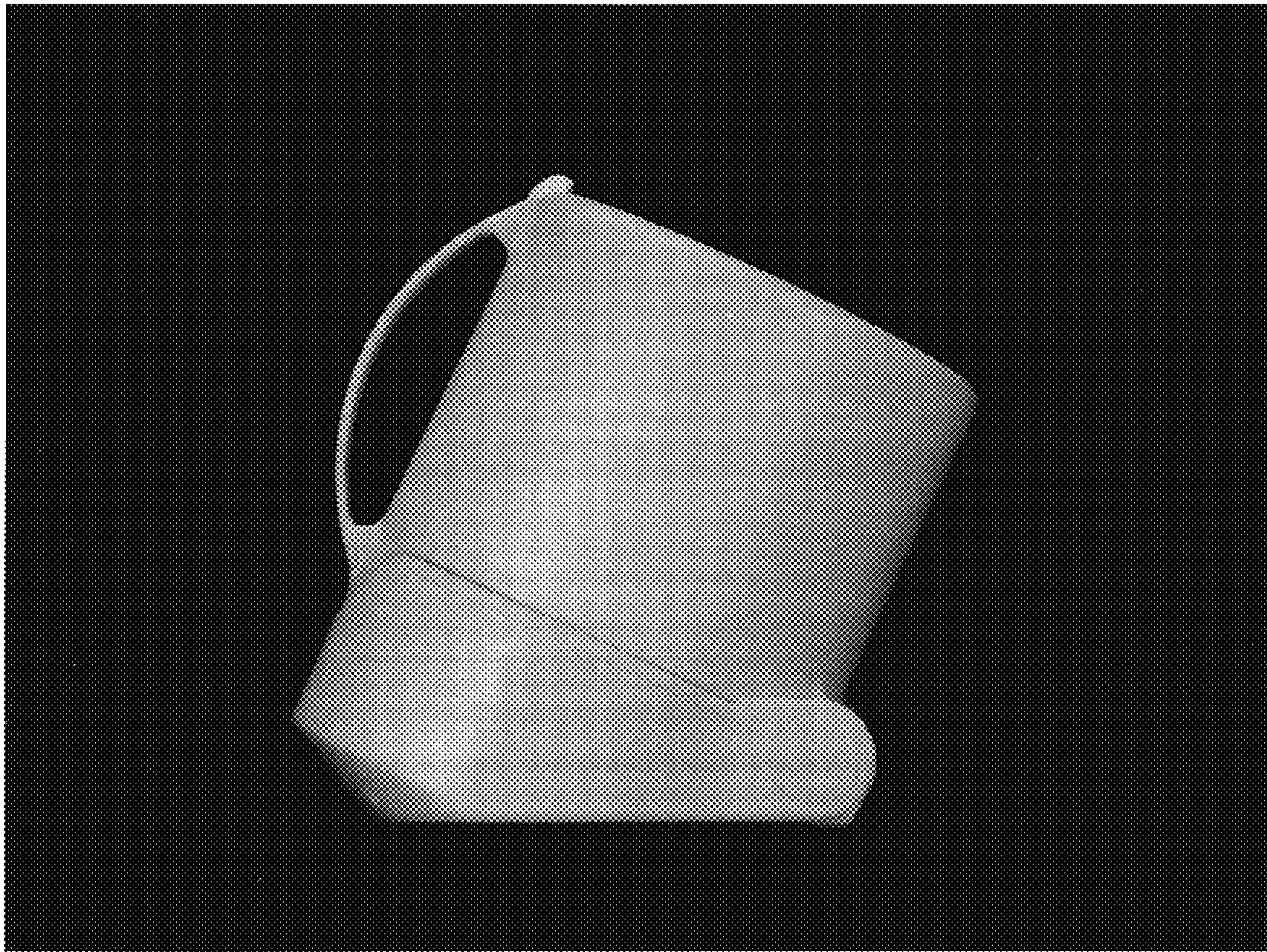

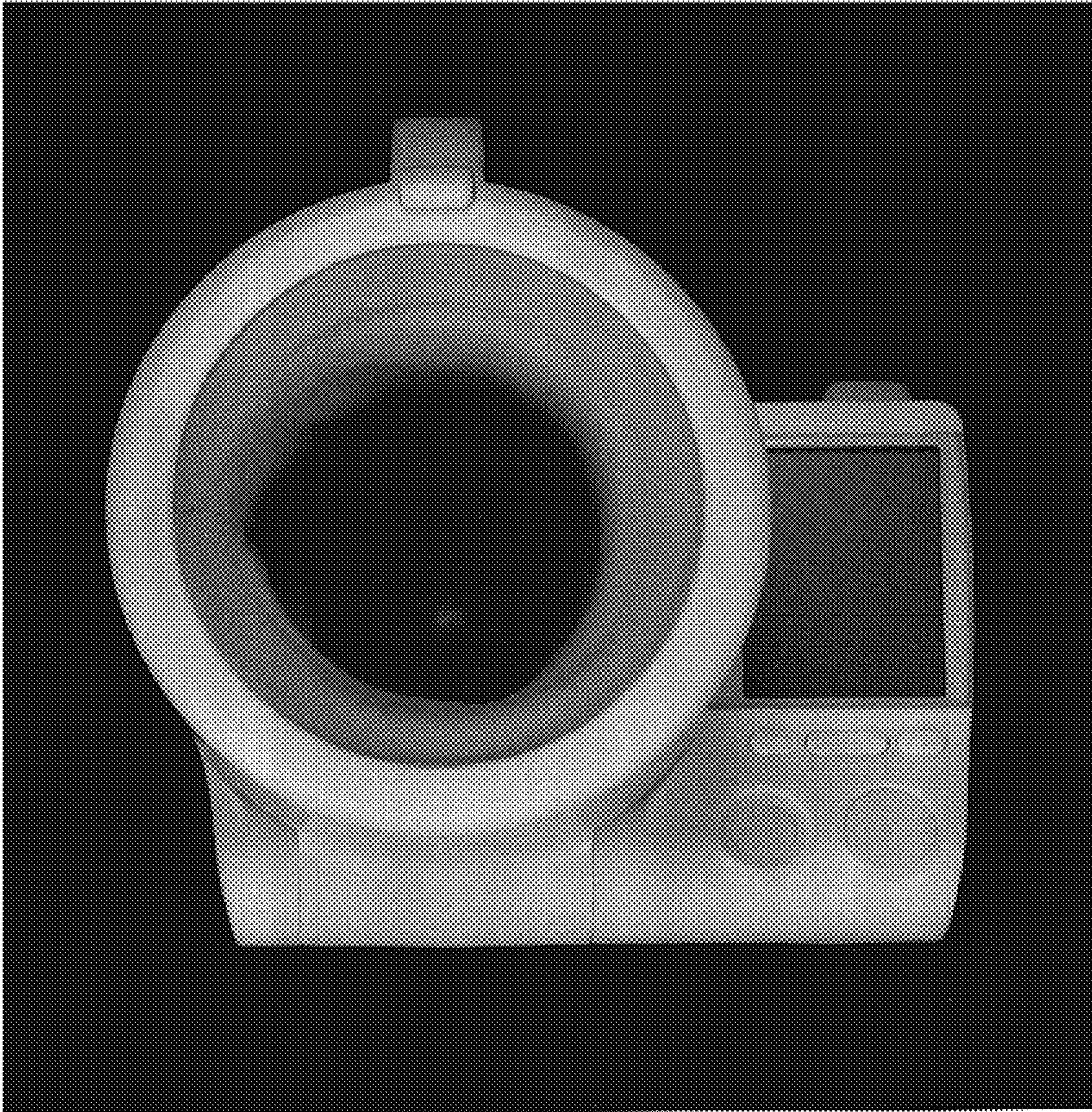

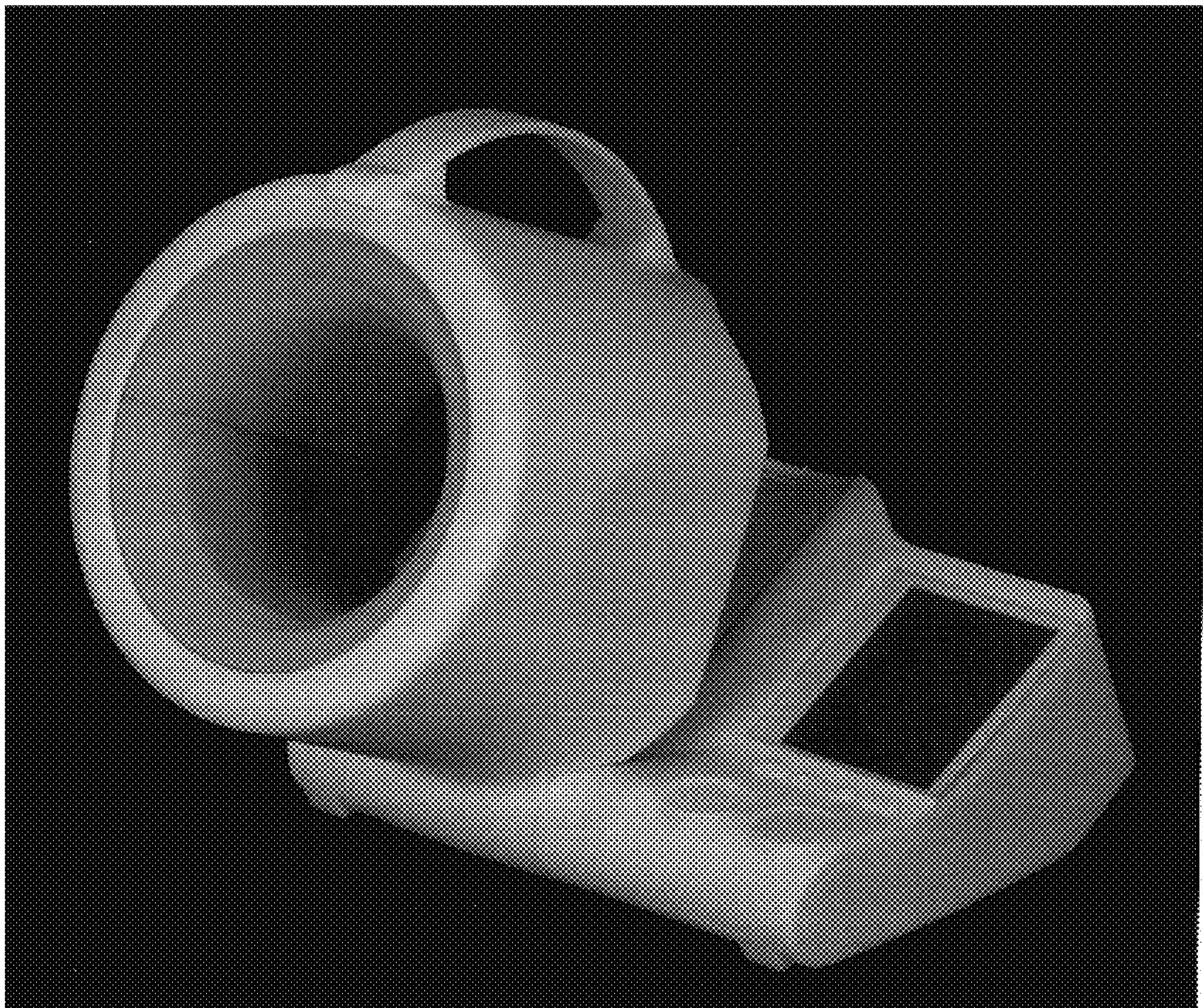

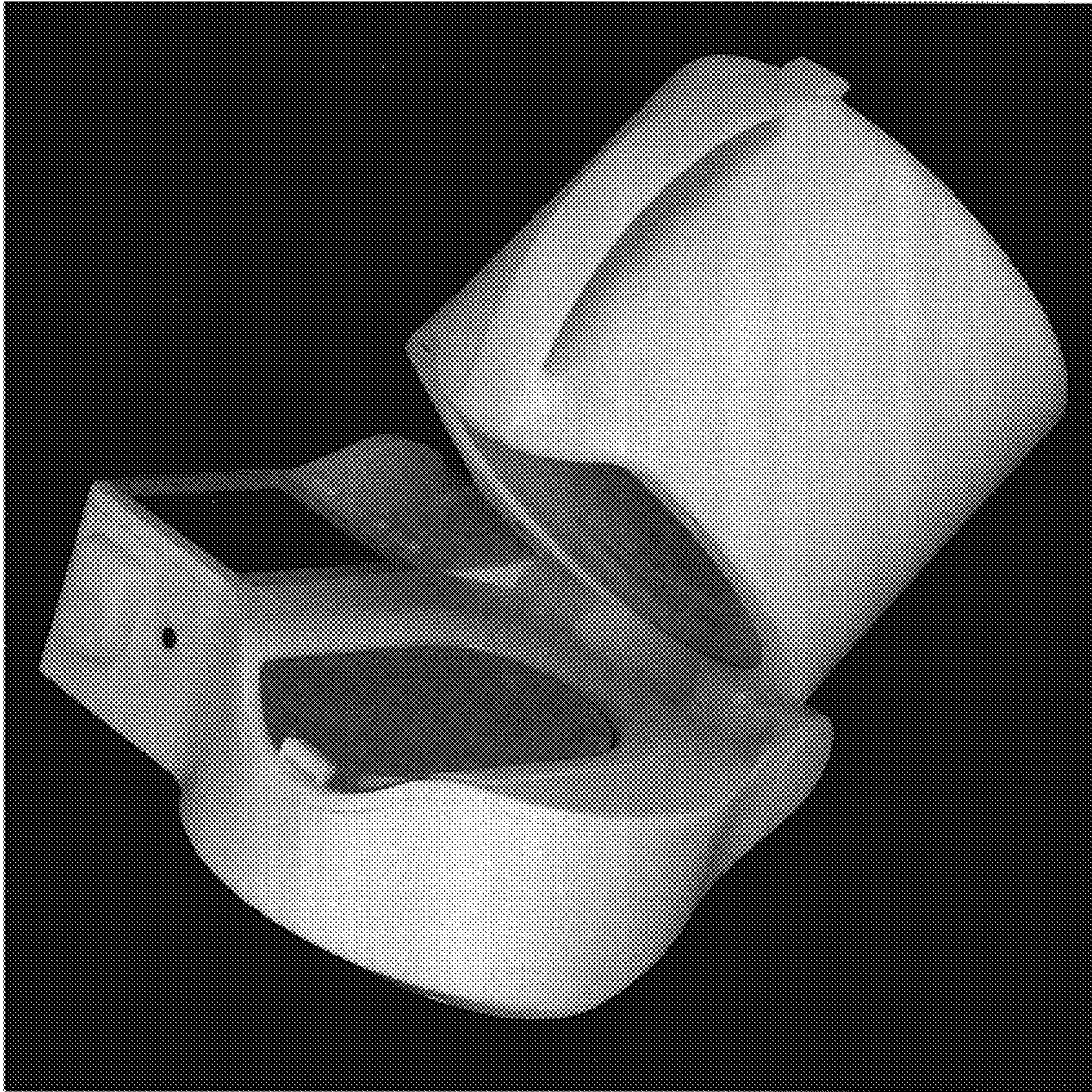

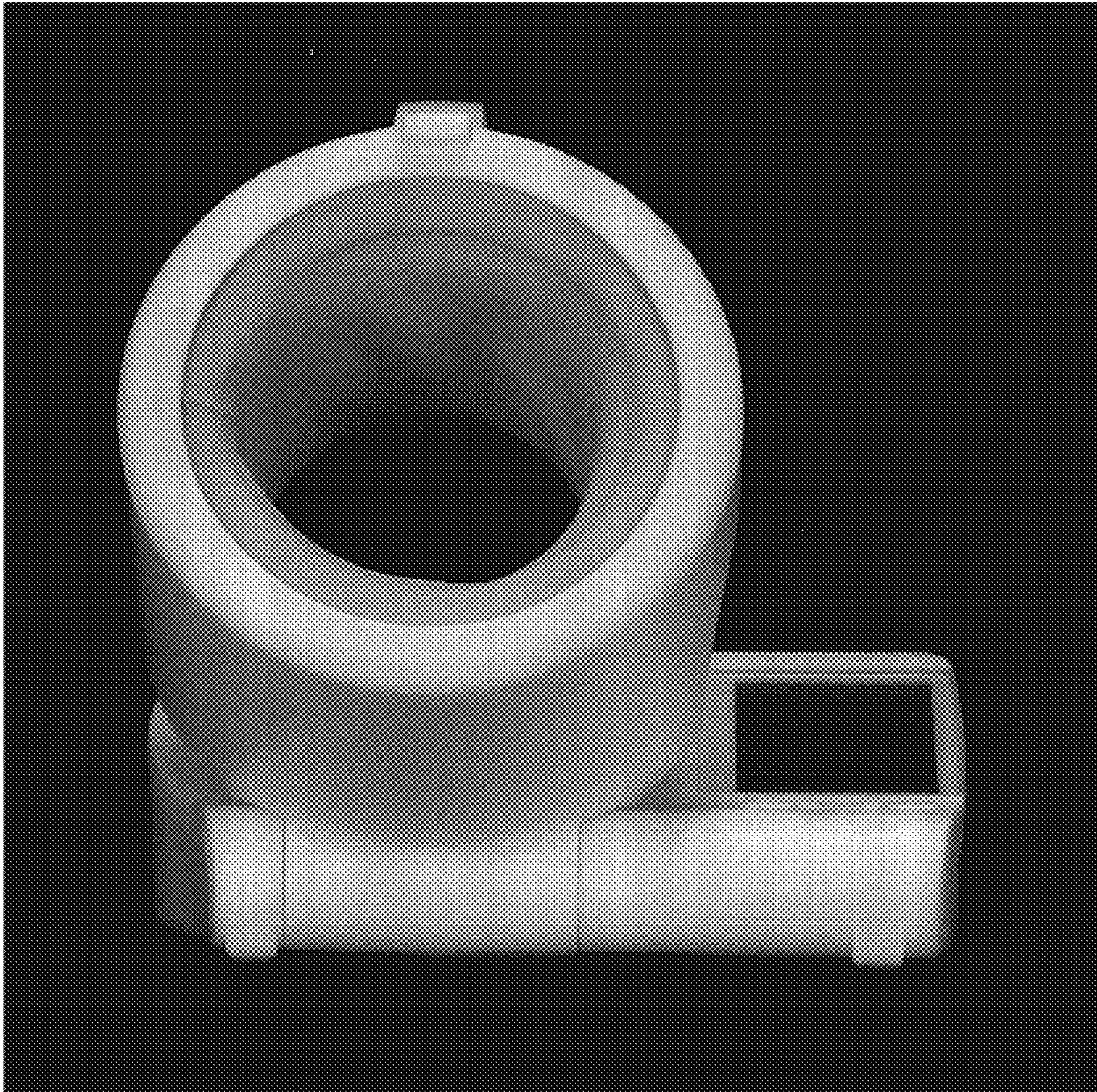

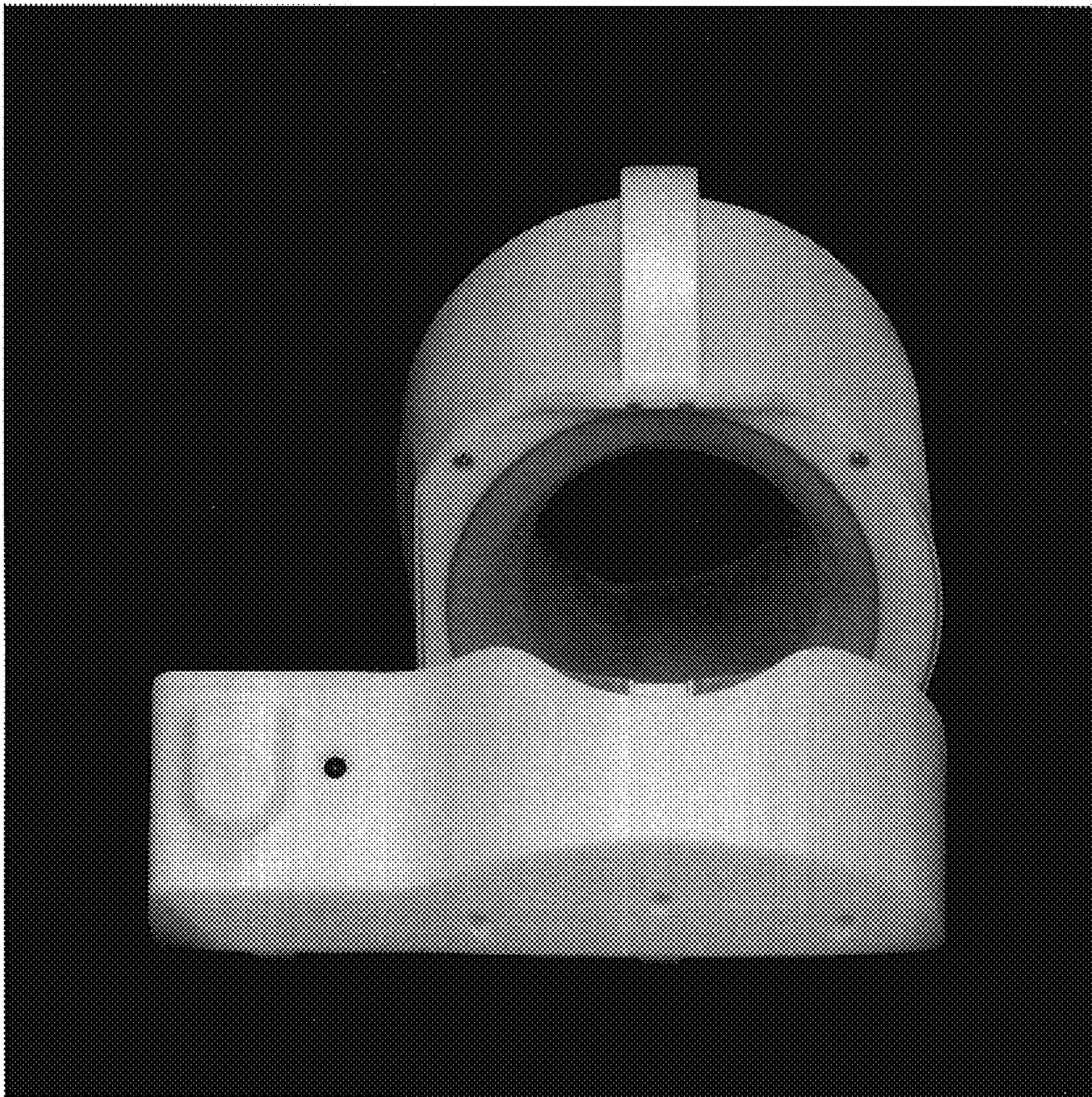

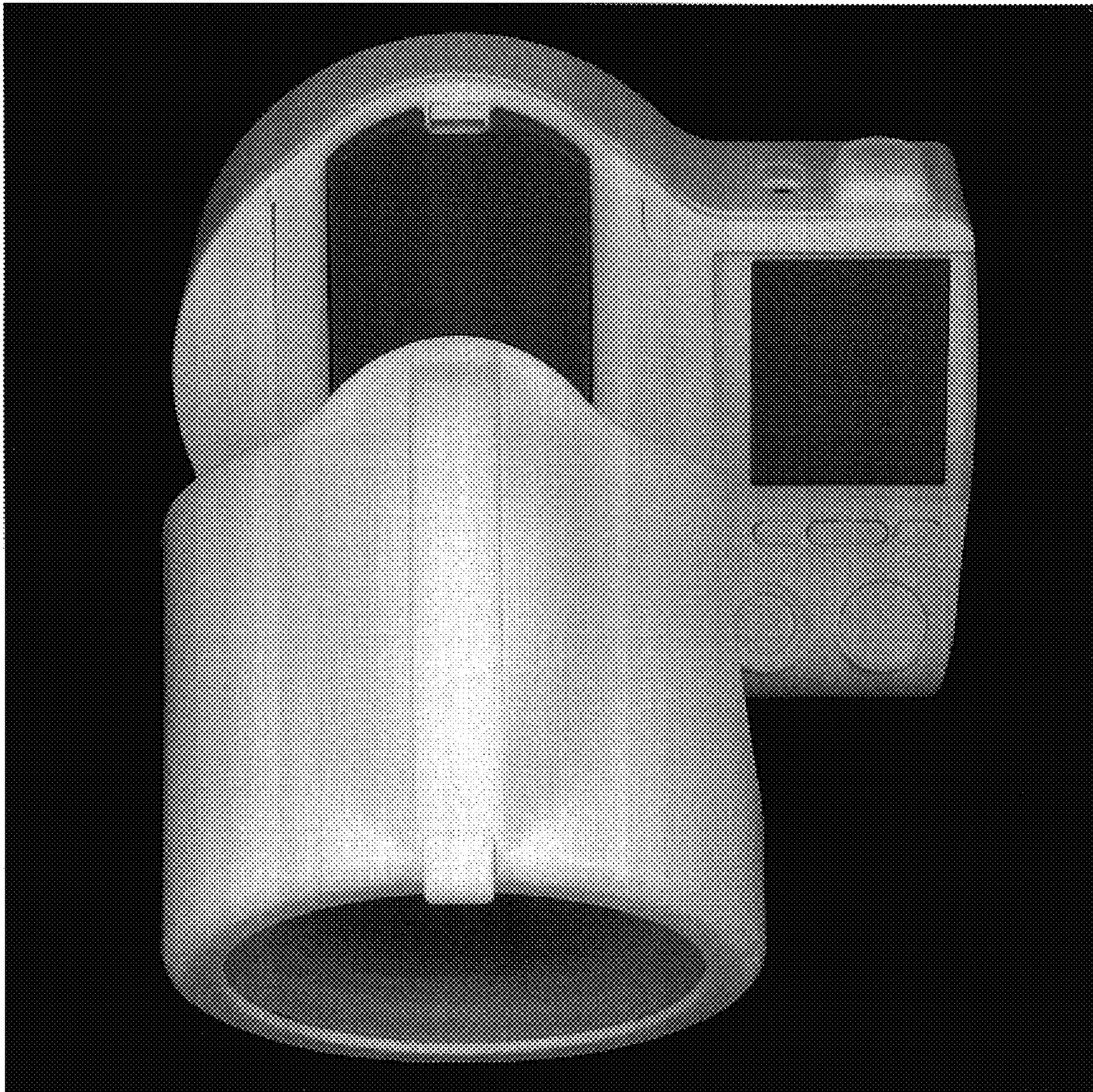

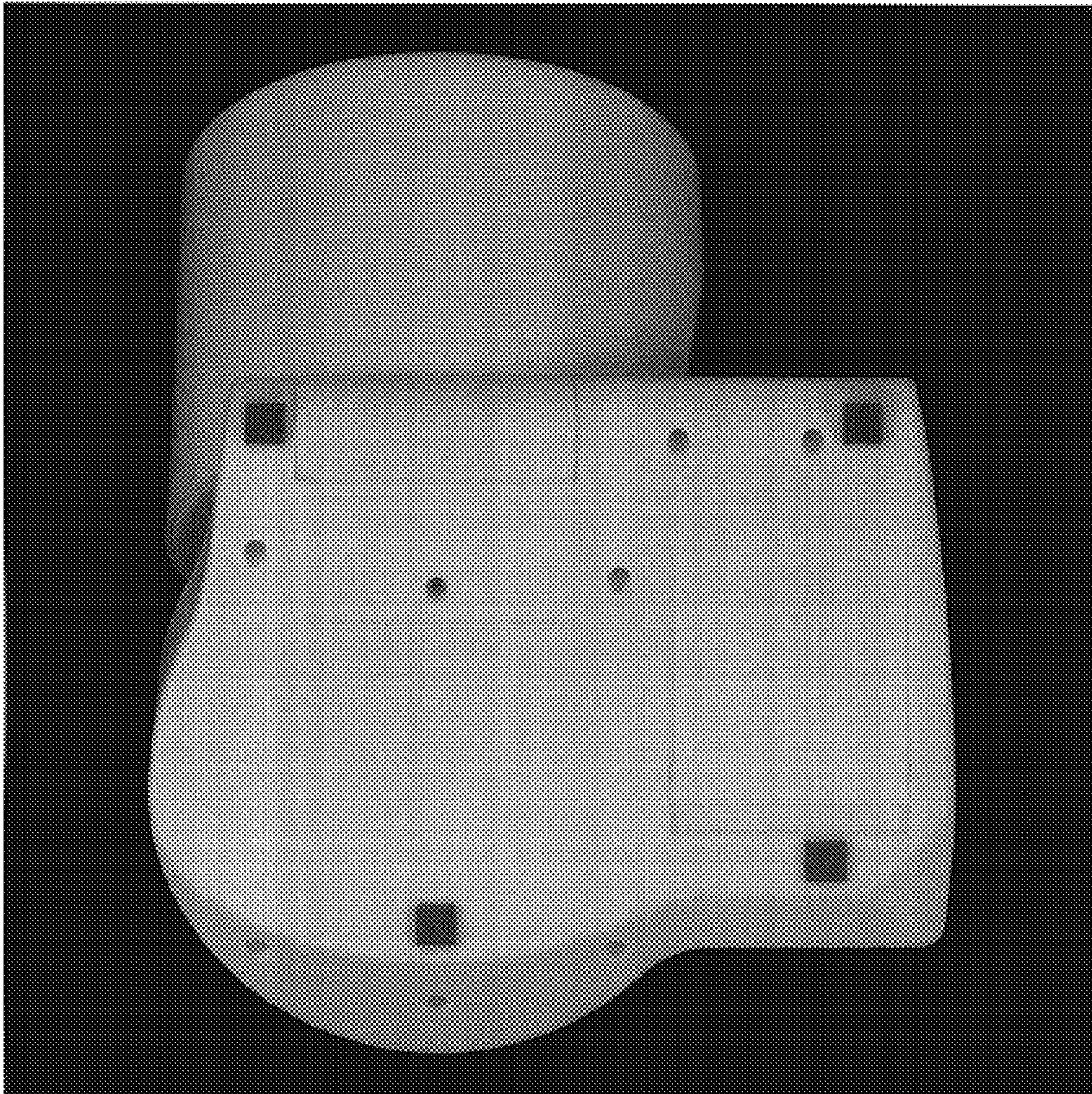

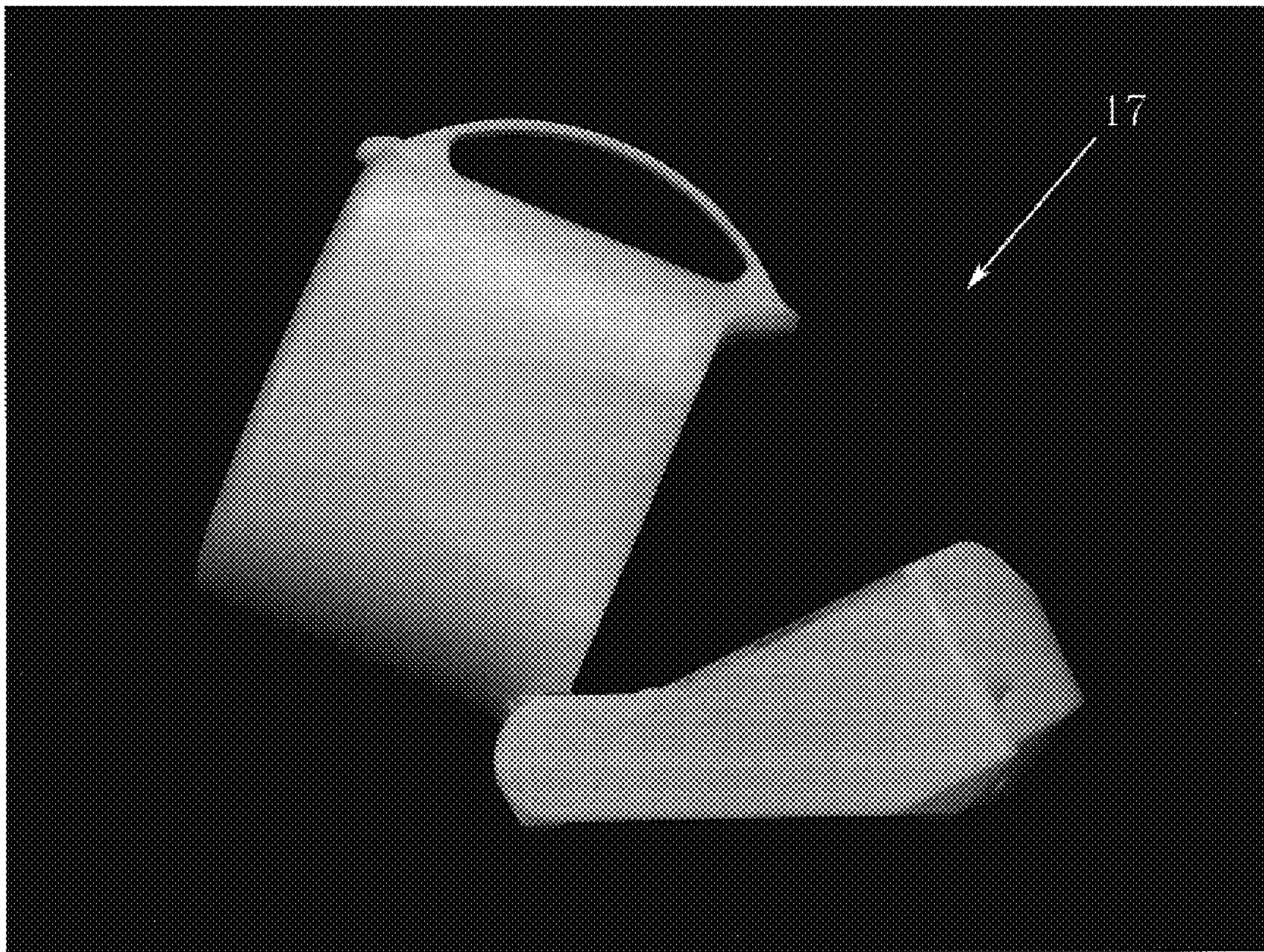

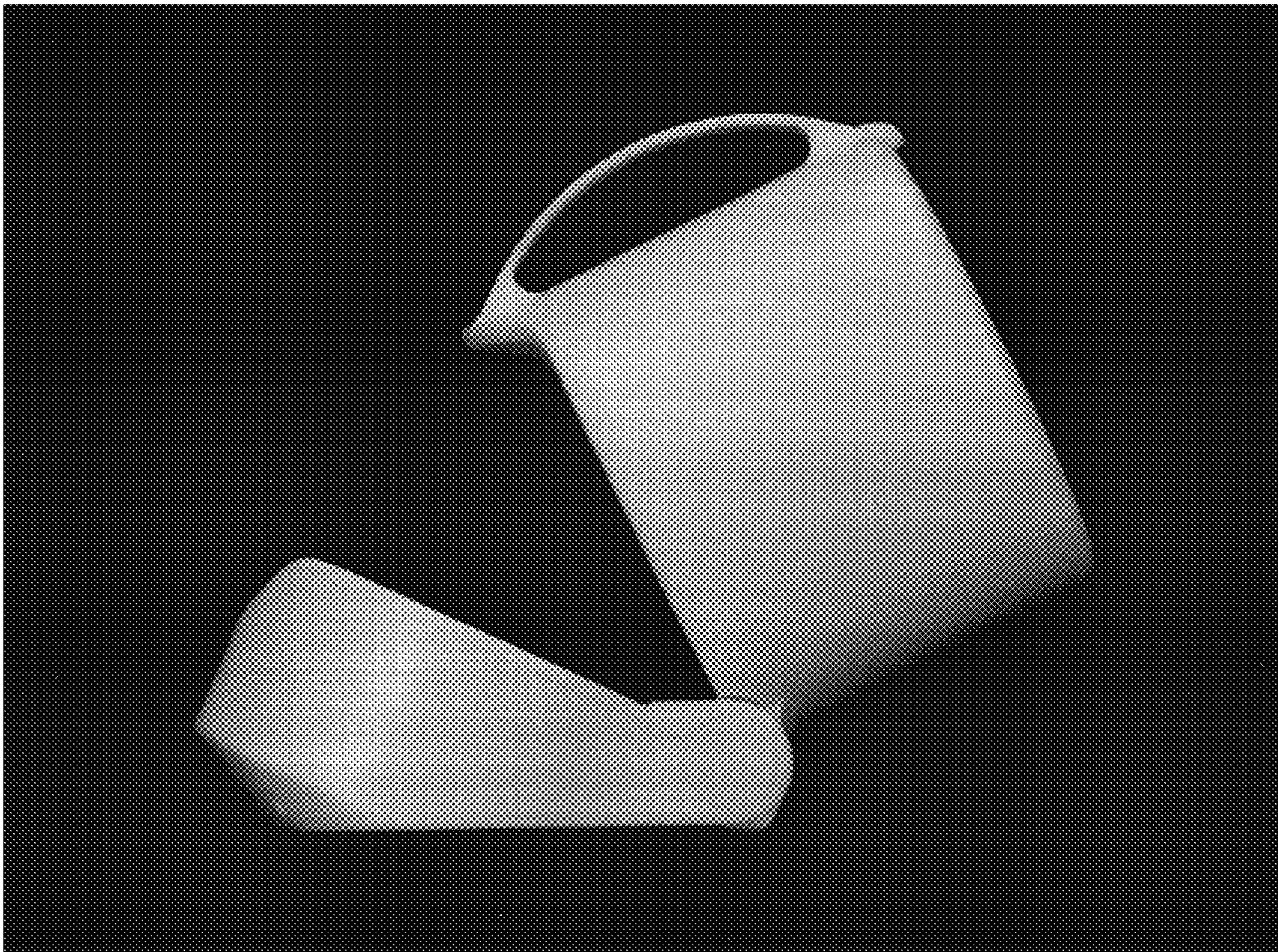
