DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my shoe design;

FIG. 2 is a right side view of the shoe shown in FIG. 1; FIG. 3 is a left side view of the shoe shown in FIG. 1; and, FIG. 4 is a rear view of the shoe shown in FIG. 1. The broken line showing of the sole, heel, and buckle is for illustrative purposes only and forms no part of the claimed design.
