(57) **CLAIM**

The ornamental design for media access center, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the front and right side of the media access center.

FIG. 2 is a perspective view of the front and right hand side of the media access center, taken from the bottom toward the top.

FIG. 3 is a perspective view of the rear and right hand side of the media access center.

FIG. 4 is a rear elevation view of the media access center. FIG. 5 is a perspective view of the front and right hand side of the media access center, with the interior console extended.

FIG. 6 is a perspective view of the front and right hand side of the media access center taken from the bottom toward the top, with the interior console extended.

FIG. 7 is a perspective view of the rear and left side of the media access center, with the interior console extended.

FIG. 8 is a right side elevation of the media access center, with the interior console extended, the left hand side being a mirror image of the right hand side.

FIG. 9 is a rear elevation view of the media access center with the interior console extended.

FIG. 10 is a perspective view of the front and right hand side of the media access center with the interior console extended and rotated 90° to the left.

FIG. 11 is a right hand side elevation view of the media access center as shown in FIG. 10.

FIG. 12 is a front elevation view of the media access center as shown in FIG. 11.

FIG. 13 is a perspective view of the front and right side of the media access center taken from the bottom toward the top with the interior console extended and rotated 90° to the left; and,

FIG. 14 is a rear elevation view of the media access center as shown in FIG. 13.

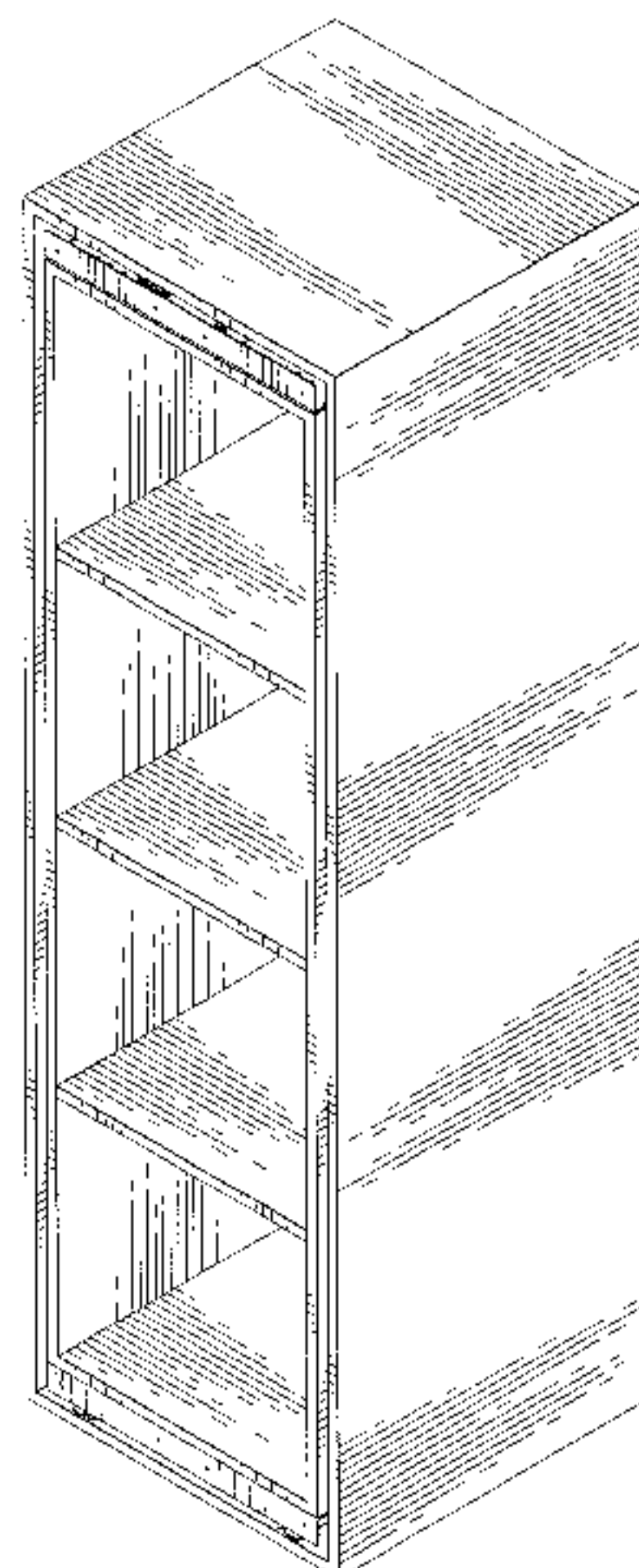

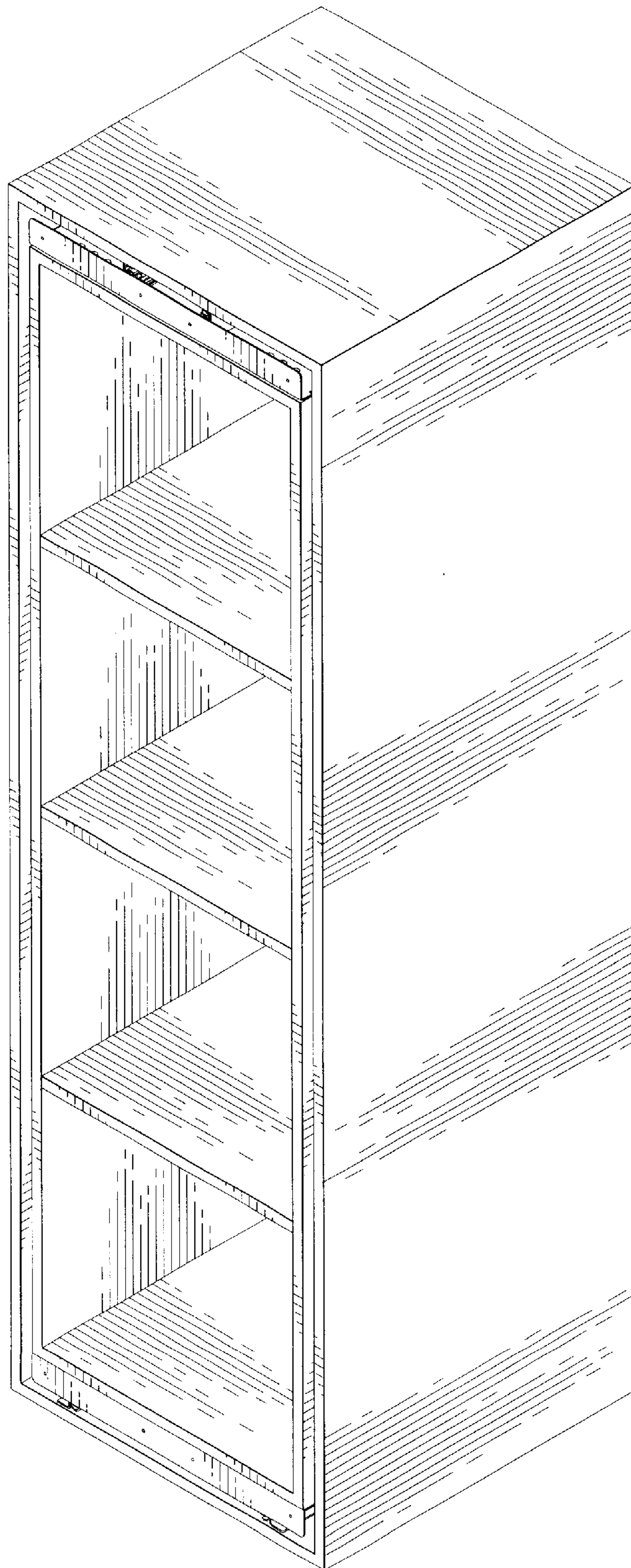

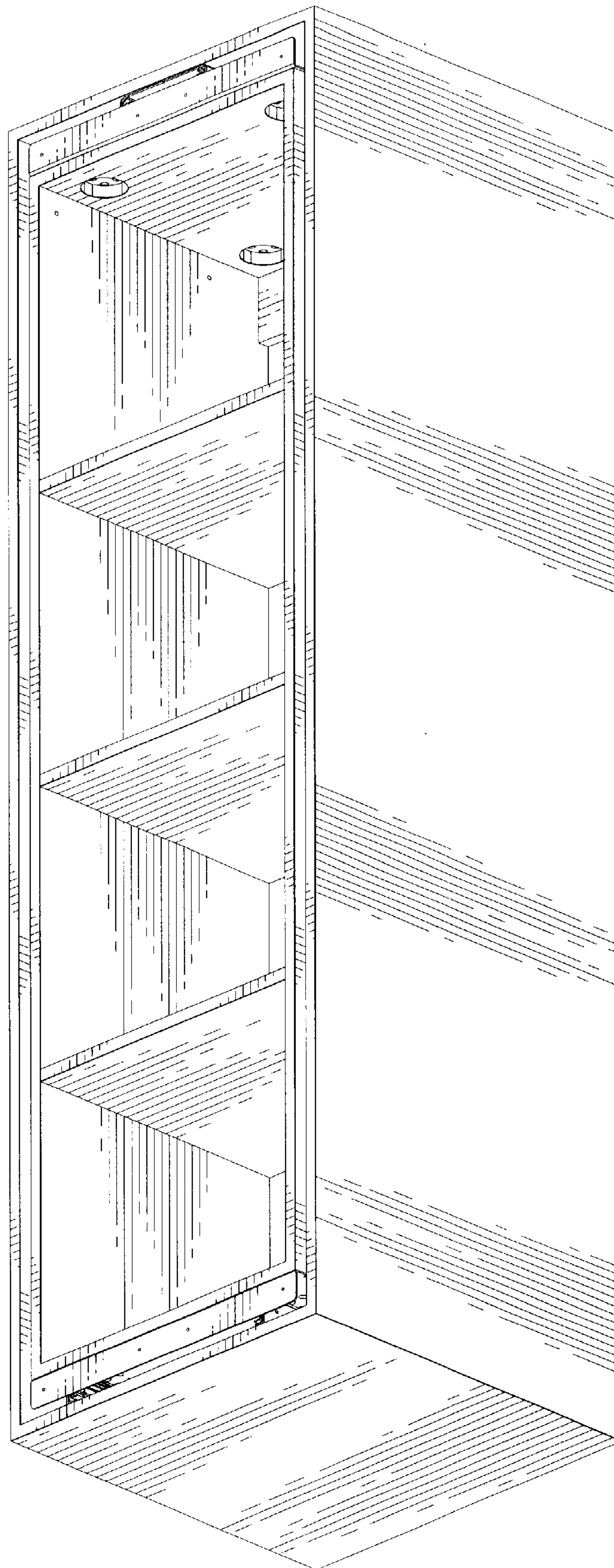

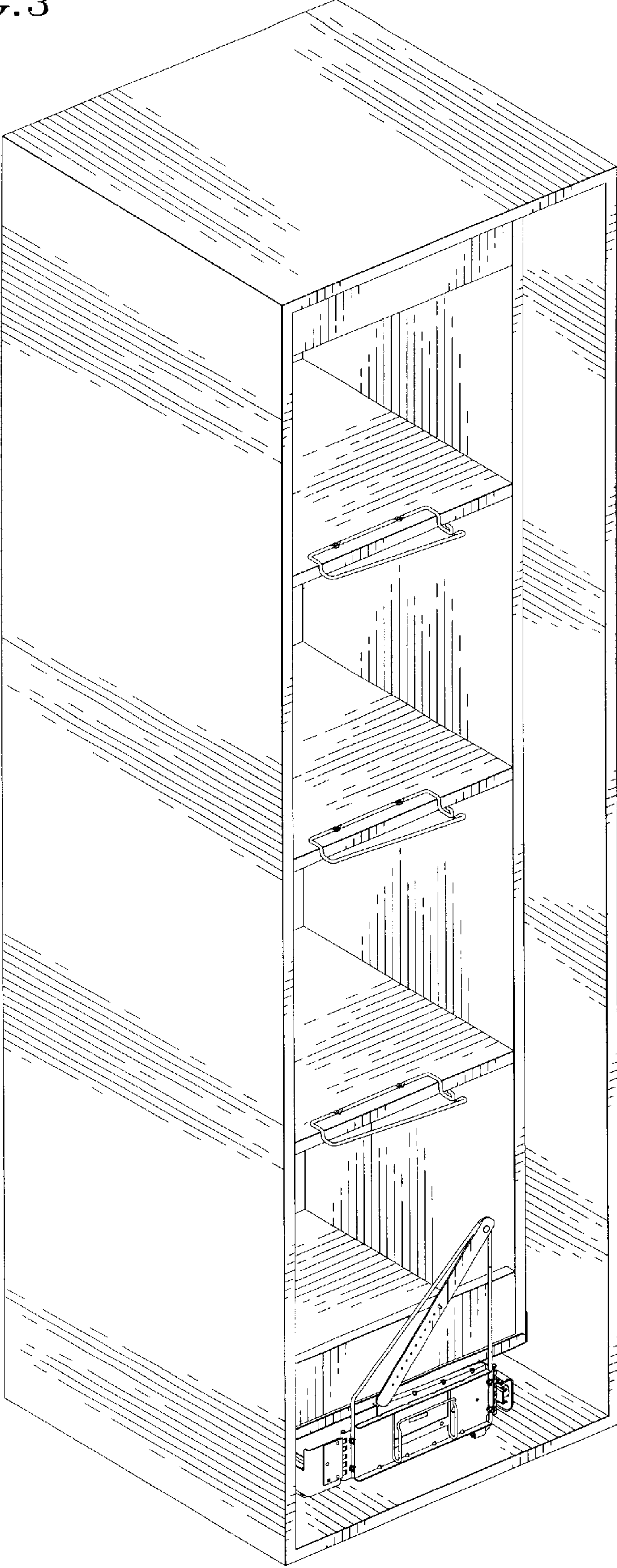

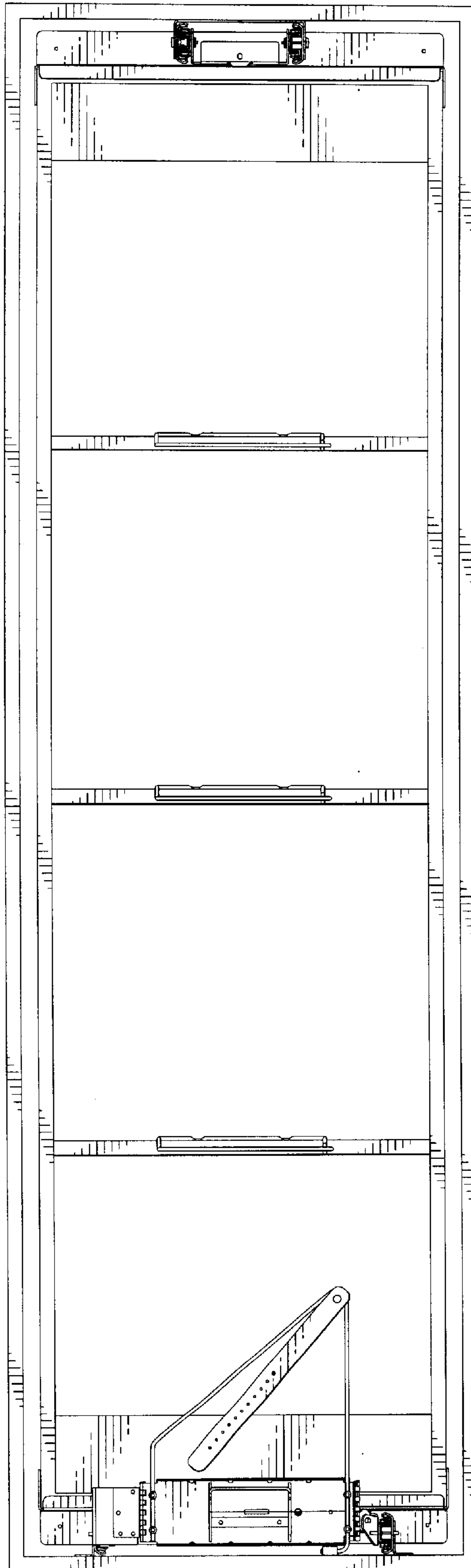

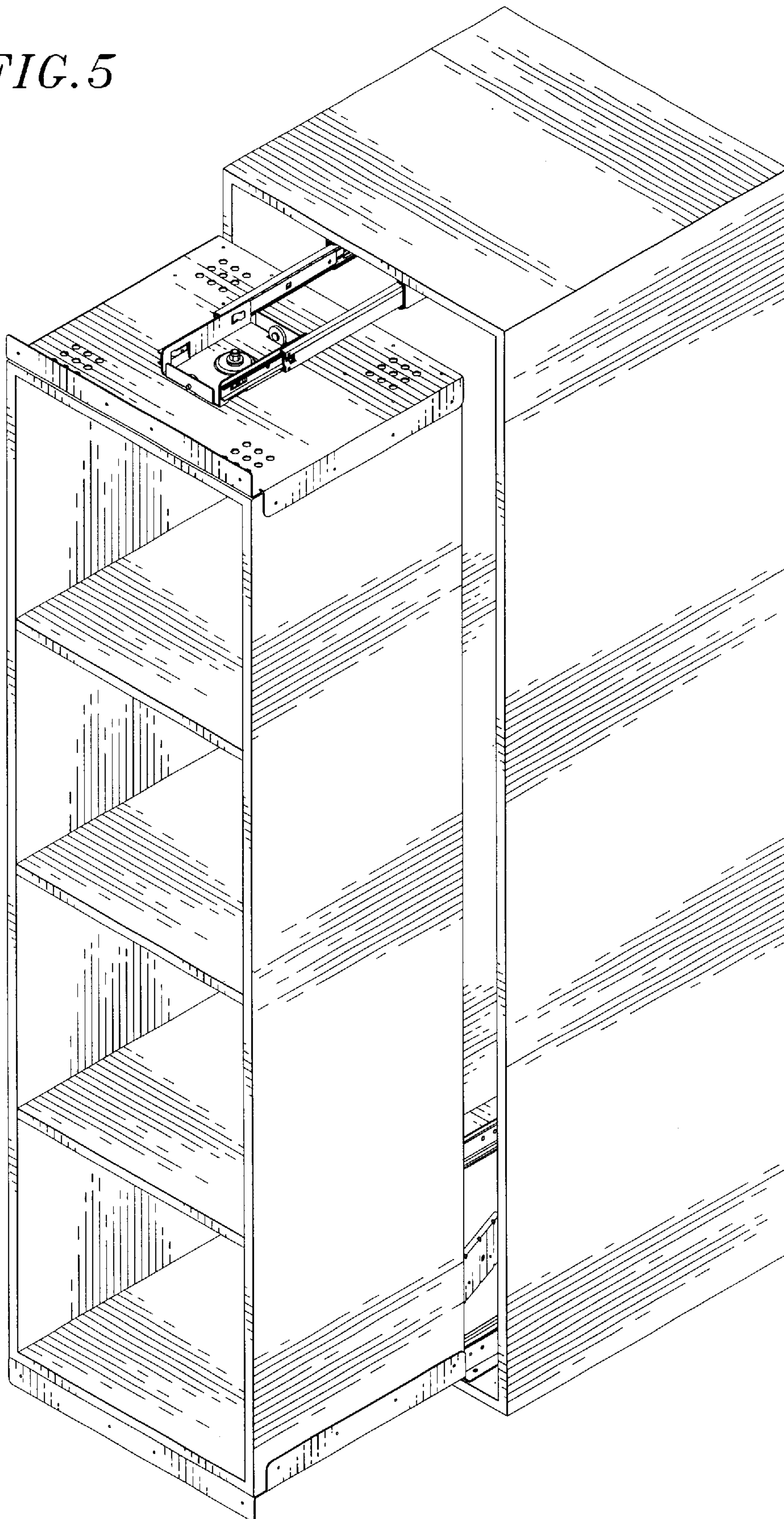

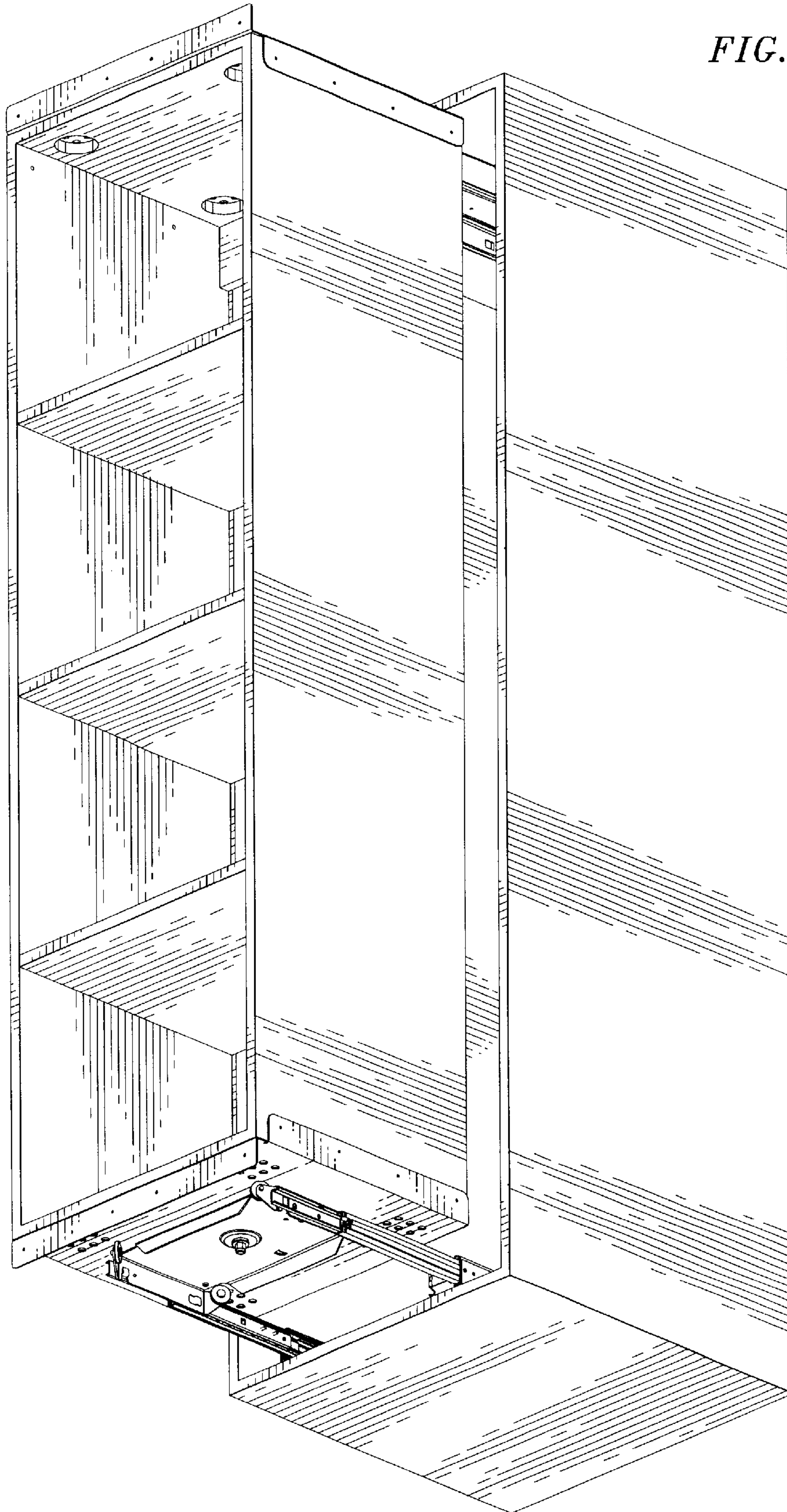

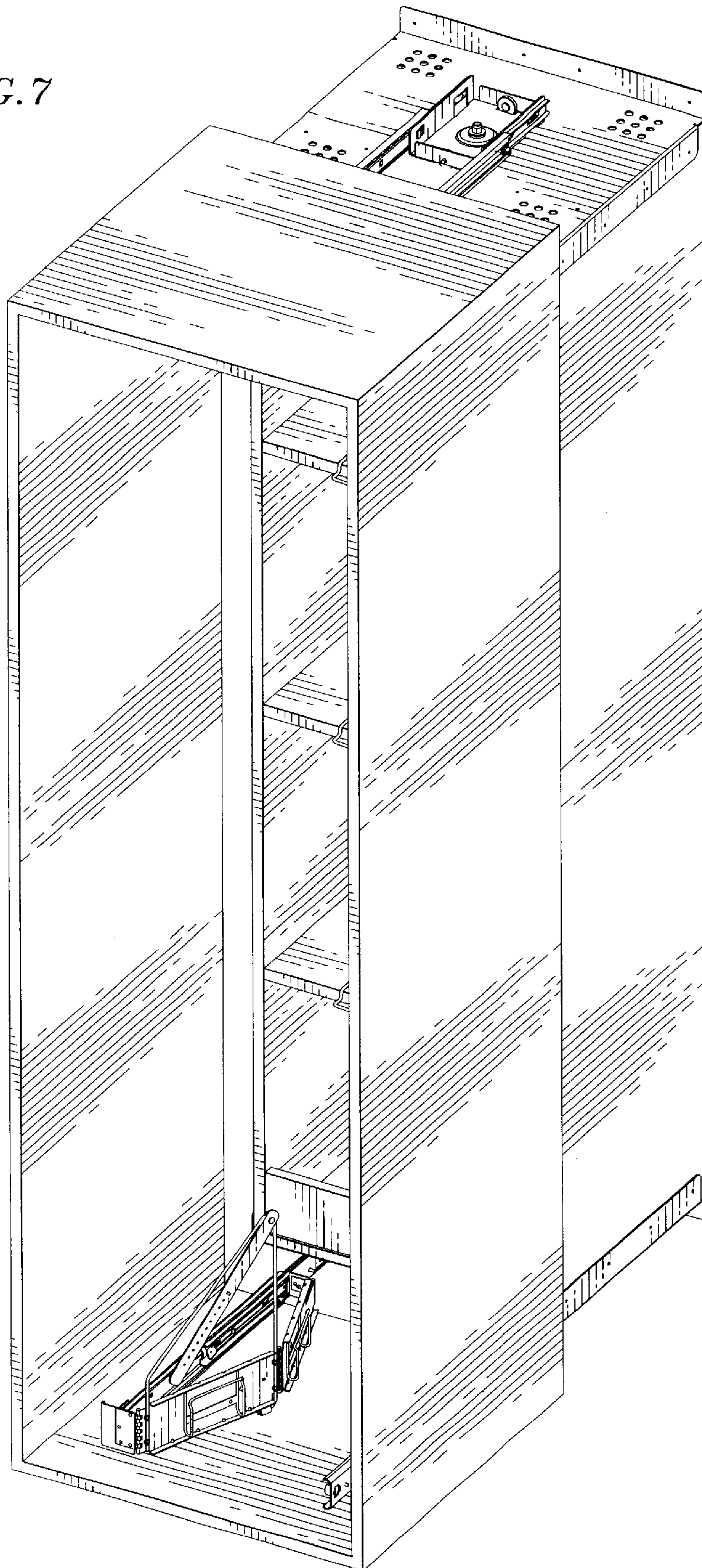

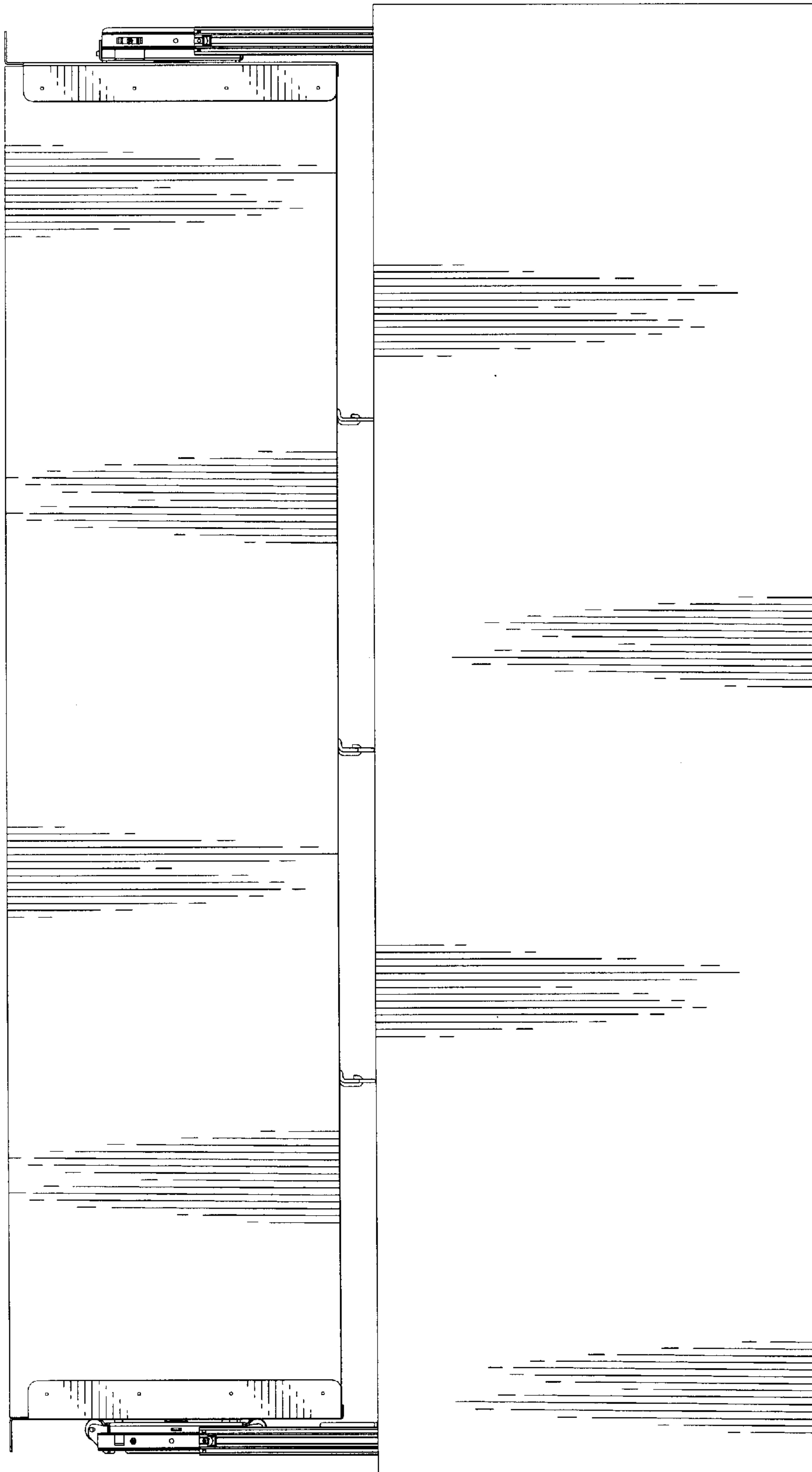

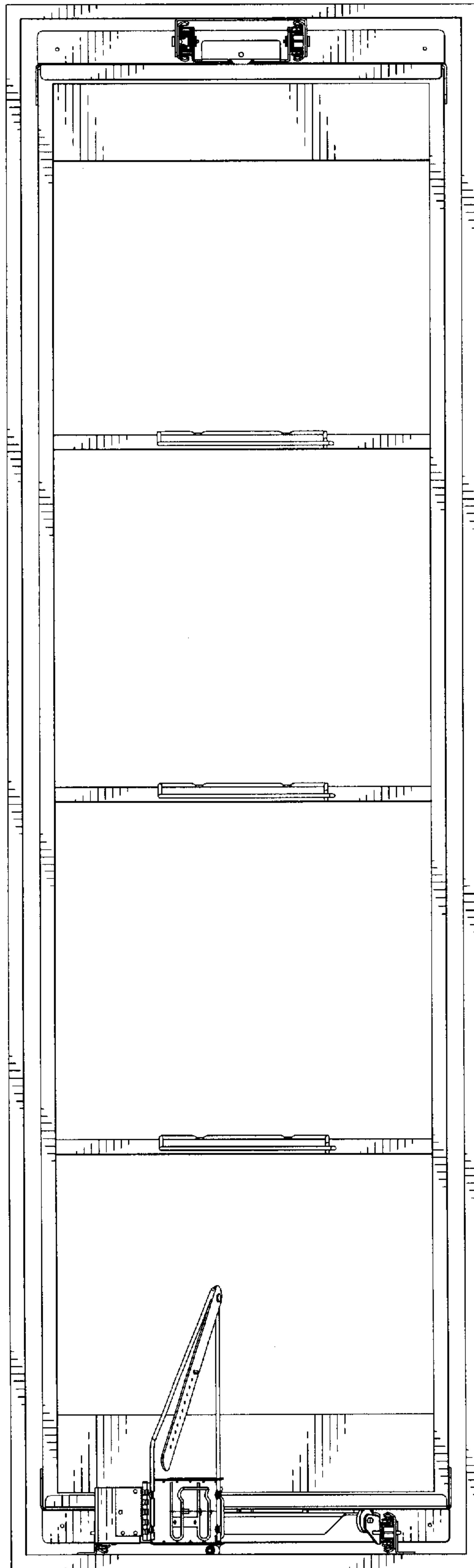

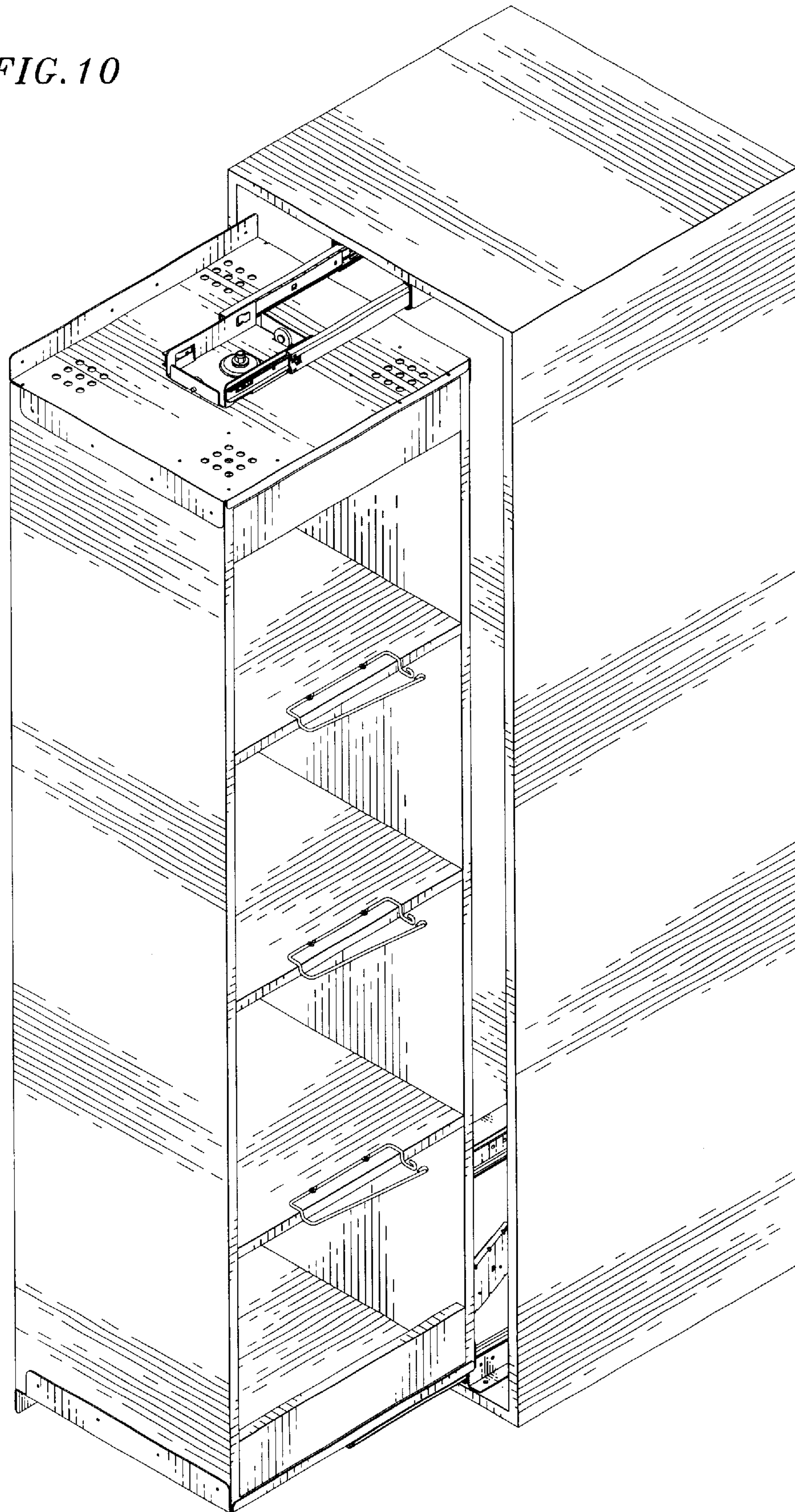

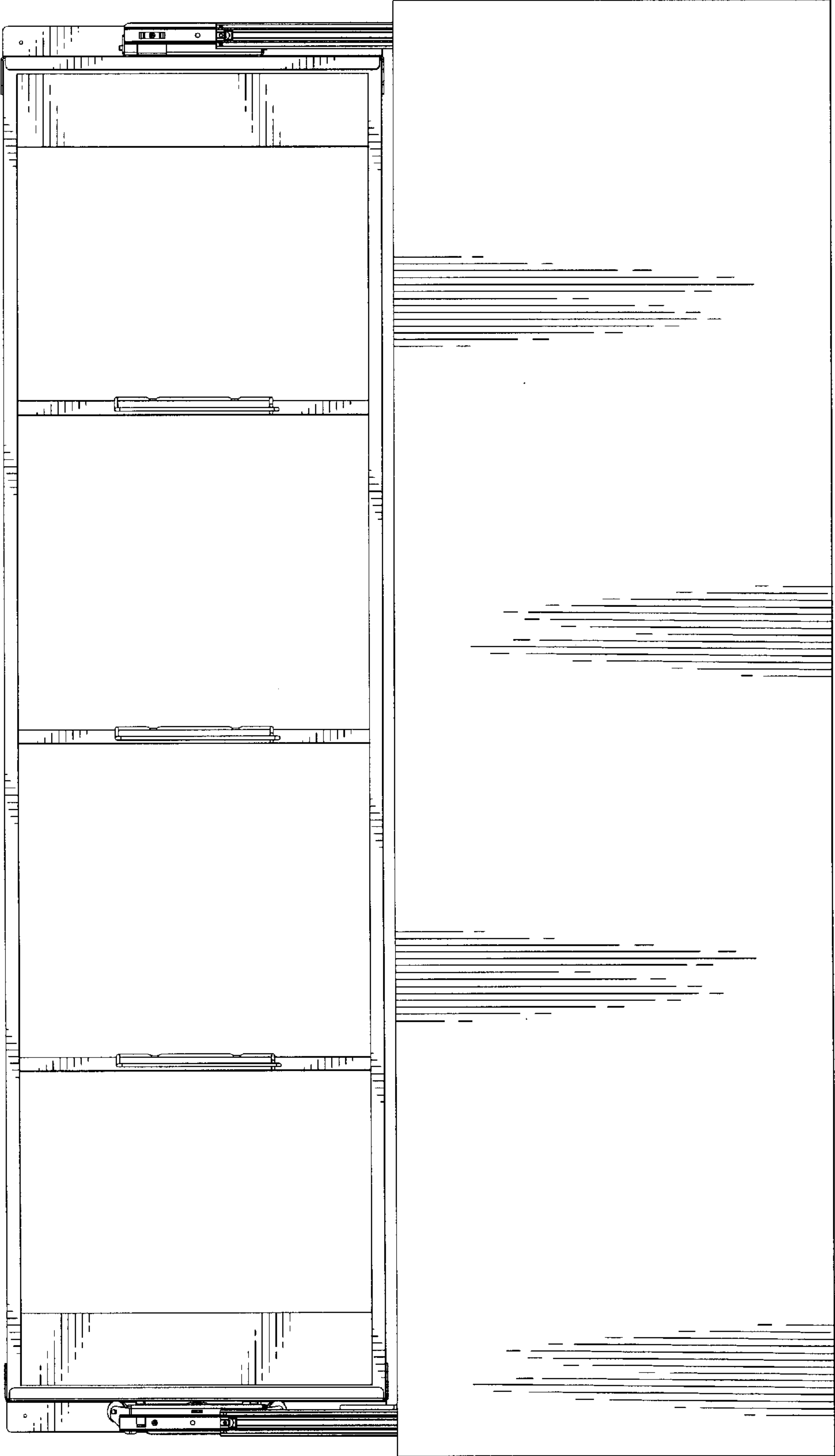

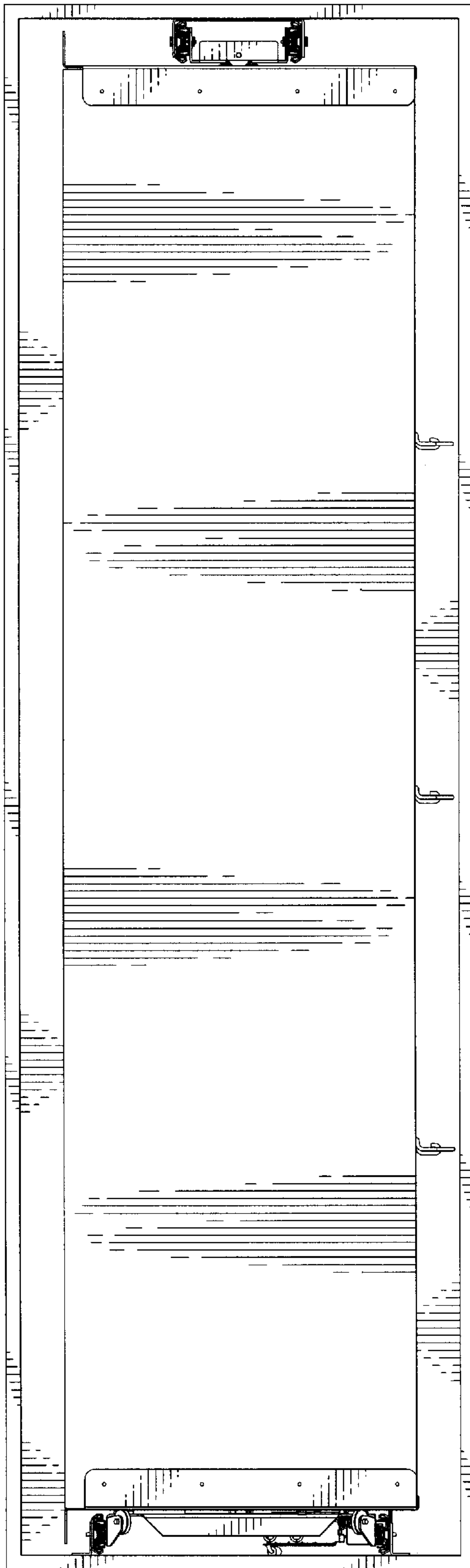

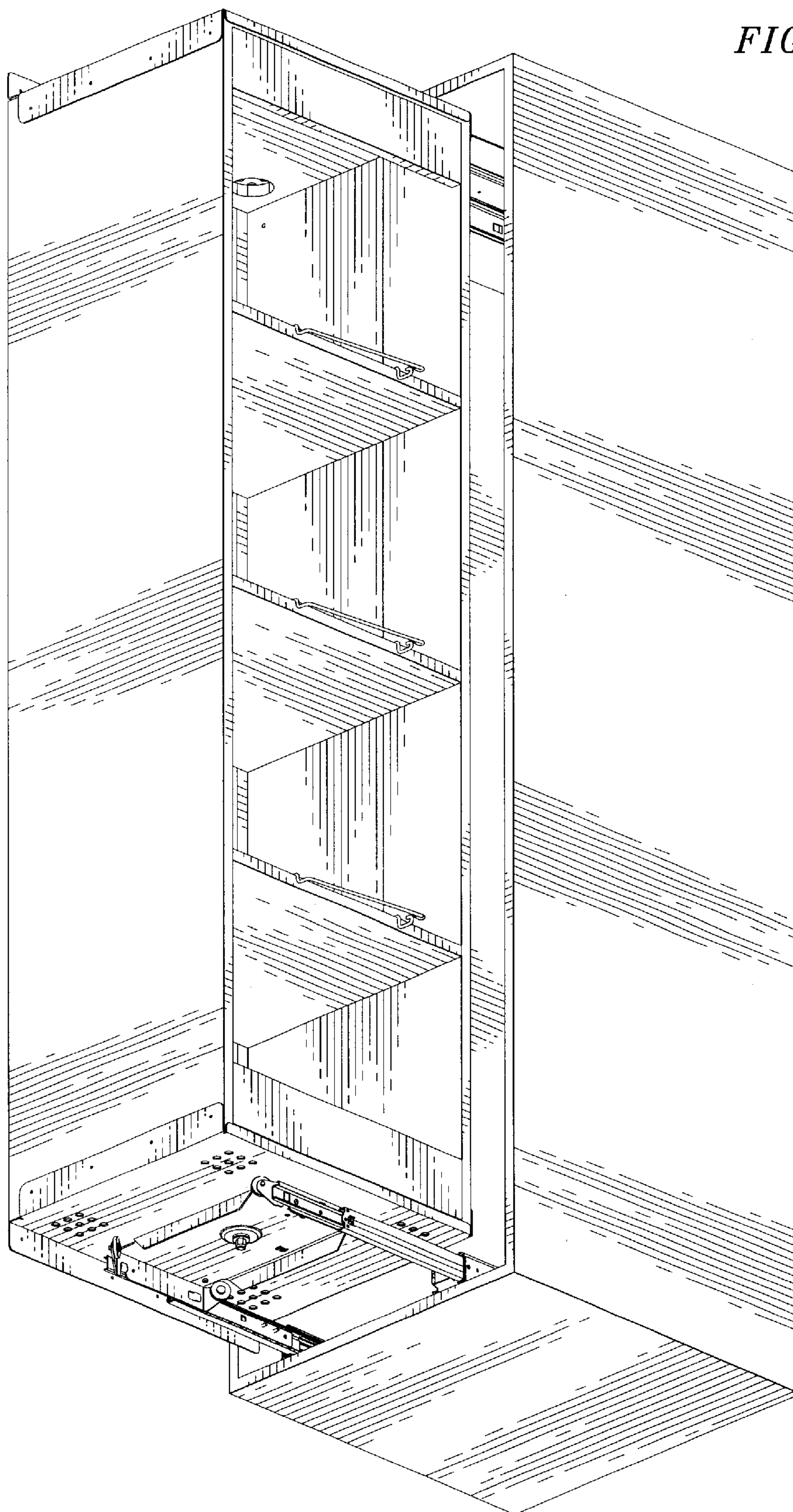
