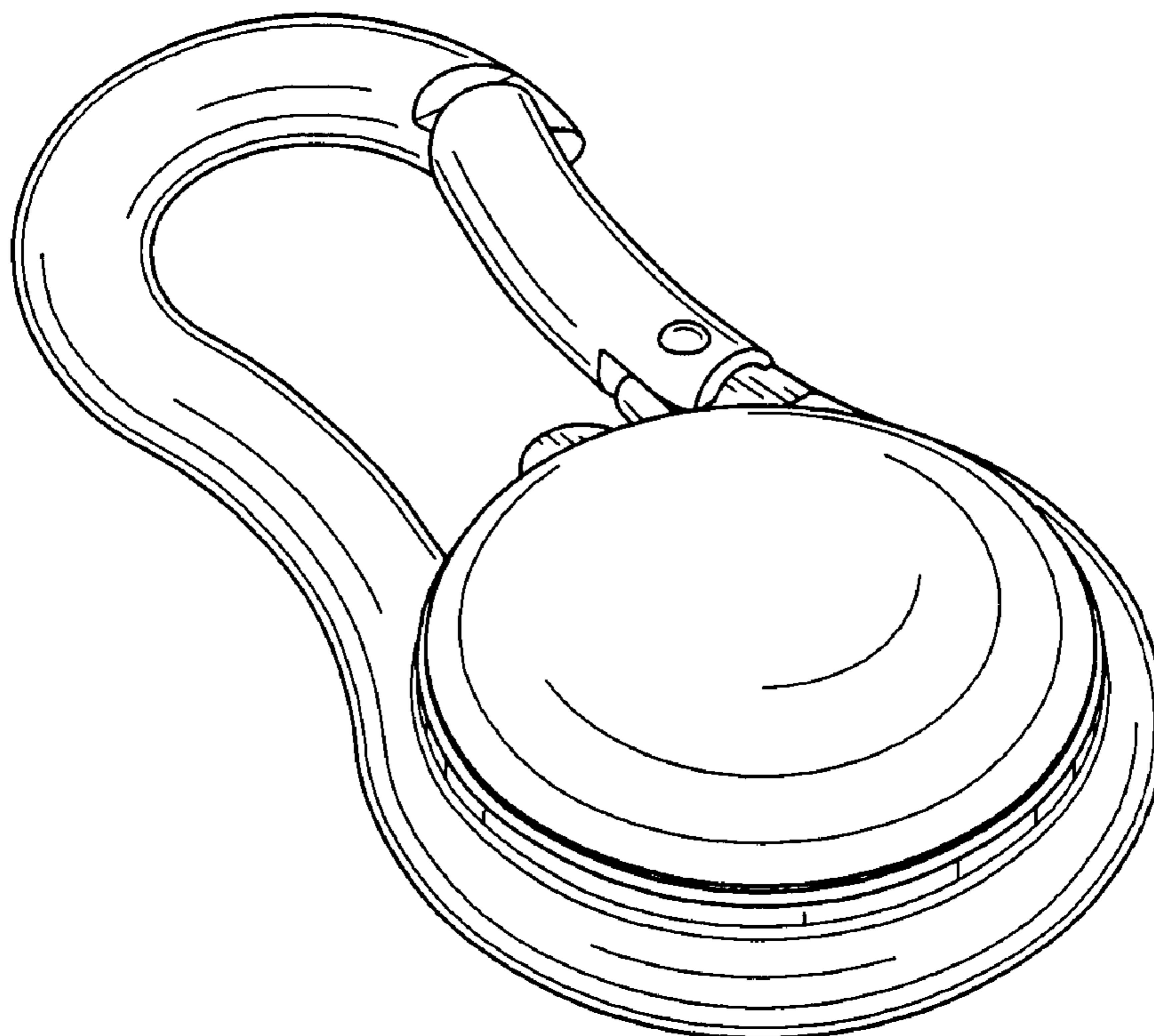

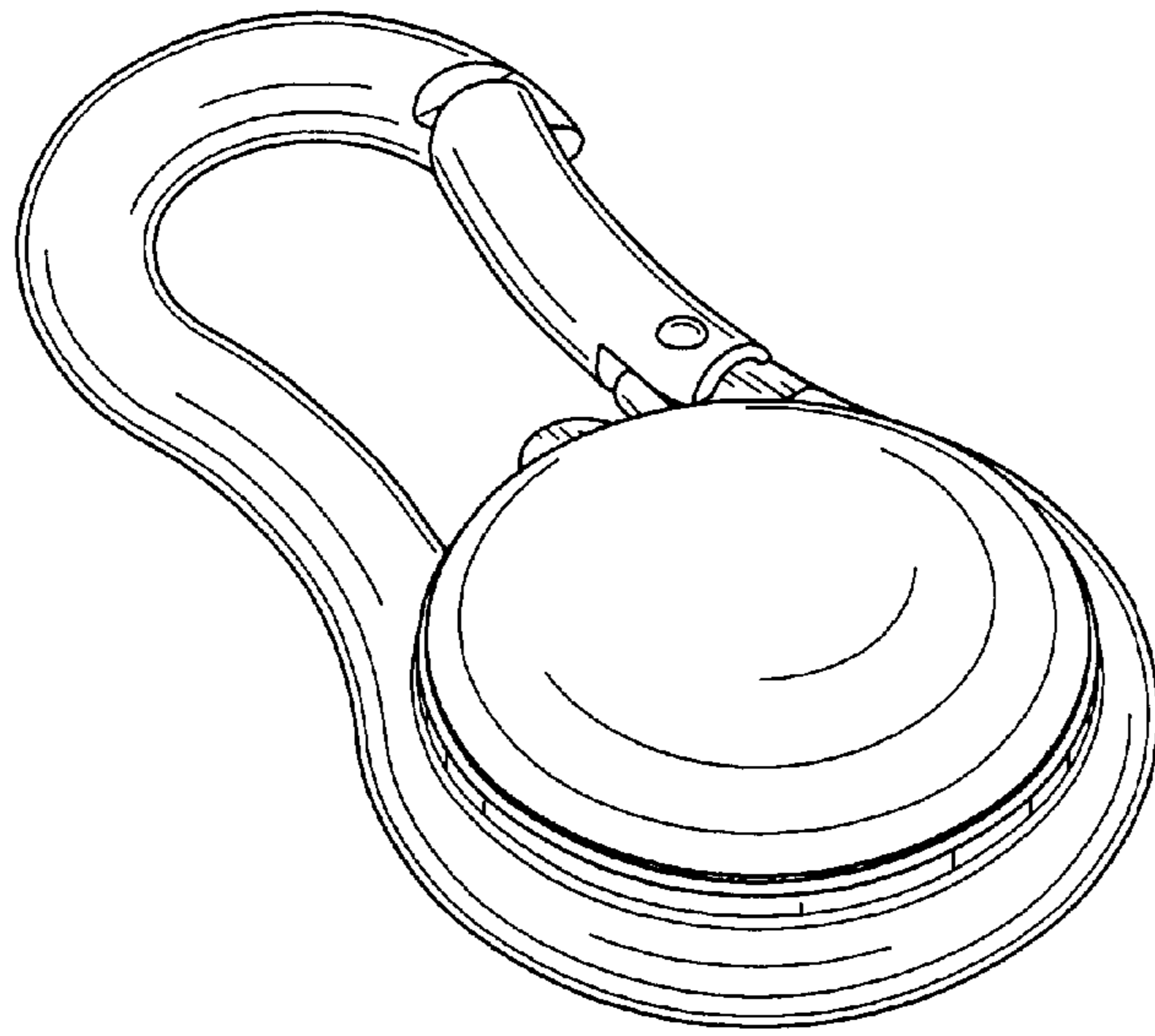
The ornamental design for a carabineer pill box, as shown and described.

**DESCRIPTION**

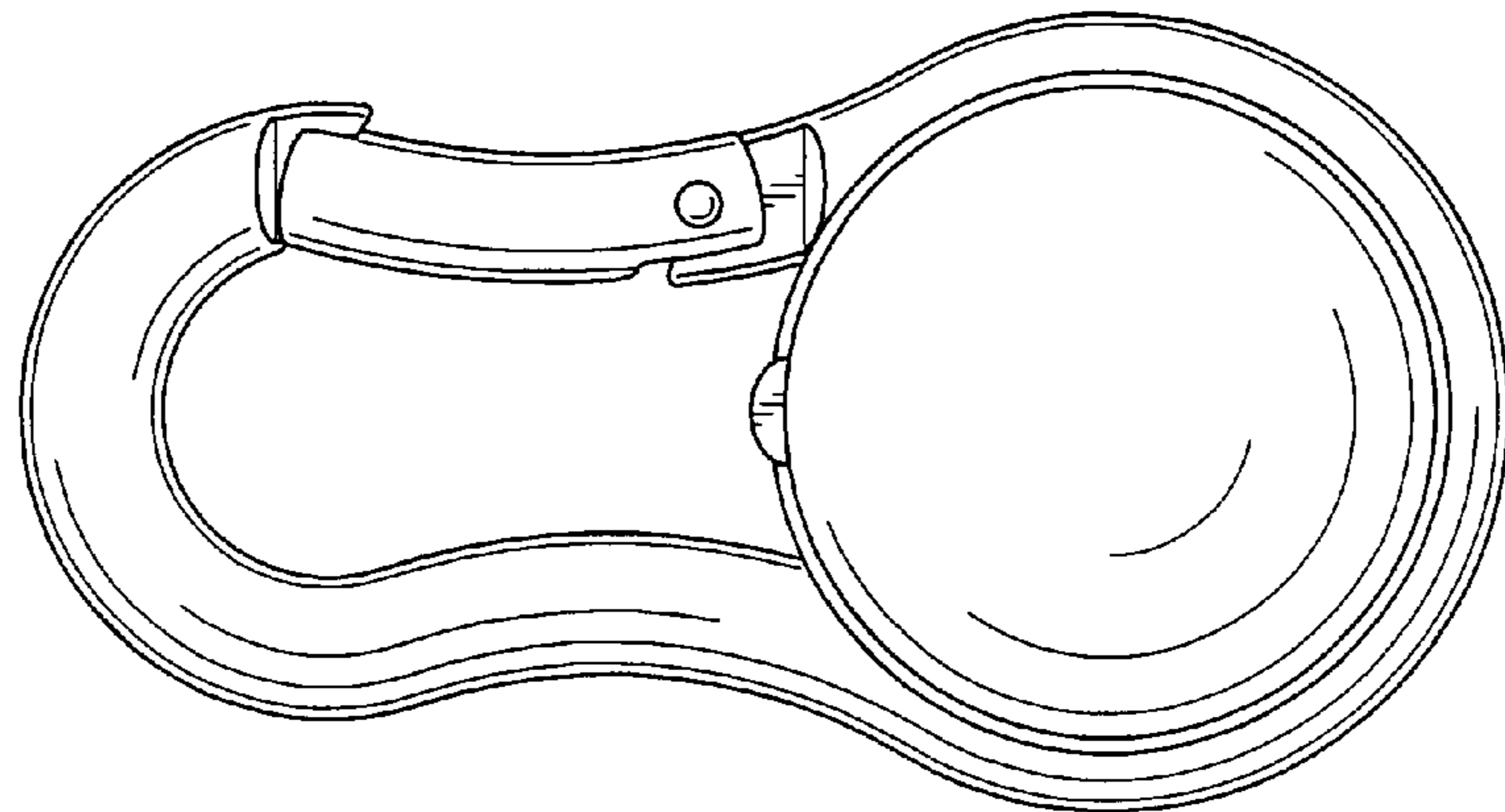
FIG. 1 is a top front perspective view of a carabineer pill box;

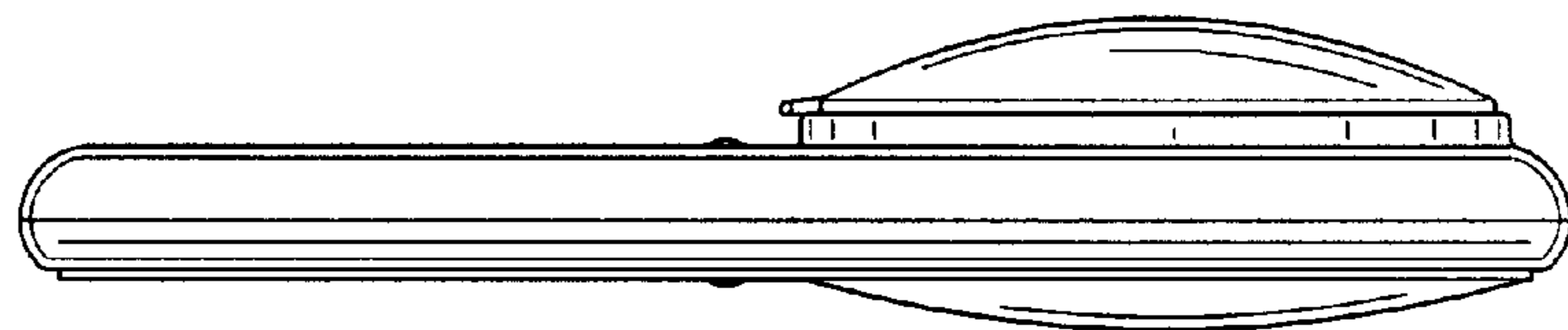




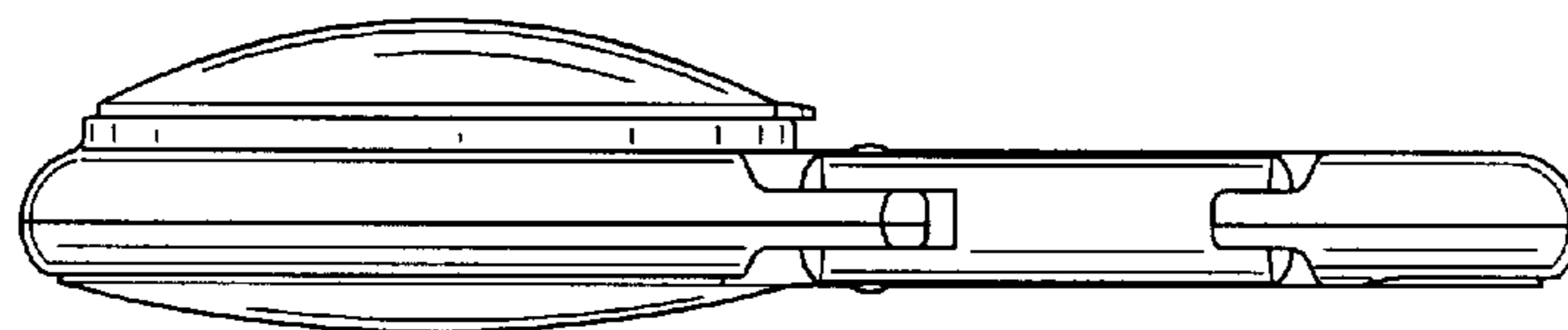

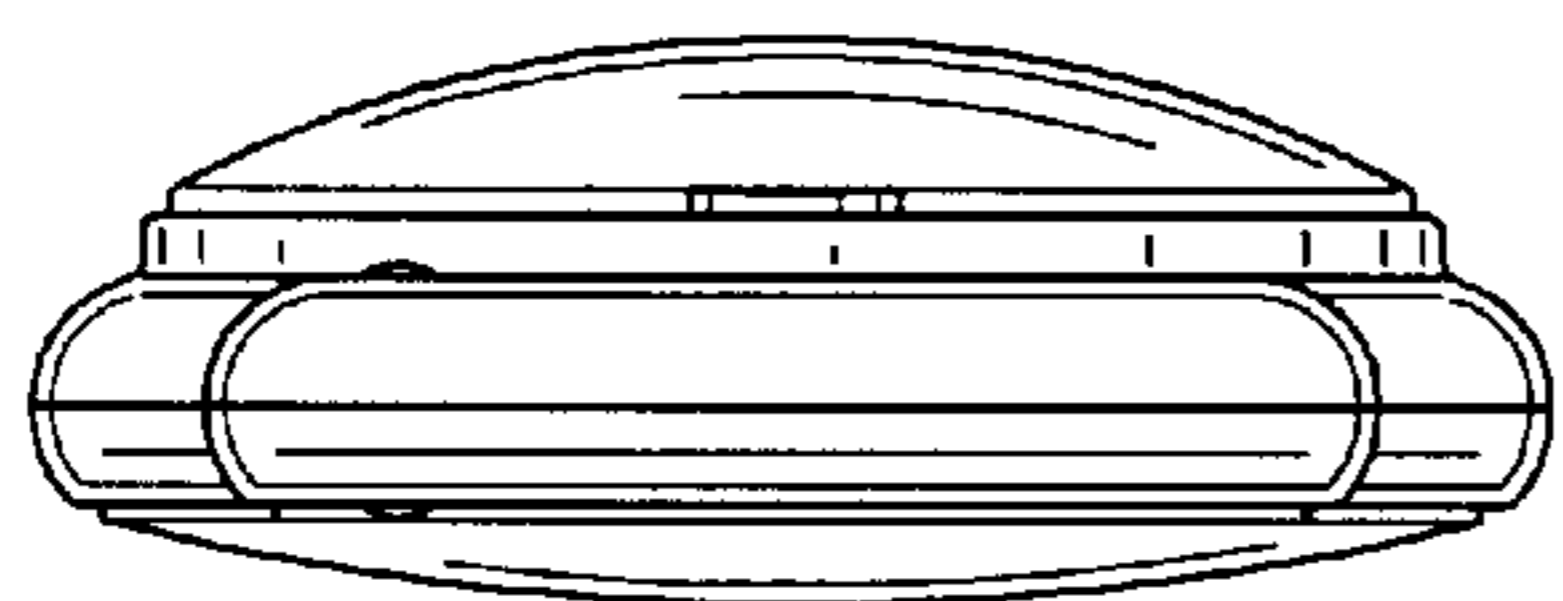

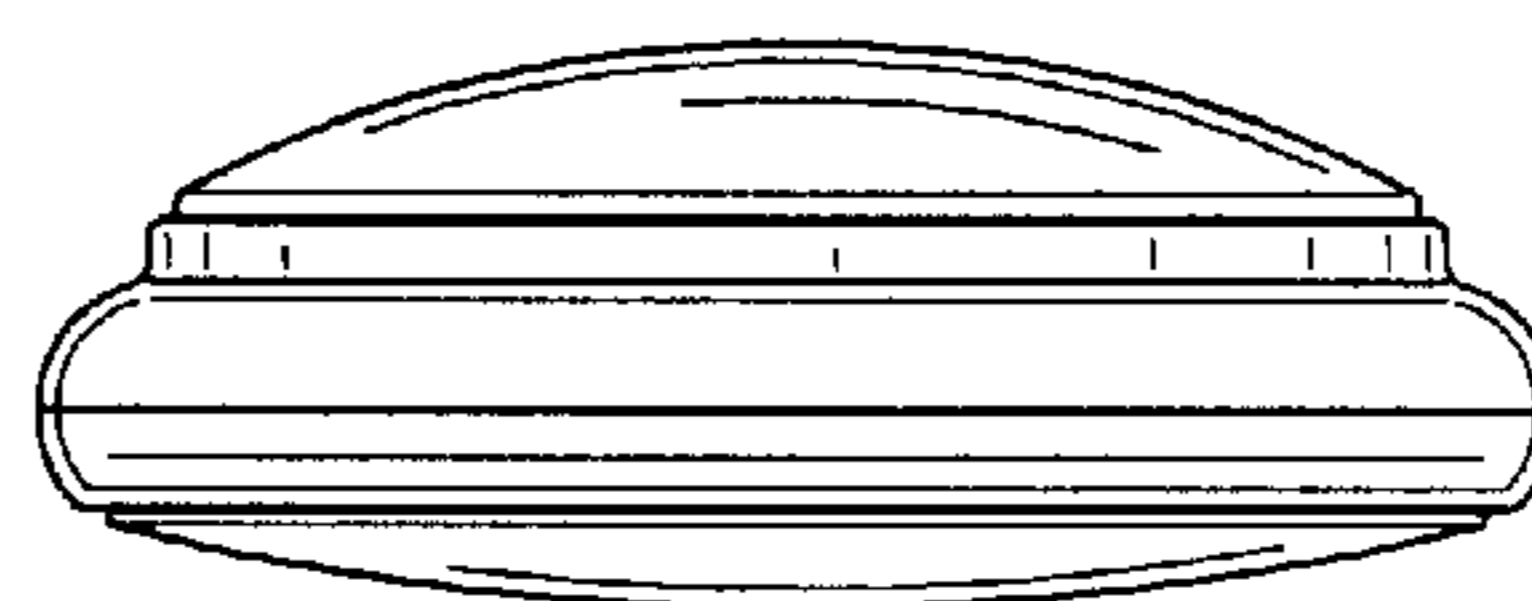

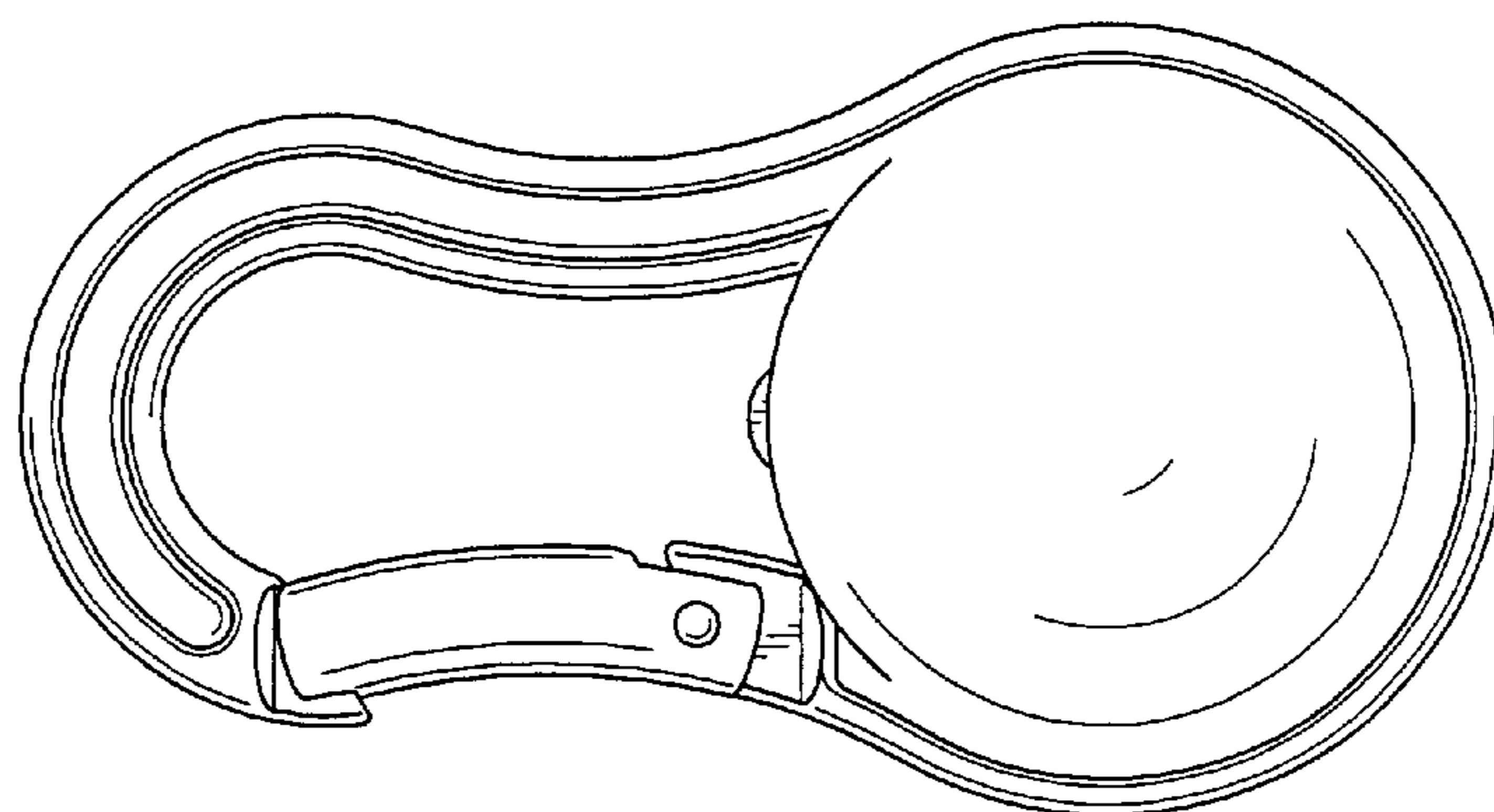

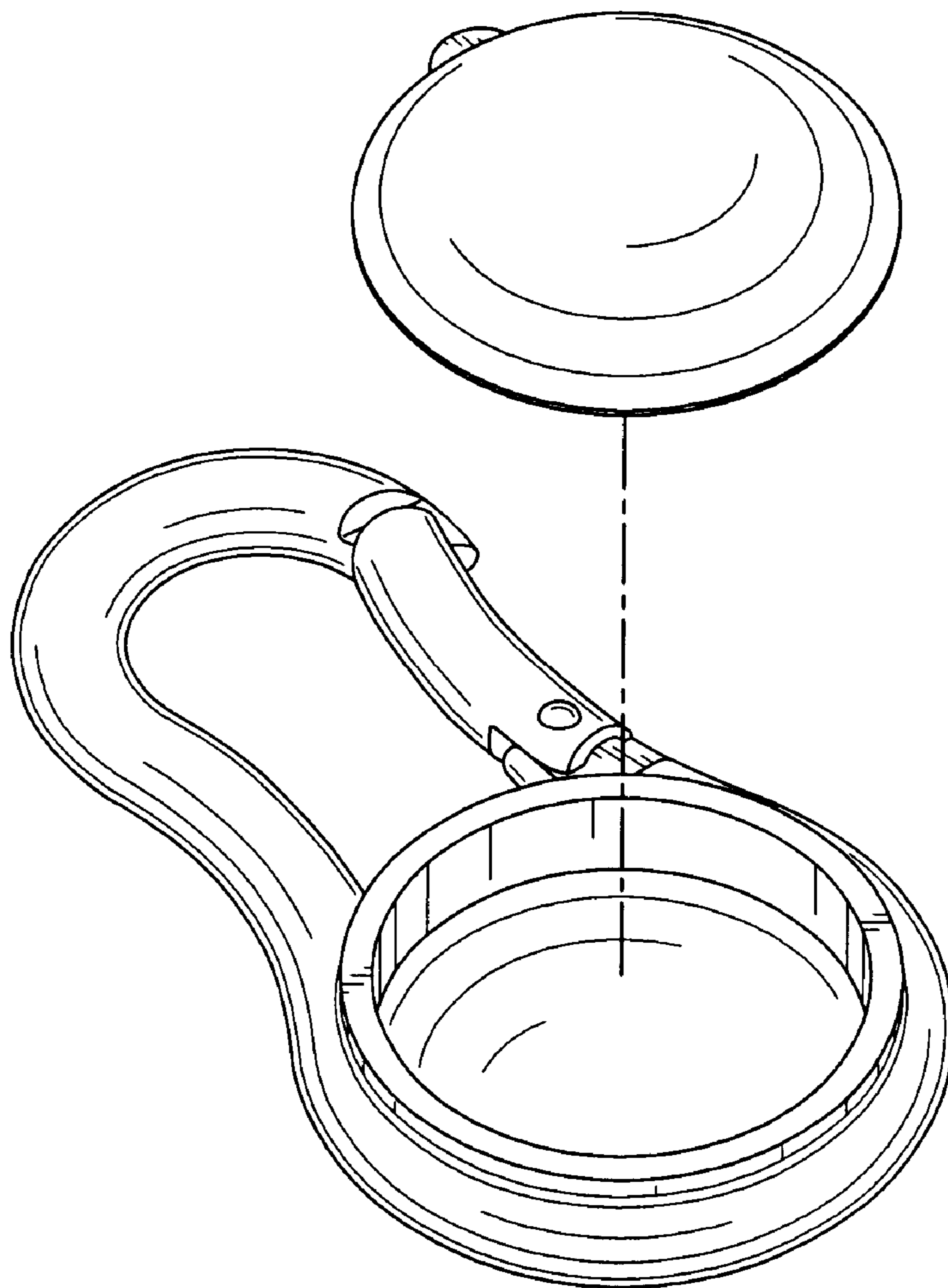
