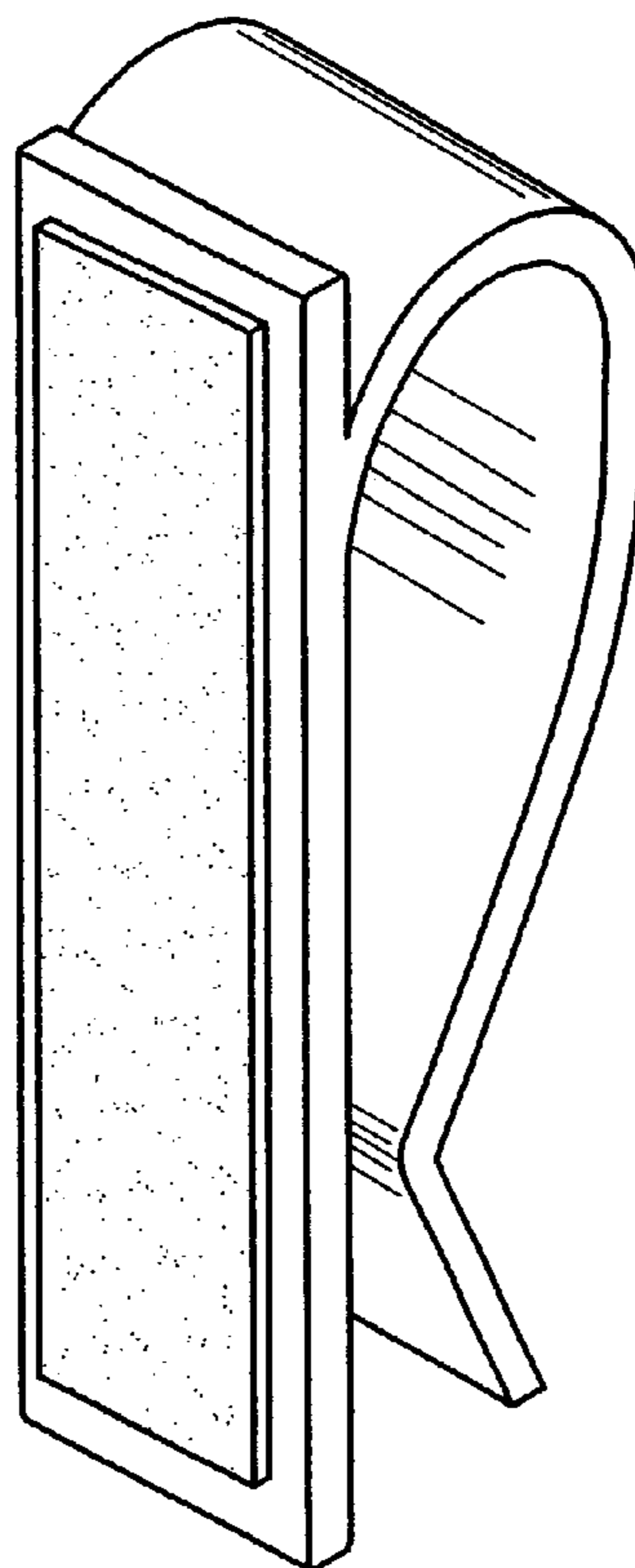
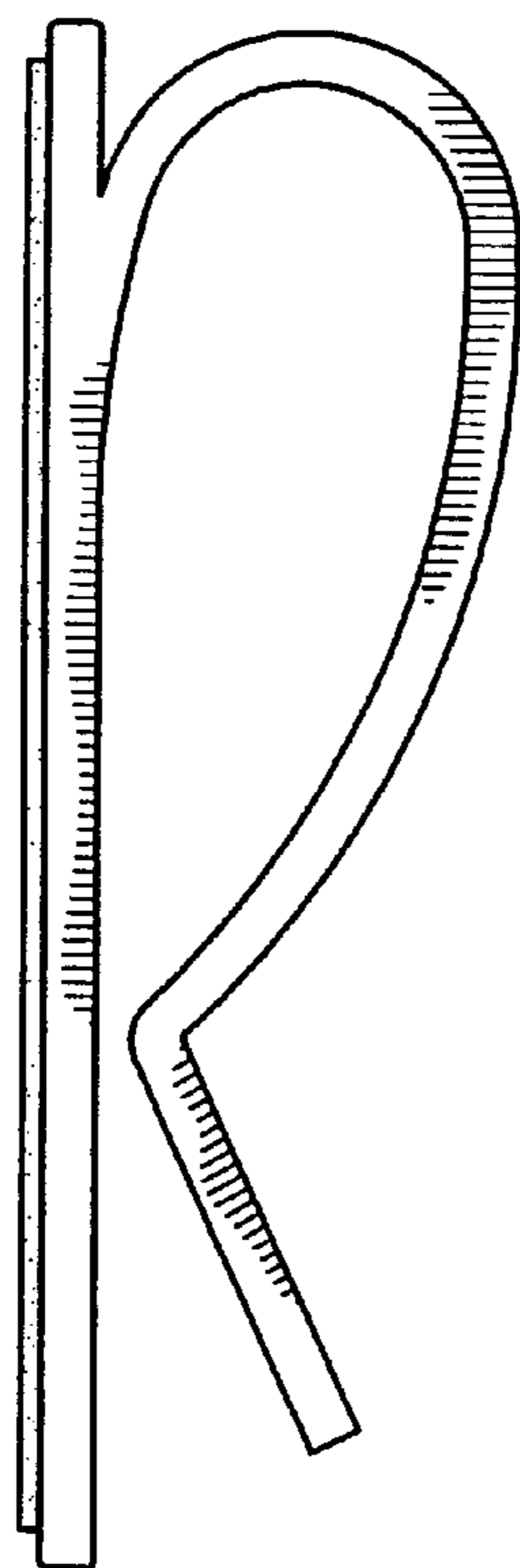
(57) **CLAIM**

The ornamental design for an adhesive backed clip, as shown and described.

**DESCRIPTION**

FIG. 1 is a right side elevational view of an adhesive backed clip showing my new design;

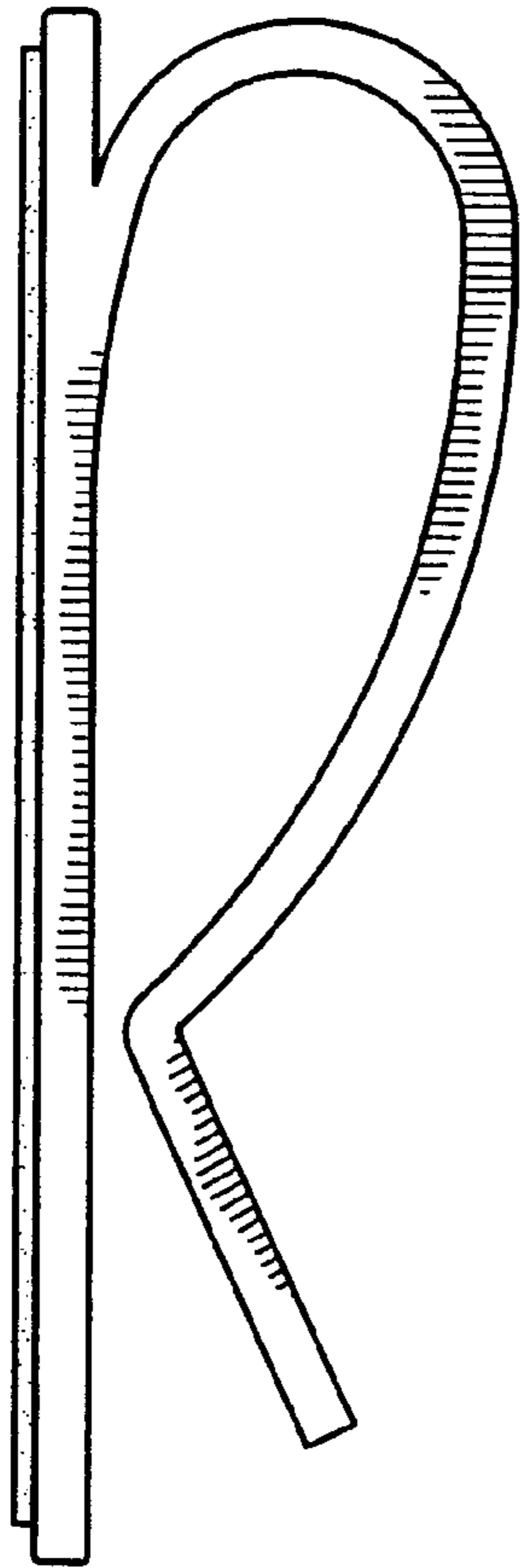

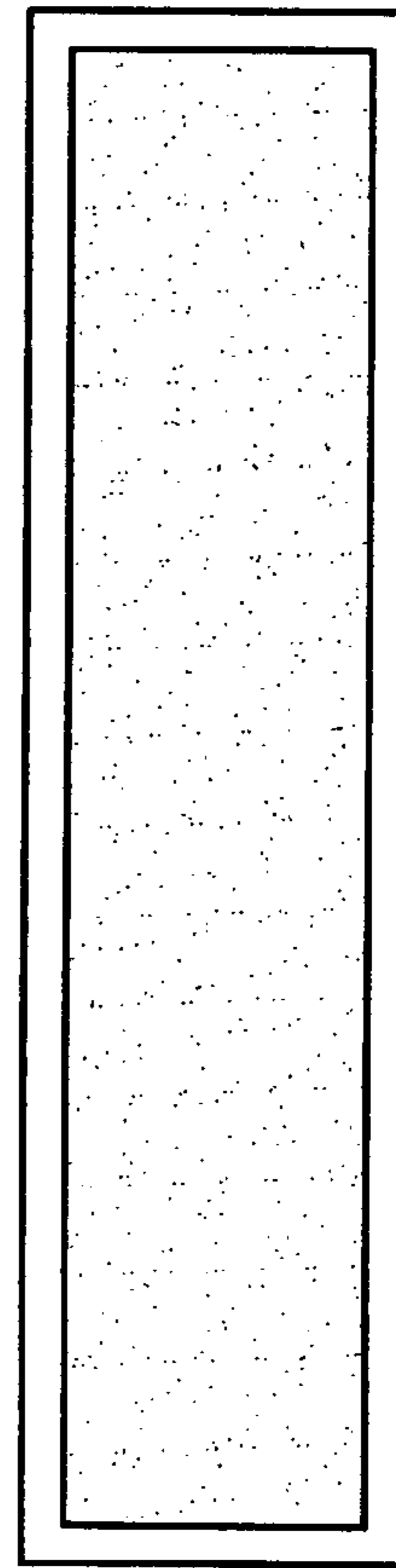

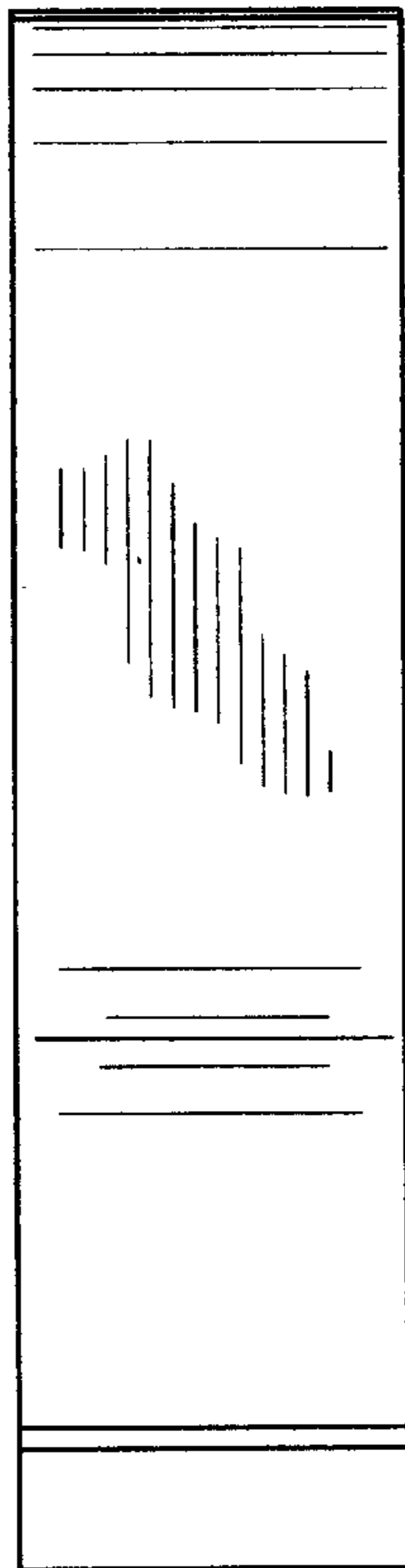

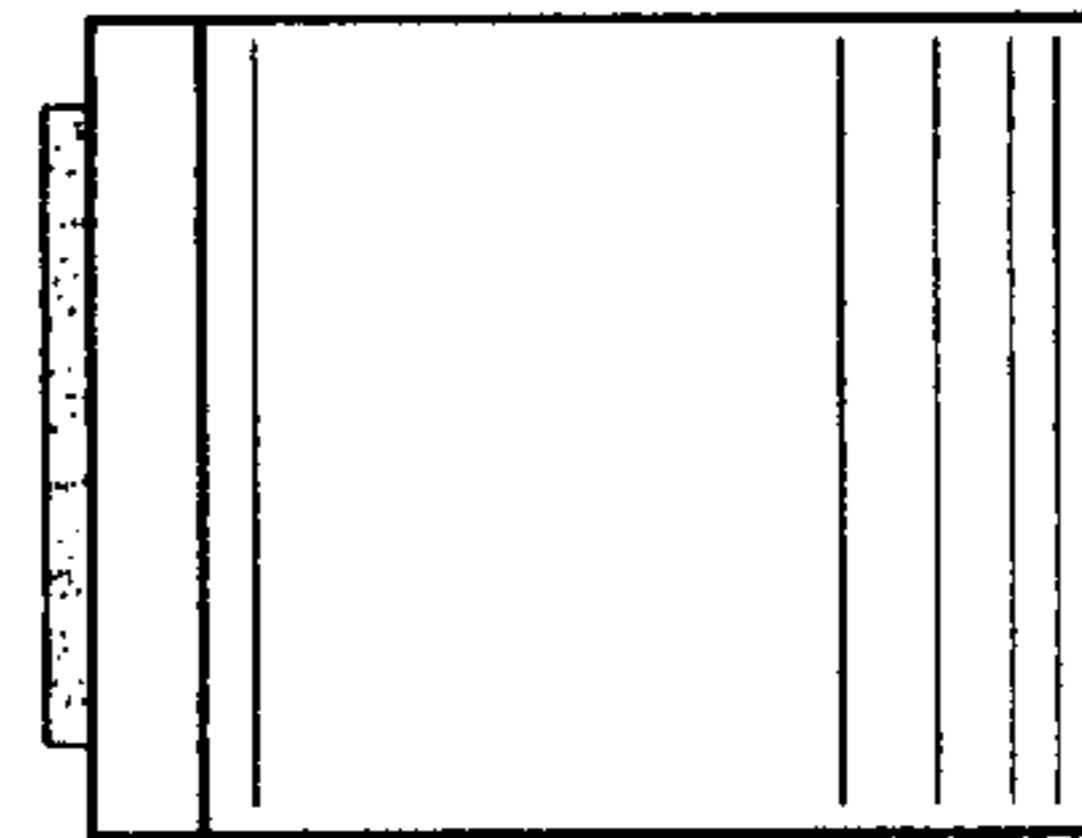

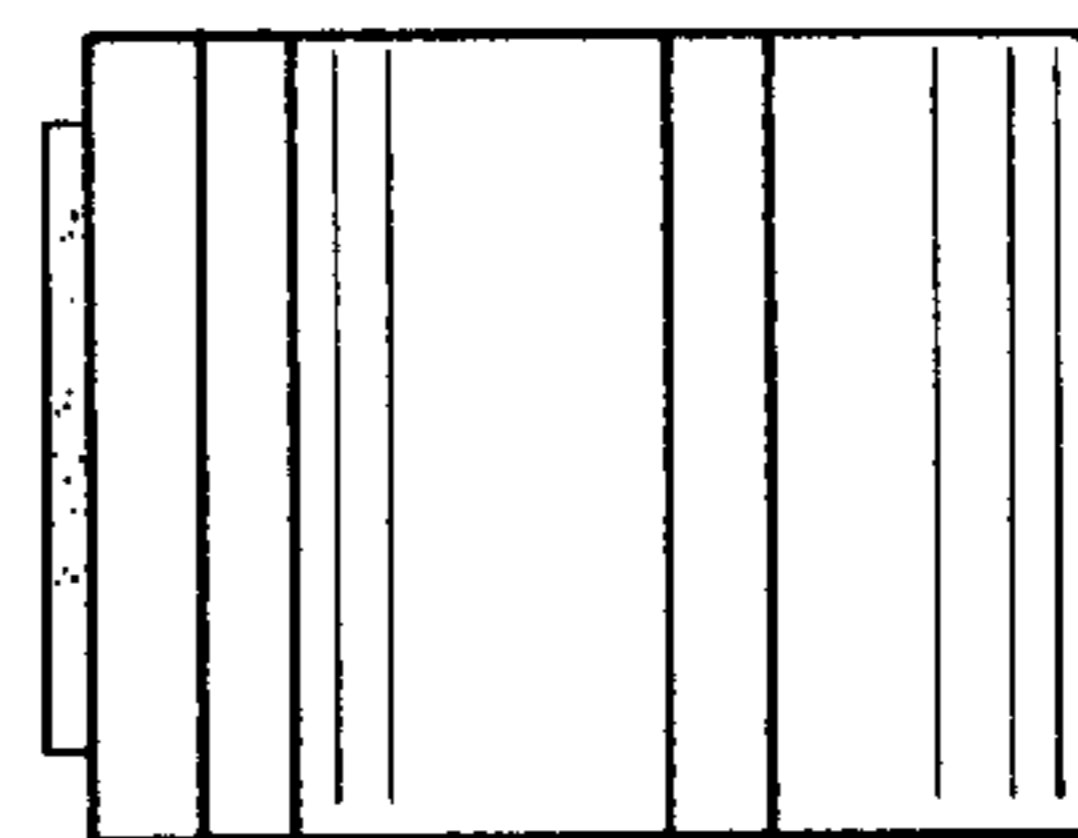

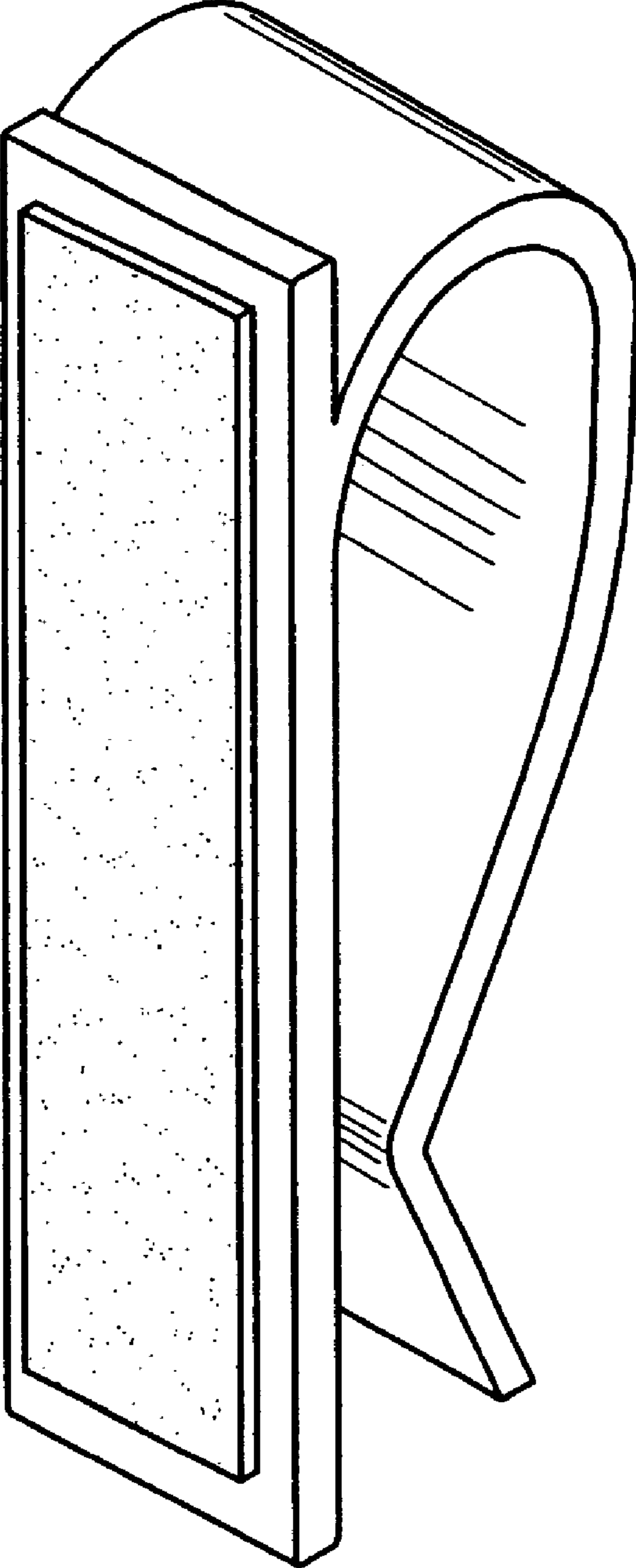
