identical with the front view;

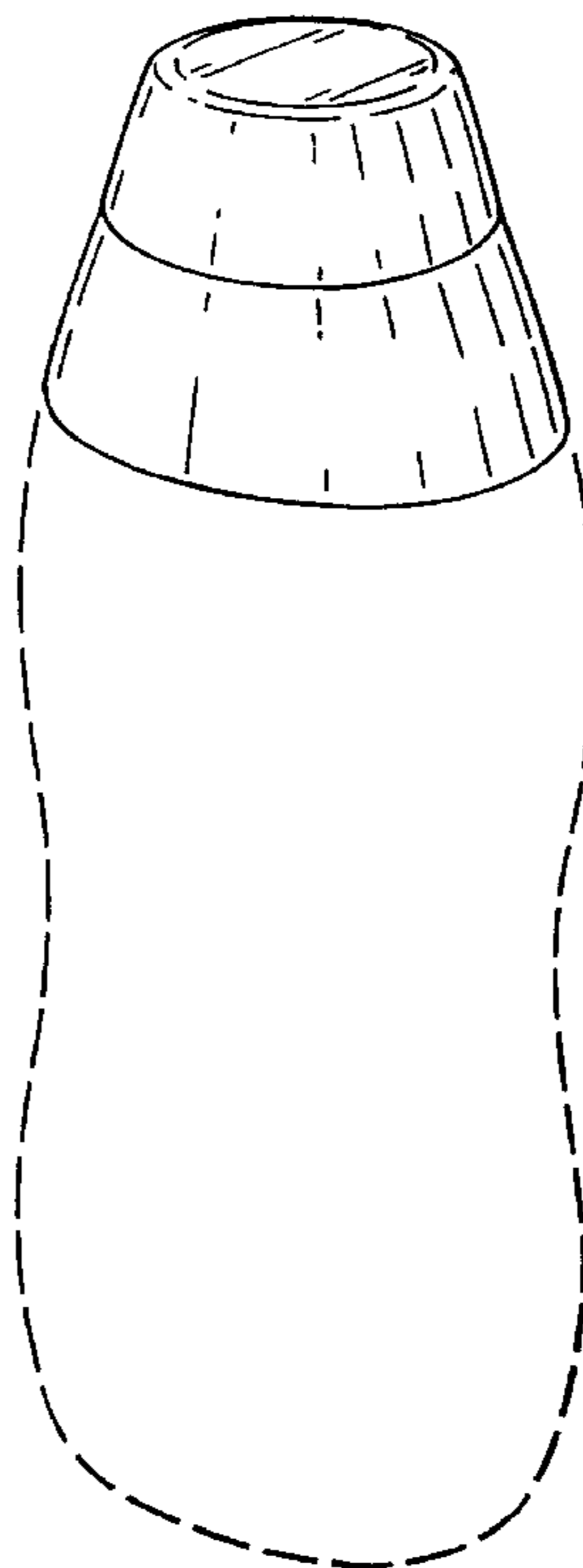
FIG. 3 is a left side view thereof, right side view is omitted

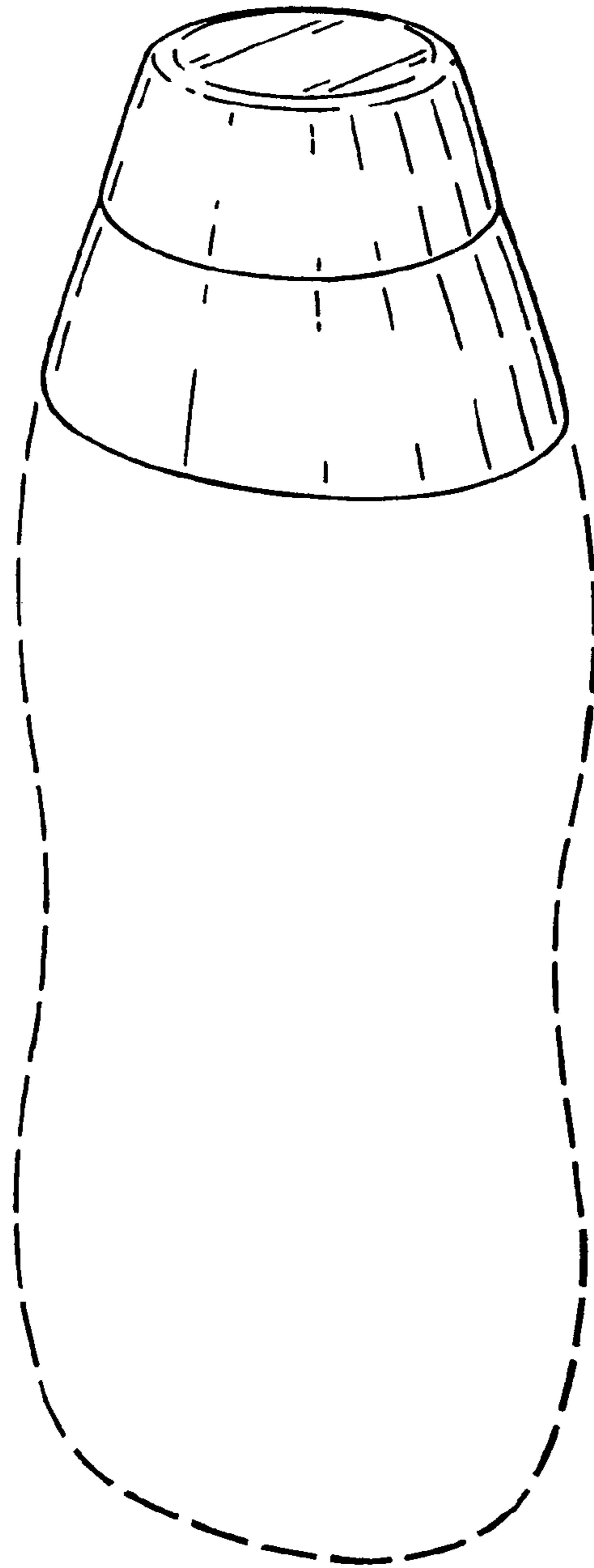

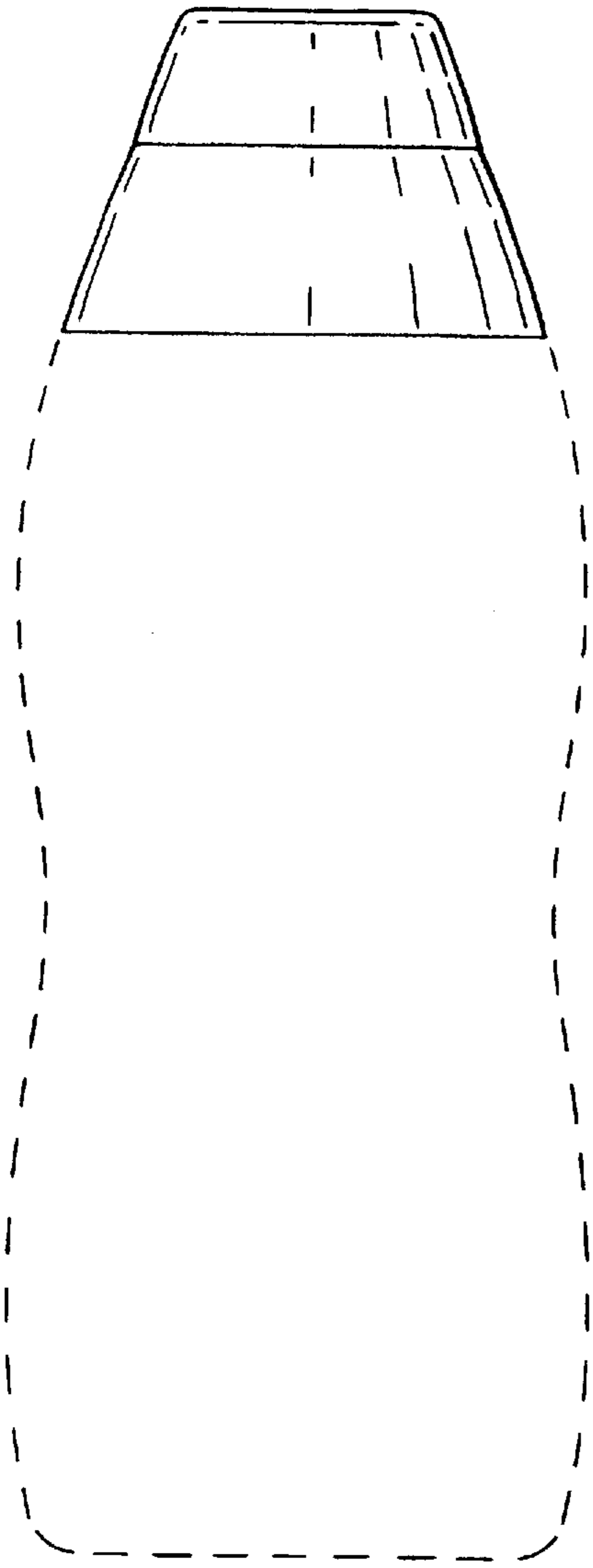

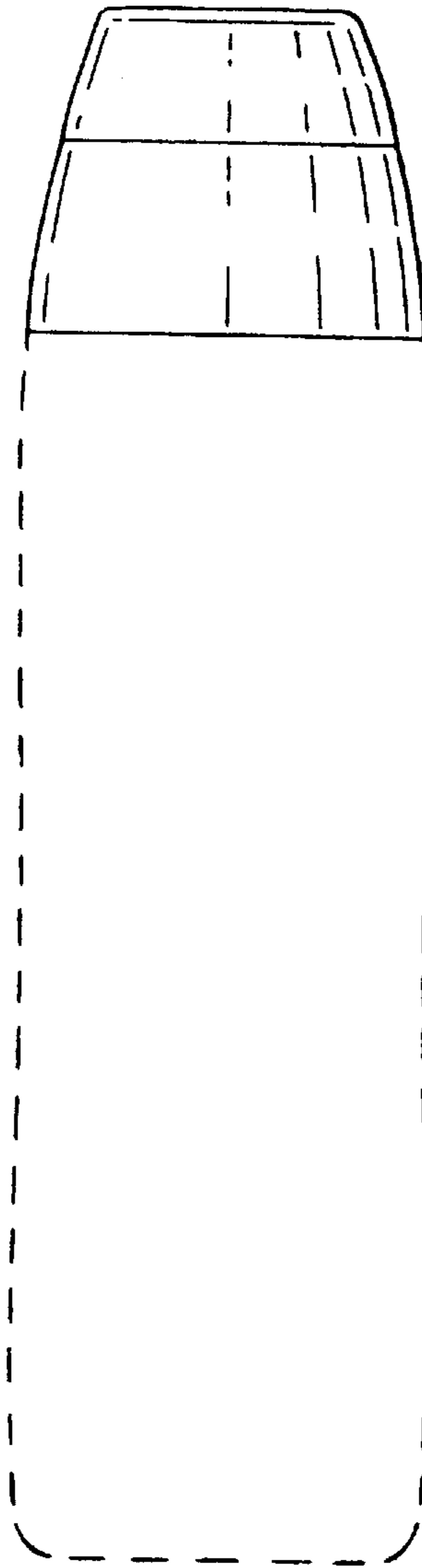

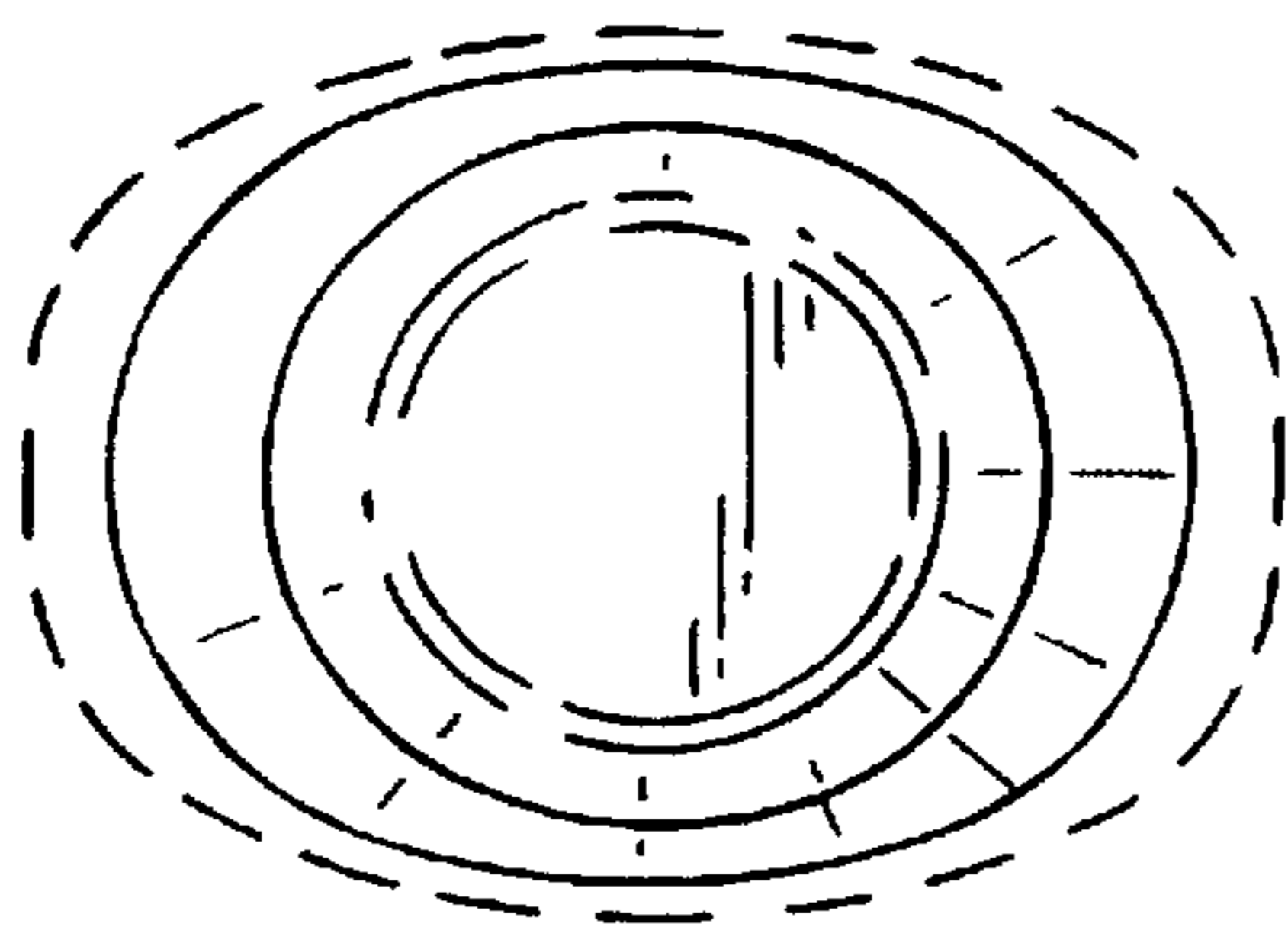

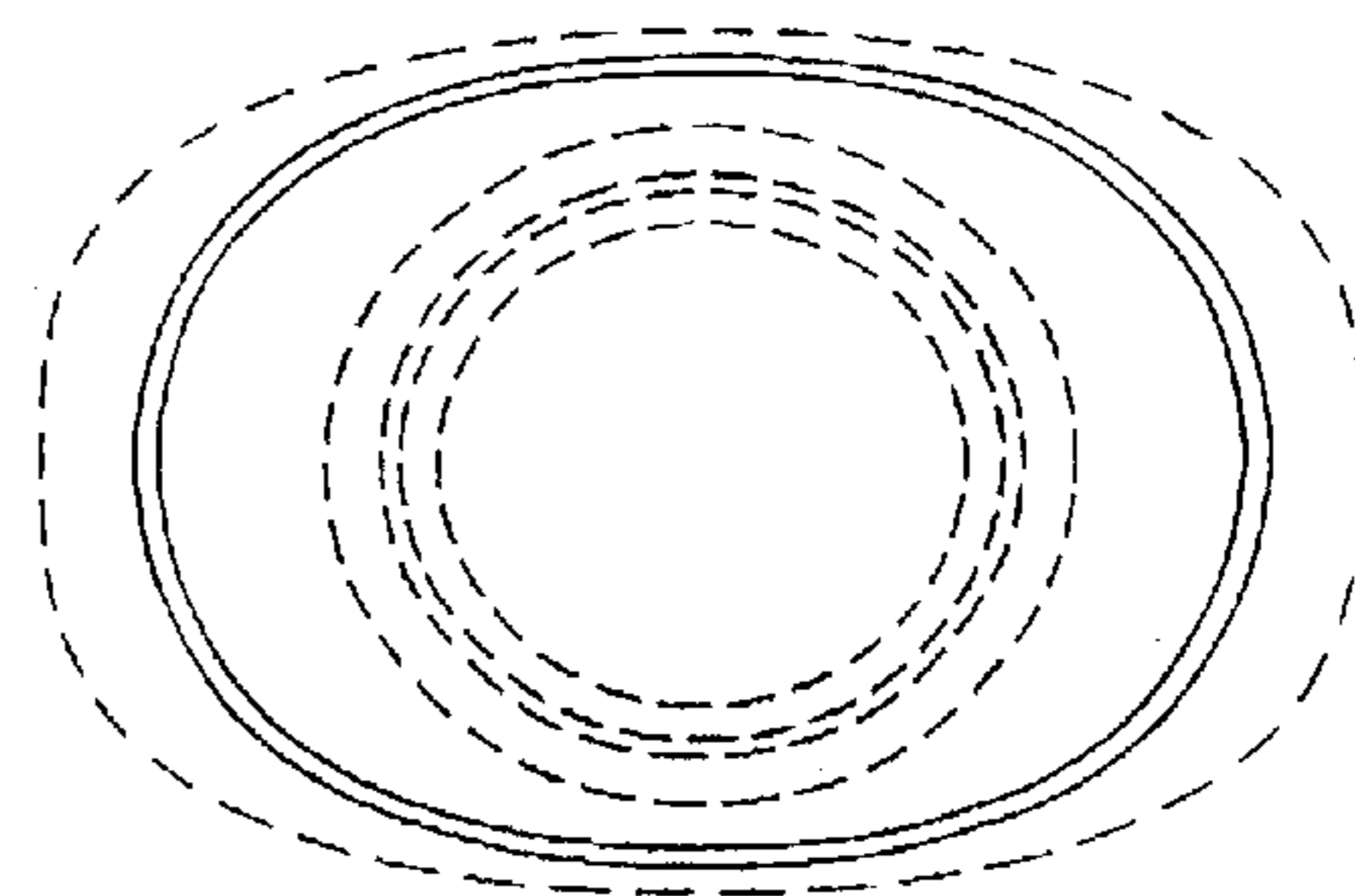
