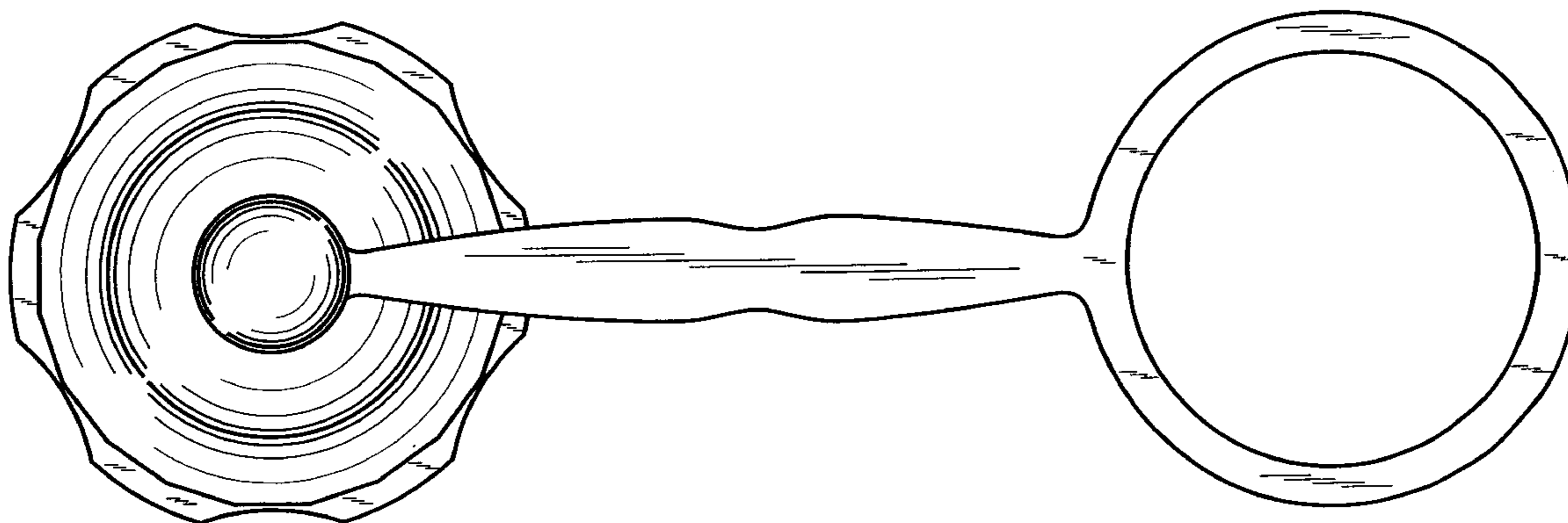
(57) **CLAIM**

The ornamental design for a lid and strap assembly, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a lid and strap assembly according to the present design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a back elevational view thereof;
FIG. 5 is a first side elevational view thereof;
FIG. 6 is a second side elevational view thereof;
FIG. 7 is a cross-sectional view taken along line 7—7 of FIG. 3; and,
FIG. 8 is a cross-sectional view taken along line 8—8 of FIG. 3.

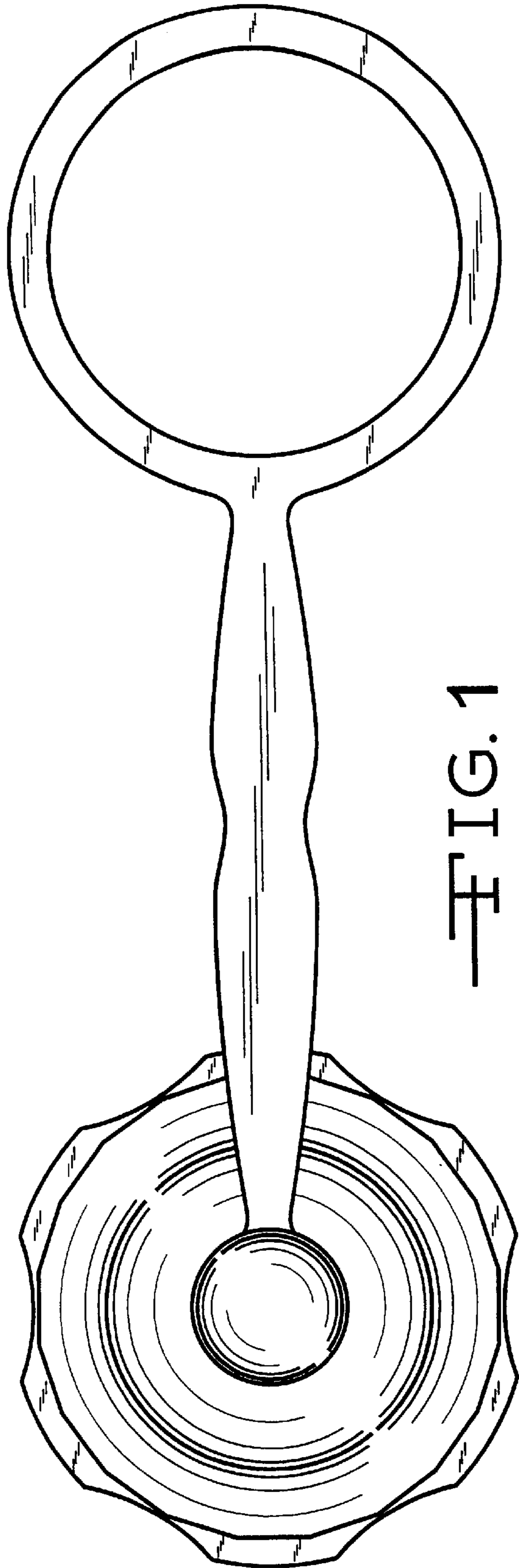

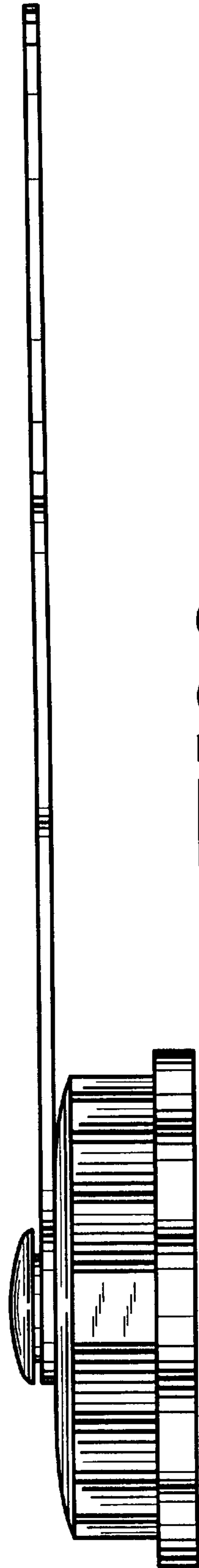
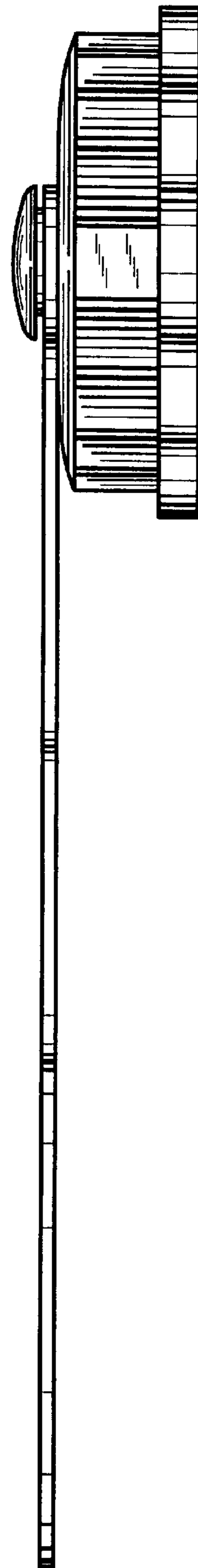
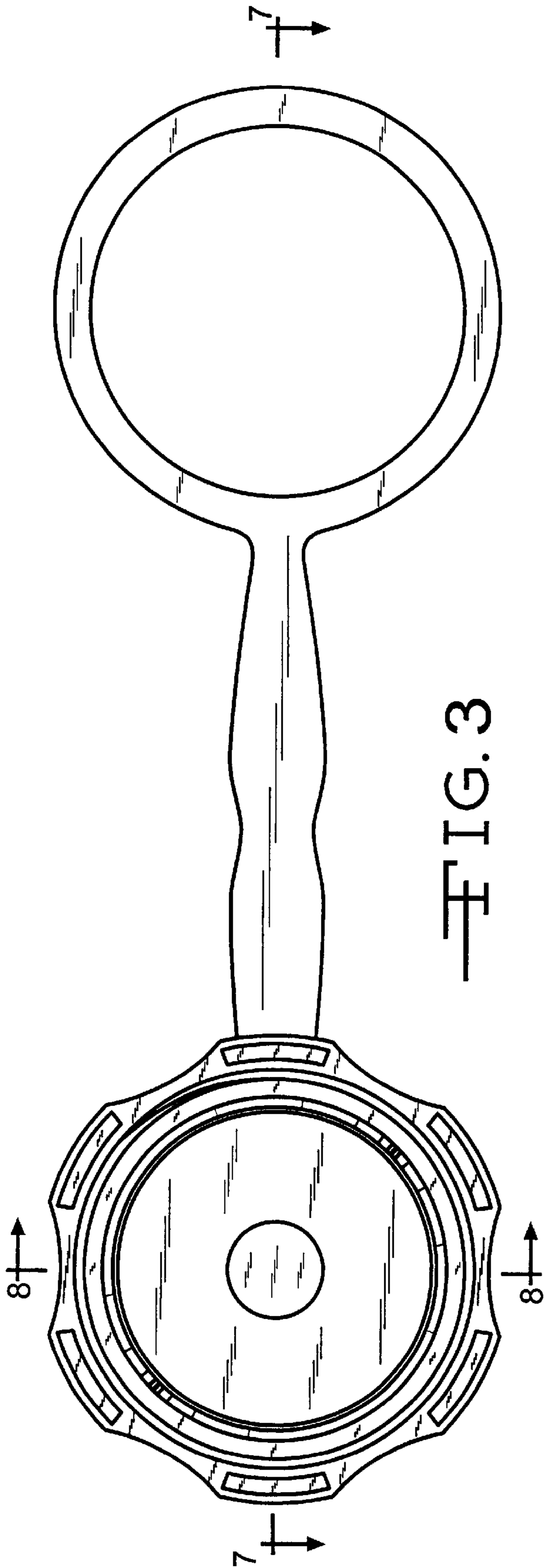

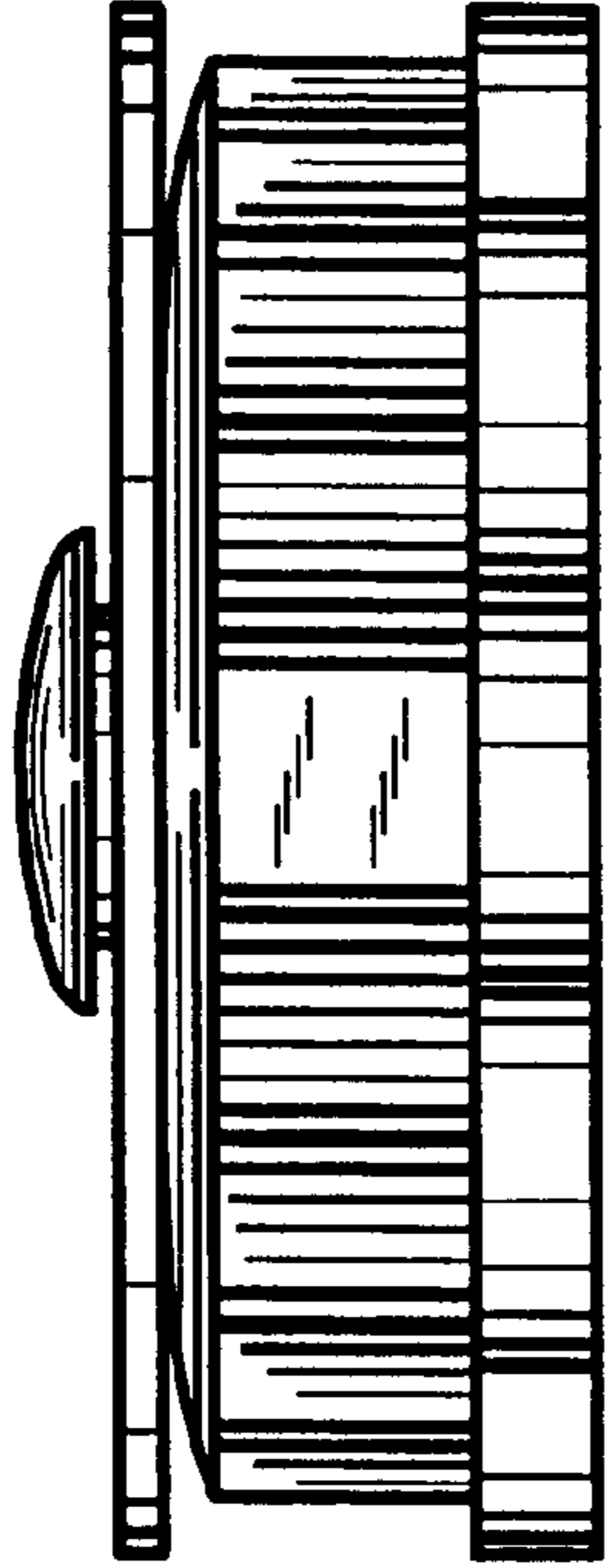

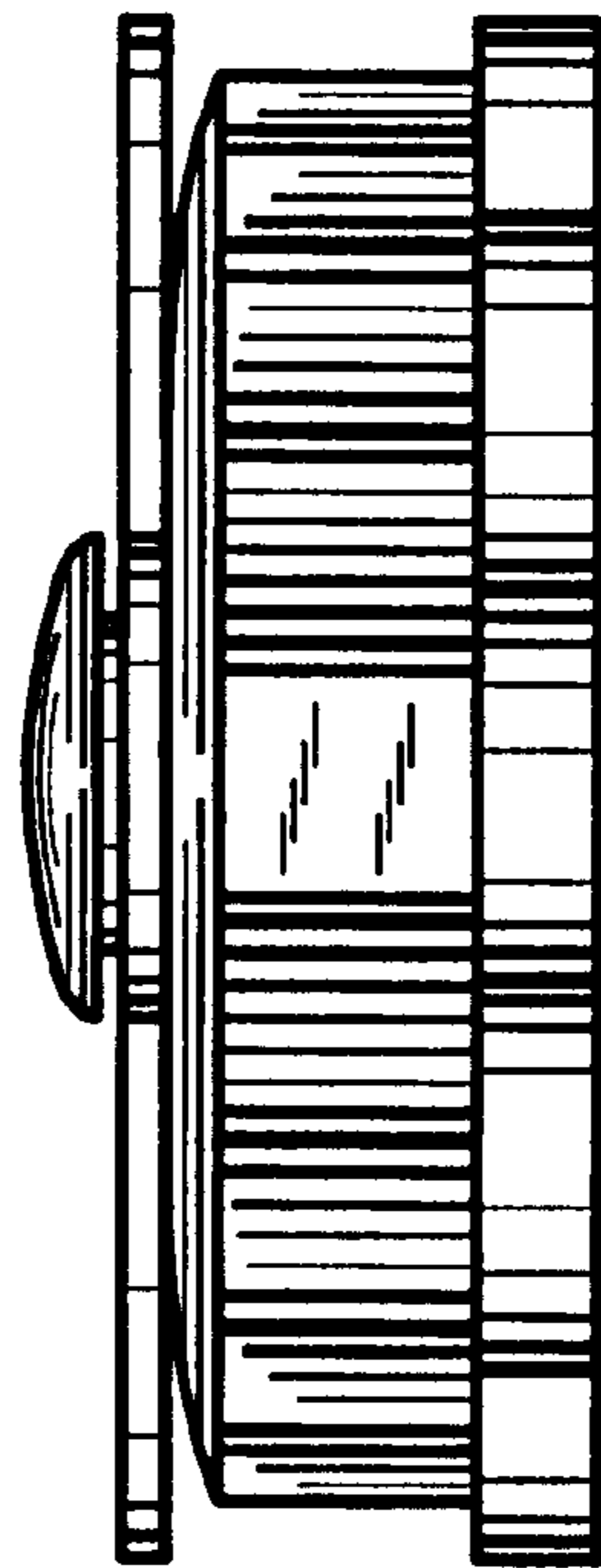

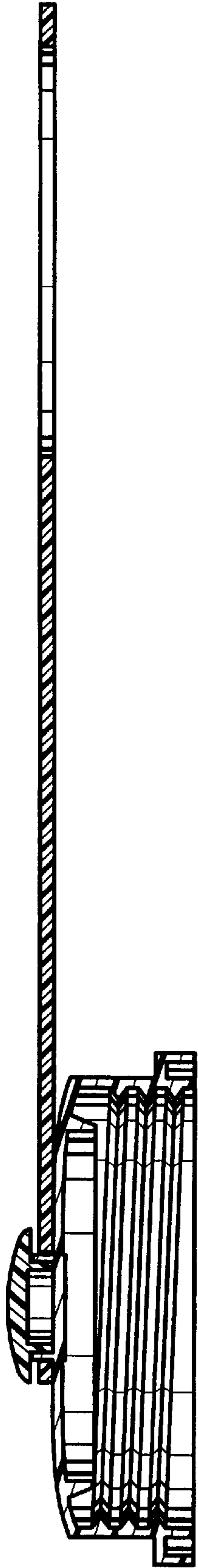

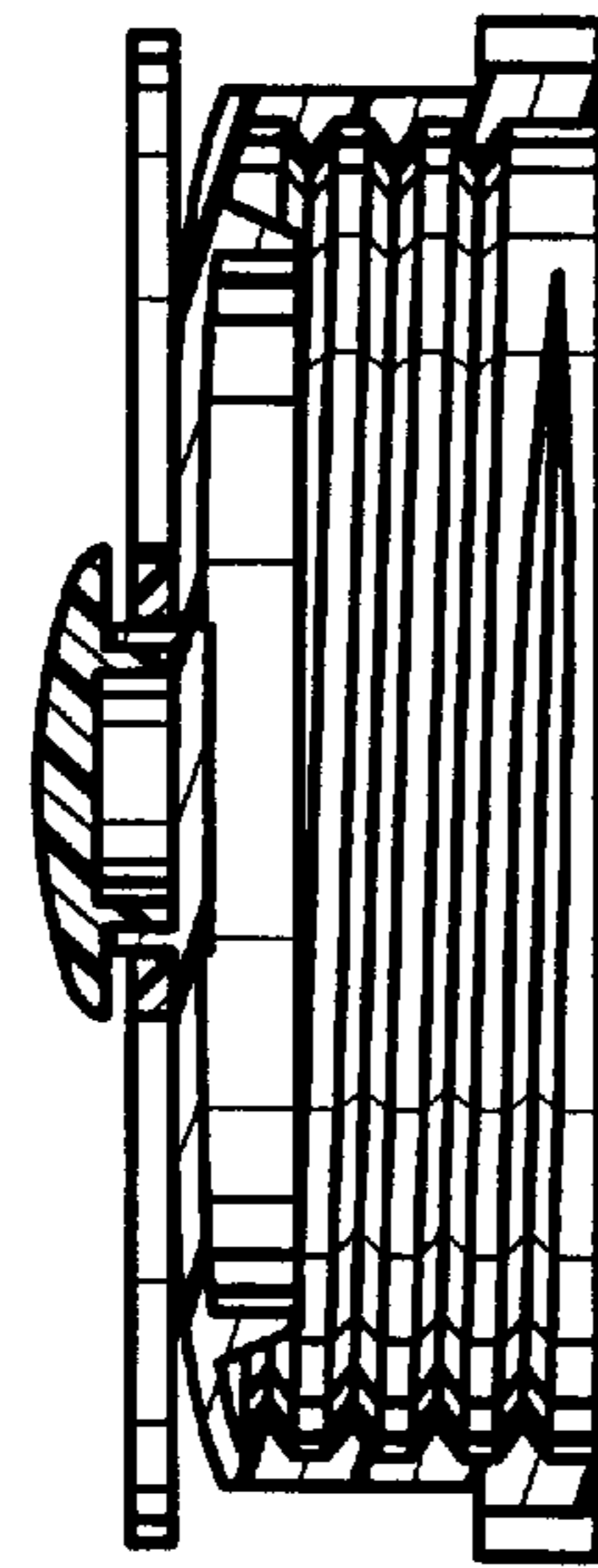
