The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bottle according to our new
design;

FIG. 2 is a front elevation view thereof, the rear, right side,
and left side elevational views being identical thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof; and,

FIG. 5 is a cross-section view taken along line 5—5 as
shown in FIG. 2.

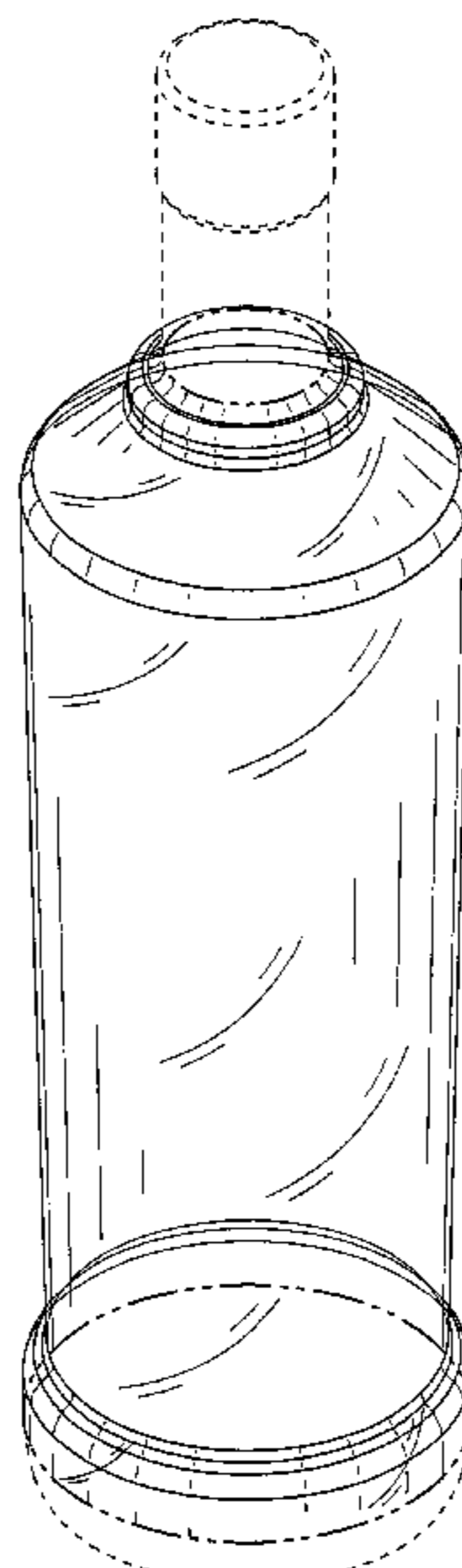

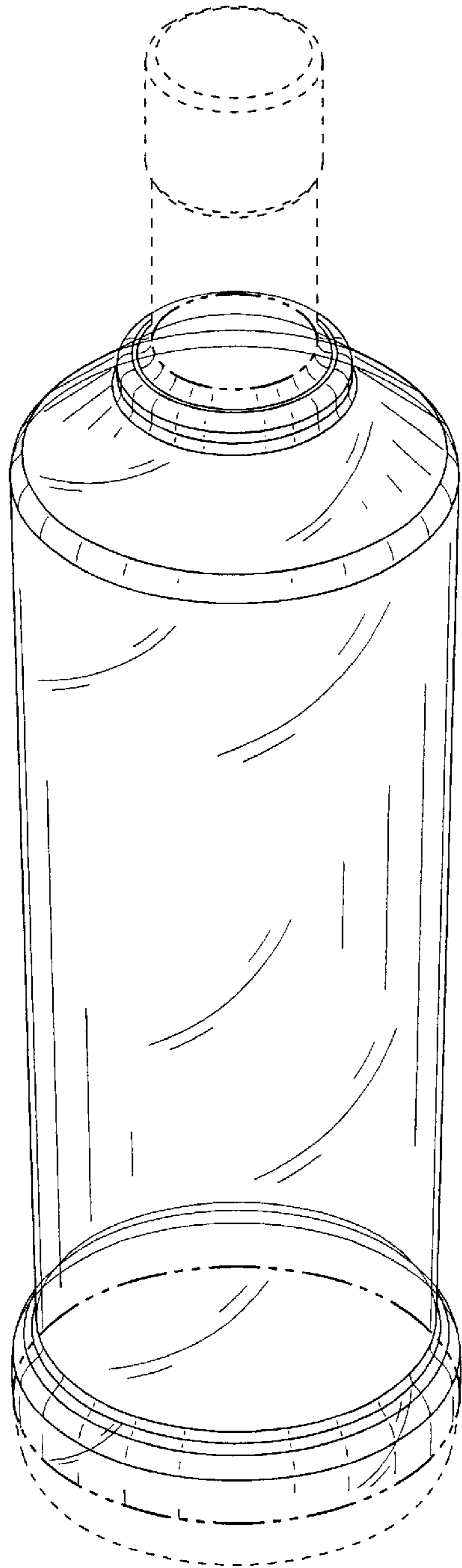

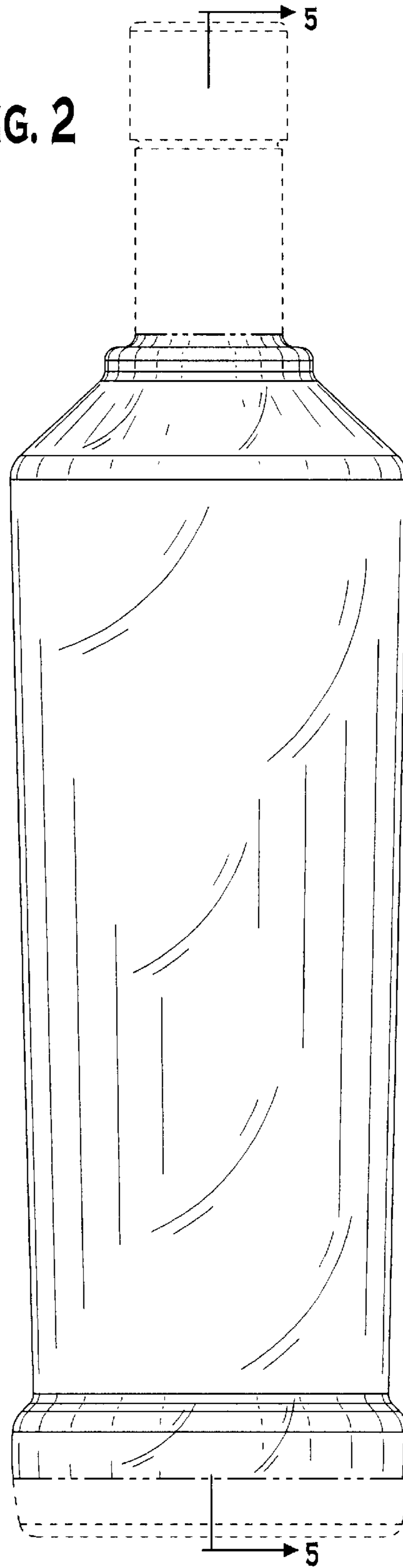

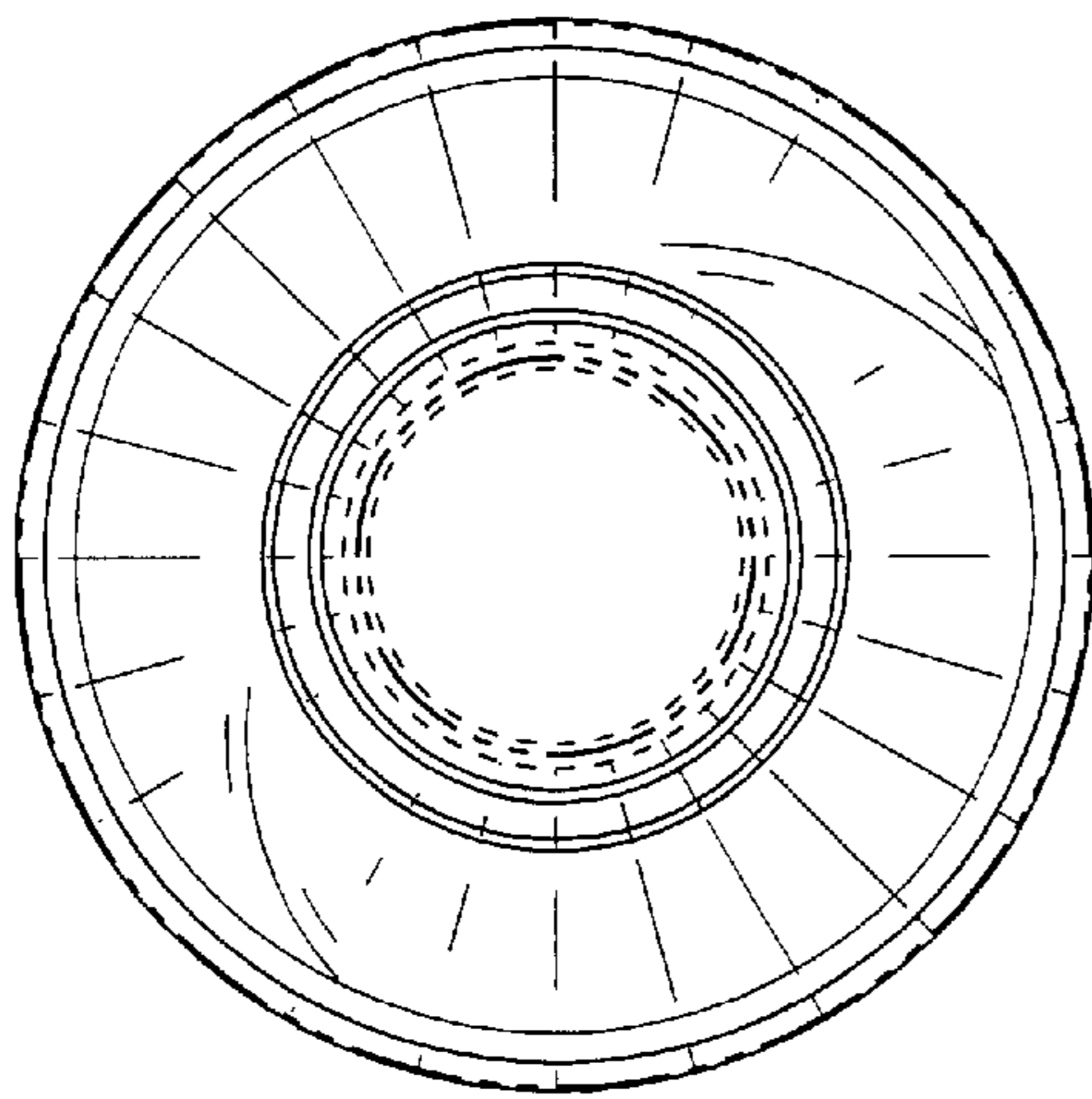

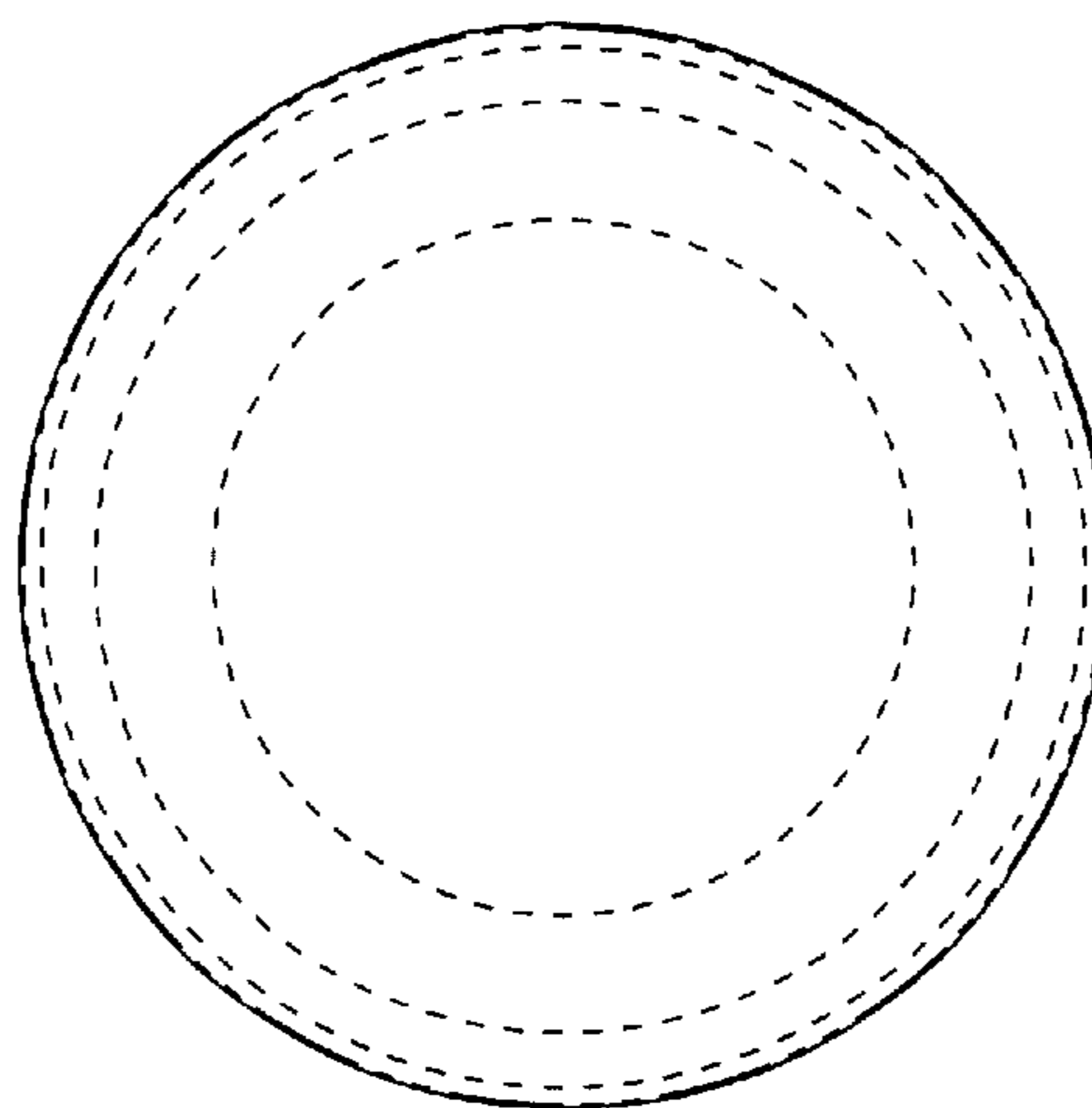
