The ornamental design for a front face of a vehicle wheel as shown and described.

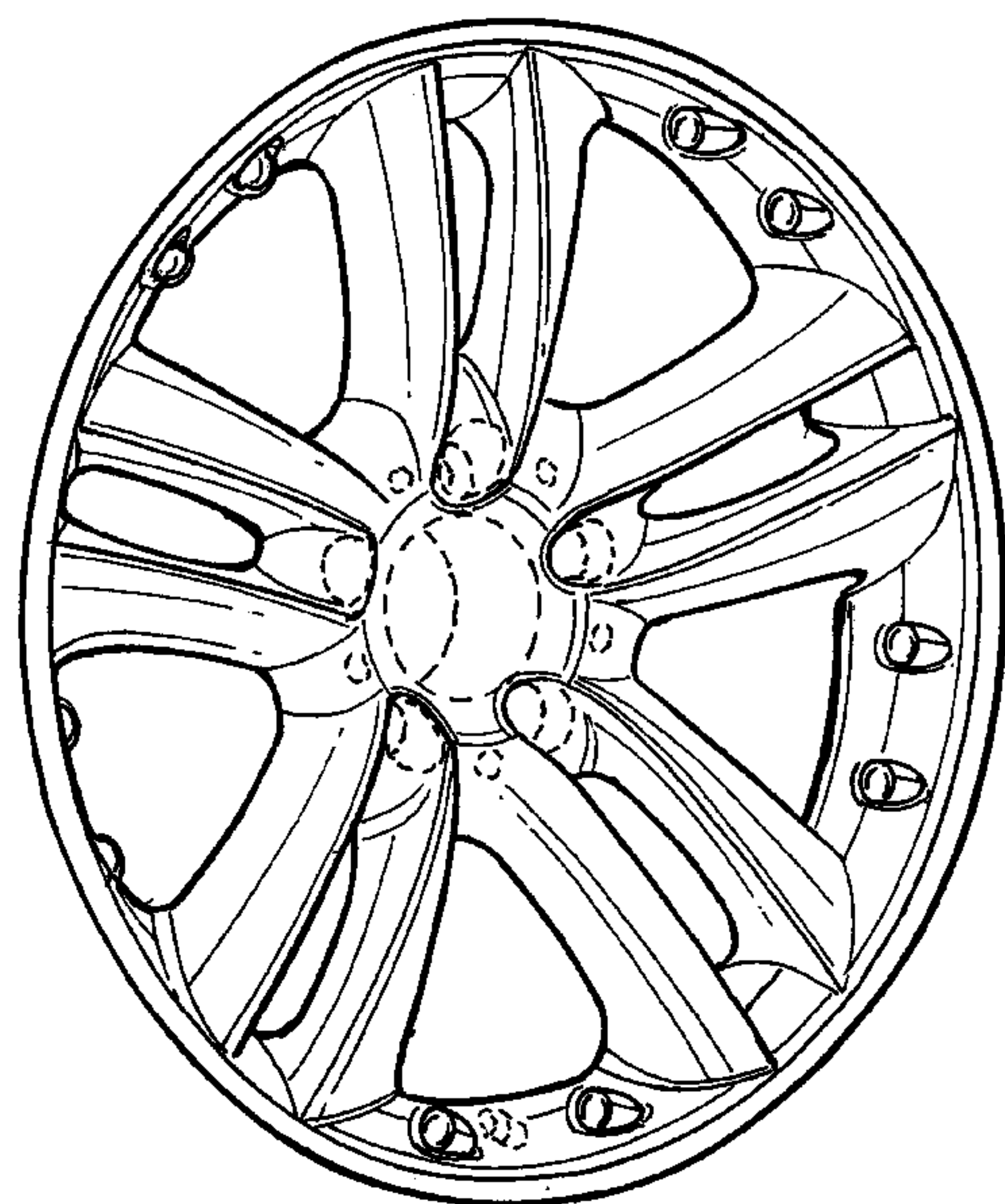
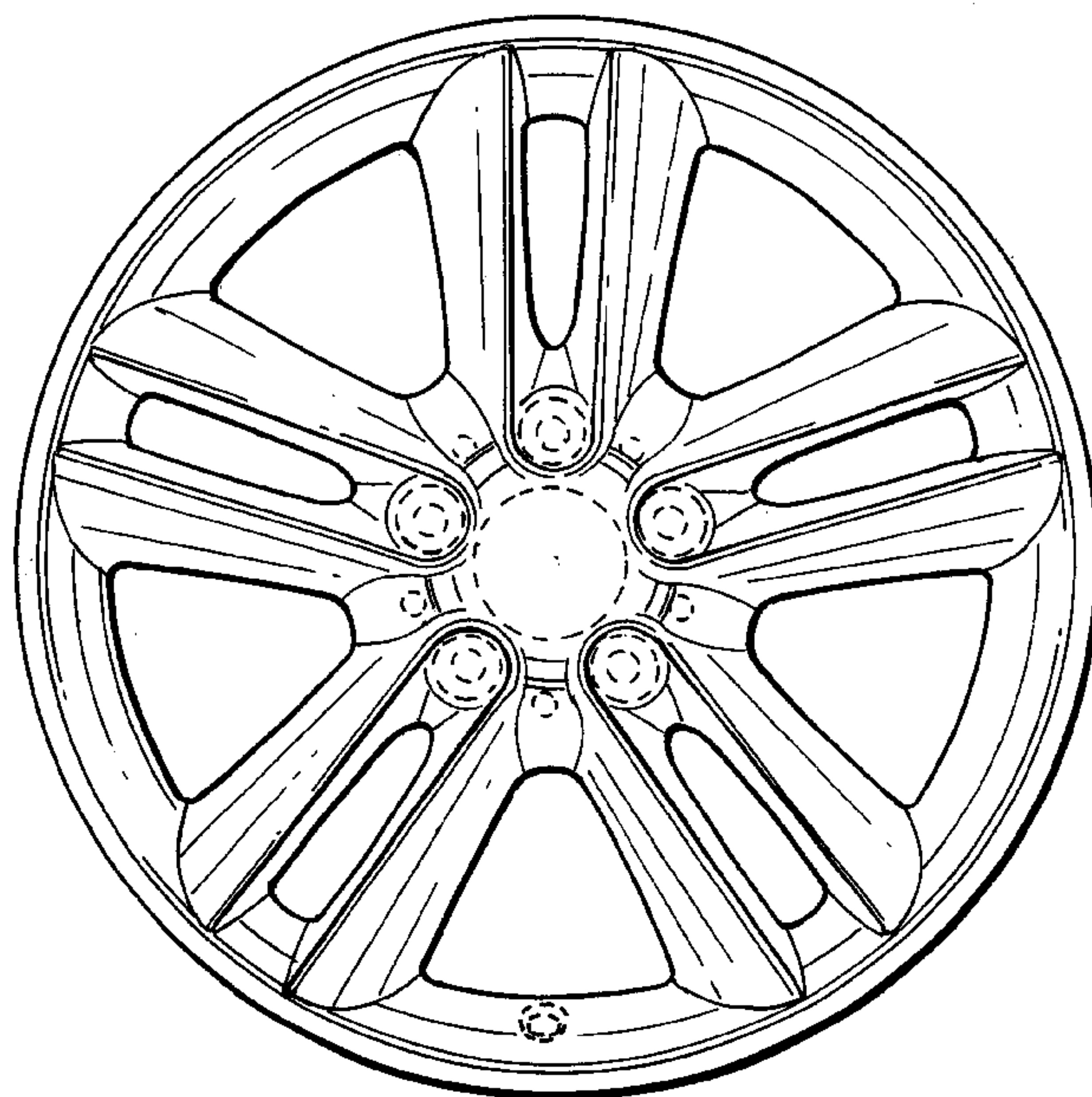
DESCRIPTION

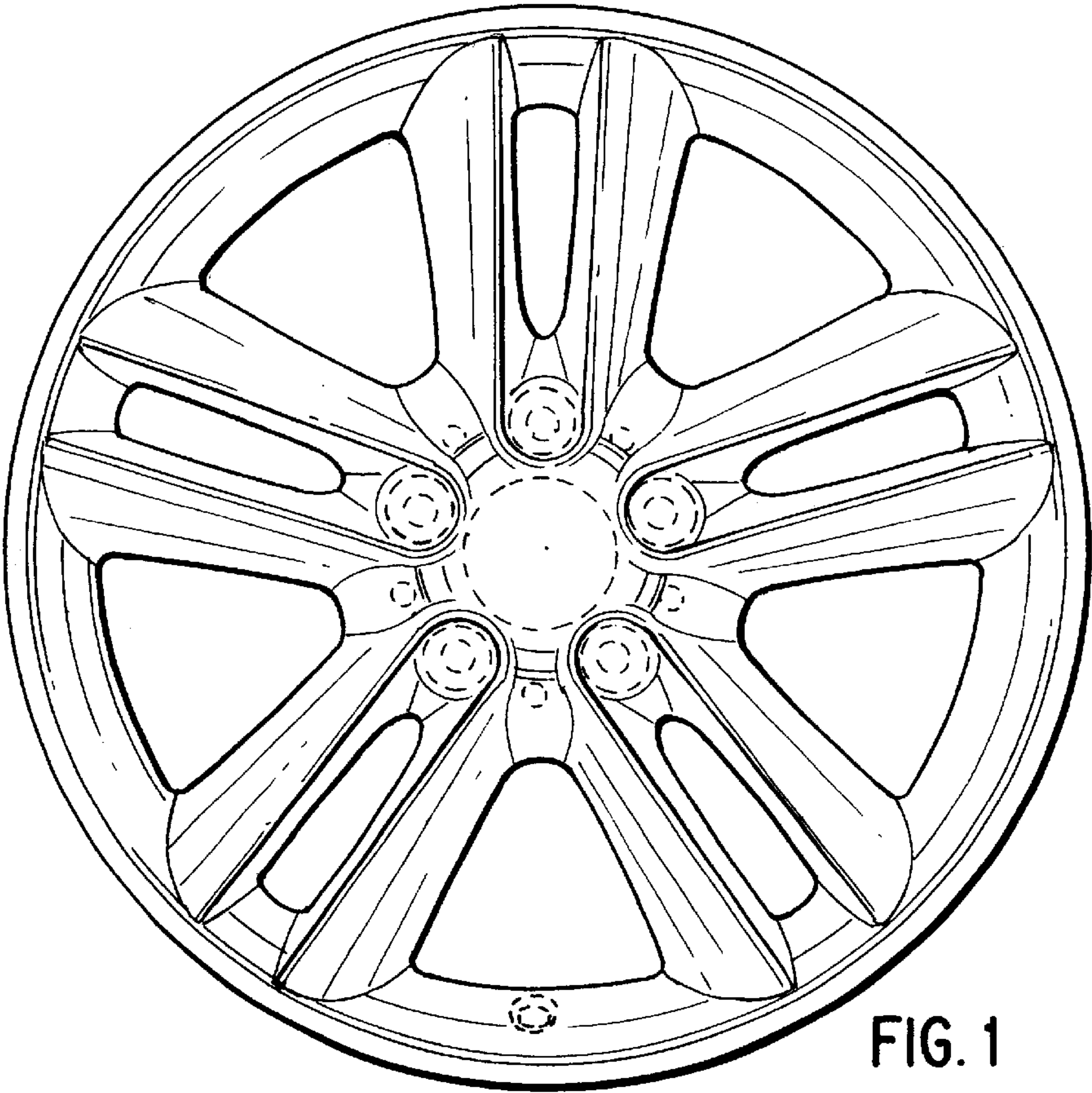

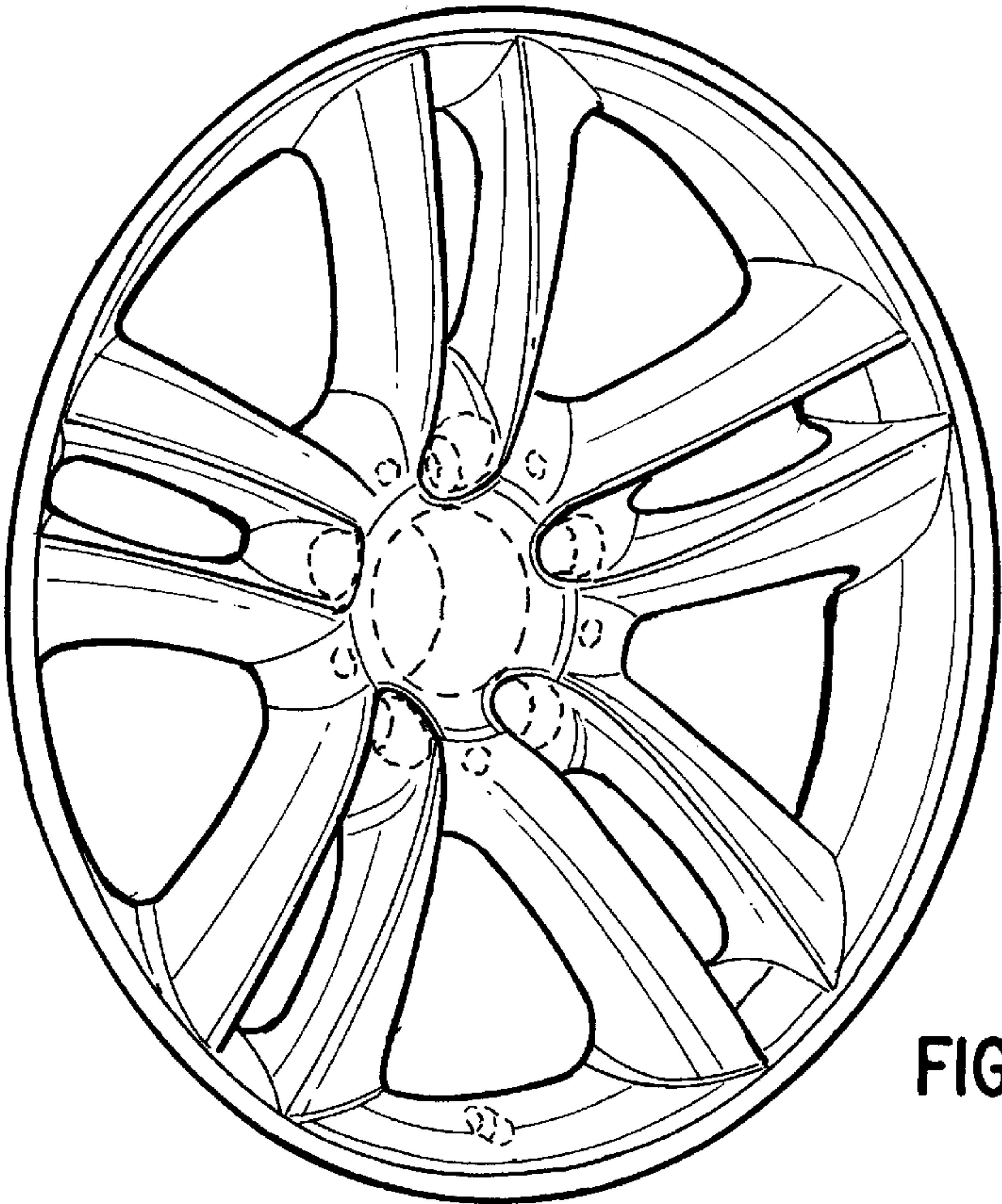

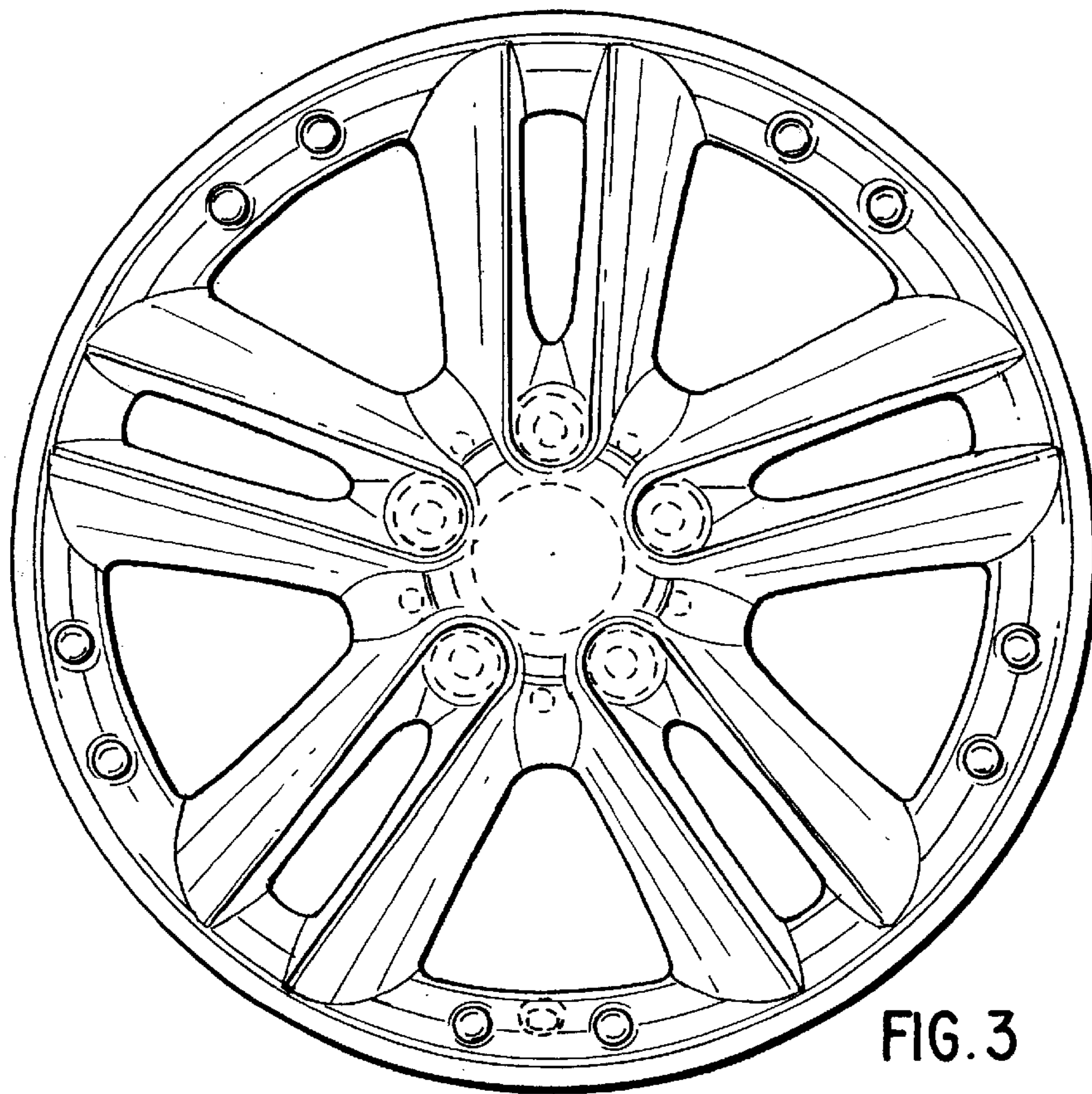

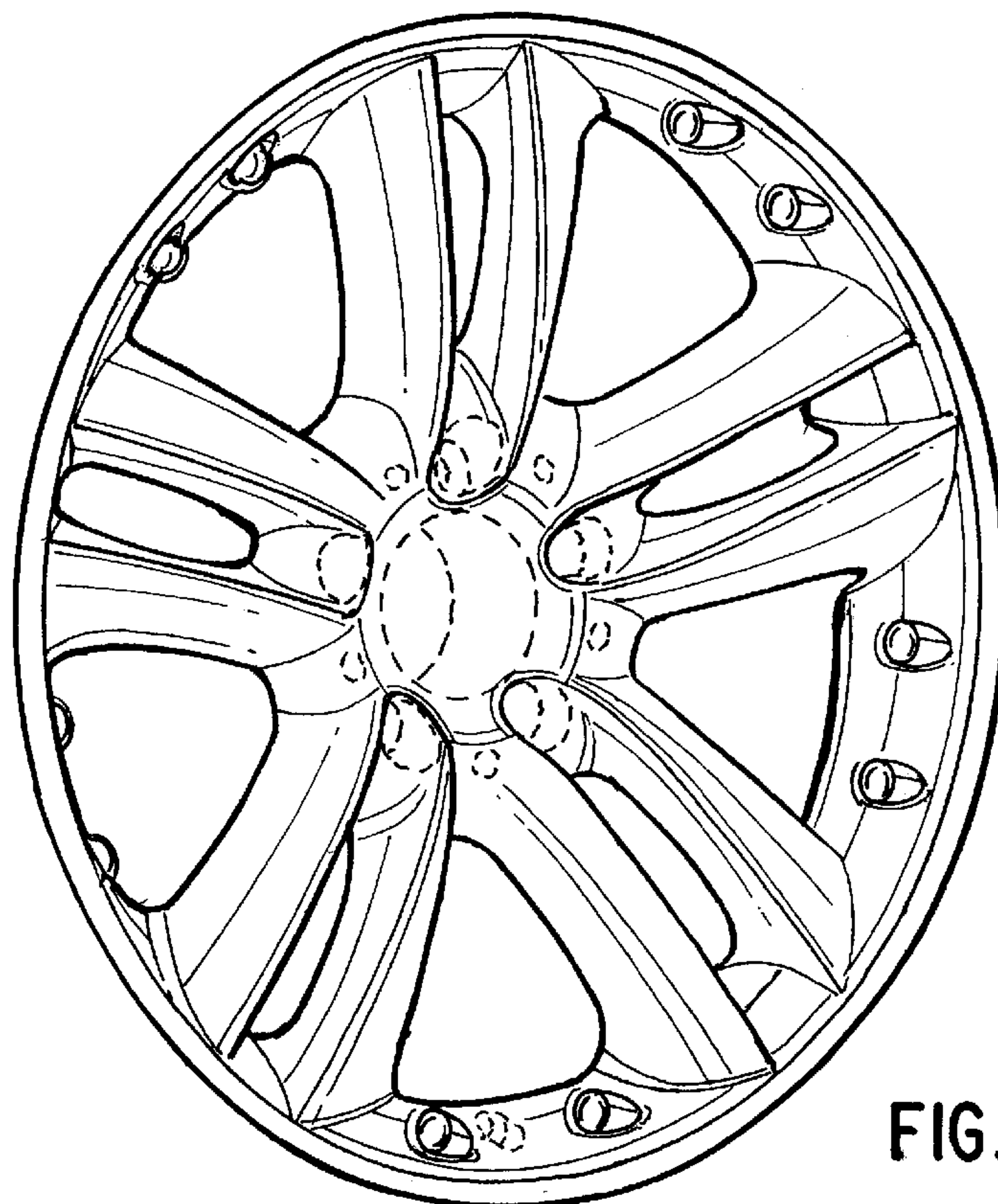
