The ornamental design for a mobile communications device, as shown and described.

DESCRIPTION

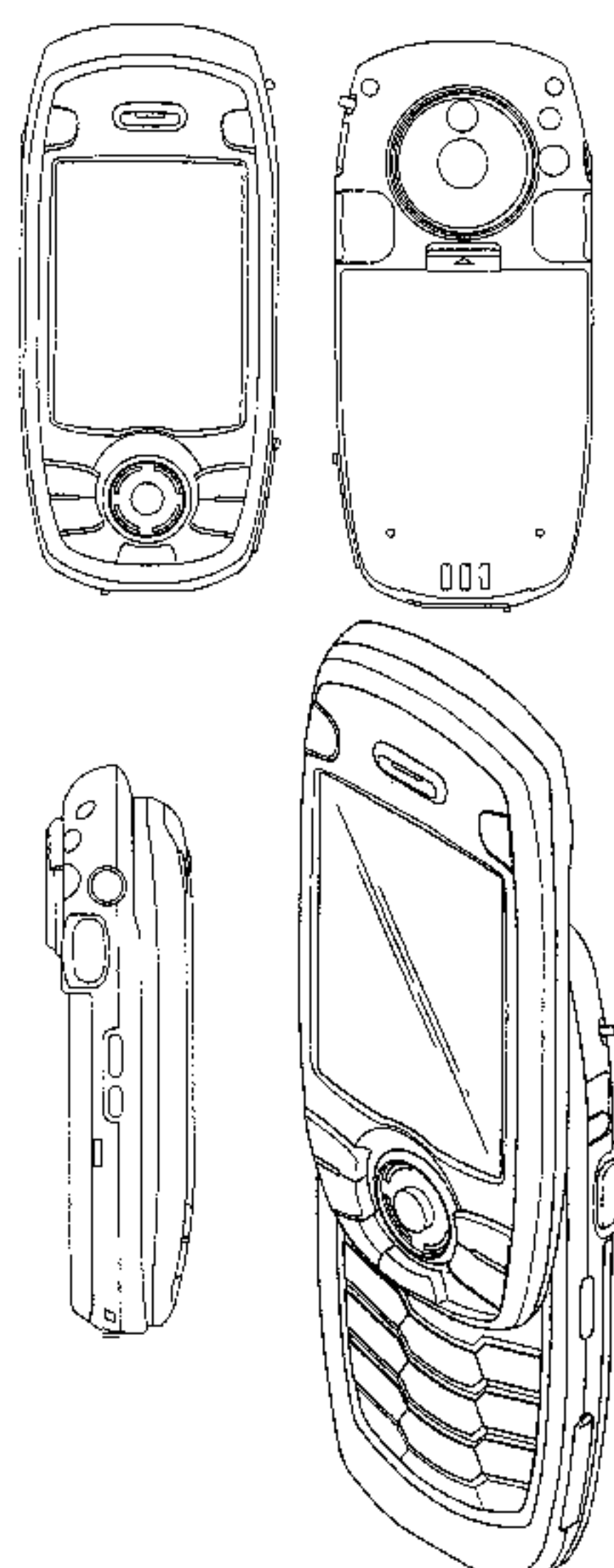

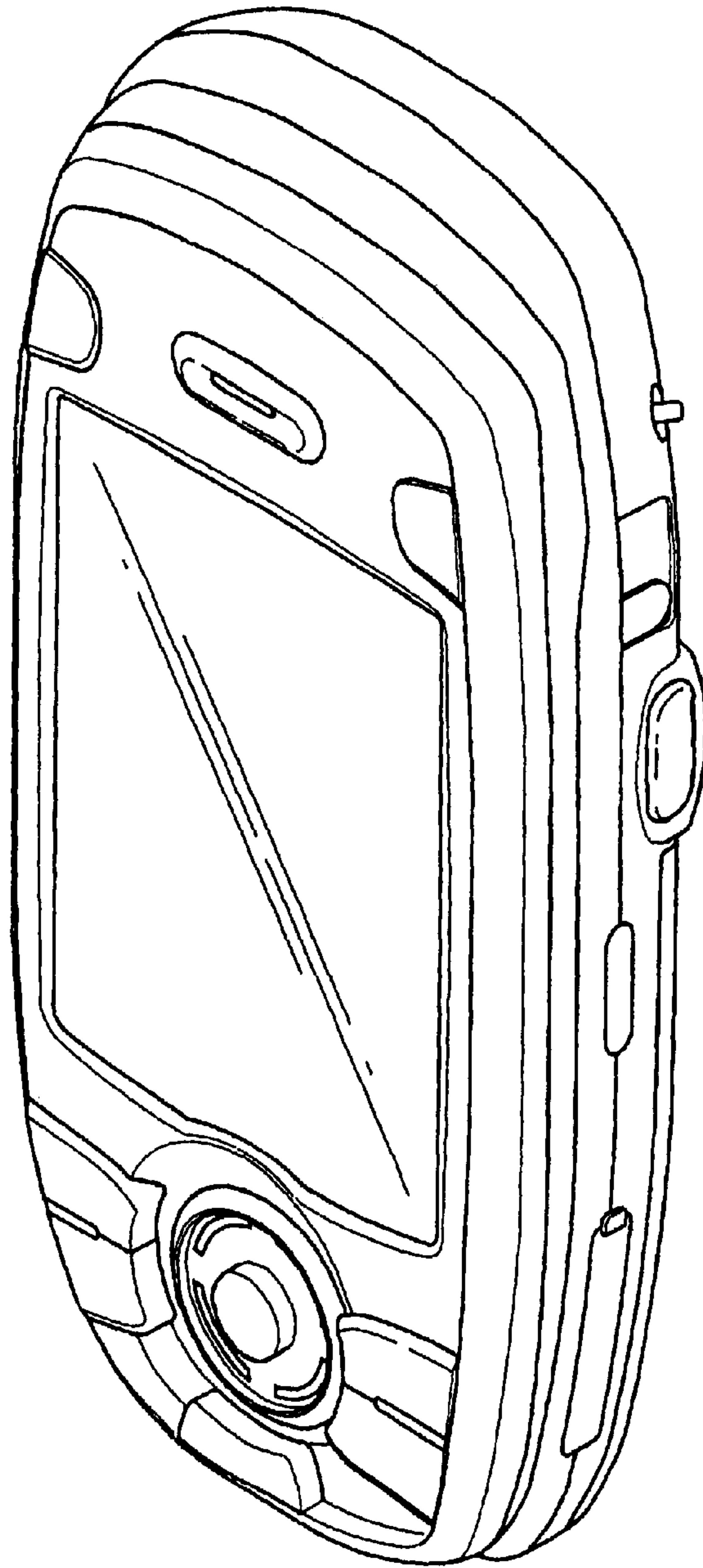

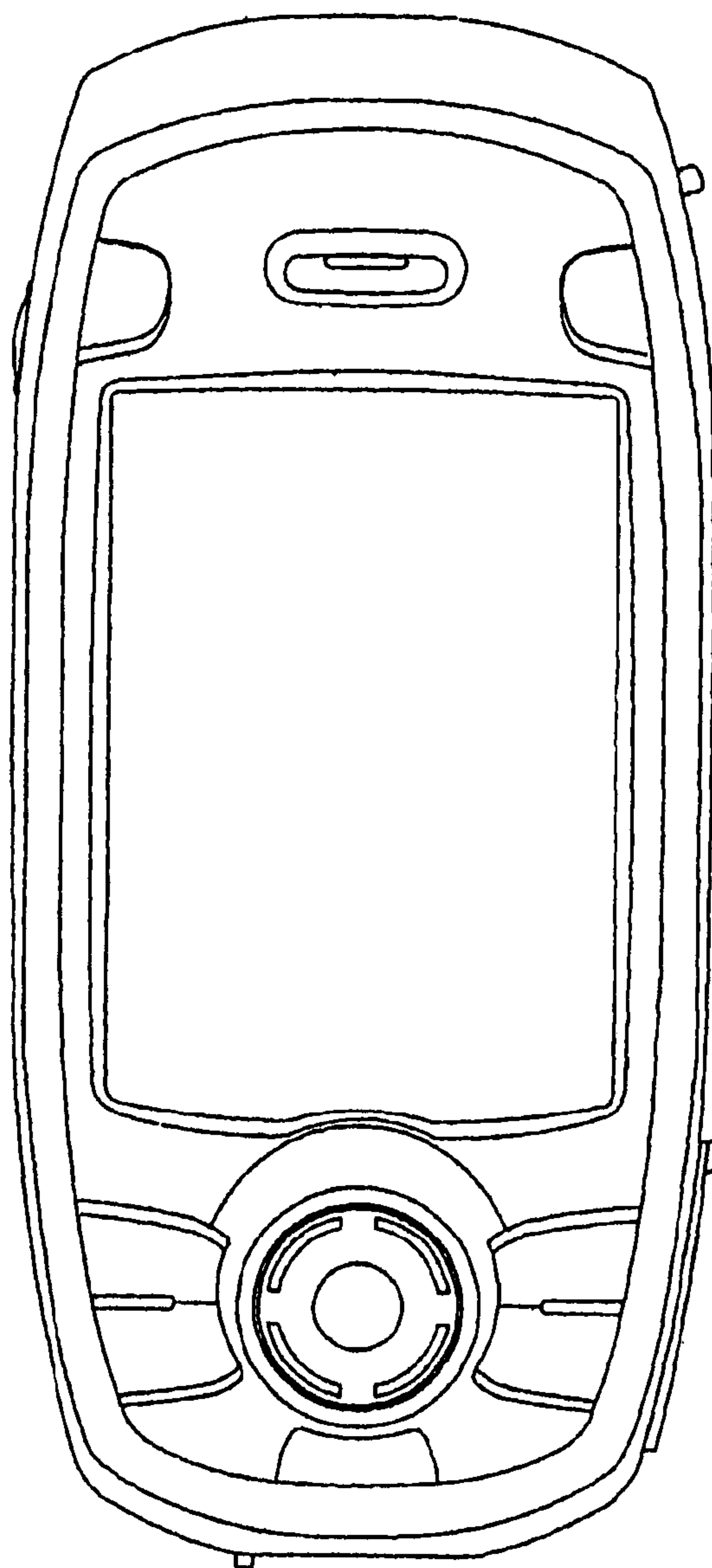

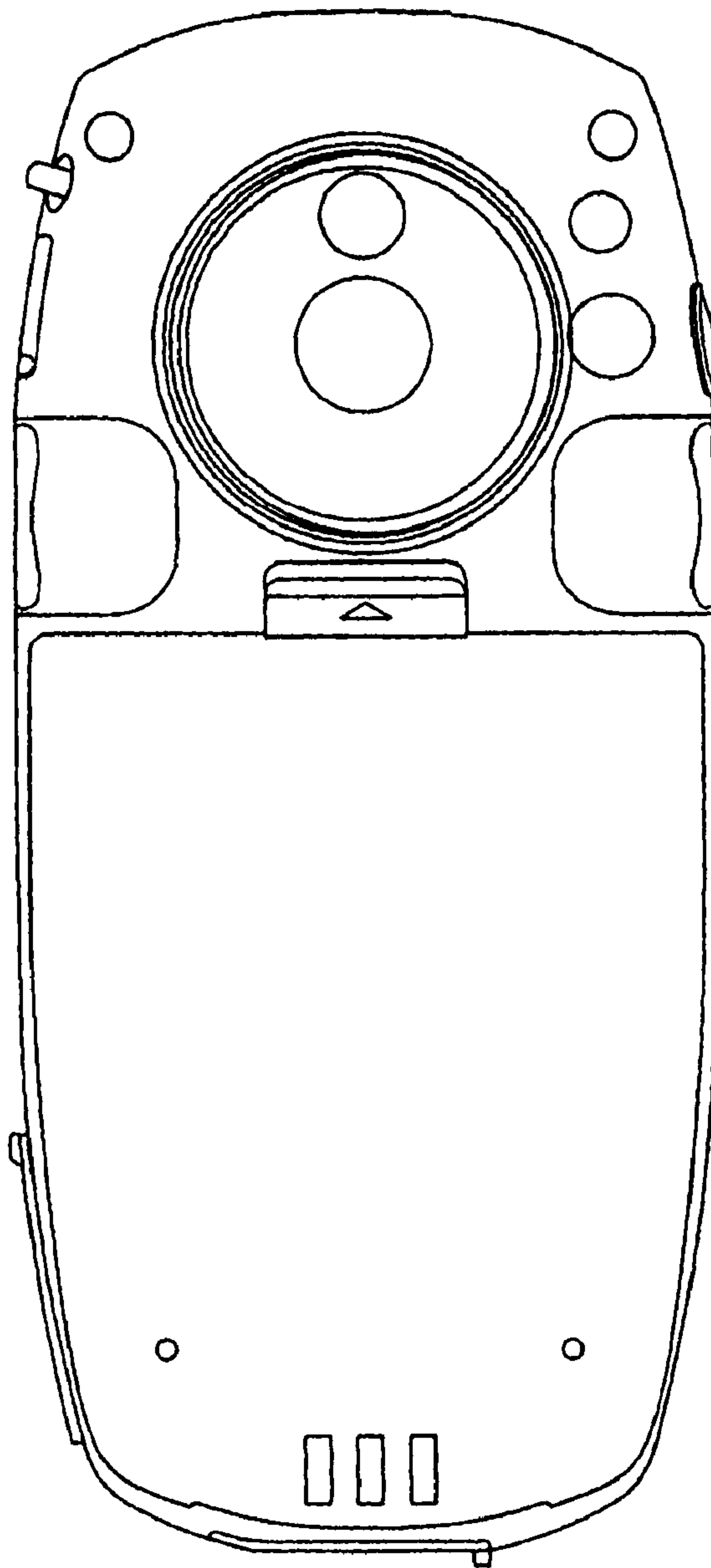

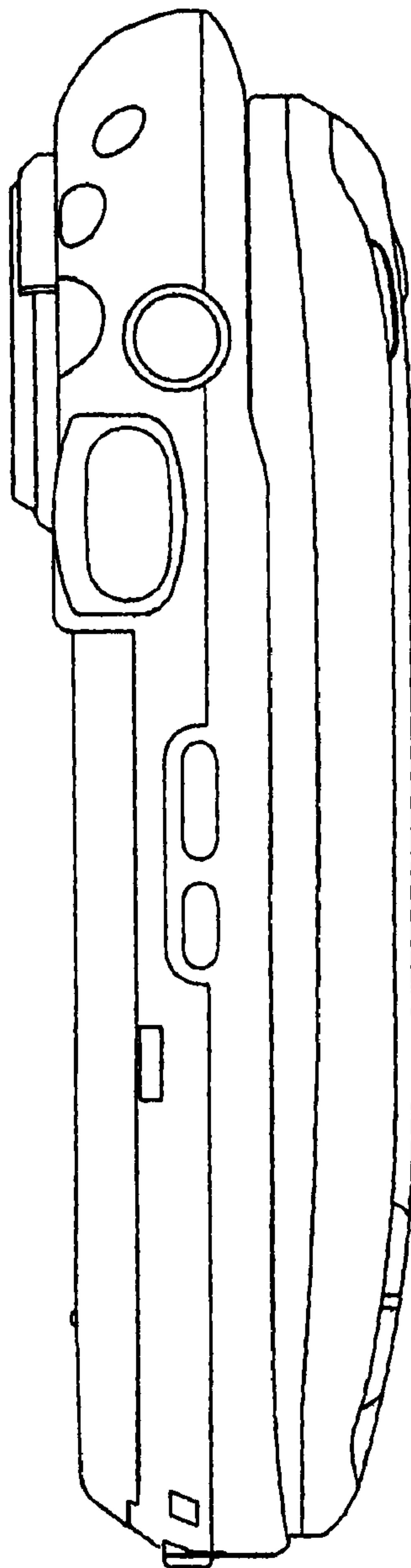

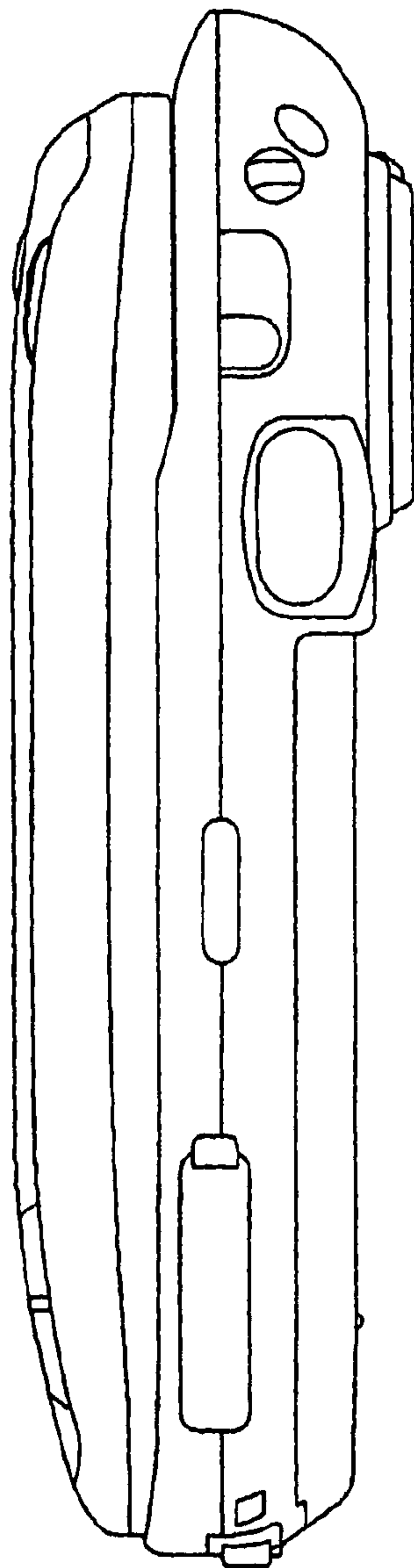

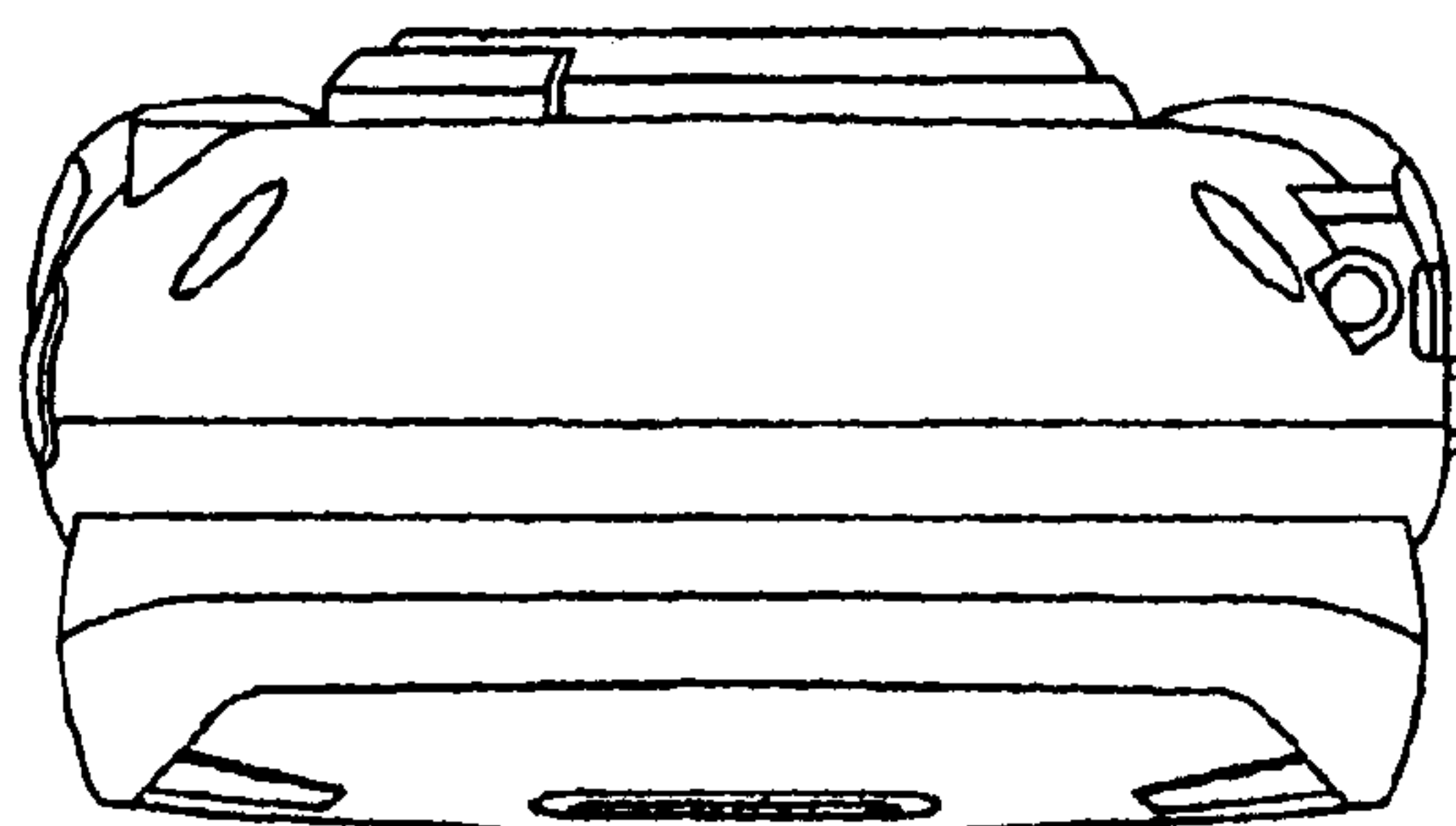

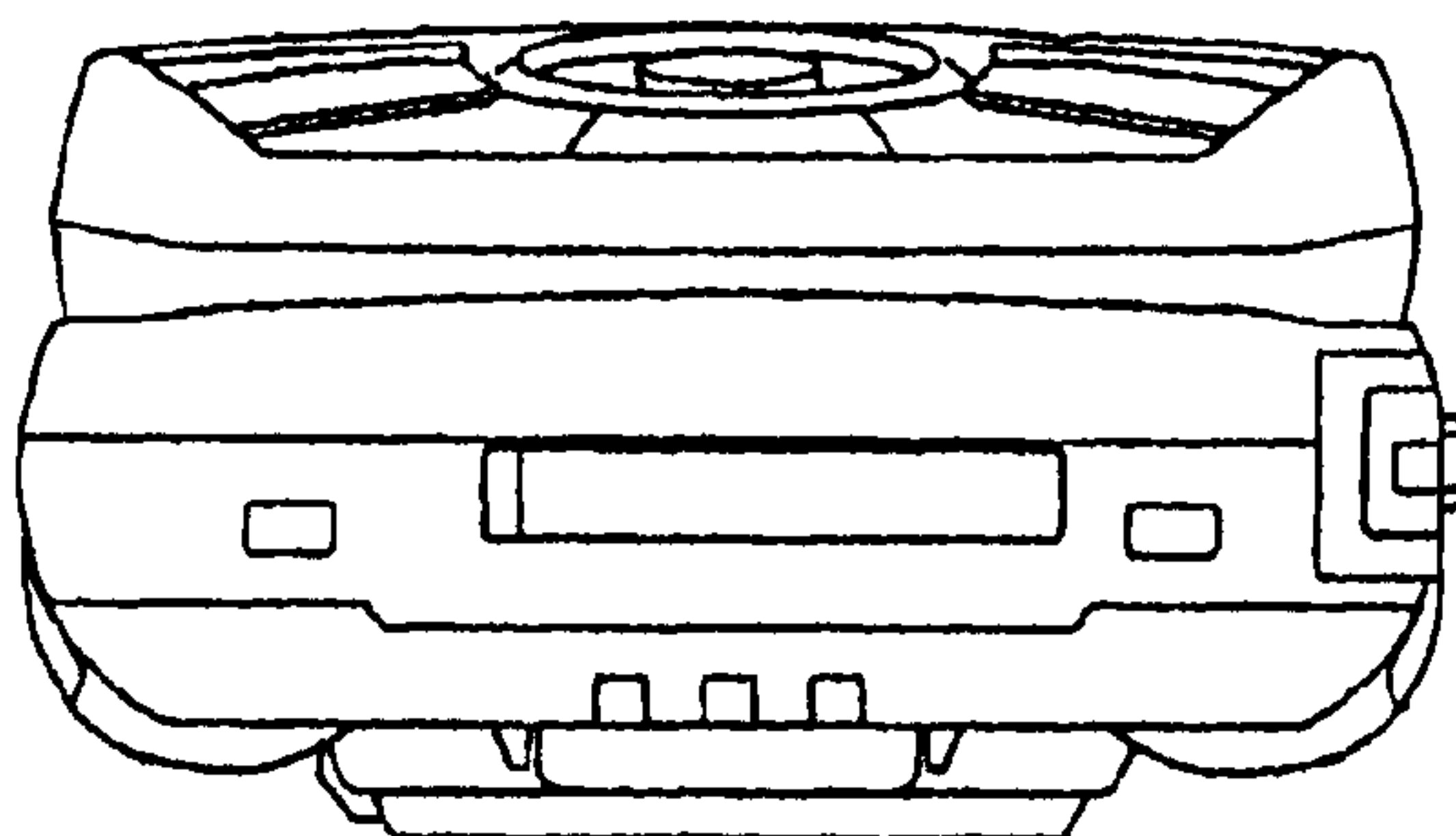
