DESCRIPTION

FIG. 1 is a front perspective view of a base for a cordless telephone with answering device;

FIG. 4 is a front view of the base of FIG. 1;

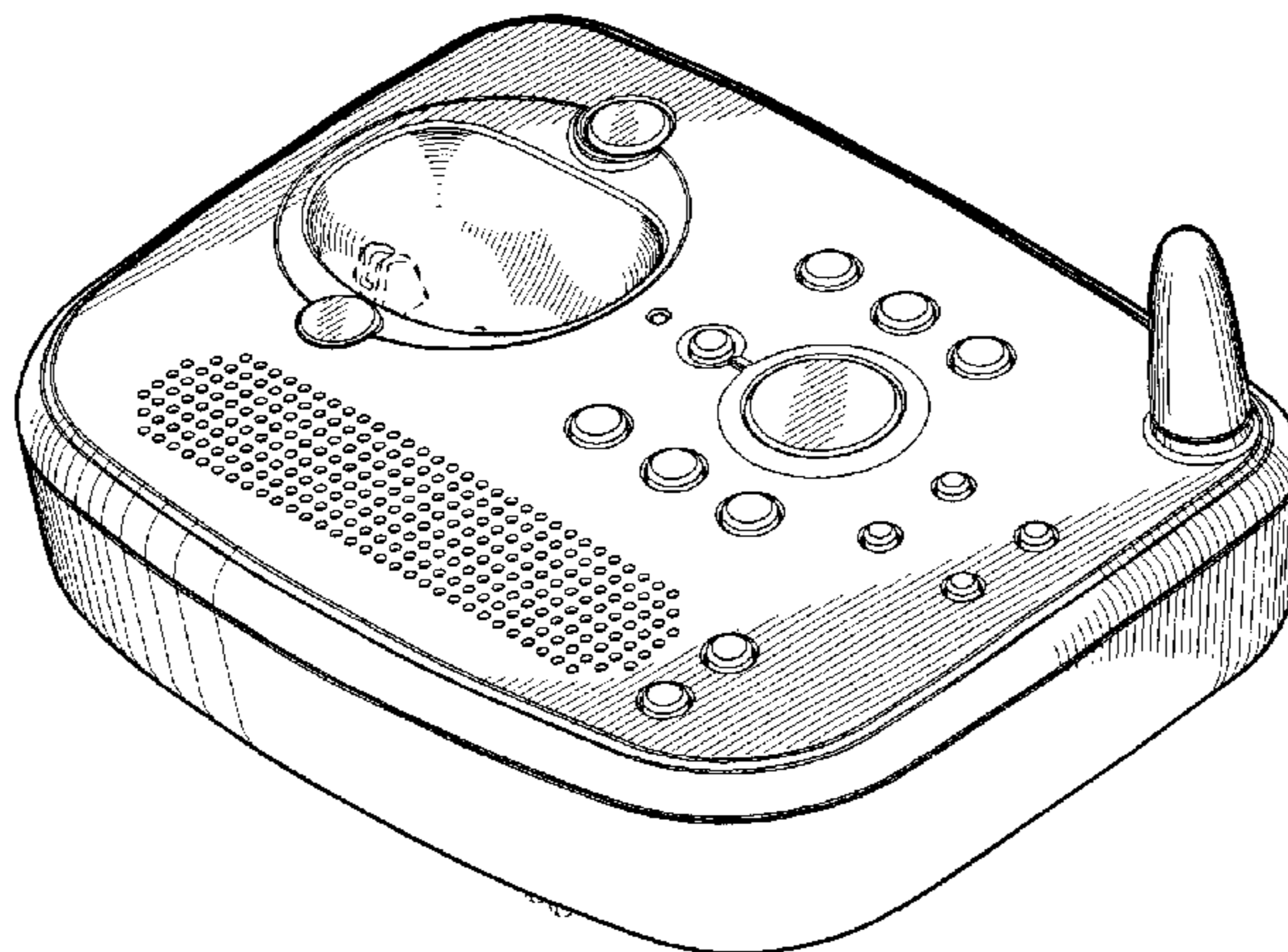
FIG. 5 is a back view of the base of FIG. 1;

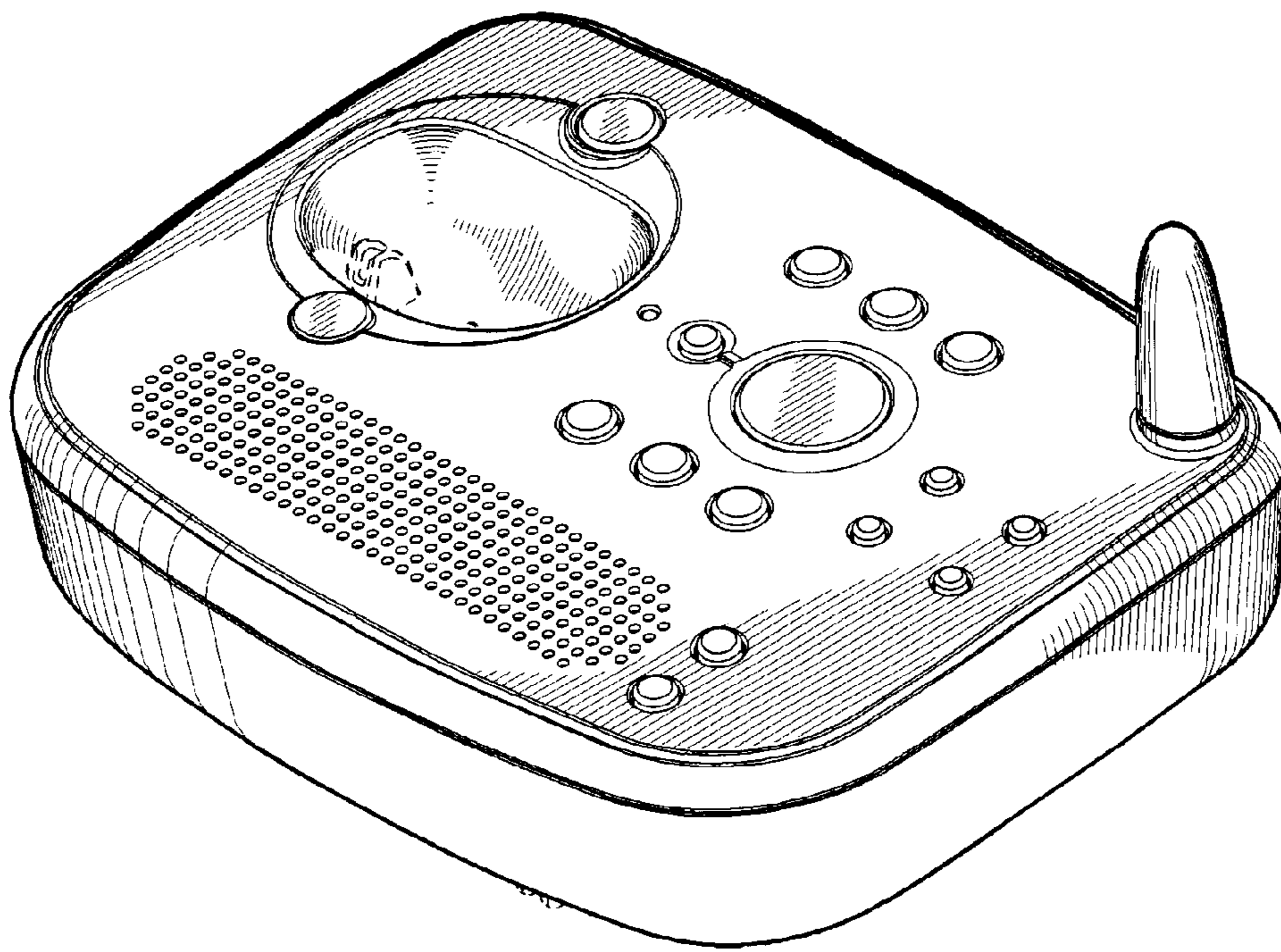

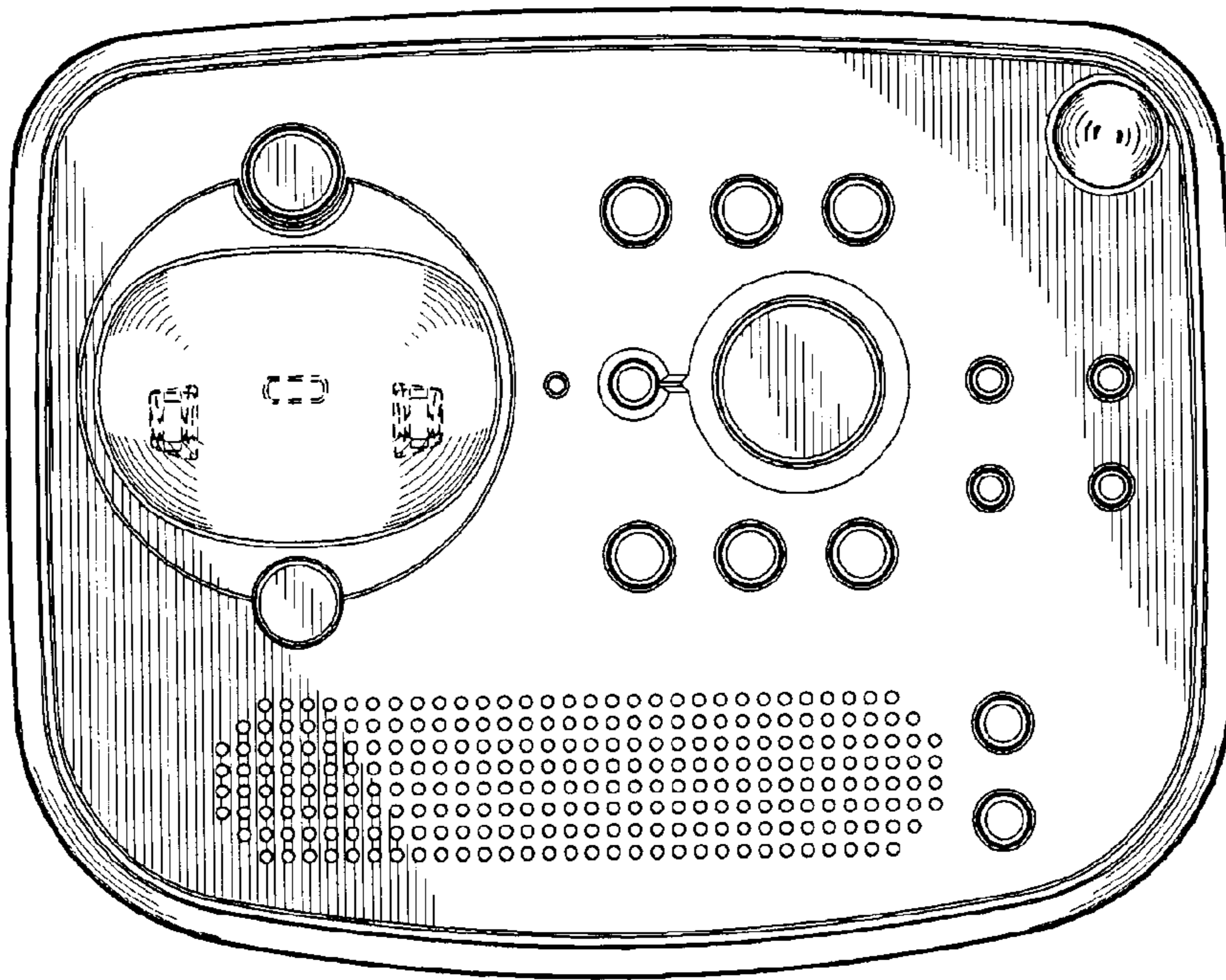

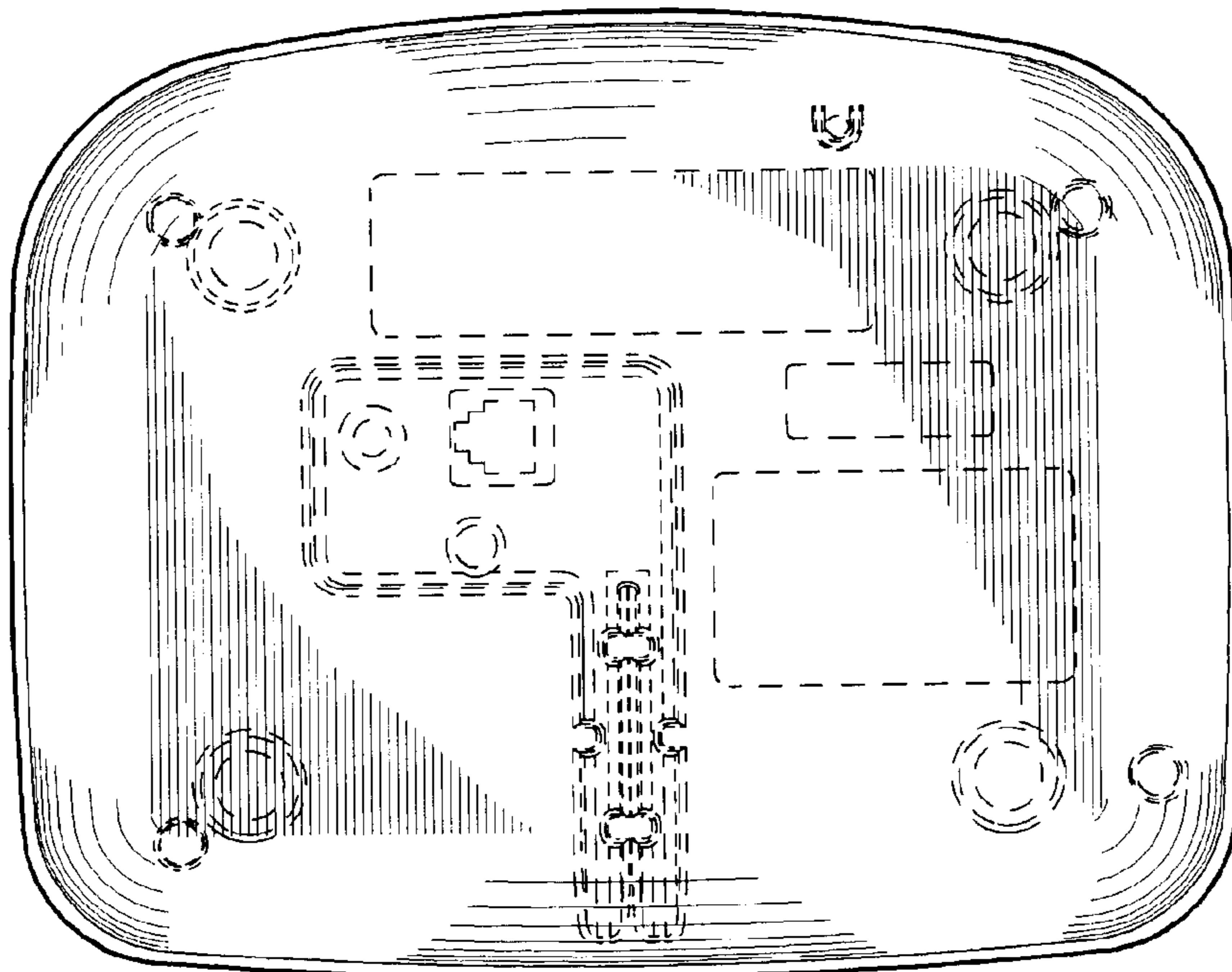

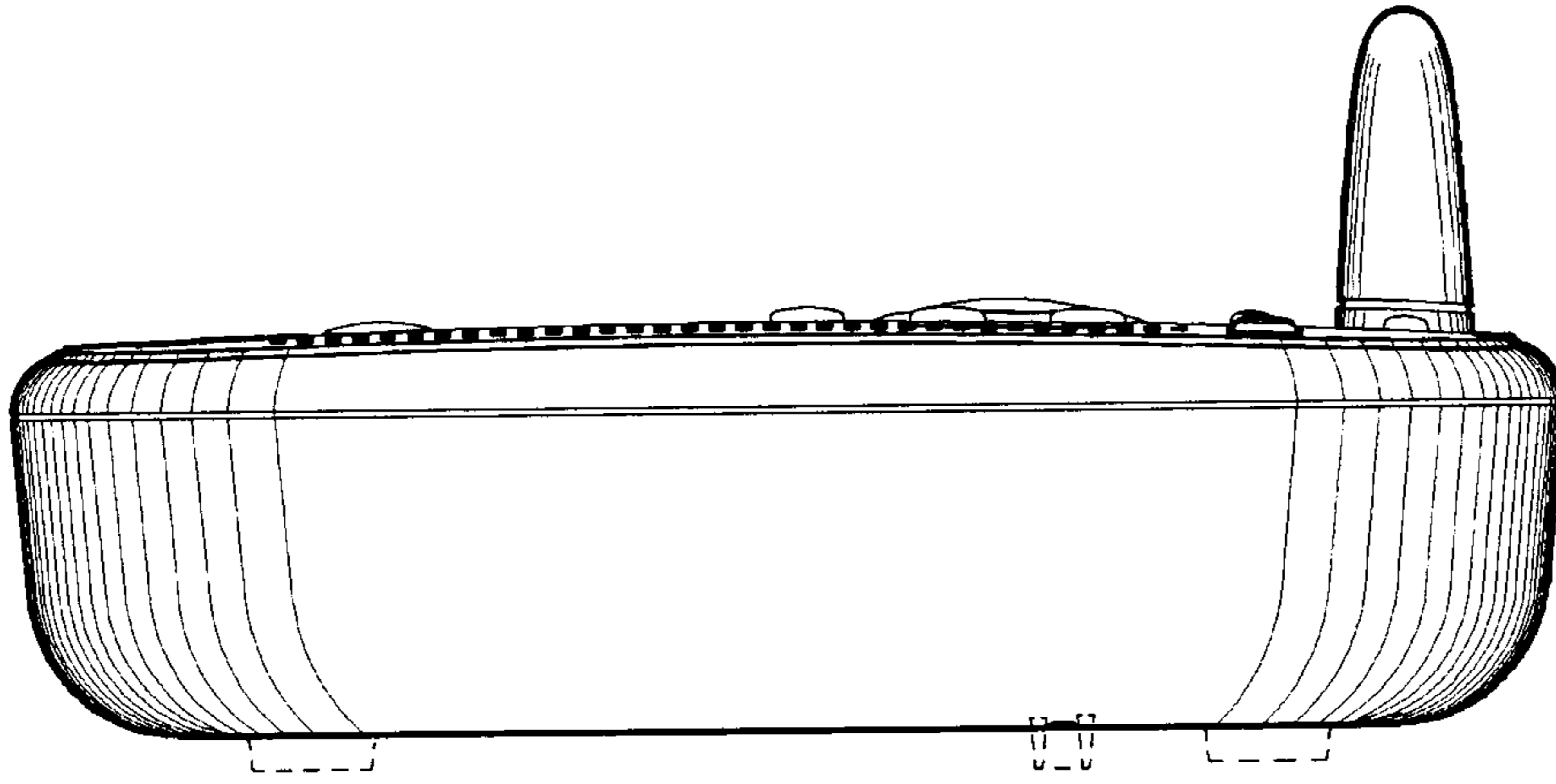

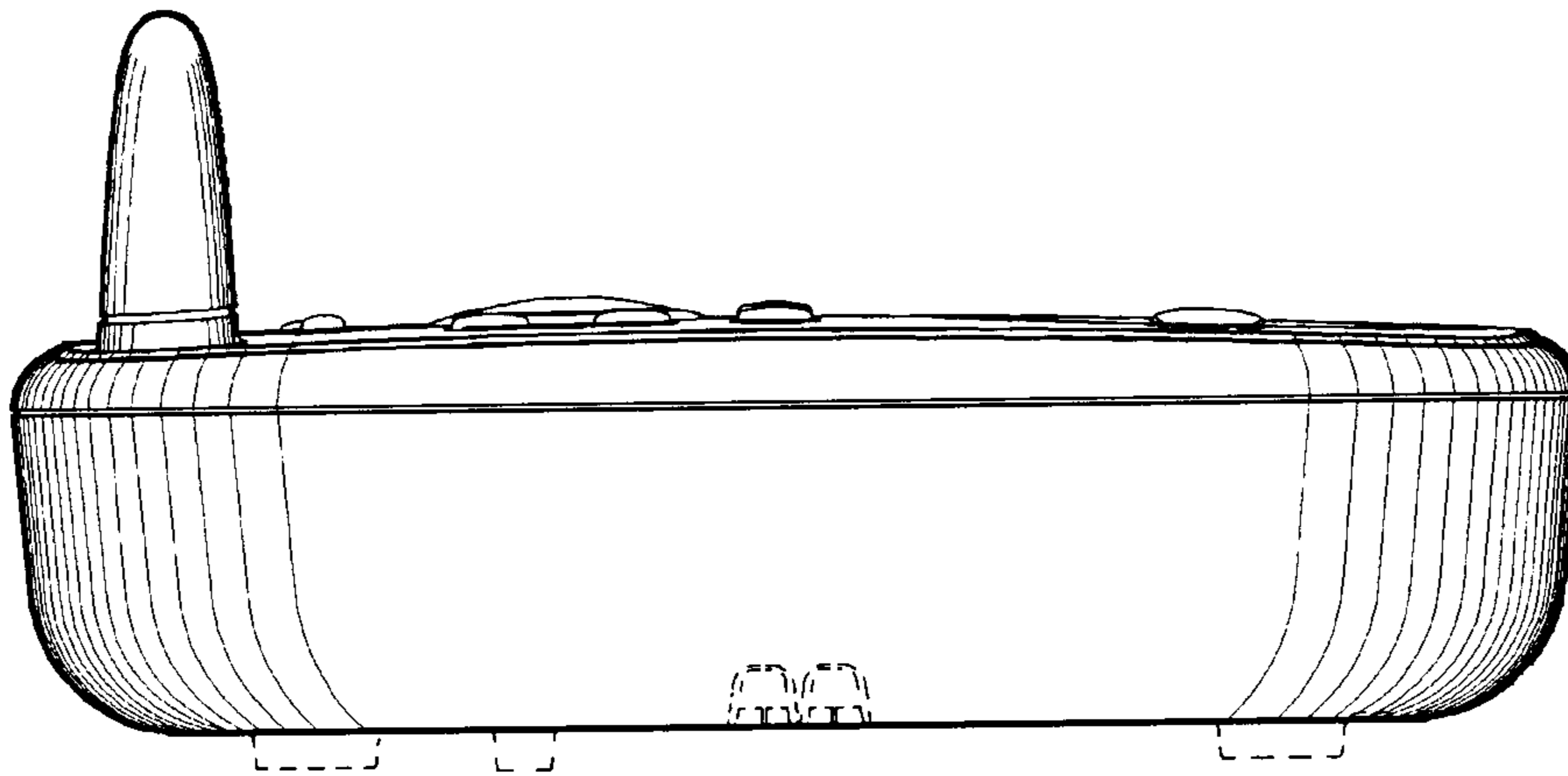

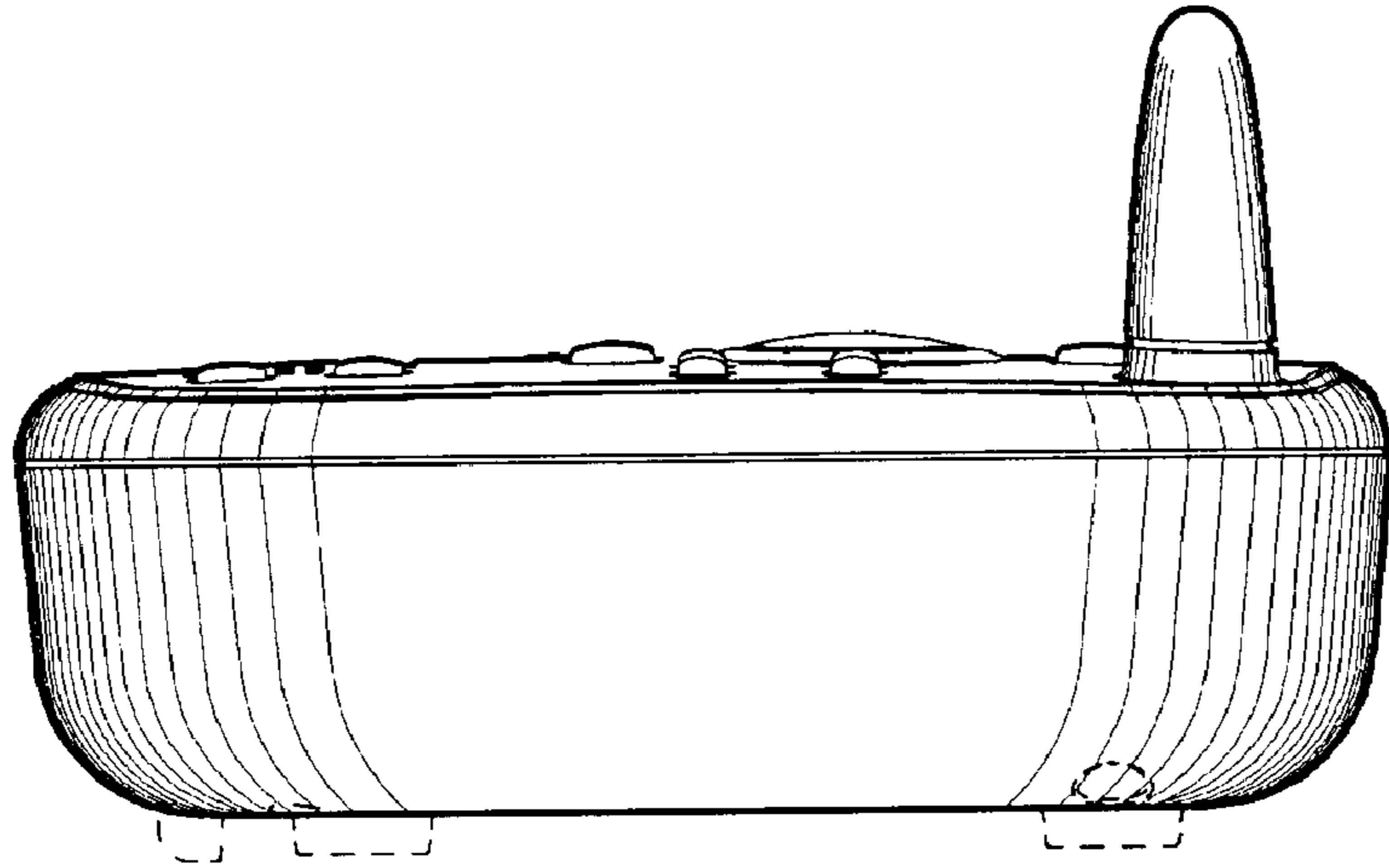

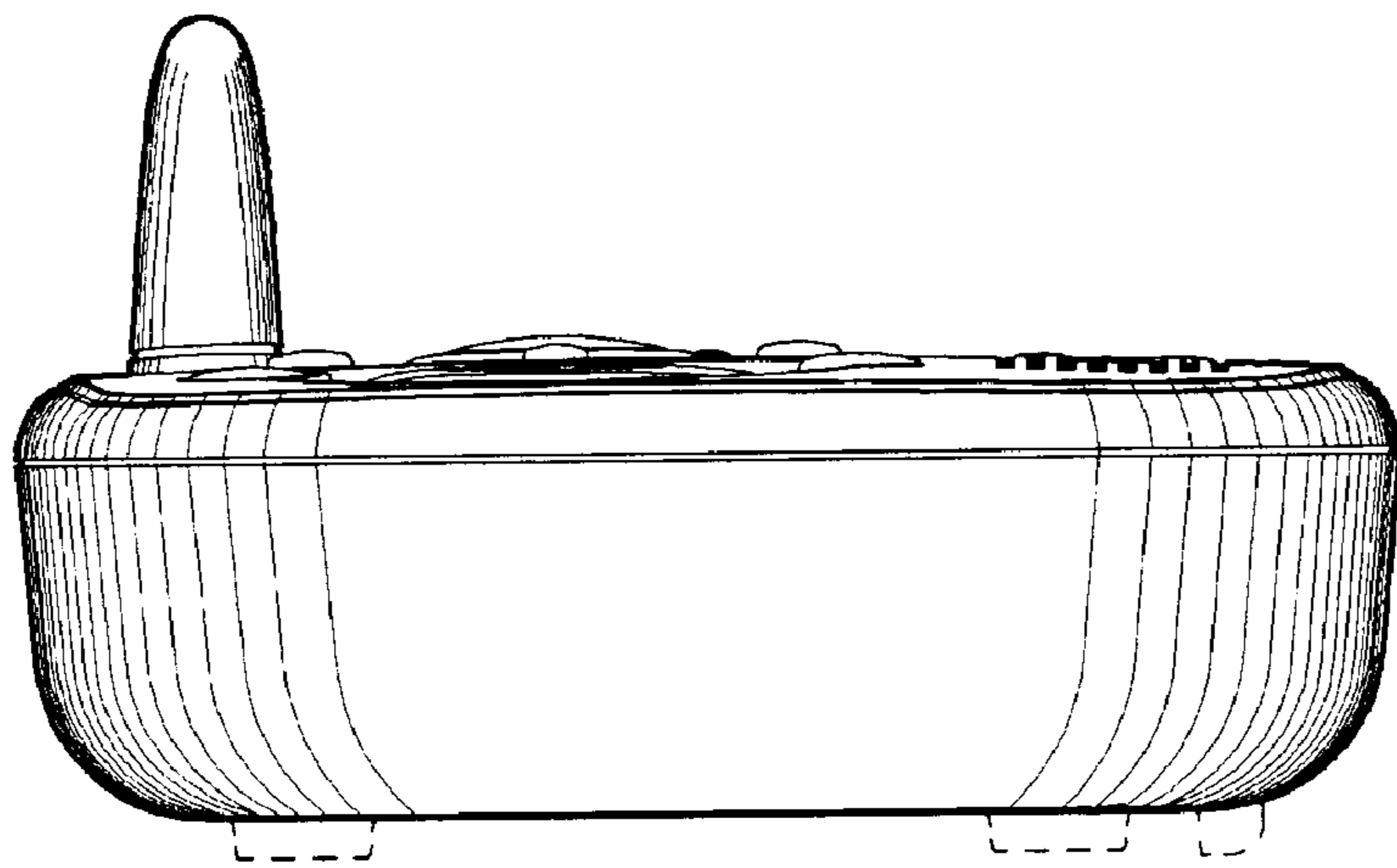
