**DESCRIPTION**

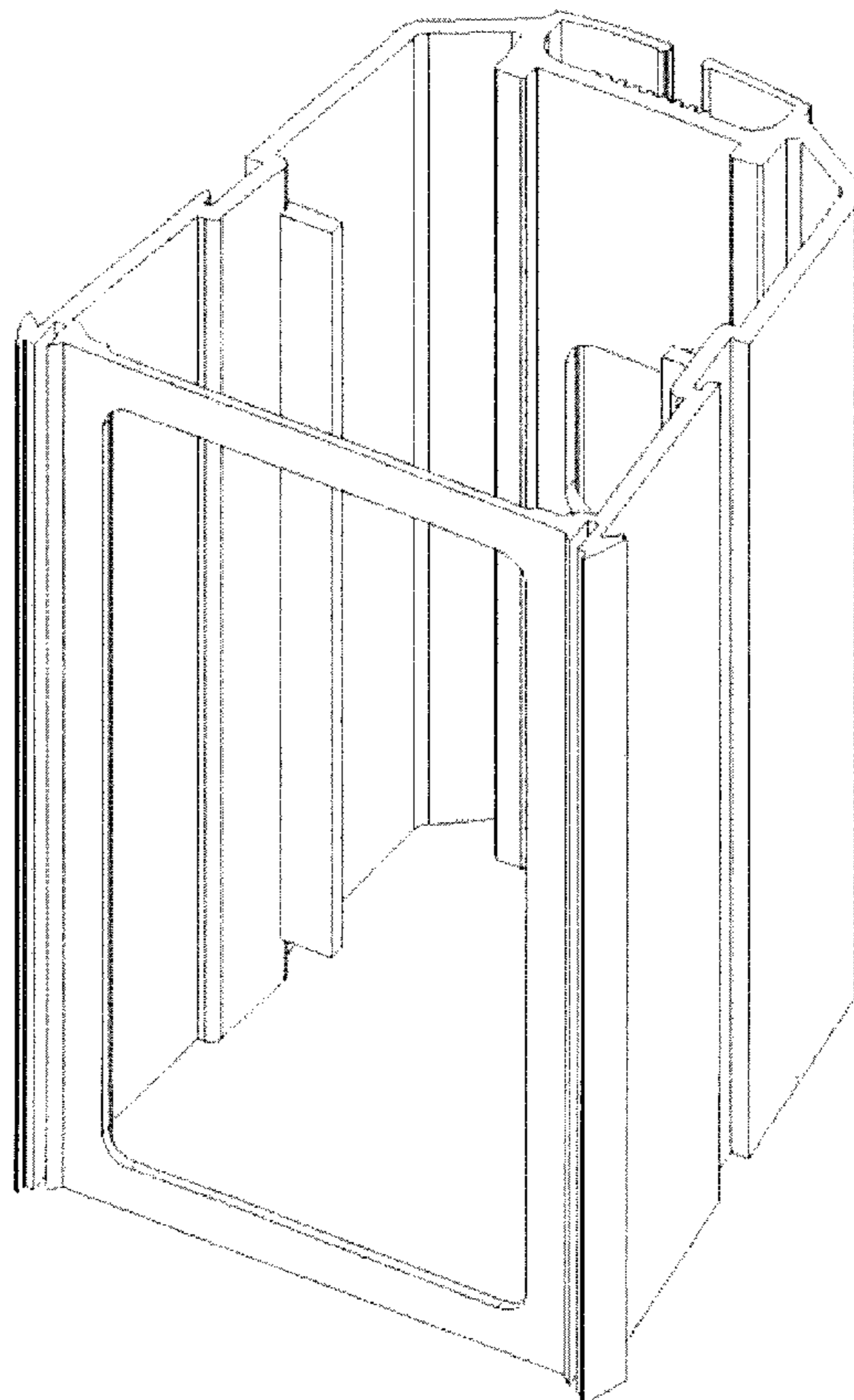
FIG. 1 is a perspective view of the audio speaker housing of the present invention;

FIG. 7 is a bottom view of the audio speaker housing.

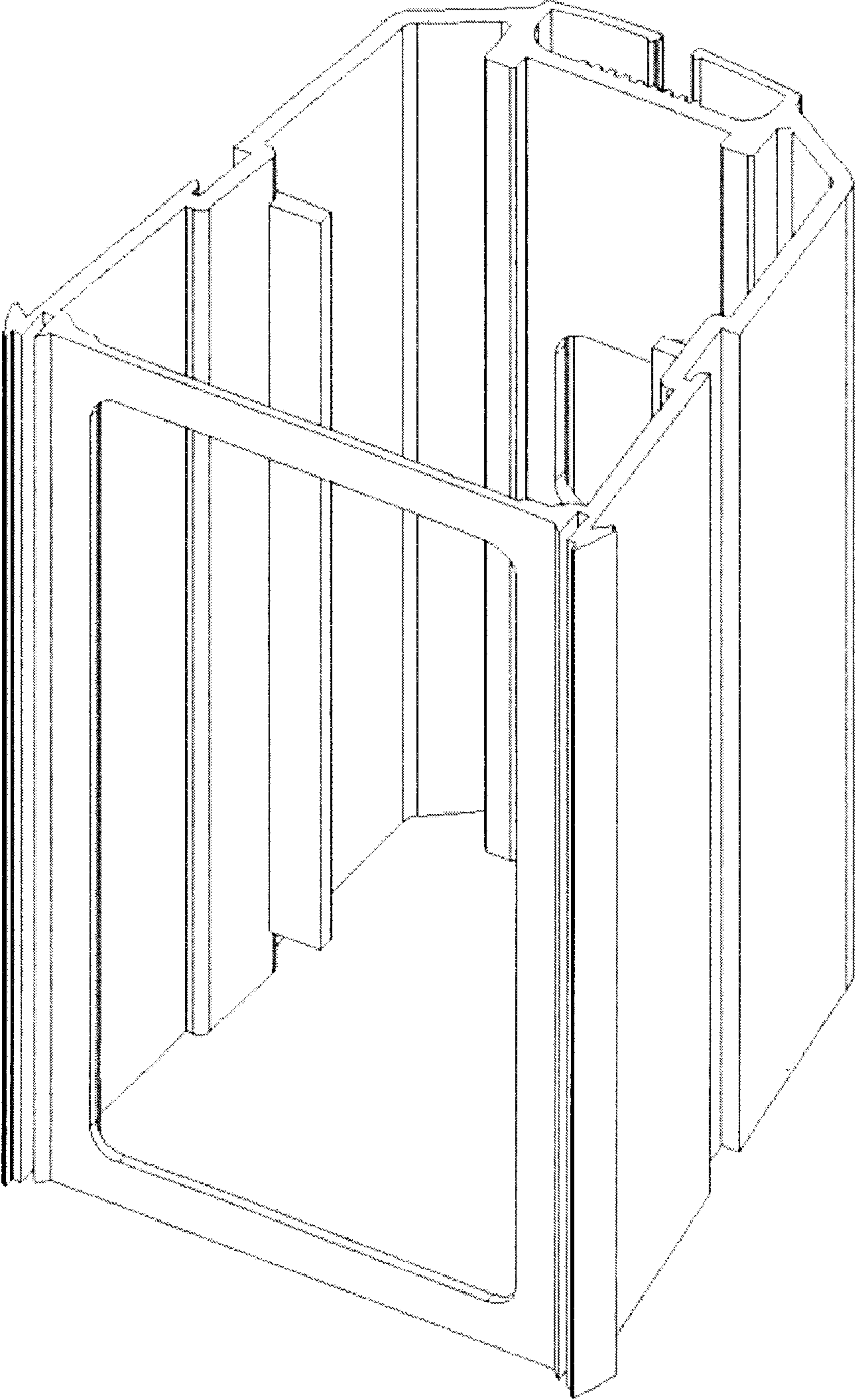

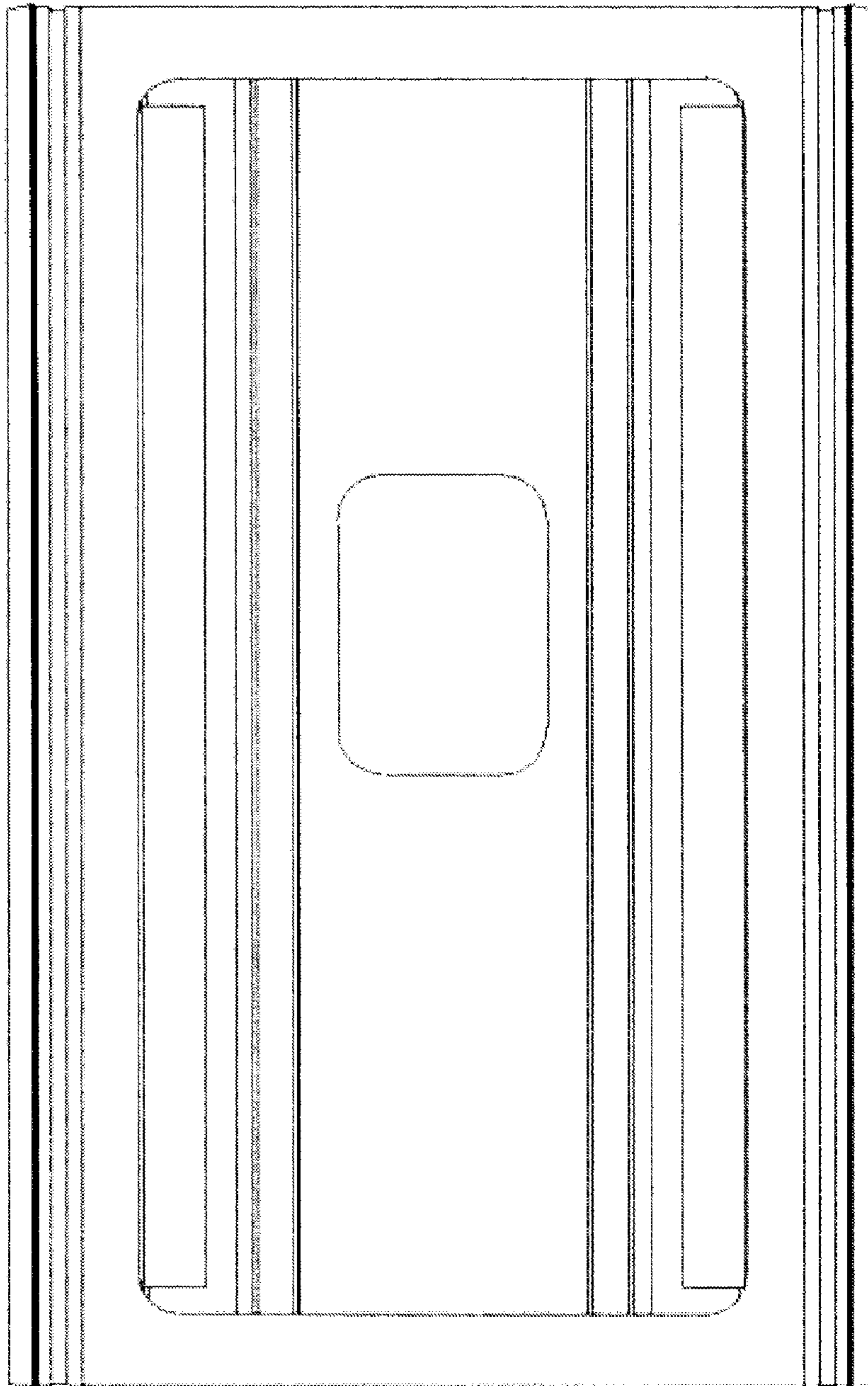

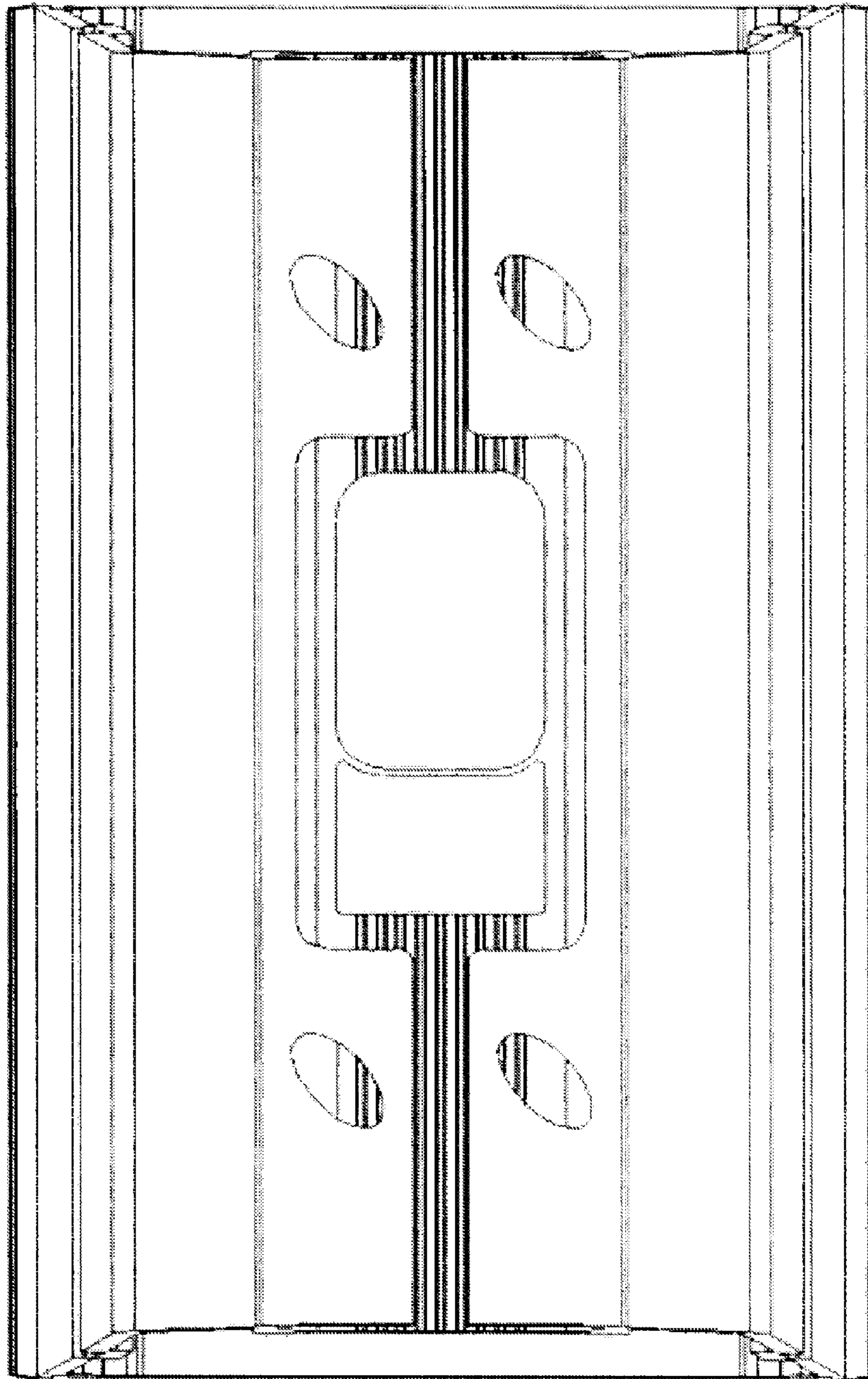




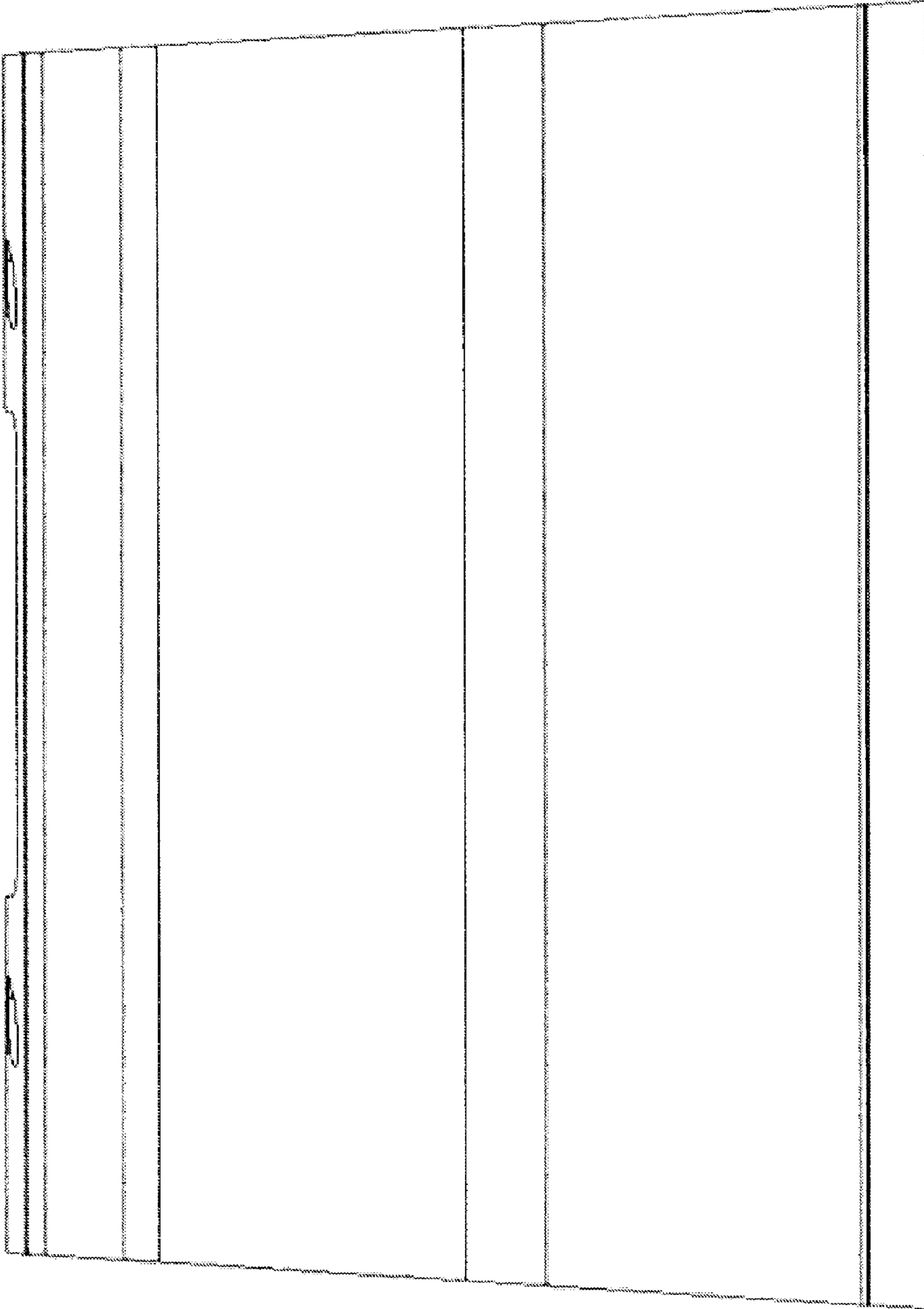

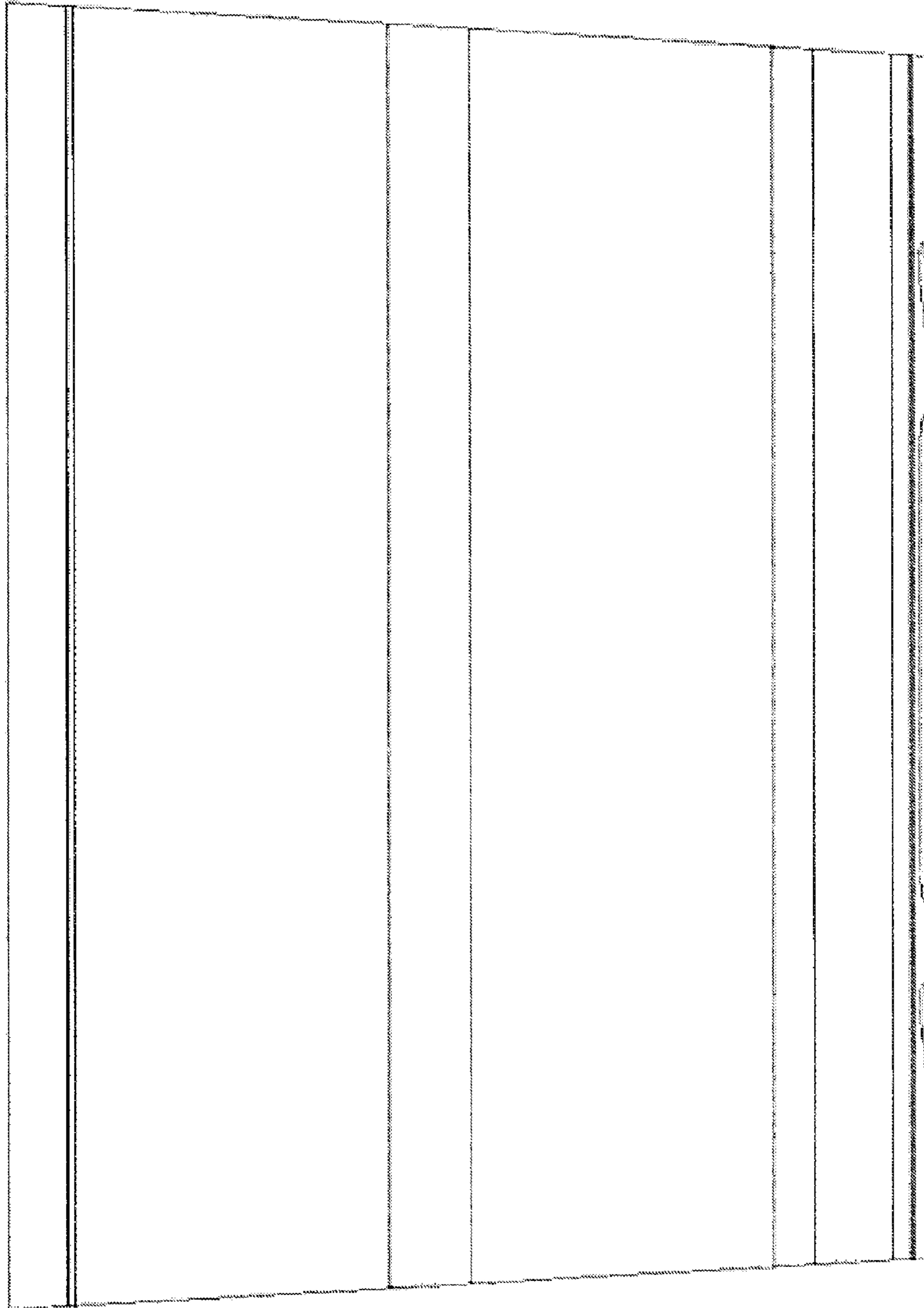

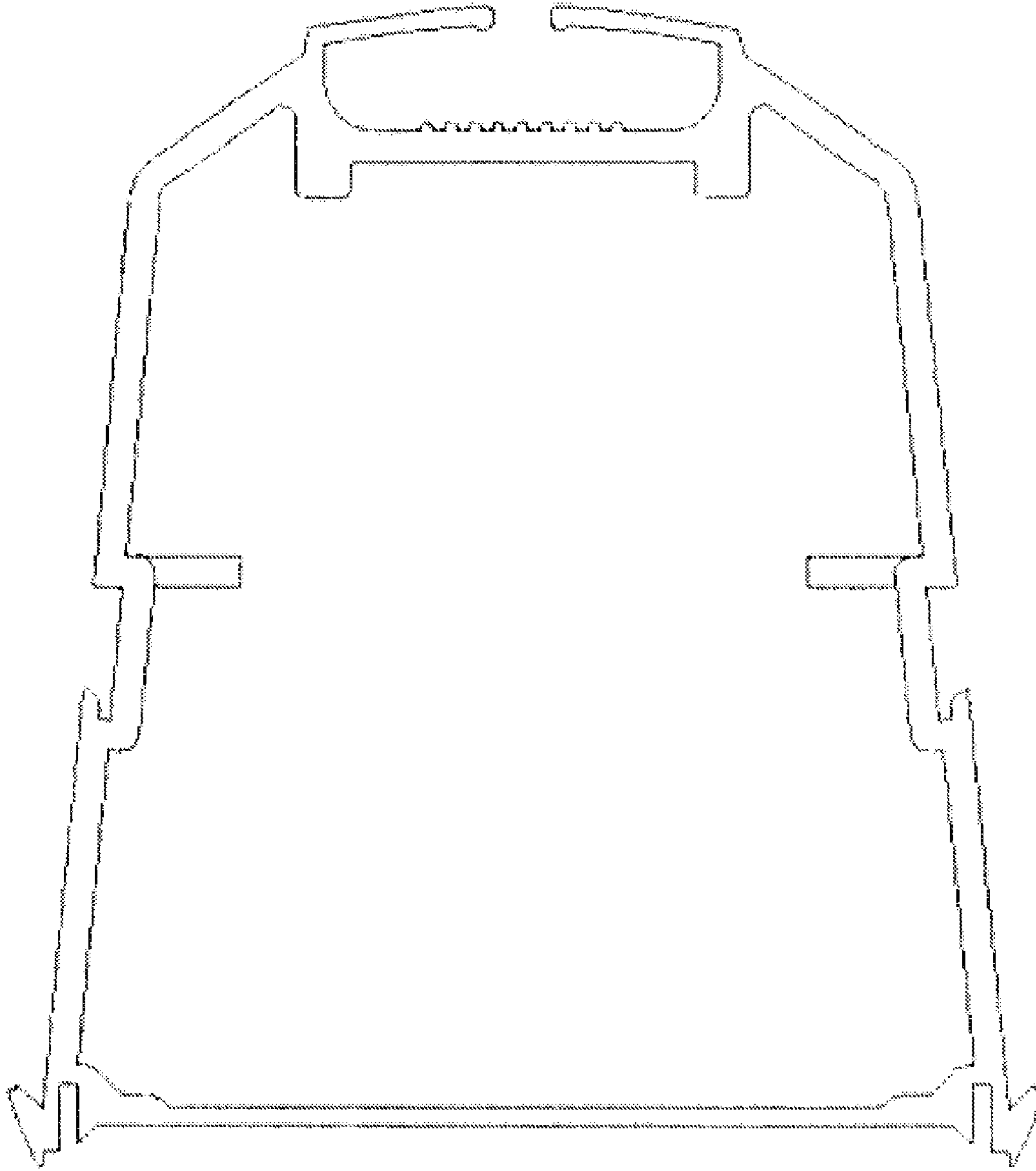

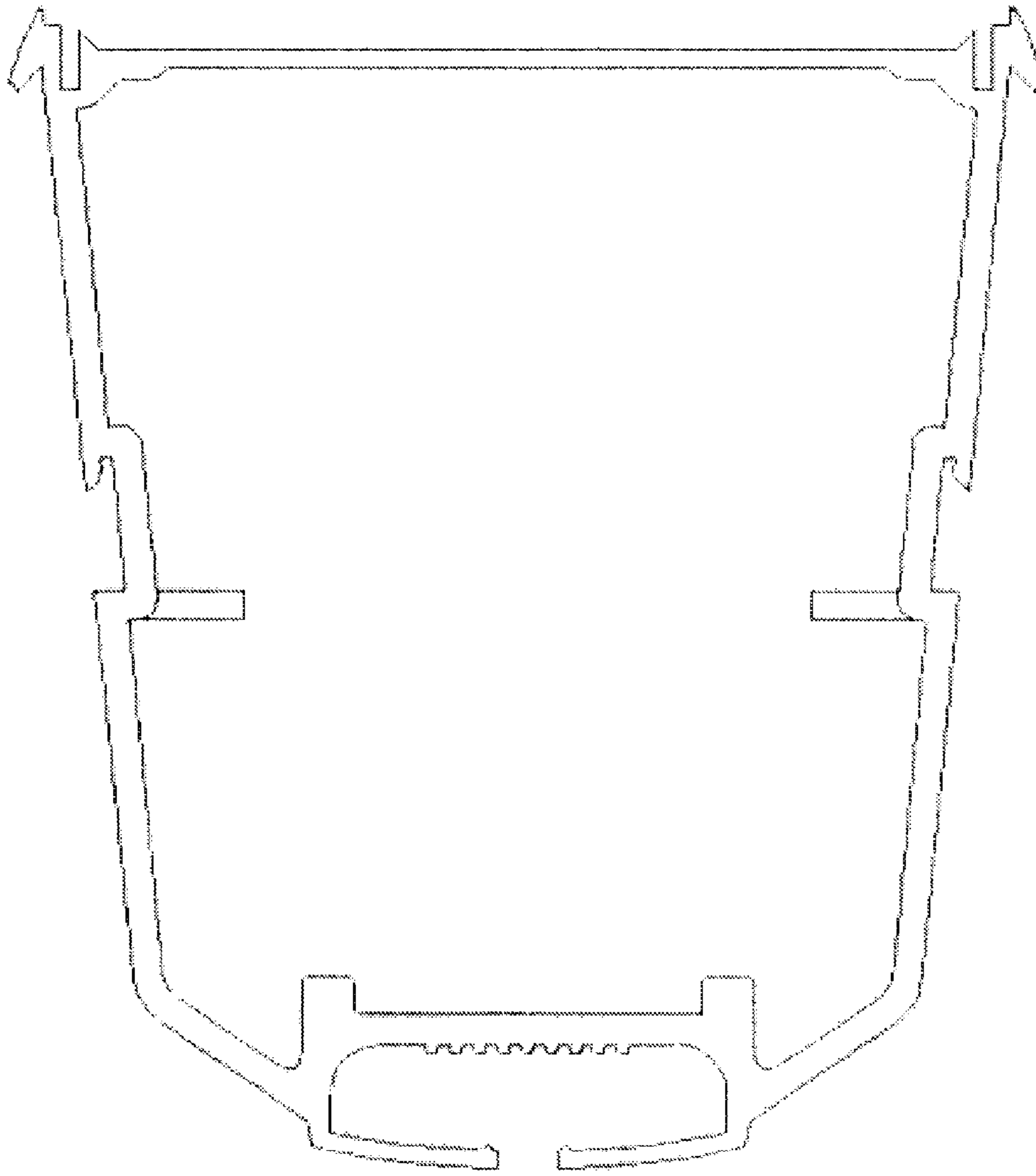
