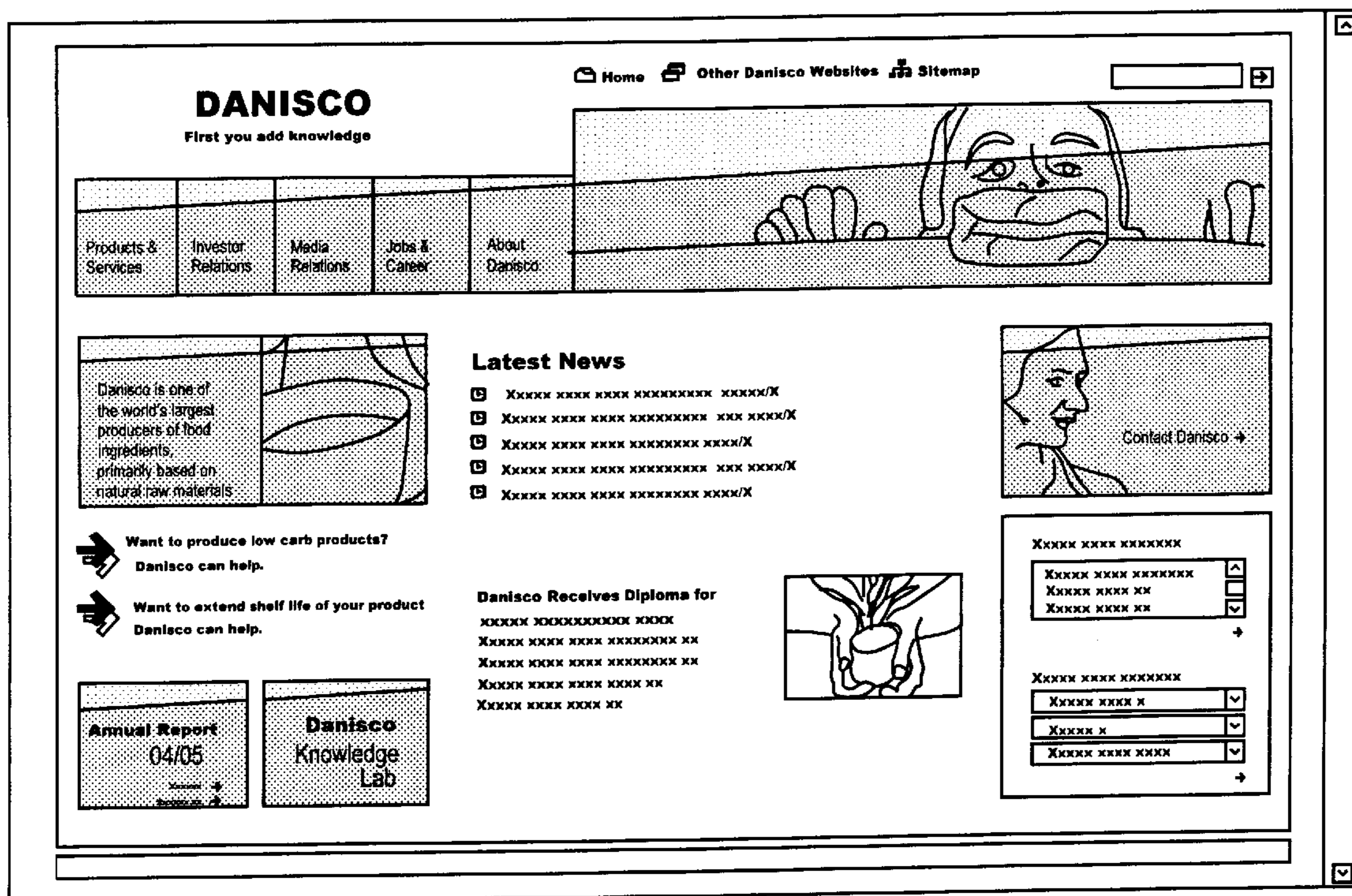
(57) **CLAIM**

I claim the ornamental design for a graphic user interface for a website, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a graphic user interface for a website showing the new design;

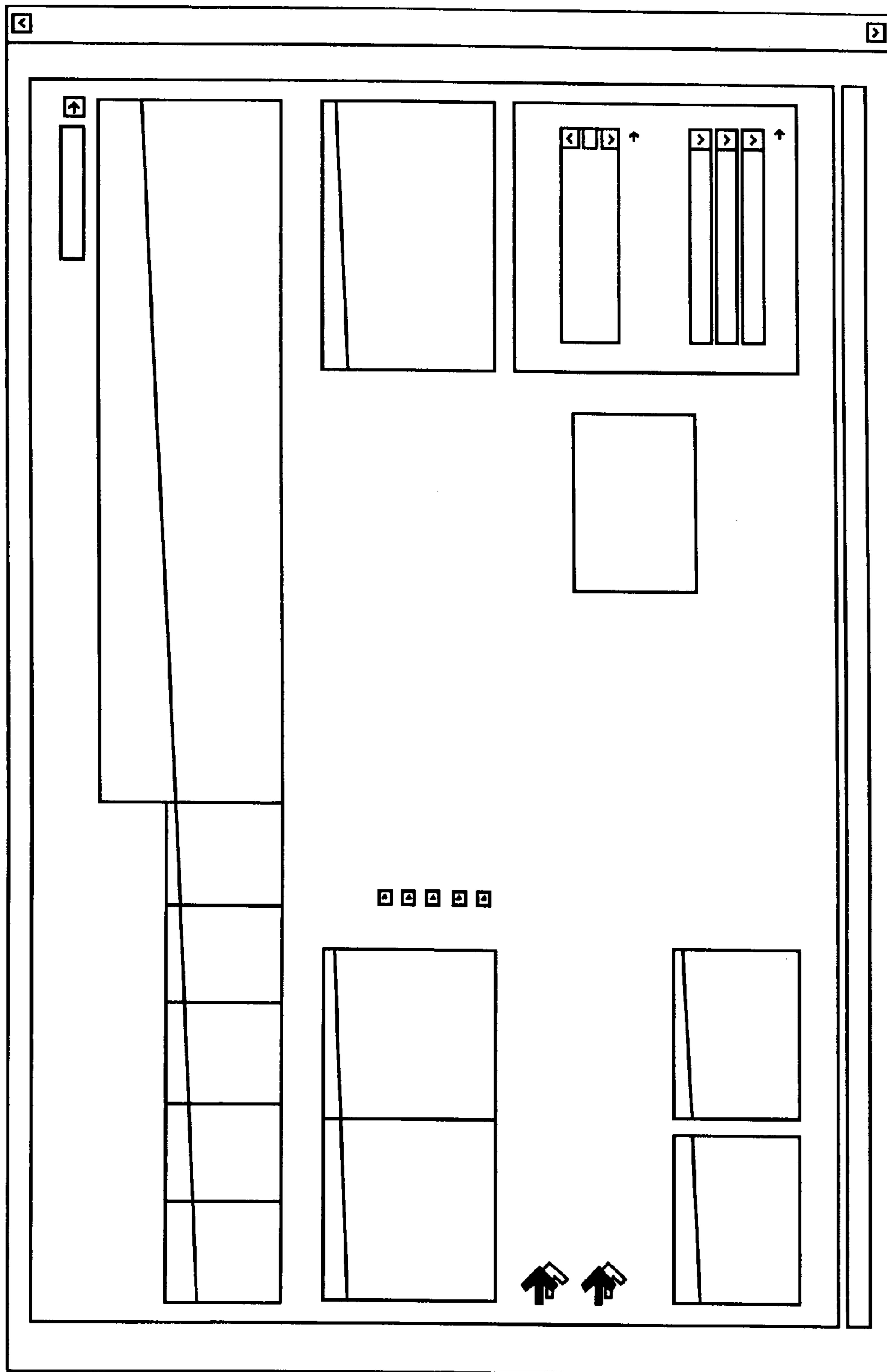

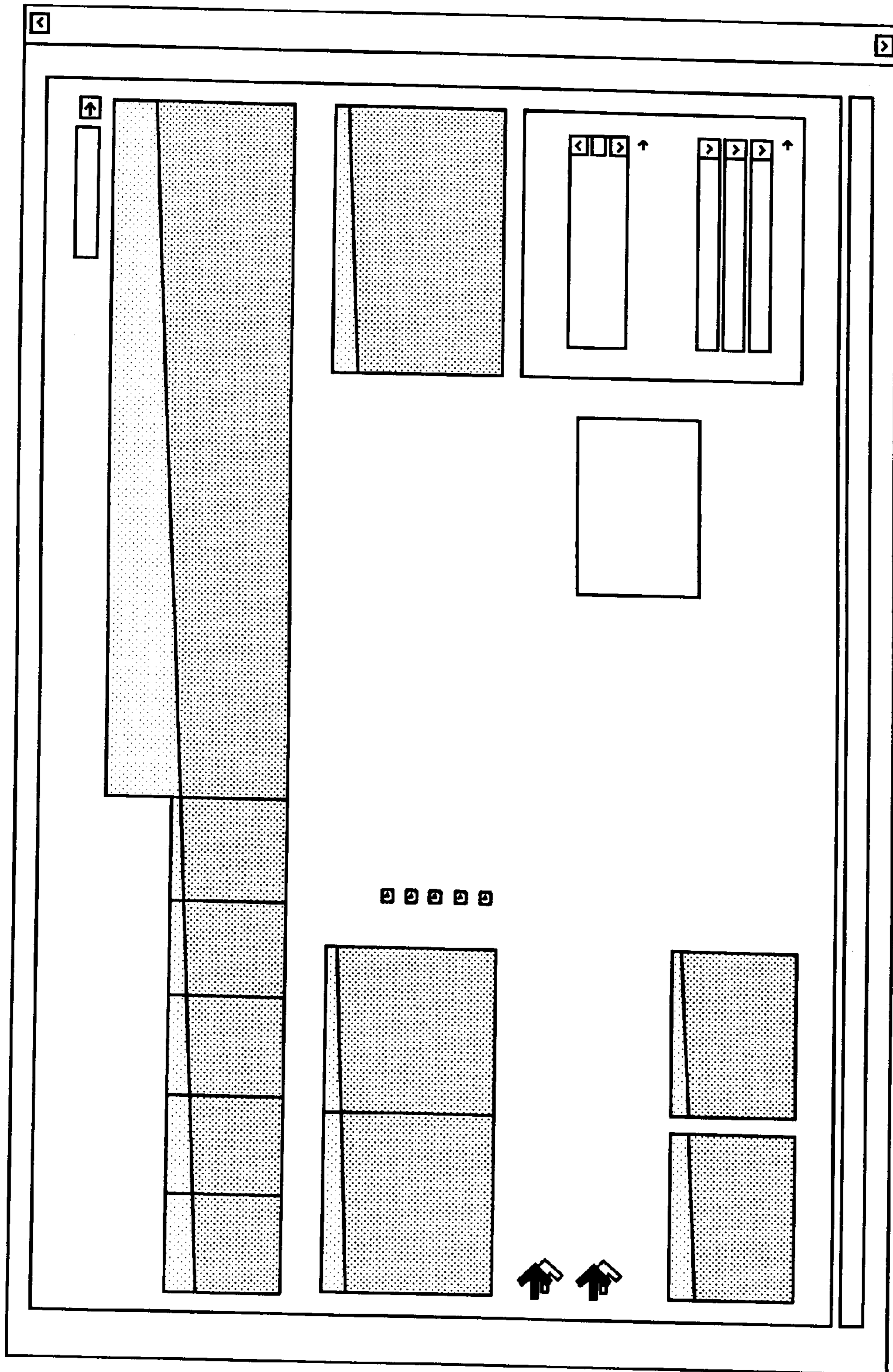

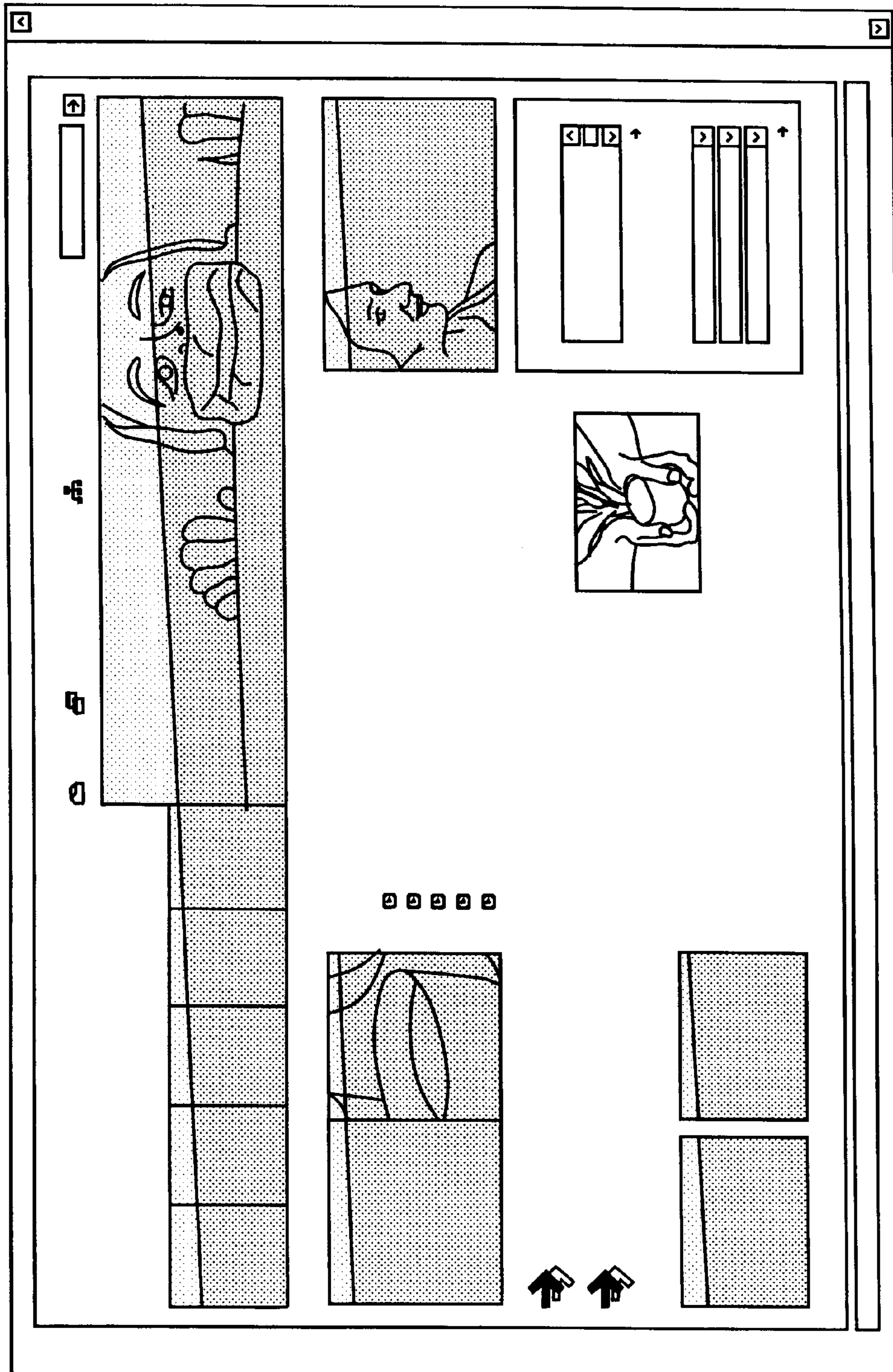

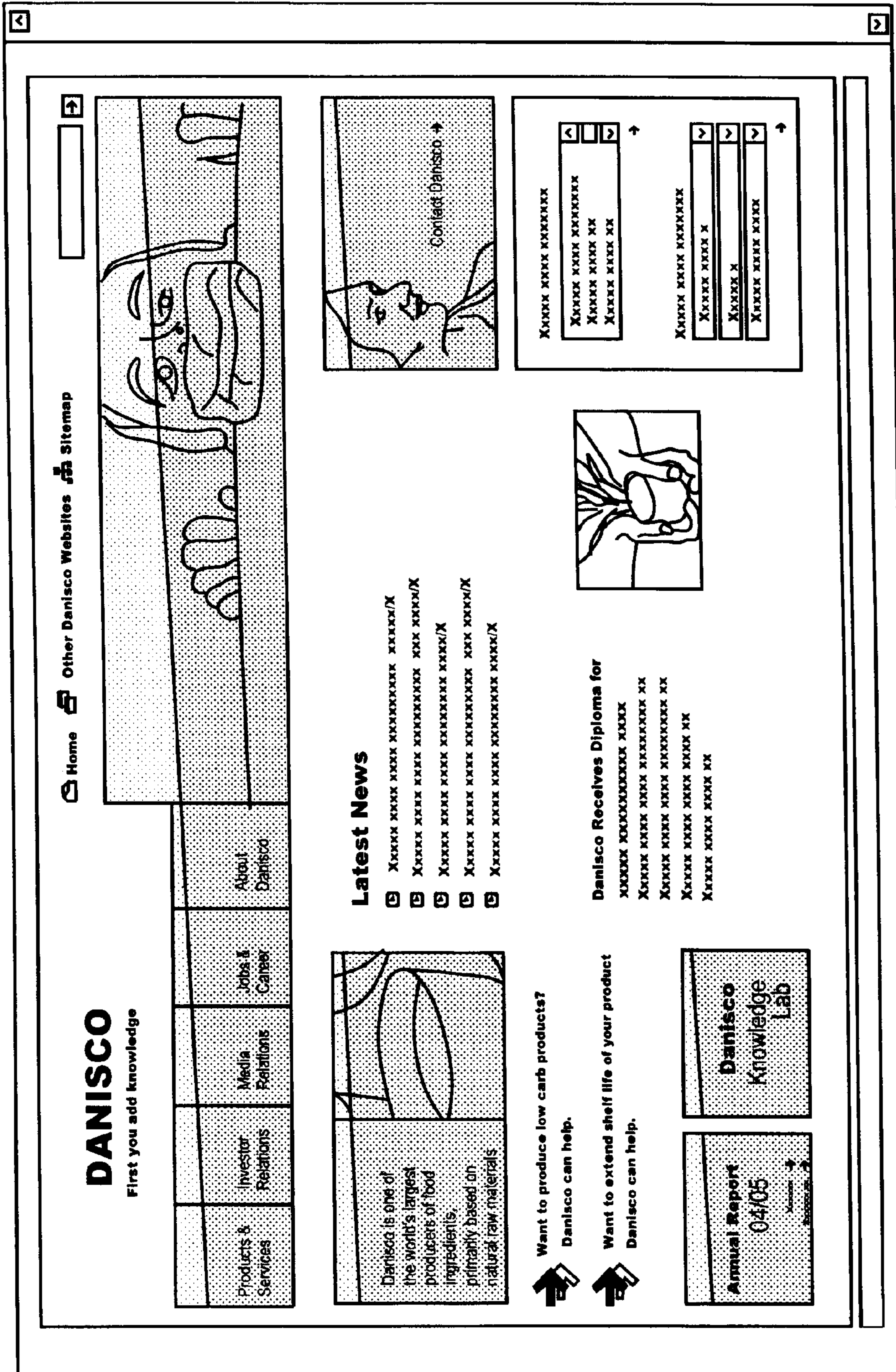

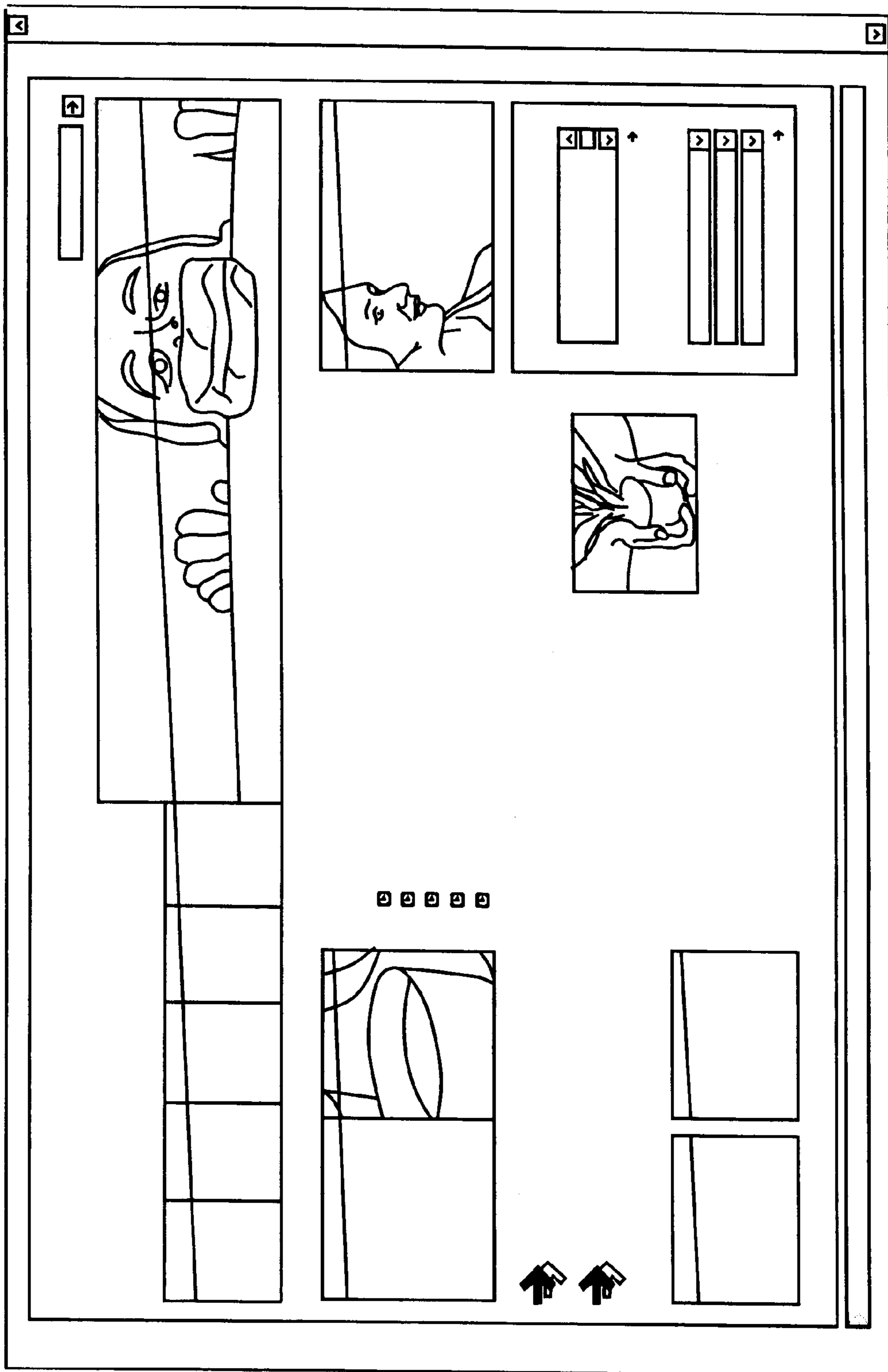

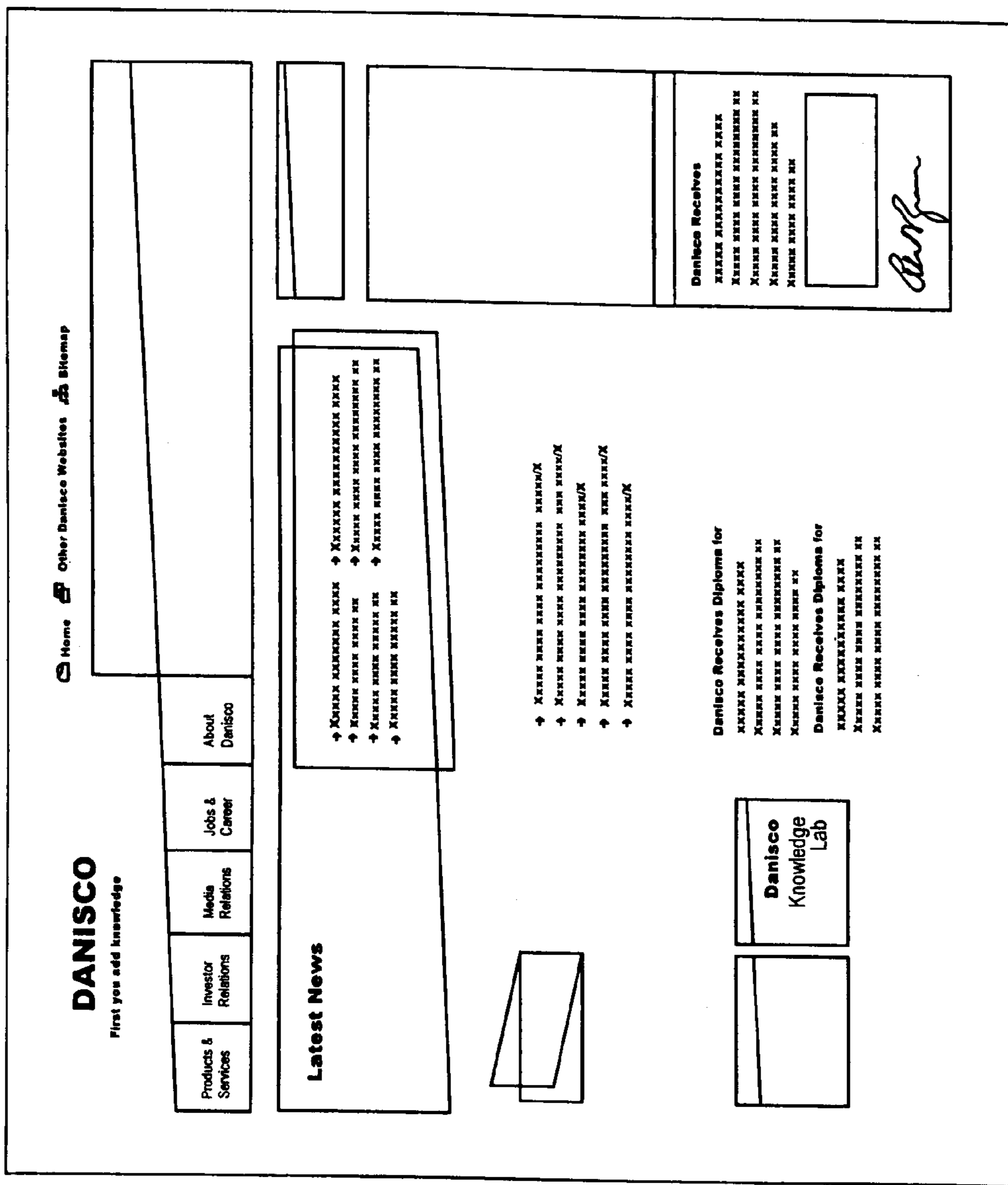
