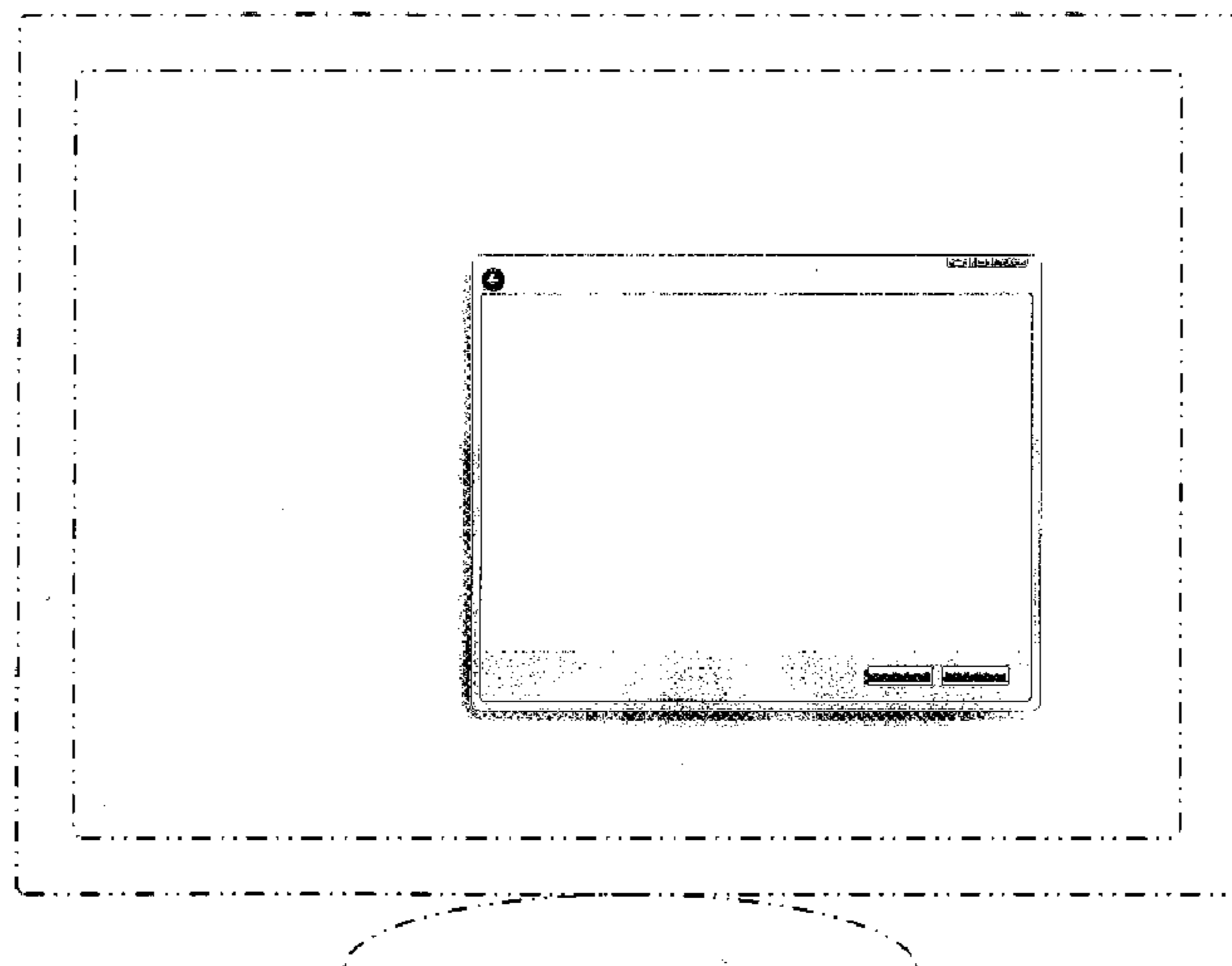
DESCRIPTION

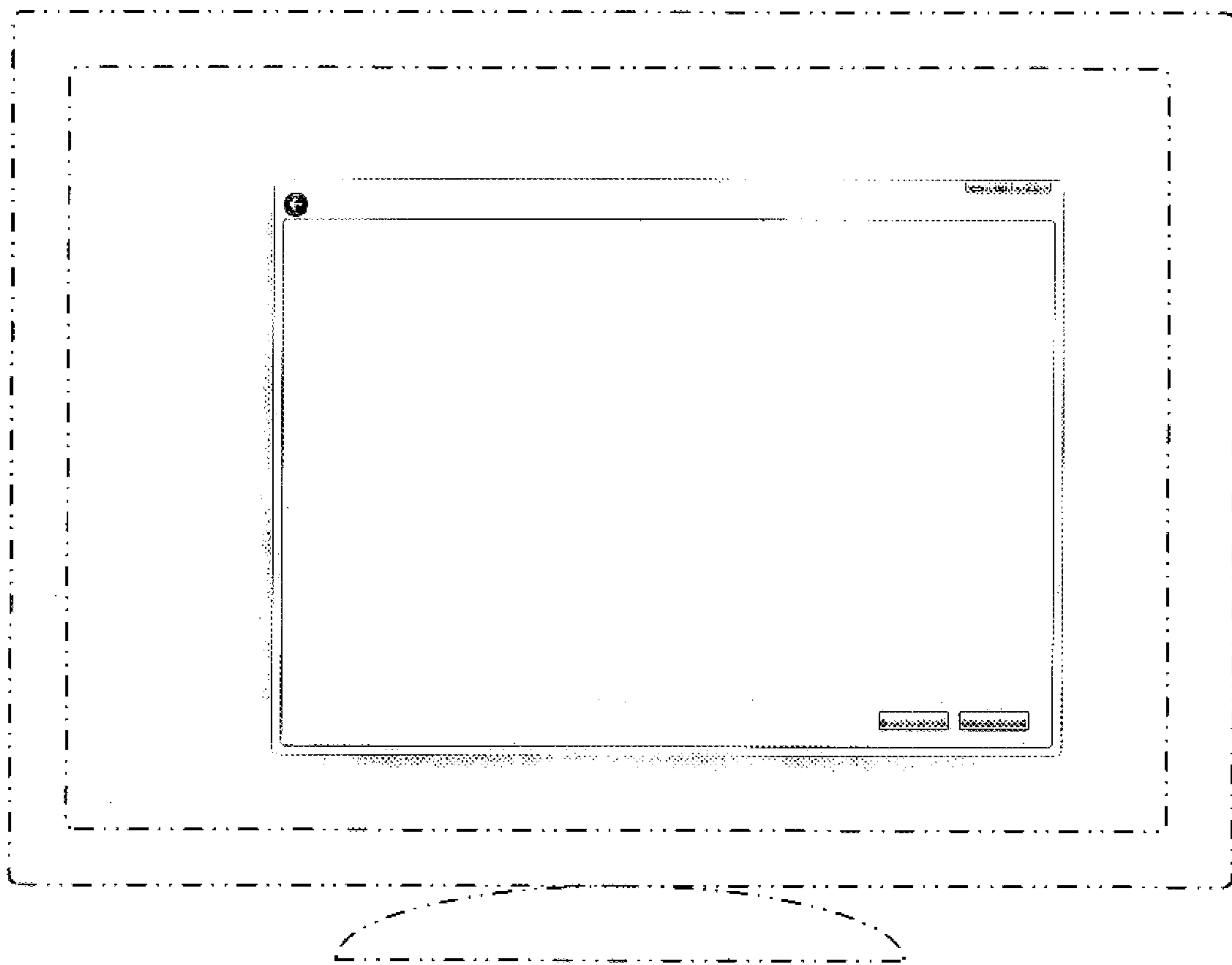

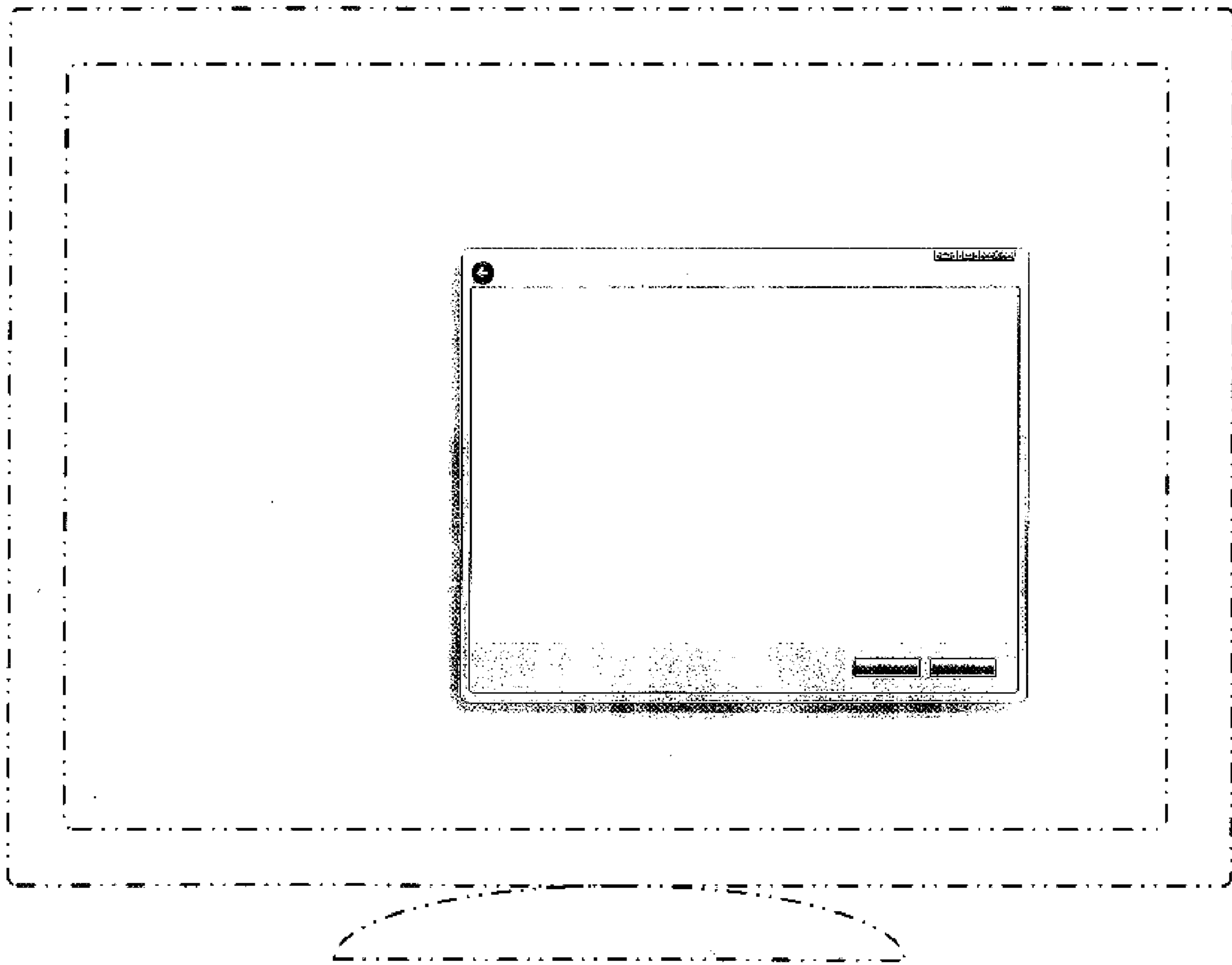

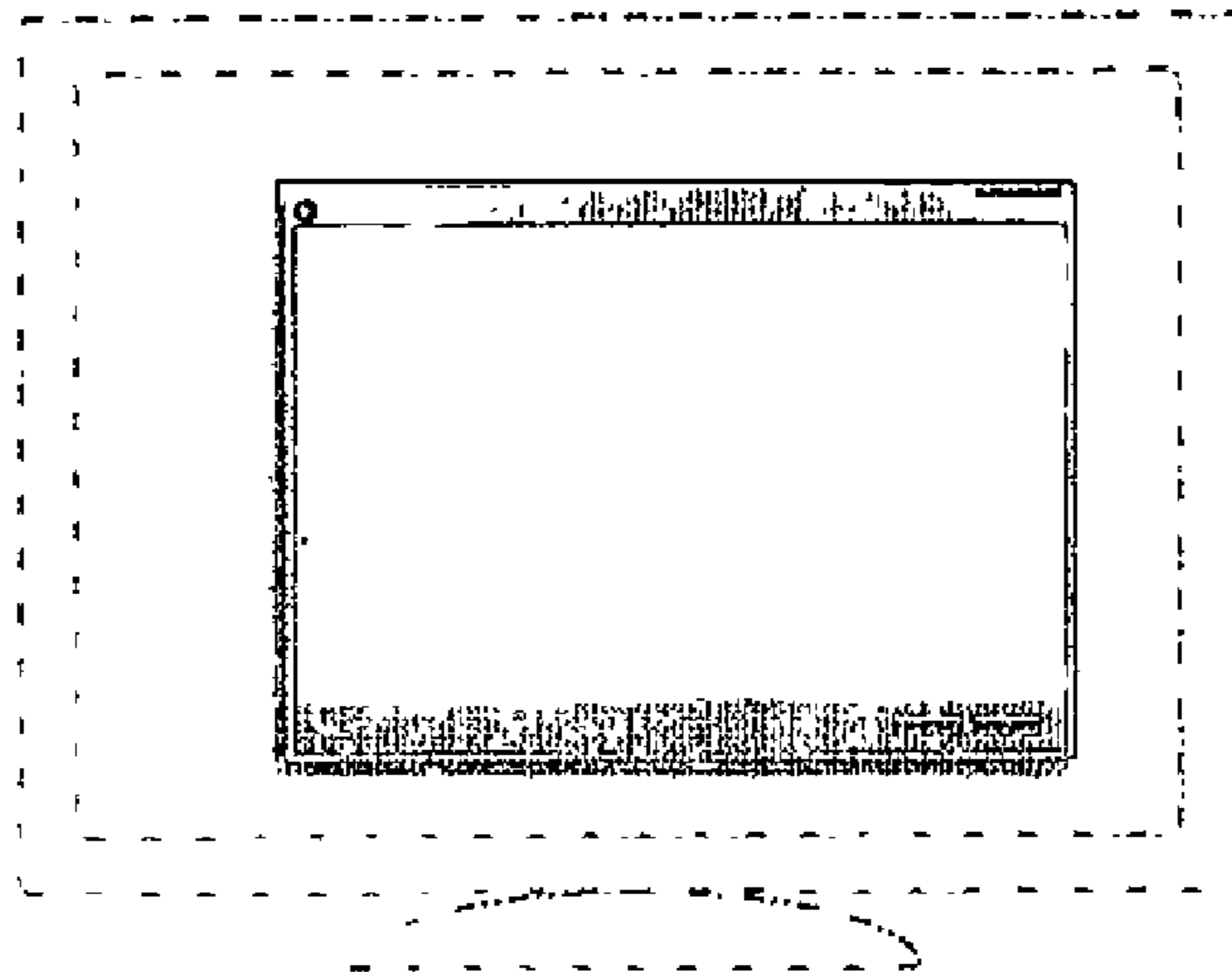

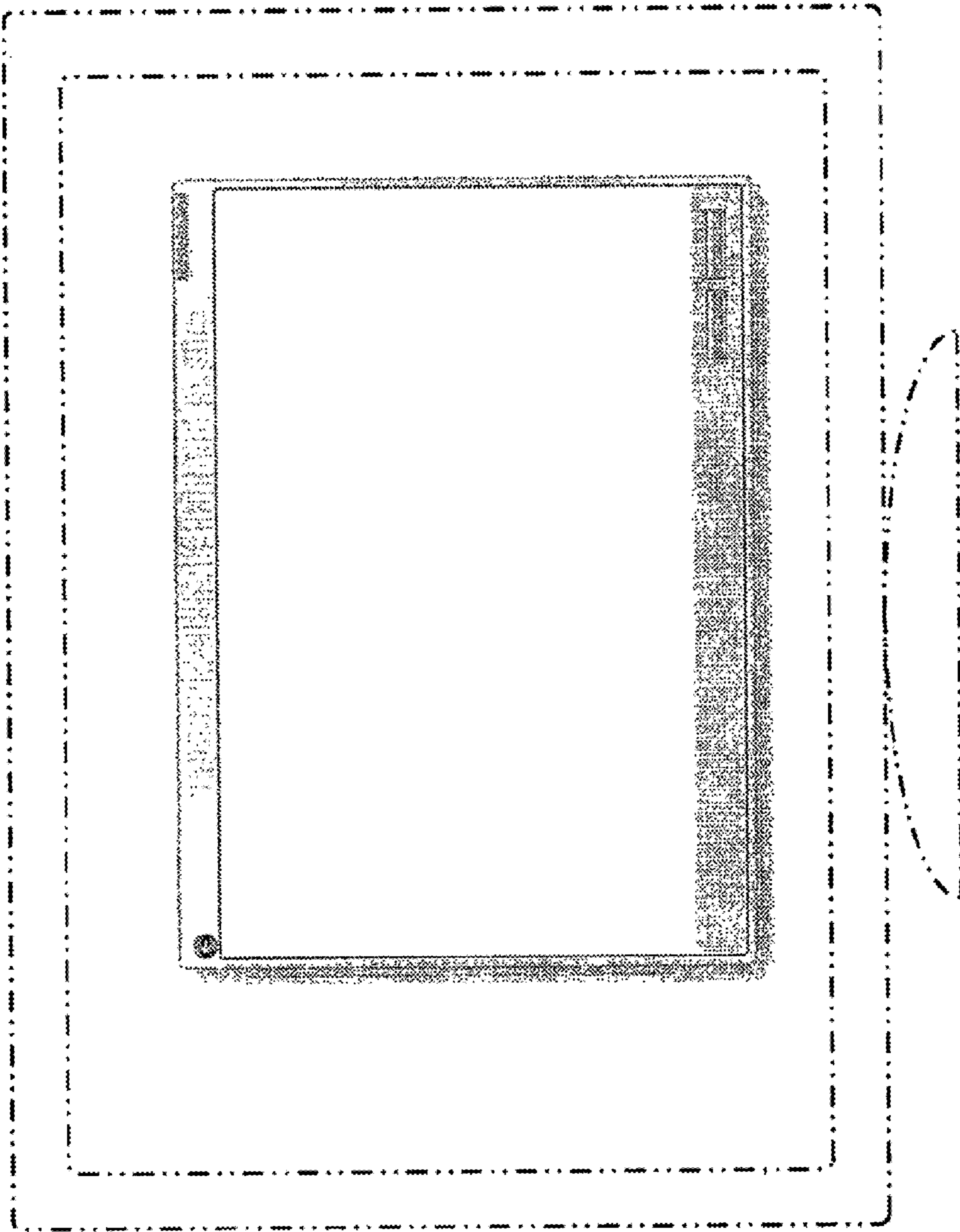

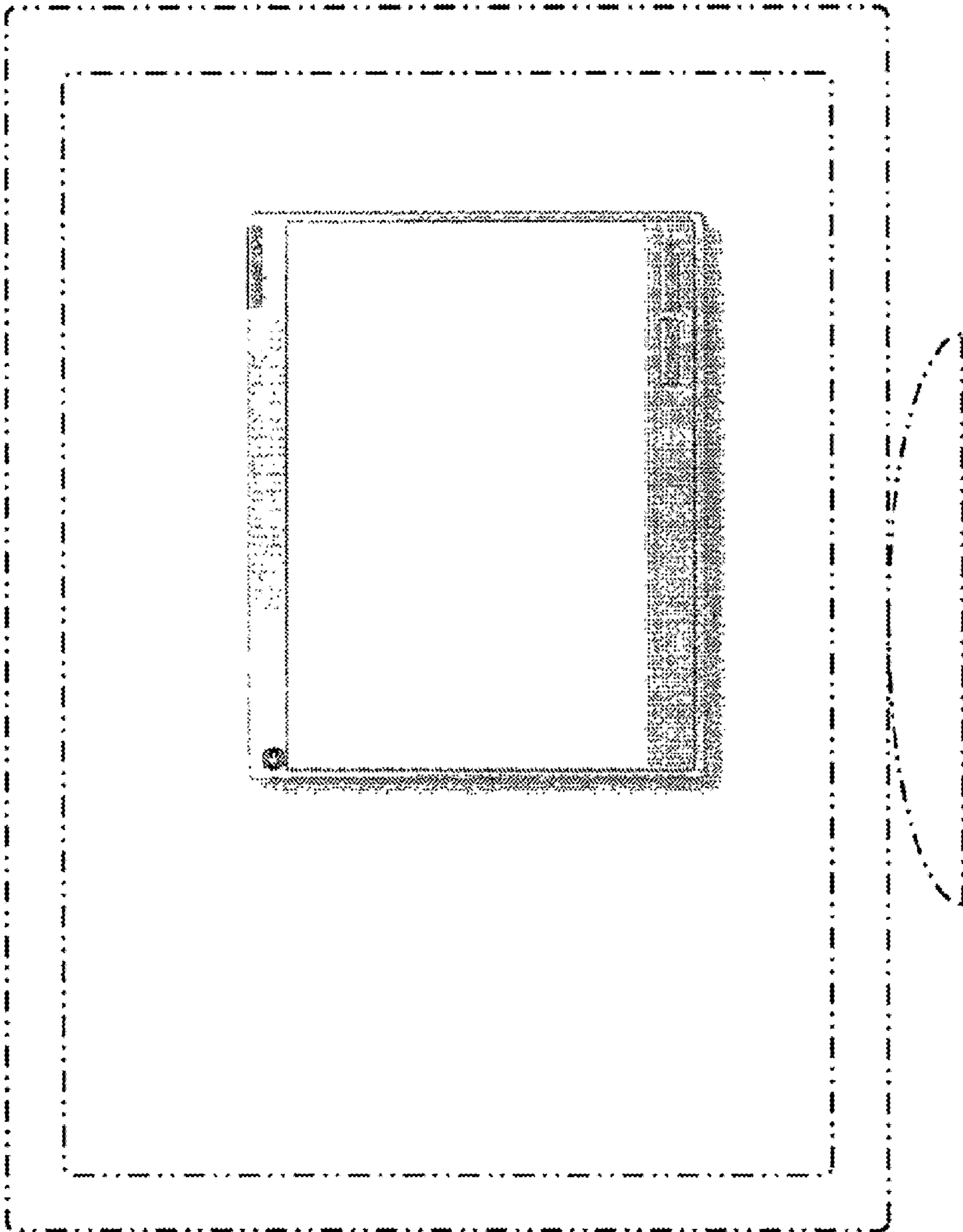
