FIG. 1 is a perspective view of a tool carrier refrigerator showing our new design;

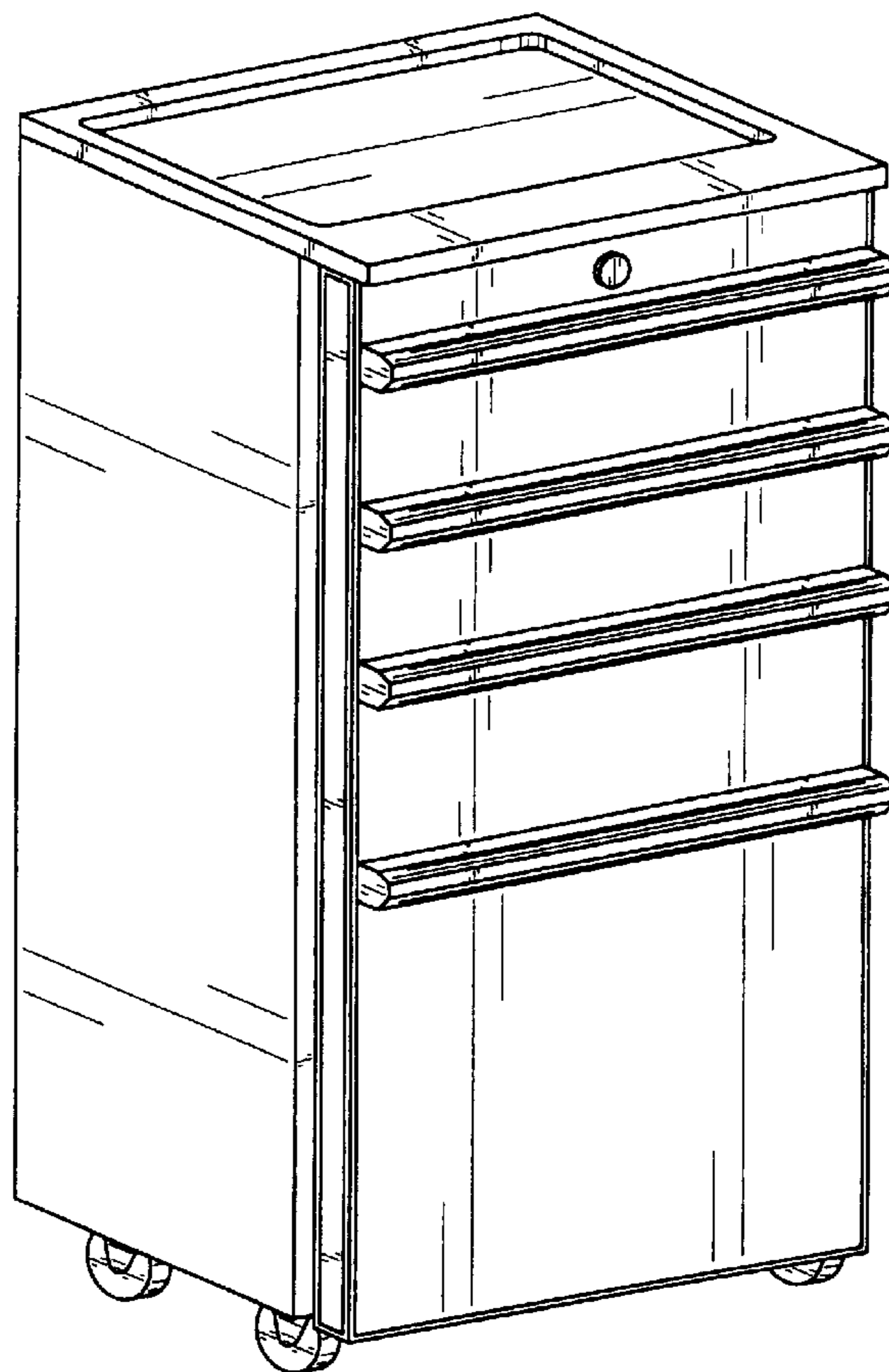
FIG. 2 is a front view thereof;

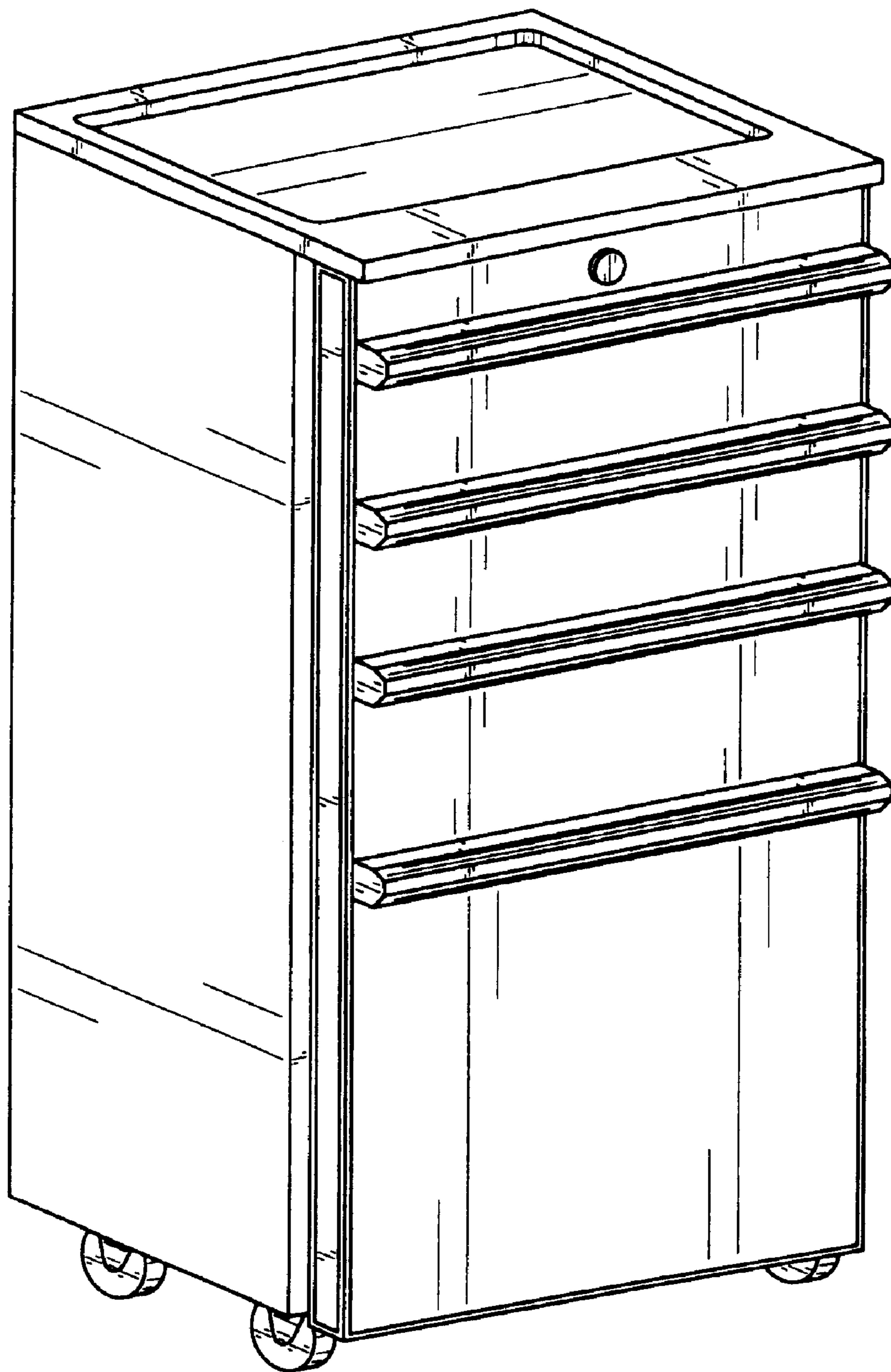

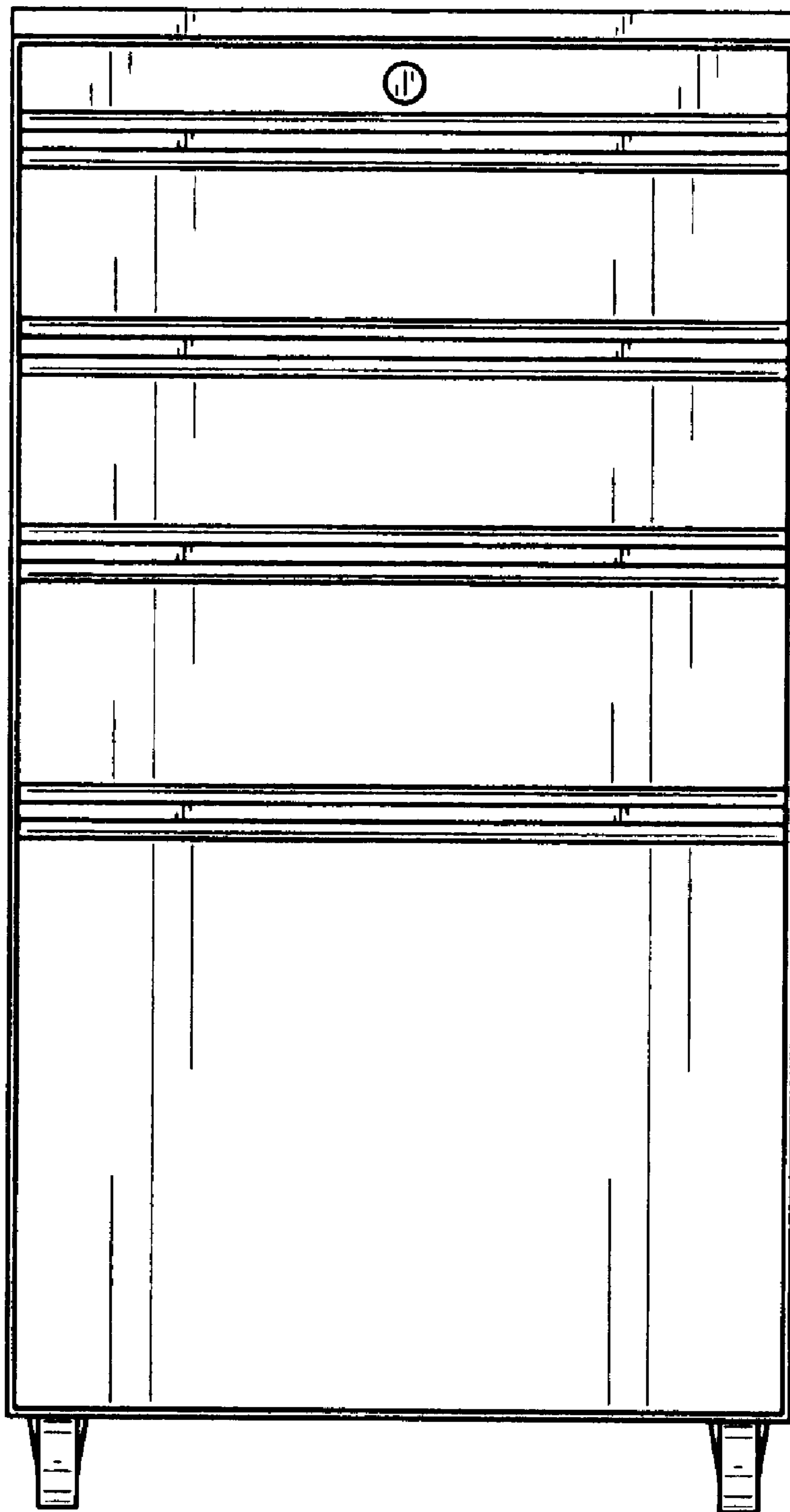

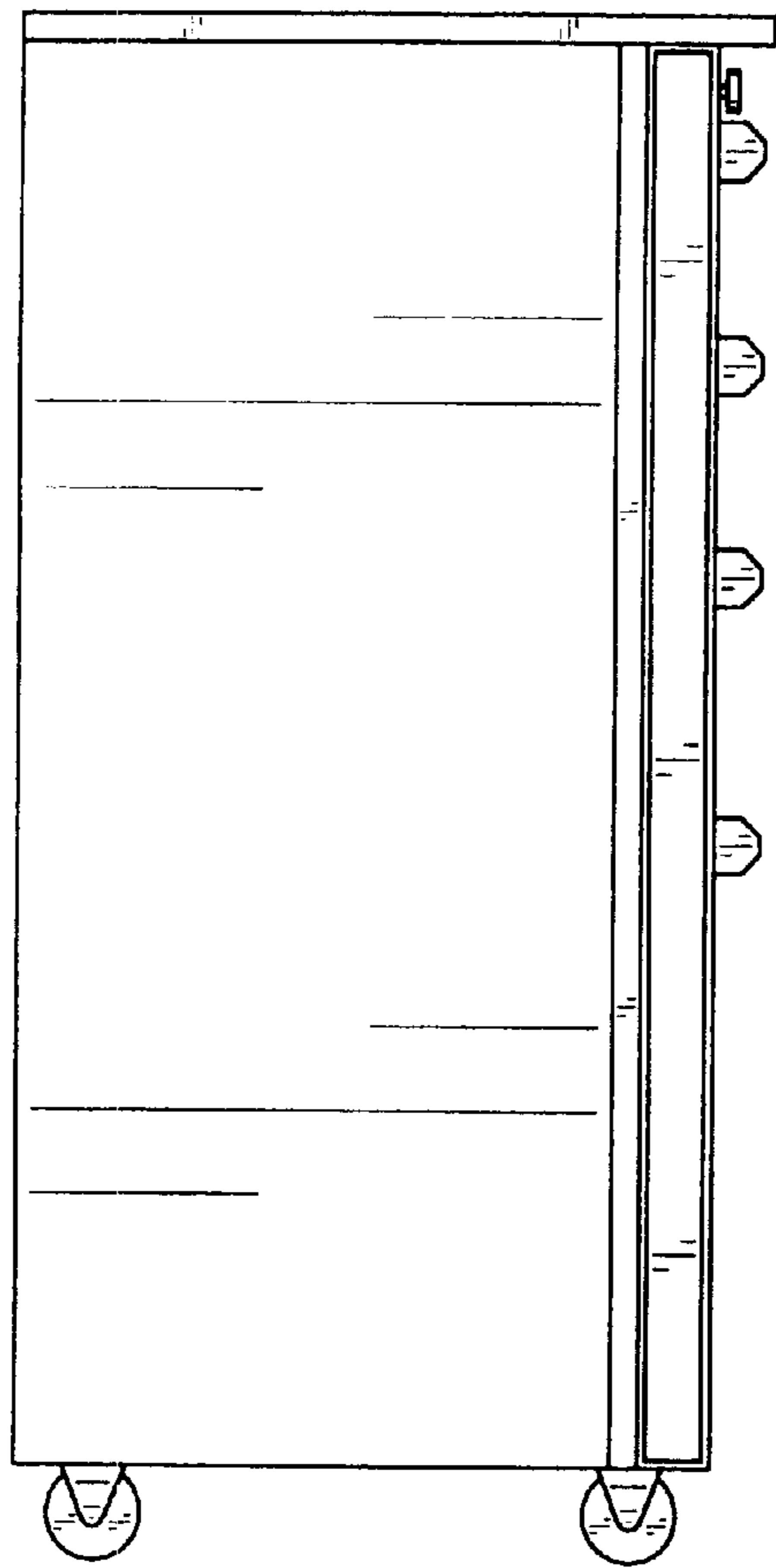

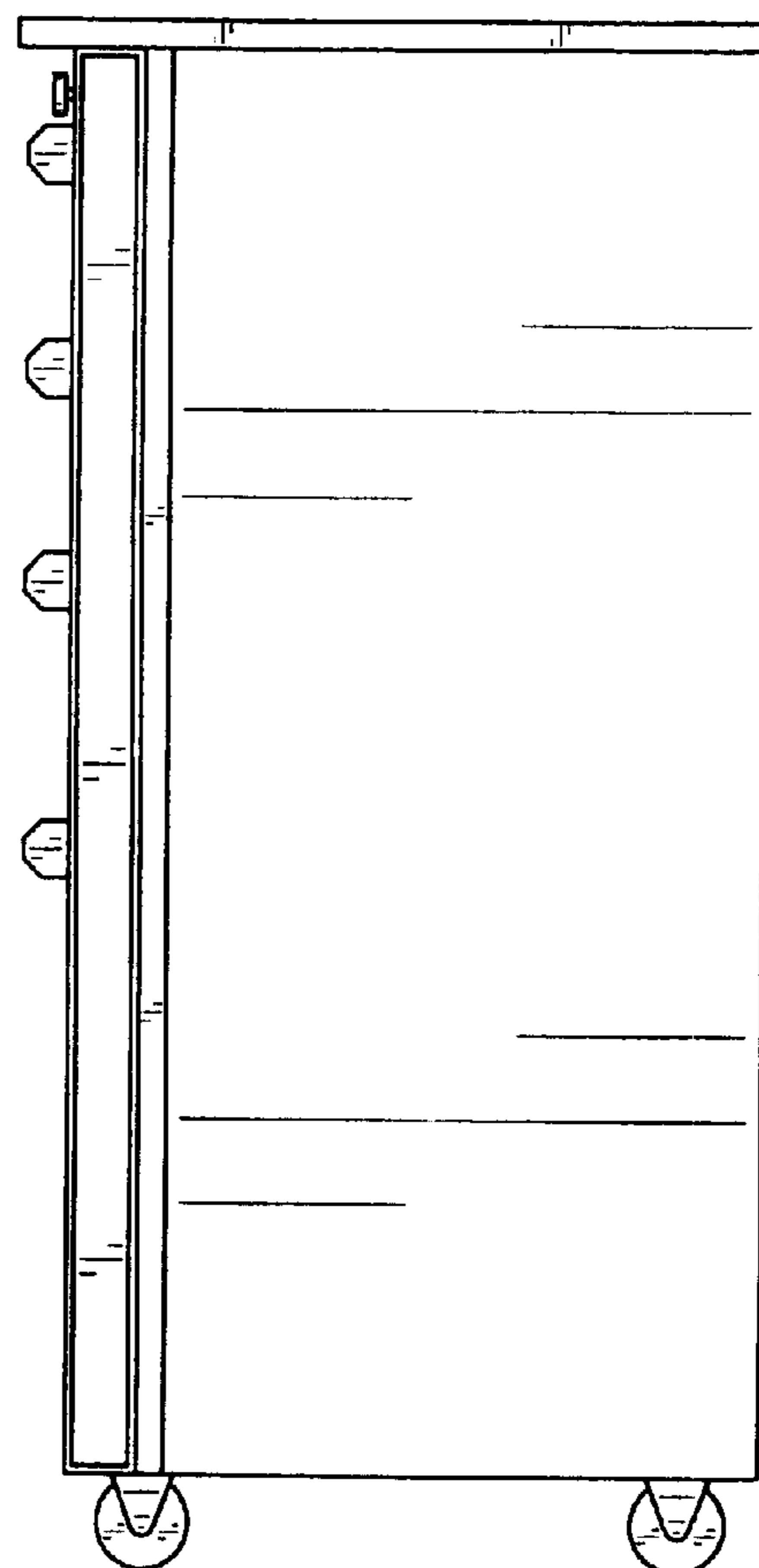

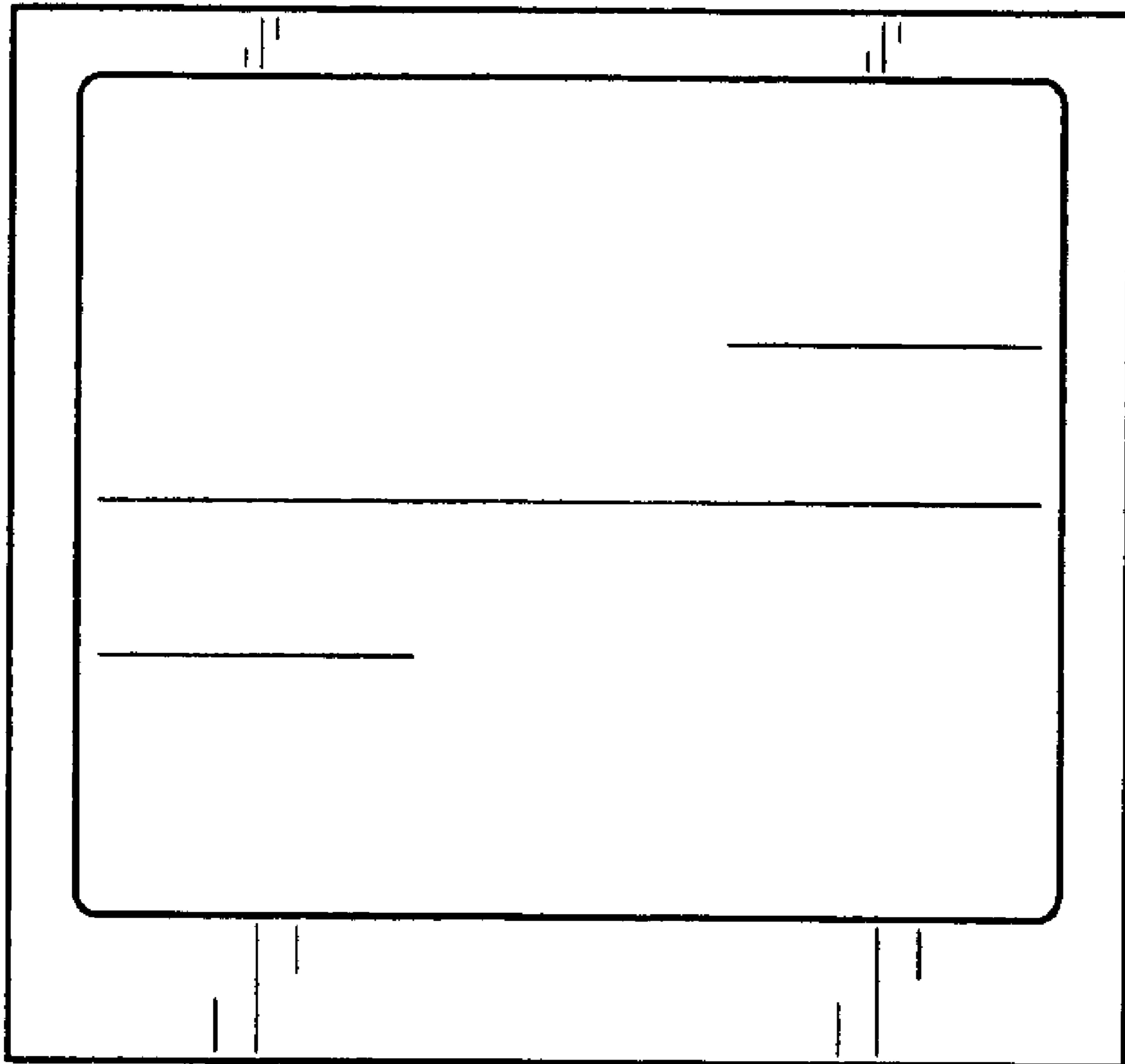
