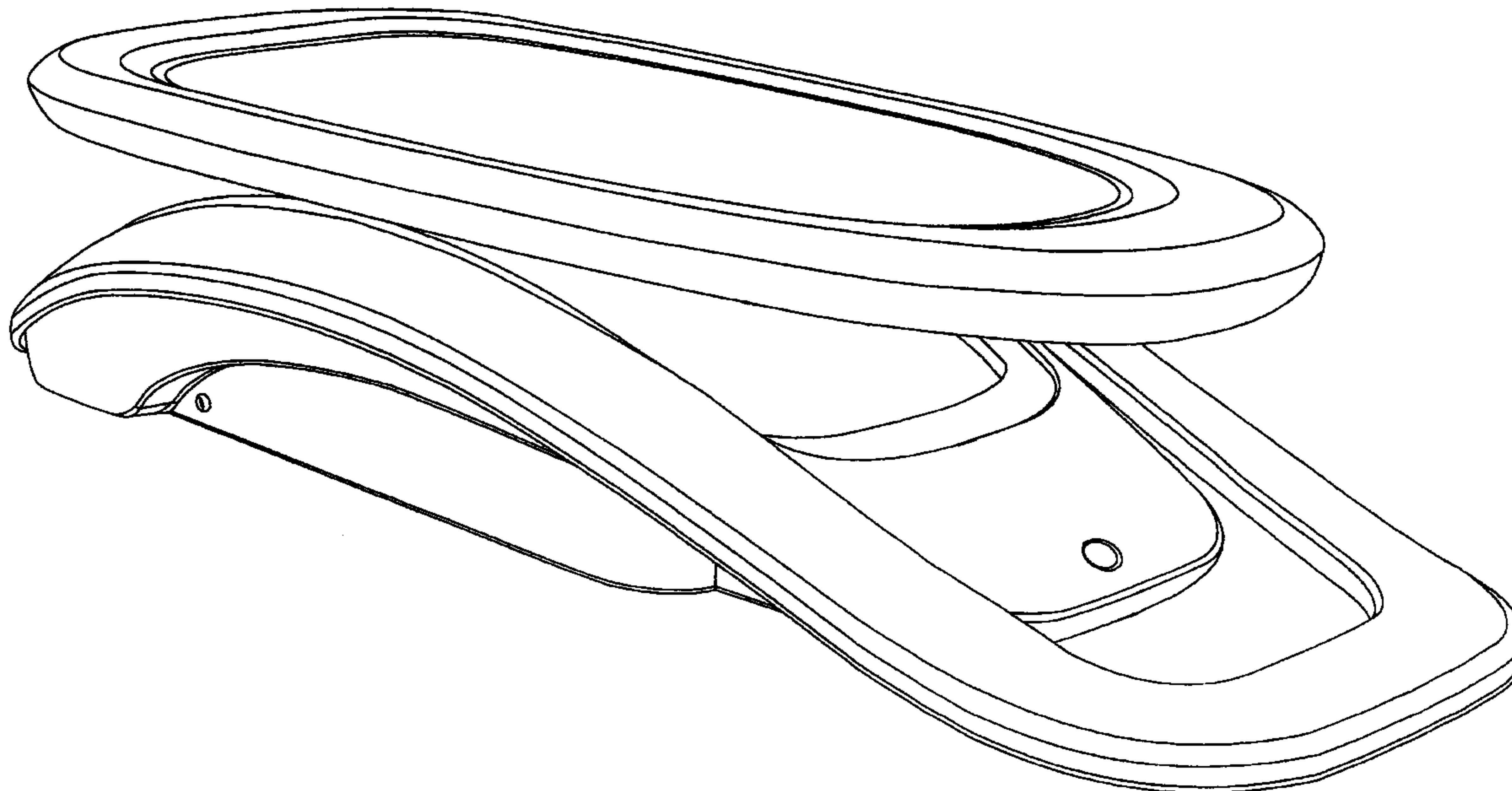
(57) **CLAIM**

DESCRIPTION

FIG. 1 is an enlarged front view of a surfing simulation apparatus showing my new design;

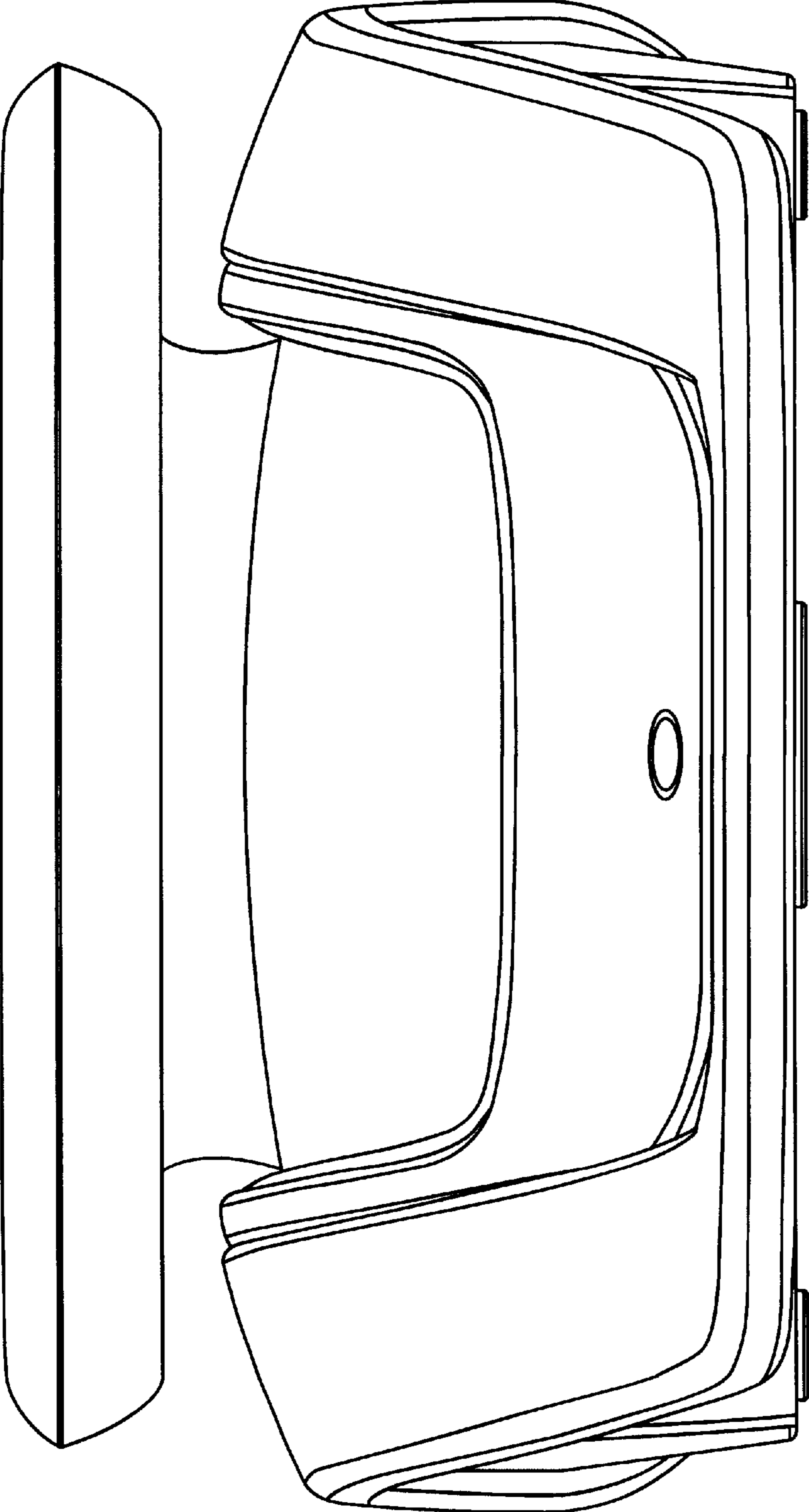

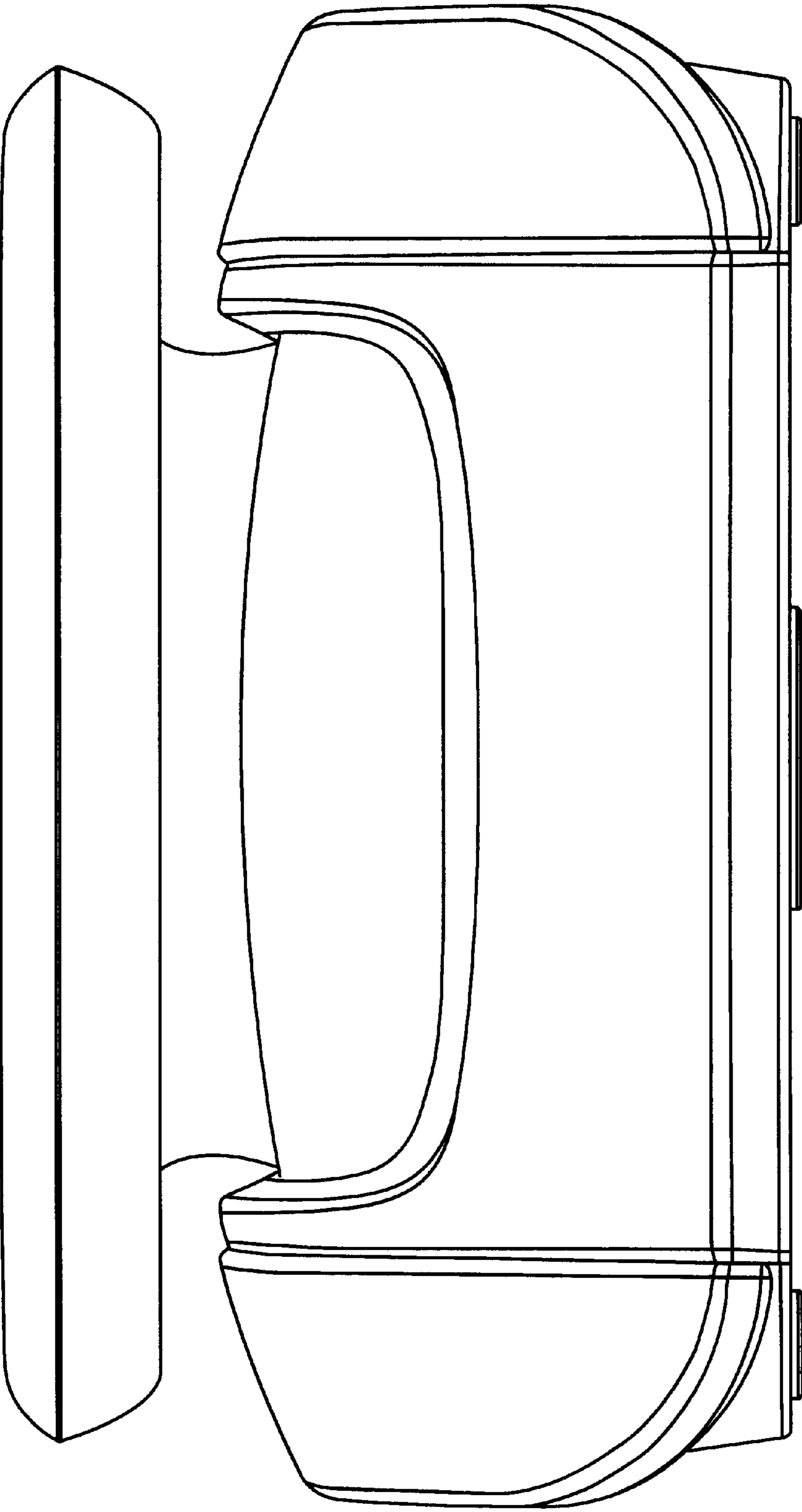

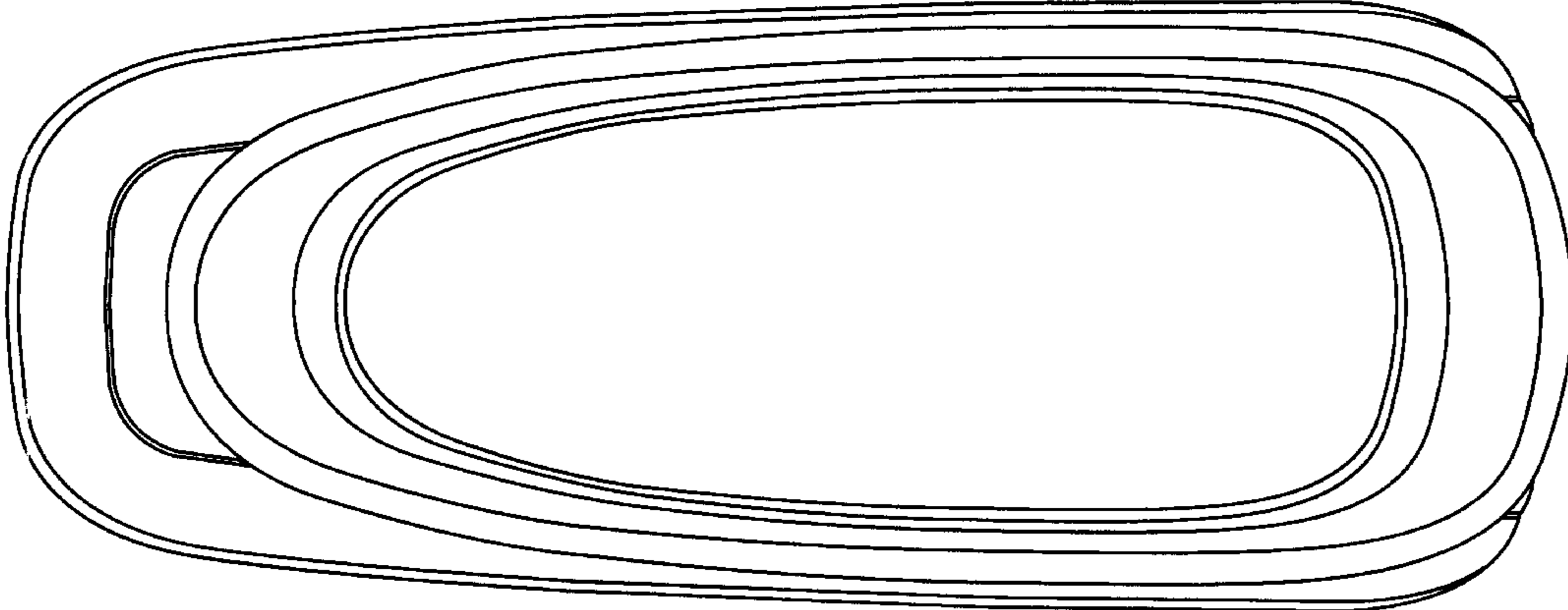
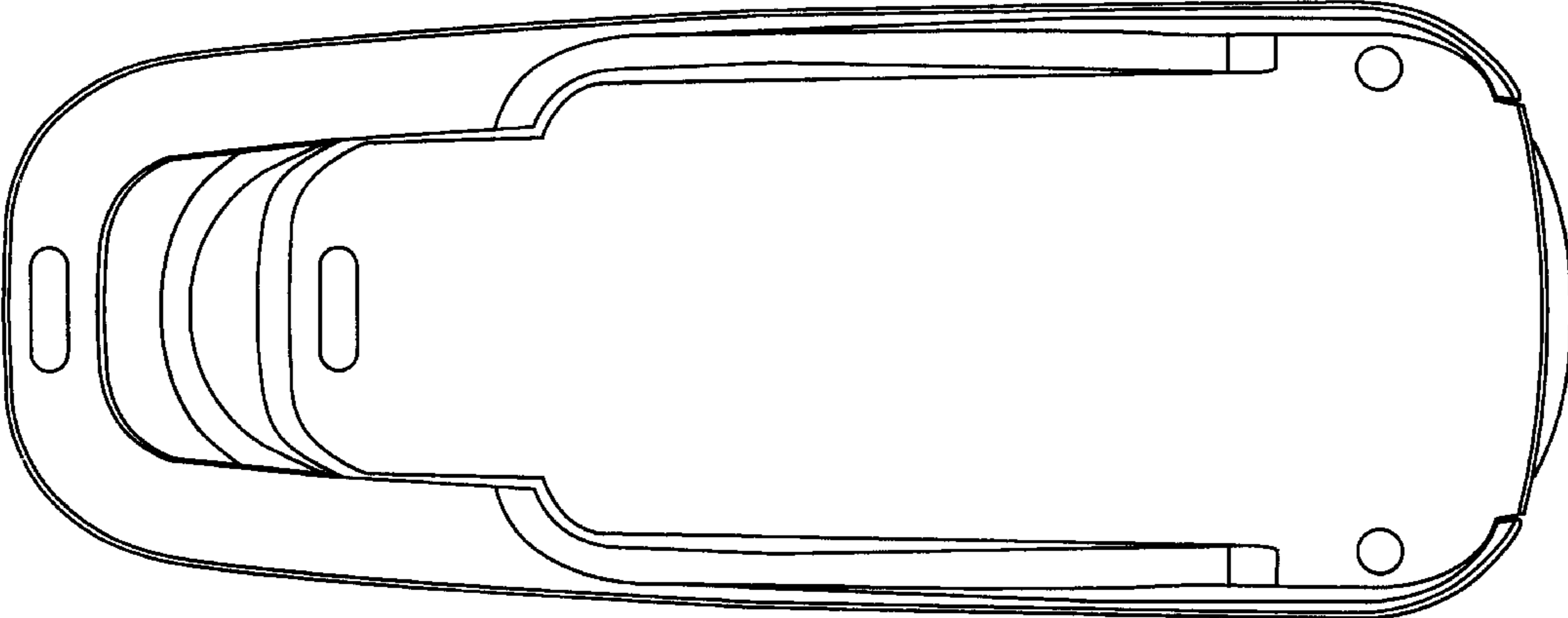

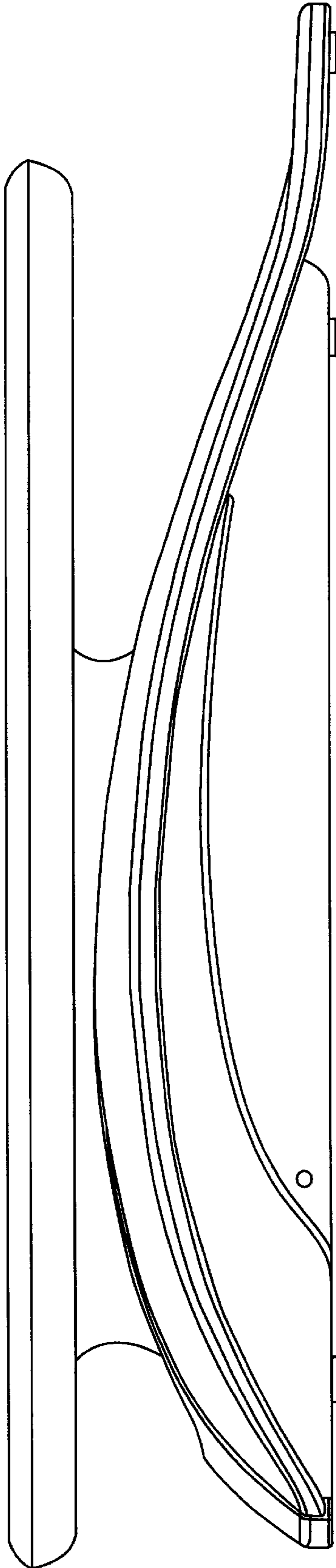

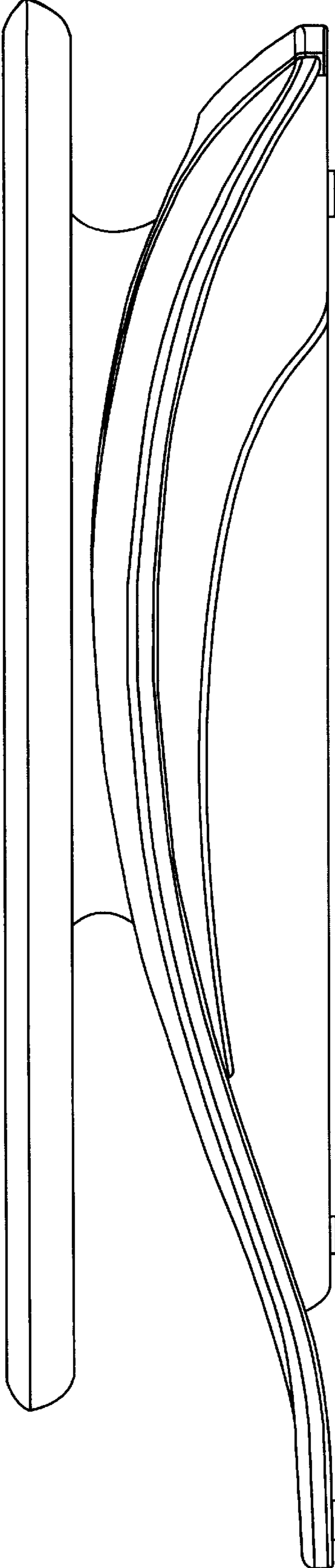

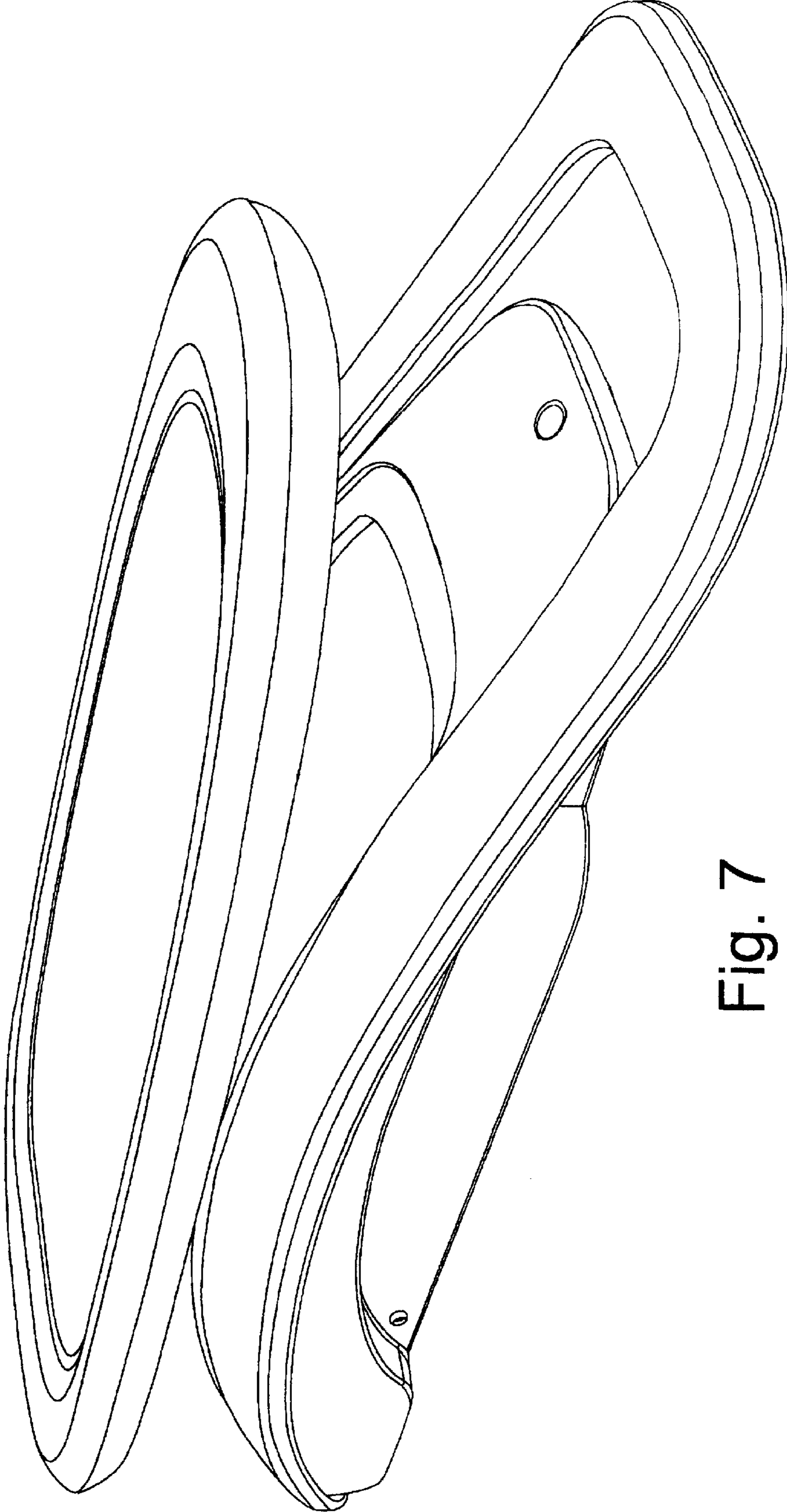

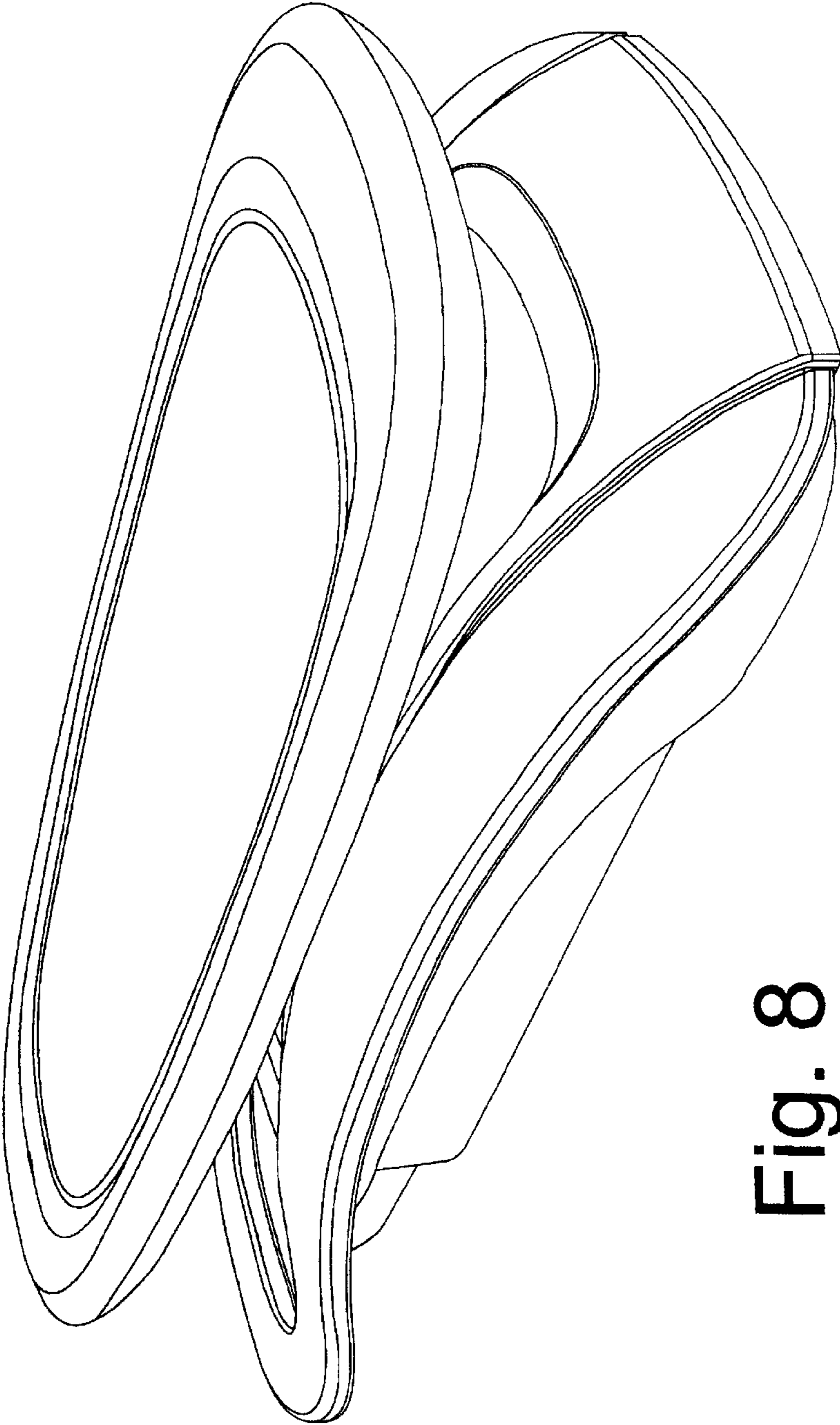
