FIG. 7 illustrates a rear plan view thereof in another embodiment;

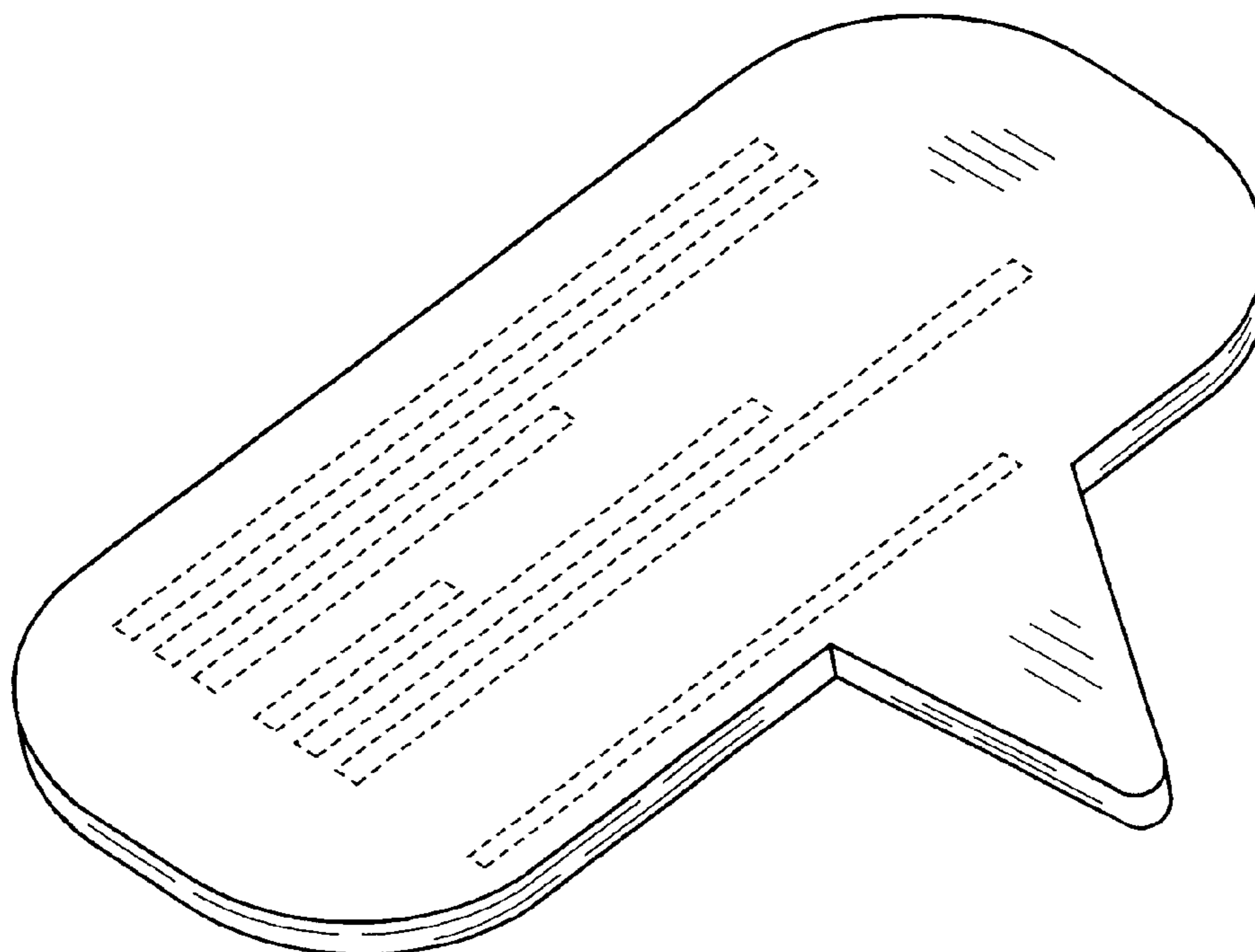
FIG. 8 illustrates a perspective view of a container and plurality of cards, showing my new design;

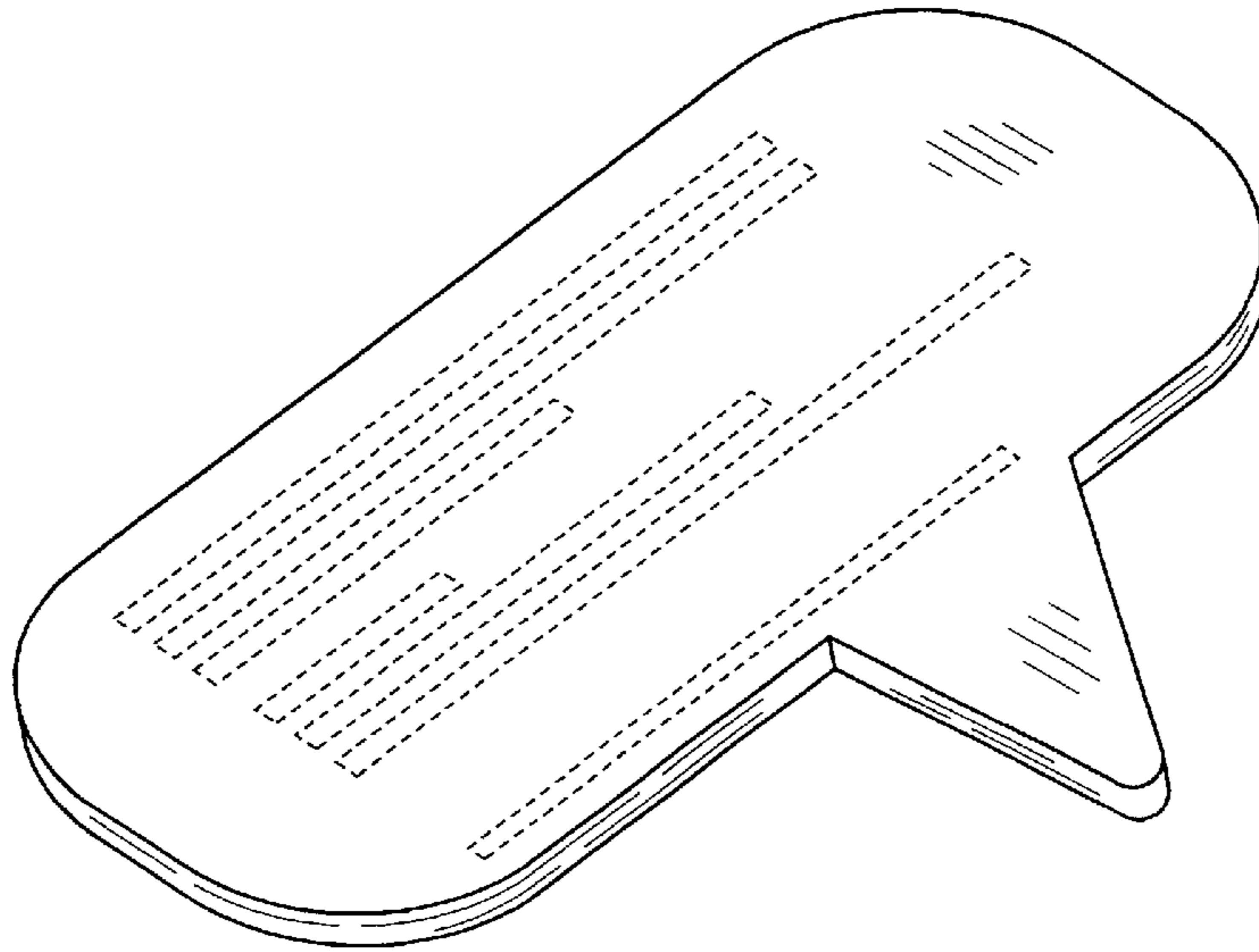

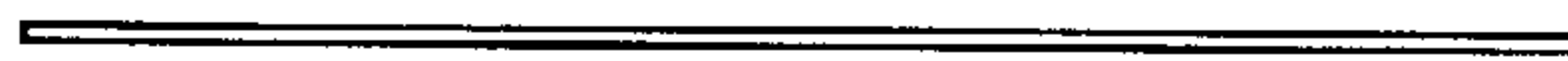

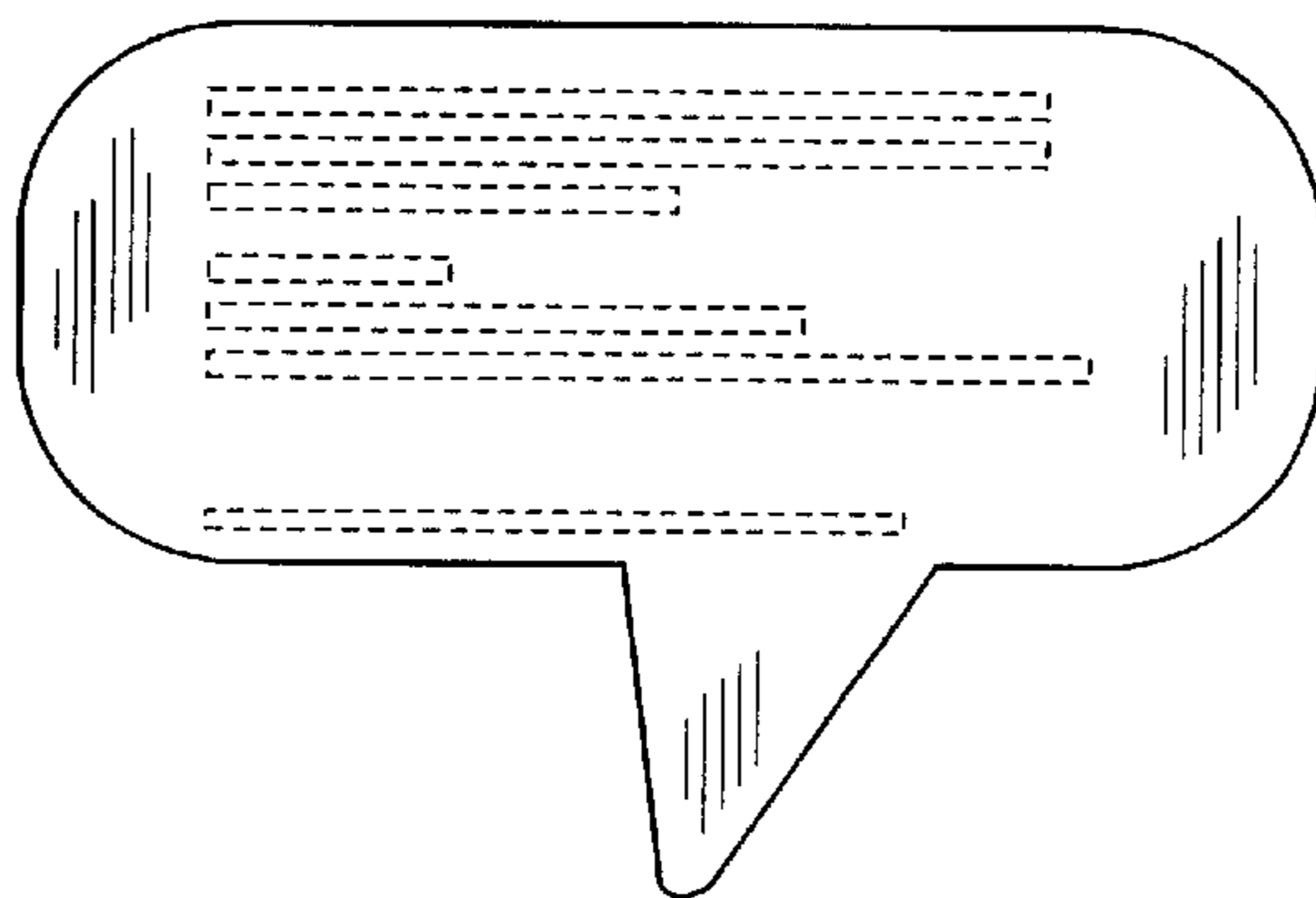

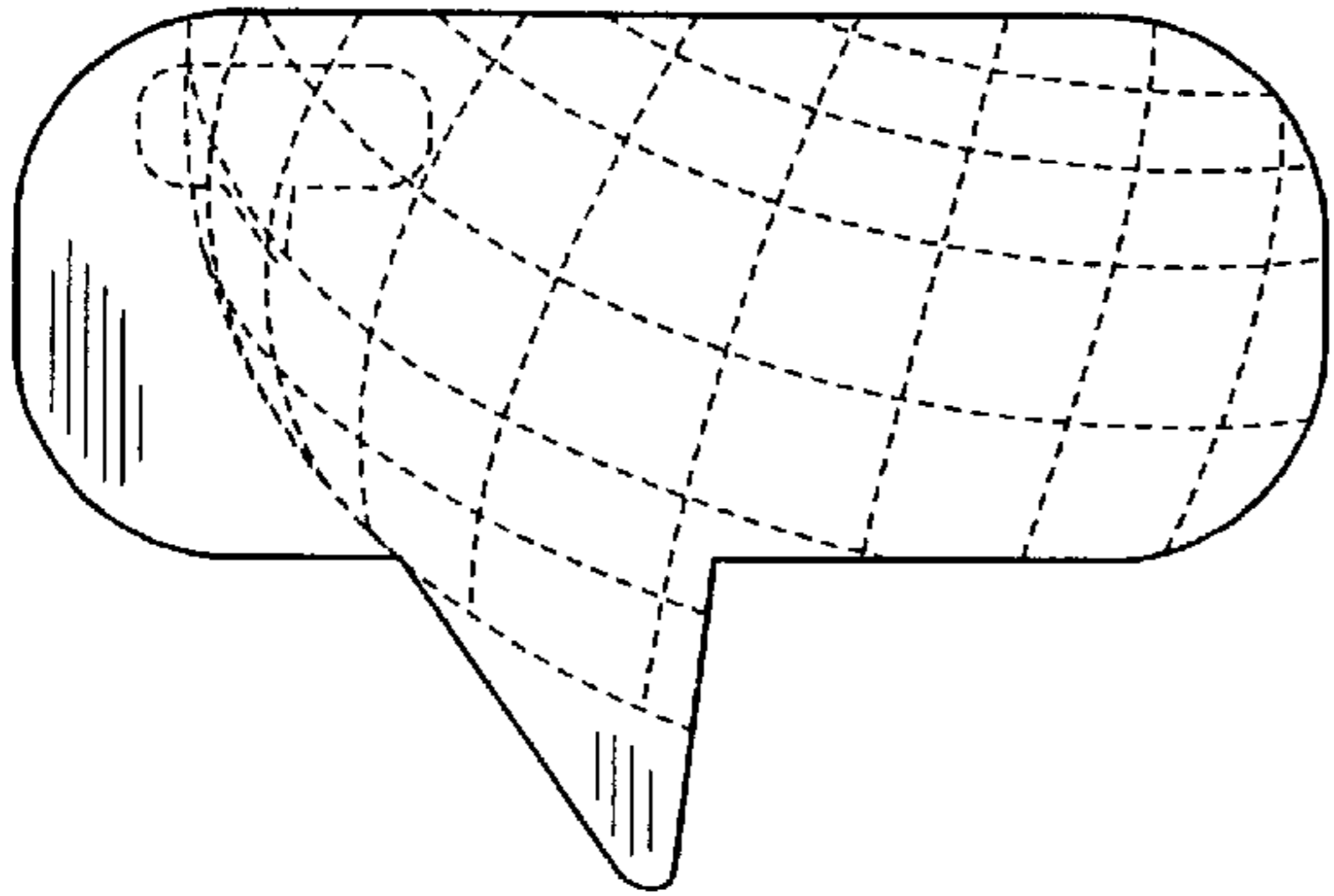

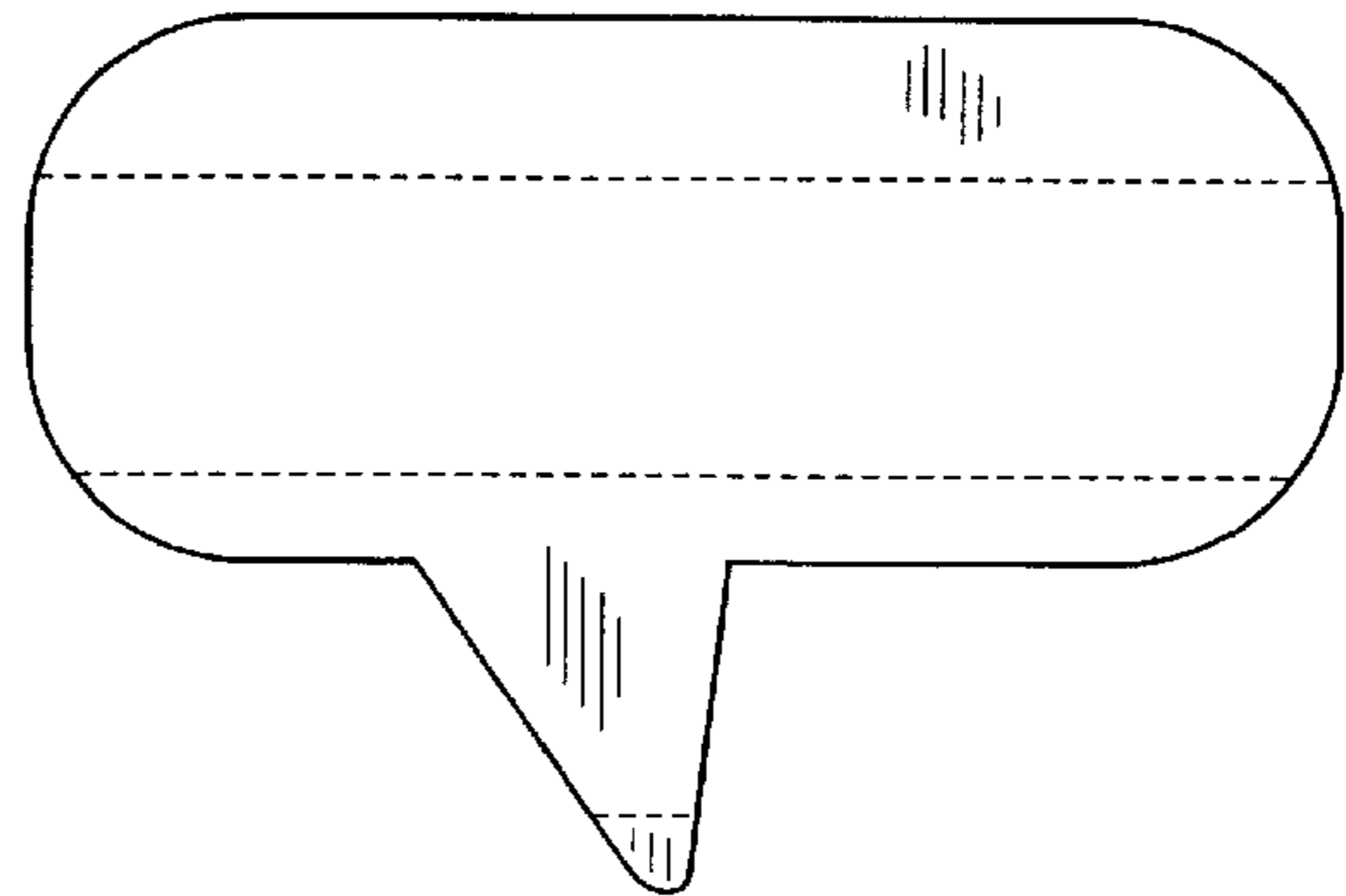

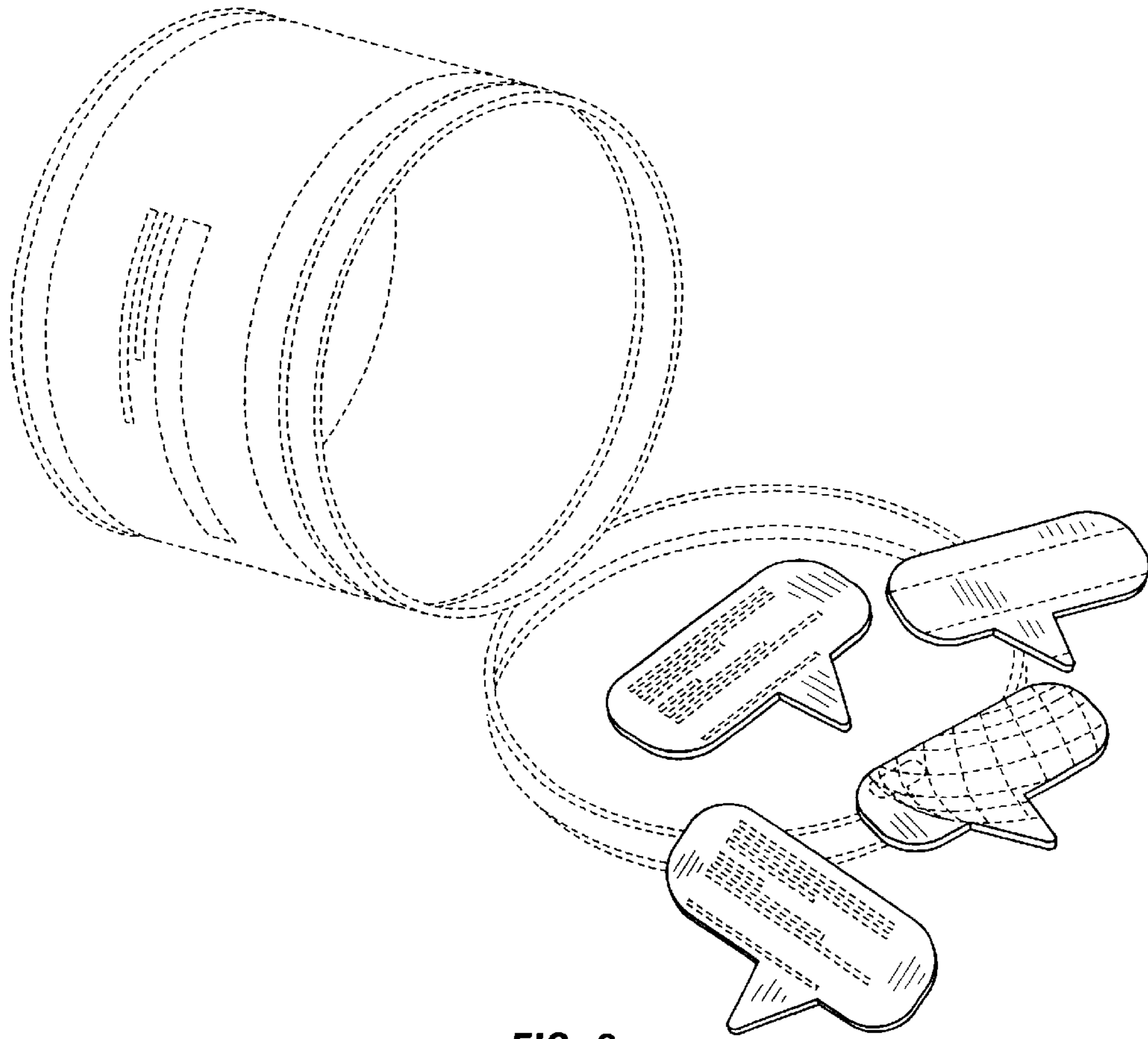

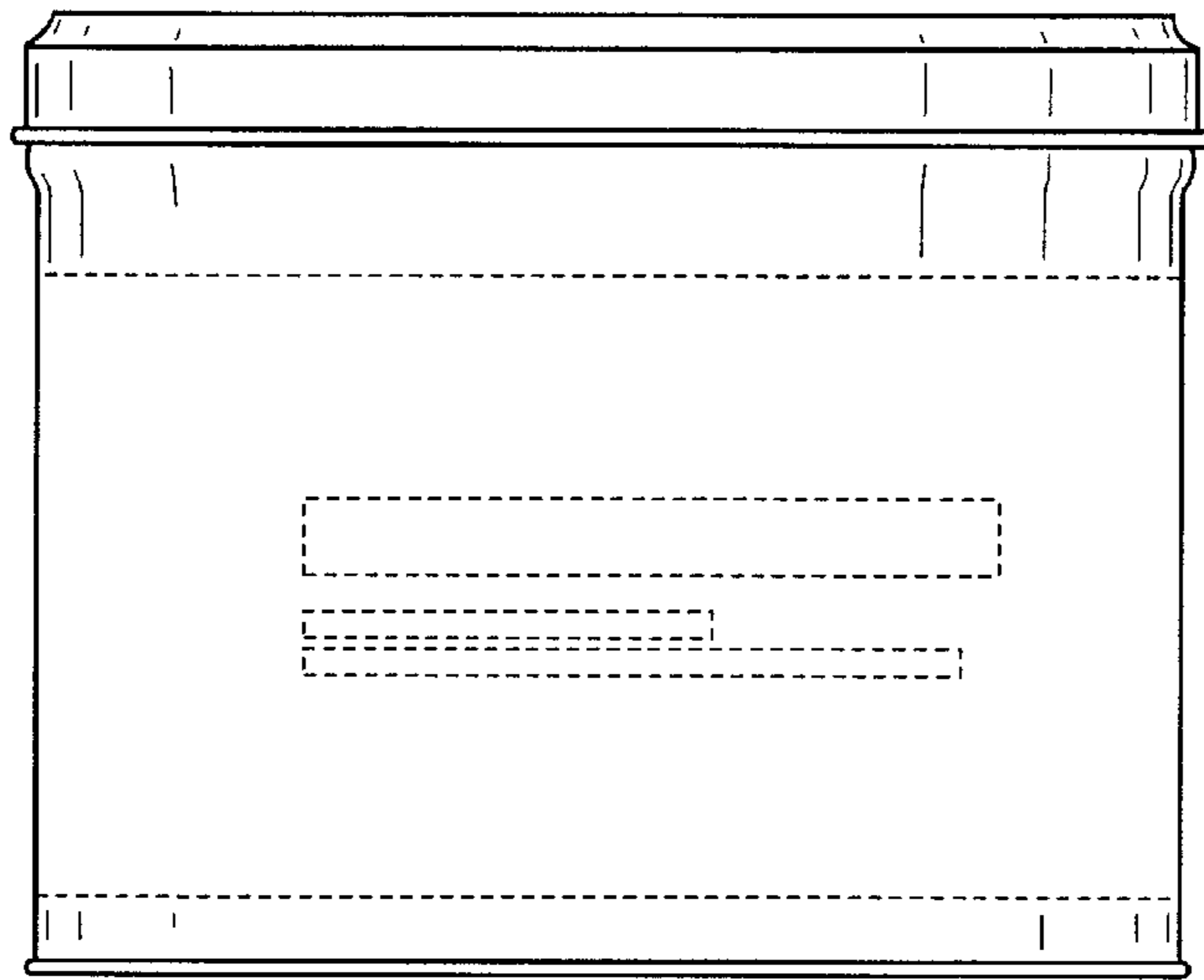

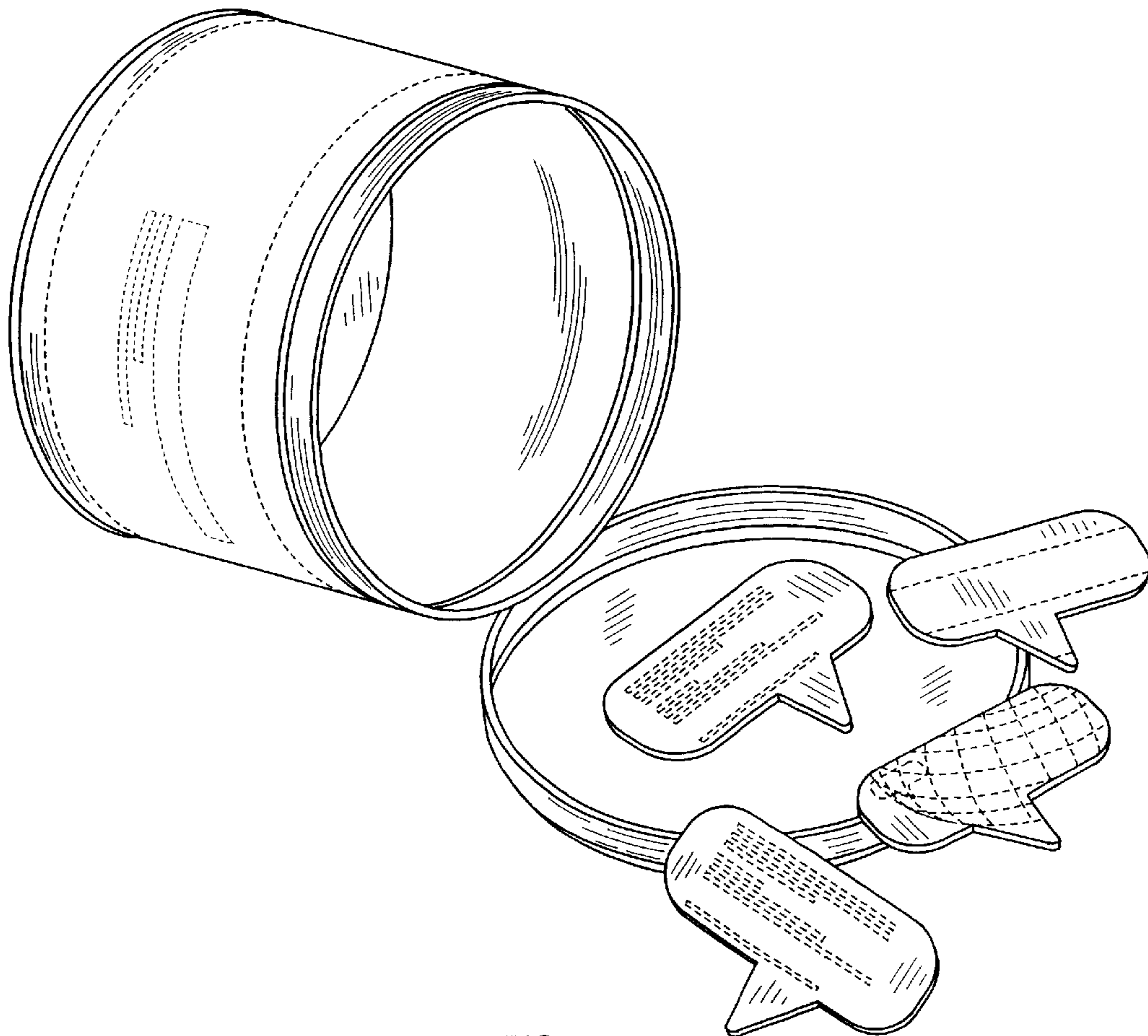
