FIG. 3 is a rear elevational view;

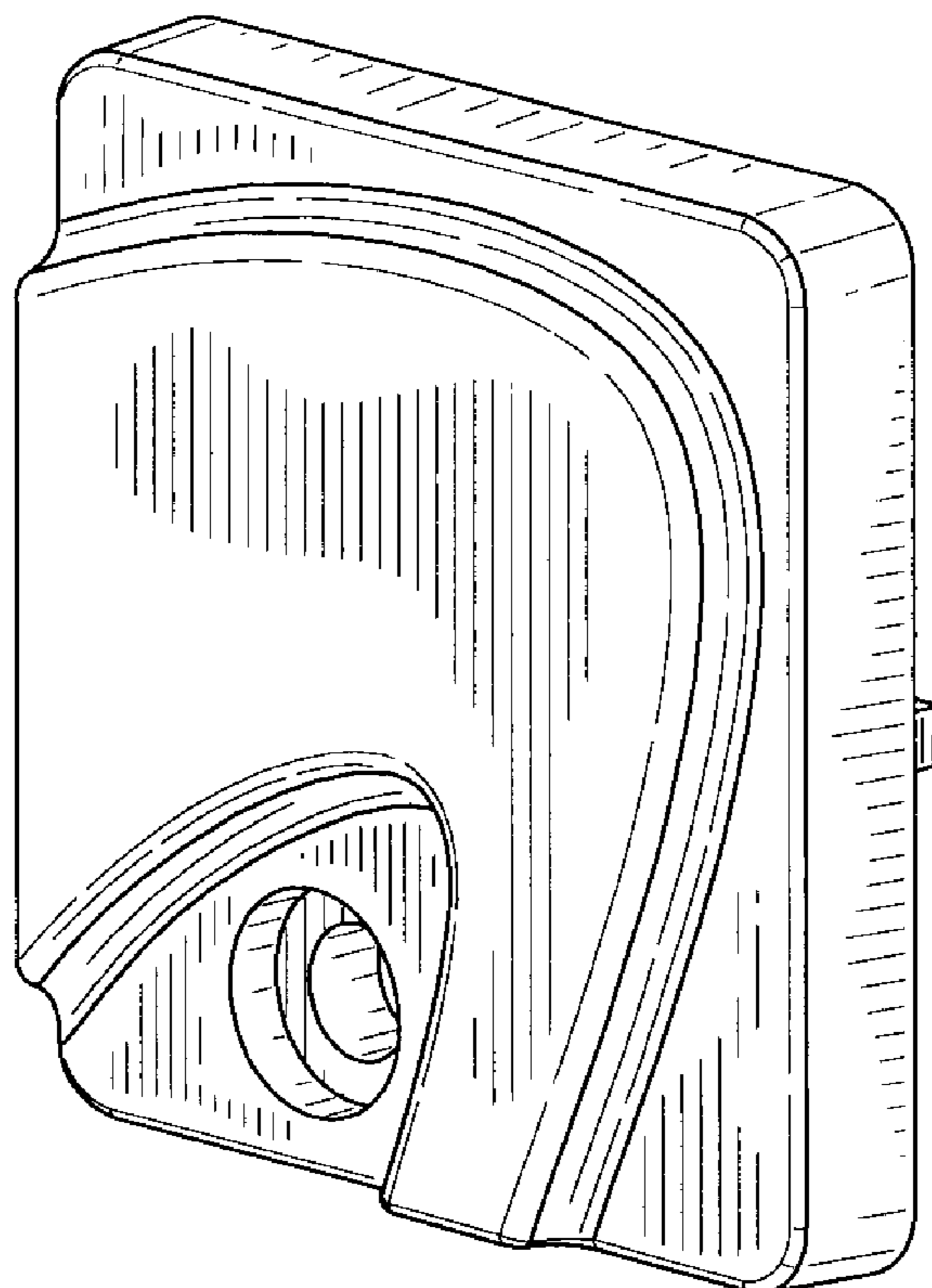
FIG. 4 is a top plan view as oriented in FIG. 1;

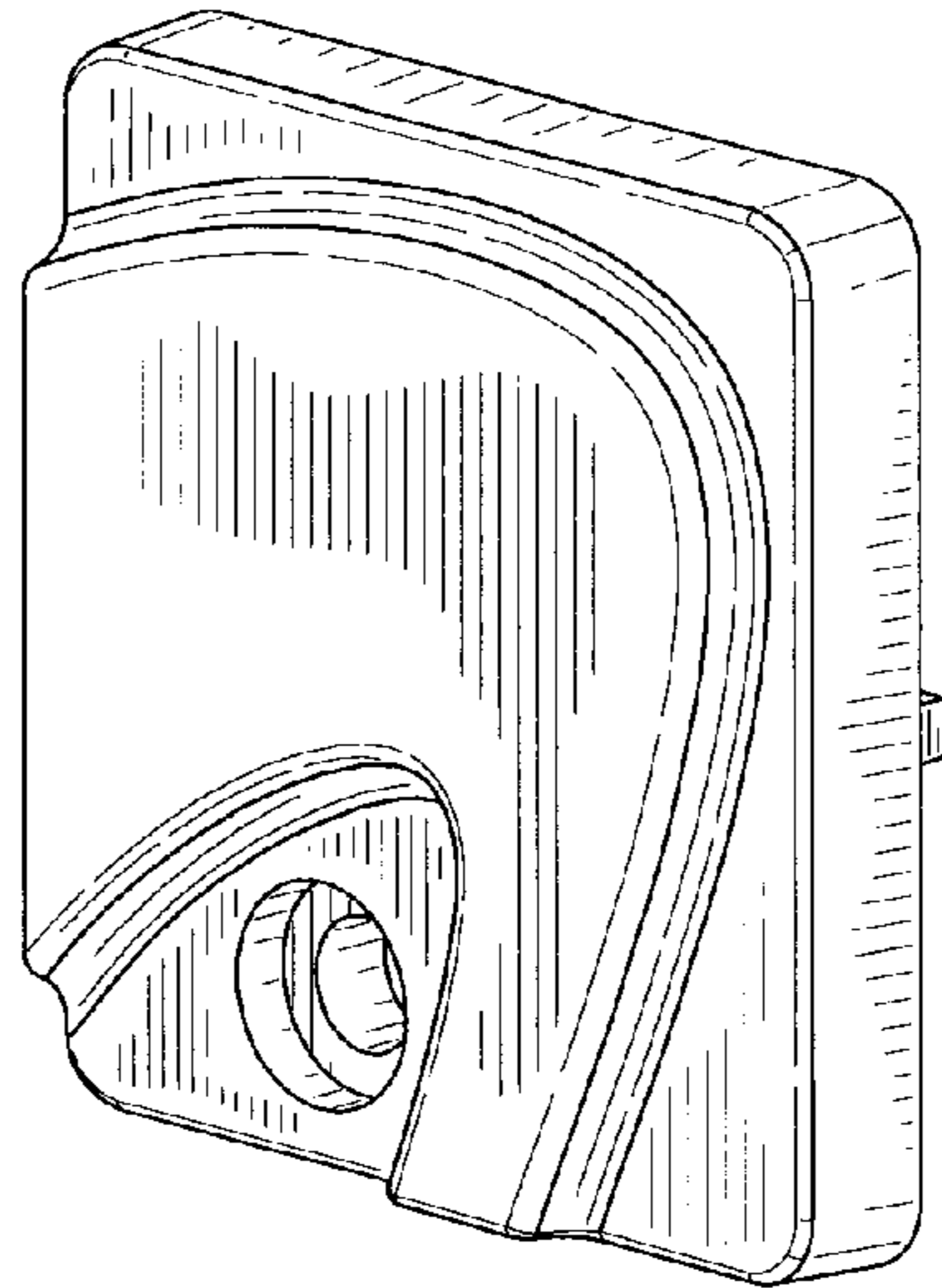

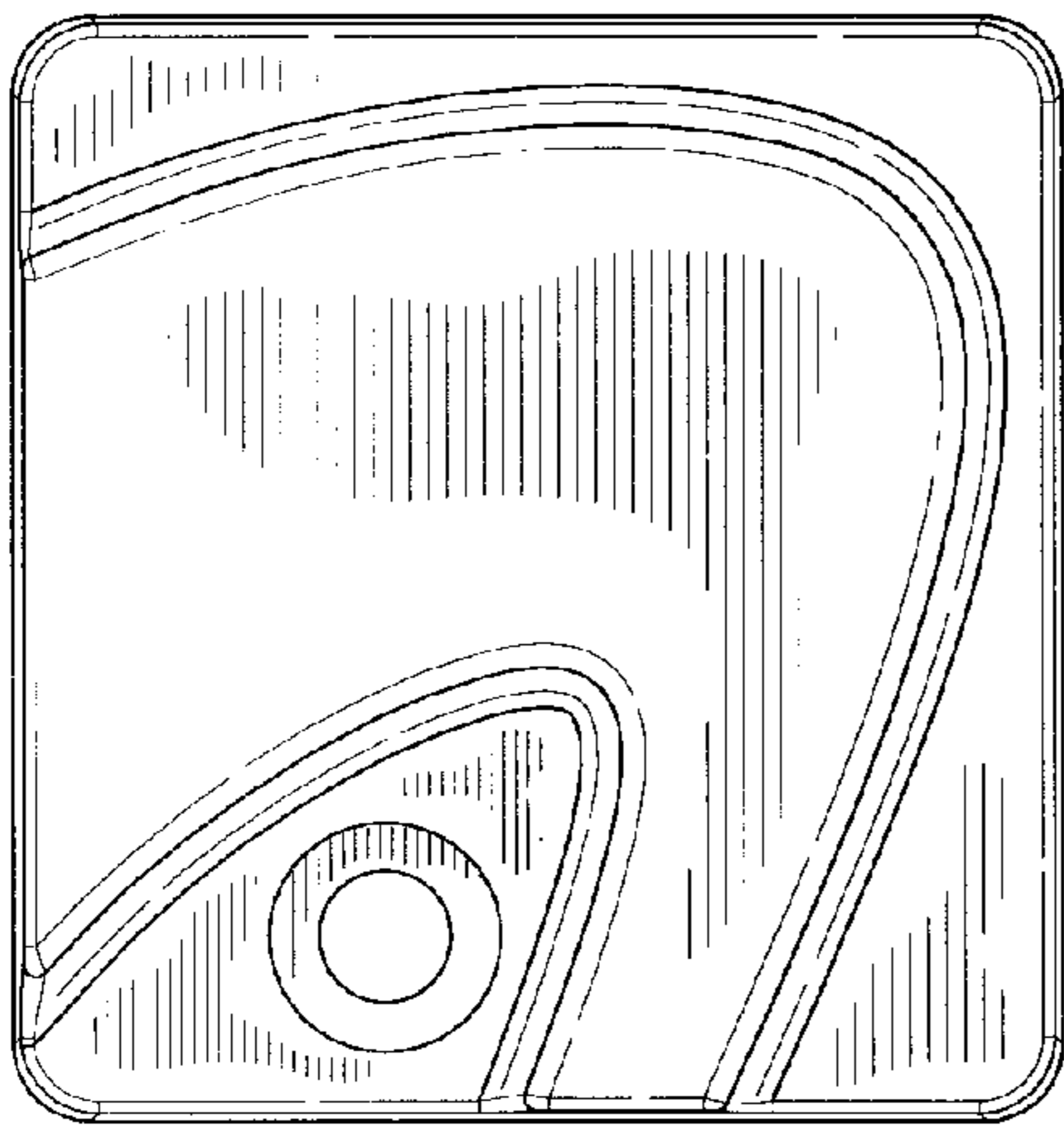

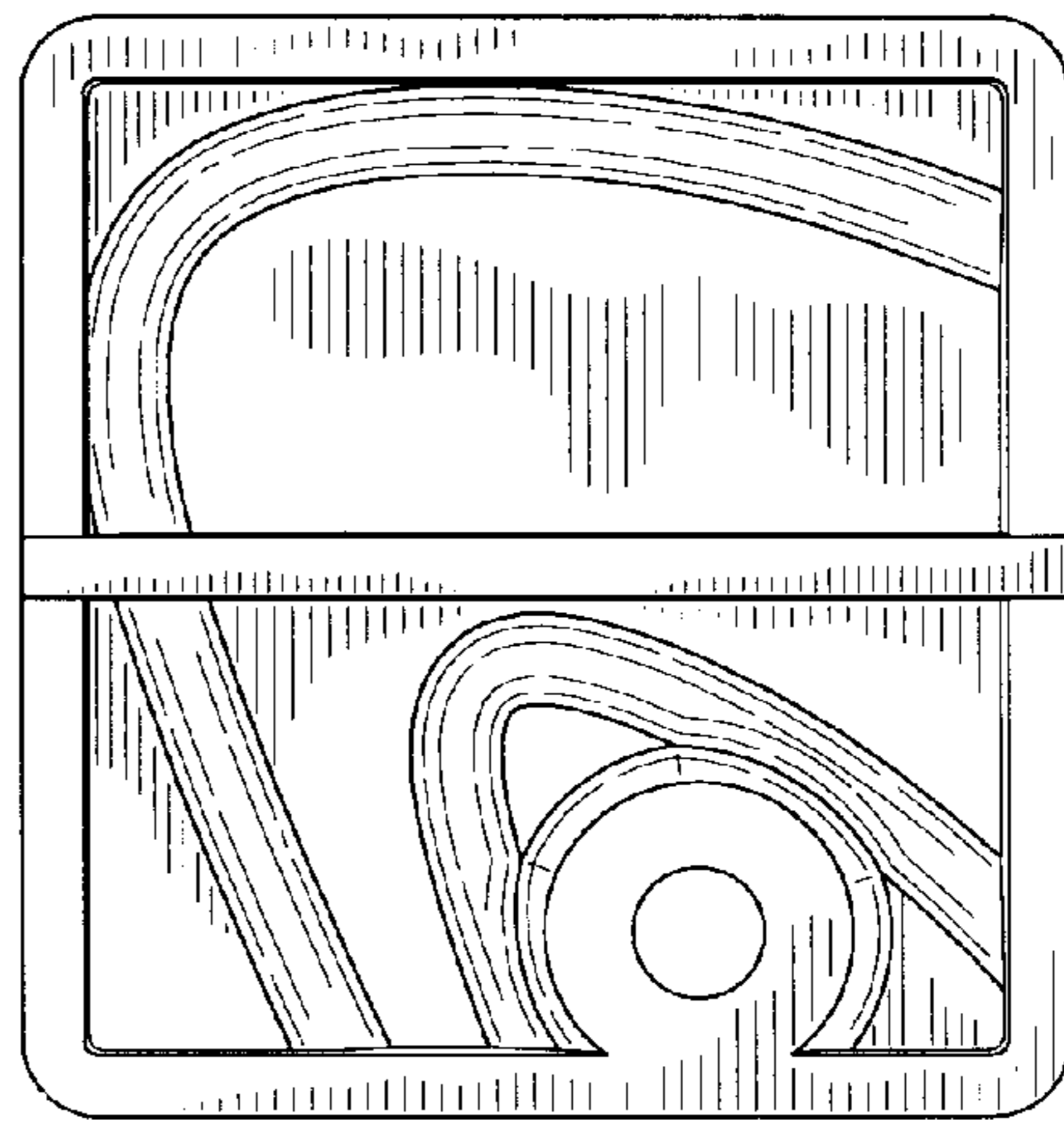

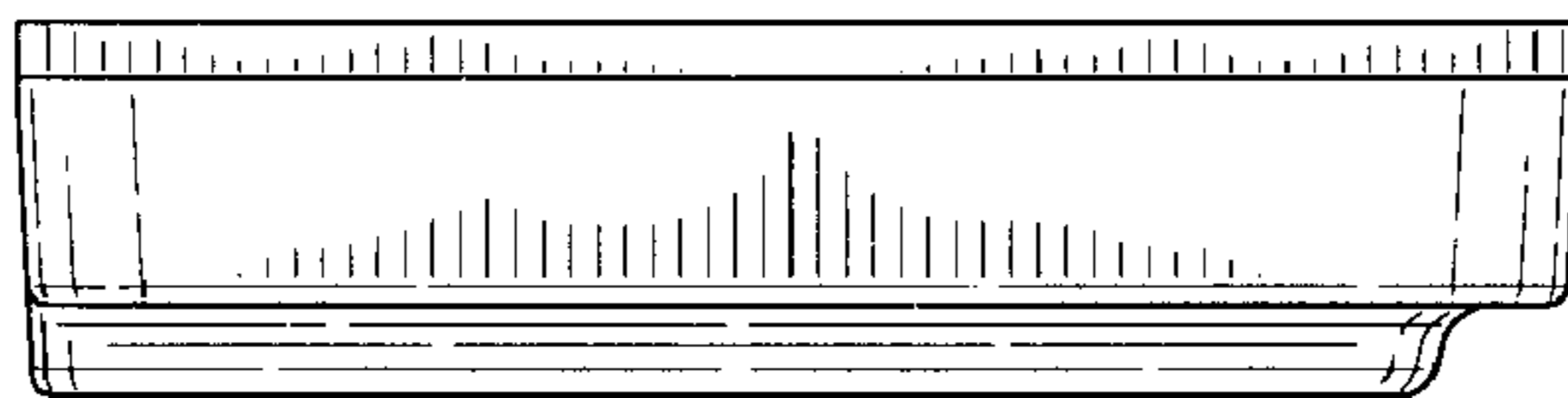

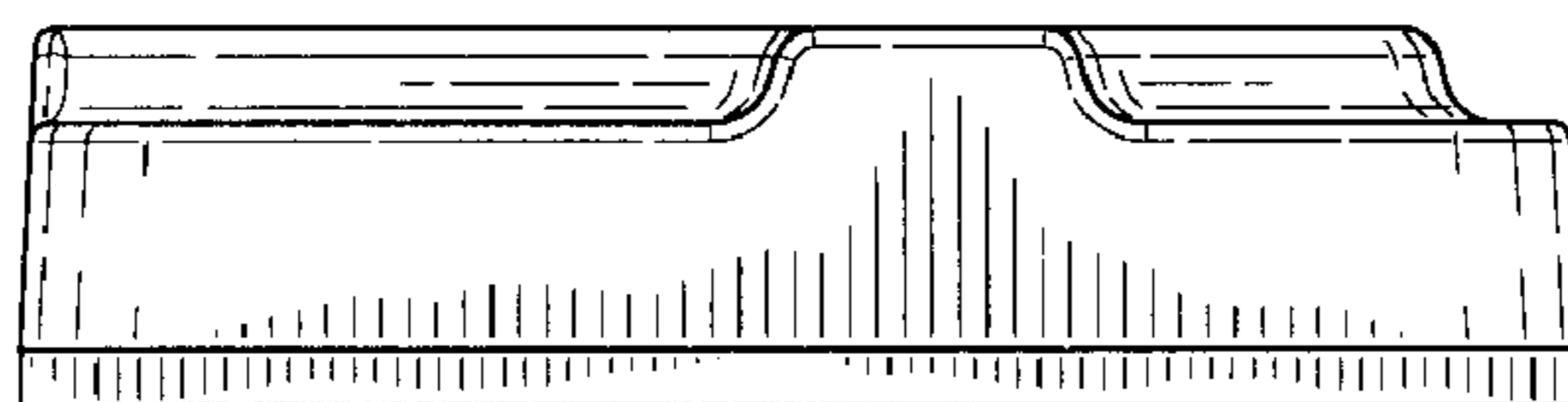

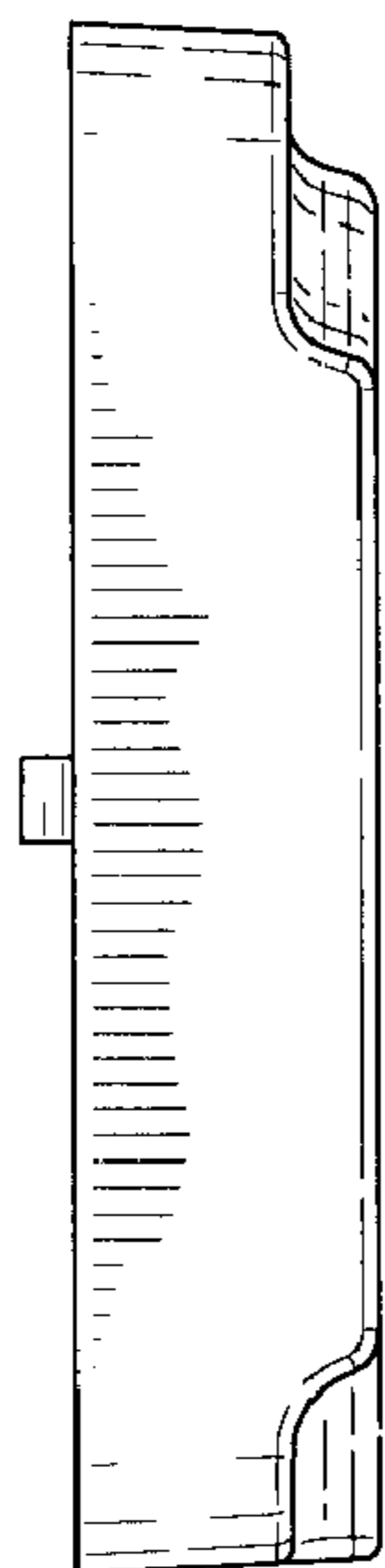

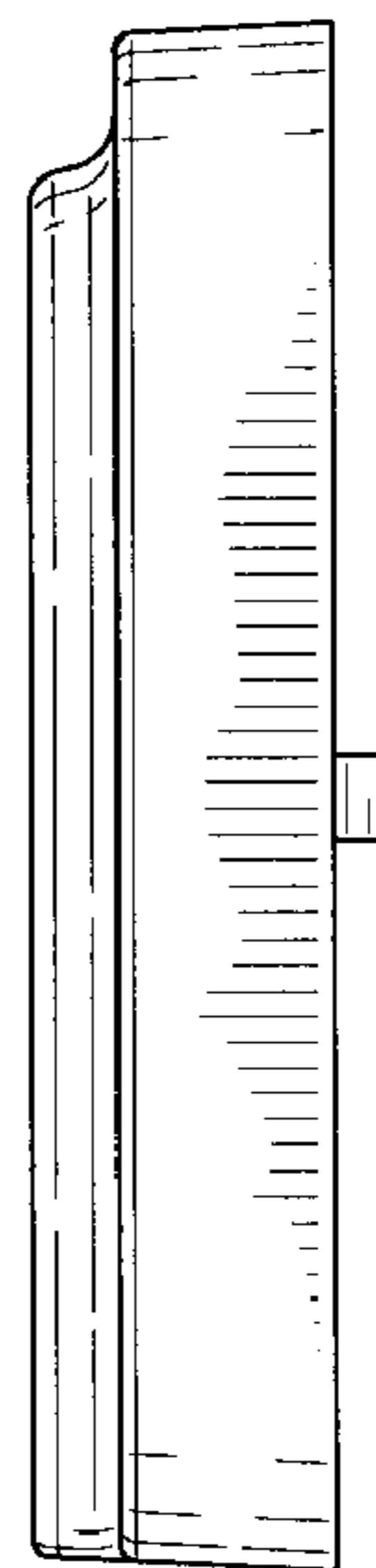
