(57) **CLAIM**

The ornamental design for a sink, as shown and described.

DESCRIPTION

In a preferred embodiment, the nature of this product is as a plumbing fixture primarily useful for washing various objects.

FIG. 1 is a right, top, front perspective view of a sink according to my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevational view thereof, the rear elevational view thereof being a mirror image of the front view shown; FIG. 4 is a right side elevational view thereof, the left side elevational view thereof being a mirror image of the right side shown;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a right, top, front perspective view of a sink according to another embodiment of my new design;

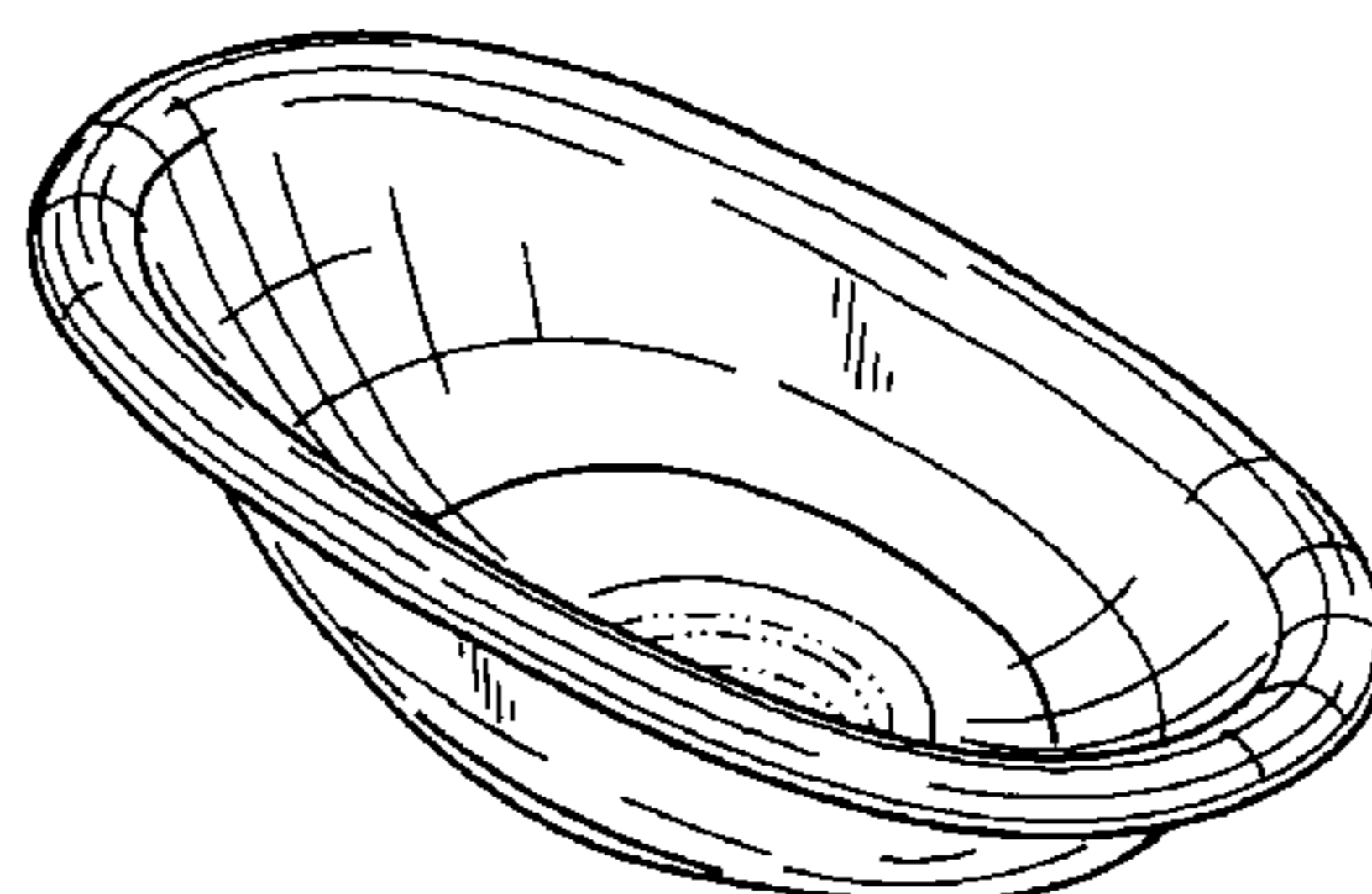
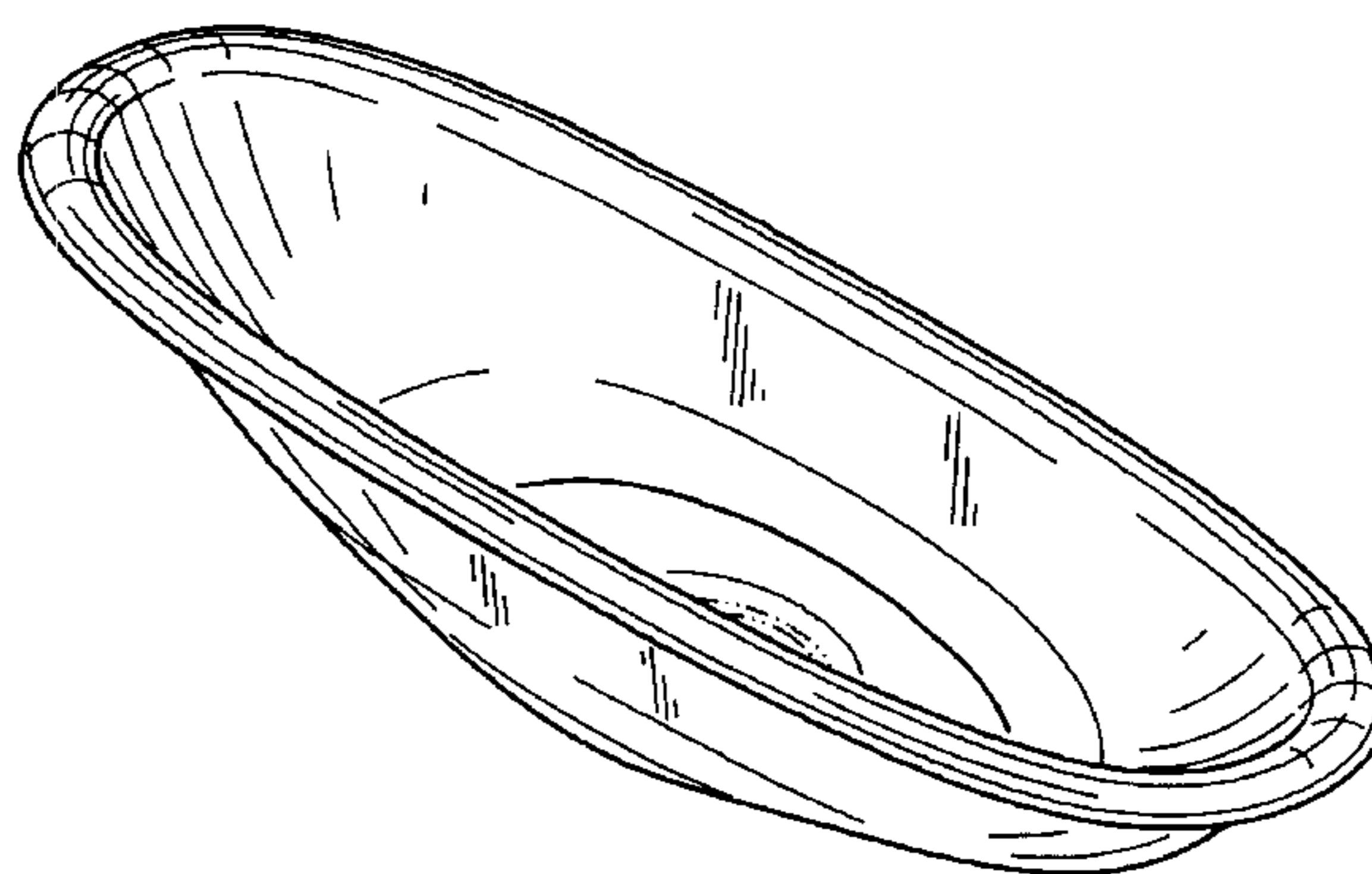
FIG. 7 is a top plan view thereof;

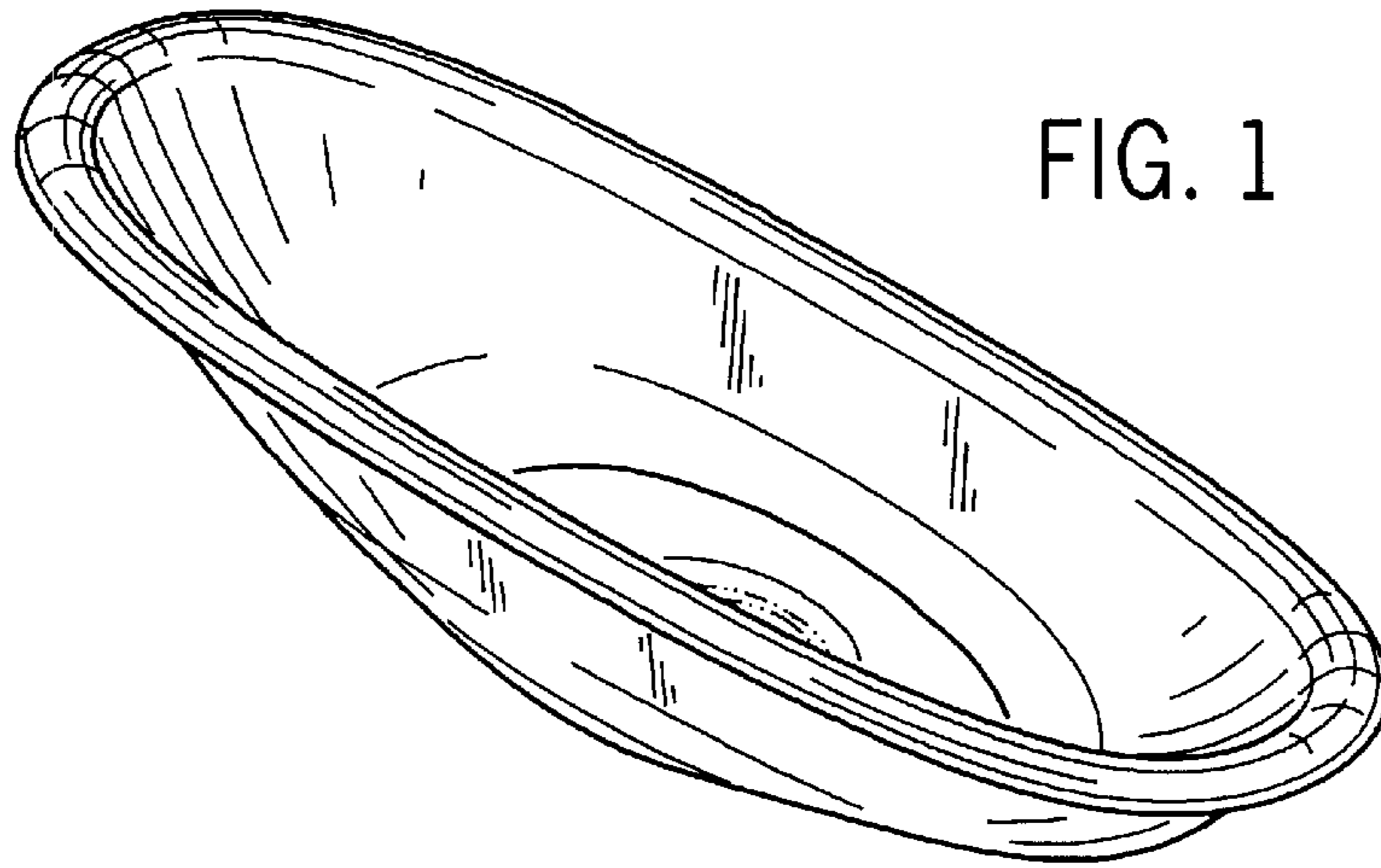

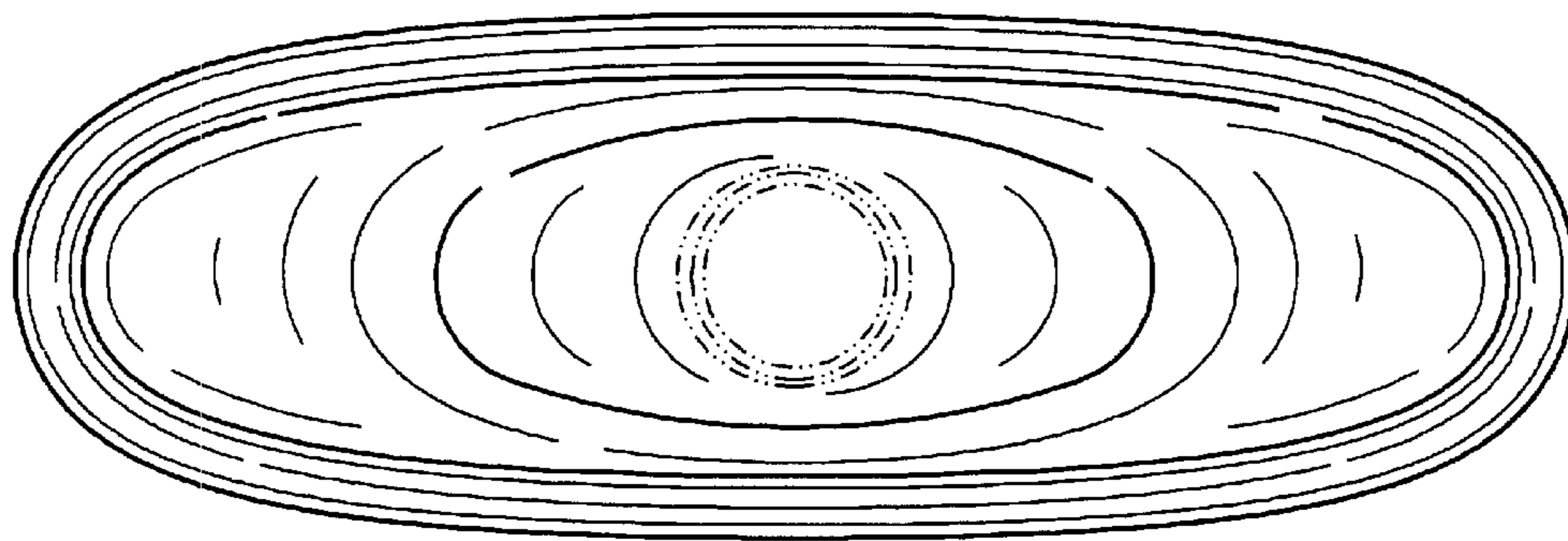

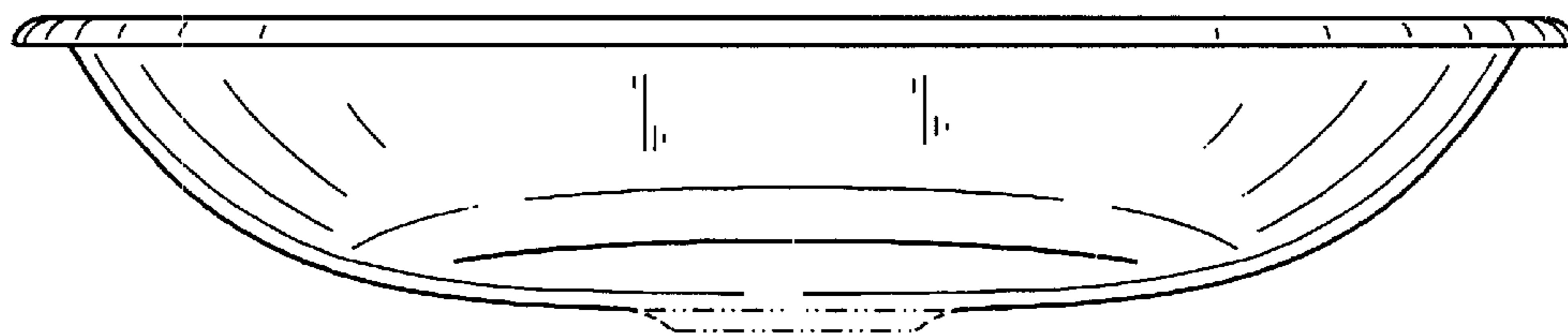

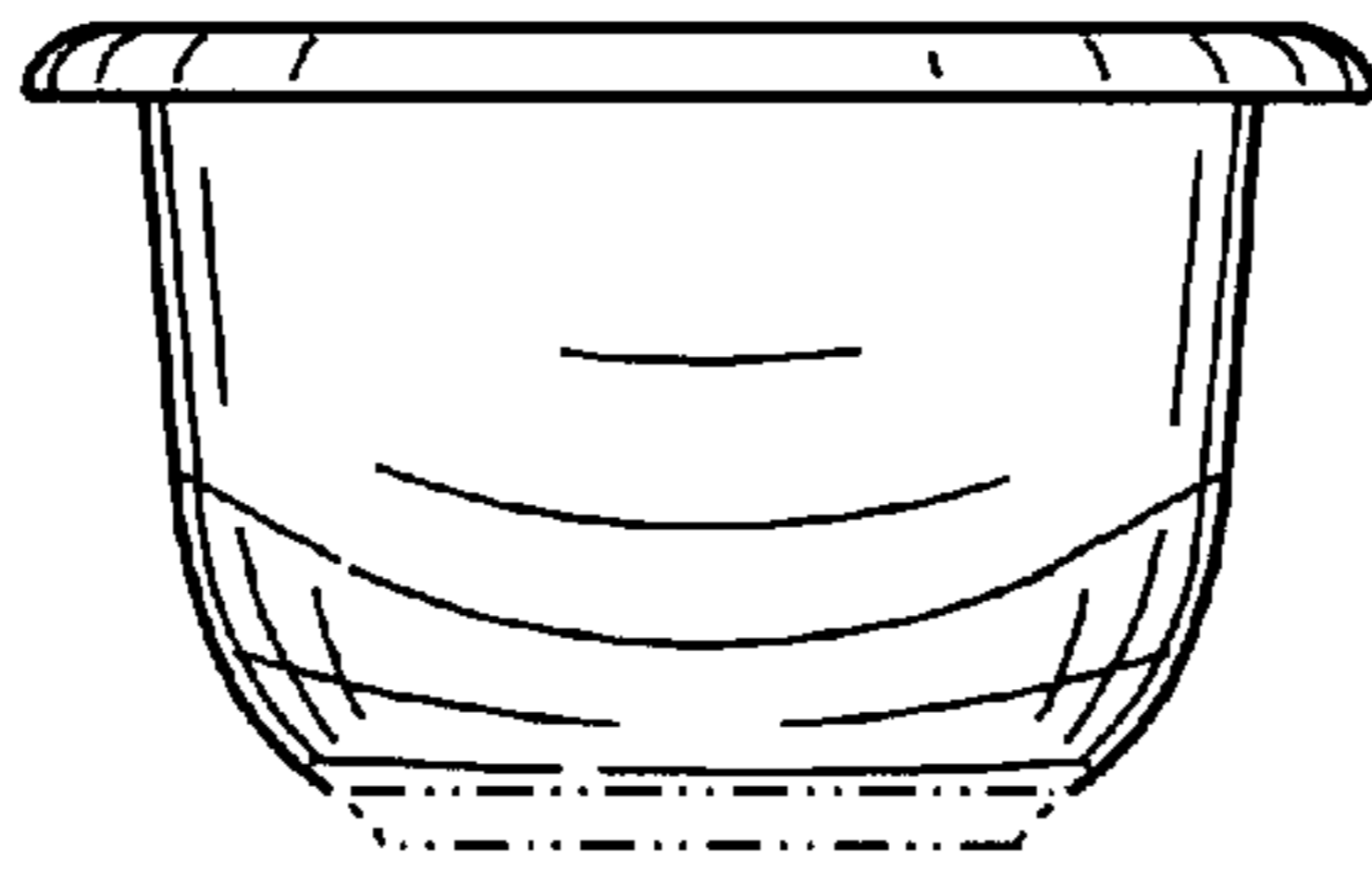

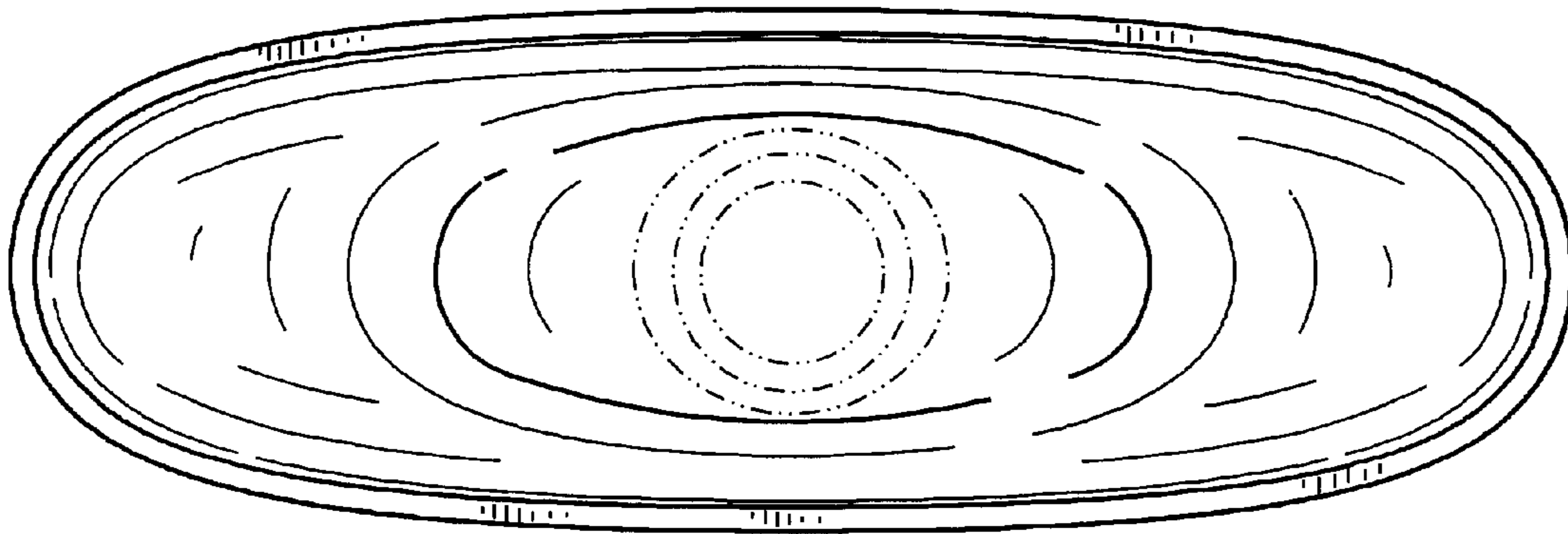

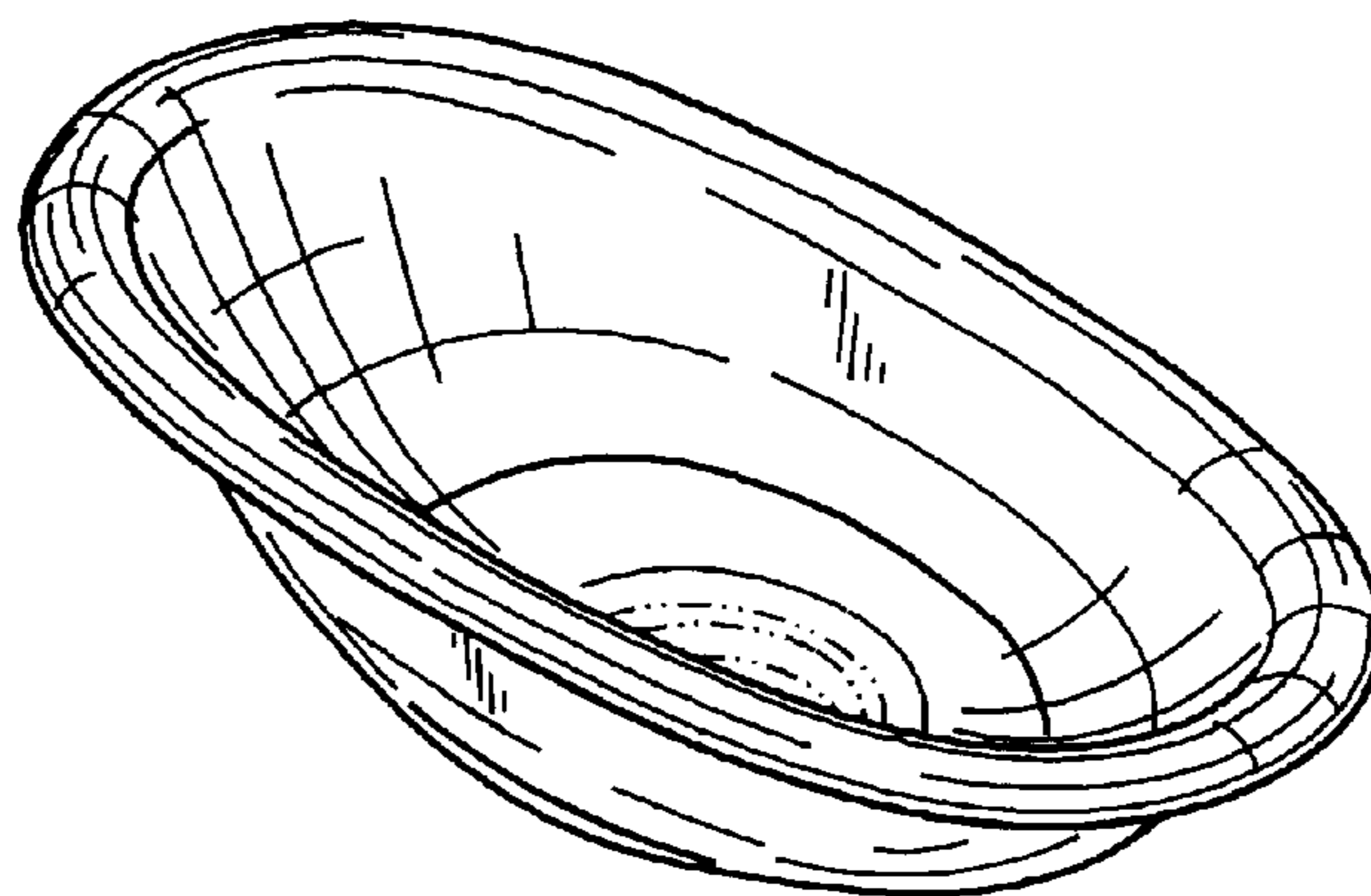

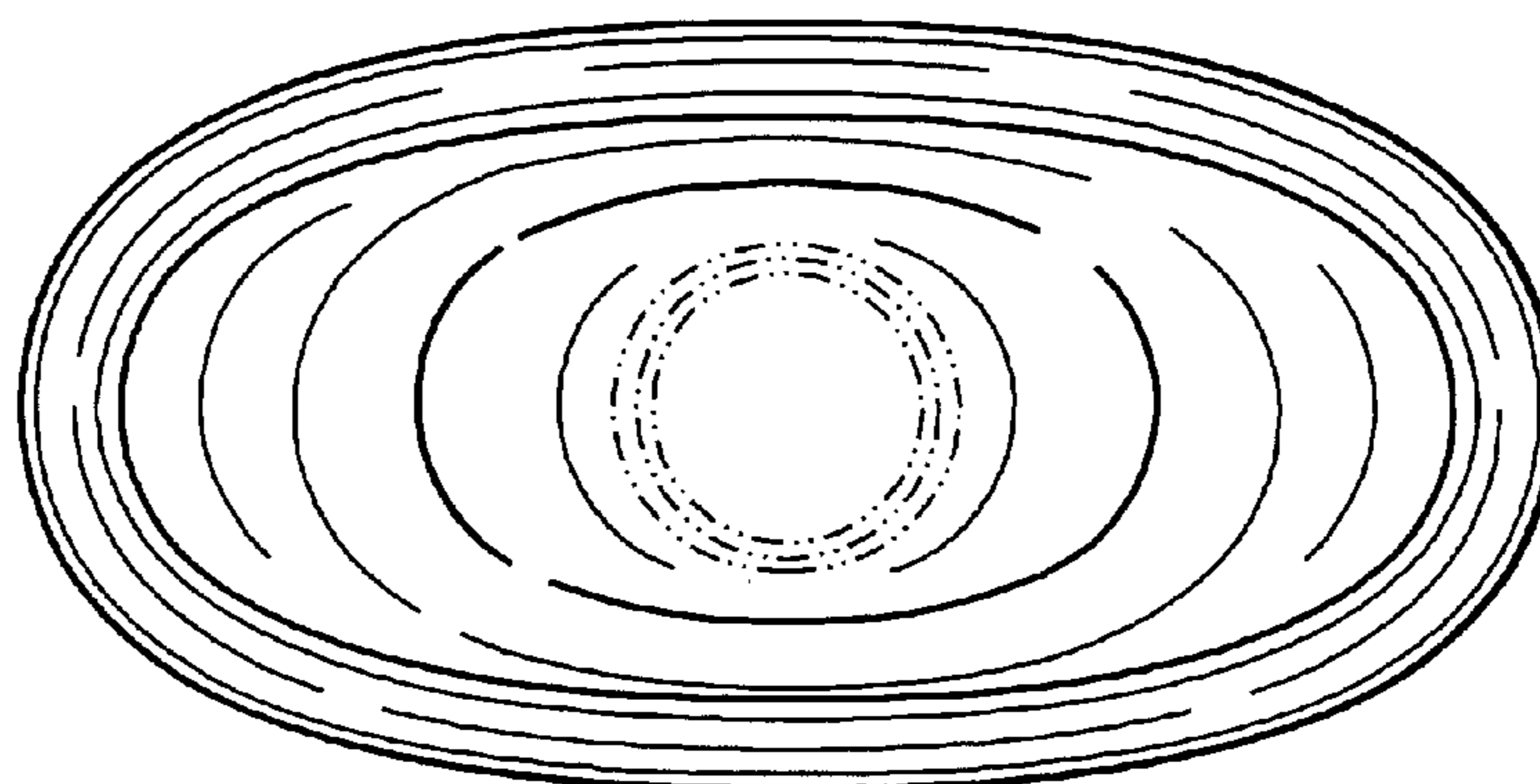

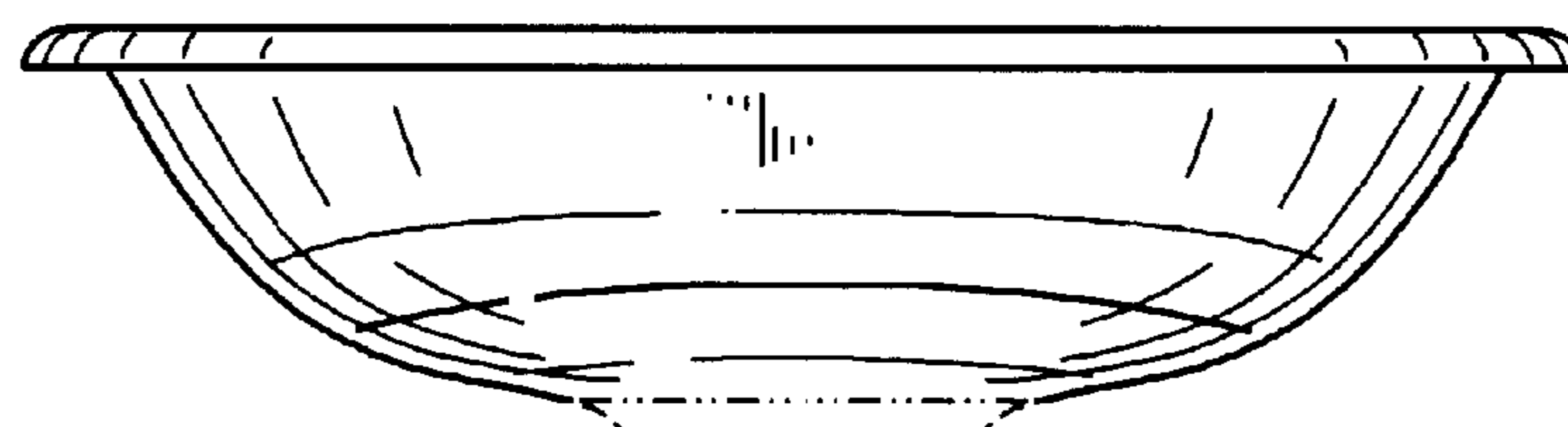

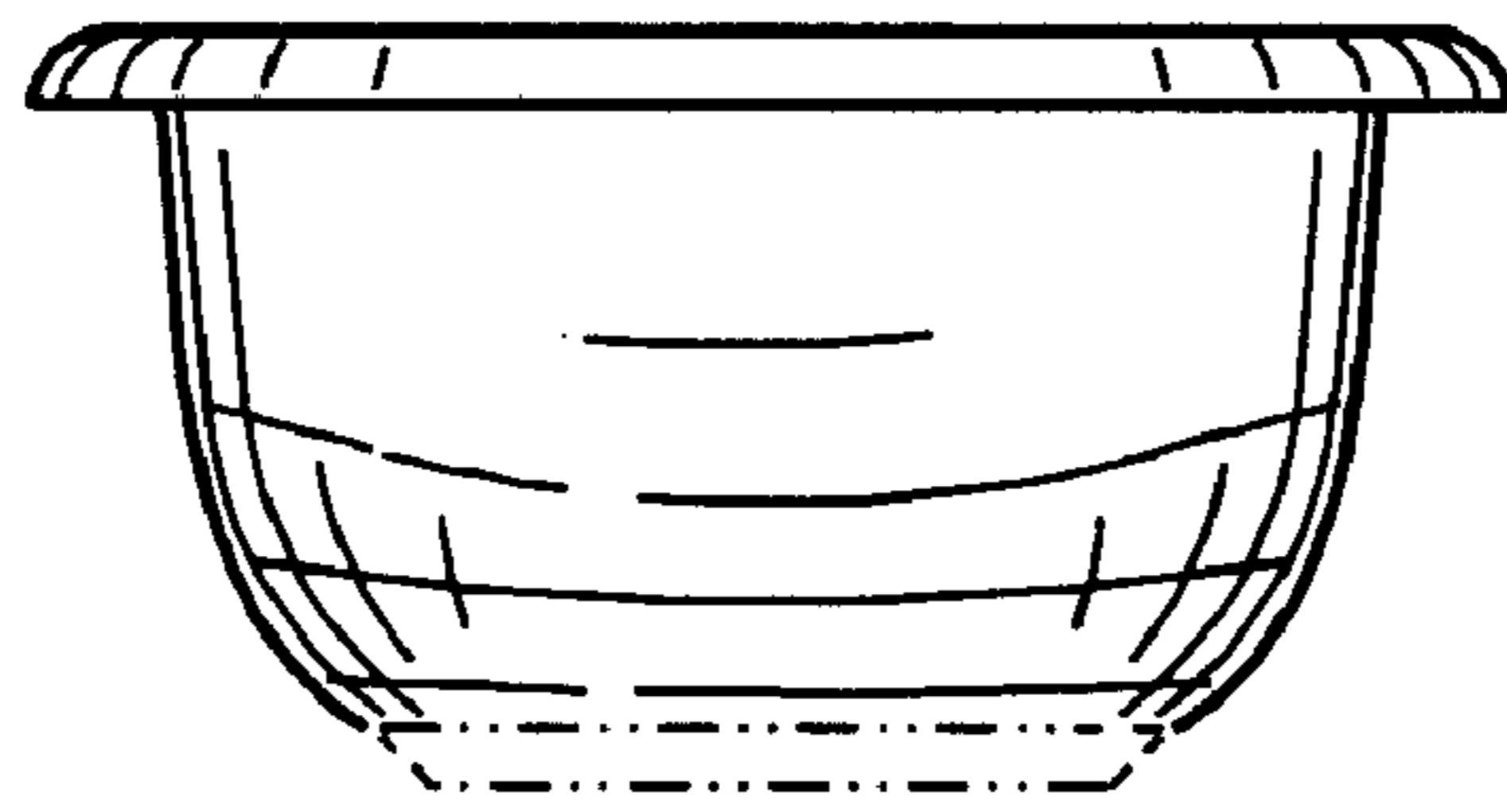
