(57) **CLAIM**

The ornamental design for an ILM full view forceps, as shown and described.

**DESCRIPTION**

FIG. 1 is a left perspective view of an ILM full view forceps showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a left side view thereof, the right side view being the same thereto;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is an enlarged fragmentary left perspective view of the tip portion thereof;

FIG. 6 is an enlarged fragmentary top plan view of the tip portion thereof;

FIG. 7 is an enlarged fragmentary left side view of the tip portion thereof, the right side view being the same thereto;

FIG. 8 is an enlarged fragmentary bottom plan view of the tip portion thereof;

FIG. 9 is an enlarged front side view of the ILM full view forceps;

FIG. 10 is an enlarged rear side view thereof.

FIG. 11 is left perspective view of an ILM full view forceps in an open position showing my new design;

FIG. 12 is a top plan view thereof;

FIG. 13 is a left side view thereof, the right side view being the same thereto;

FIG. 14 is a bottom plan view thereof;

FIG. 15 is an enlarged fragmentary left perspective view of the tip portion thereof;

FIG. 16 is an enlarged fragmentary top plan view of the tip portion thereof;

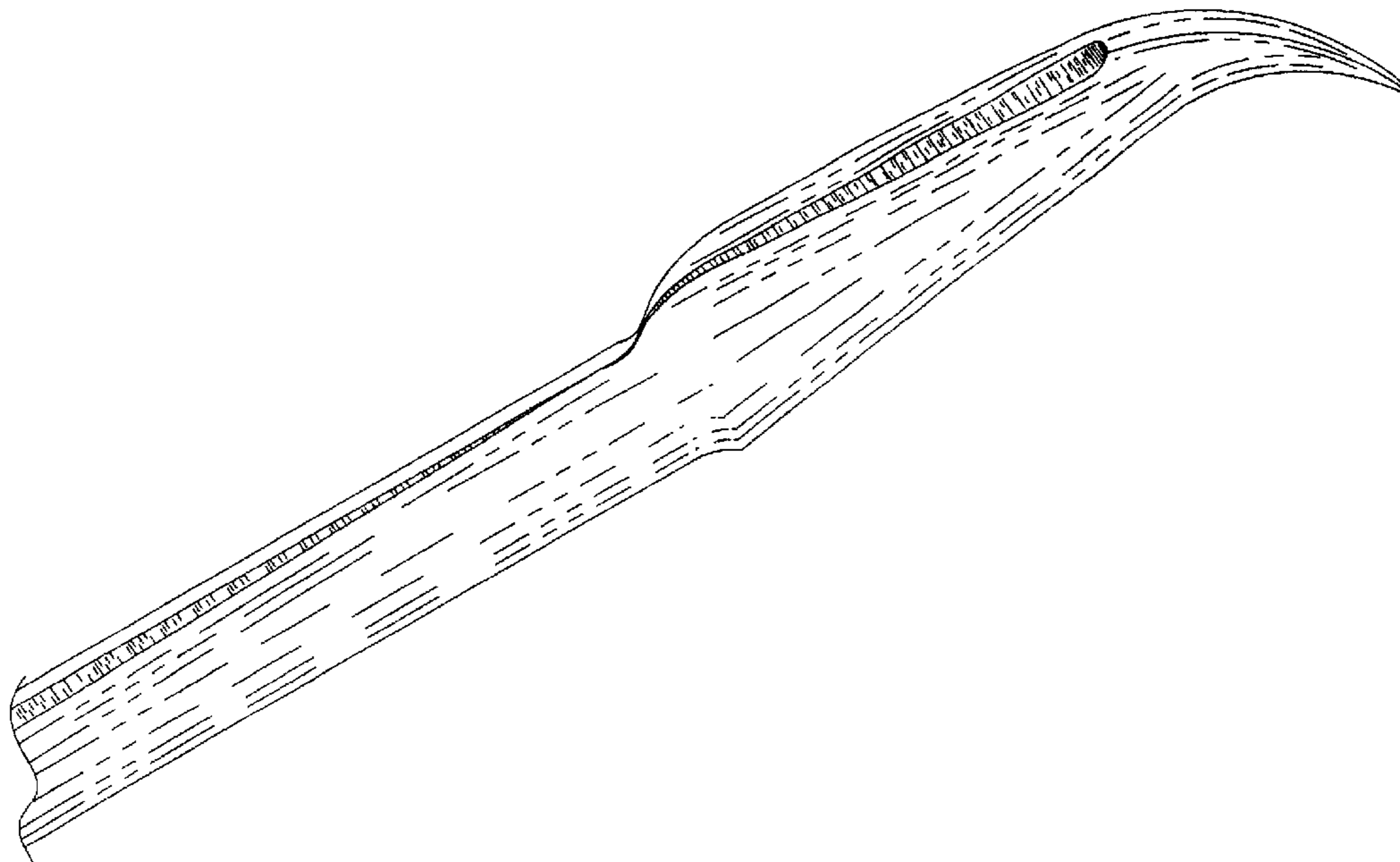
FIG. 17 is an enlarged fragmentary left side view of the tip portion thereof, the right side view being the same thereto;

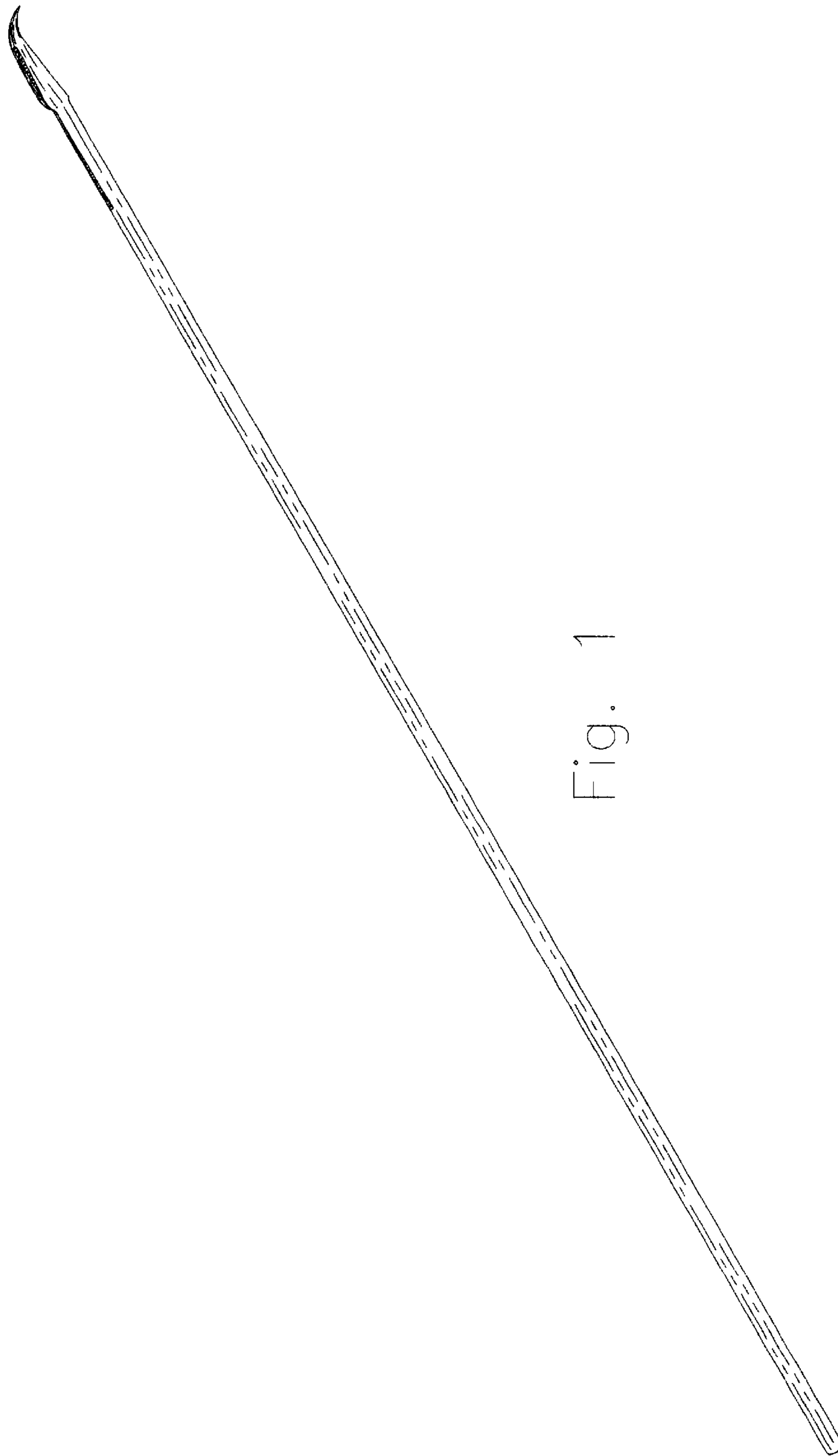

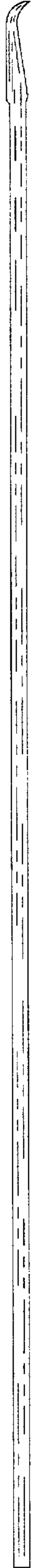

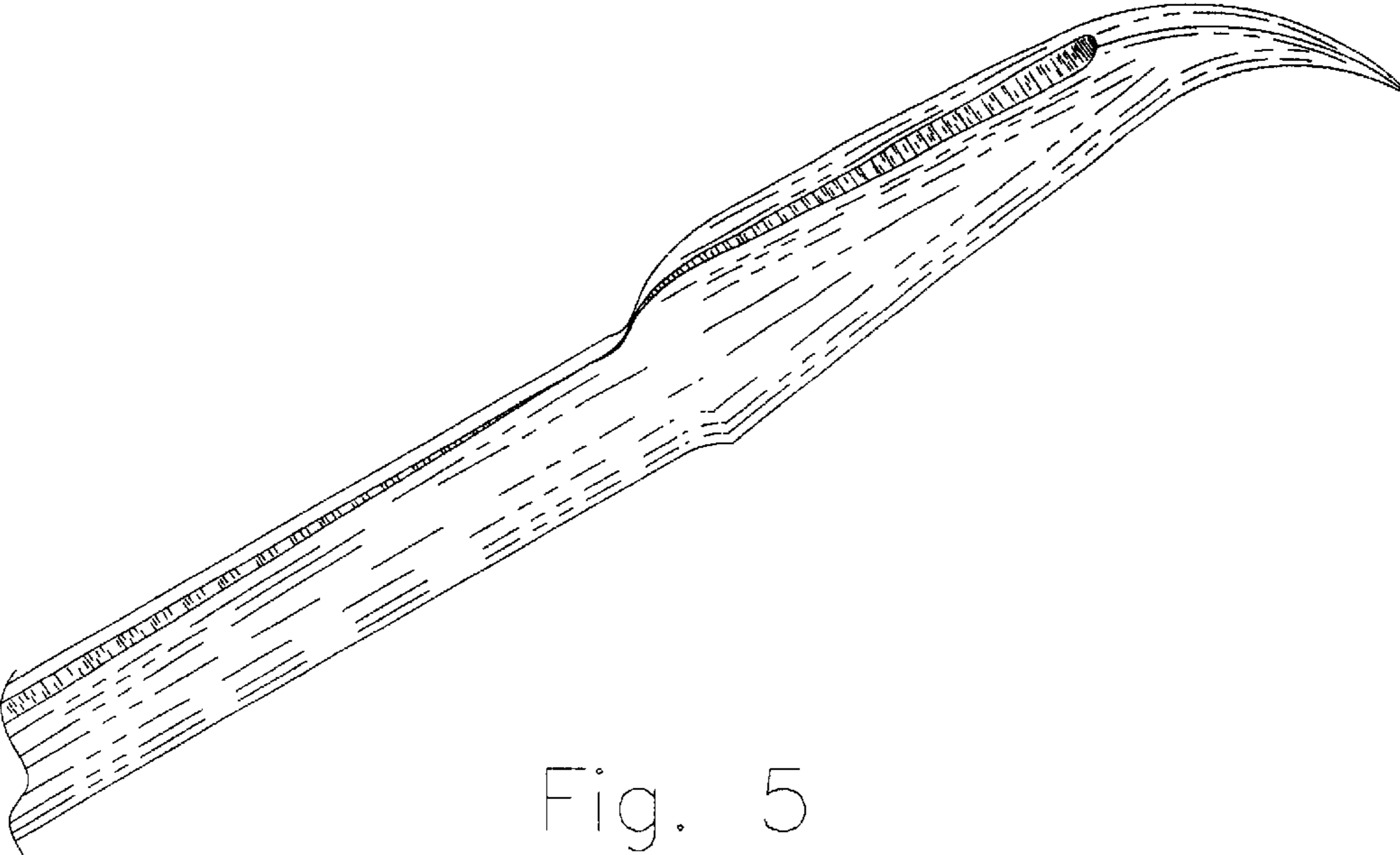

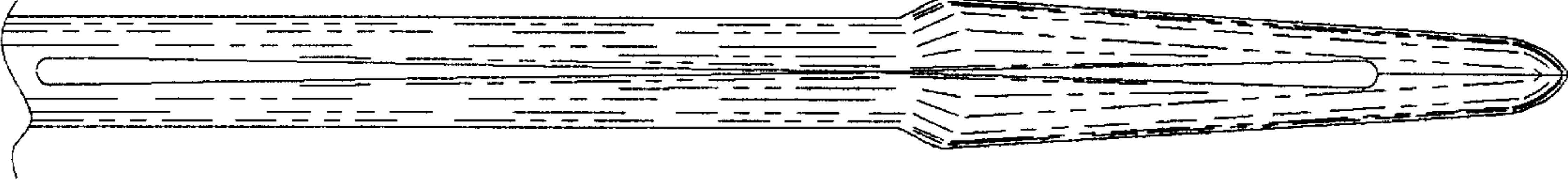

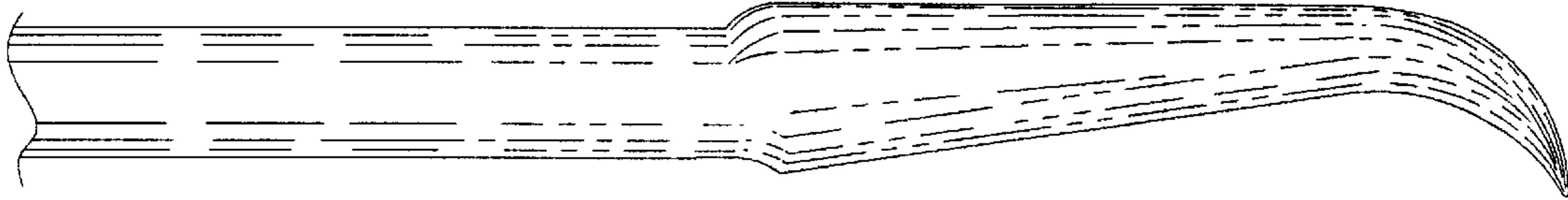

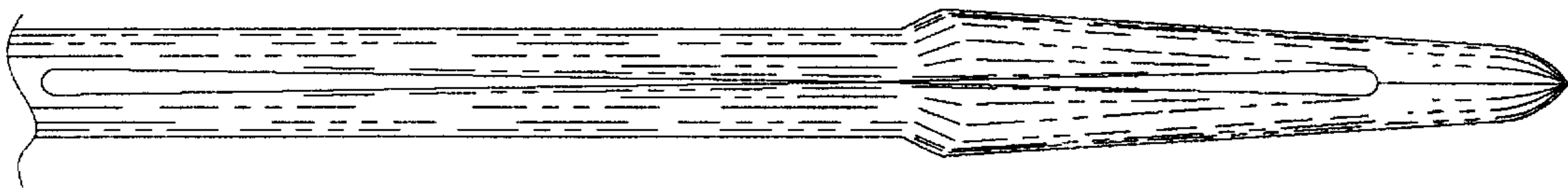

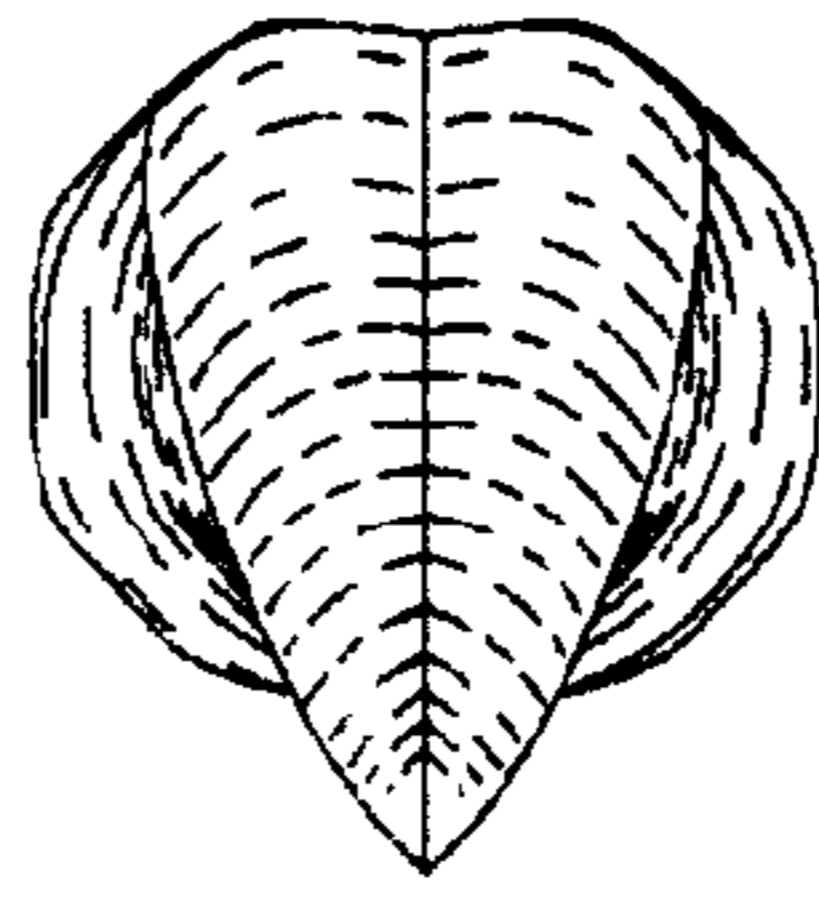

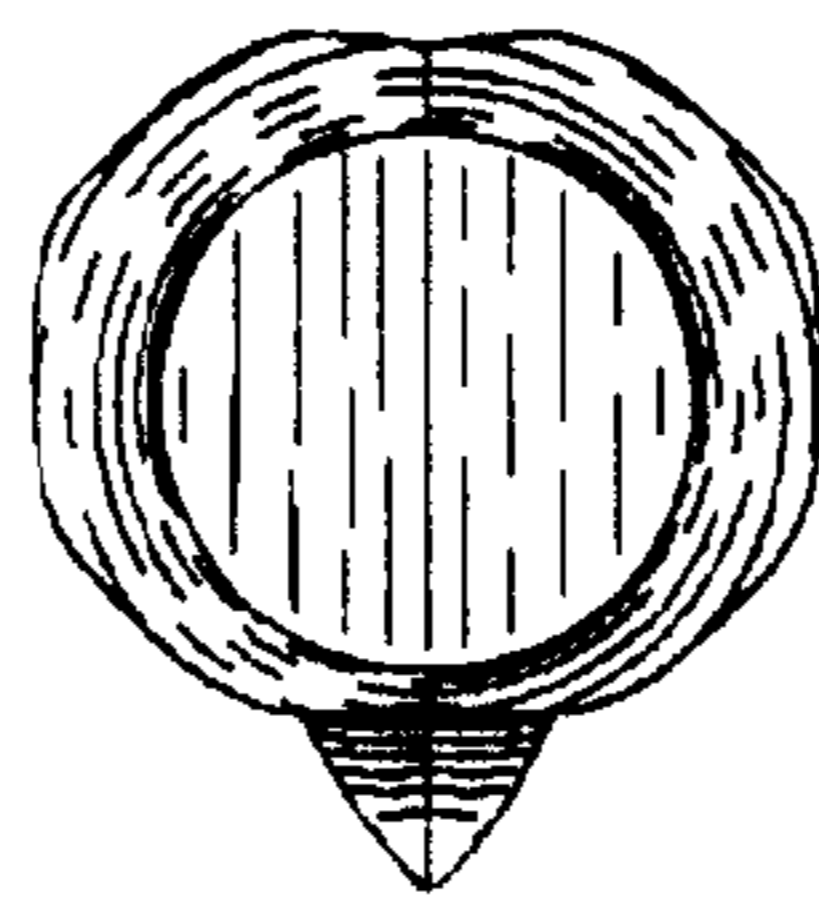

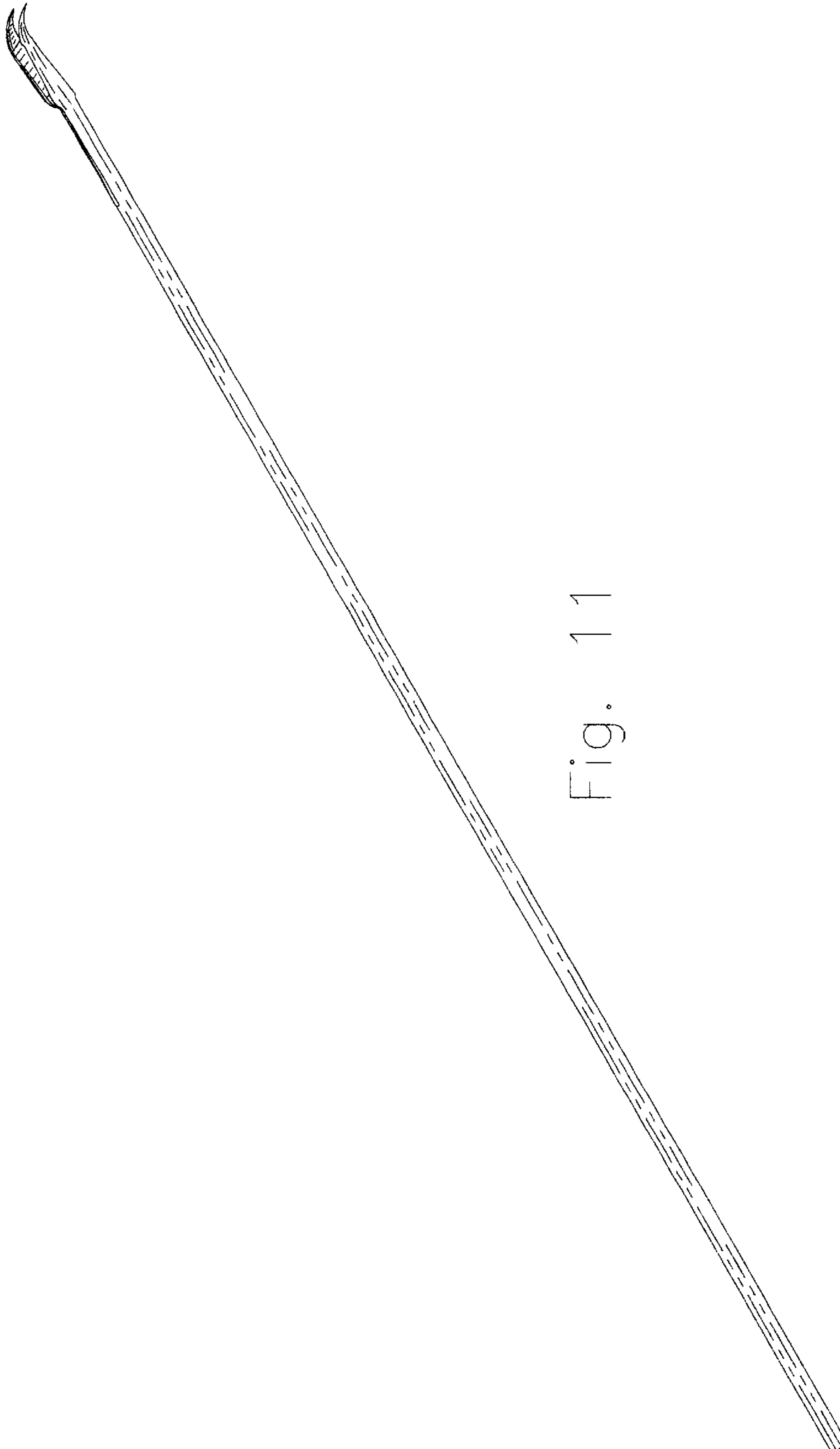

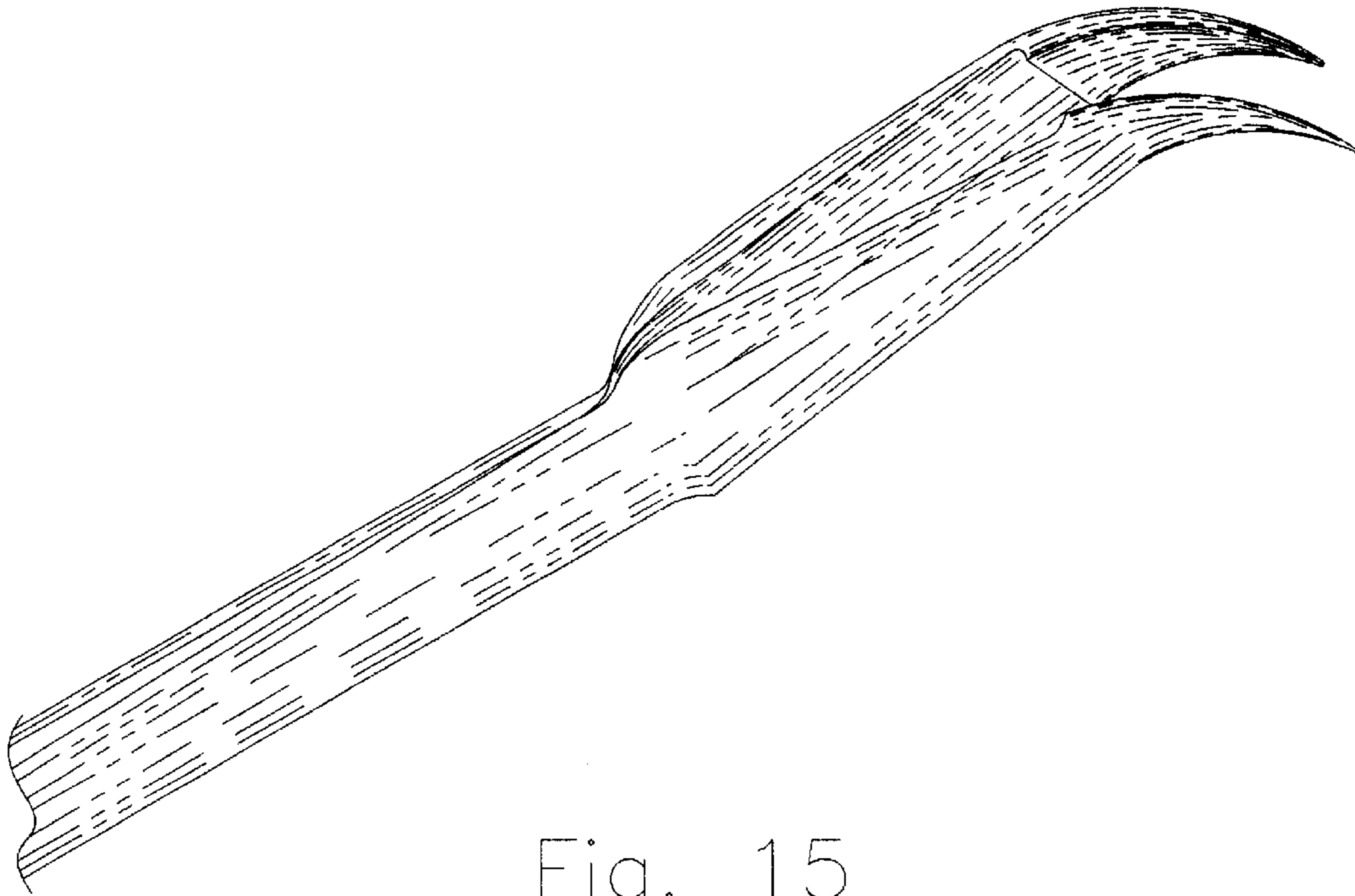

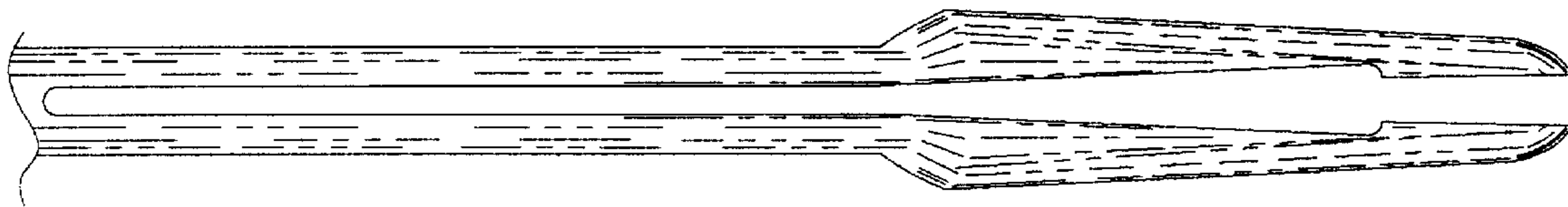

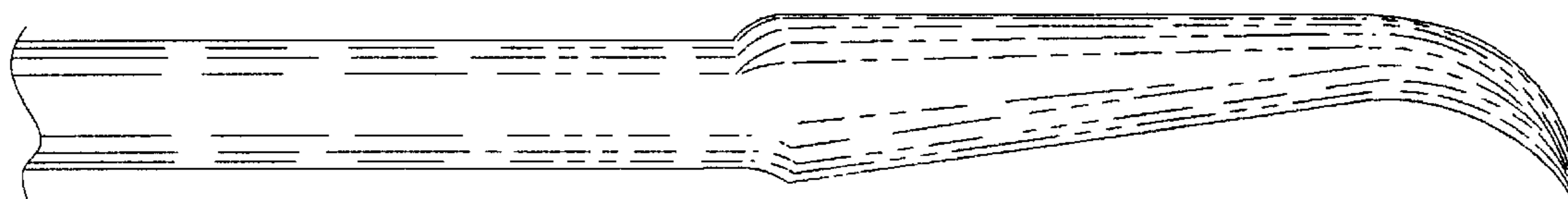

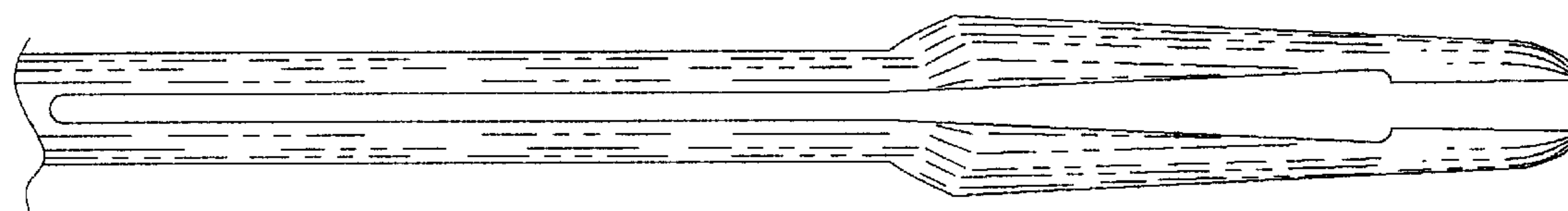

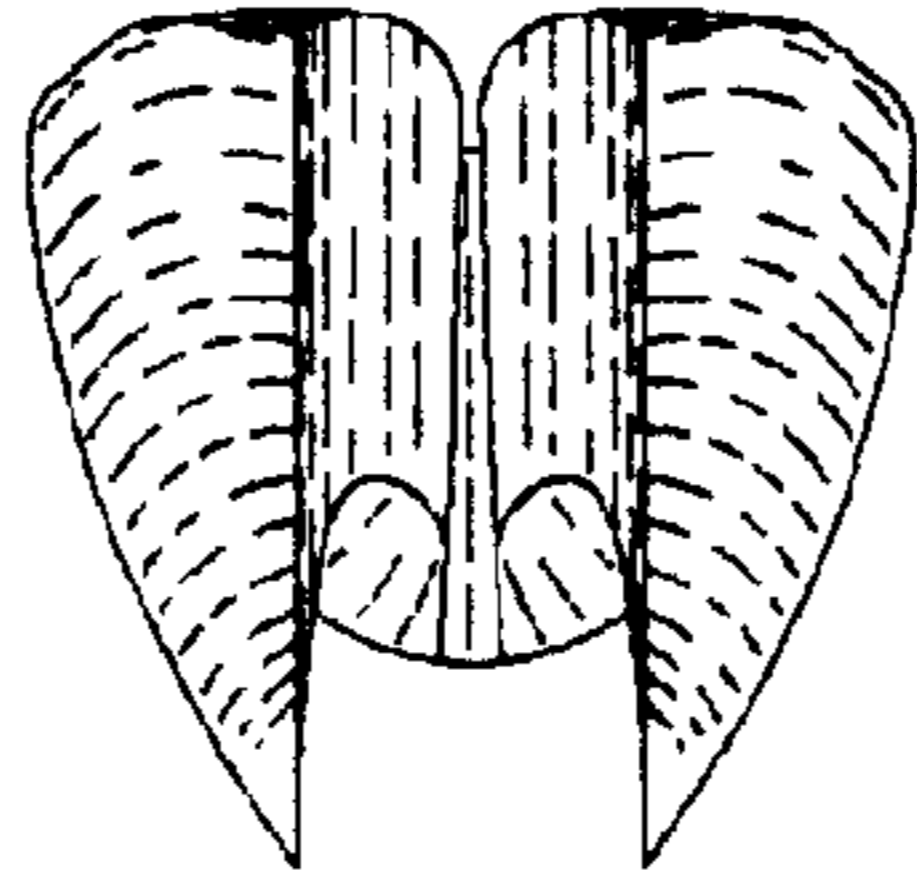

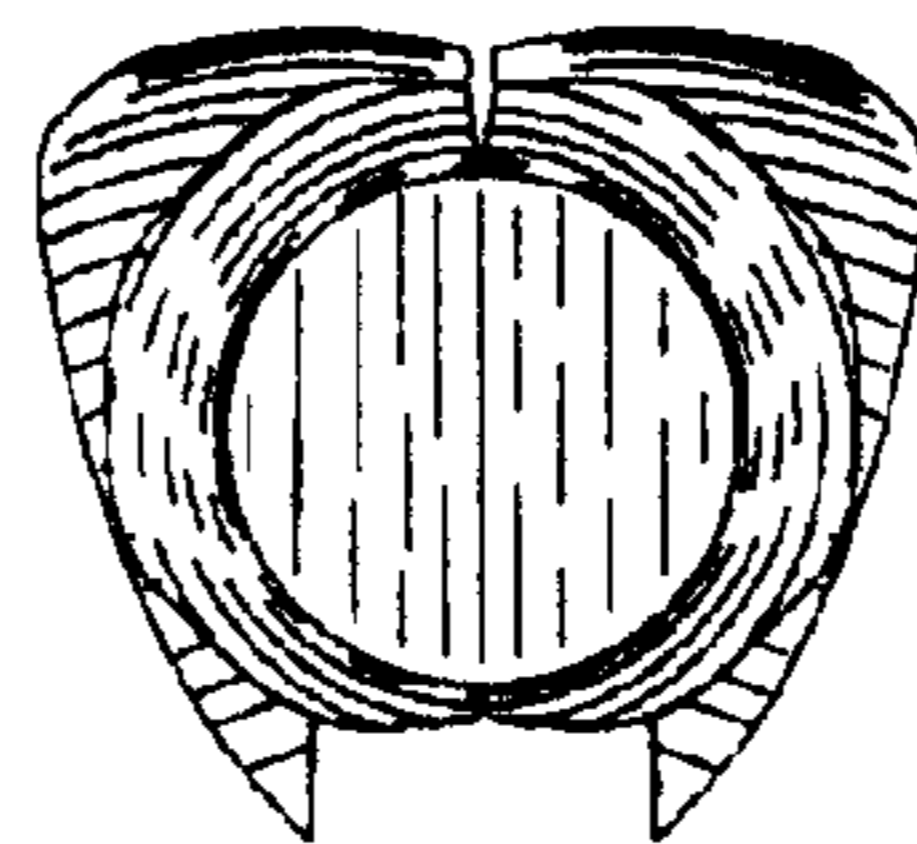
