(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my new design;

FIG. 2 is a left side view of the shoe shown in FIG. 1;

FIG. 3 is a right side view of the shoe shown in FIG. 1;

FIG. 4 is a front view of the shoe shown in FIG. 1;

FIG. 5 is a top view of the shoe shown in FIG. 1;

FIG. 6 is a front perspective view of an alternate embodiment of the shoe shown in FIG. 1;

FIG. 7 is a left side view of the alternative embodiment of the shoe shown in FIG. 6;

FIG. 8 is a right side view of the alternative embodiment of the shoe shown in FIG. 6;

FIG. 9 is a front view of the alternative embodiment of the shoe shown in FIG. 6; and,

FIG. 10 is a top view of the alternative embodiment of the shoe shown in FIG. 6.

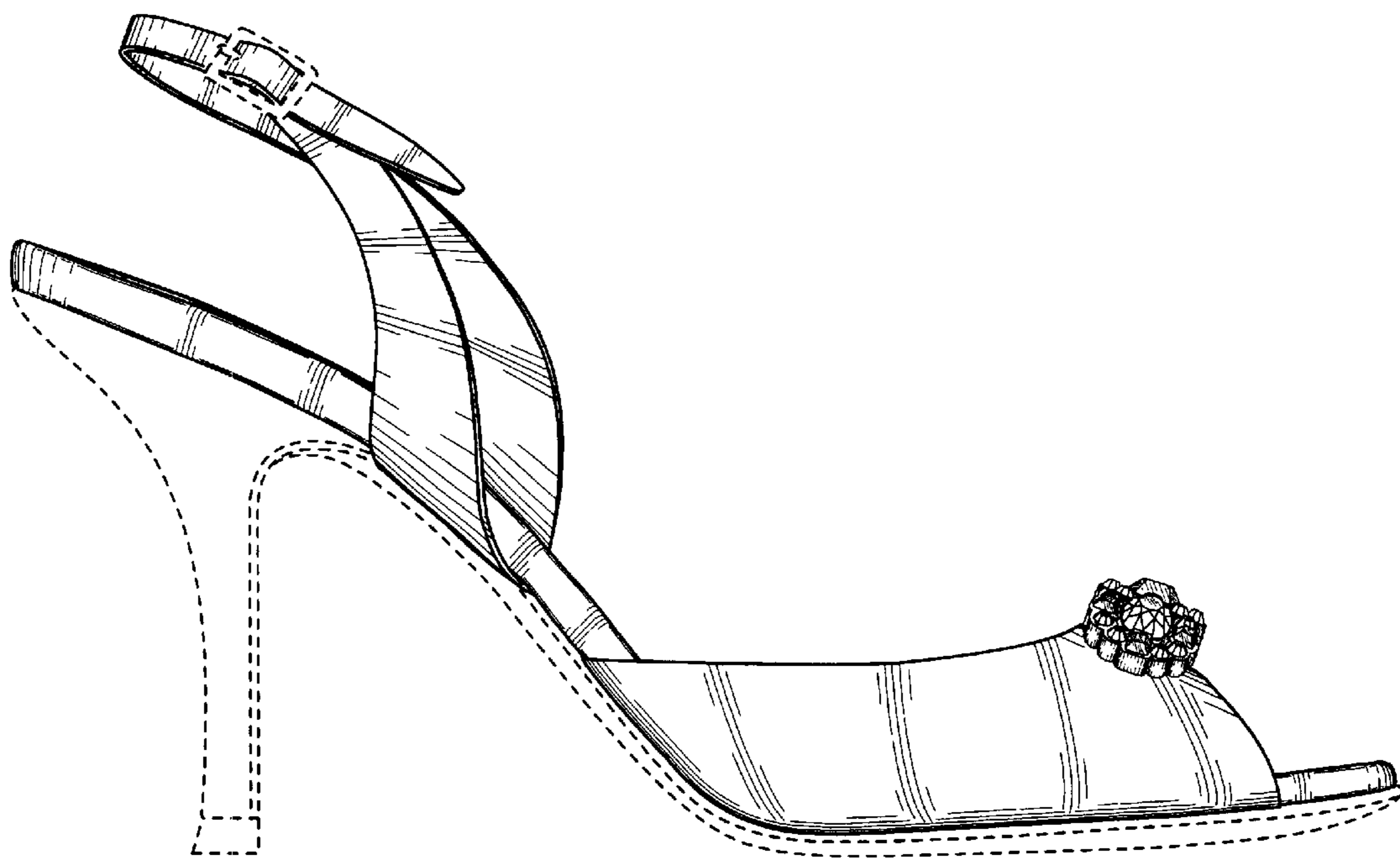

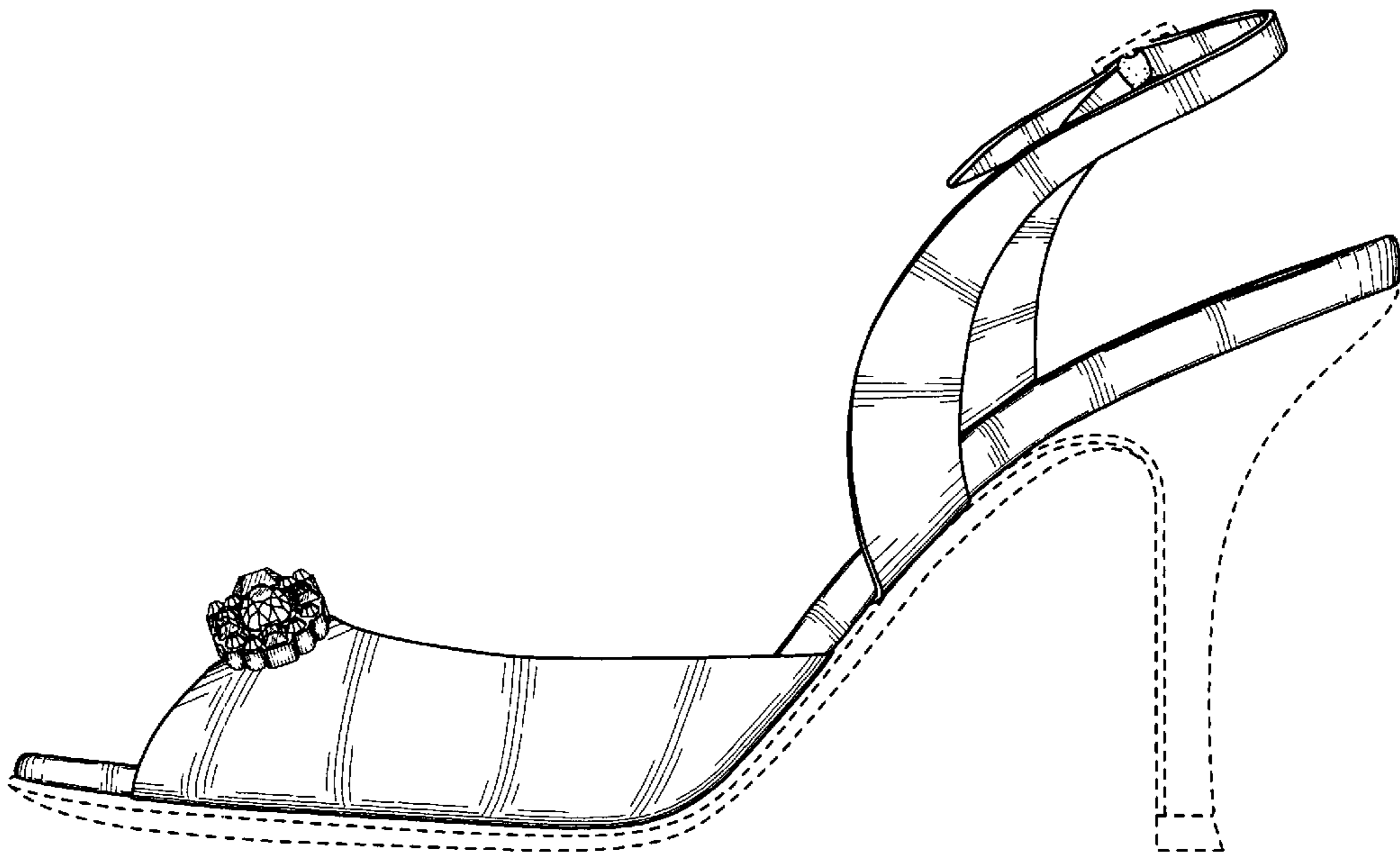

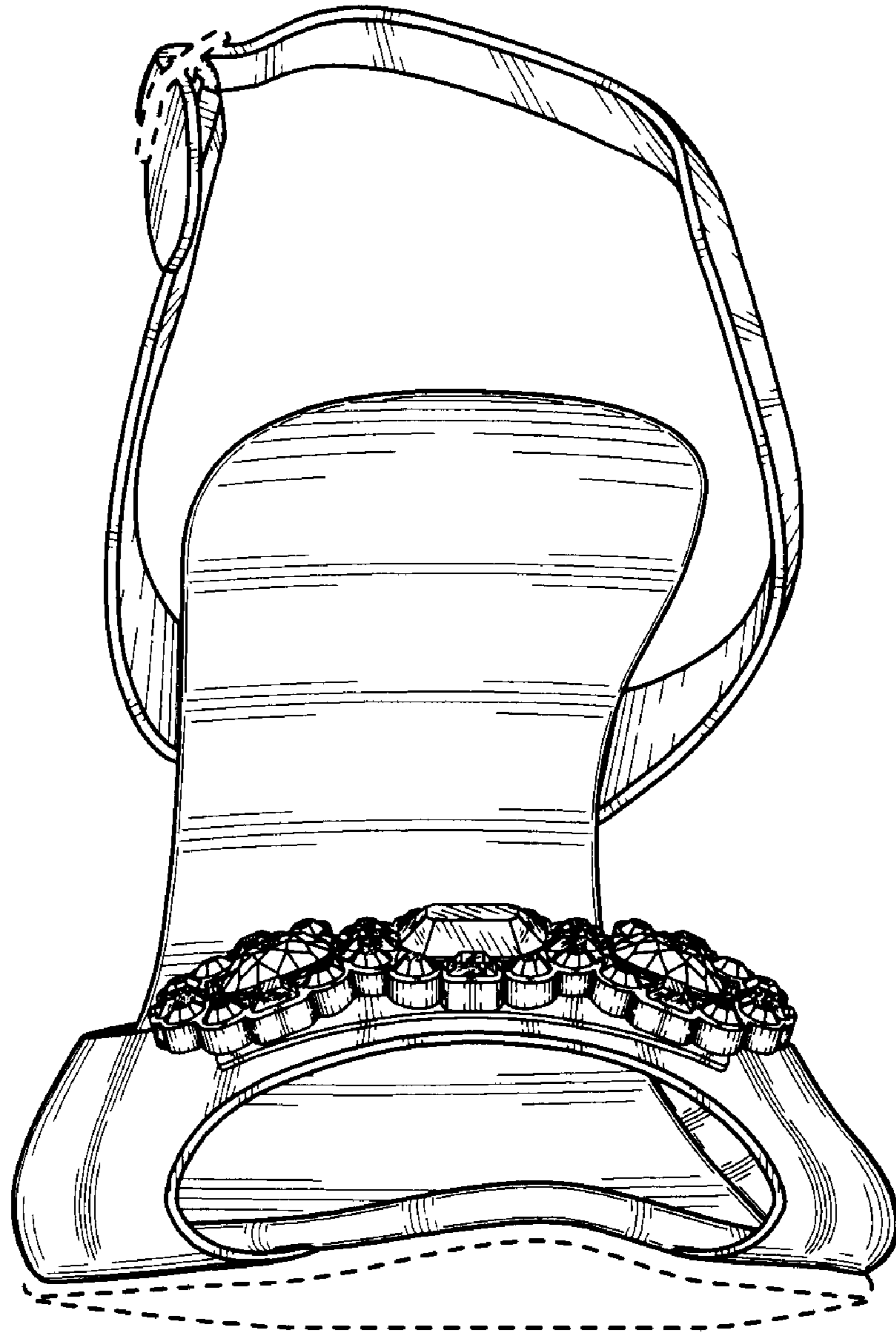

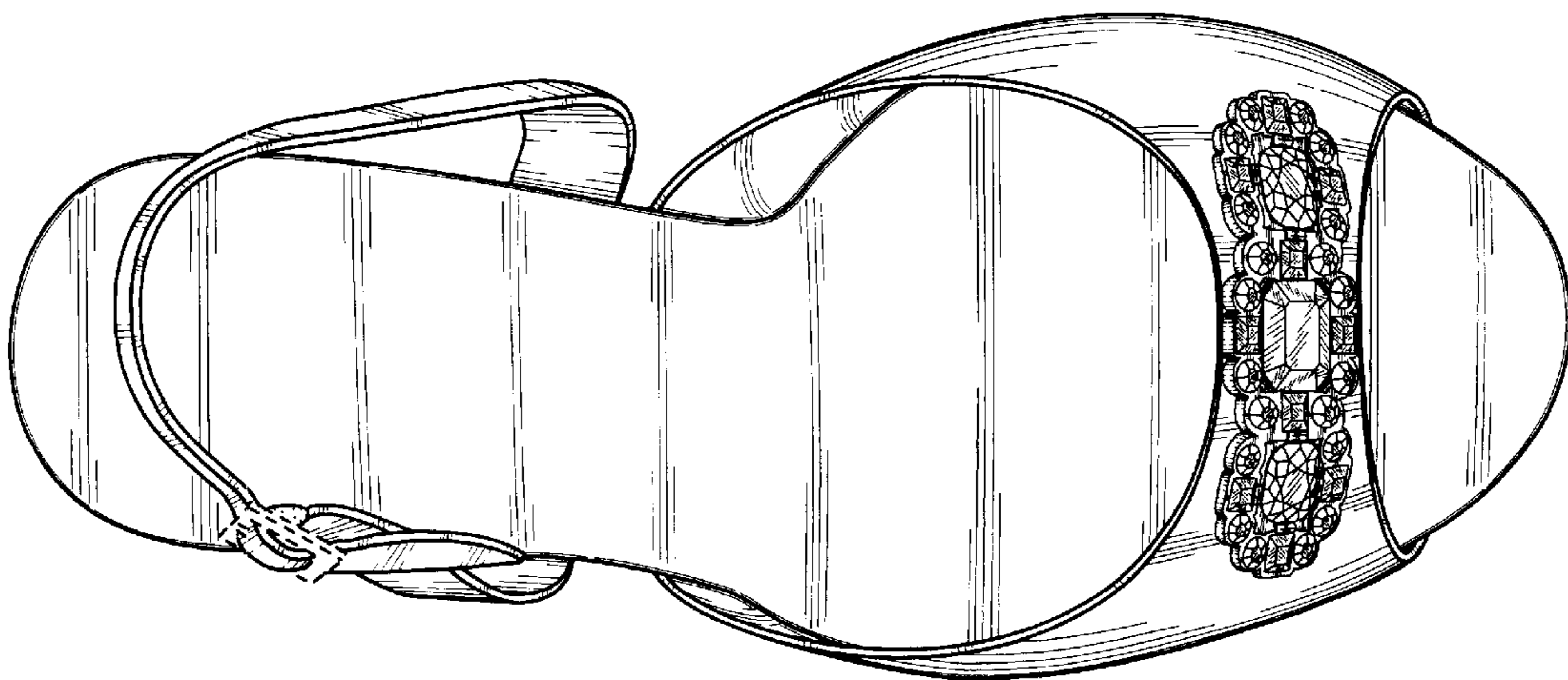

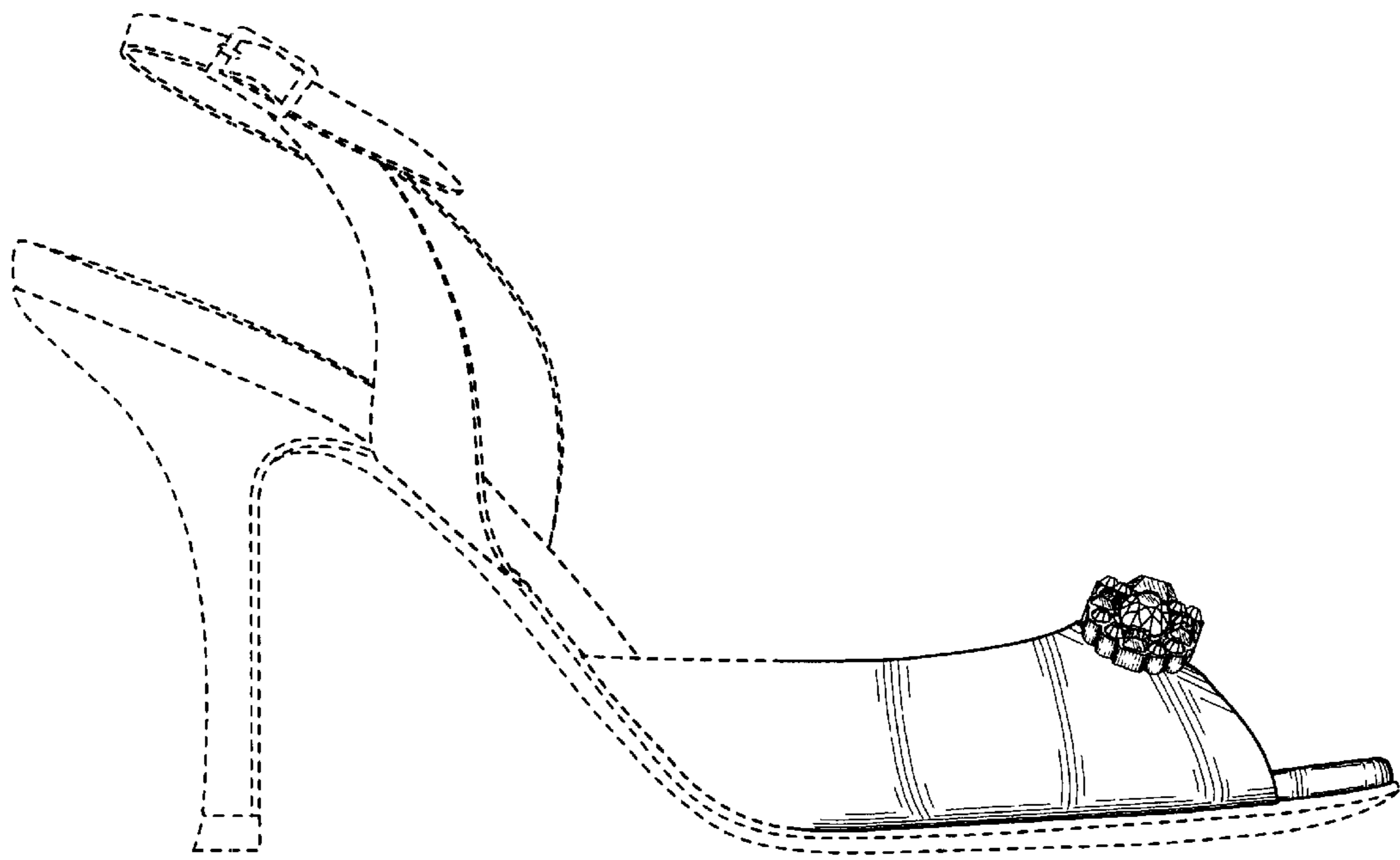

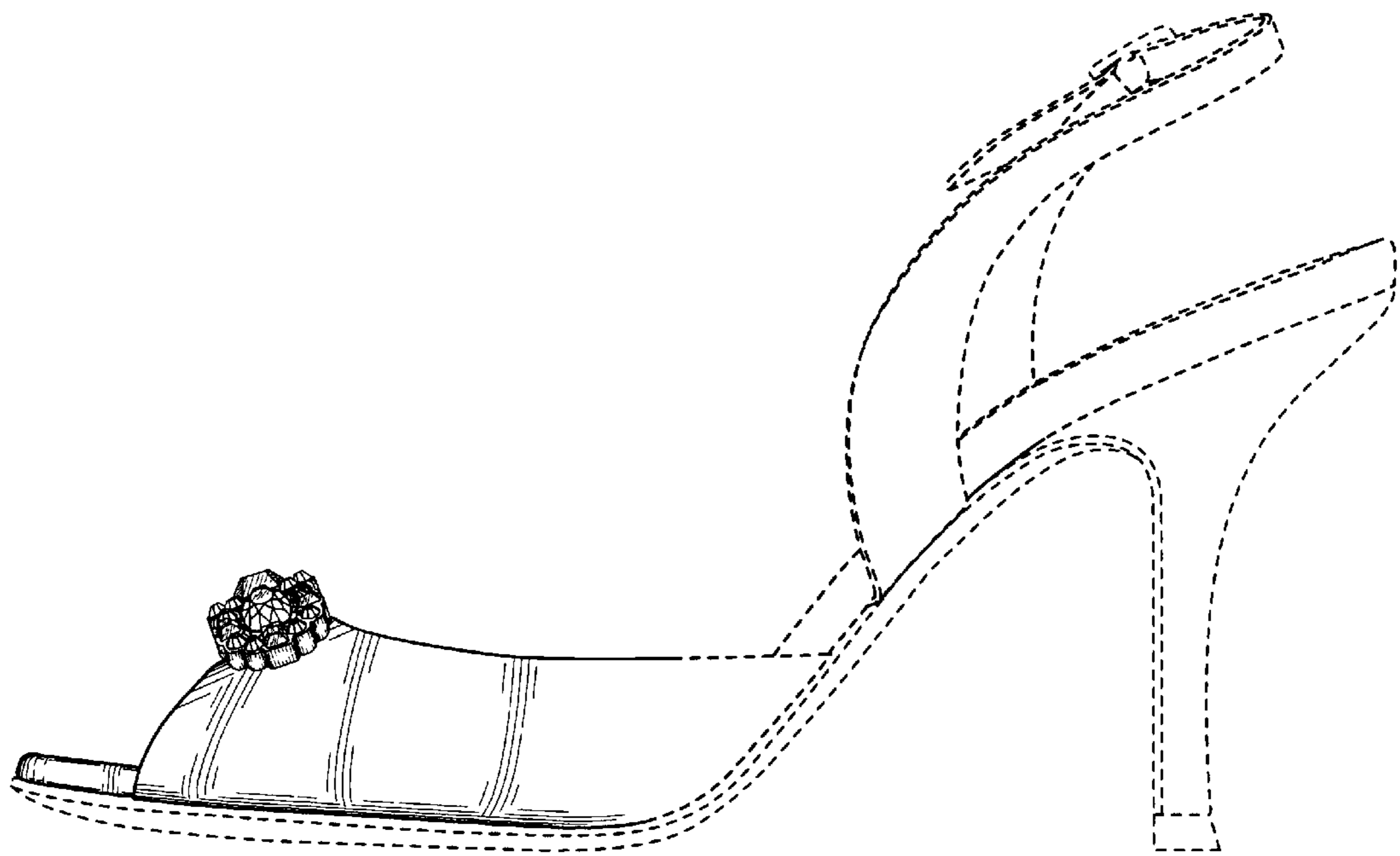

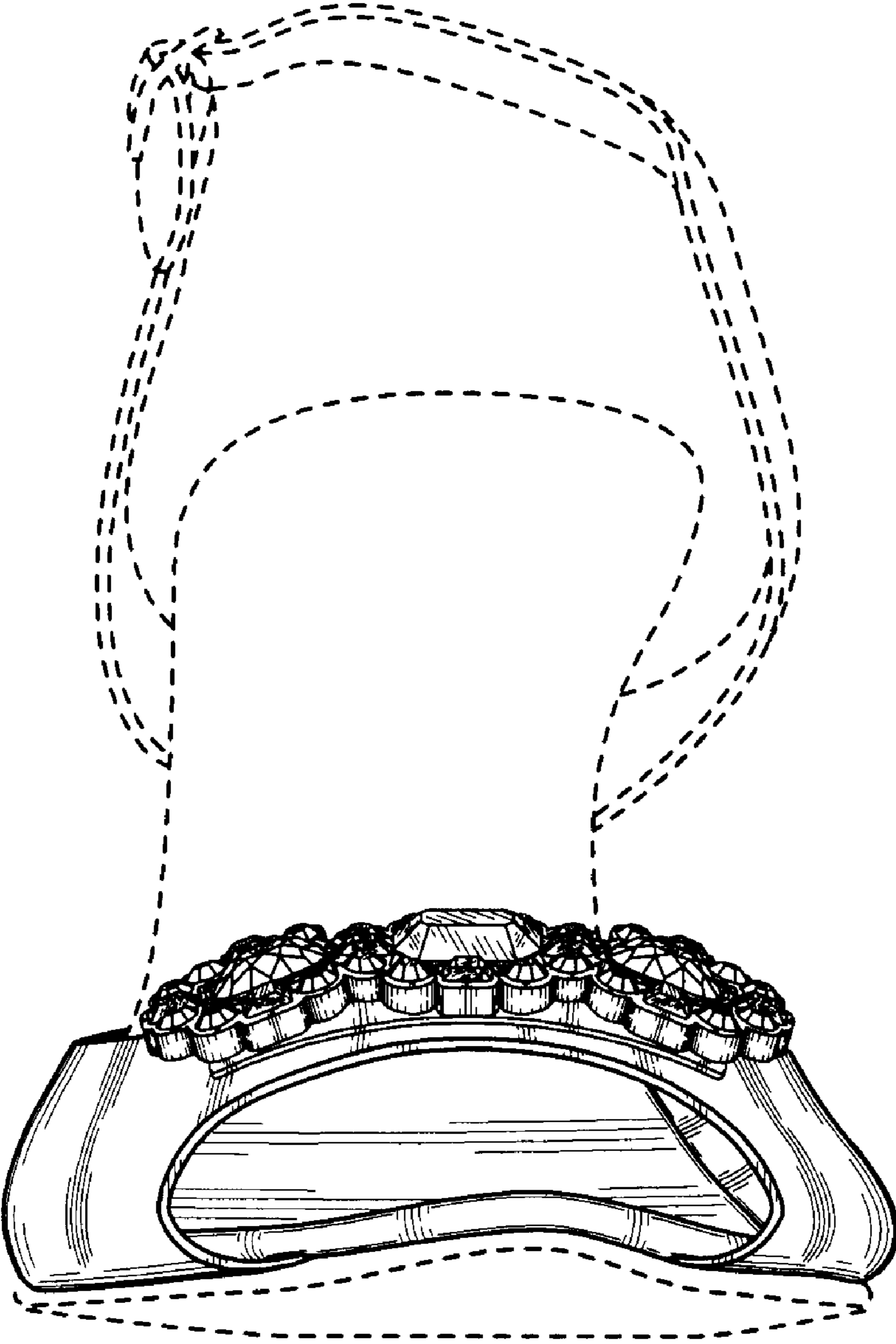

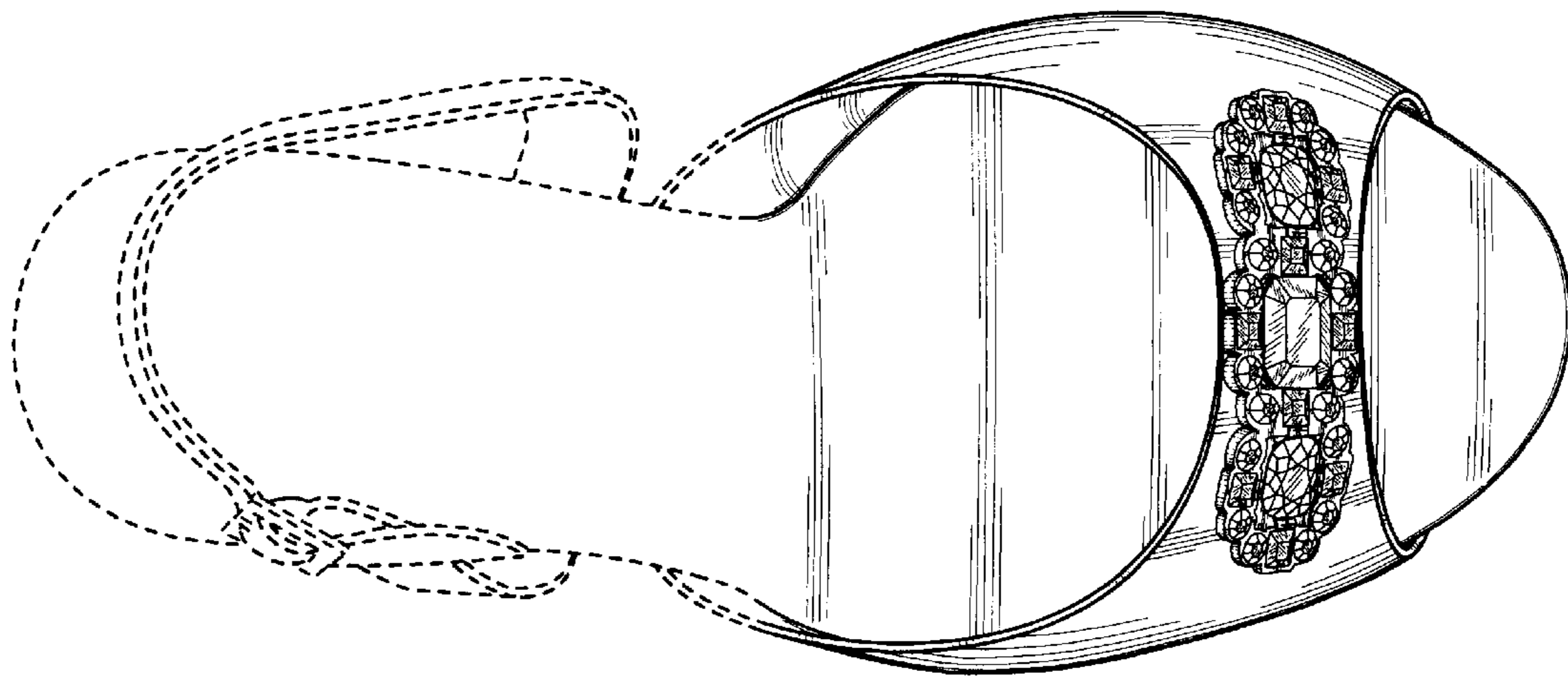
