(57) **CLAIM**

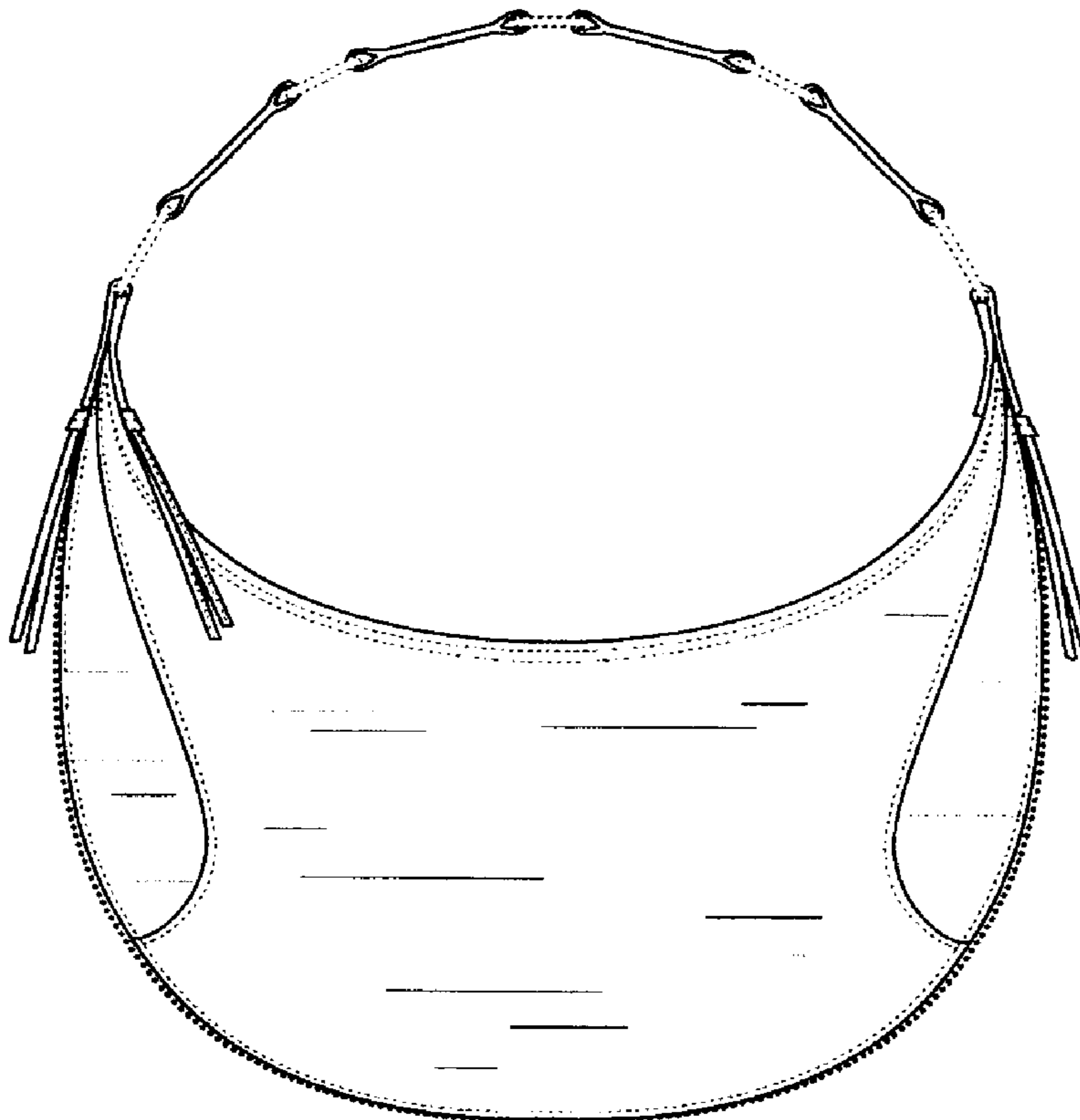
The ornamental design for a handbag, as shown and described.

**DESCRIPTION**

FIG. 1 is bottom plan view of a handbag, in non-expanded condition, showing my new design;

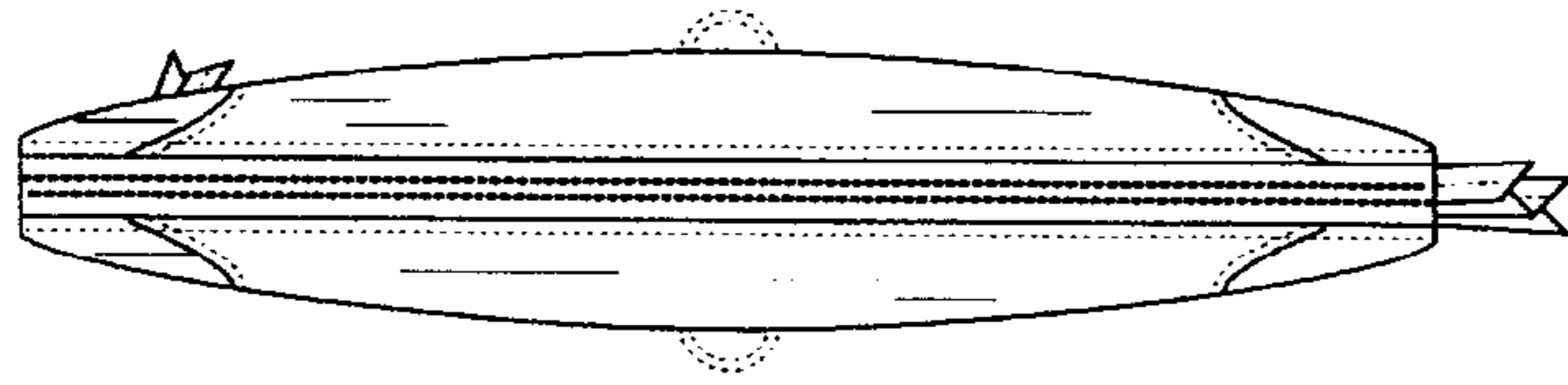

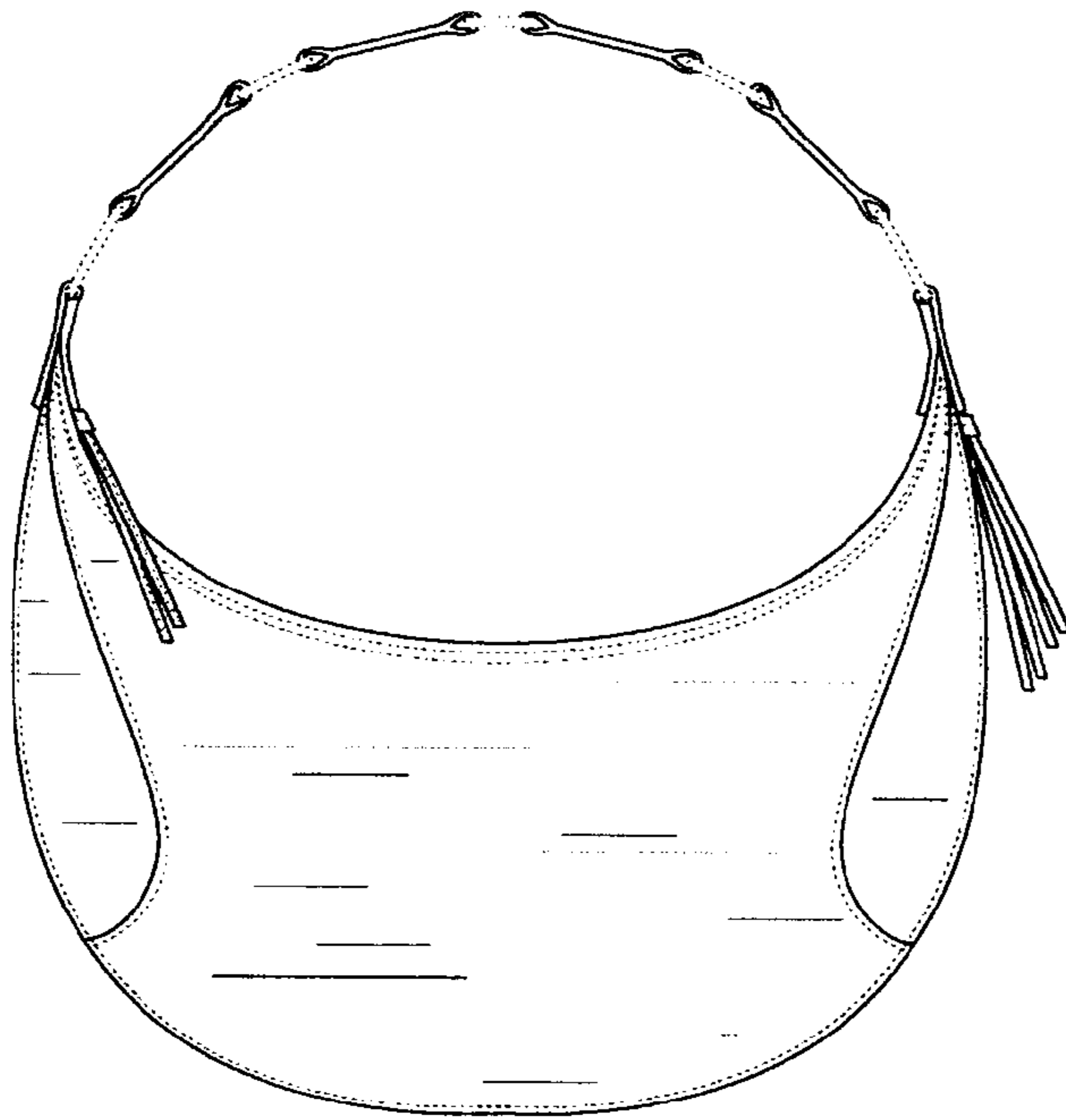

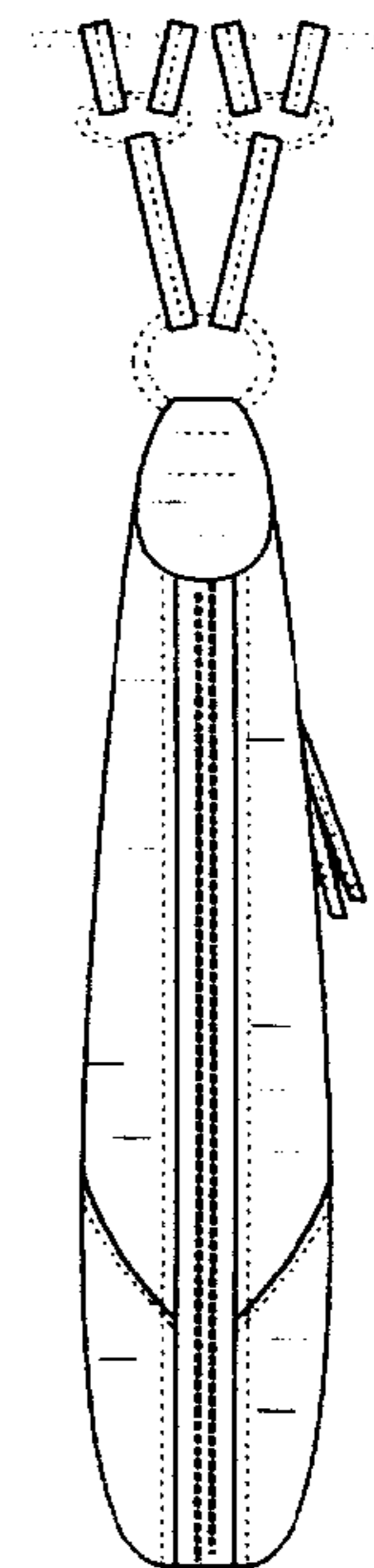

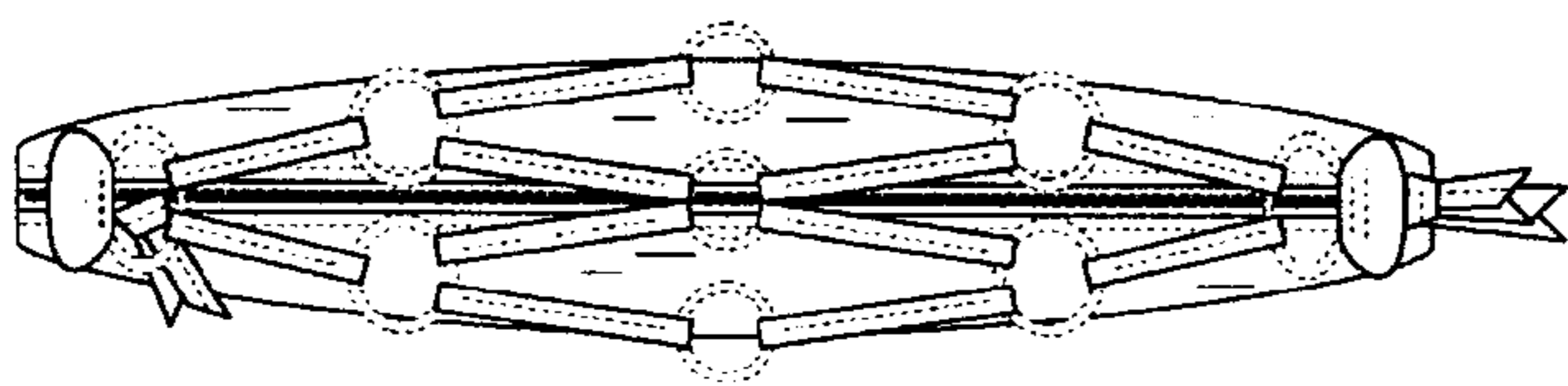

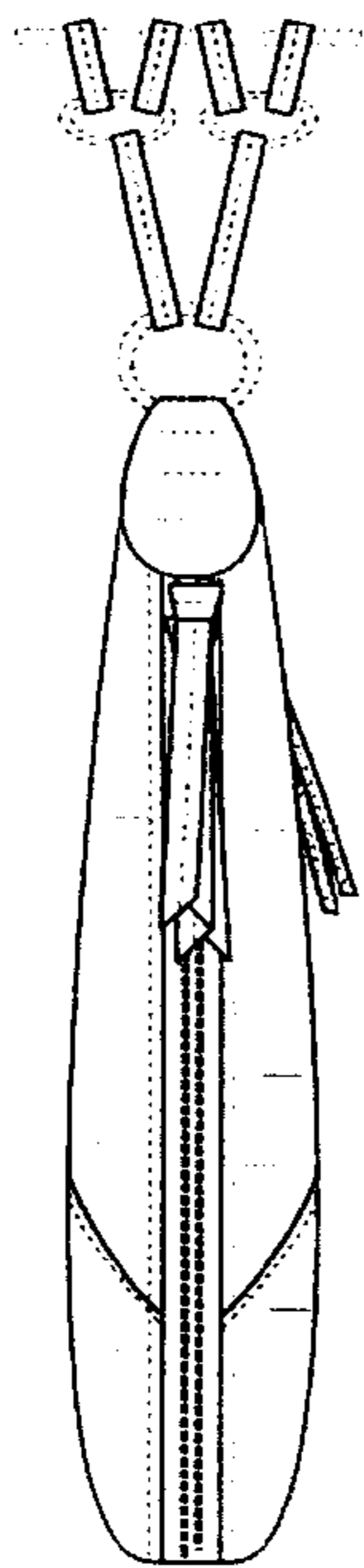

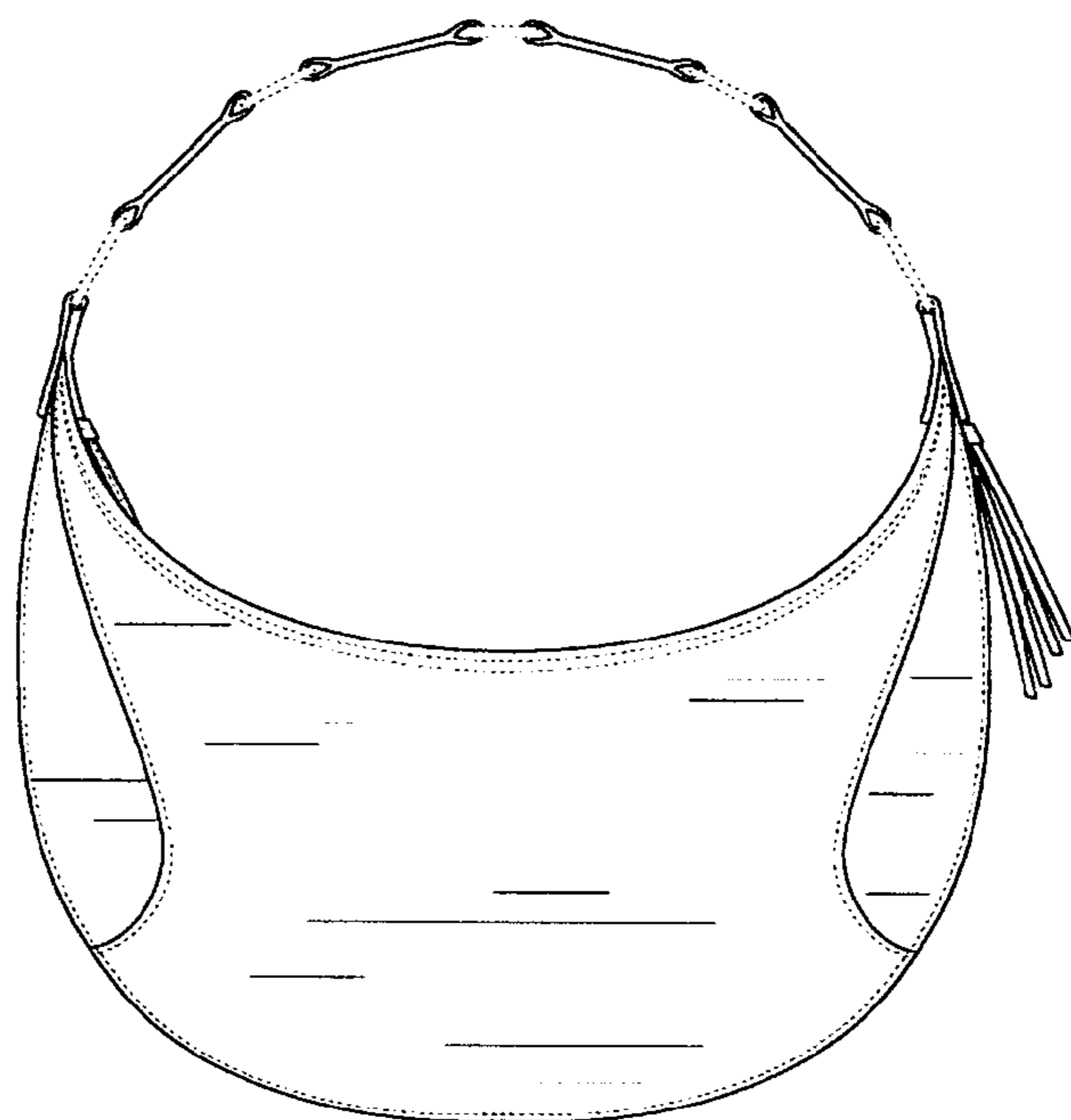

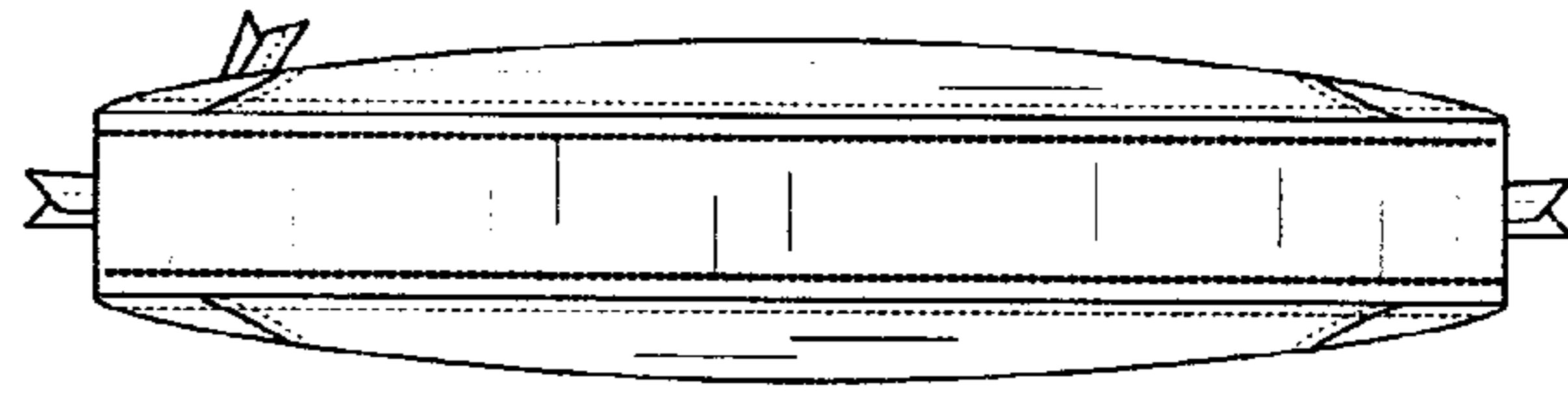

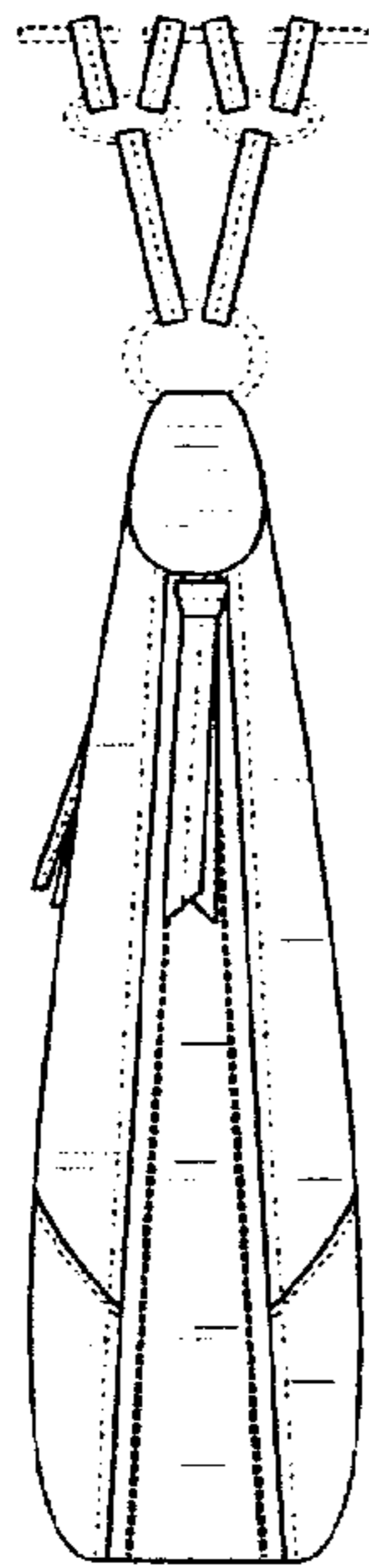

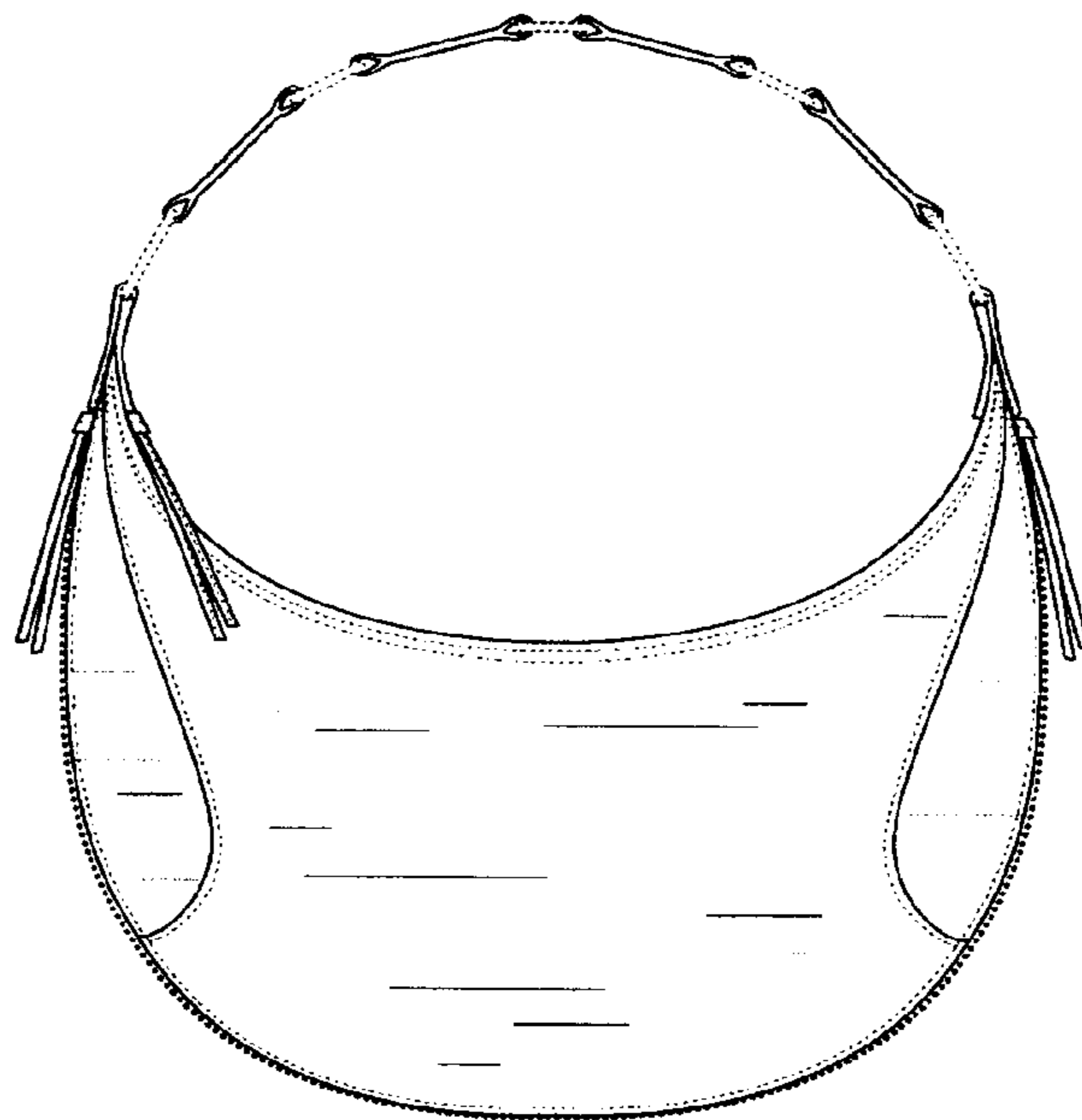

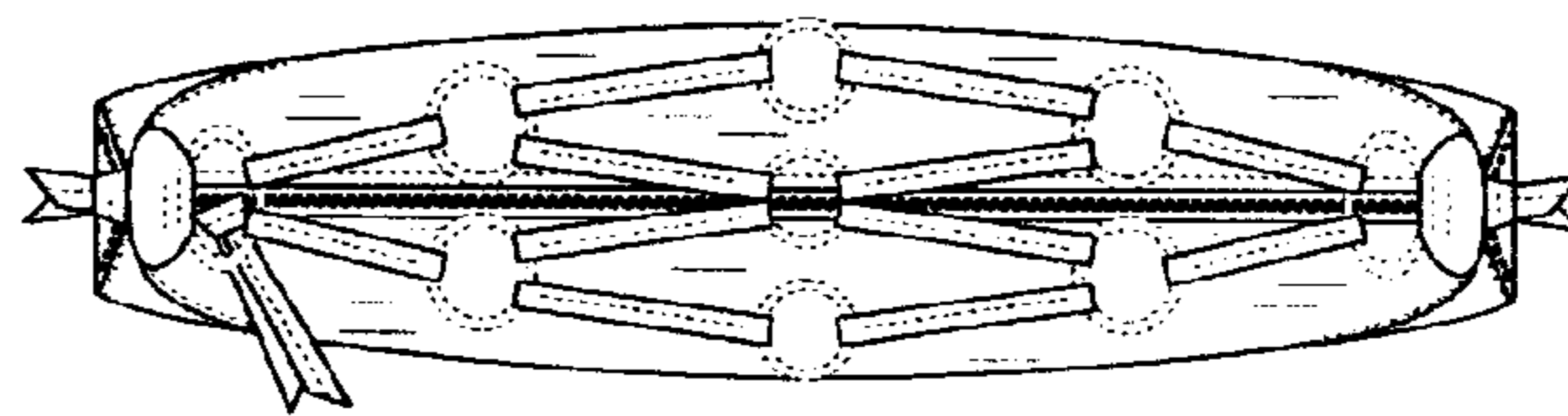

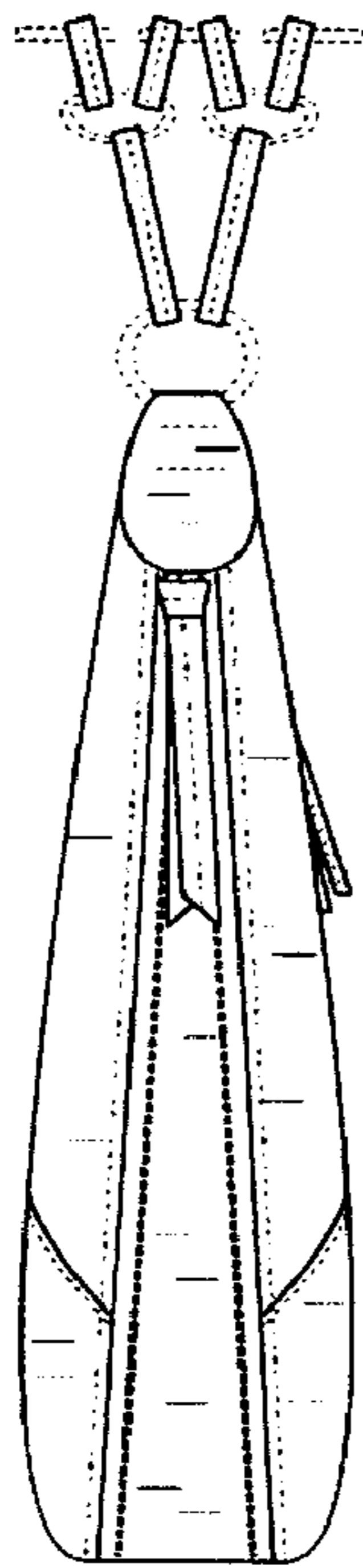

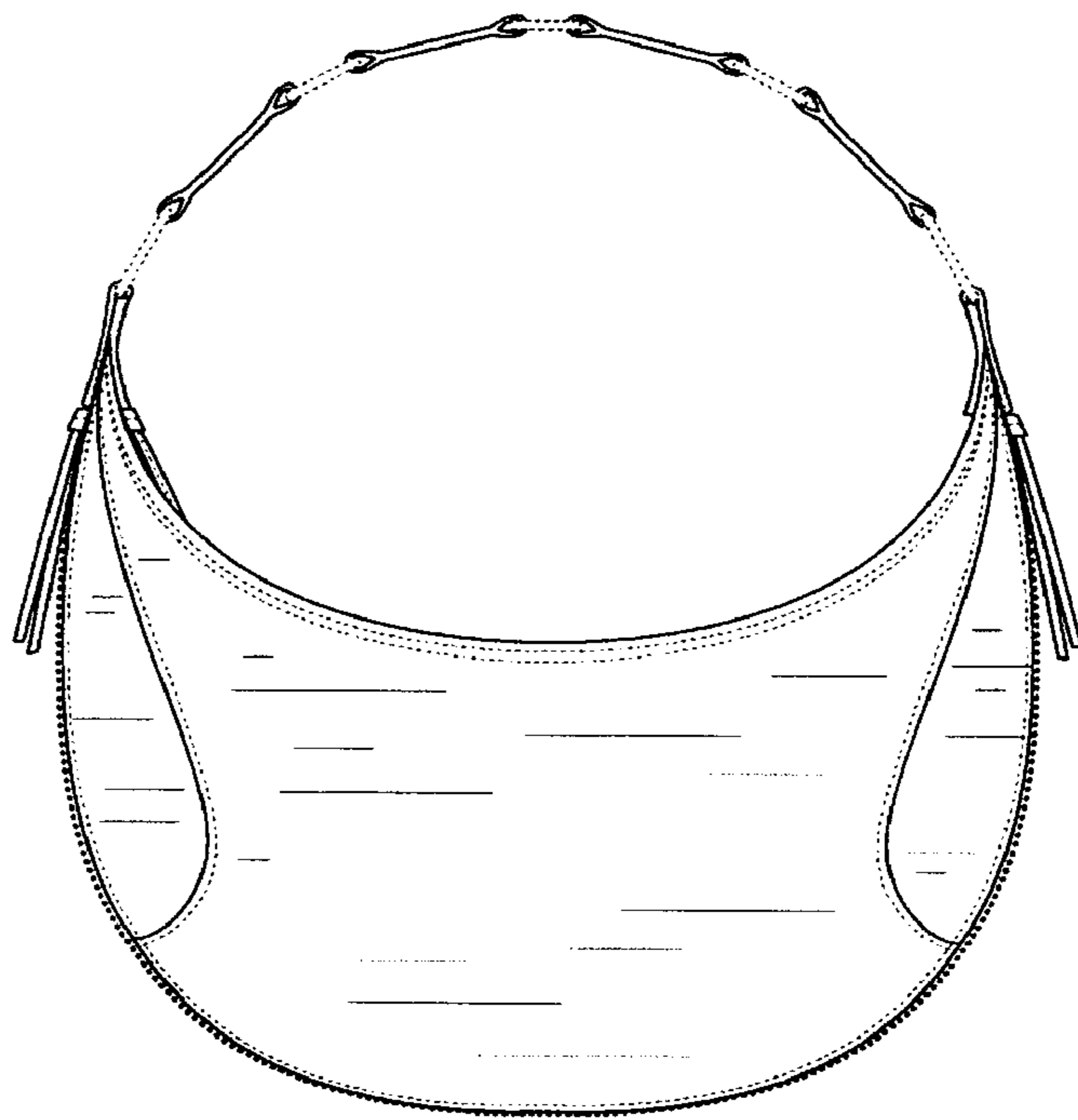
