I claim, the ornamental design for a seat, as shown and described.

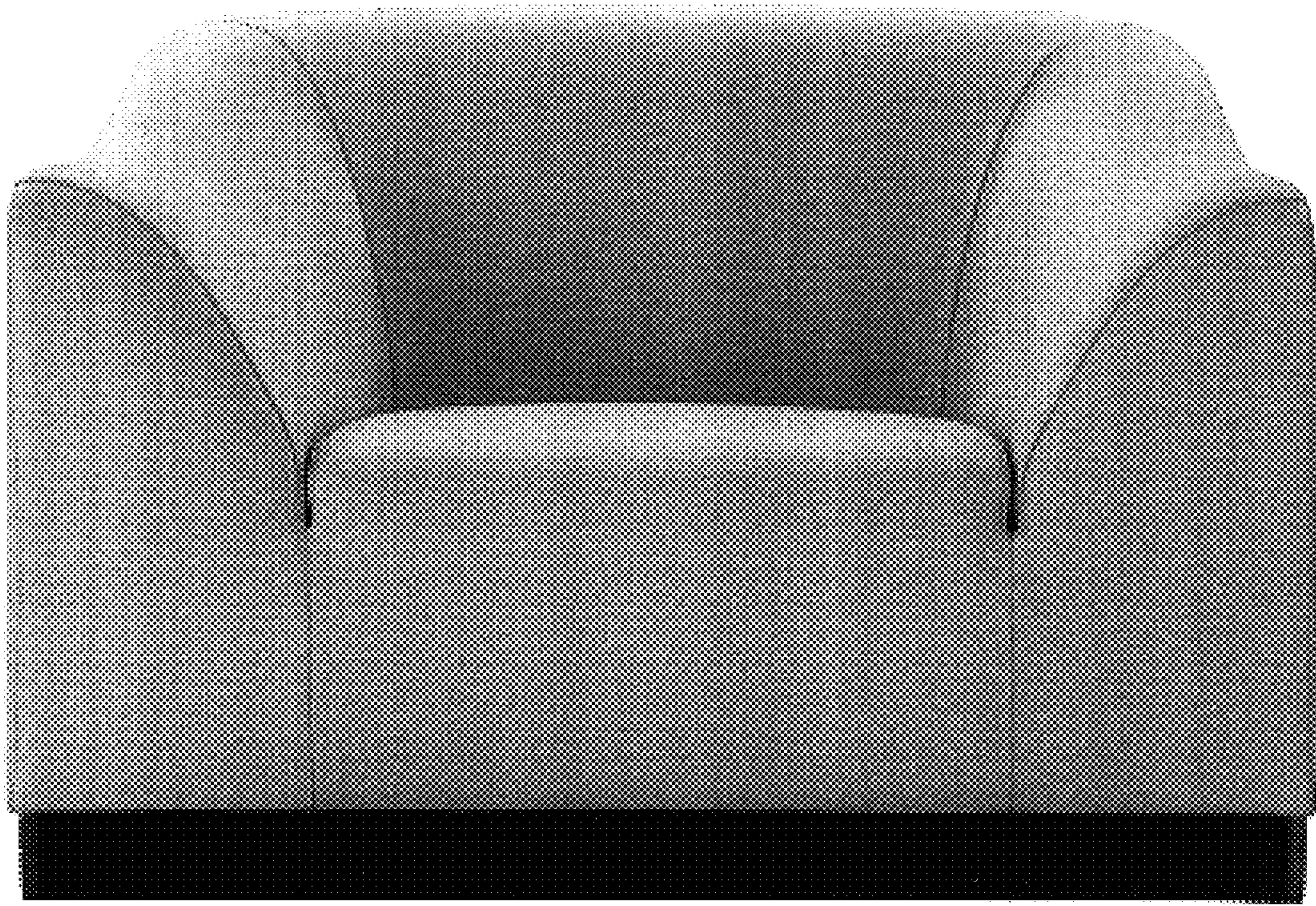

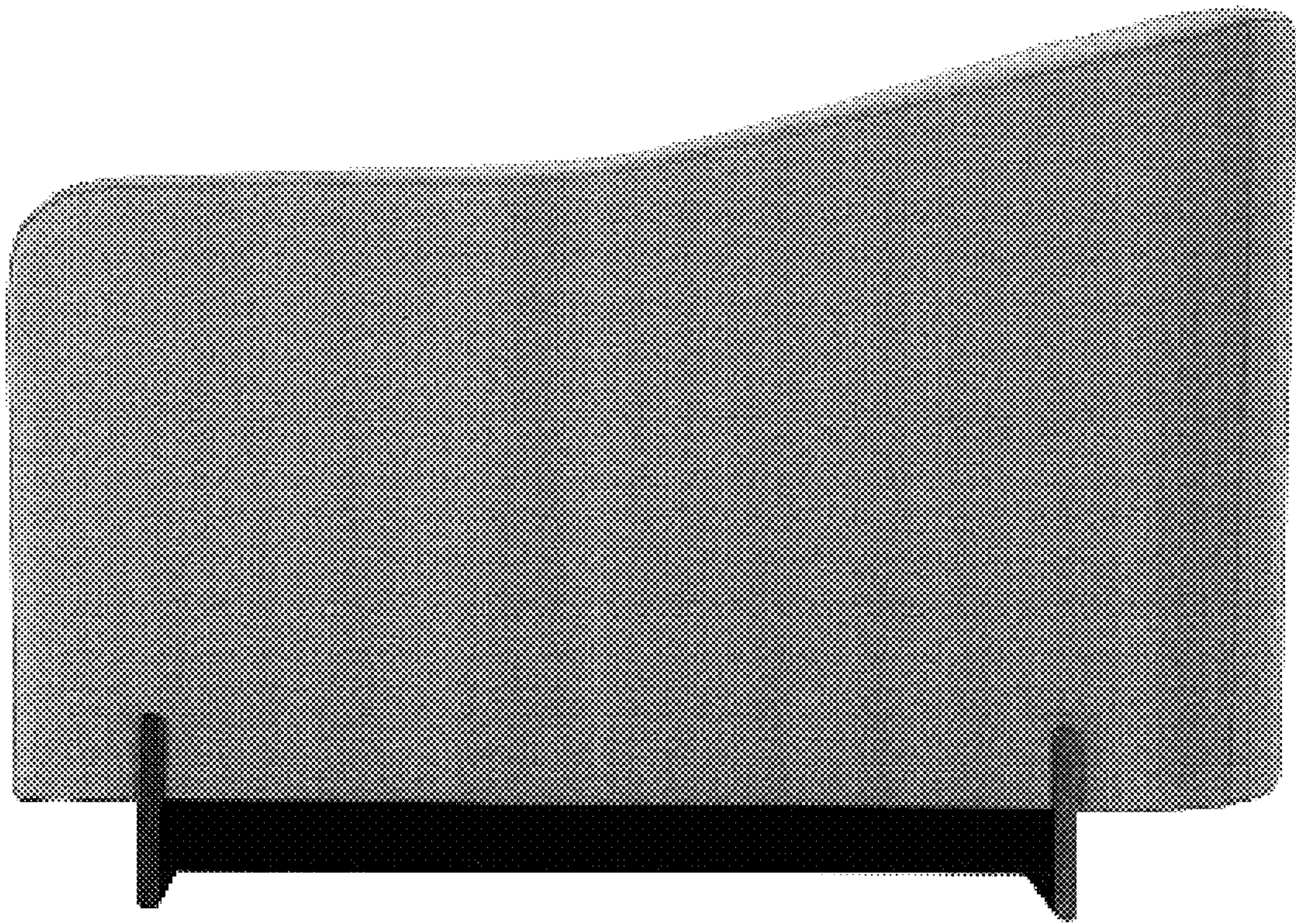

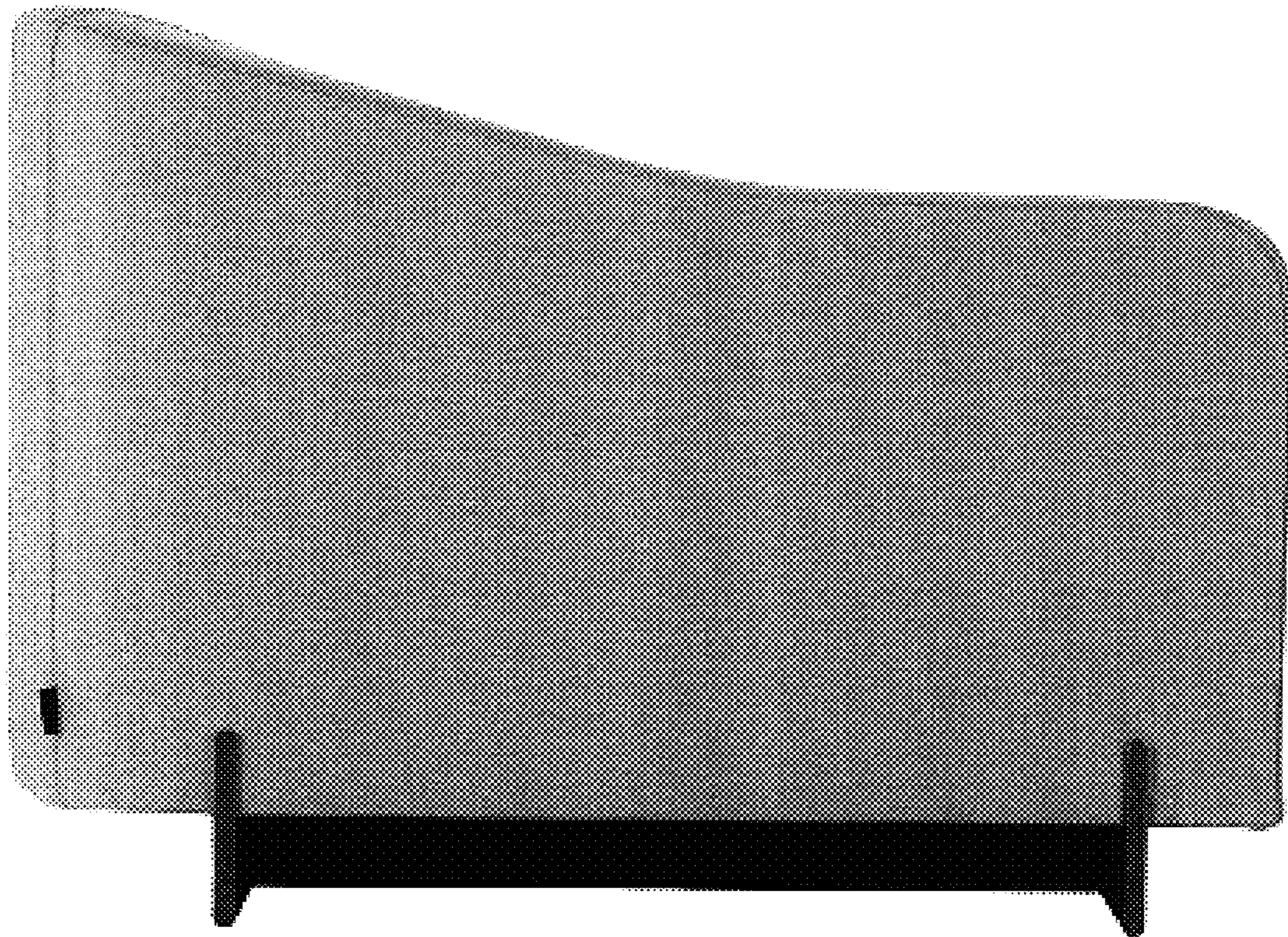

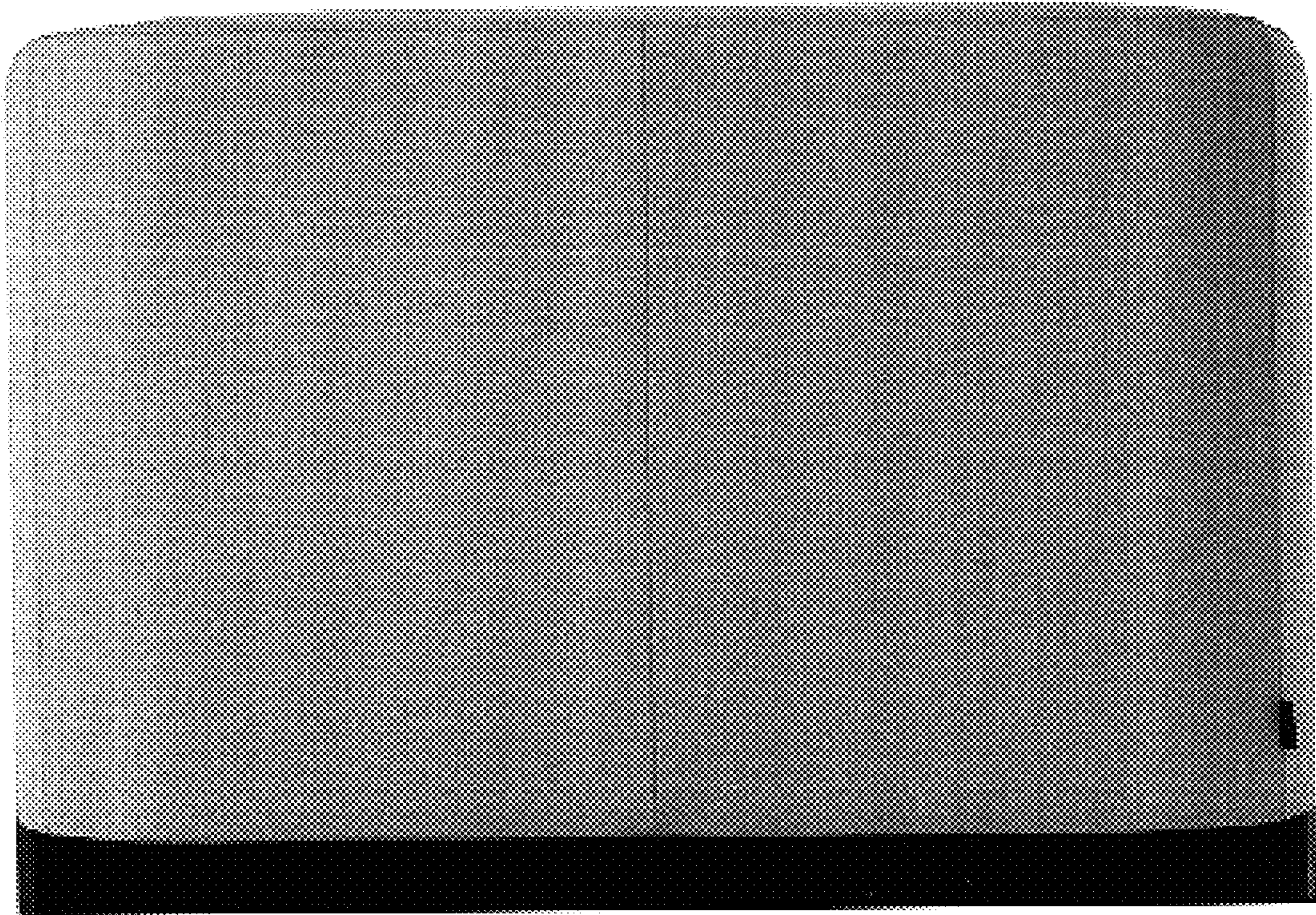

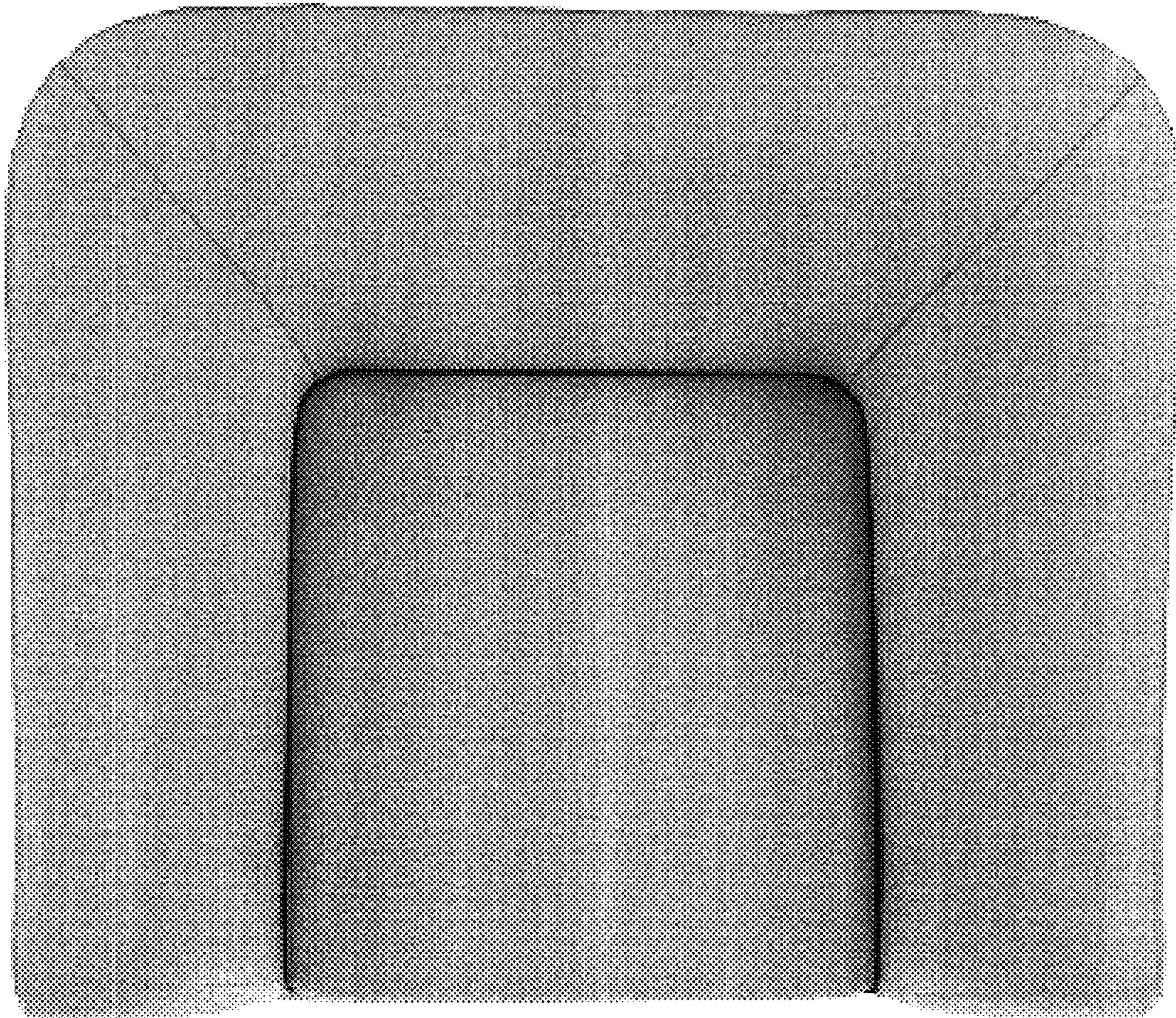

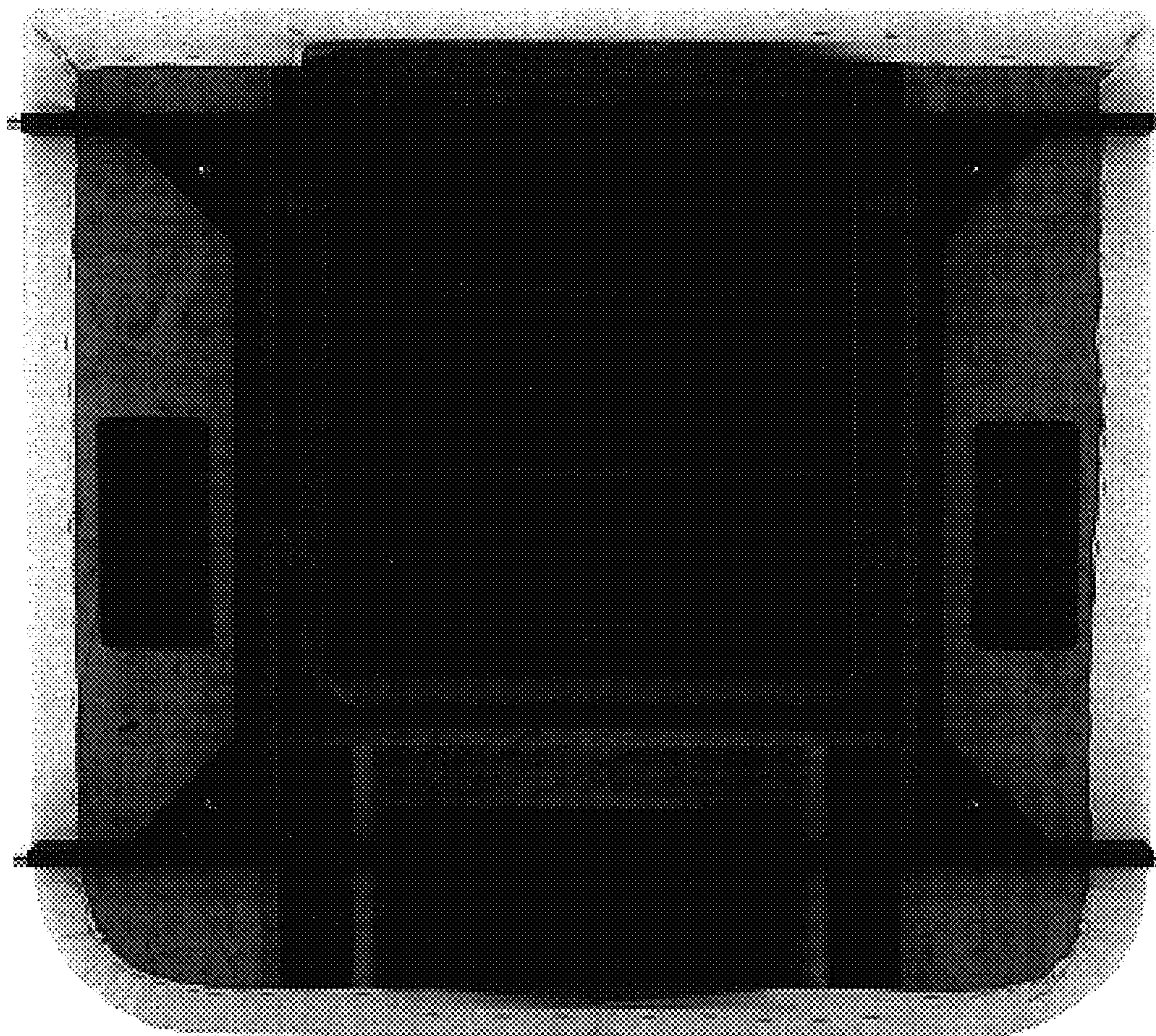

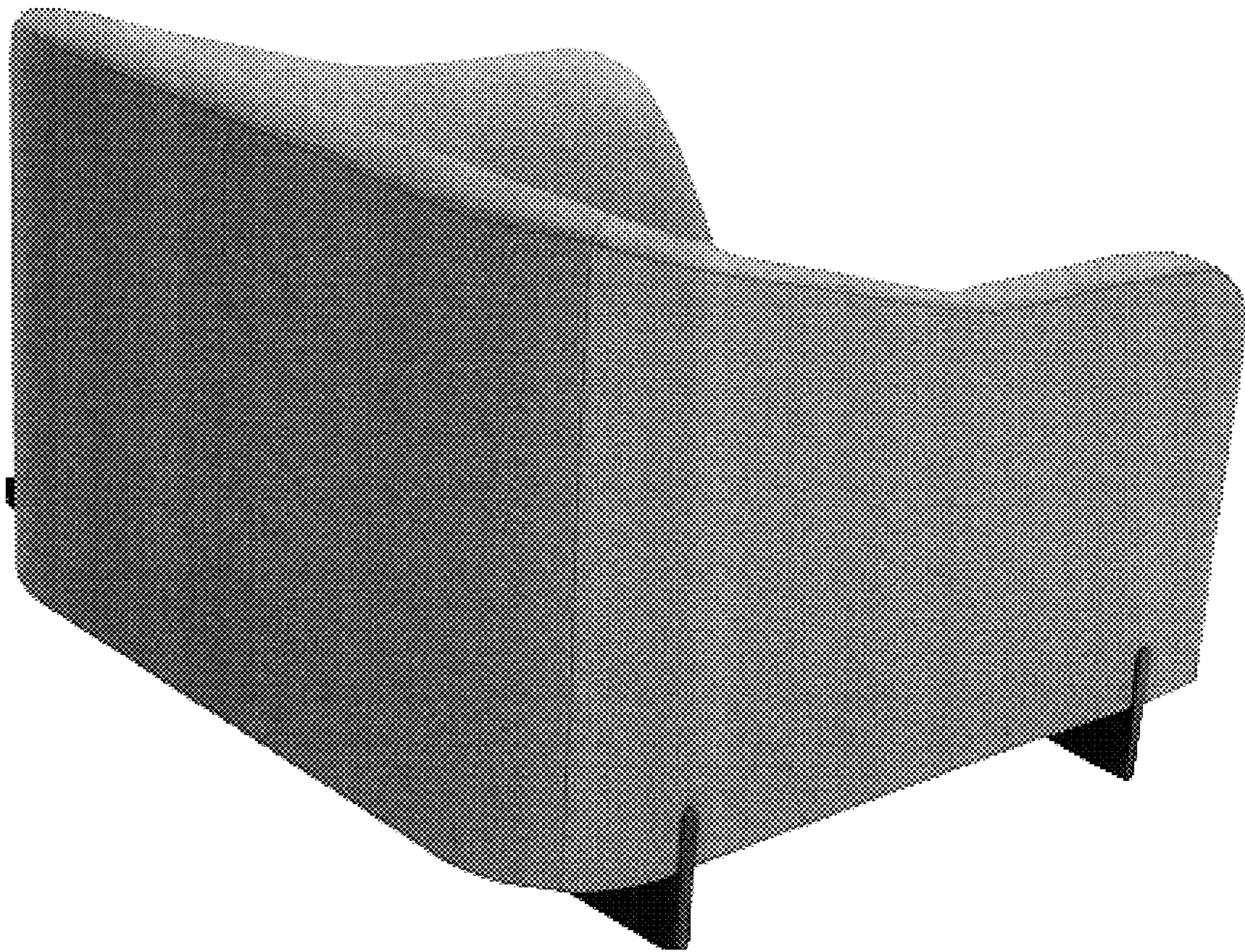

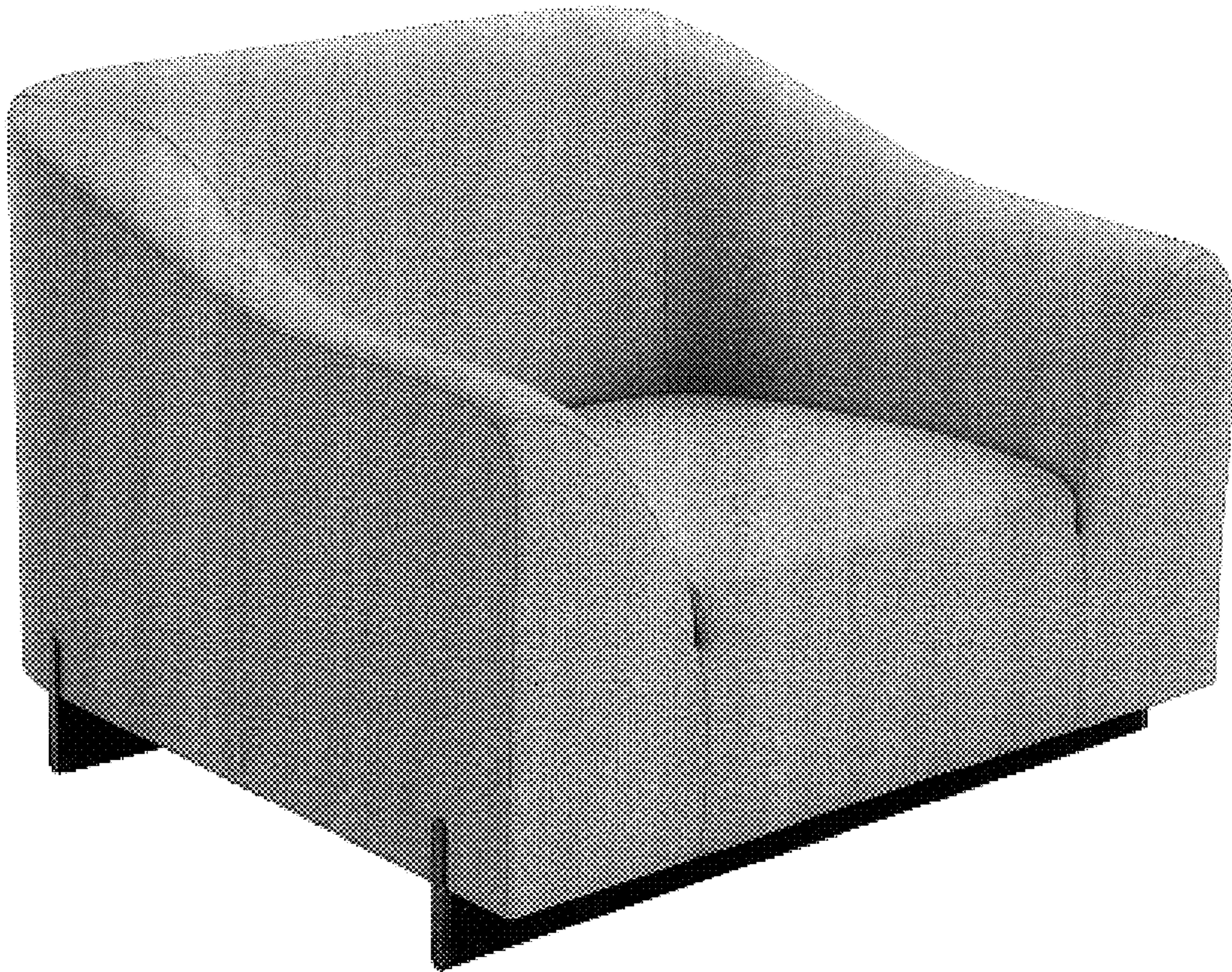
