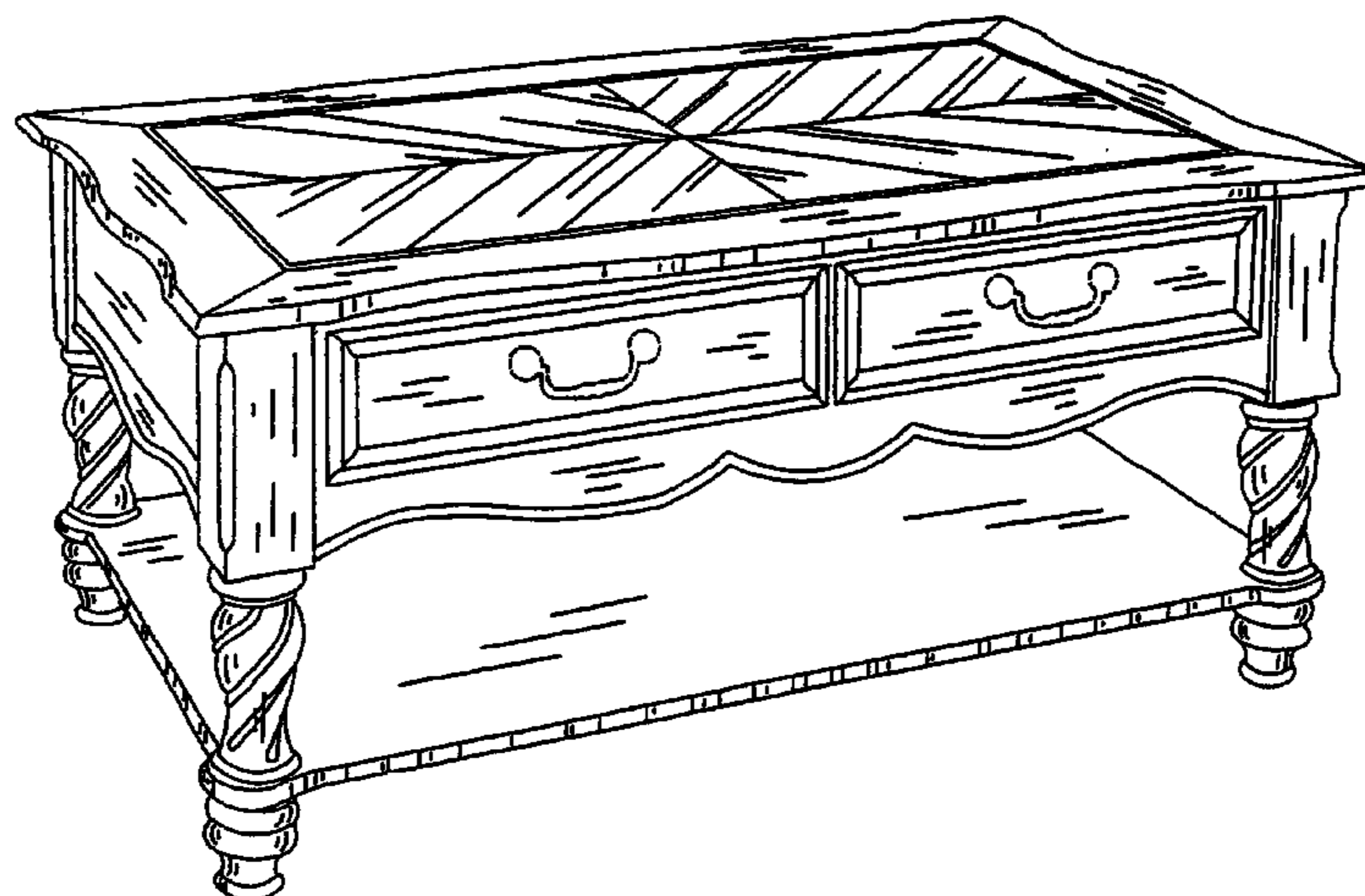
(57) **CLAIM**

We claim the ornamental design for a cocktail table, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cocktail table according to an embodiment of the invention.
FIG. 2 is a front elevational view of a cocktail table according to an embodiment of the invention.
FIG. 3 is a side elevational view of a cocktail table according to an embodiment of the invention. The elevational view of the opposite side being a mirror image thereof.
FIG. 4 is a top plan view of a cocktail table according to an embodiment of the invention; and,
FIG. 5 is a back elevational view of a cocktail table according to an embodiment of the invention.
The dashed lines represent environmental elements only and form no part of the claimed design.

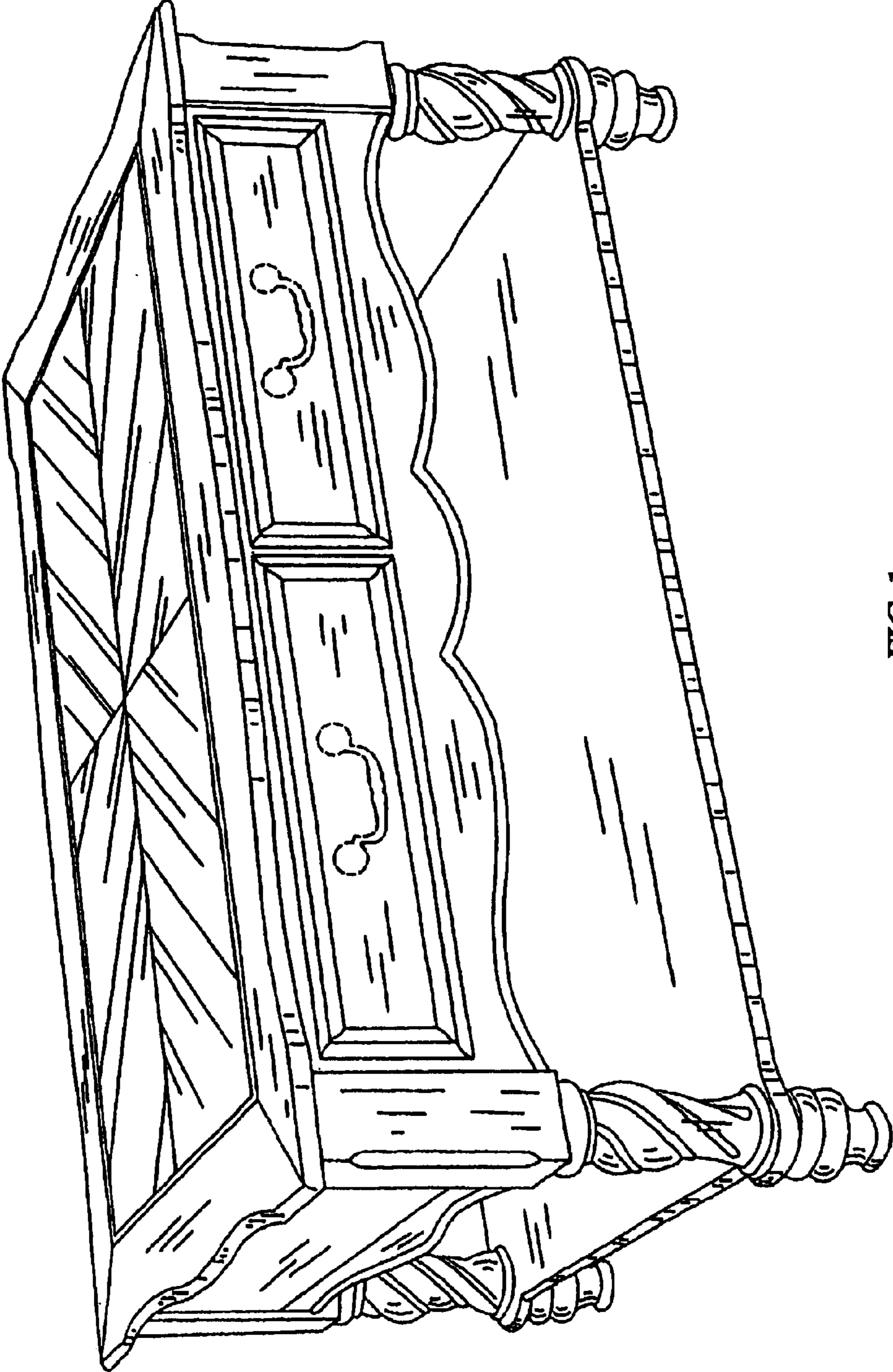

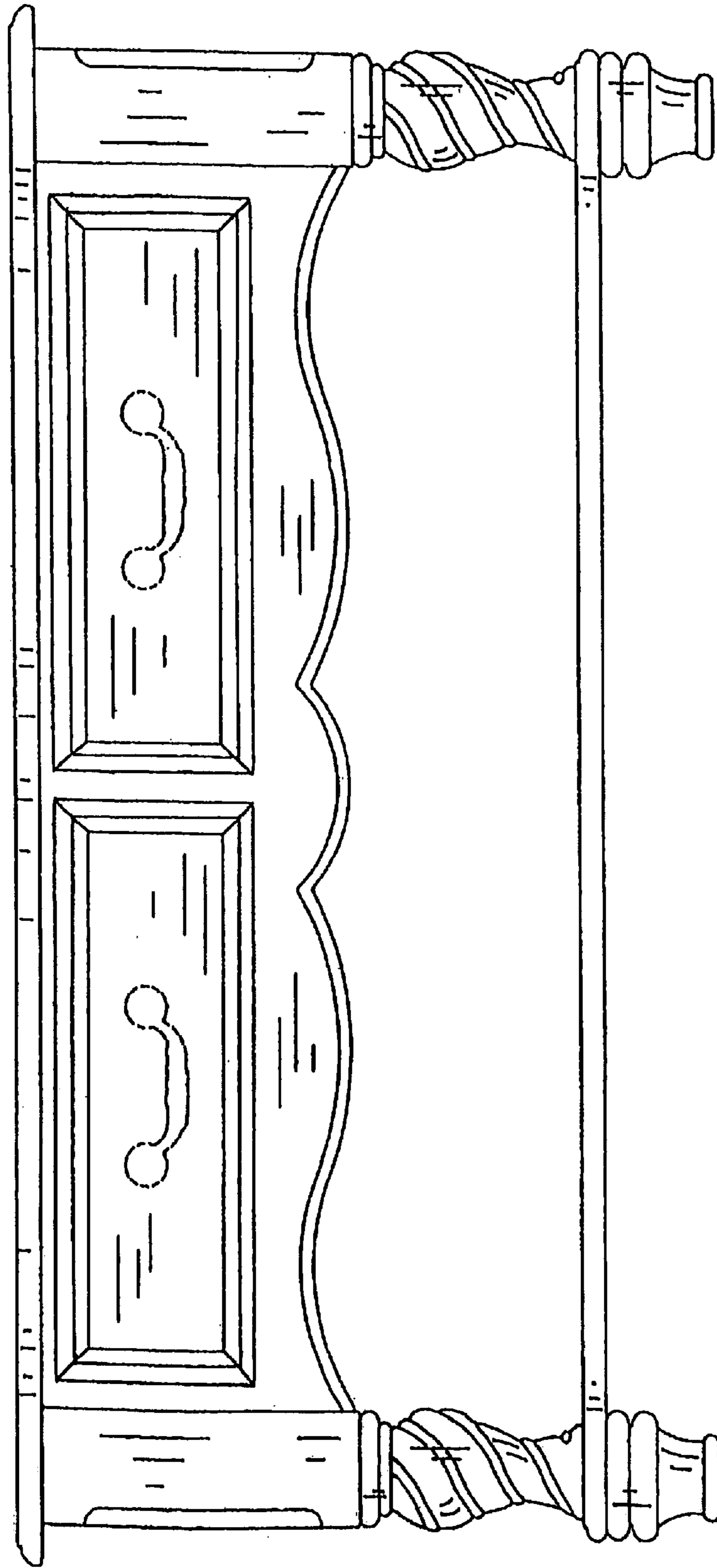

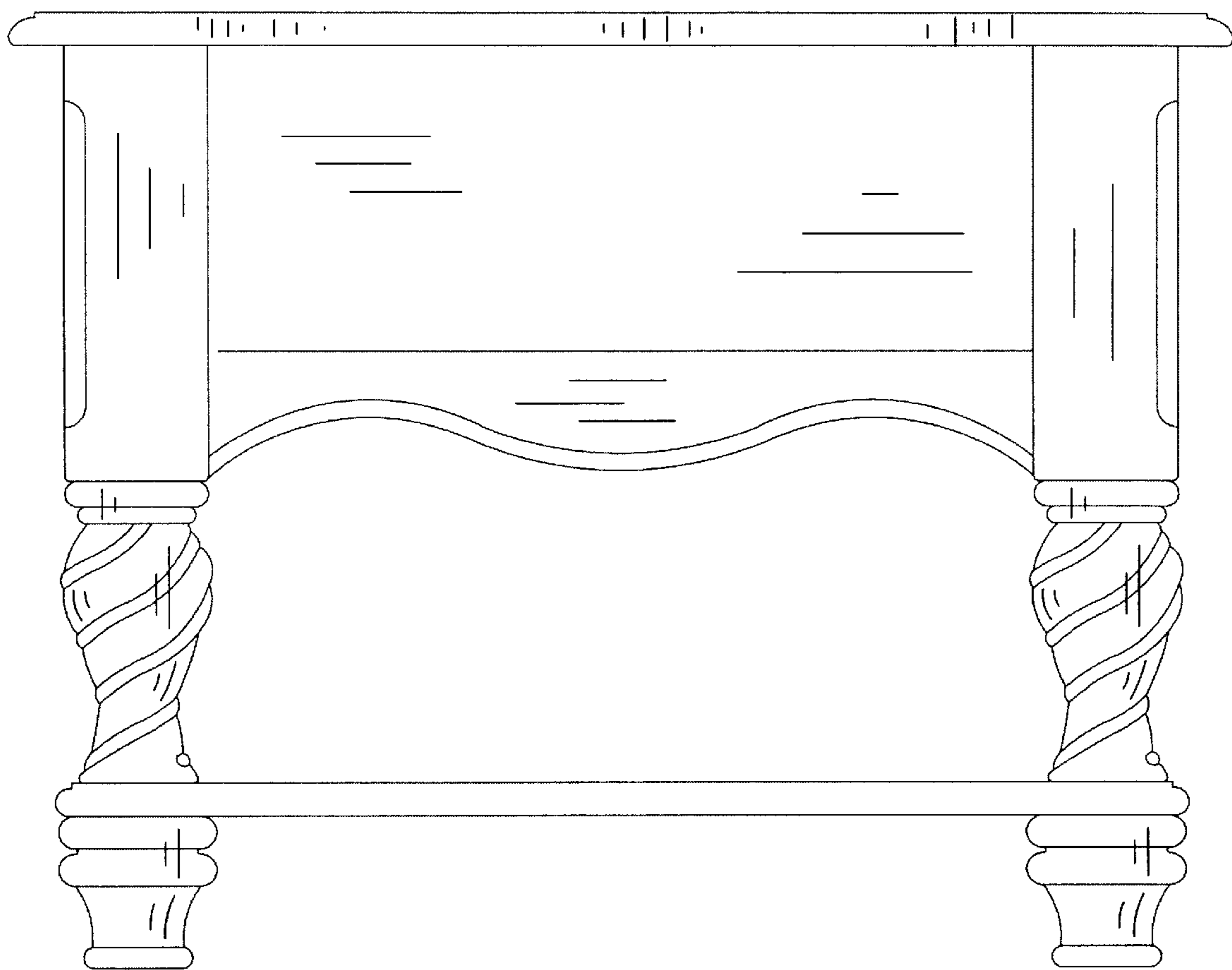
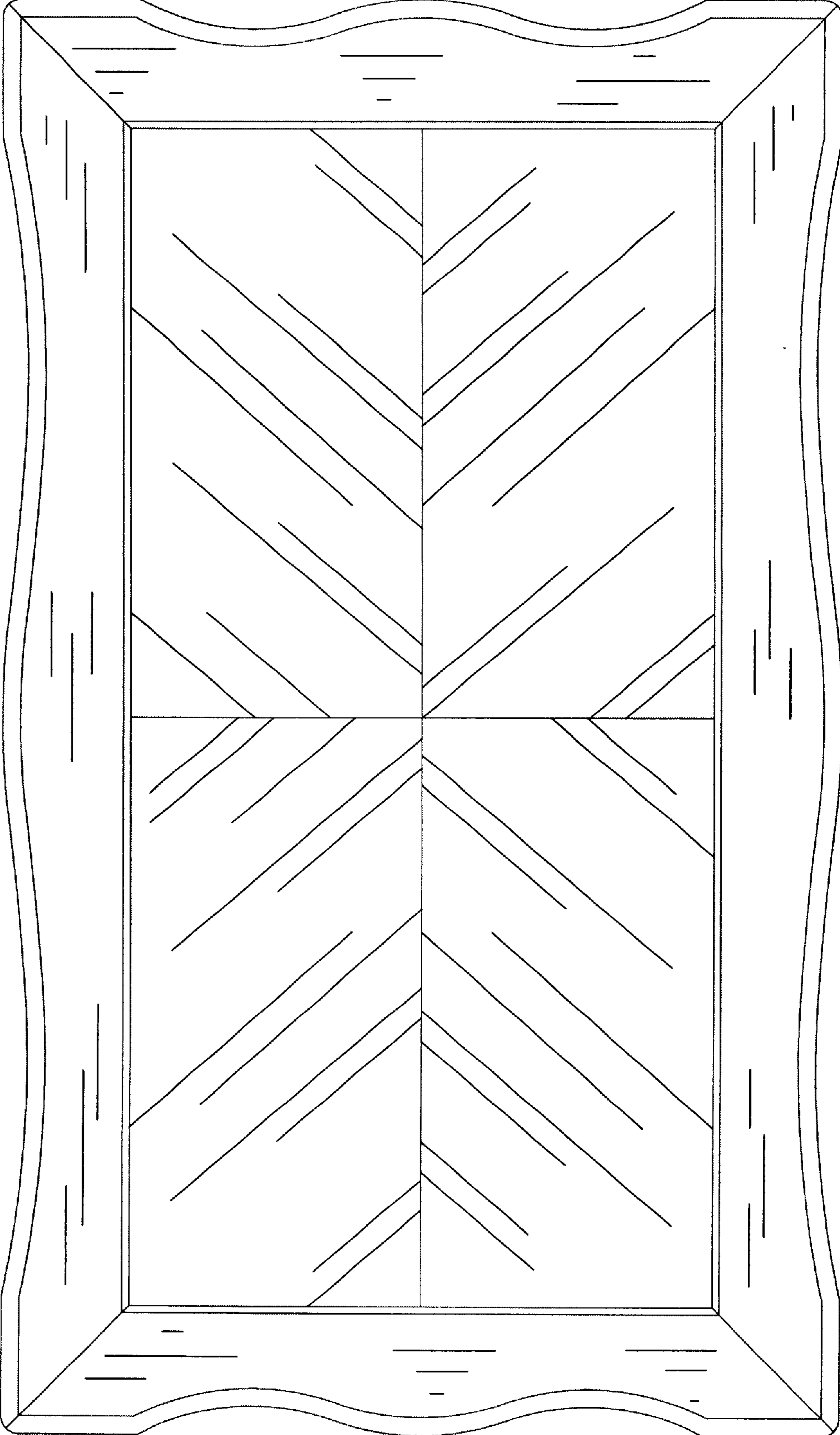

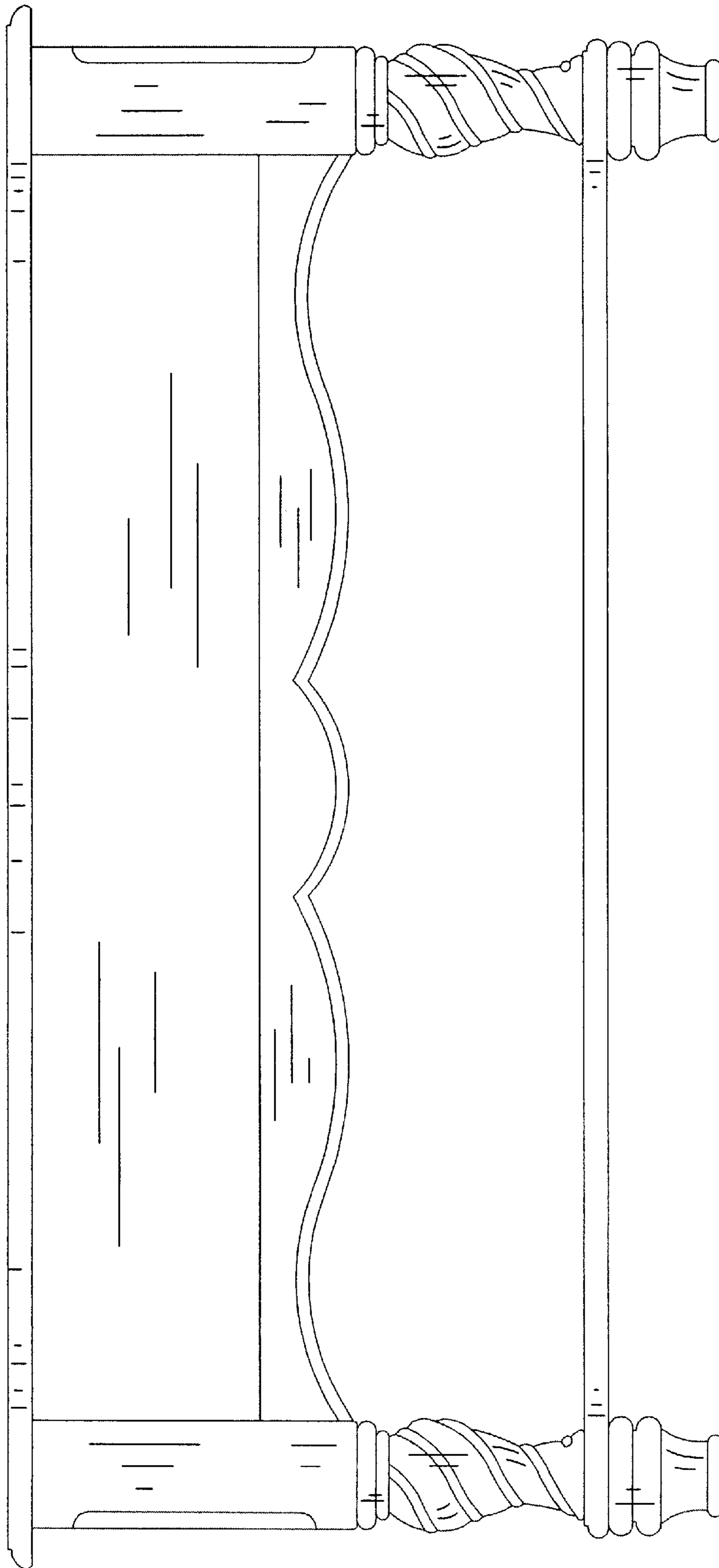
