(57) **CLAIM**

I claim the ornamental design for a handle for a plaster
trowel, as shown and described.

FIG. 5 is an opposite side view thereof;

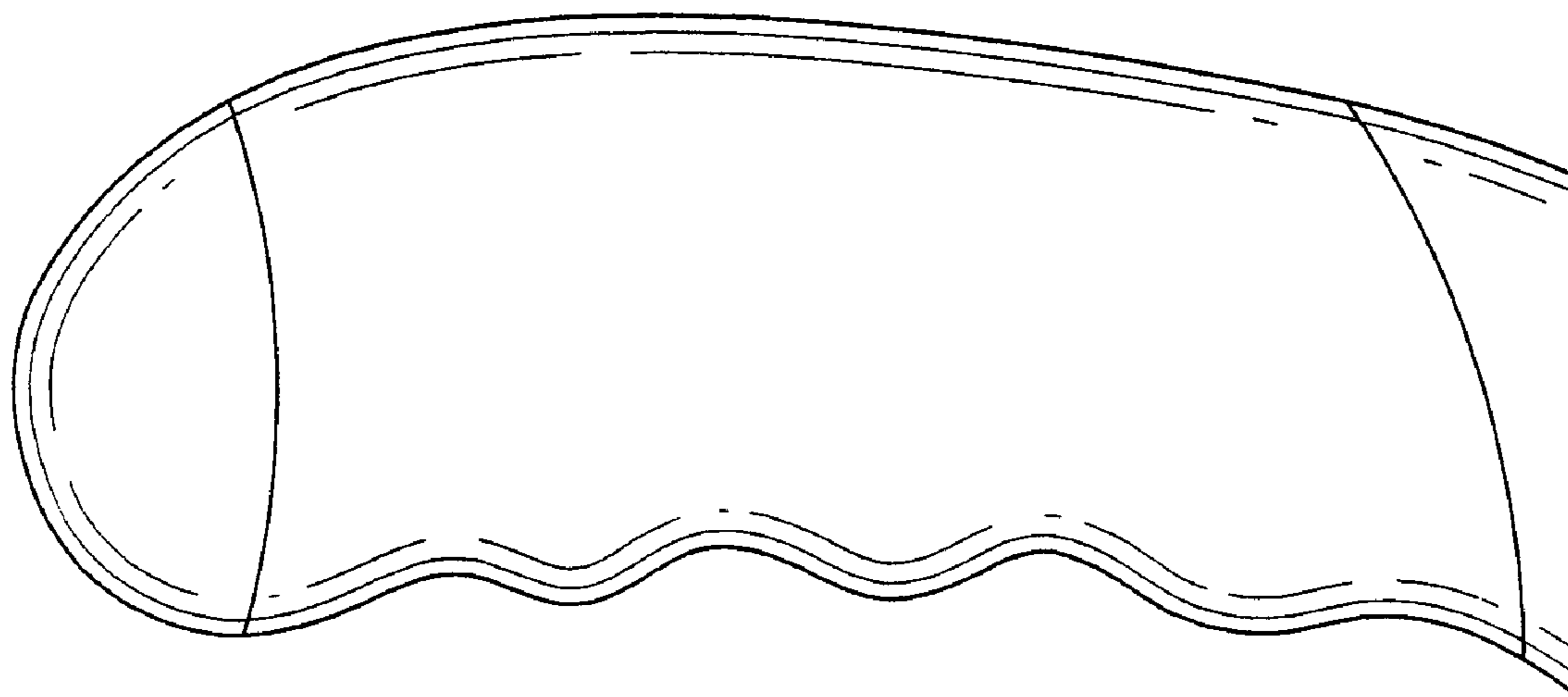
FIG. 6 is a top plan view thereof;

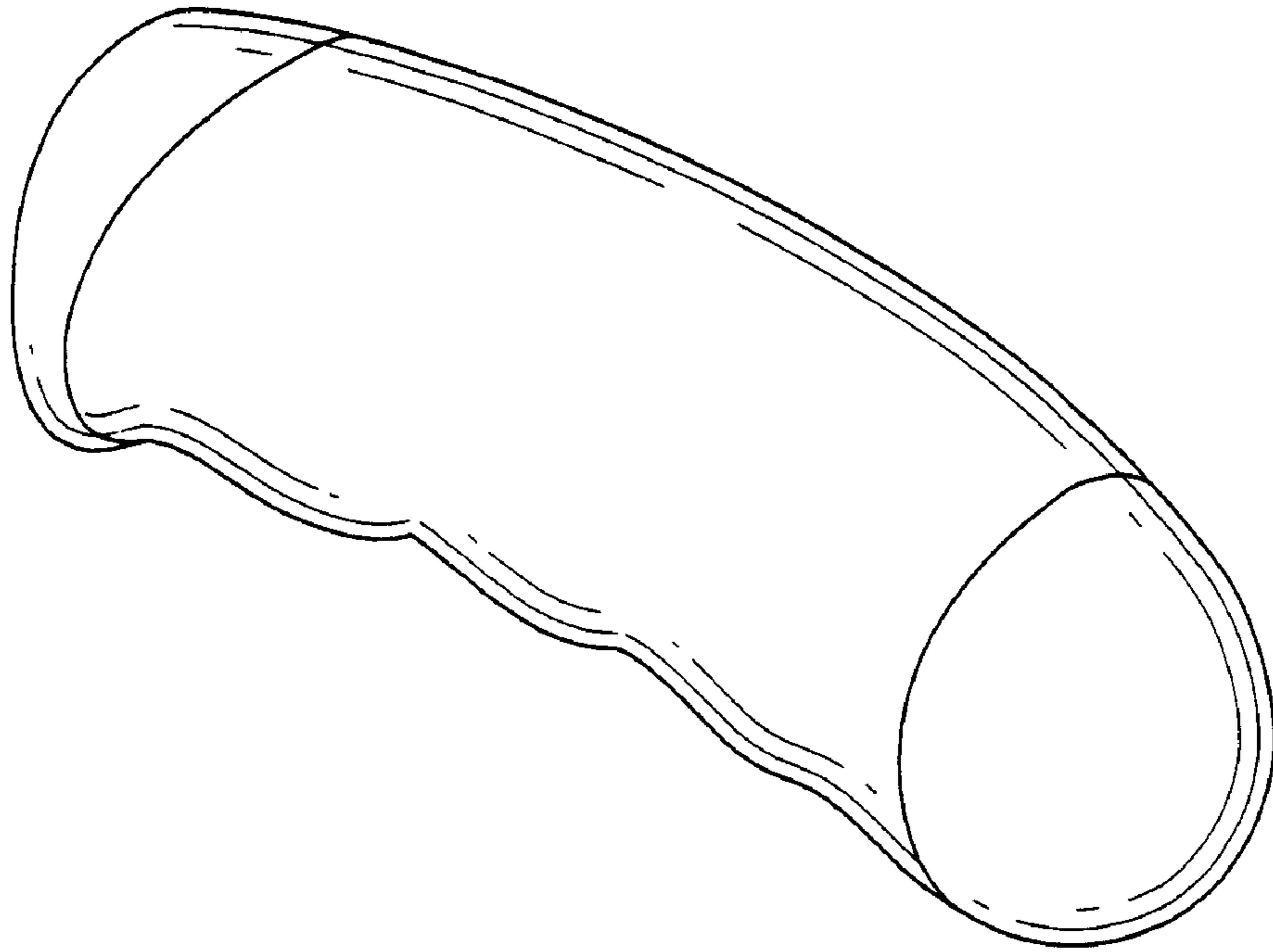

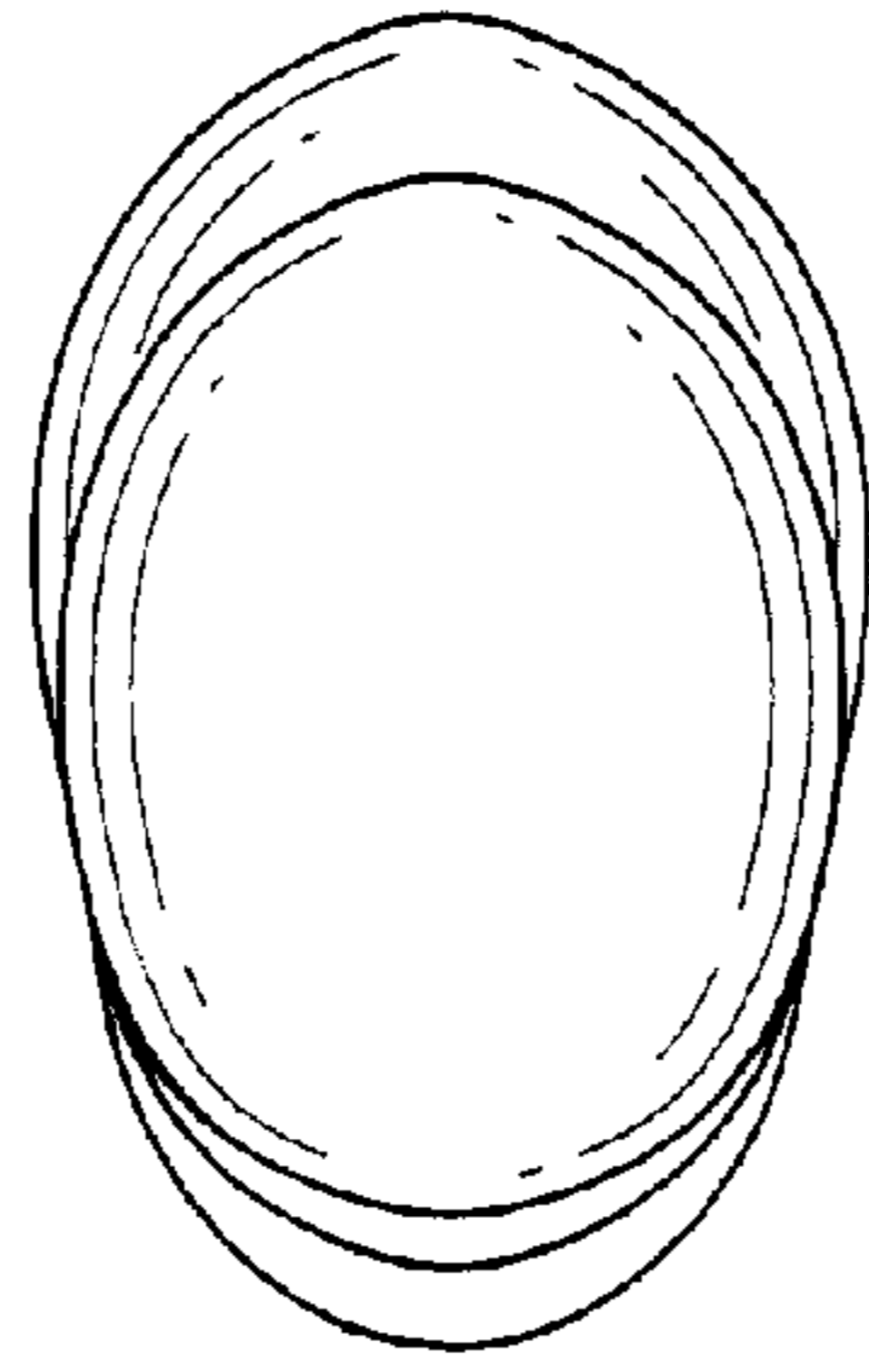

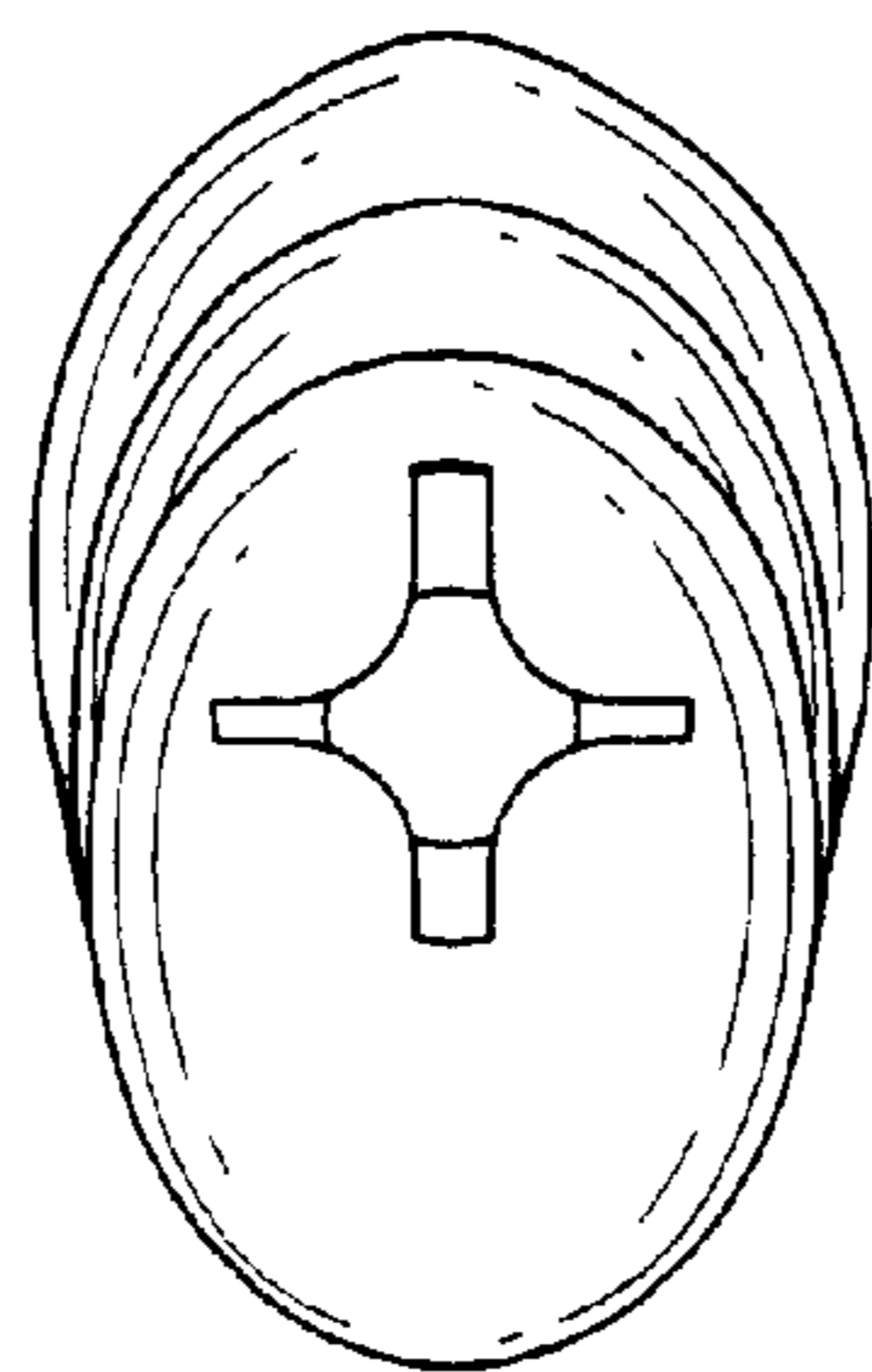

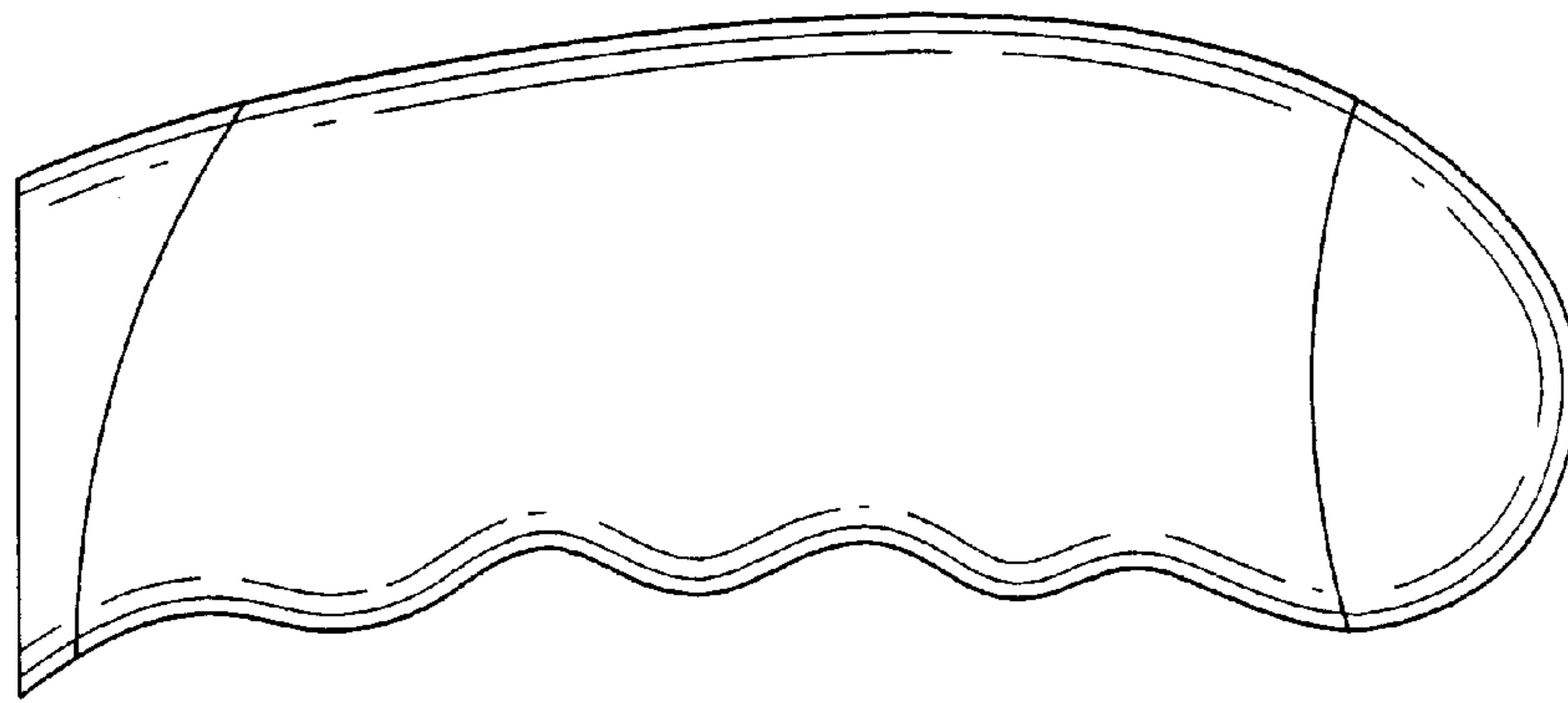

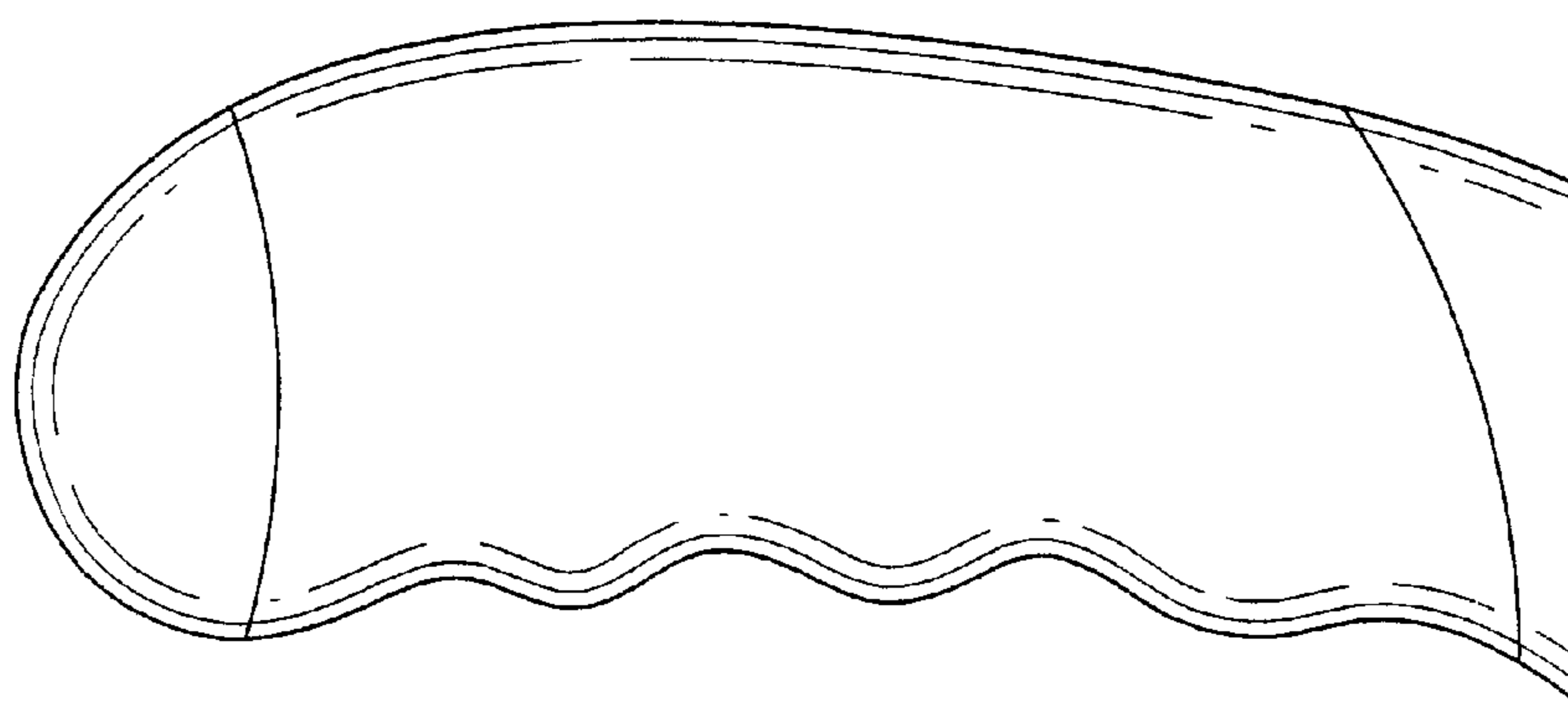

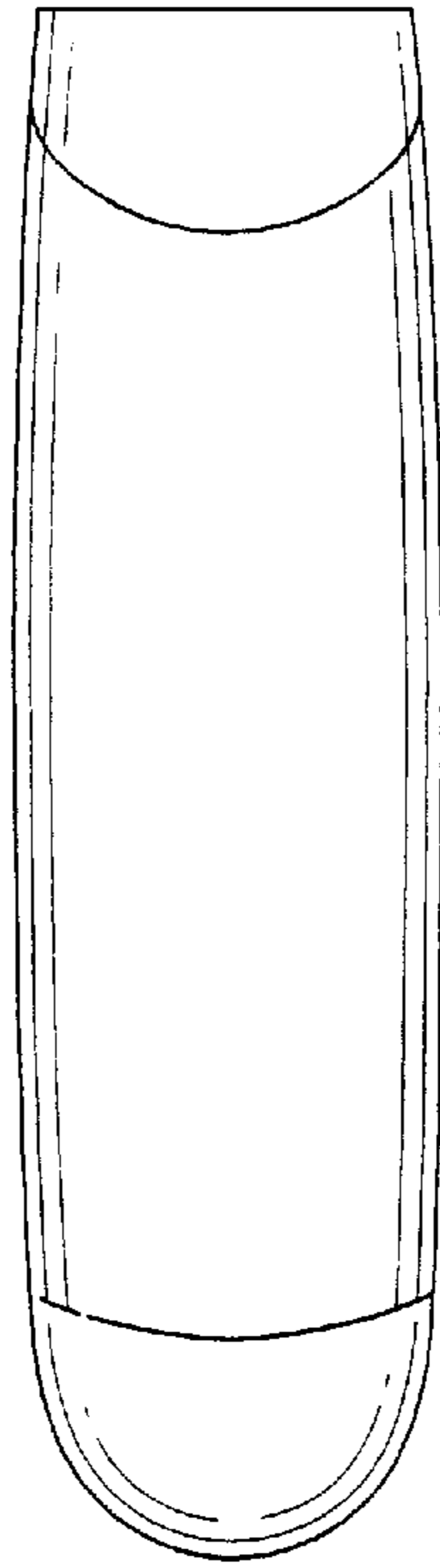

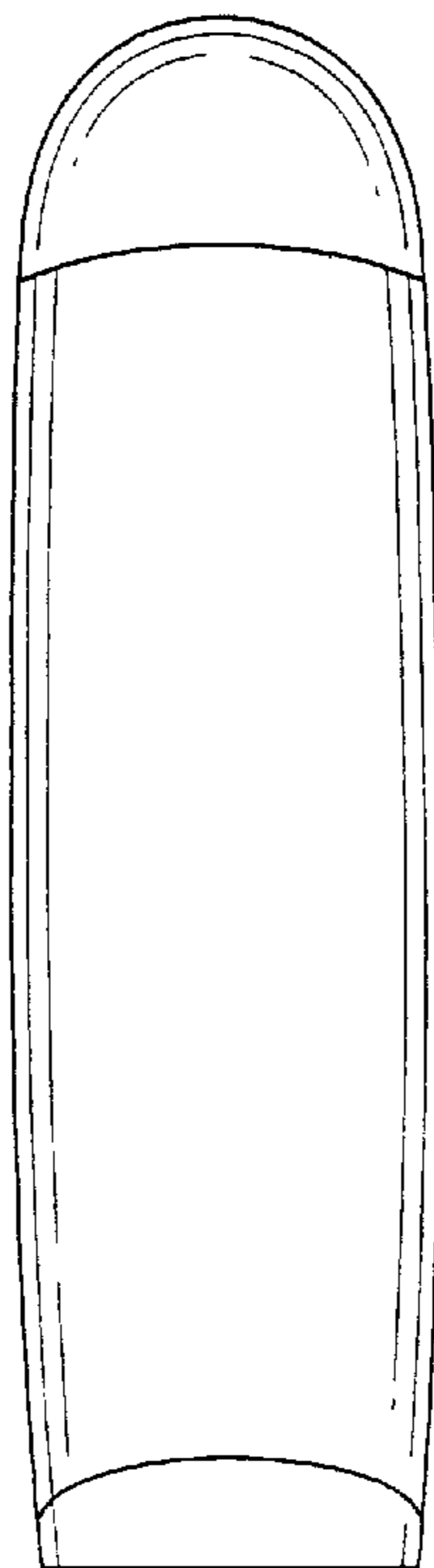

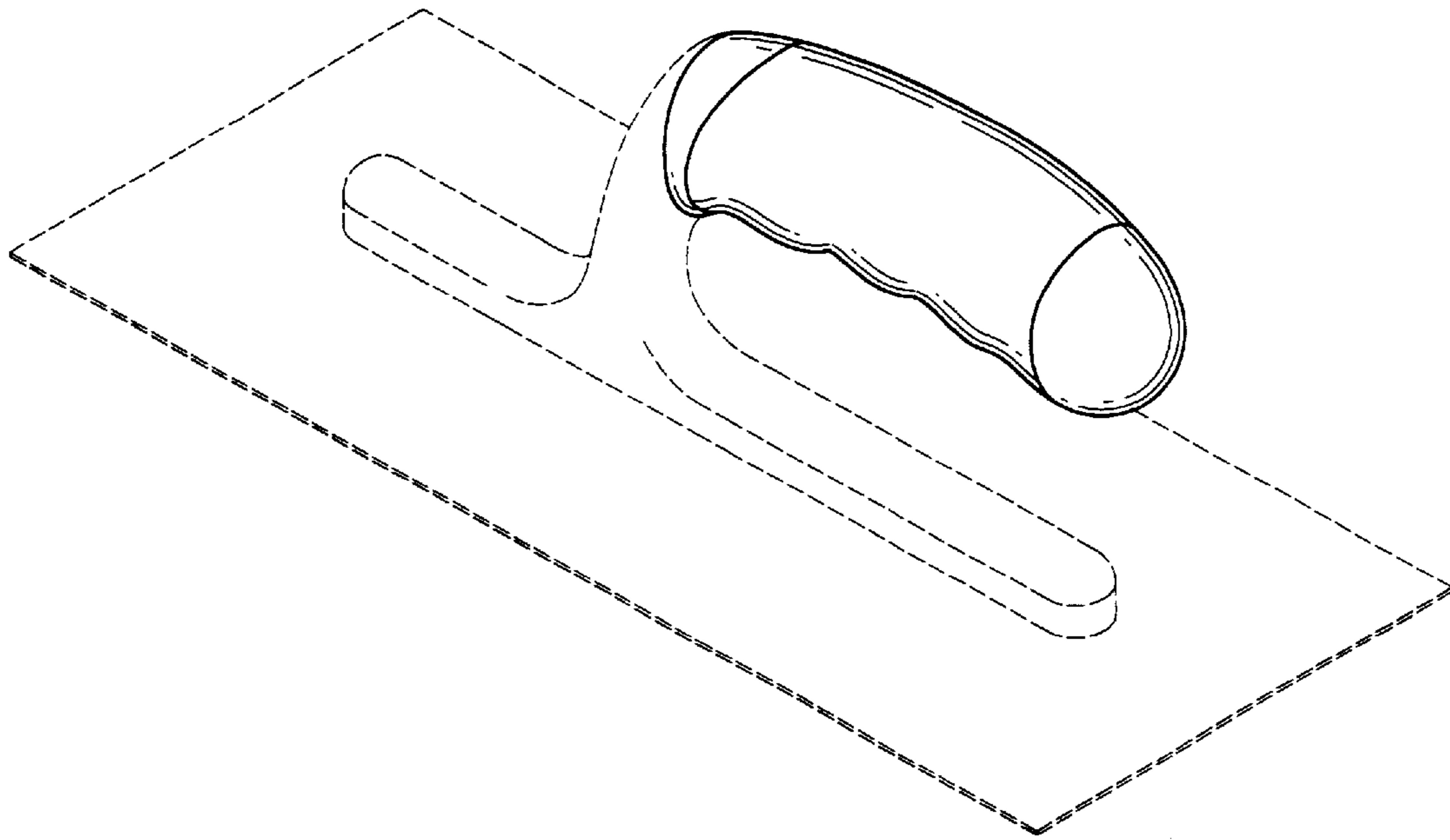
