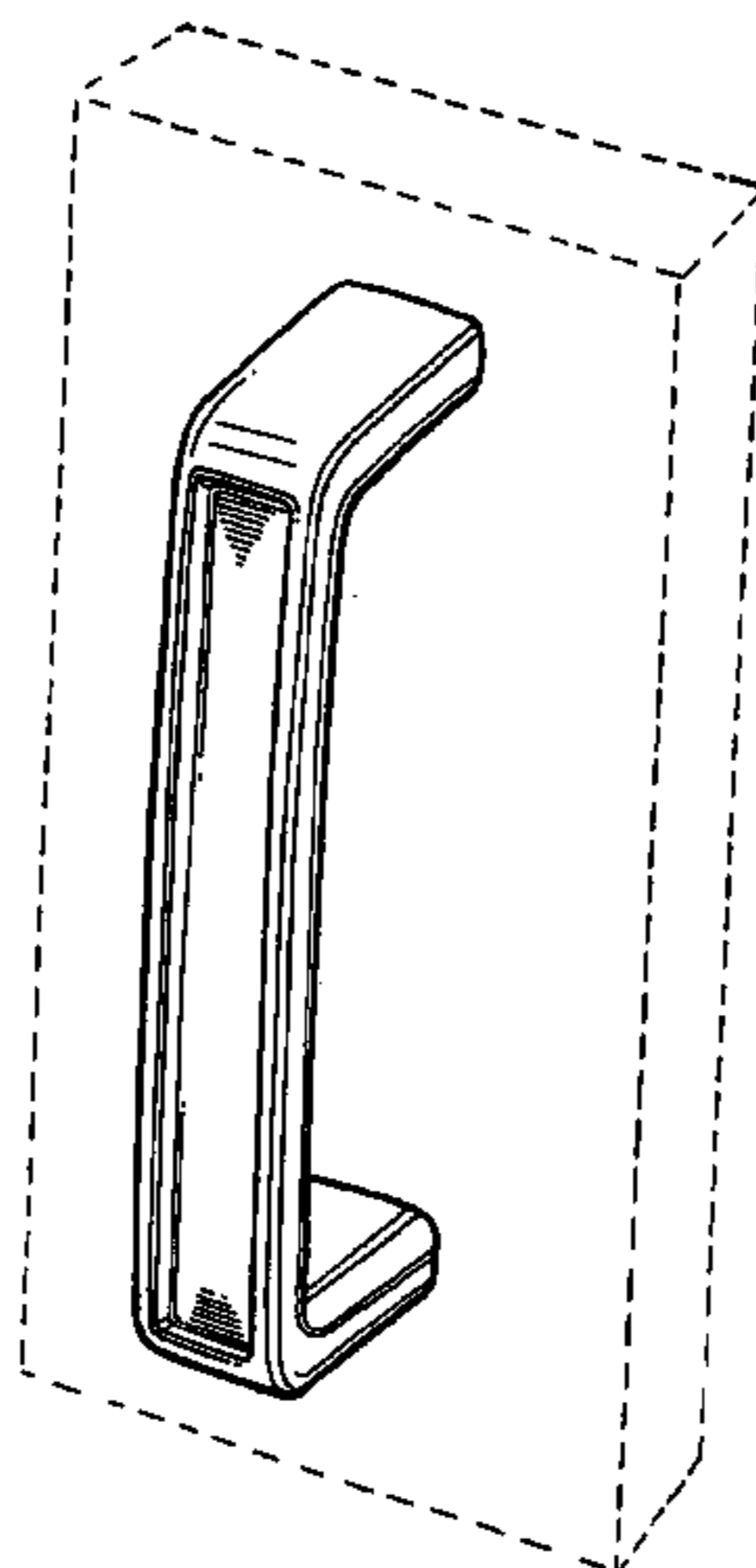
(57) **CLAIM**

The ornamental design for a handset grip, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the new design for a handset grip;
FIG. 2 is a front elevational view of the new design for a handset grip;
FIG. 3 is a top plan view of the new design for a handset grip, the bottom plan view being the mirror image;
FIG. 4 is a right side elevational view of the new design for a handset grip, the left side elevational view being a mirror image; and,
FIG. 5 is a back elevational view of the new design for a handset grip.
The broken lines in the Figures are for illustrative purposes only and form no part of the claimed design.

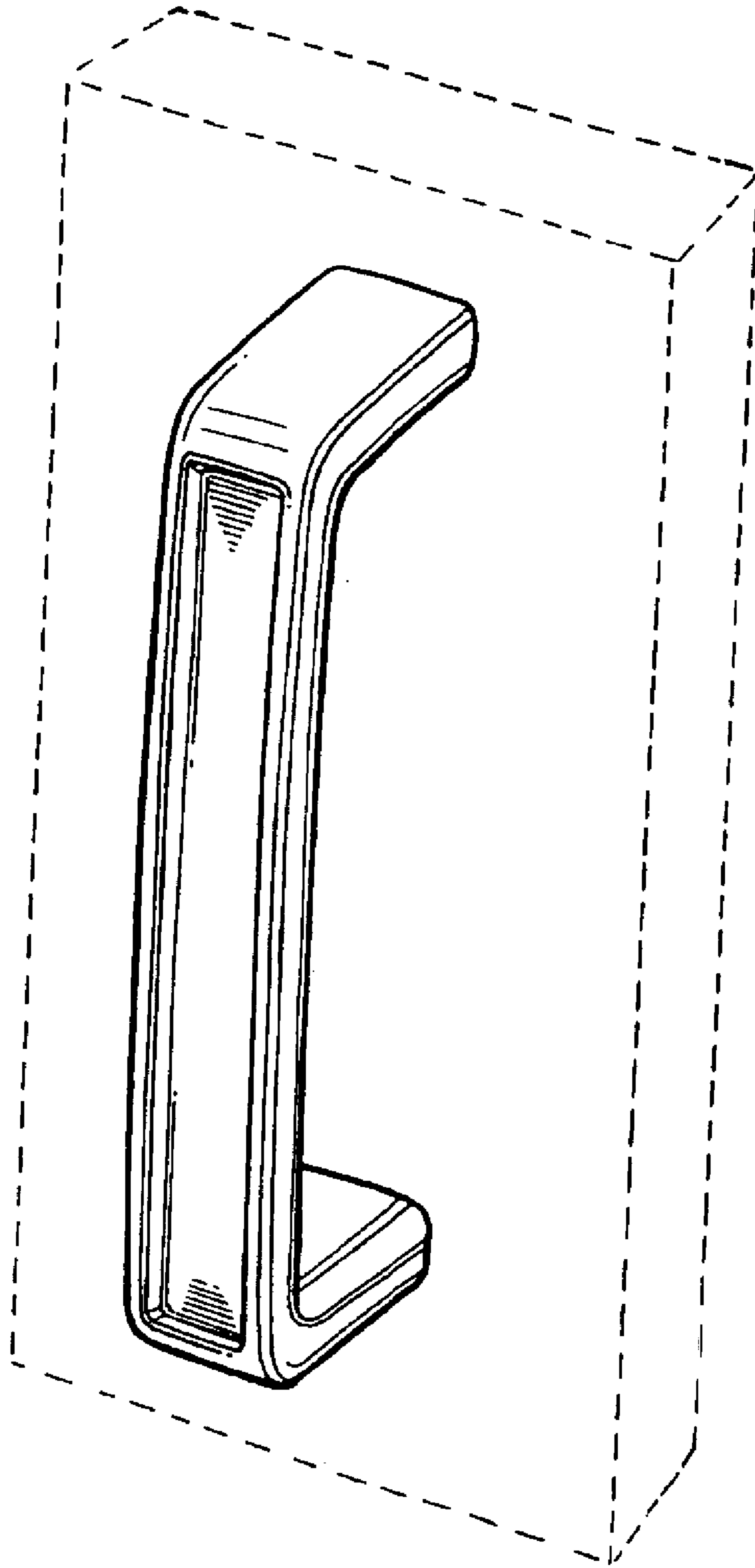

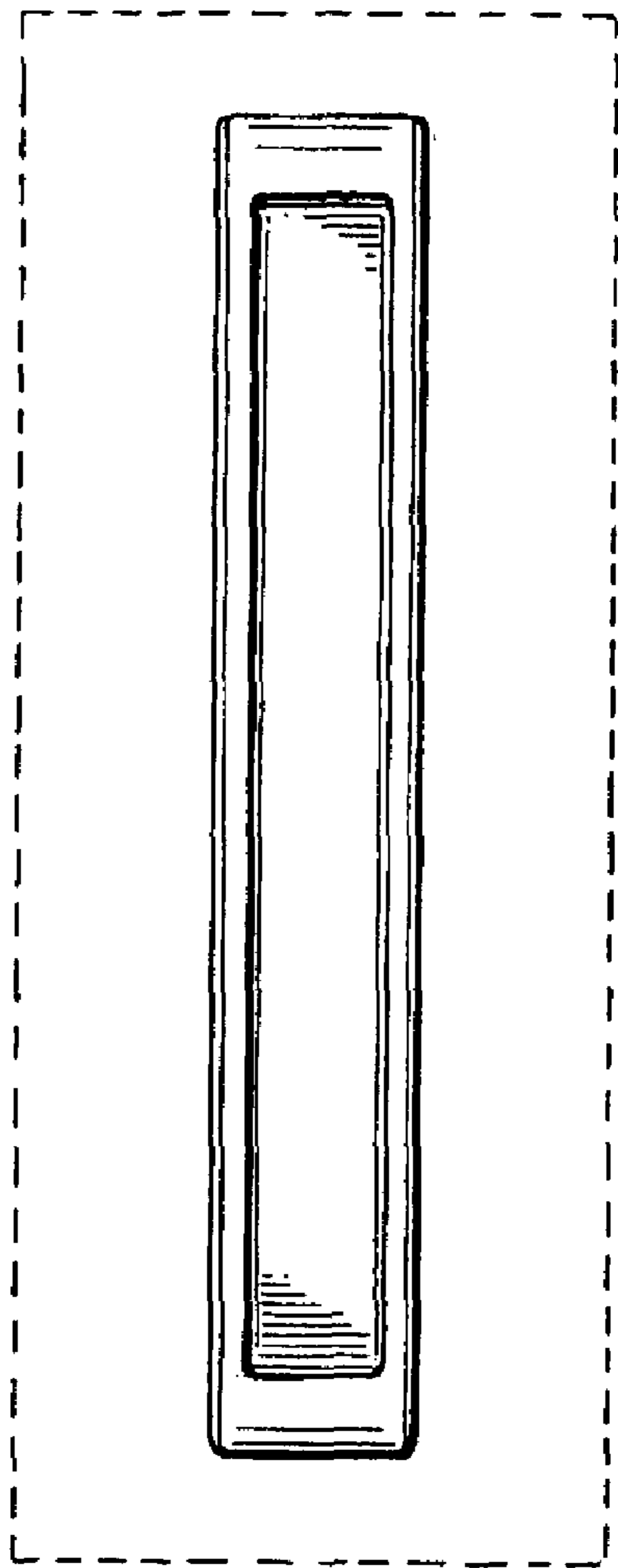

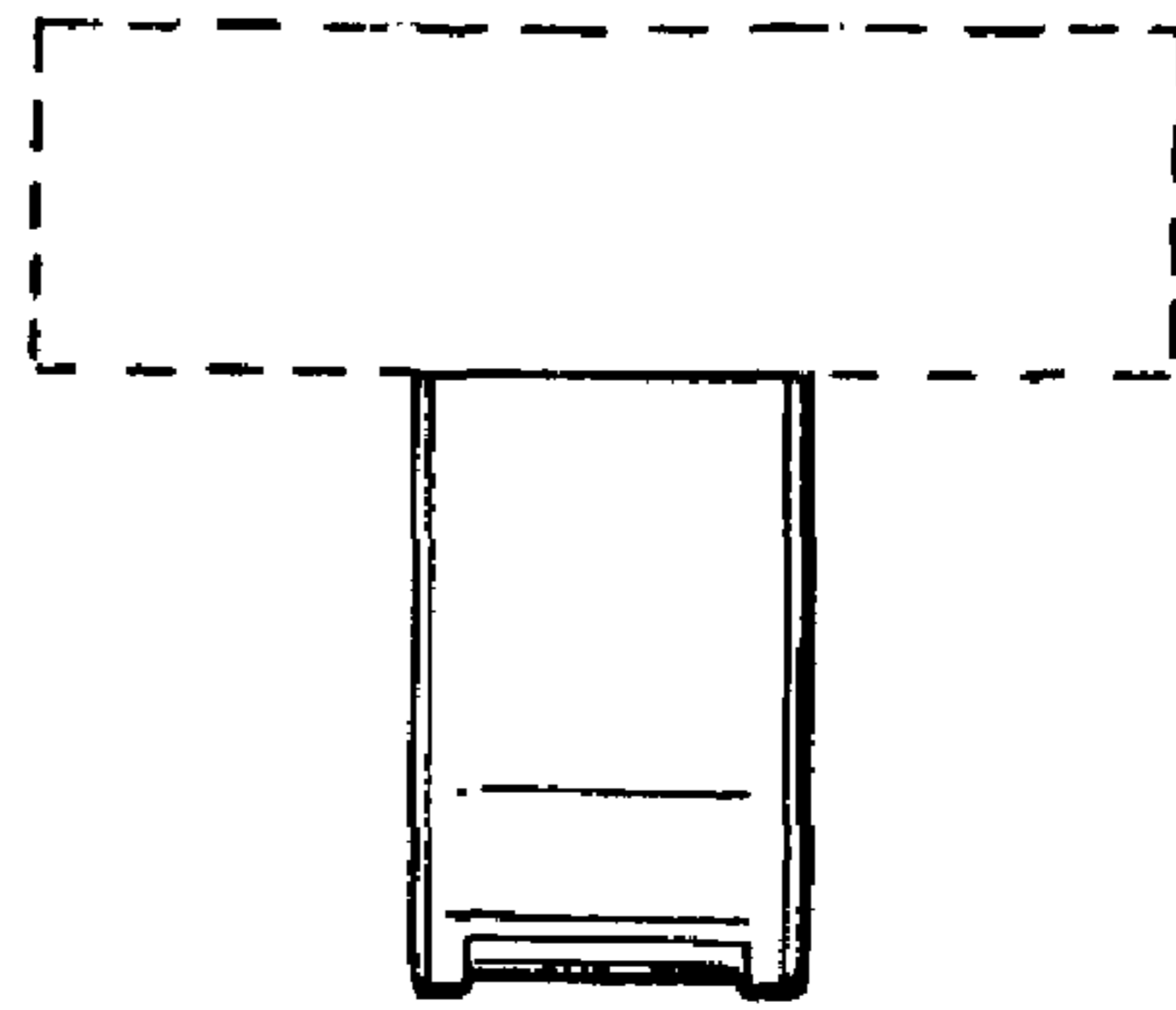

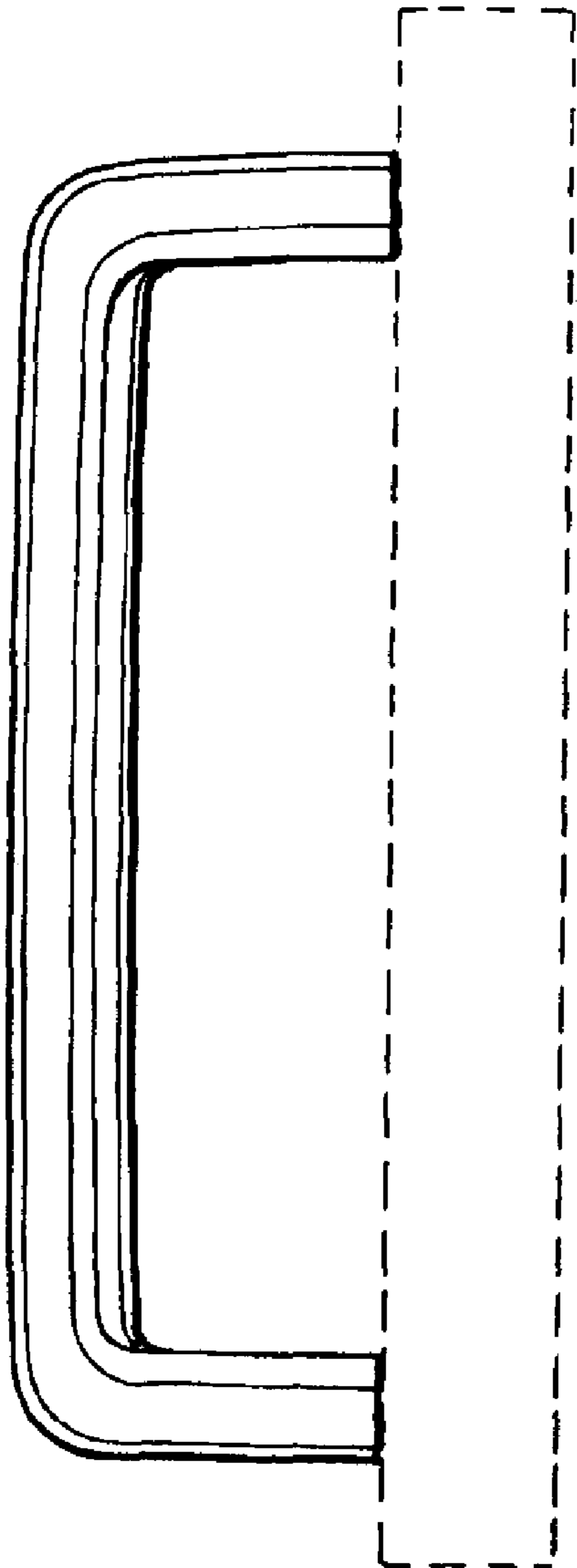

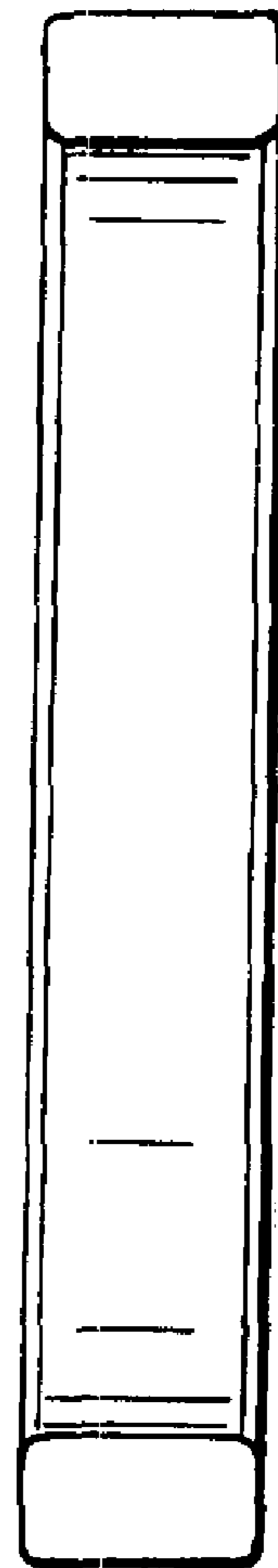
