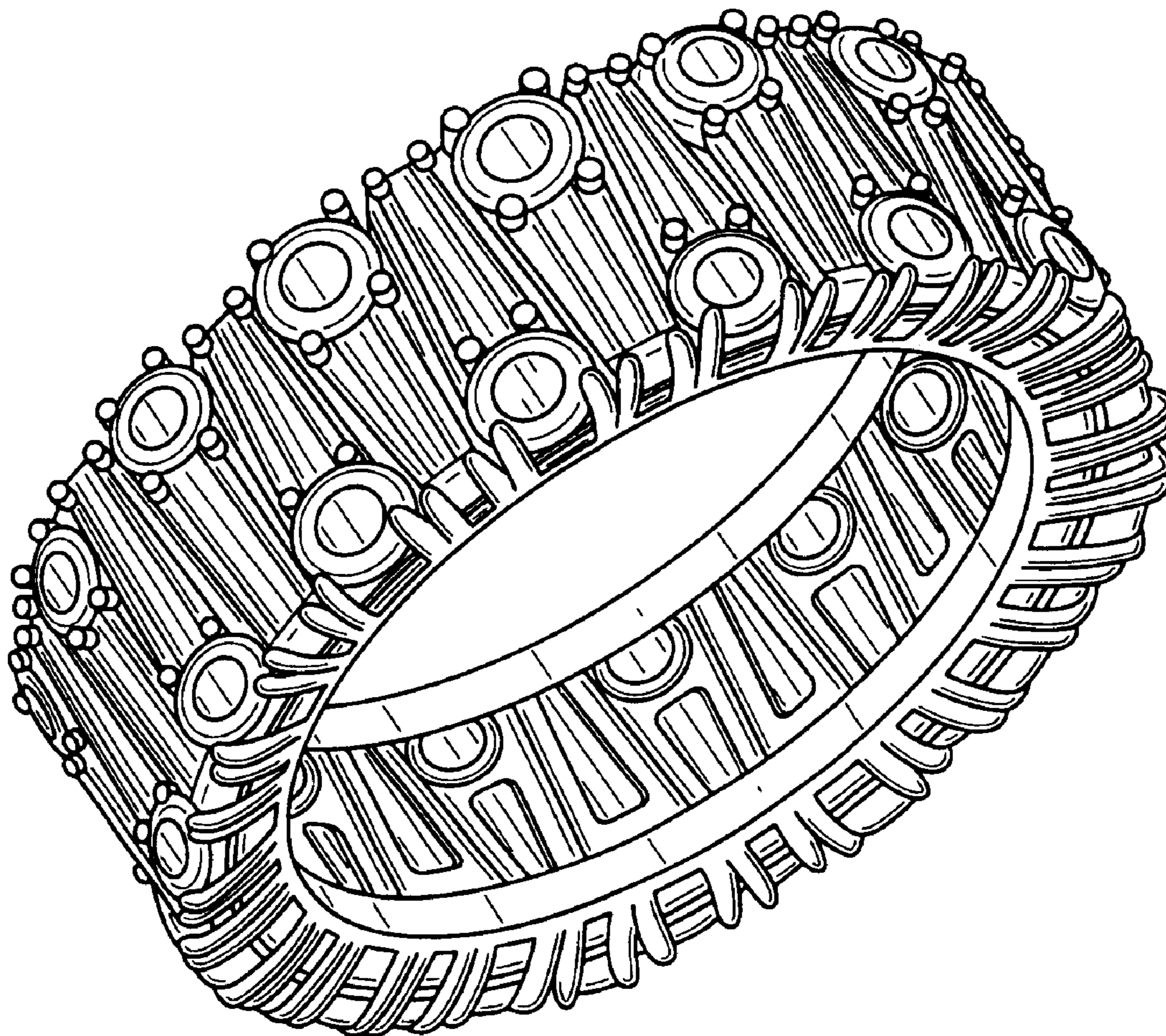
FIG. 1 is a perspective view of a ring in accordance with the present design;

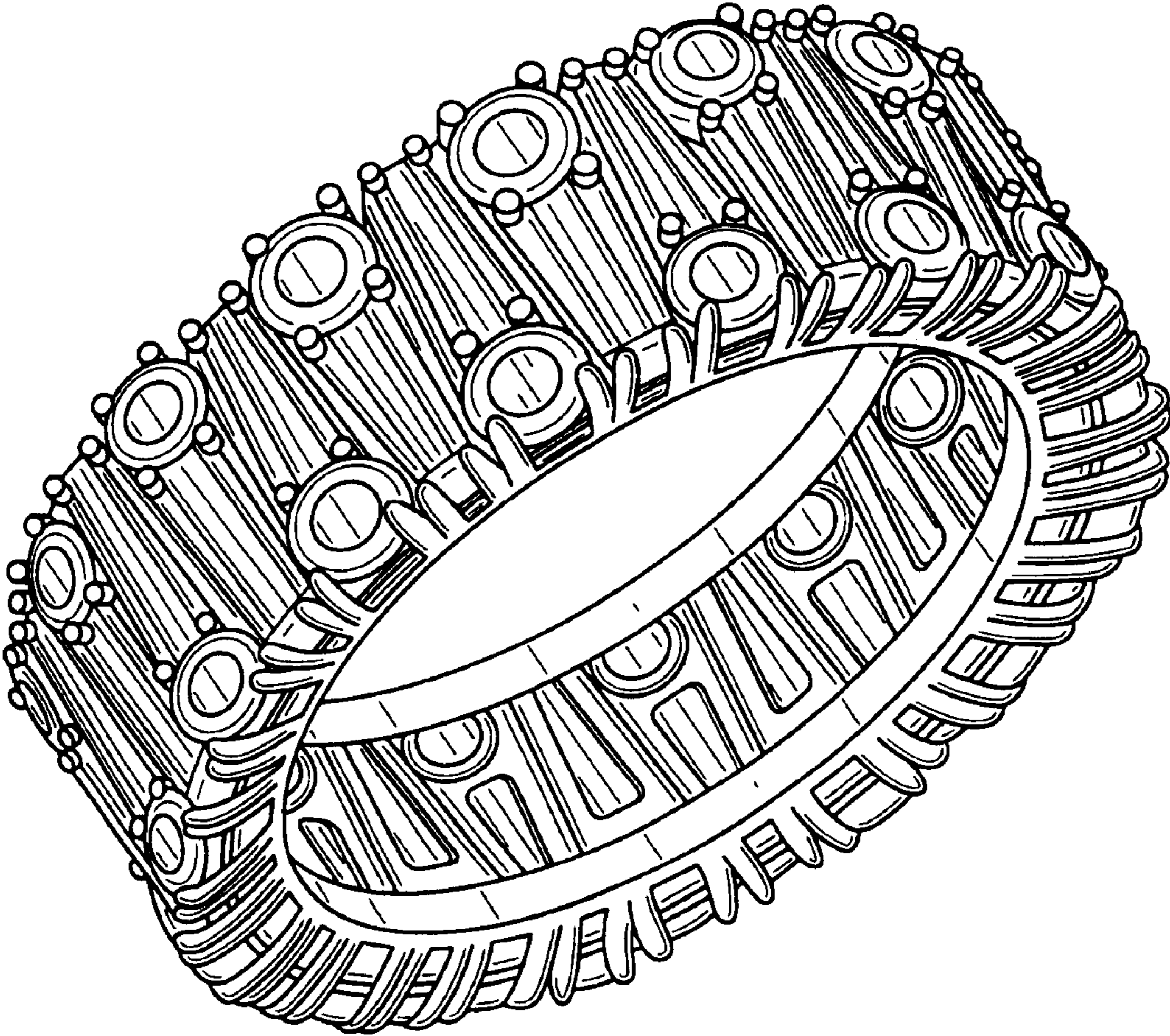

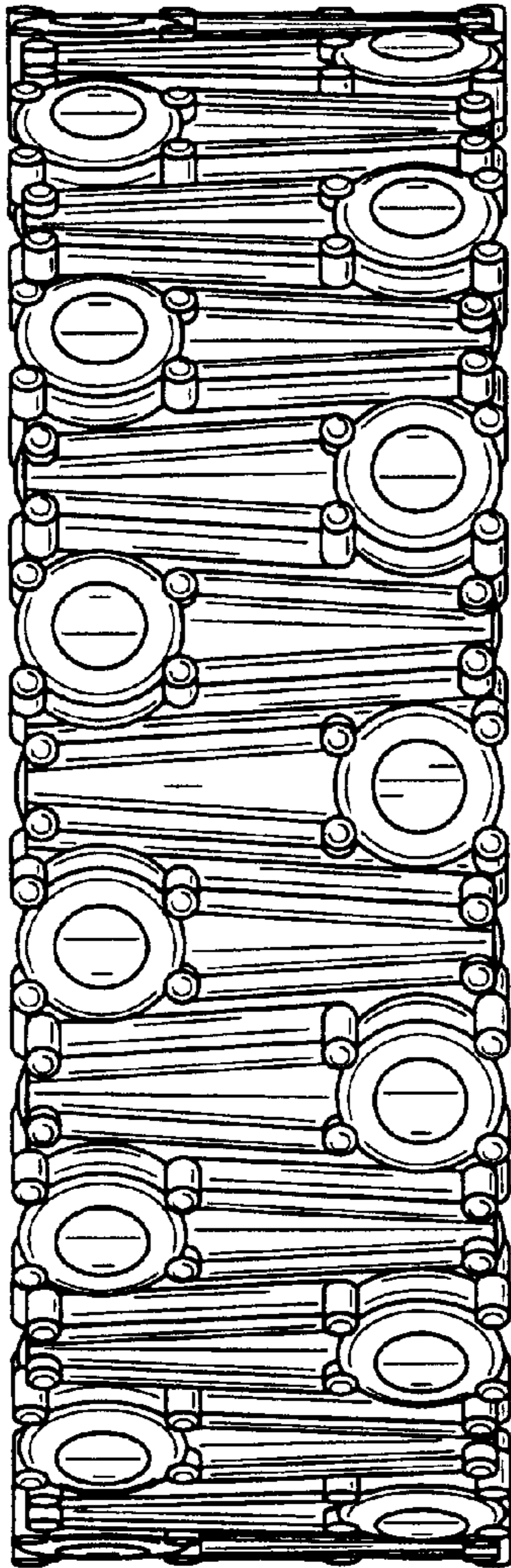

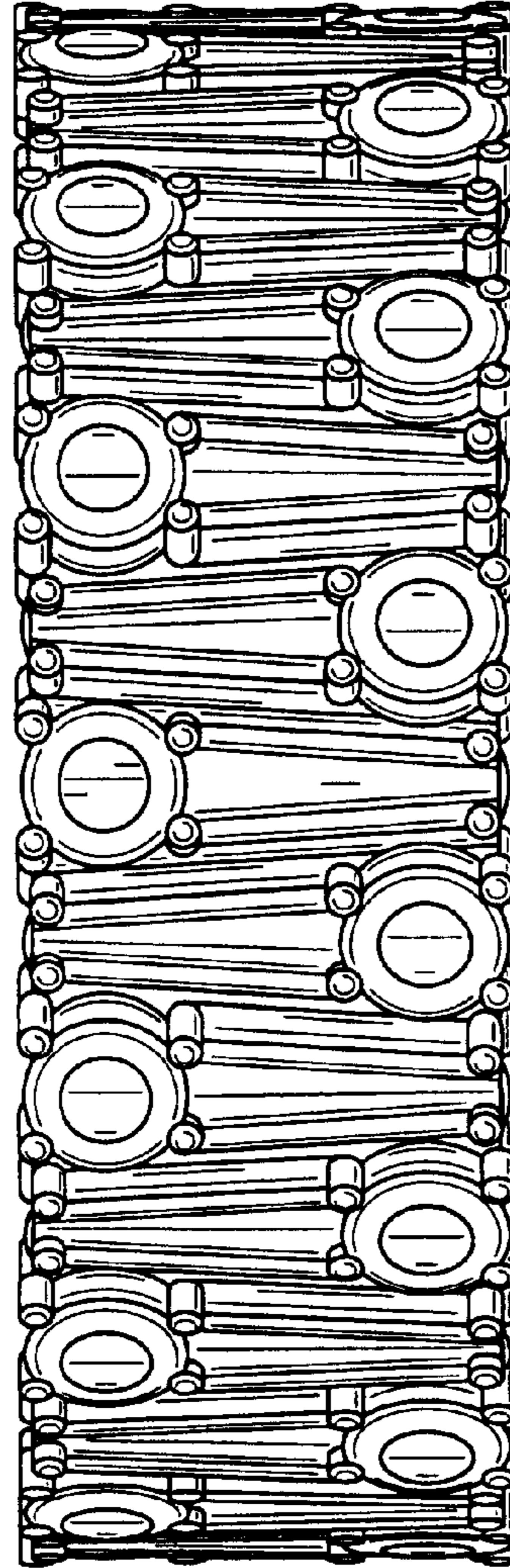

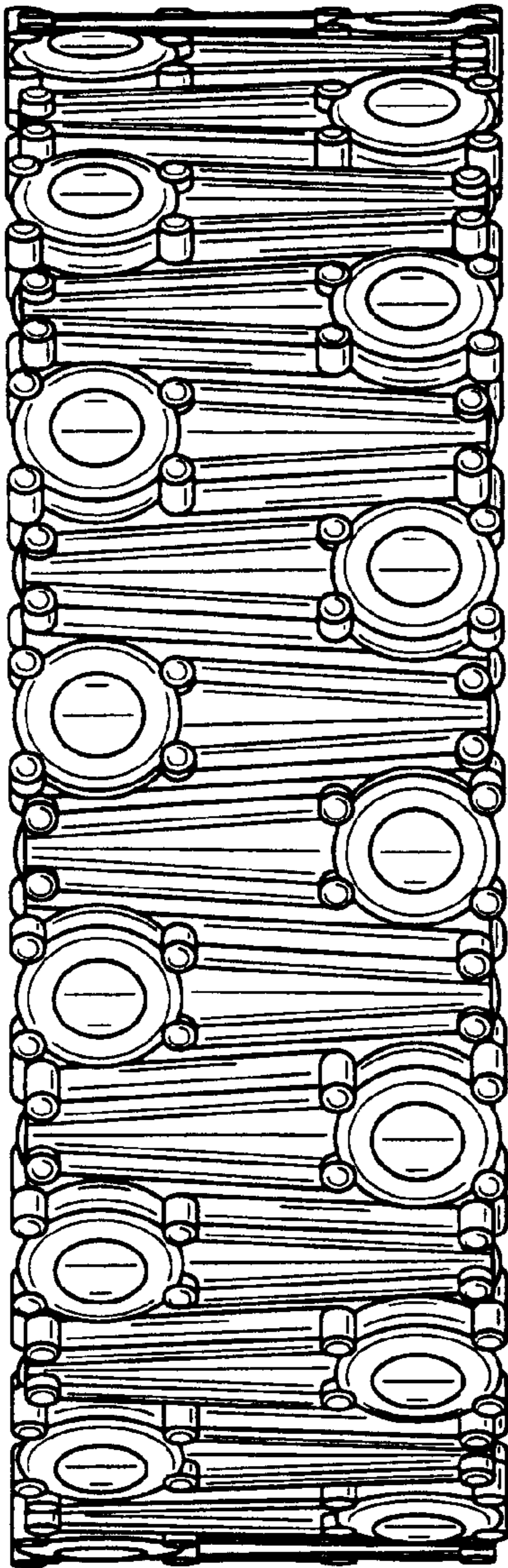

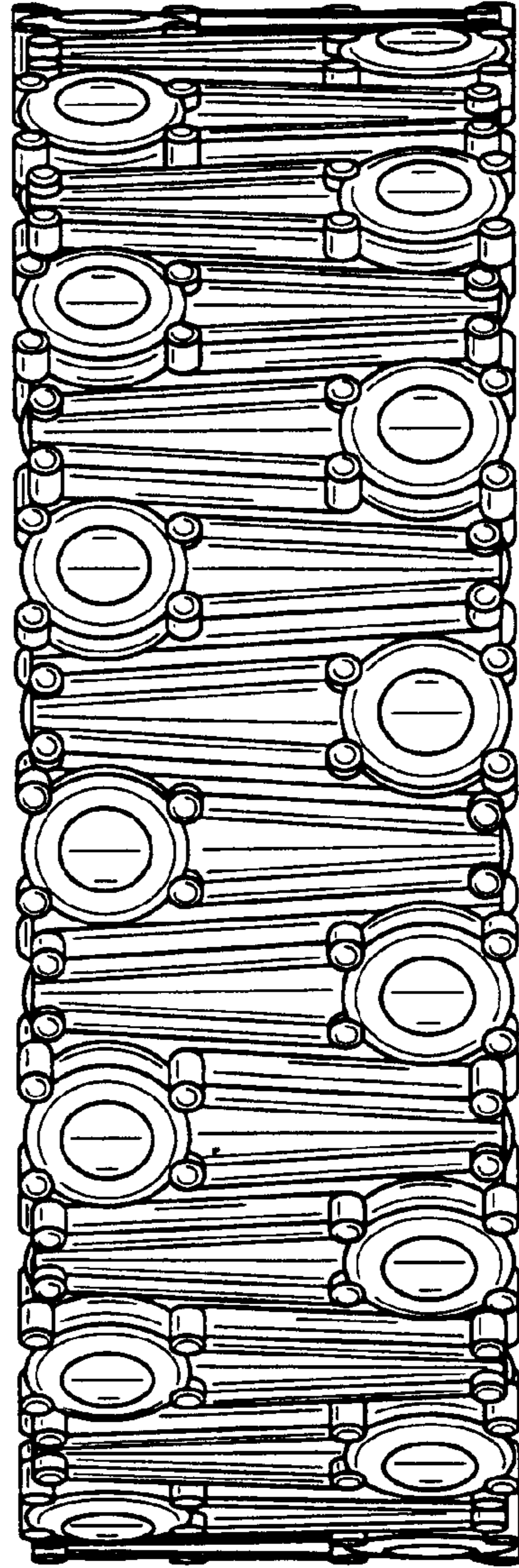

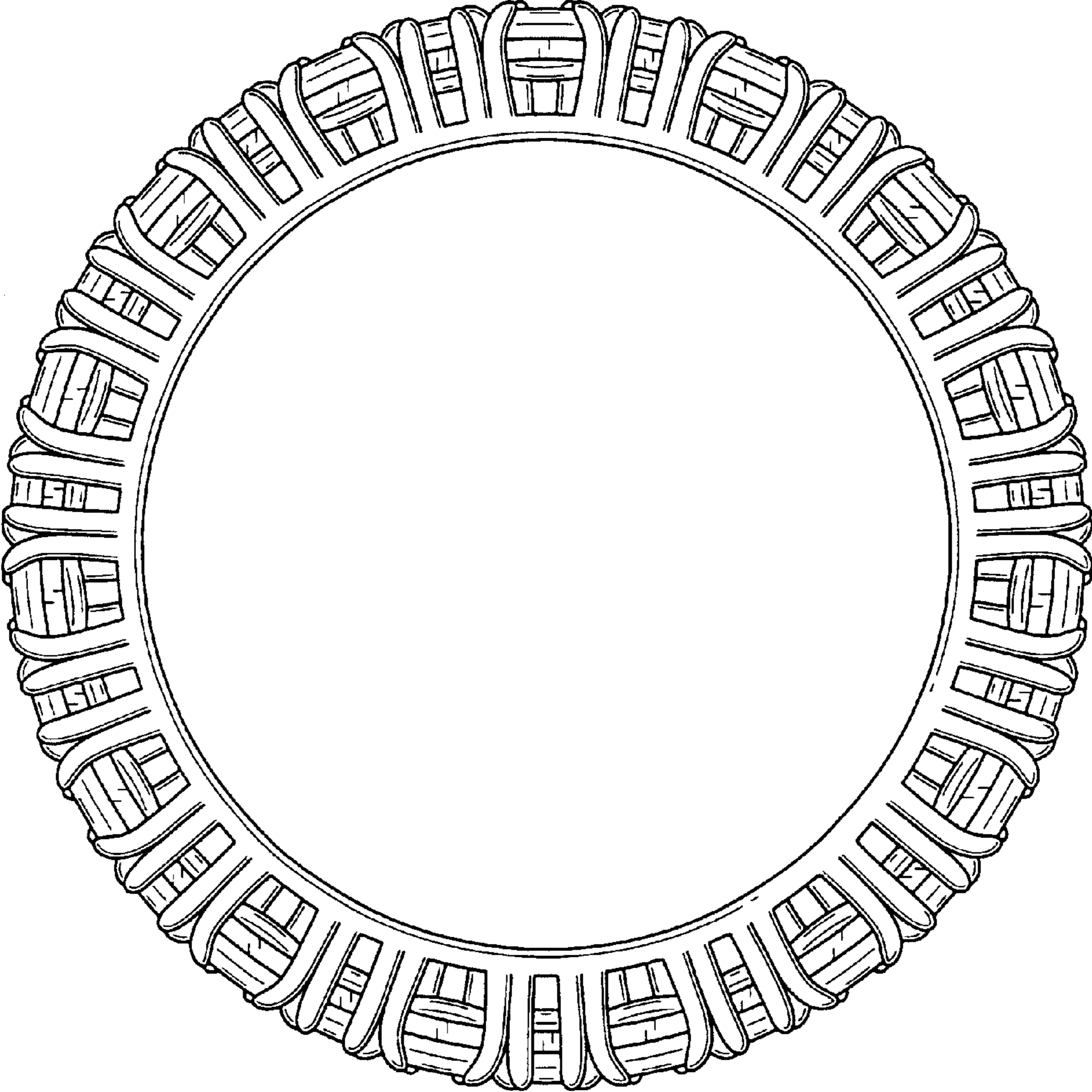

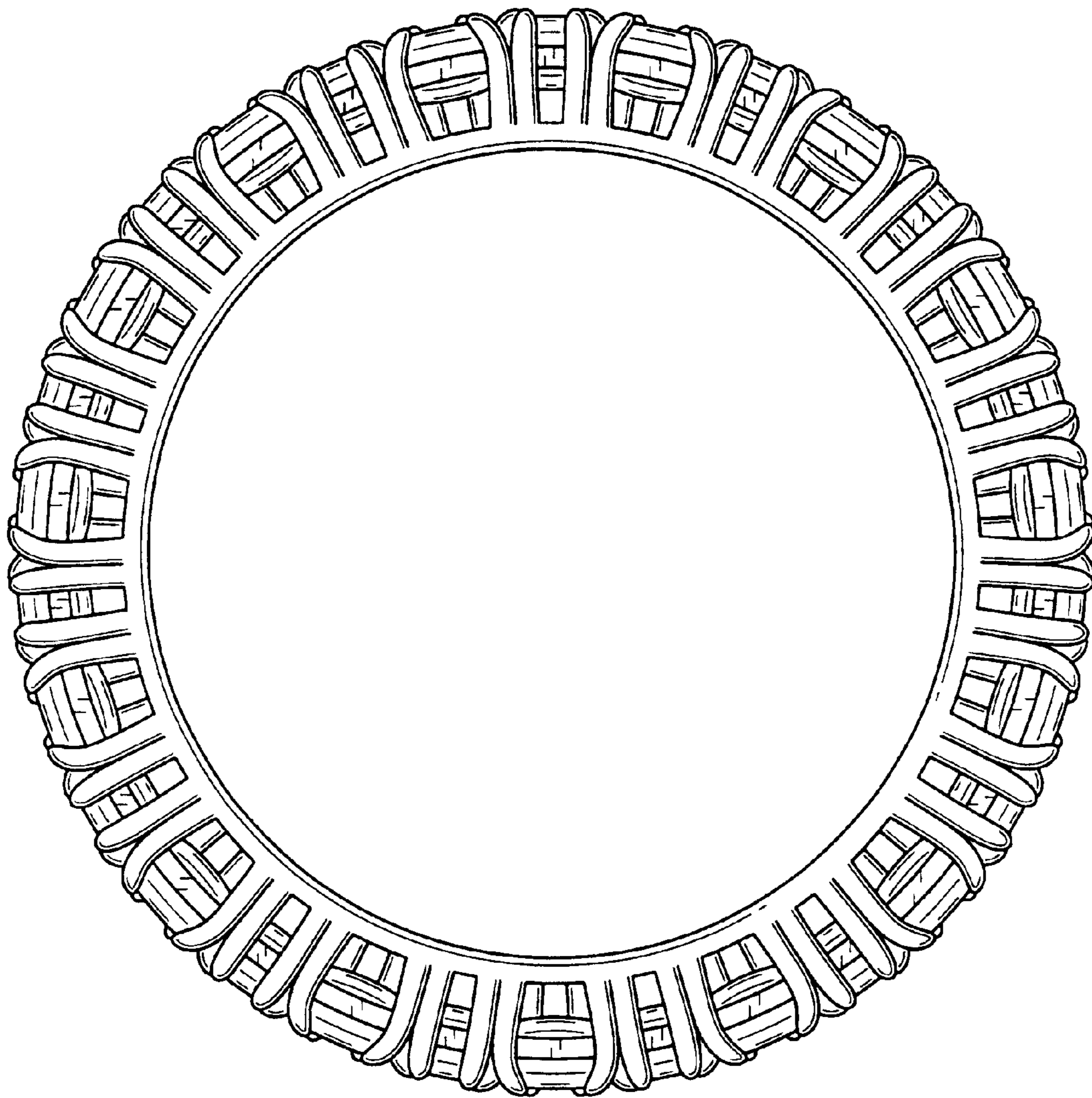
