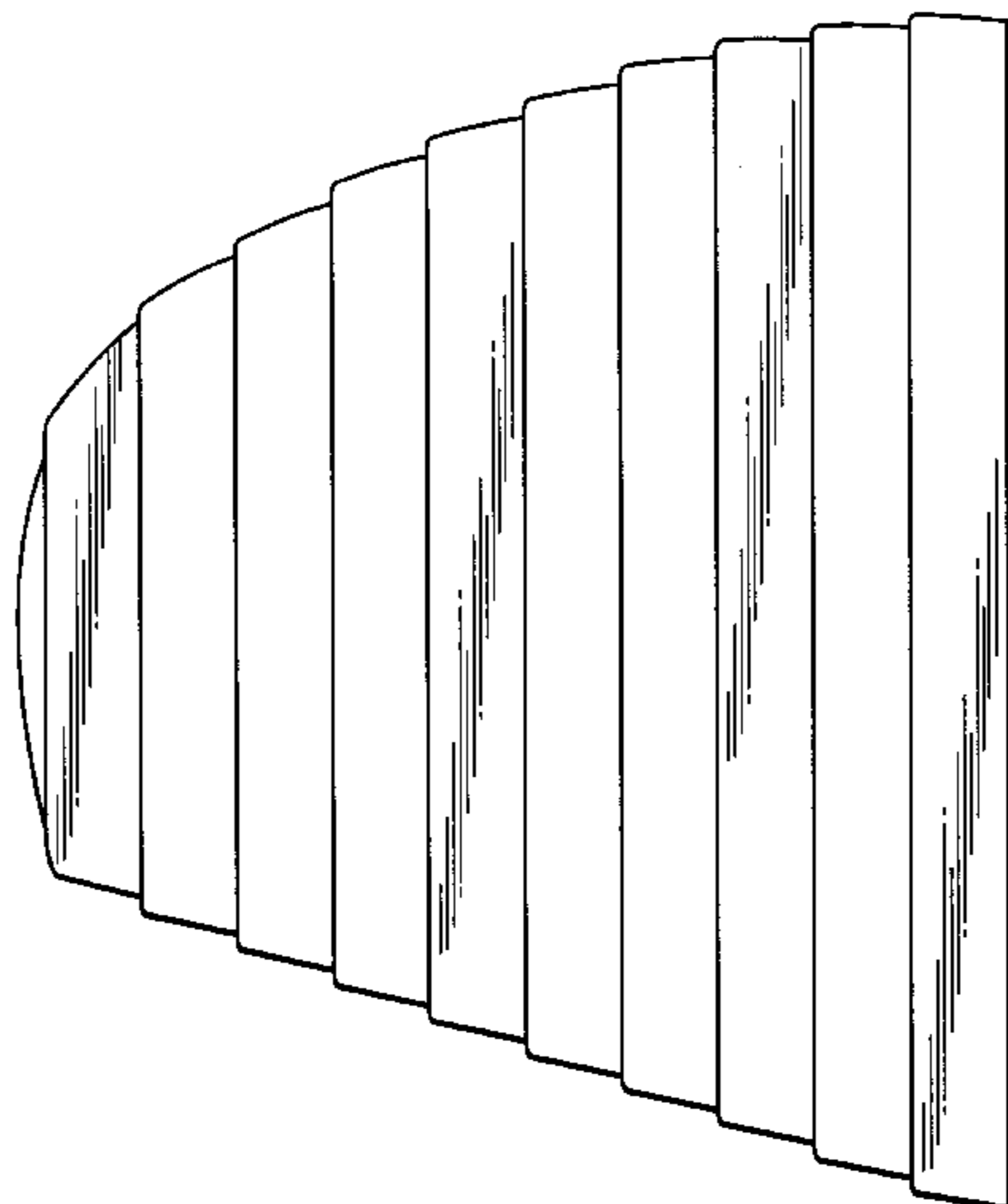
(57) **CLAIM**

The ornamental design for a decorative louver assembly for an automobile, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view illustrating the design for a decorative louver assembly for an automobile; FIG. 2 is a top plan view thereof; FIG. 3 is a left elevation view thereof; FIG. 4 is an upper elevation view thereof; FIG. 5 is a right elevation view thereof; FIG. 6 is a lower elevation view thereof; and, FIG. 7 is a bottom plan view thereof.

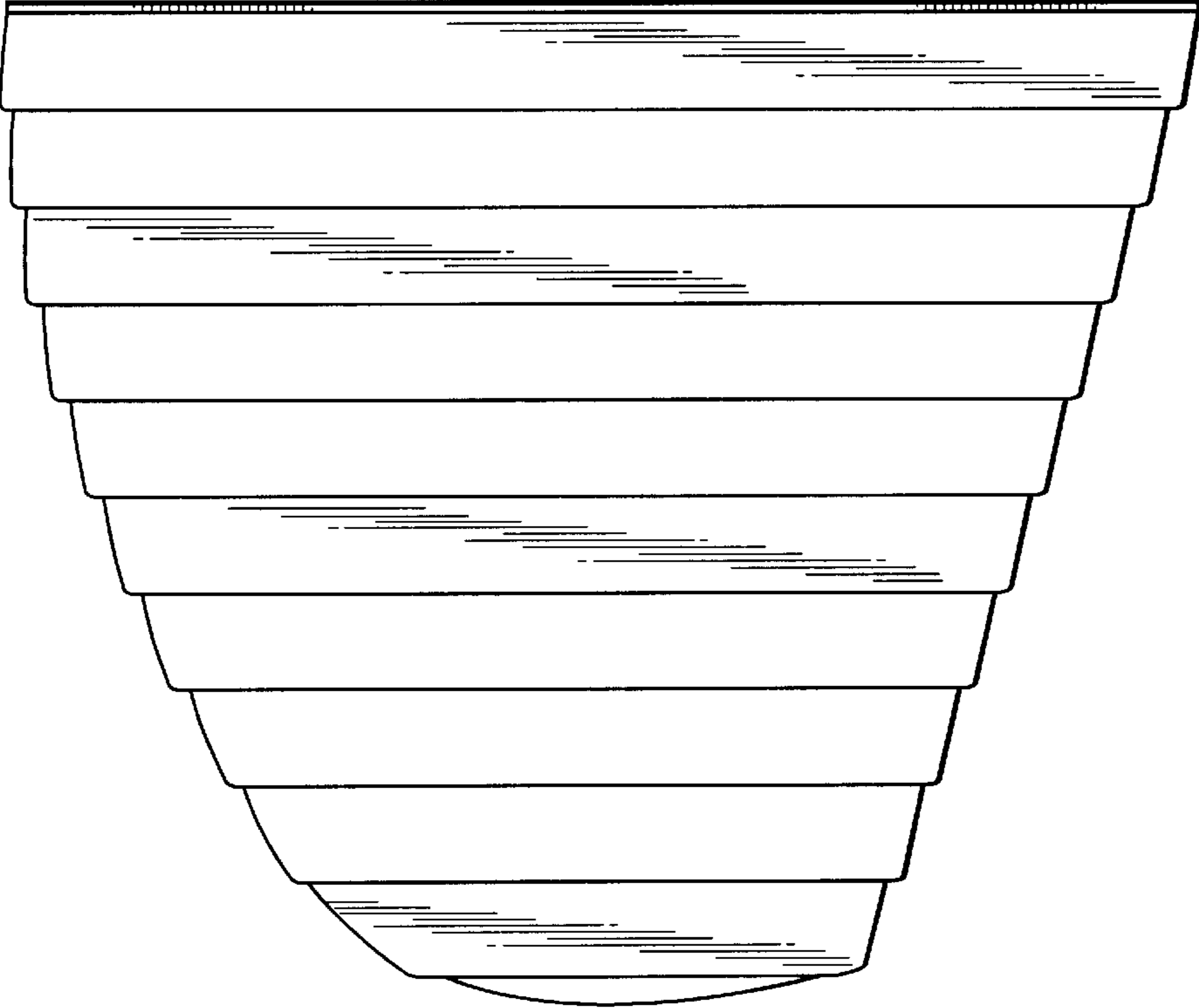

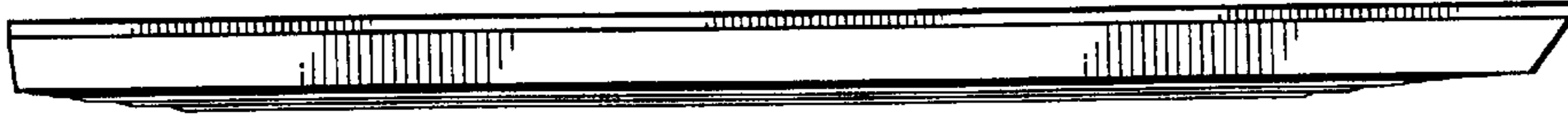

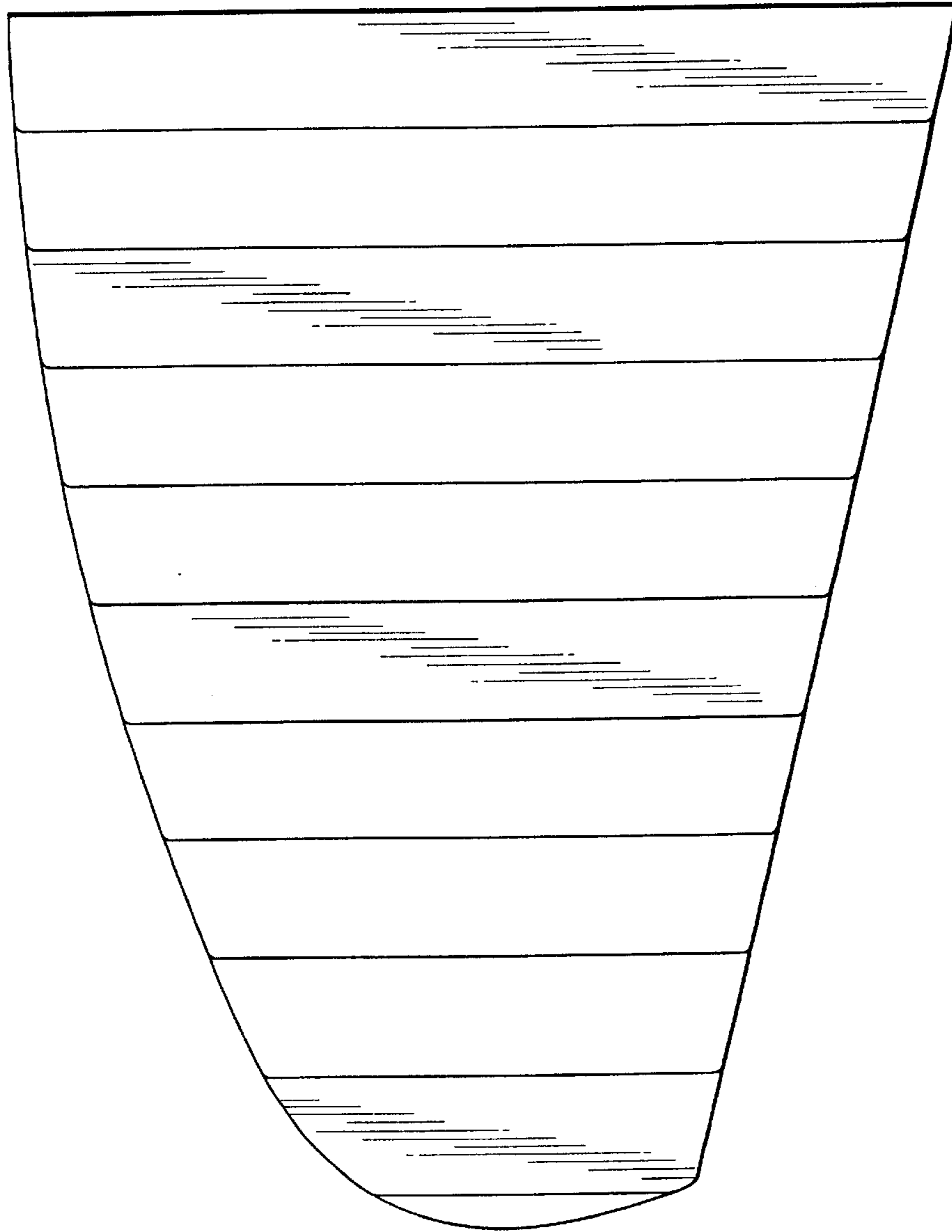

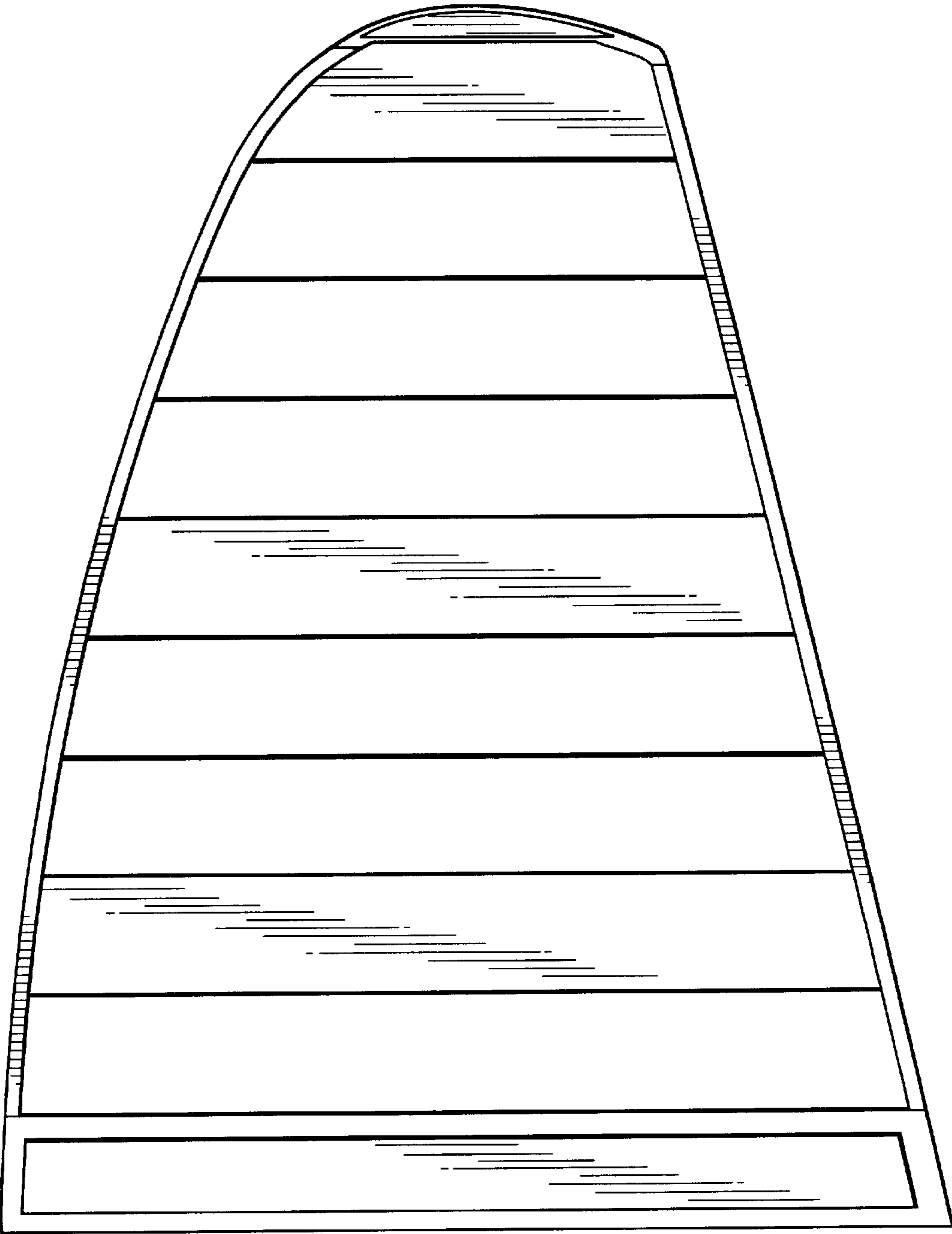
