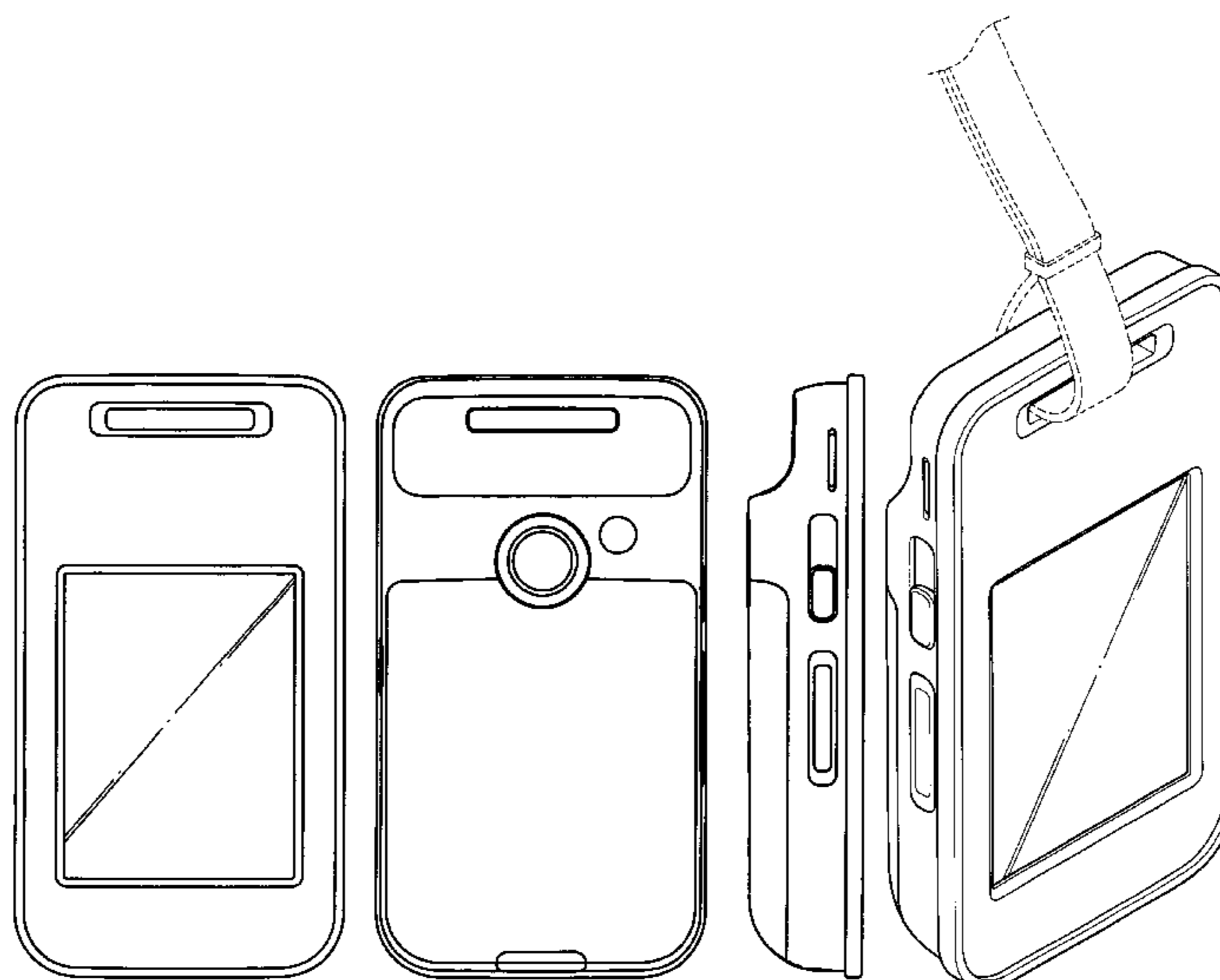
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the mobile phone showing our design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a perspective view thereof with strap attachment. The broken line showing of a strap in FIG. 8 is included for illustrative purposes only and forms no part of the claimed design.

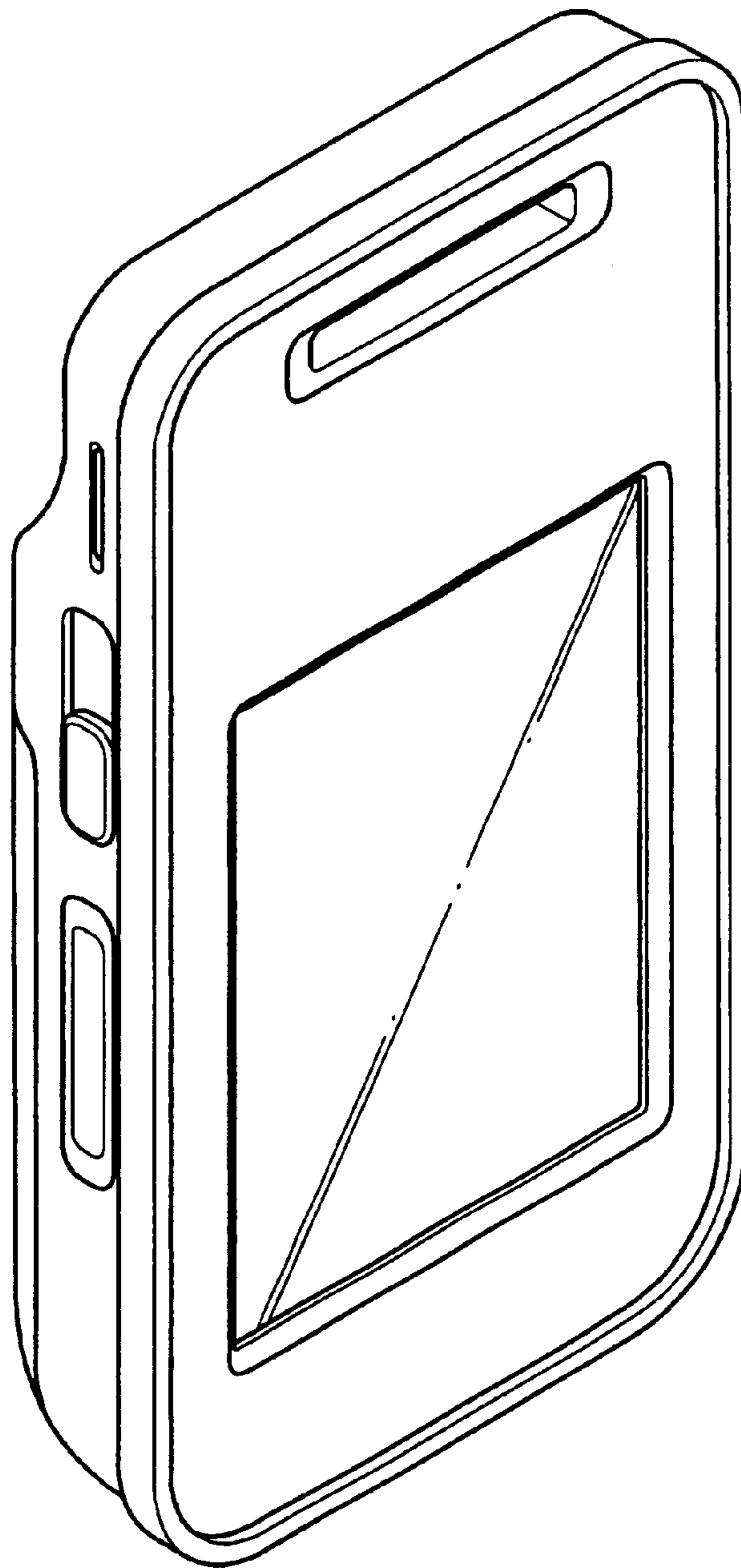

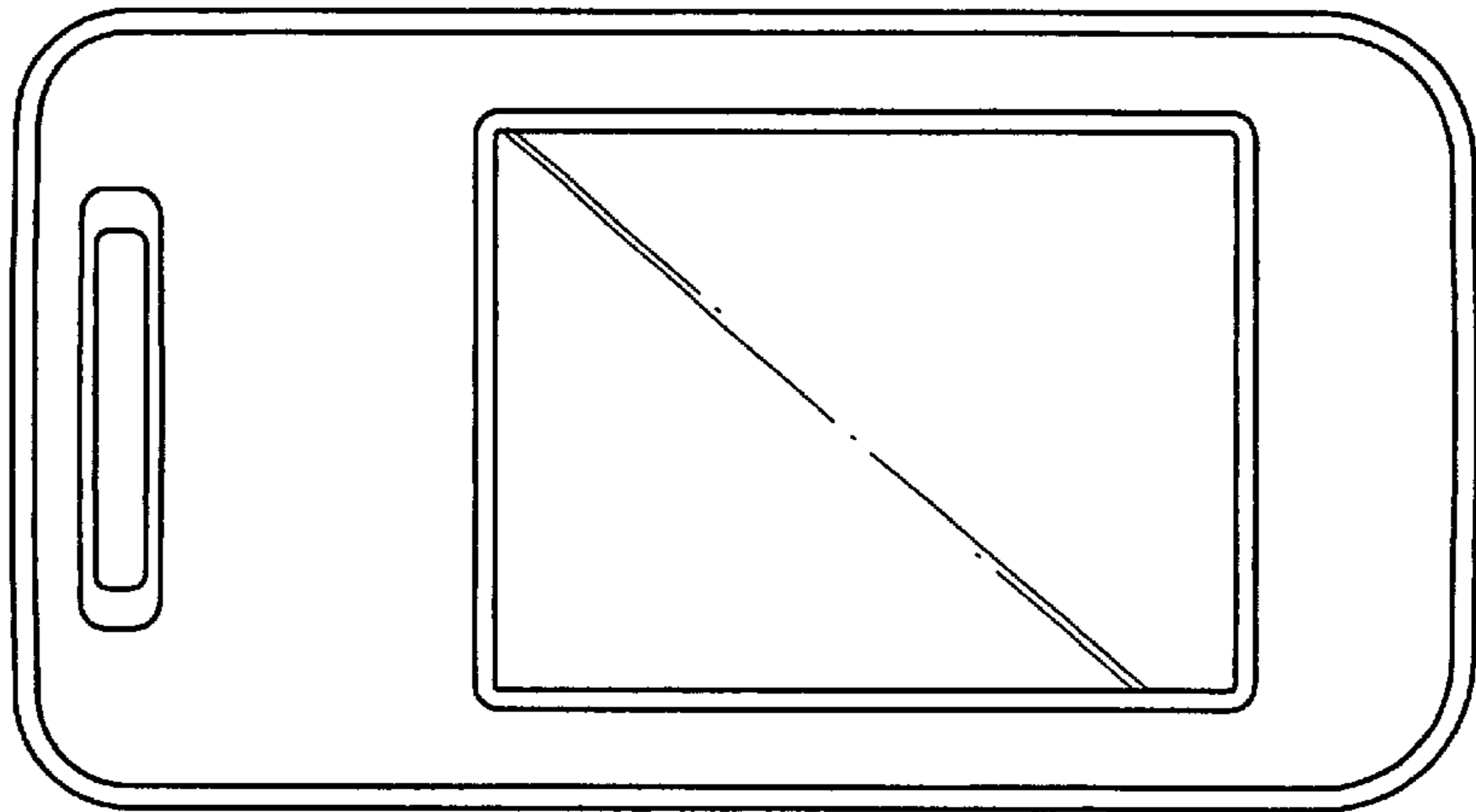

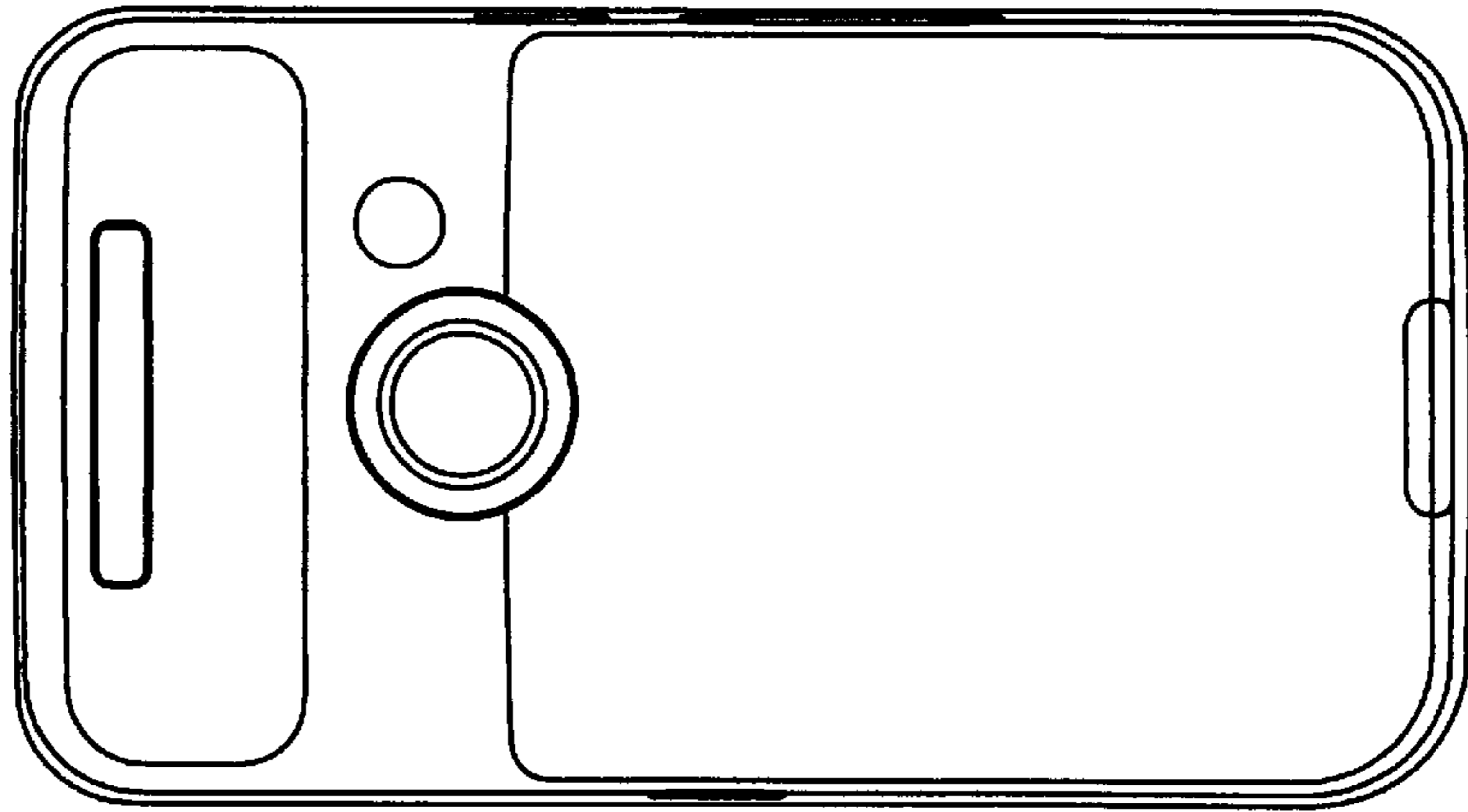

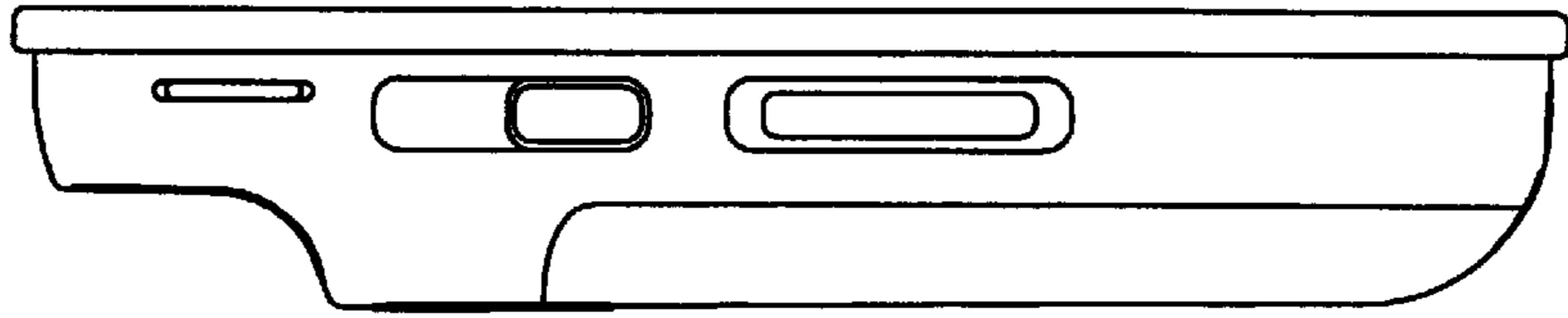

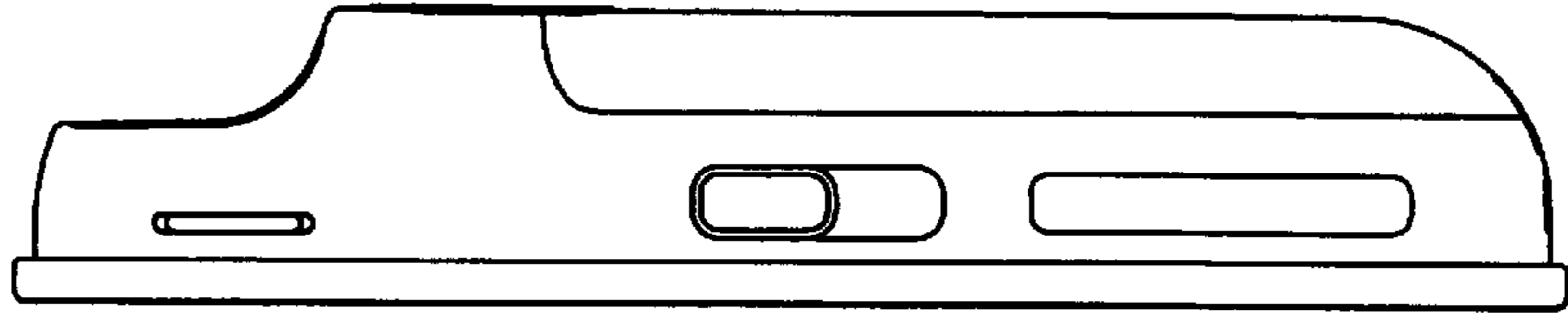

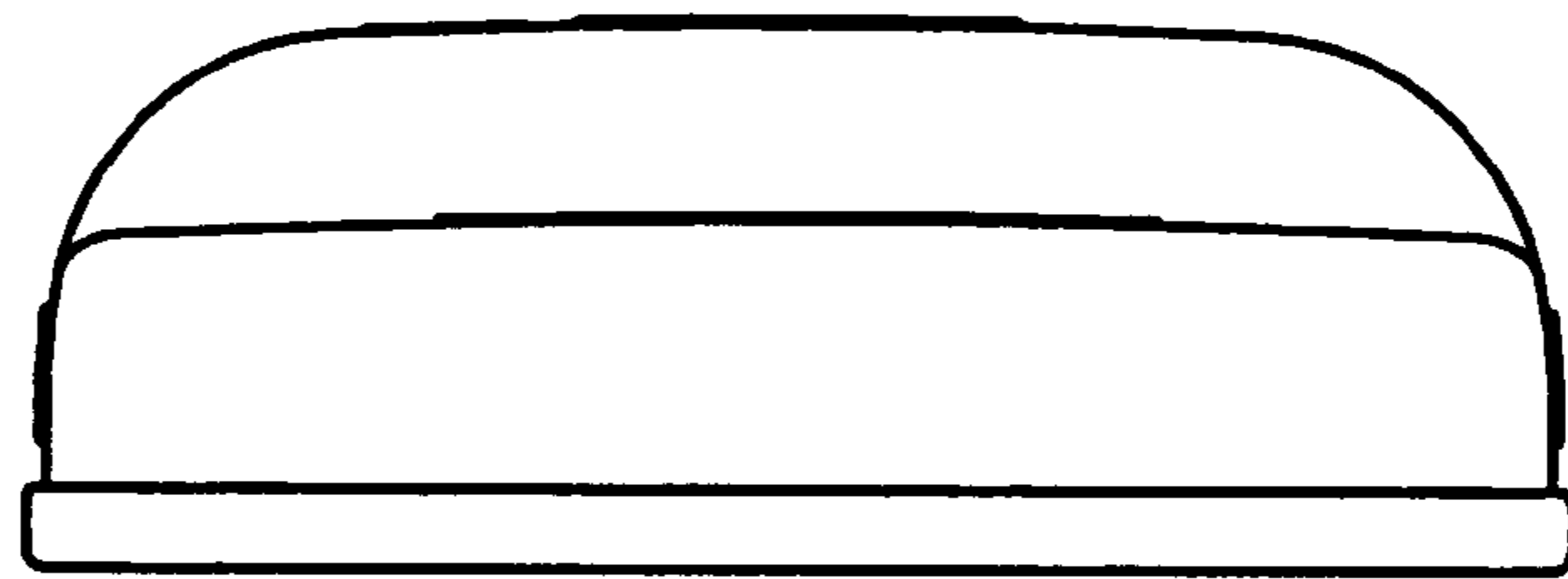

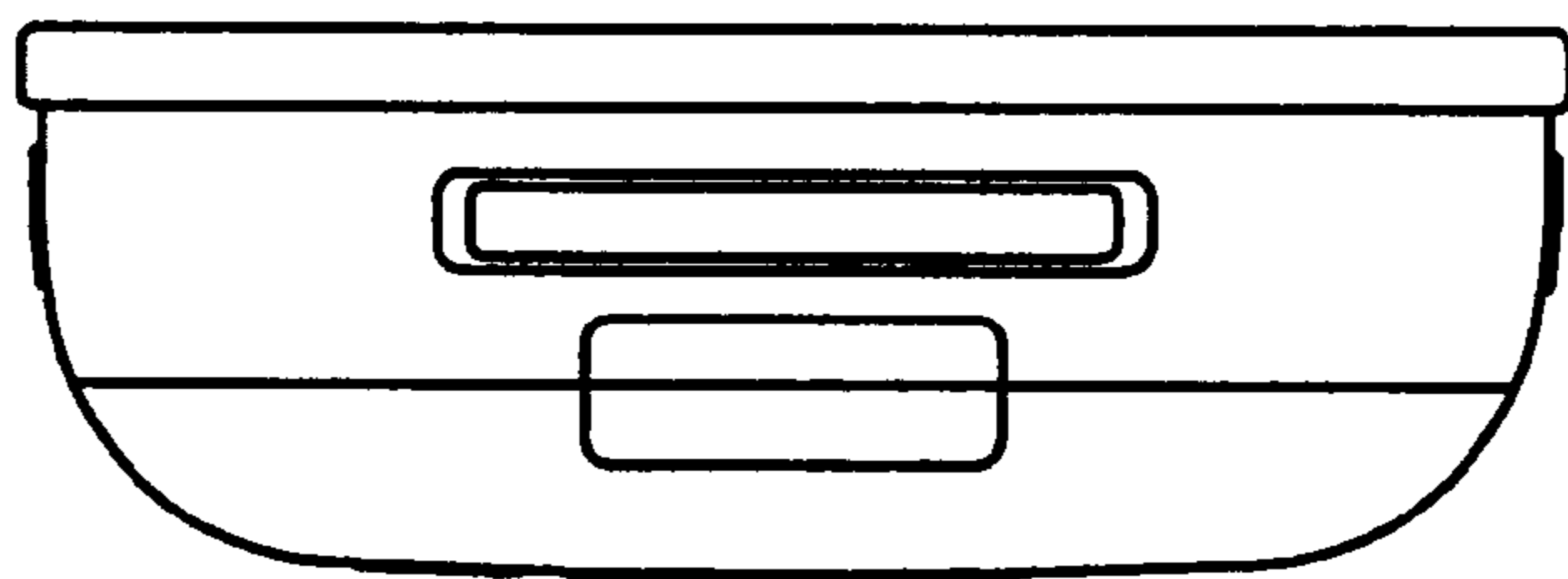
