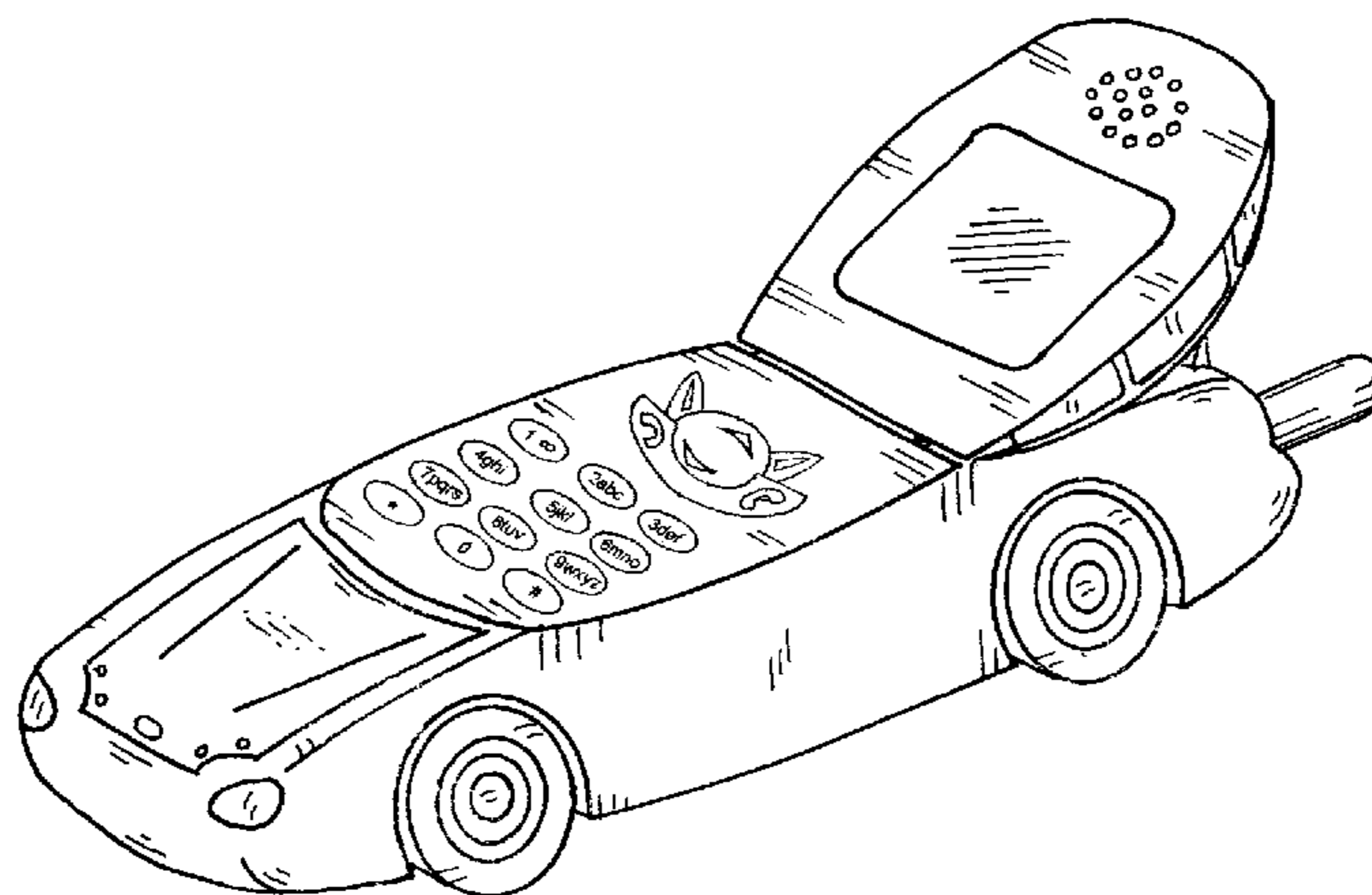

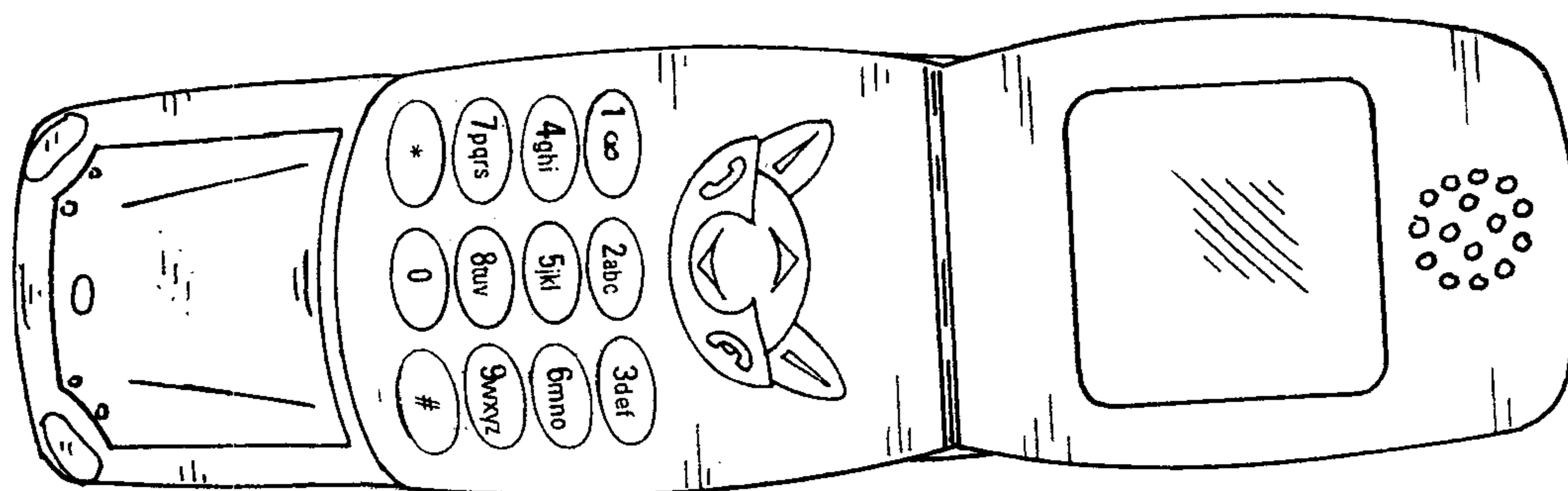
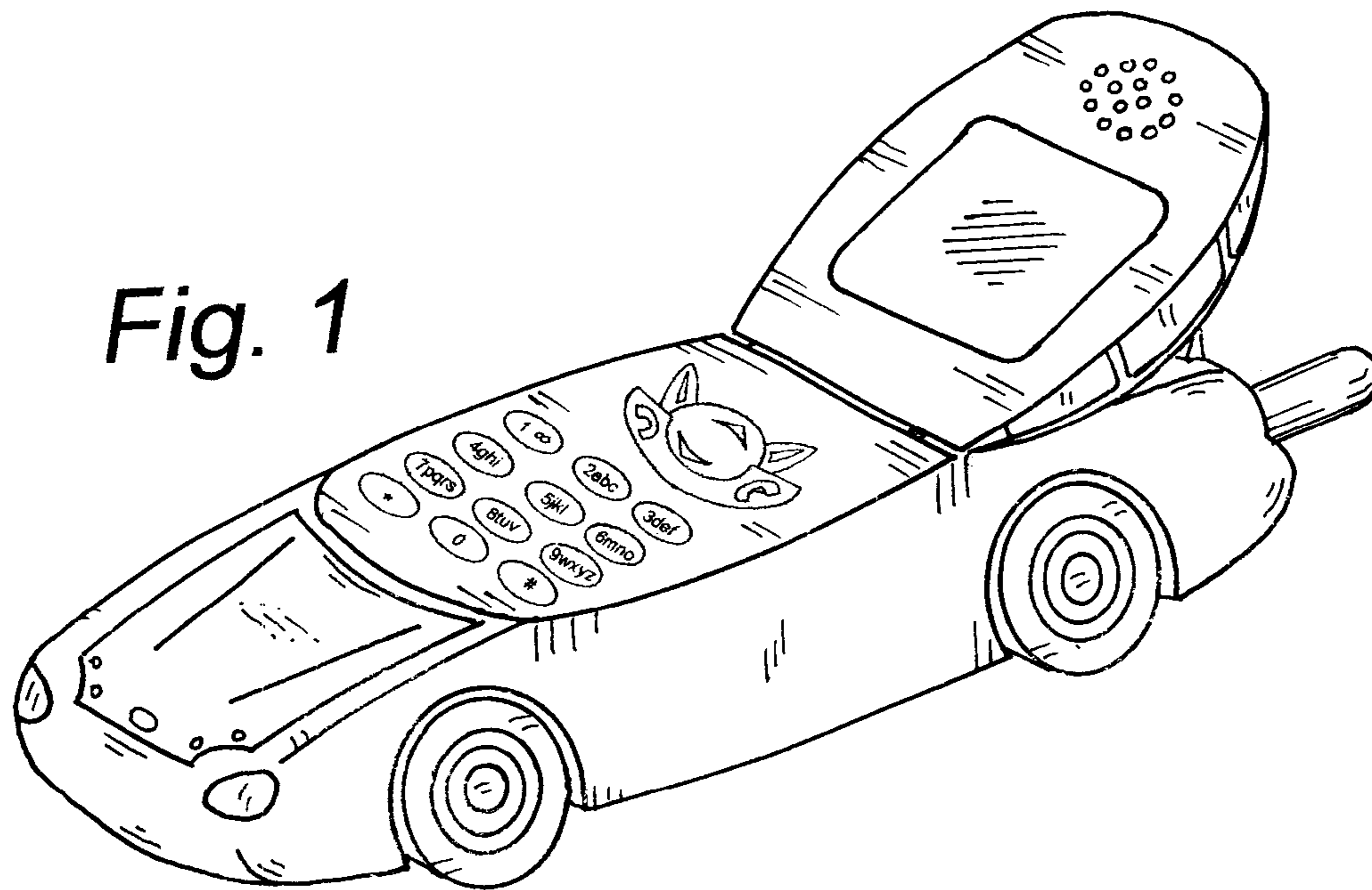
The ornamental design for a cell phone, as shown and described.

**DESCRIPTION**

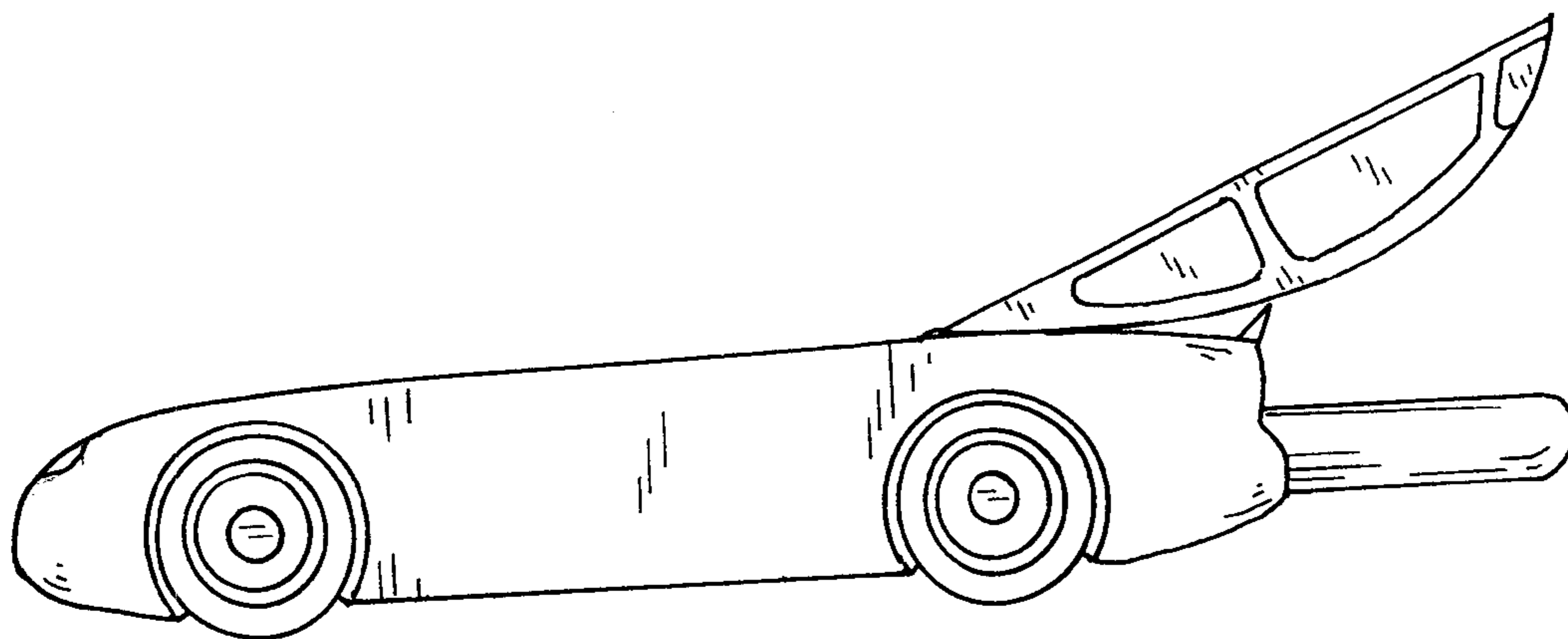

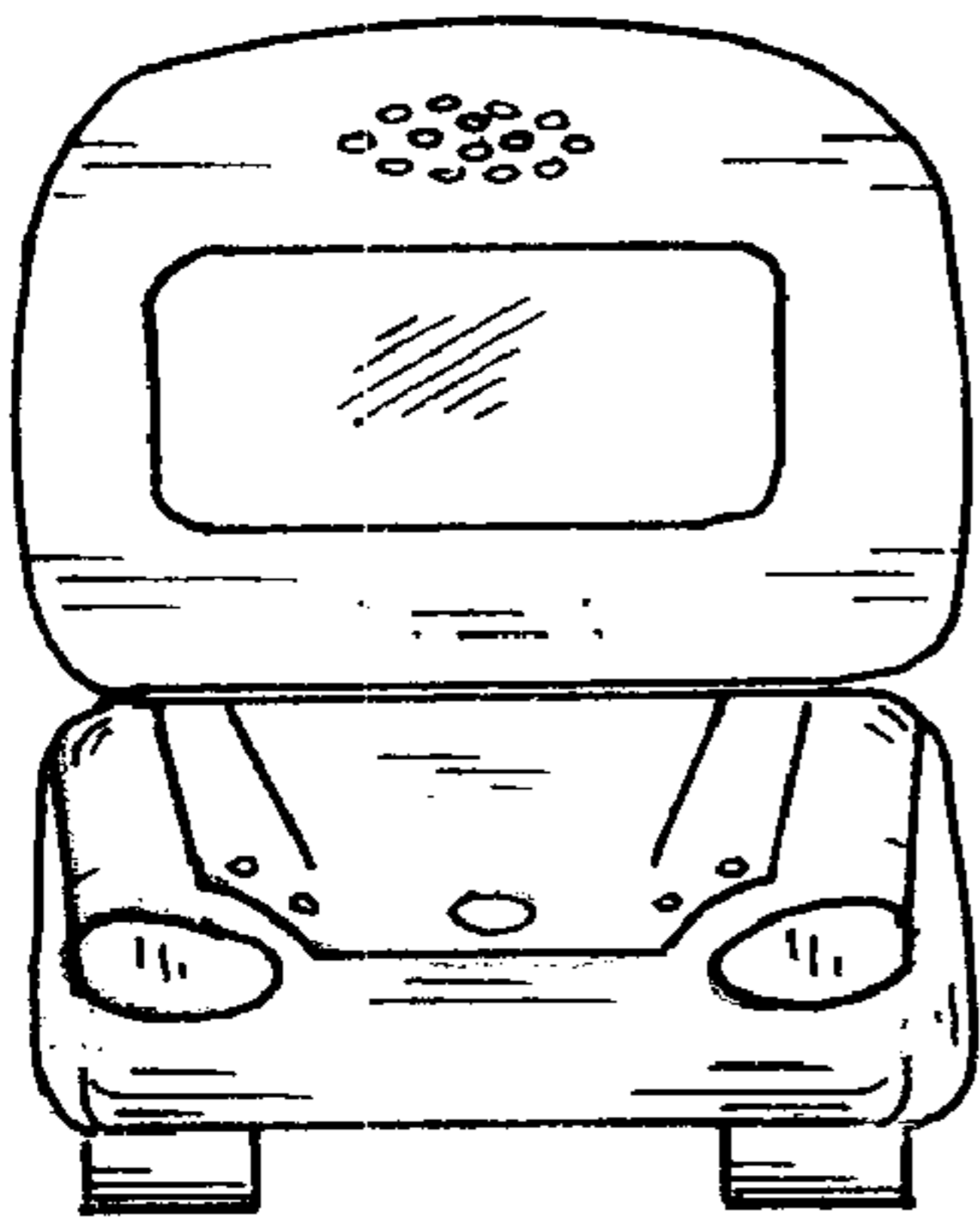
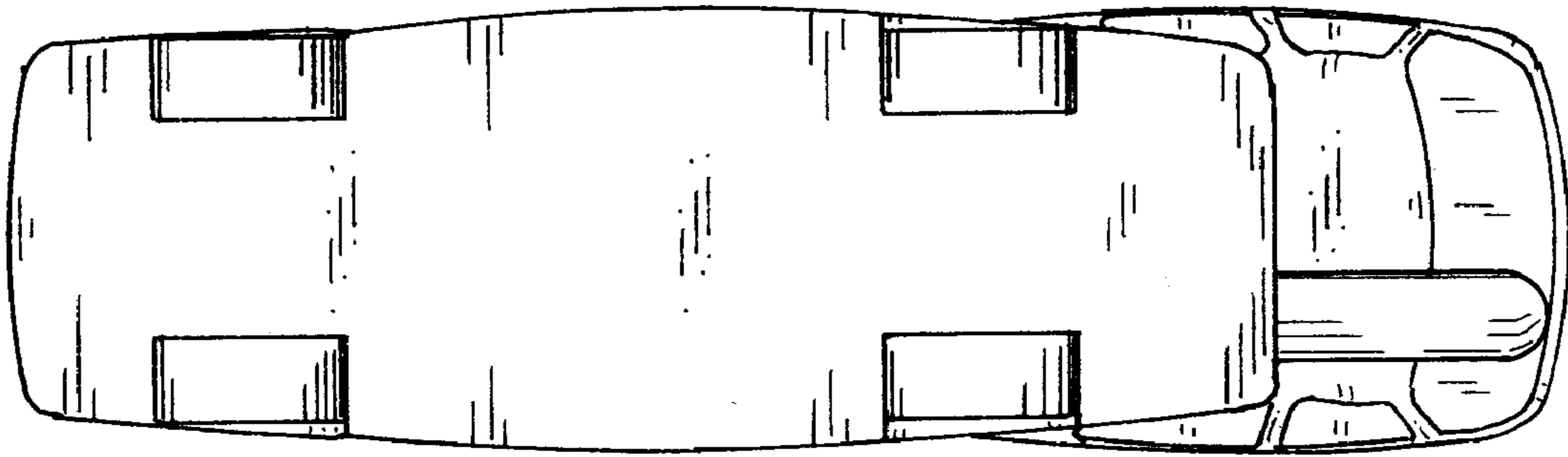

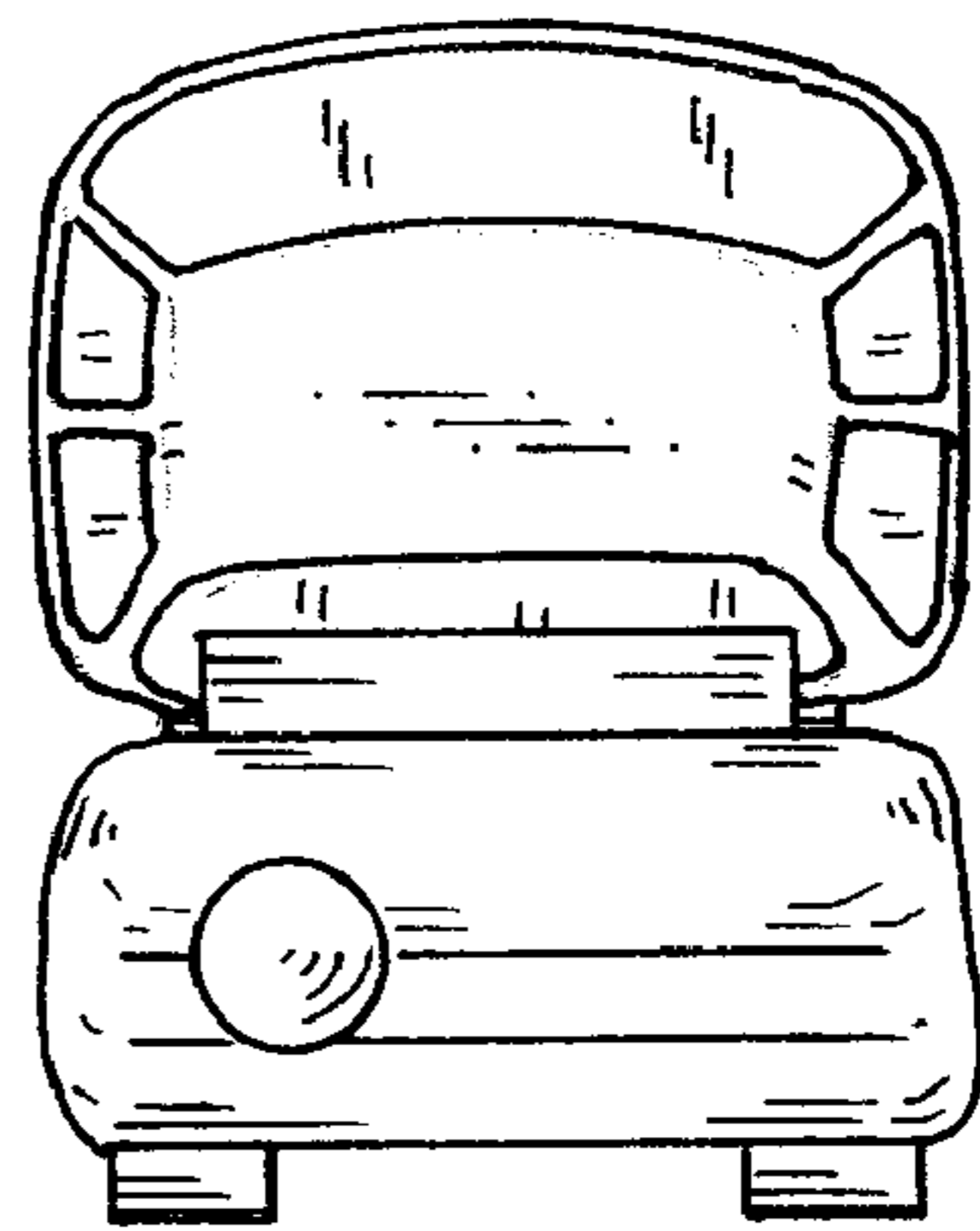
