An ornamental design for a microphone housing, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a microphone housing showing our new design;

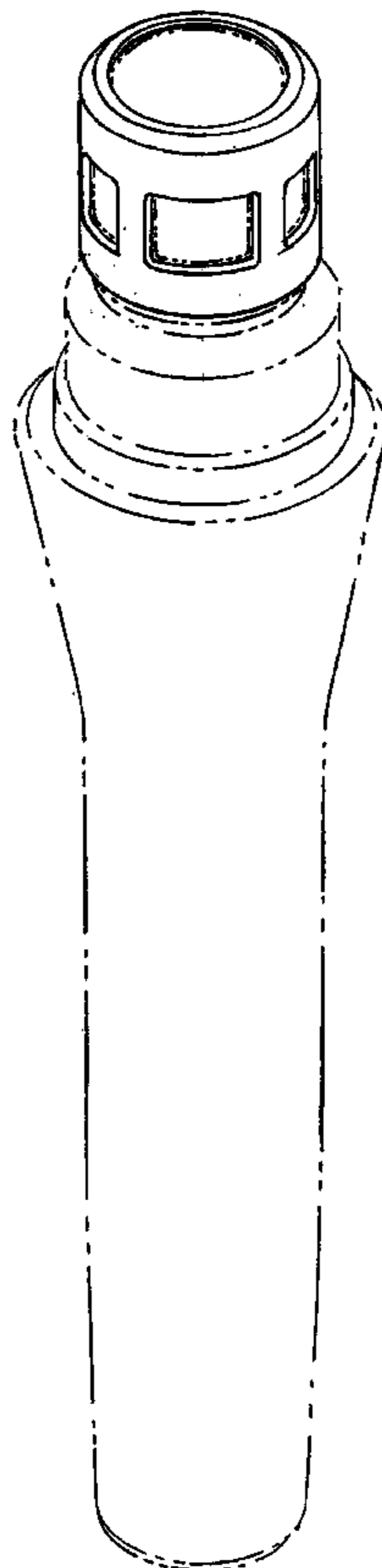

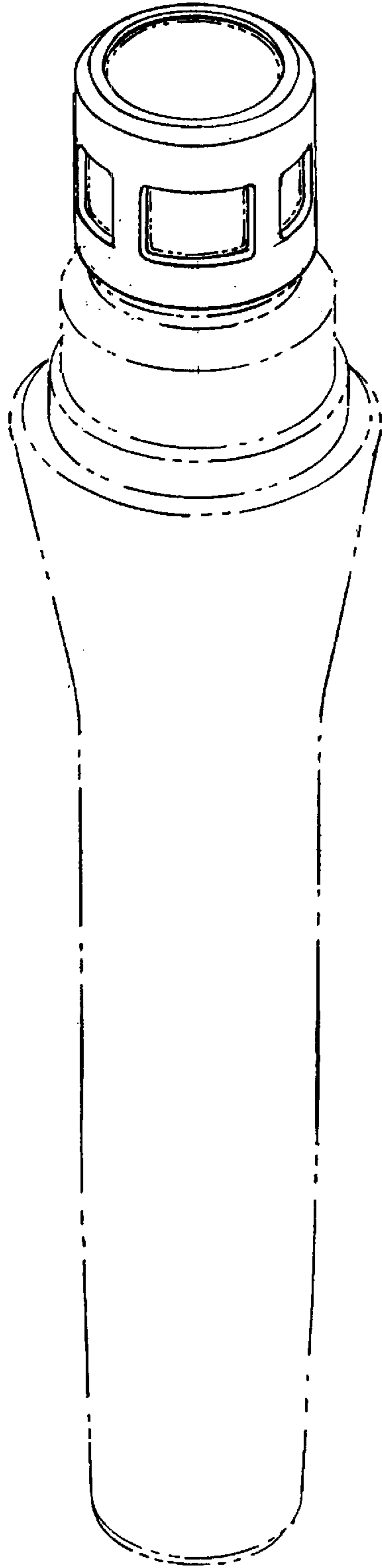

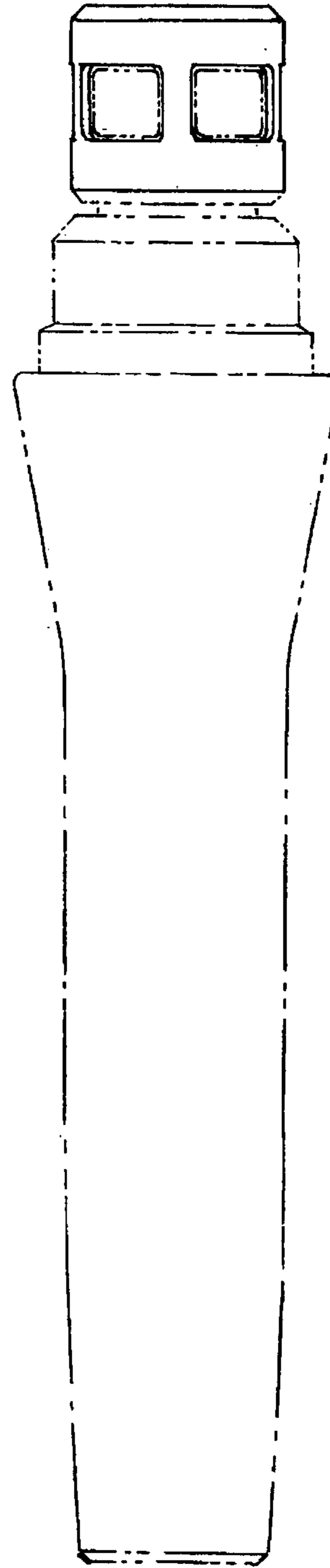

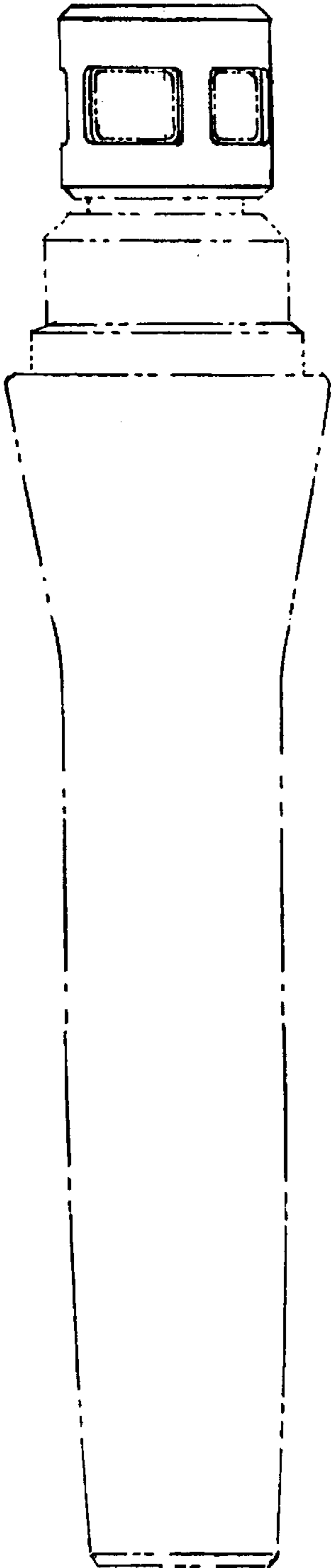

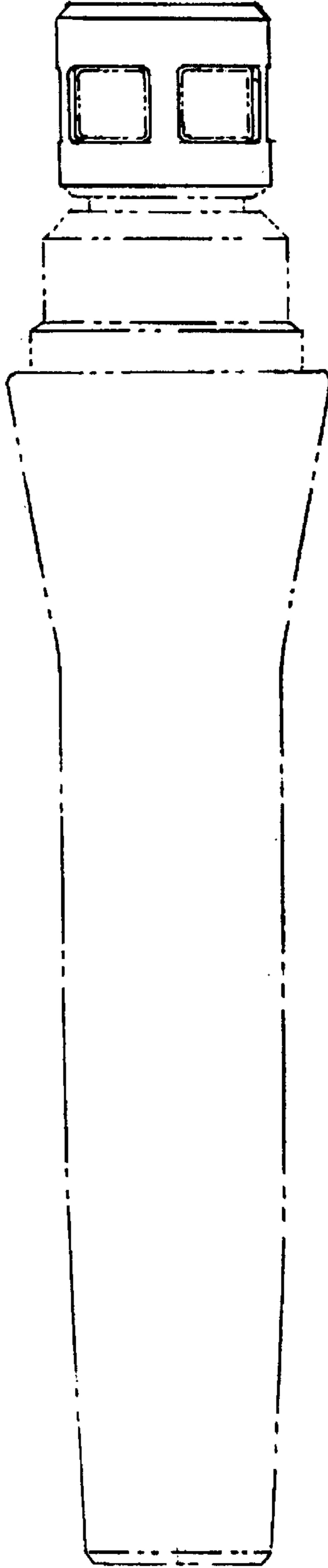
