an internal combustion engine, showing our new design;

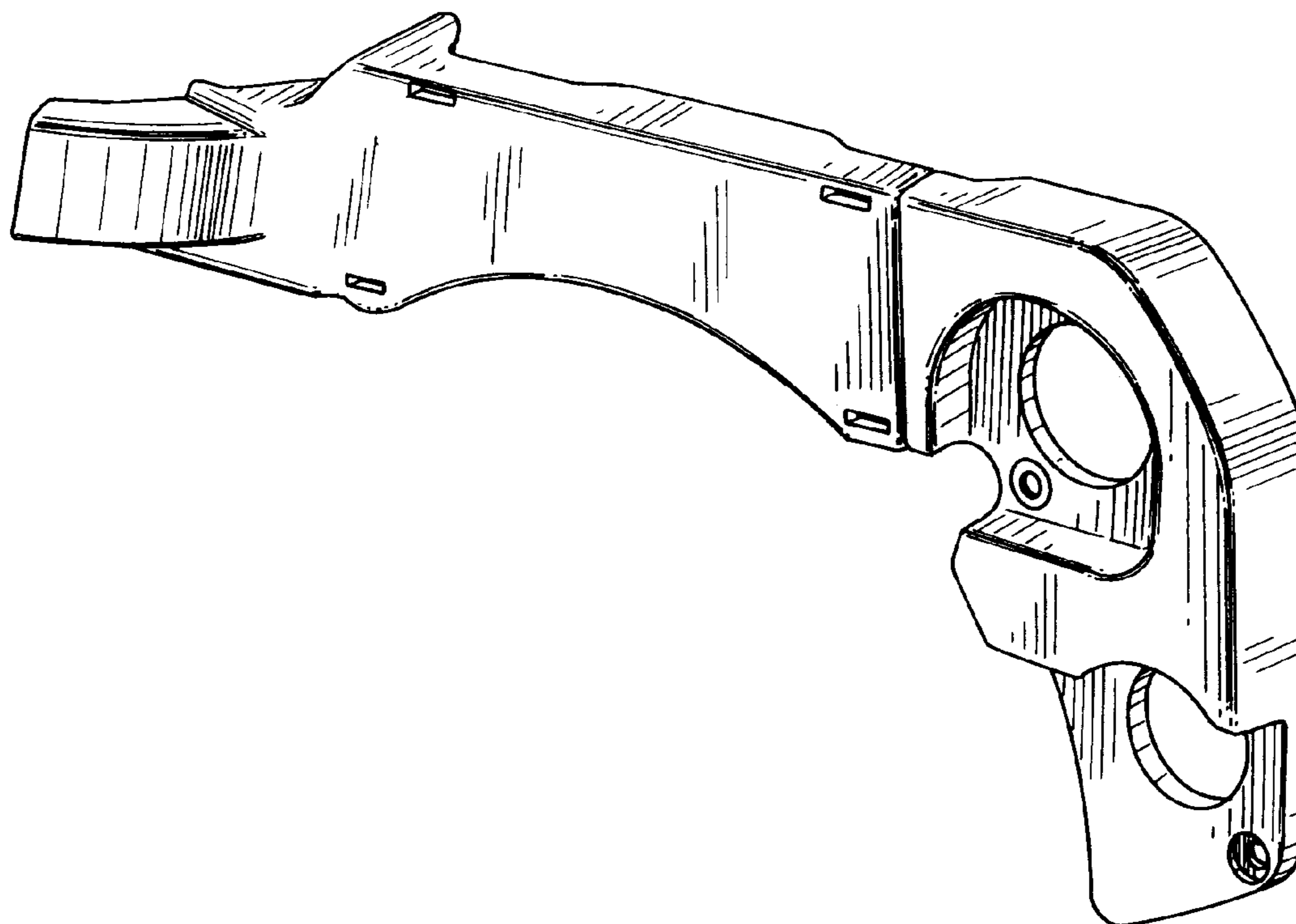

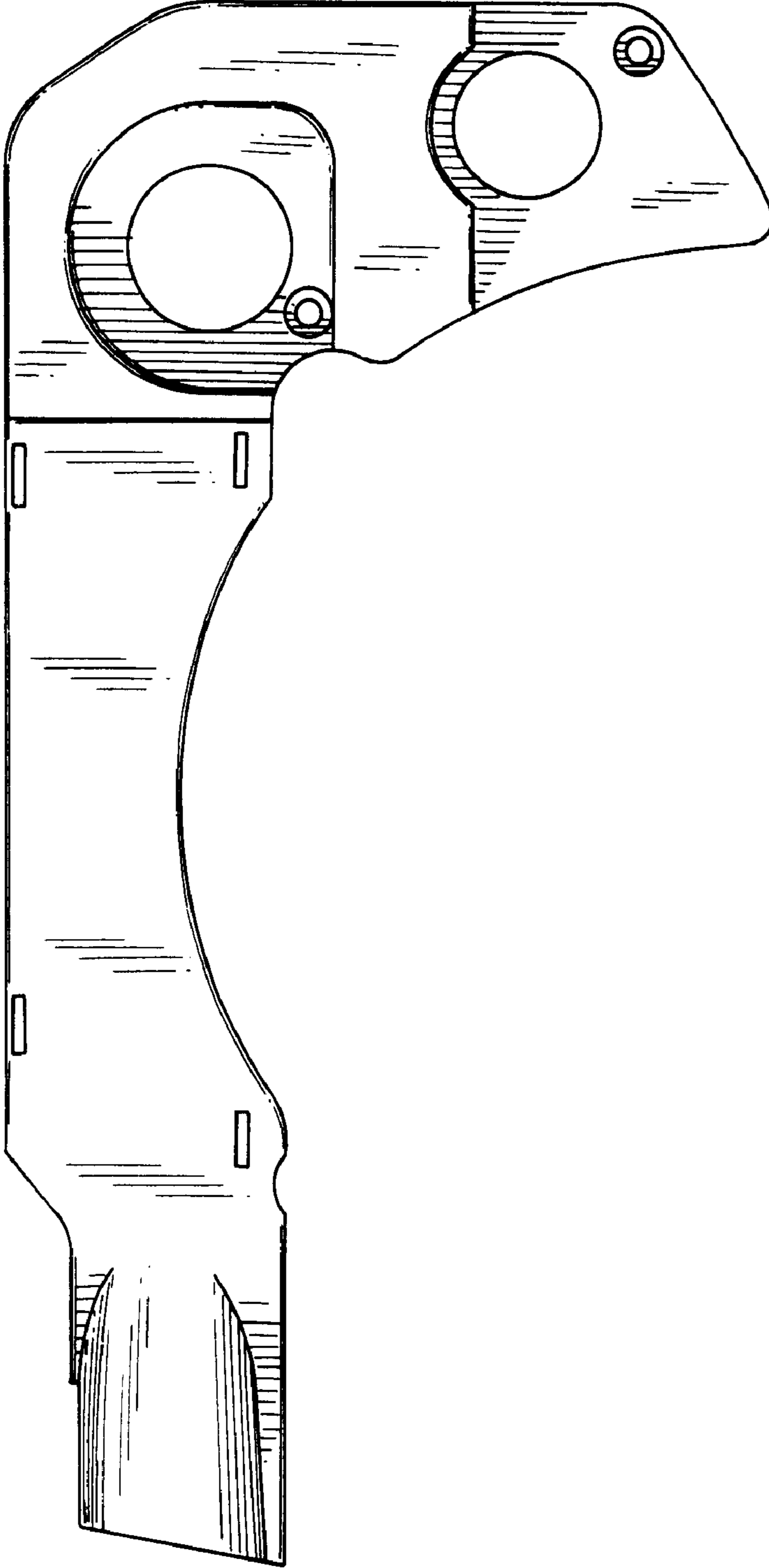

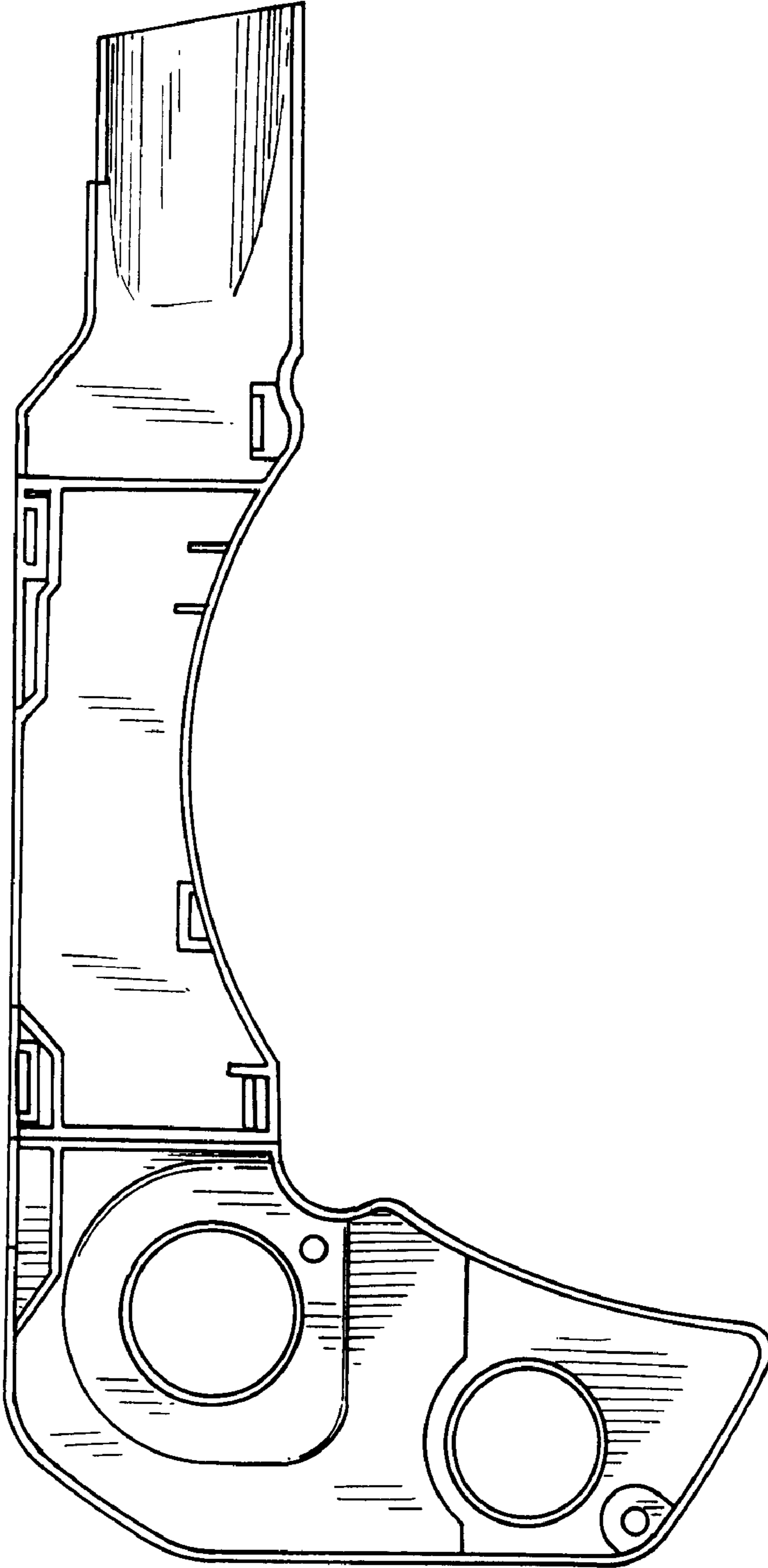

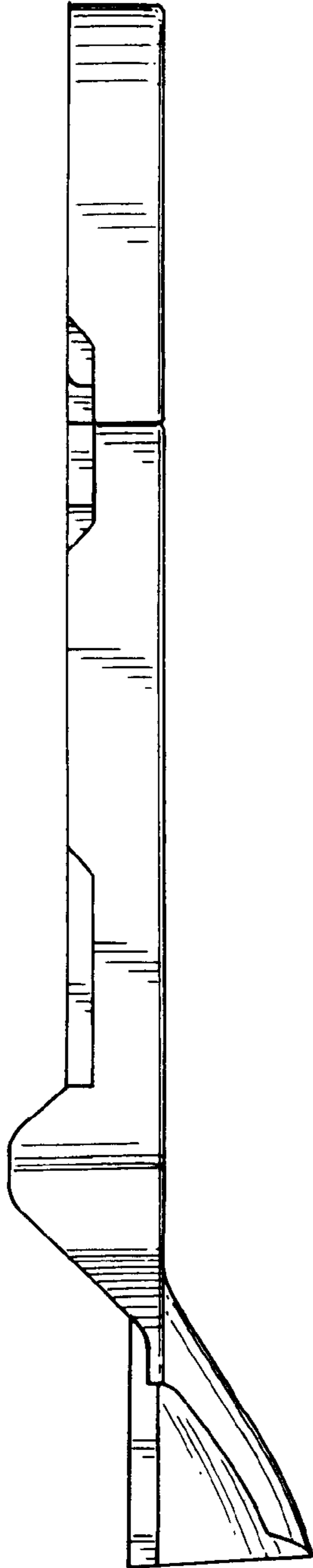

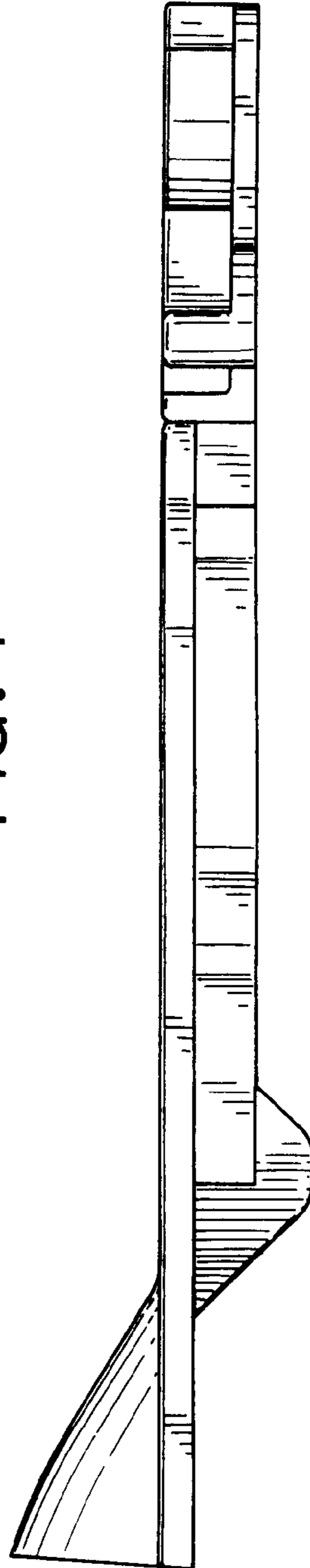

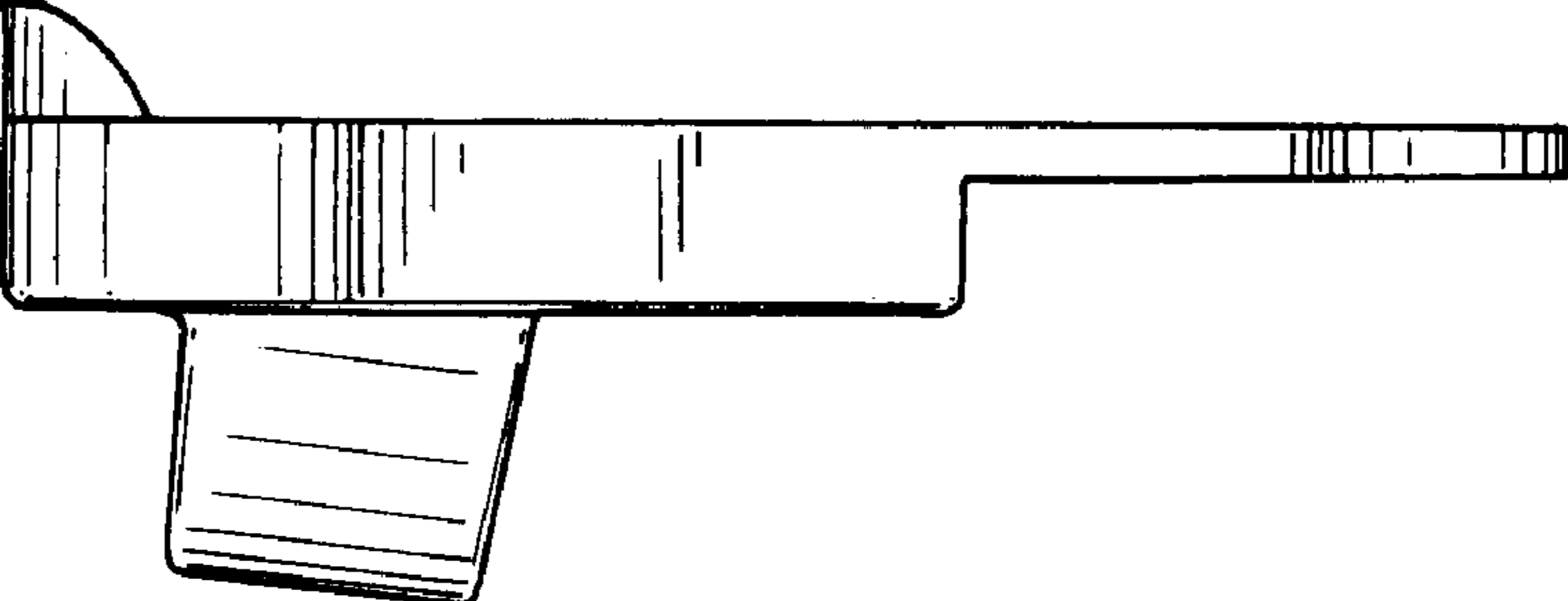

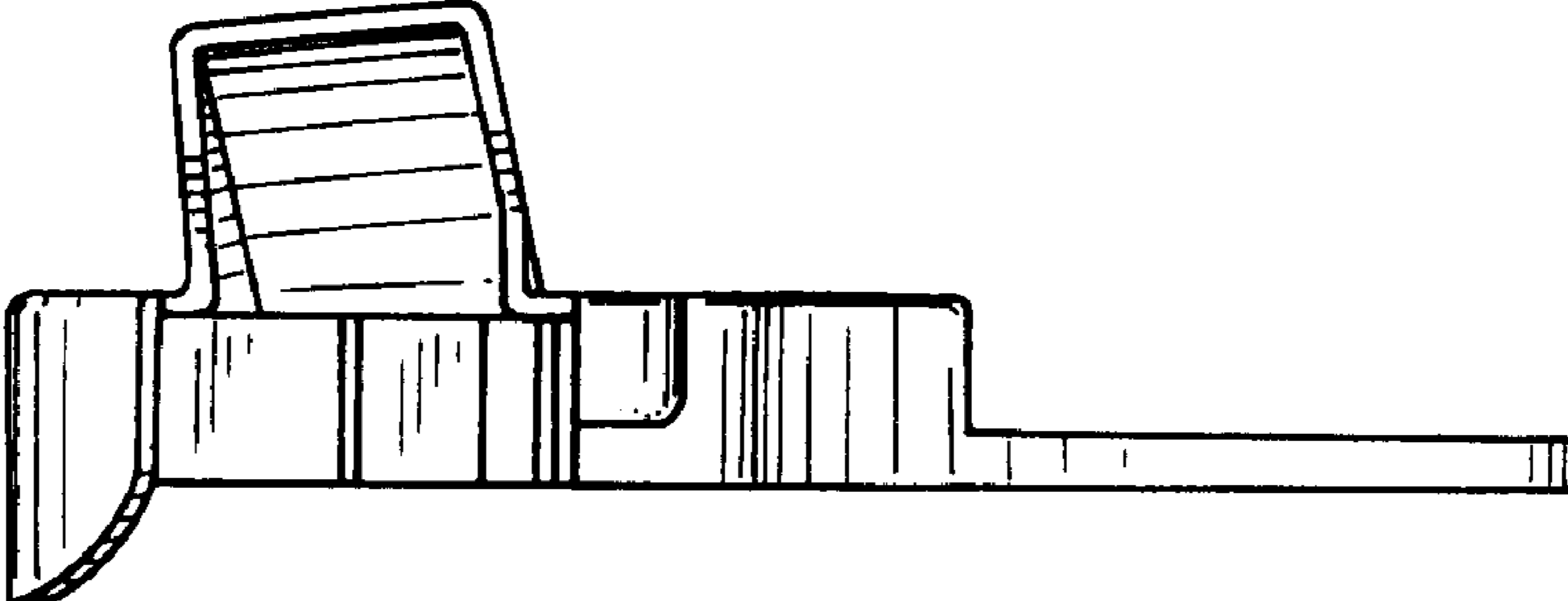
