DESCRIPTION

FIG. 1 is a perspective view of a cooling unit showing my ornamental design;

FIG. 3 is a right side plan view of the cooling unit embodiment shown in FIG. 1;

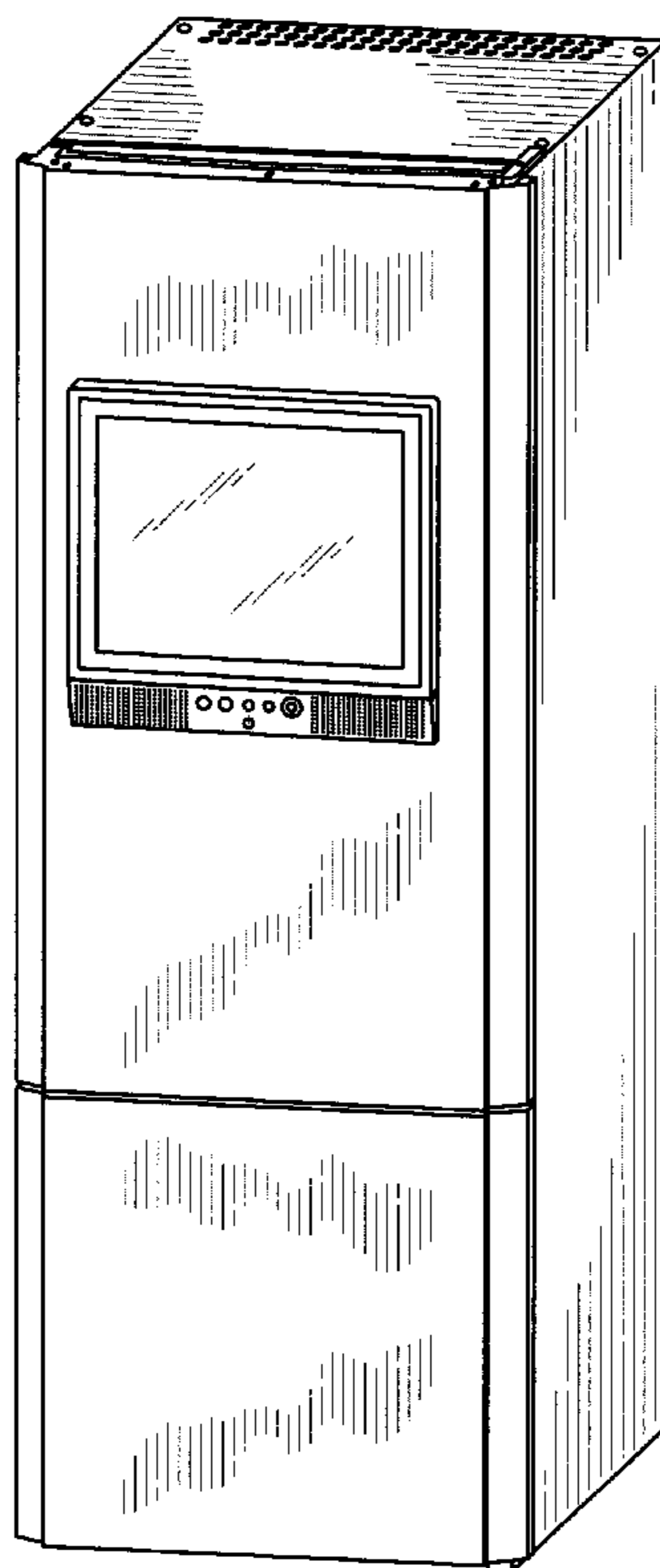
FIG. 4 is a left side plan view of the cooling unit embodiment shown in FIG. 1;

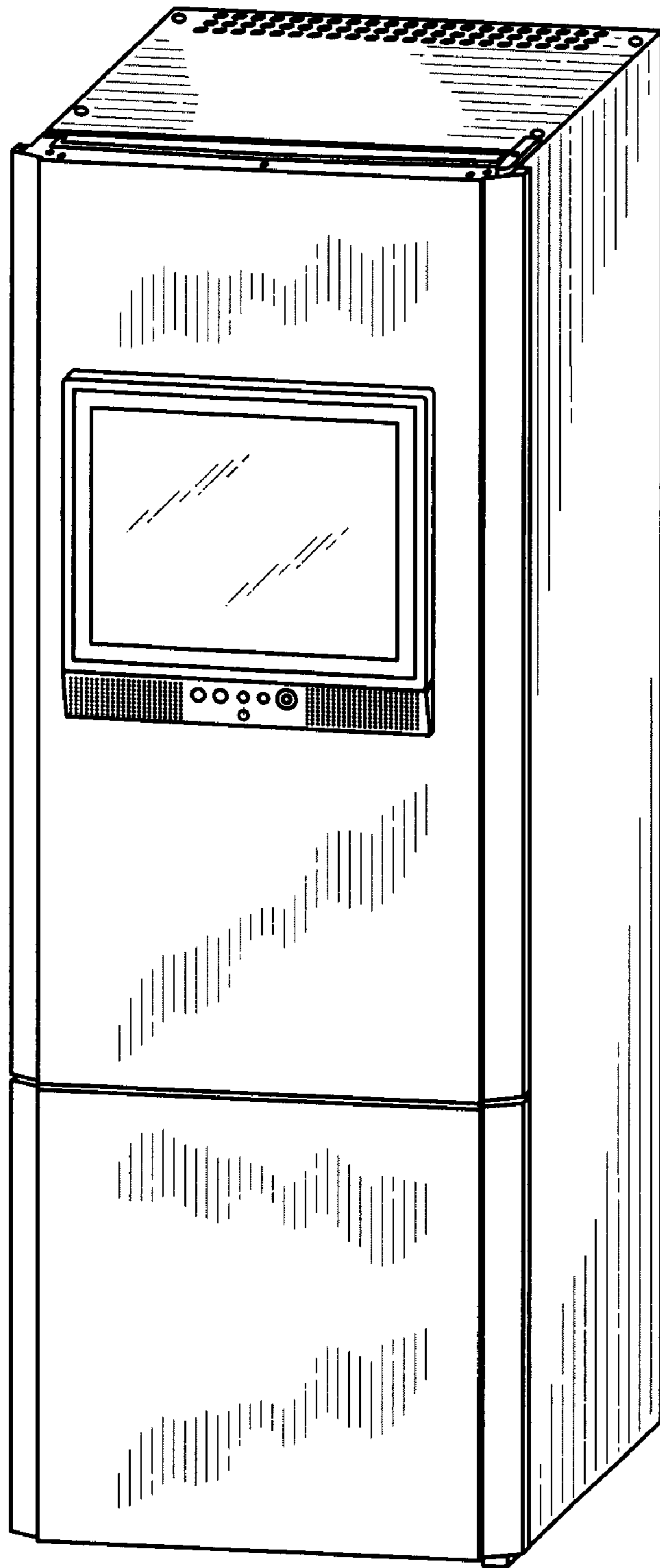

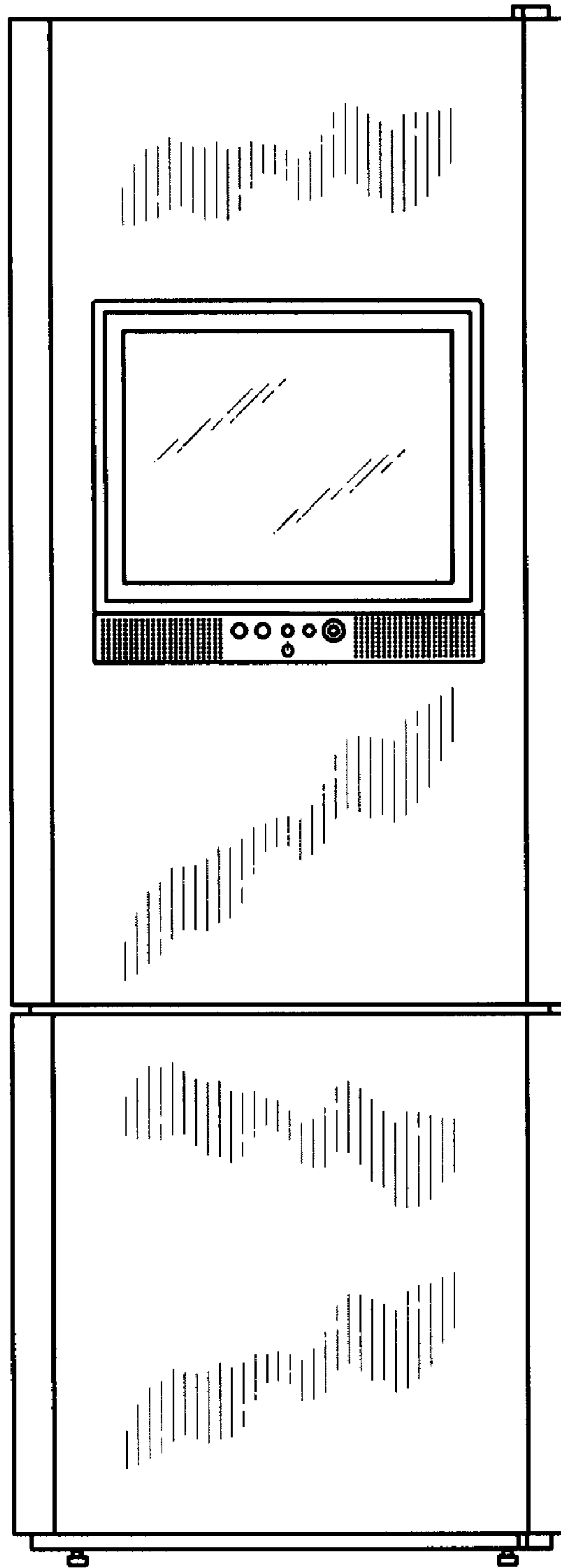

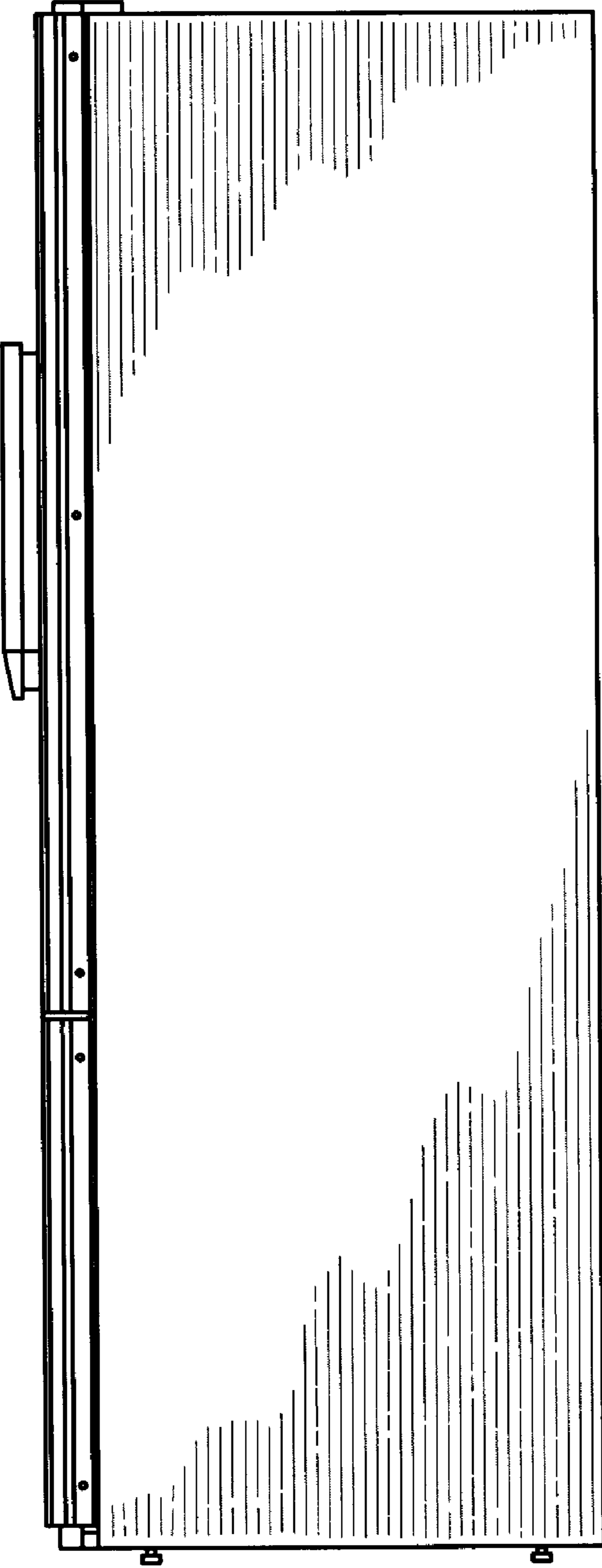

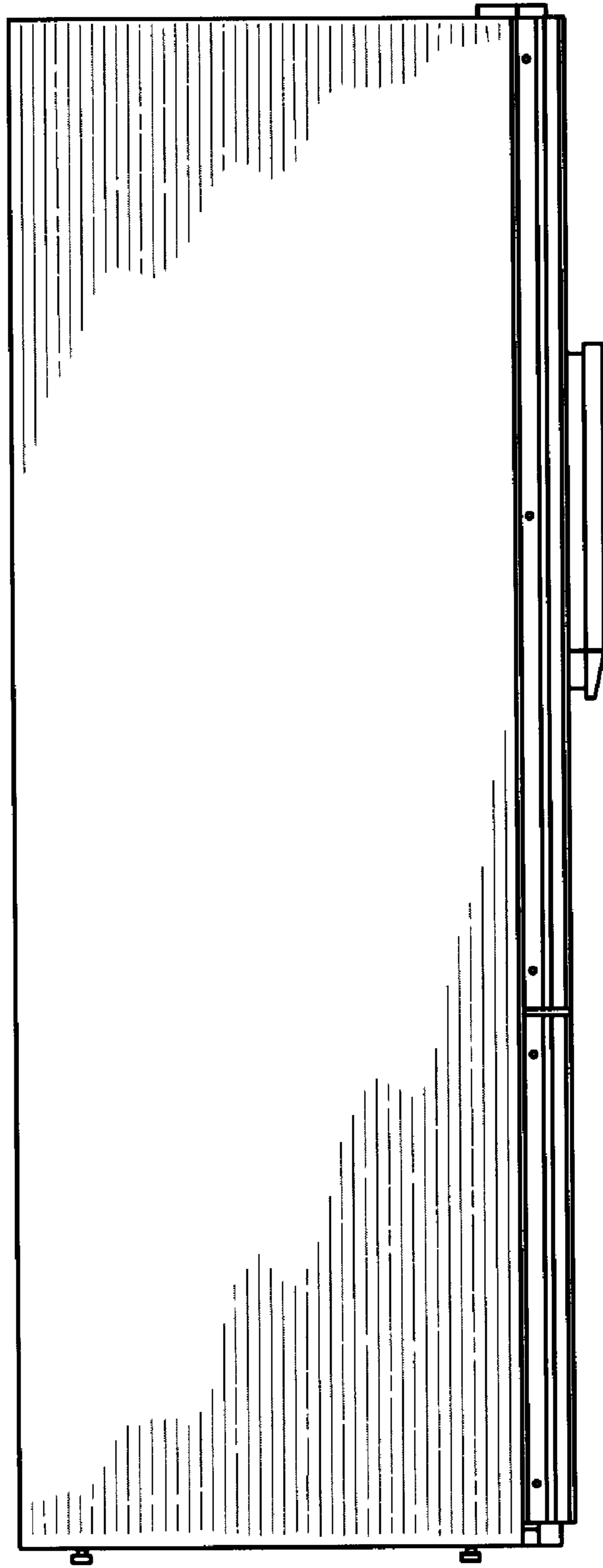

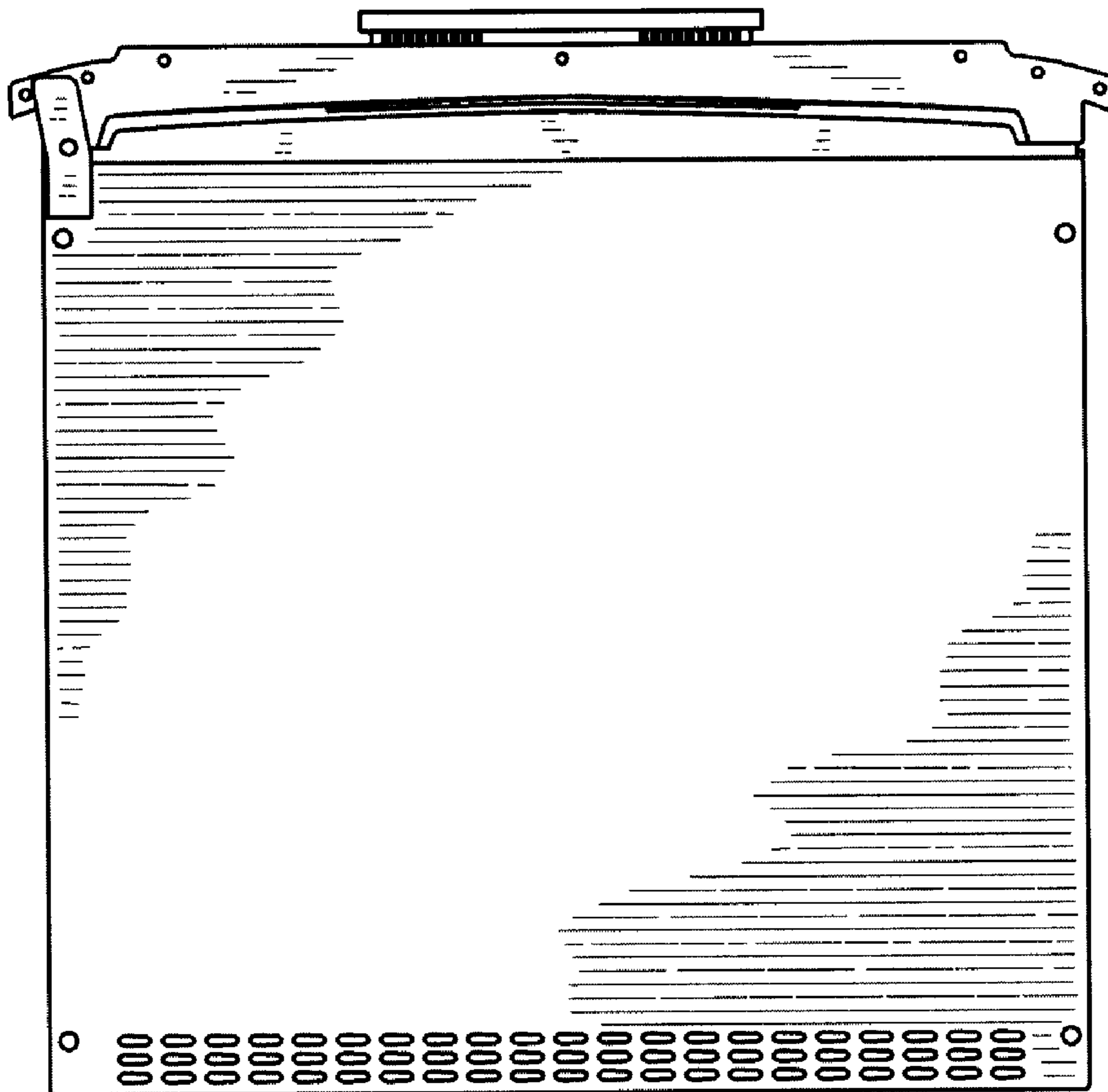

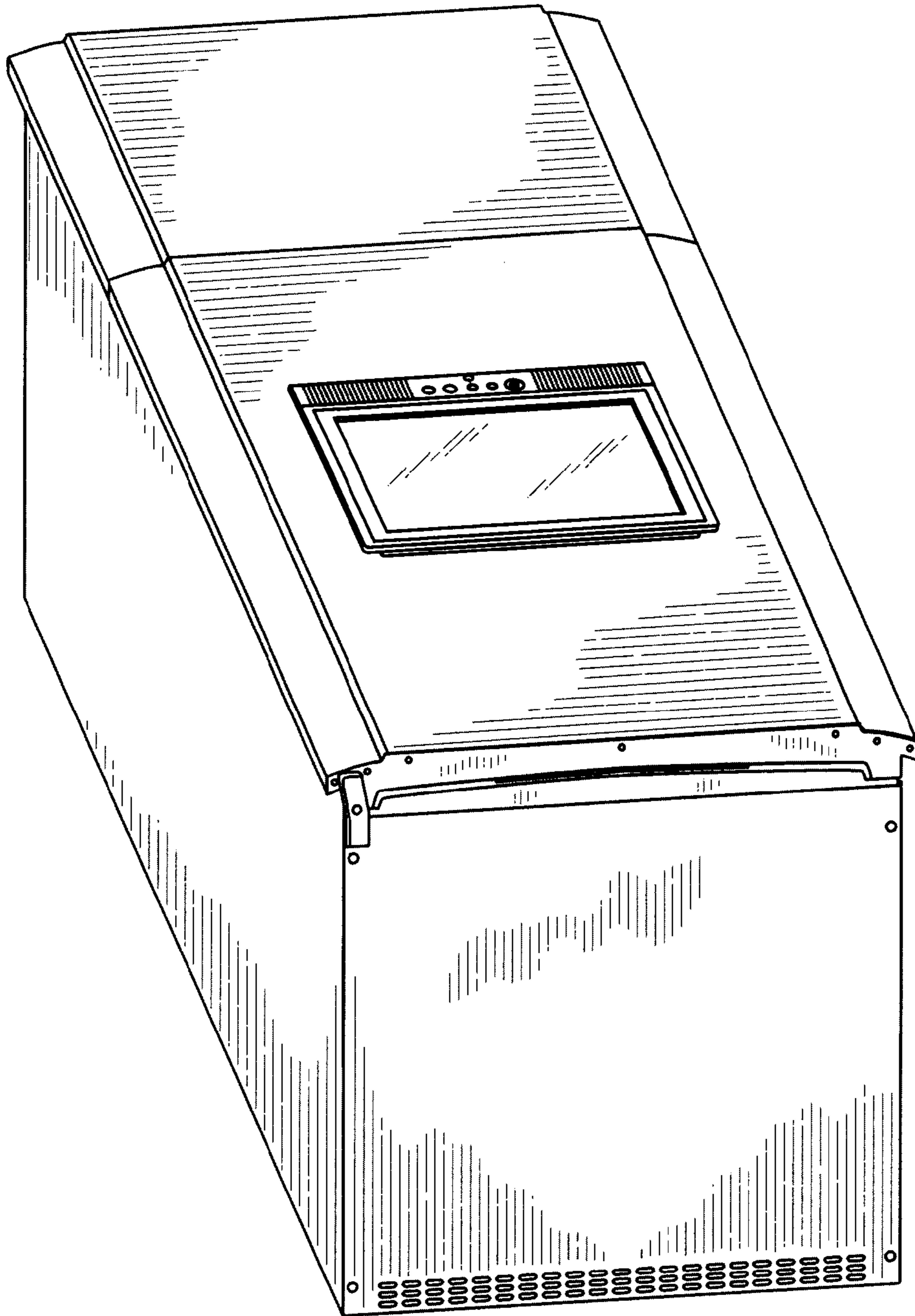

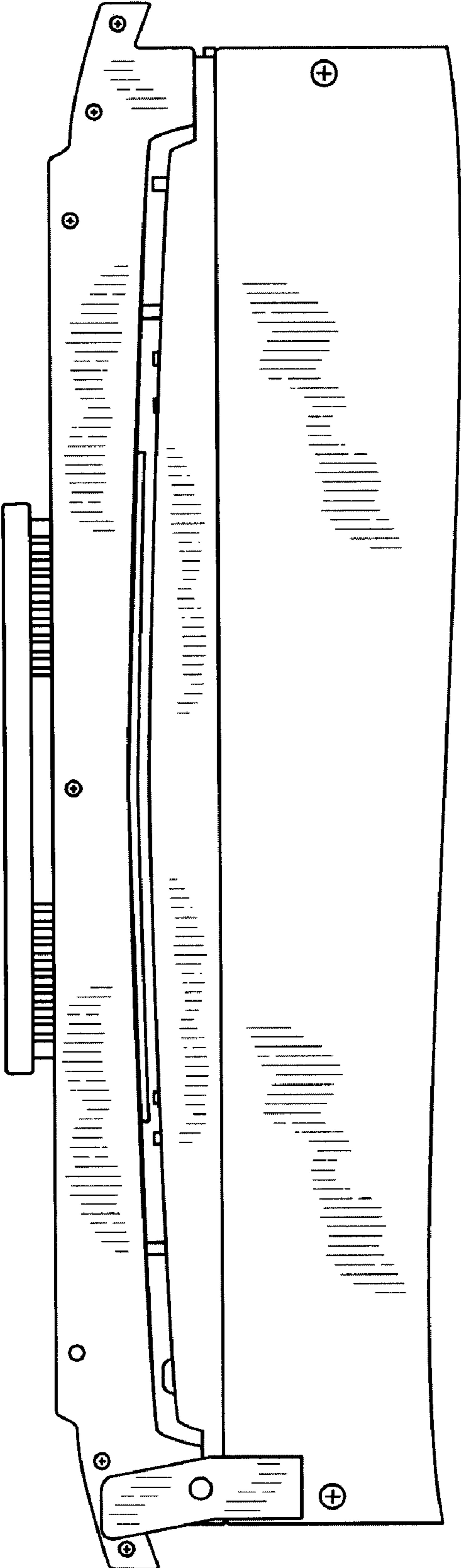
