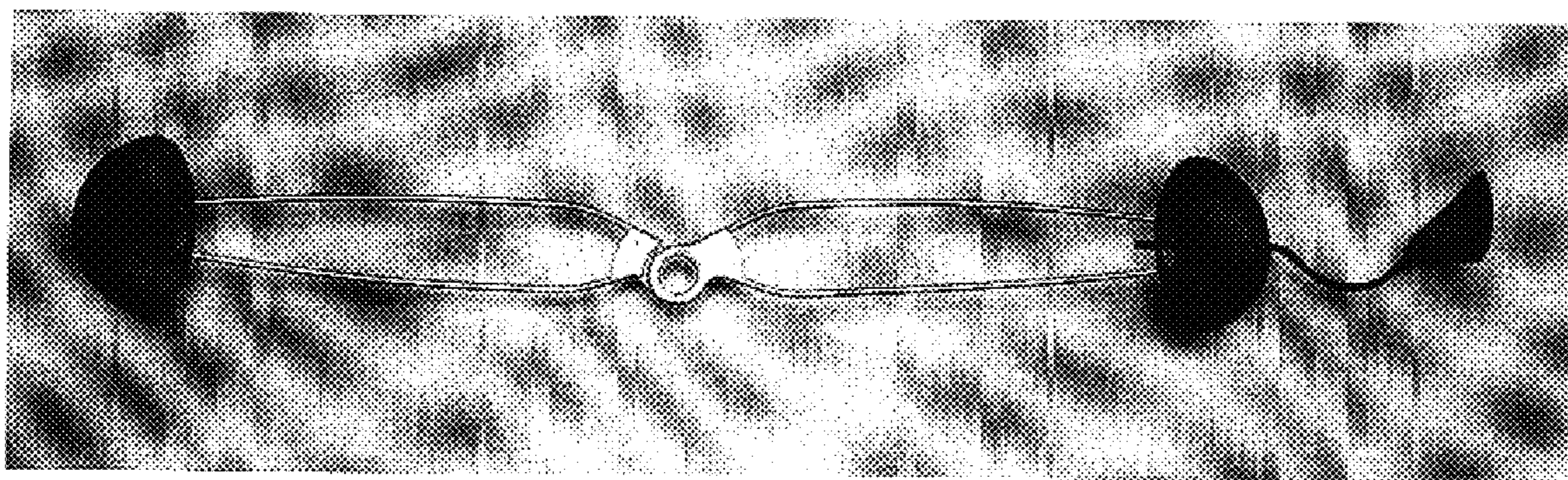
(57) **CLAIM**

I claim the ornamental design for an orthotic device, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of the orthotic device; FIG. 2 is a bottom perspective view of the orthotic device; FIG. 3 is an isometric view of the orthotic device; FIG. 4 is an enlarged top view of the jointed portion of the orthotic device; FIG. 5 is an enlarged bottom view of the jointed portion of the orthotic device; FIG. 6 is an enlarged back view of the jointed portion of the orthotic device; and, FIG. 7 is an enlarged front view of the jointed portion of the orthotic device.

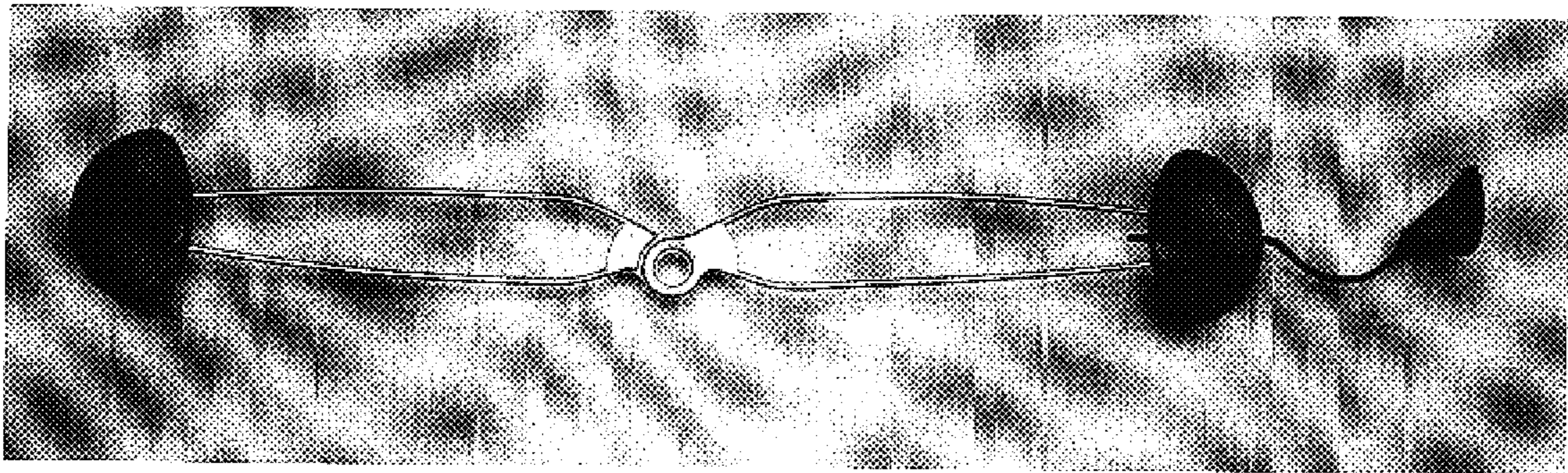

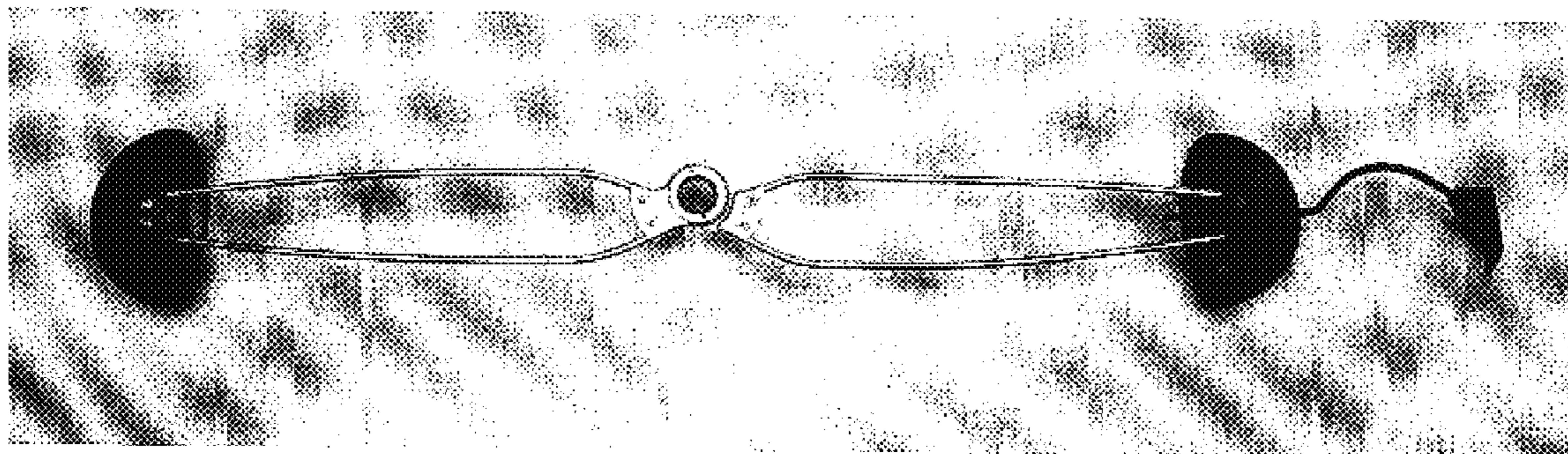

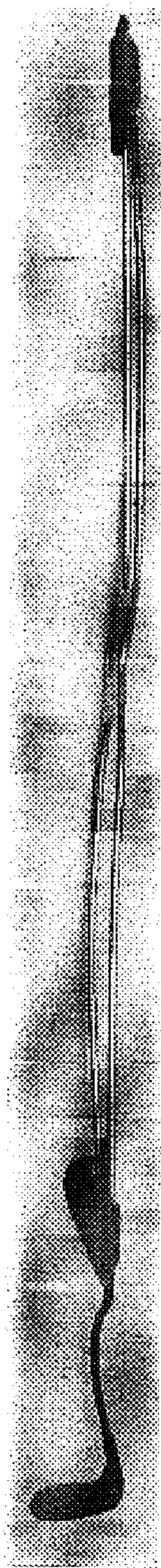

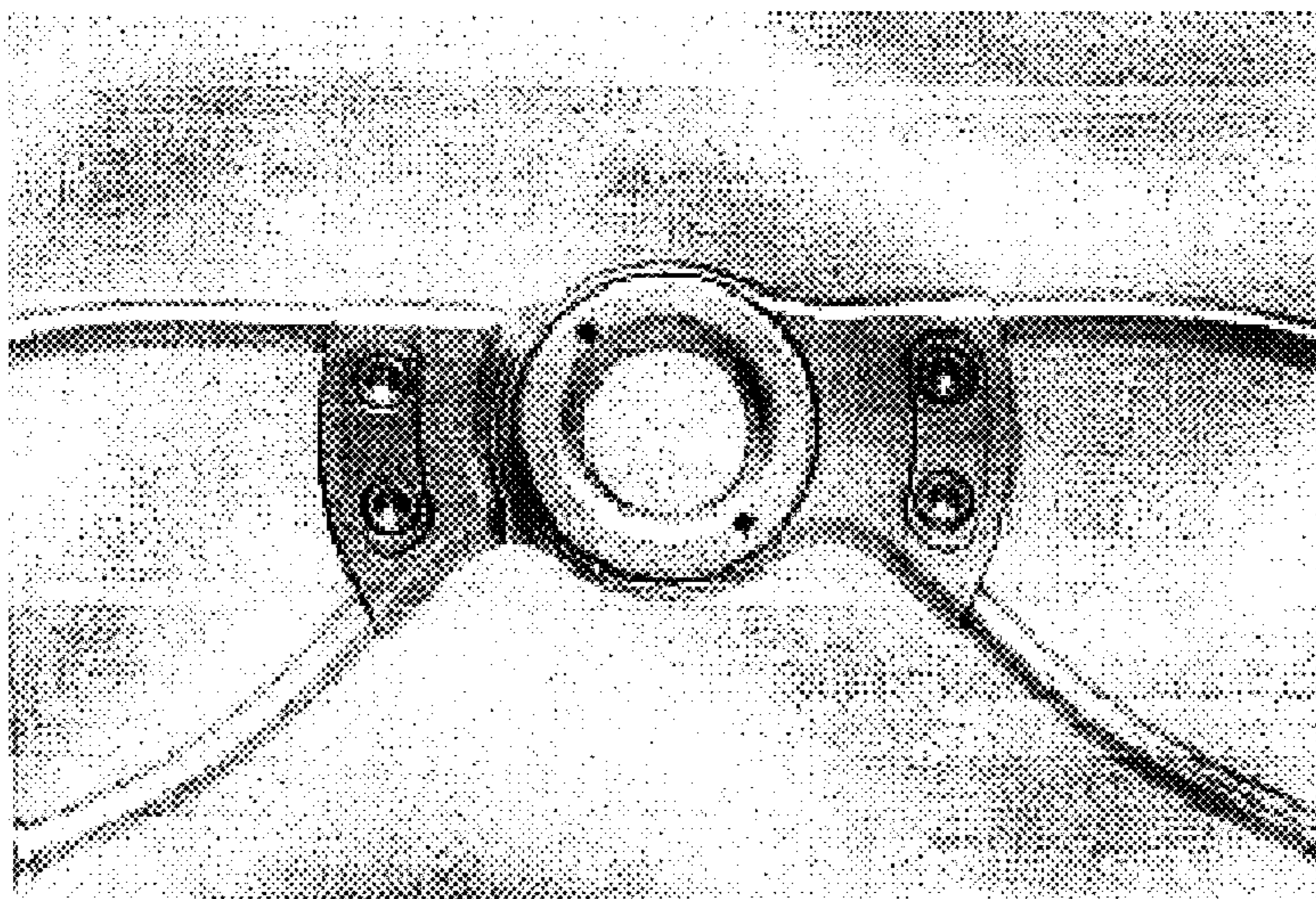

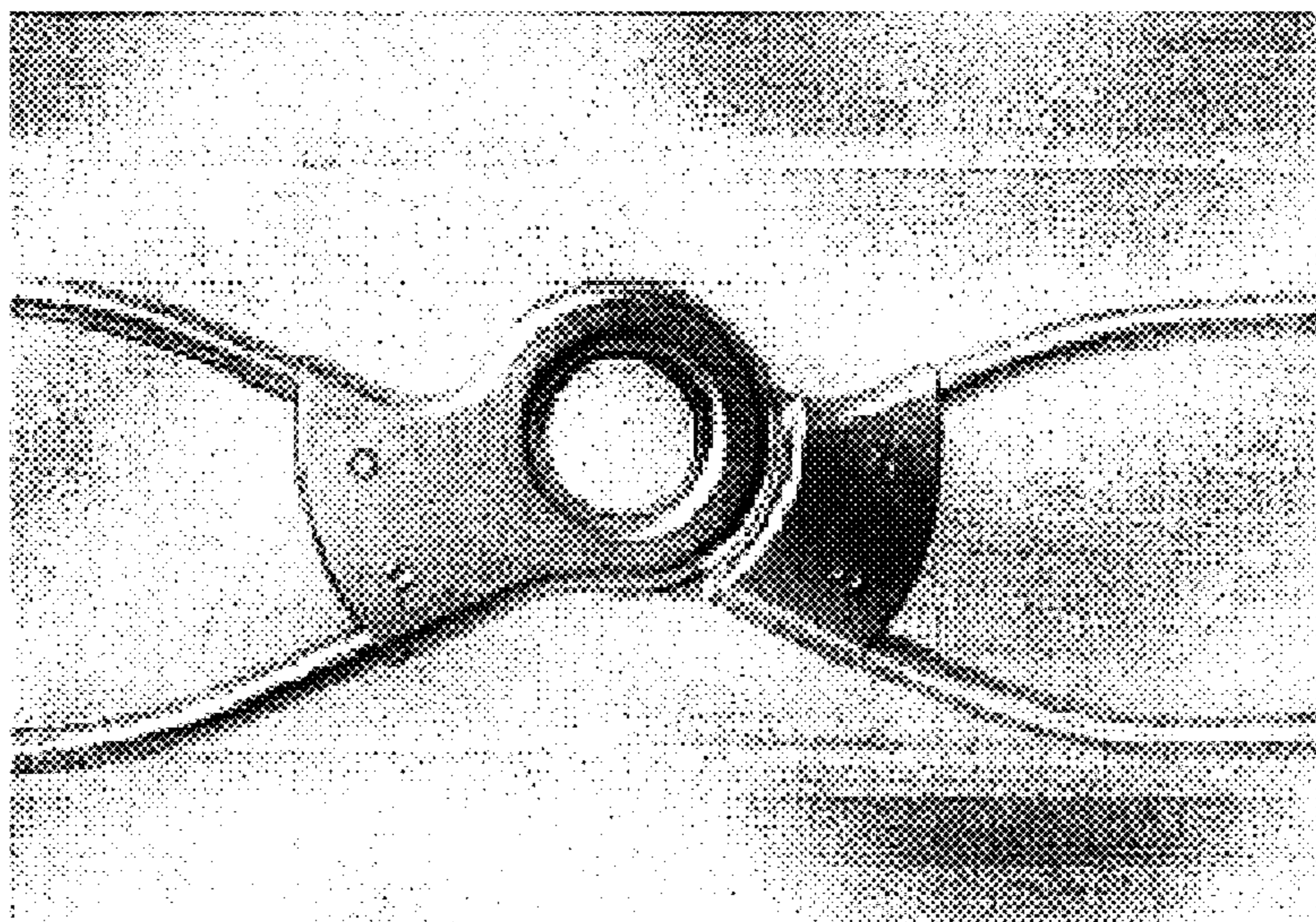

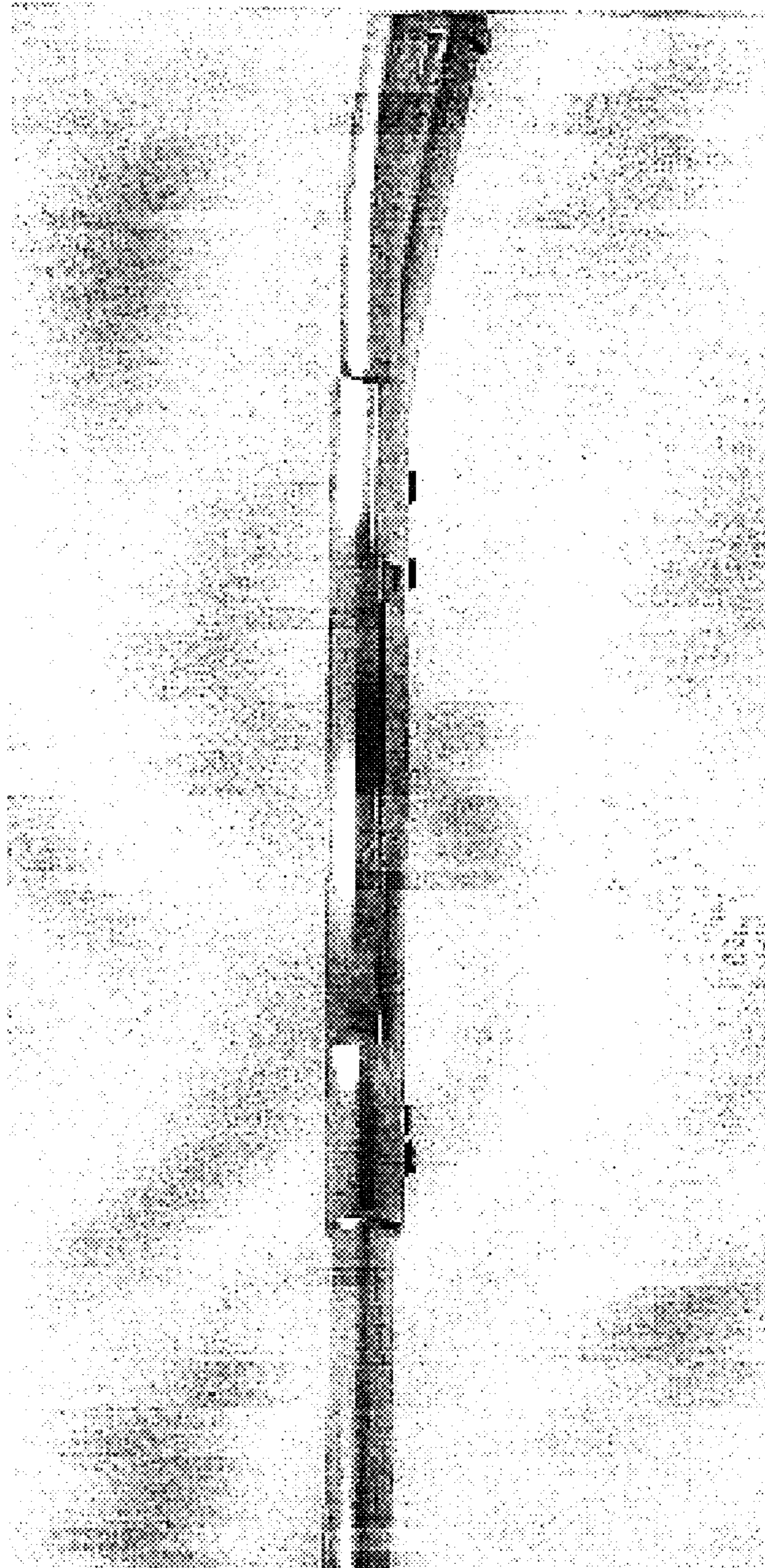

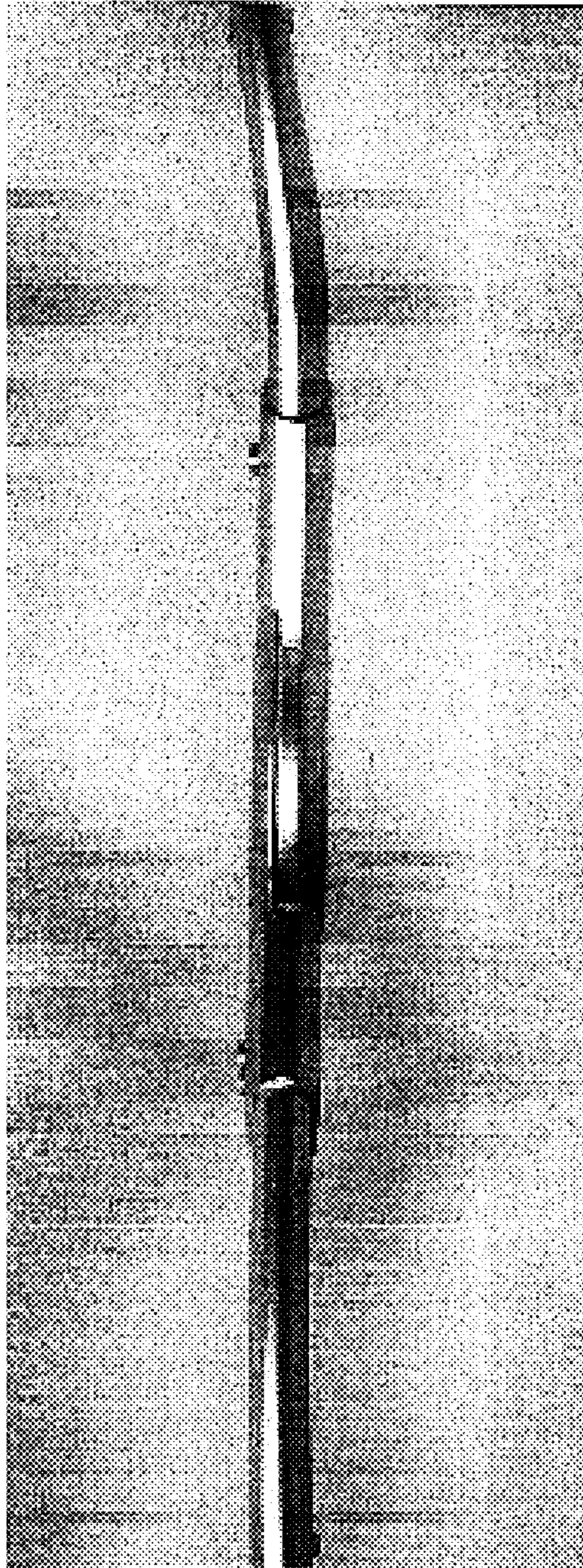
