FIG. 1 is a front view of the sports glove holder.

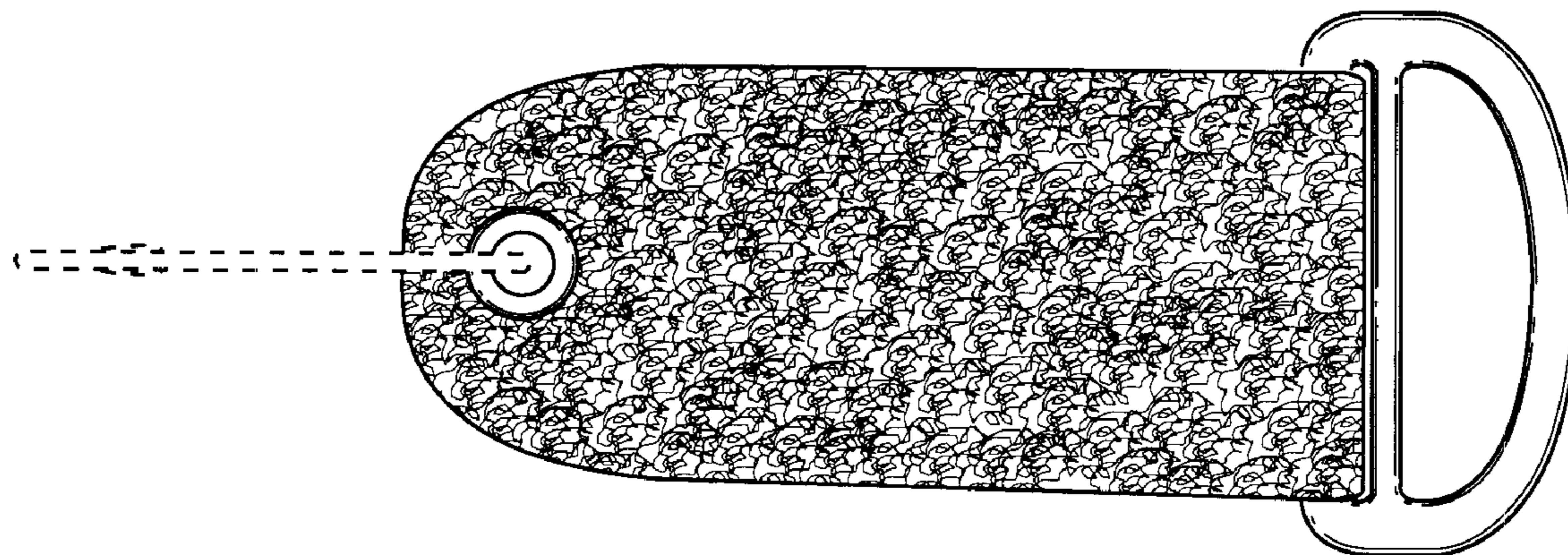
FIG. 2 is a rear view of the sports glove holder.

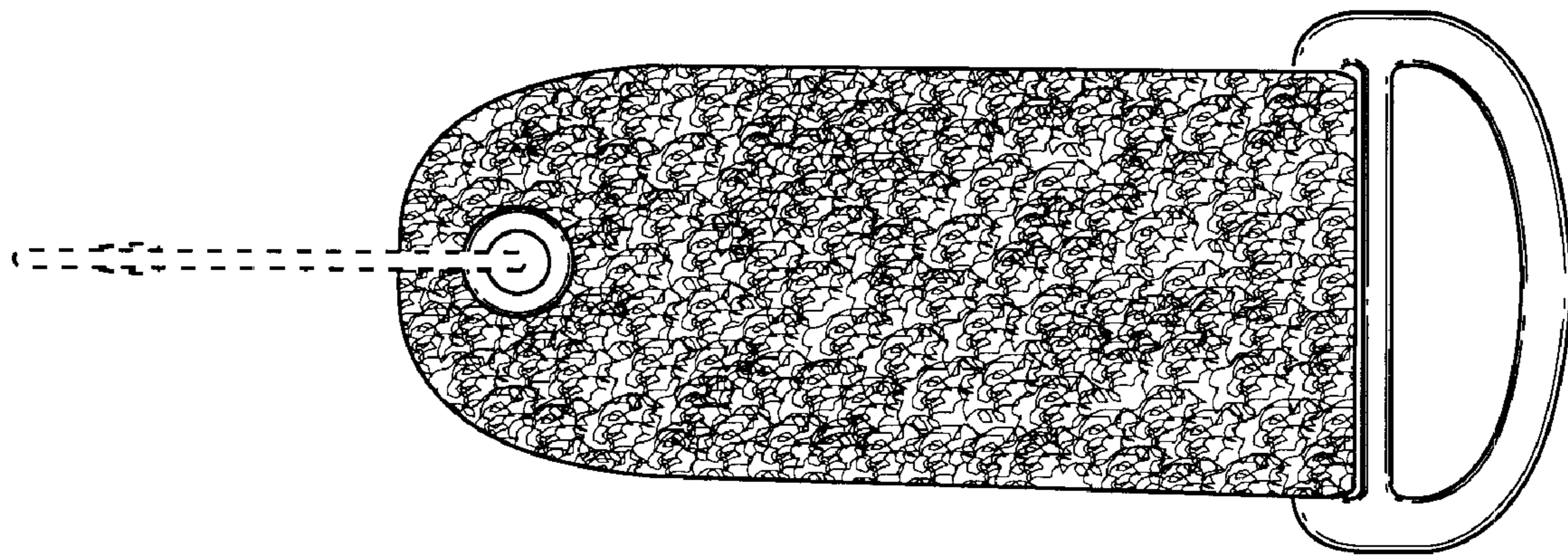

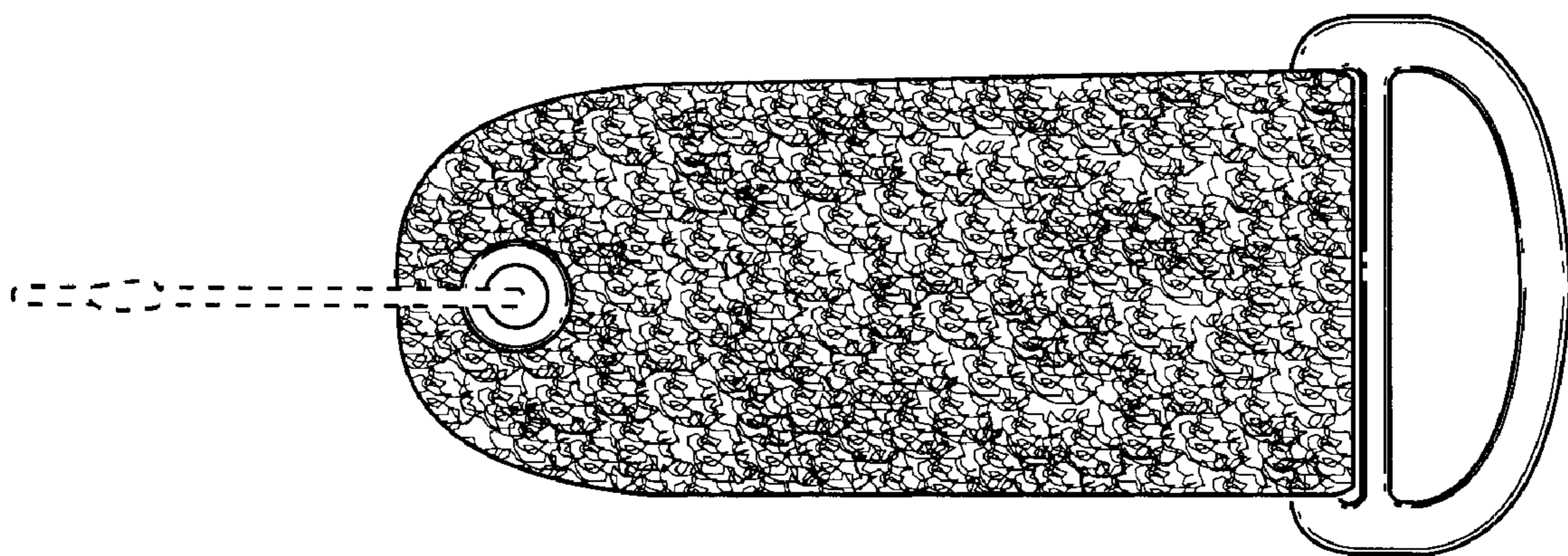

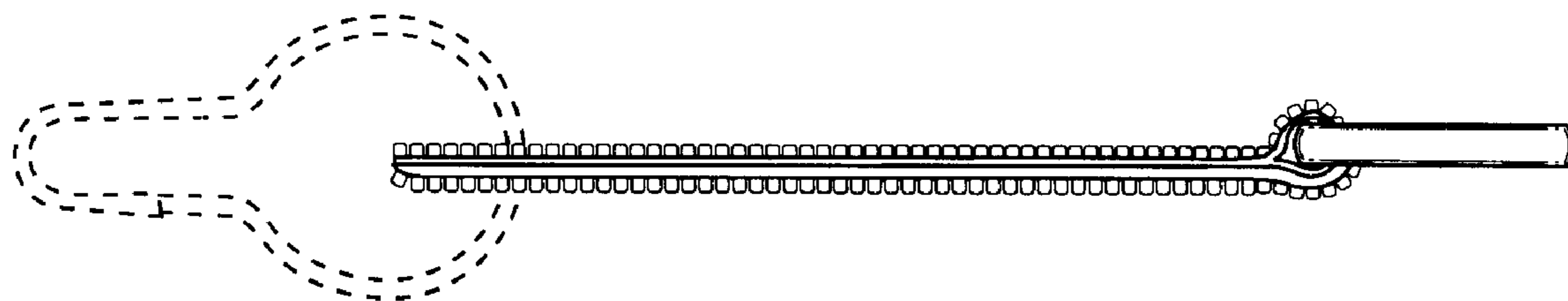

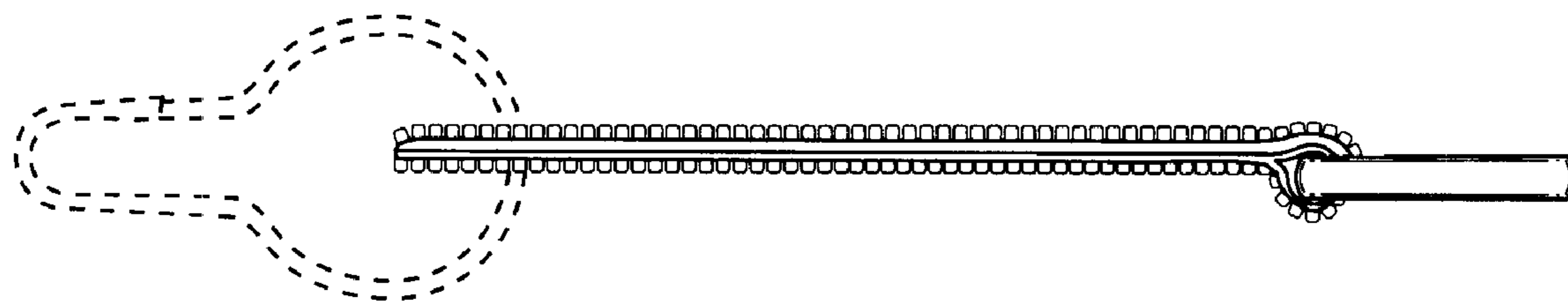
