(57) **CLAIM**

I claim the ornamental design for softside luggage, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the softside luggage embodying my new design.

FIG. 2 is a front view thereof.

FIG. 3 is a rear view thereof.

FIG. 4 is a left side view thereof, the right side thereof being a mirror image

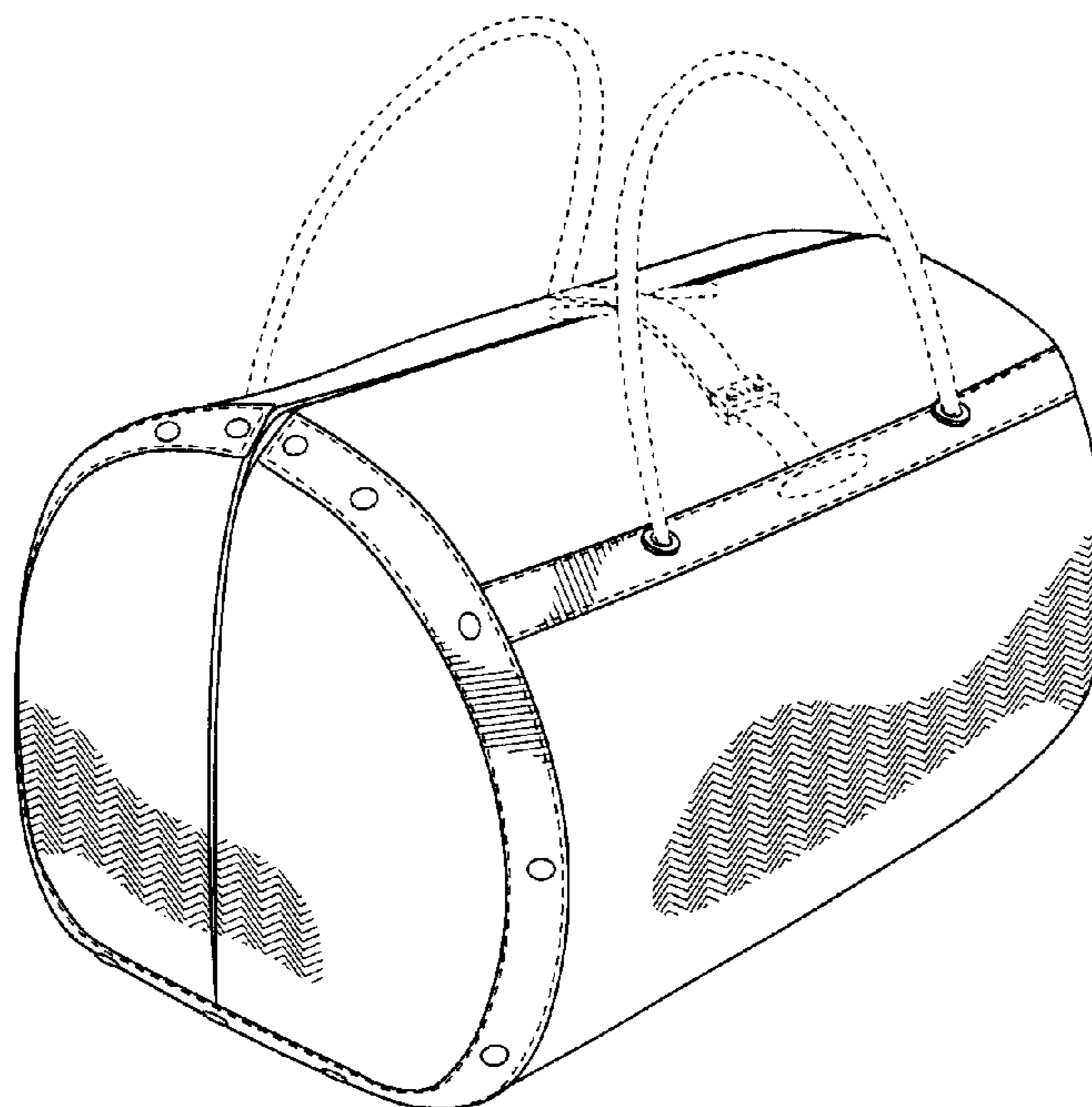
FIG. 5 is a top view thereof; and,

FIG. 6 is a bottom view thereof.

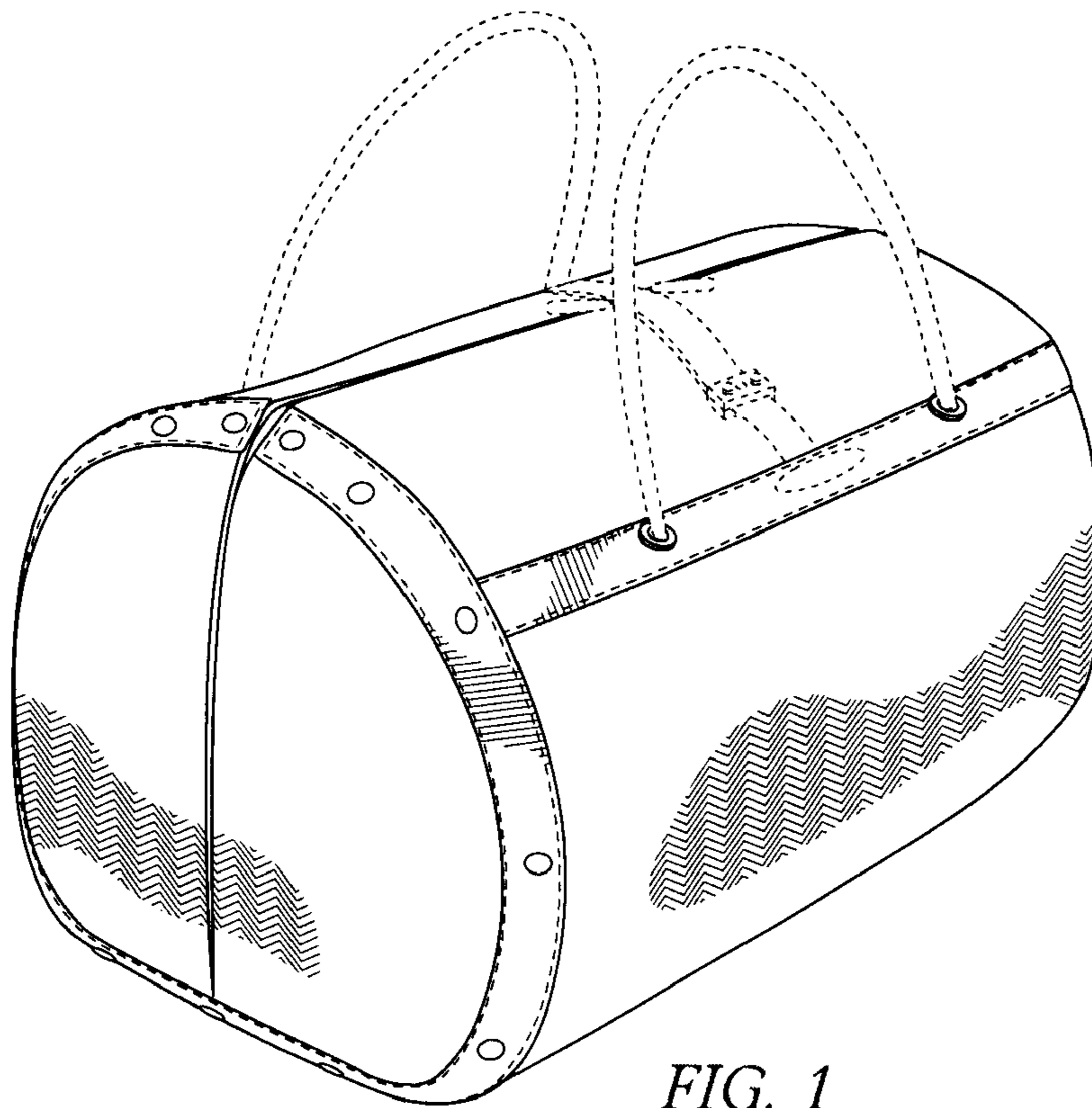

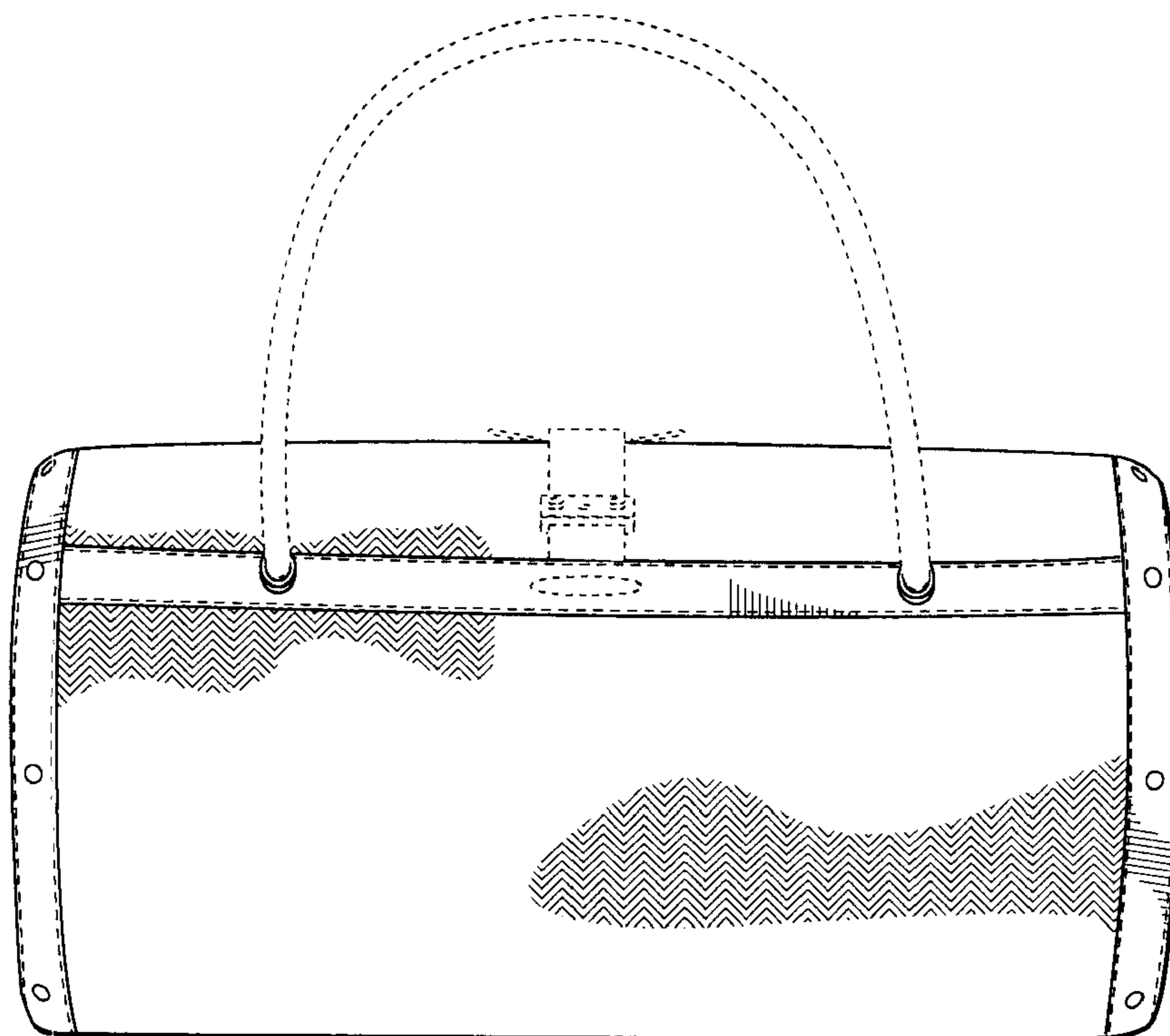

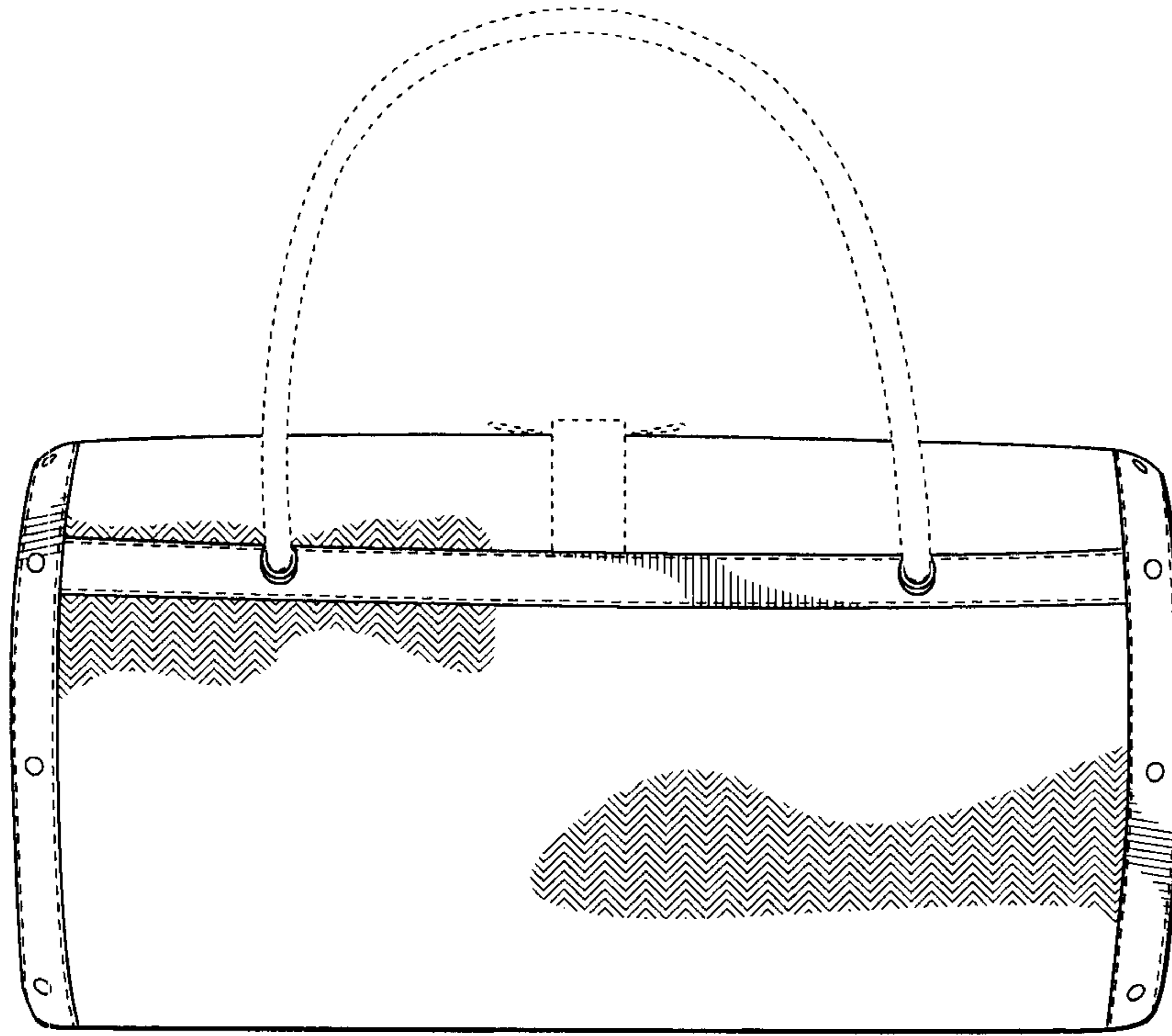

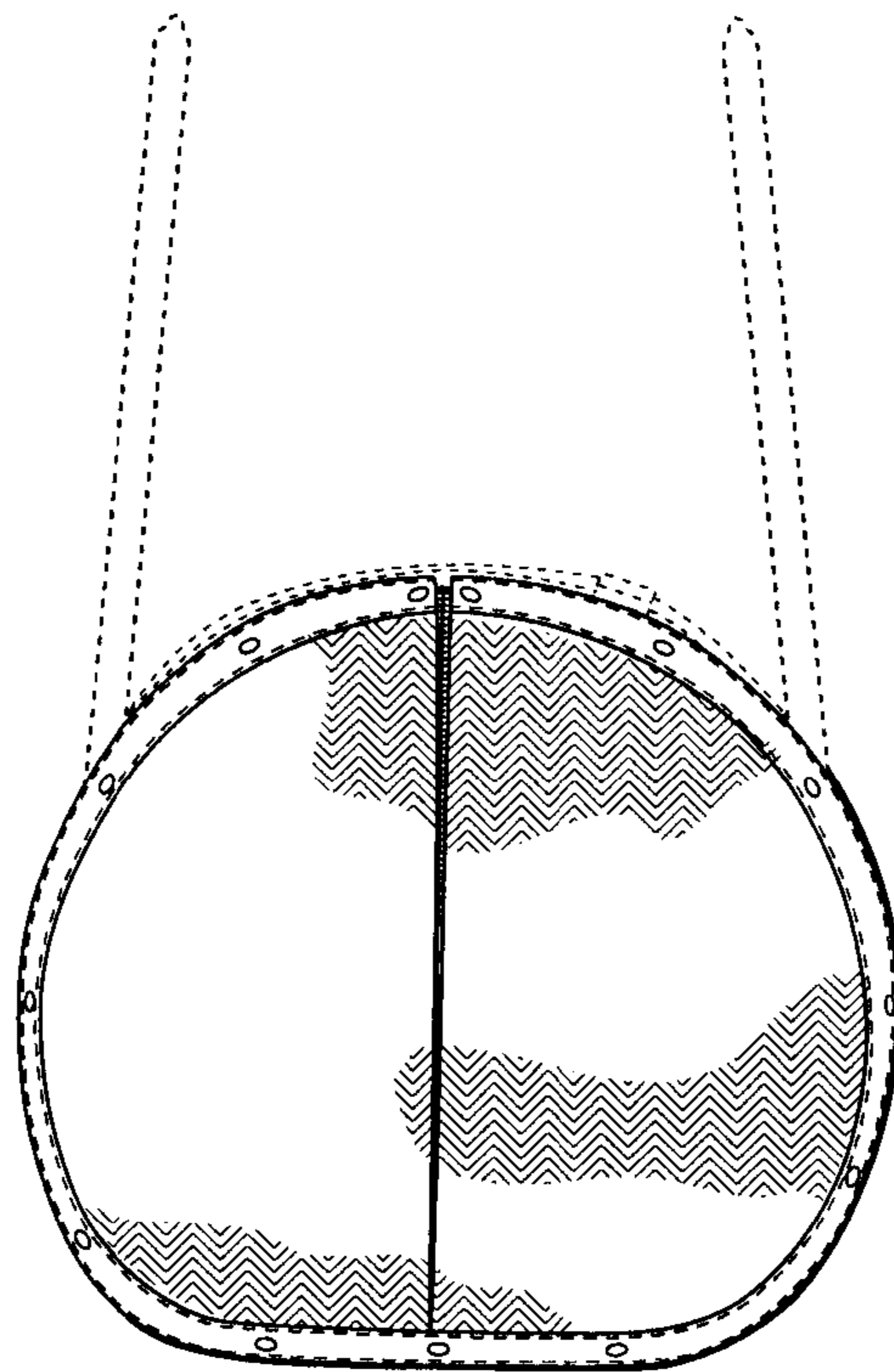

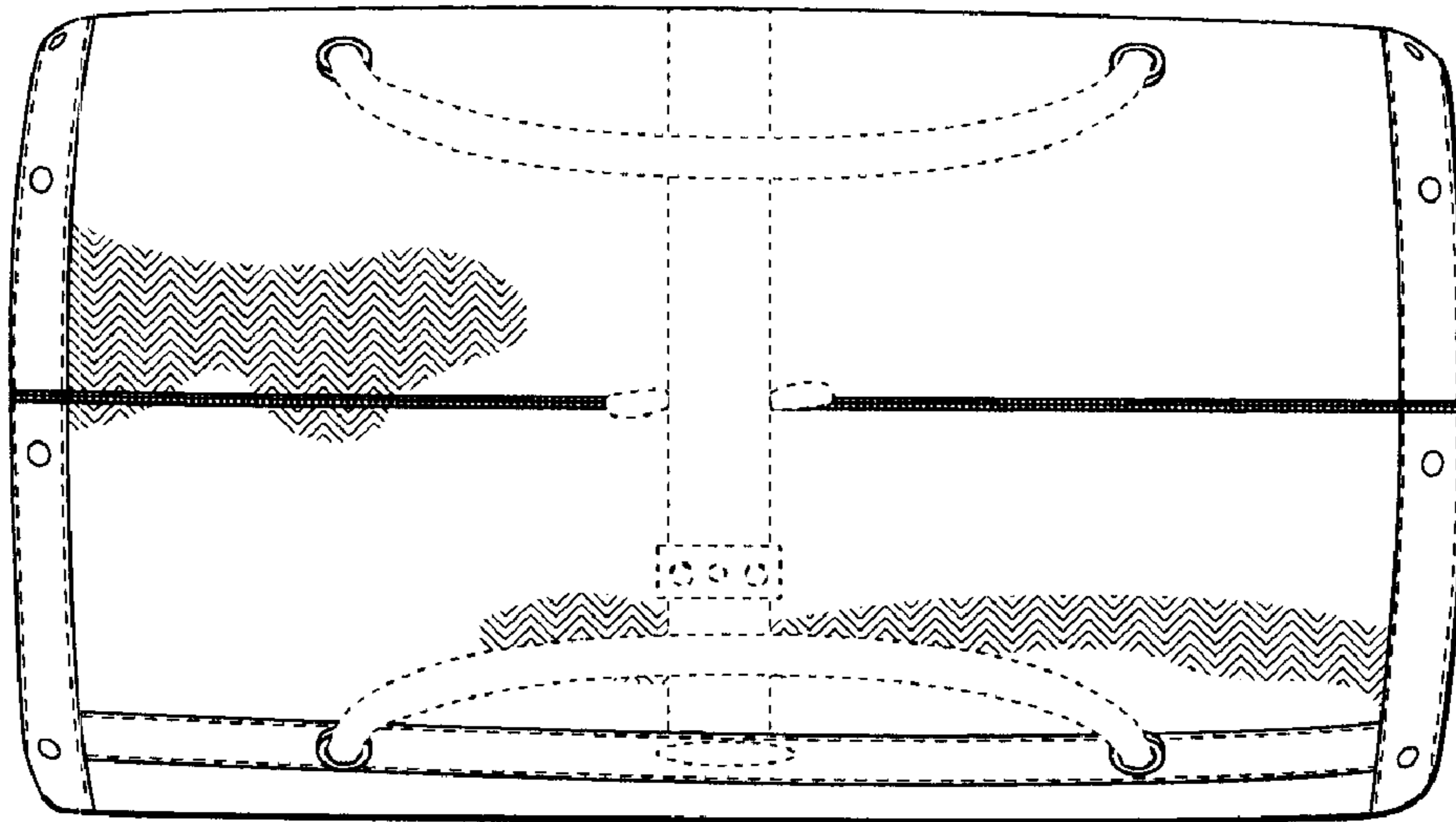

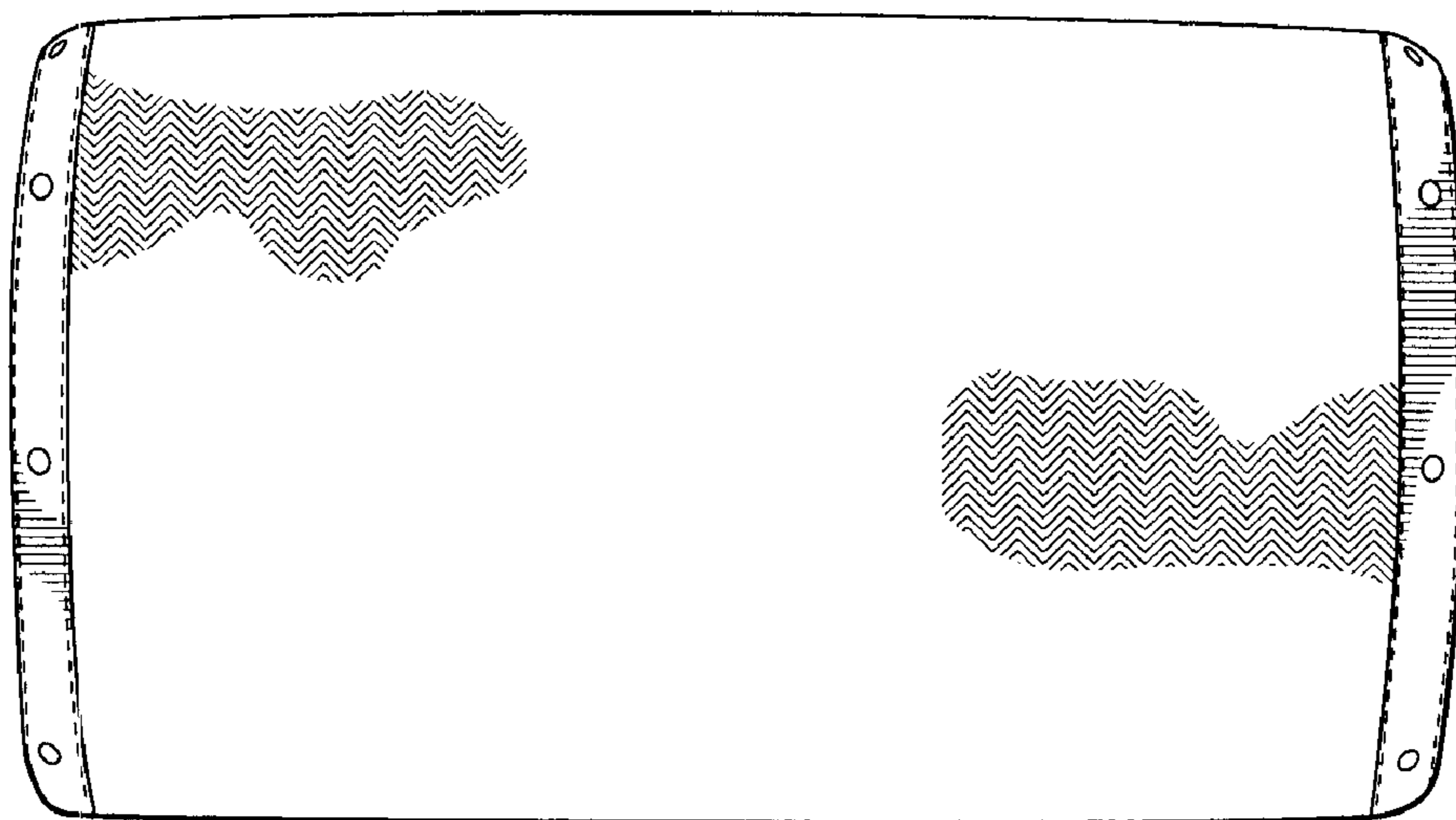
