FIG. 4 is a bottom view thereof.

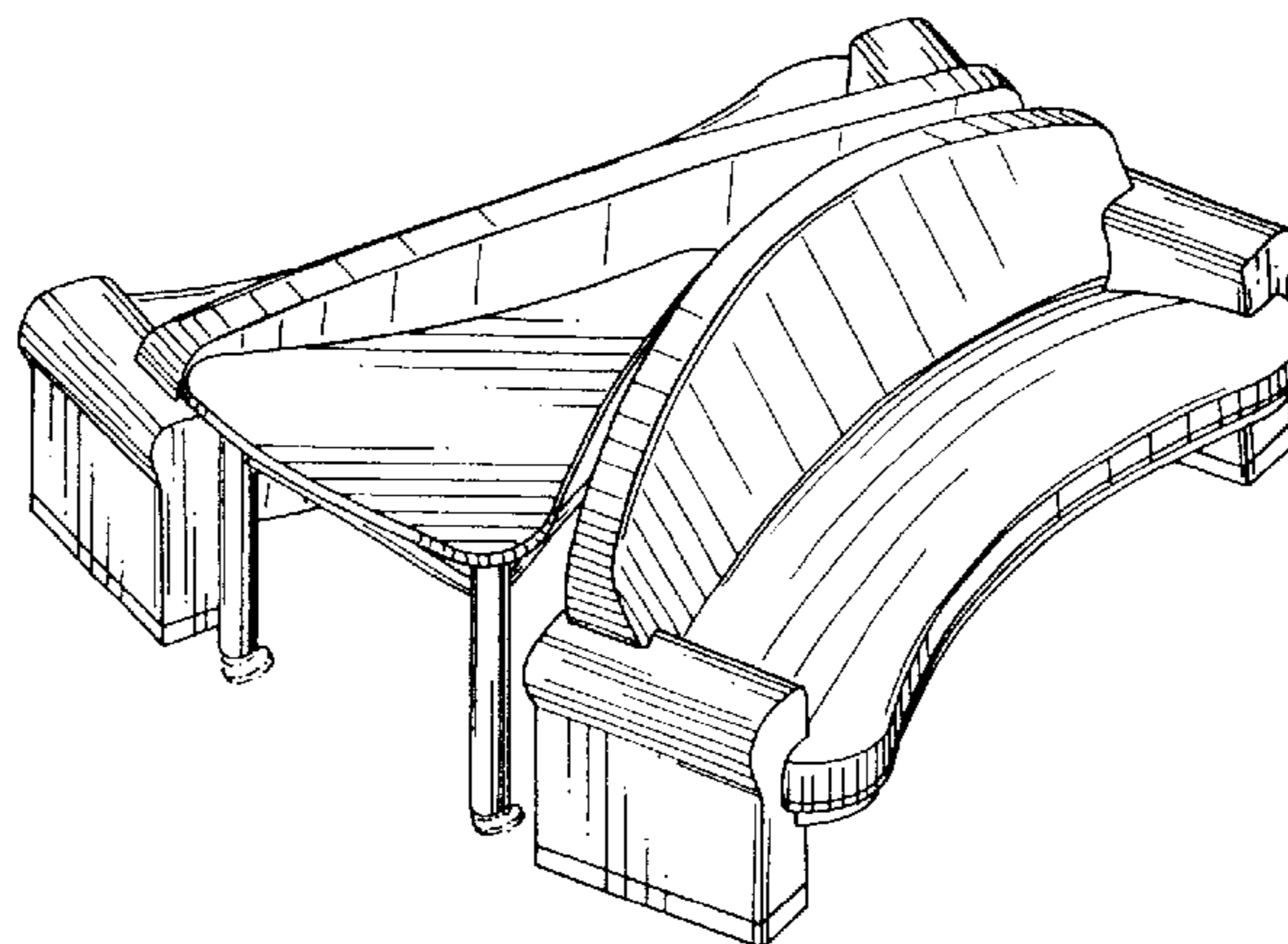
FIG. 5 is a left-side view thereof.

FIG. 6 is a top view thereof; and,

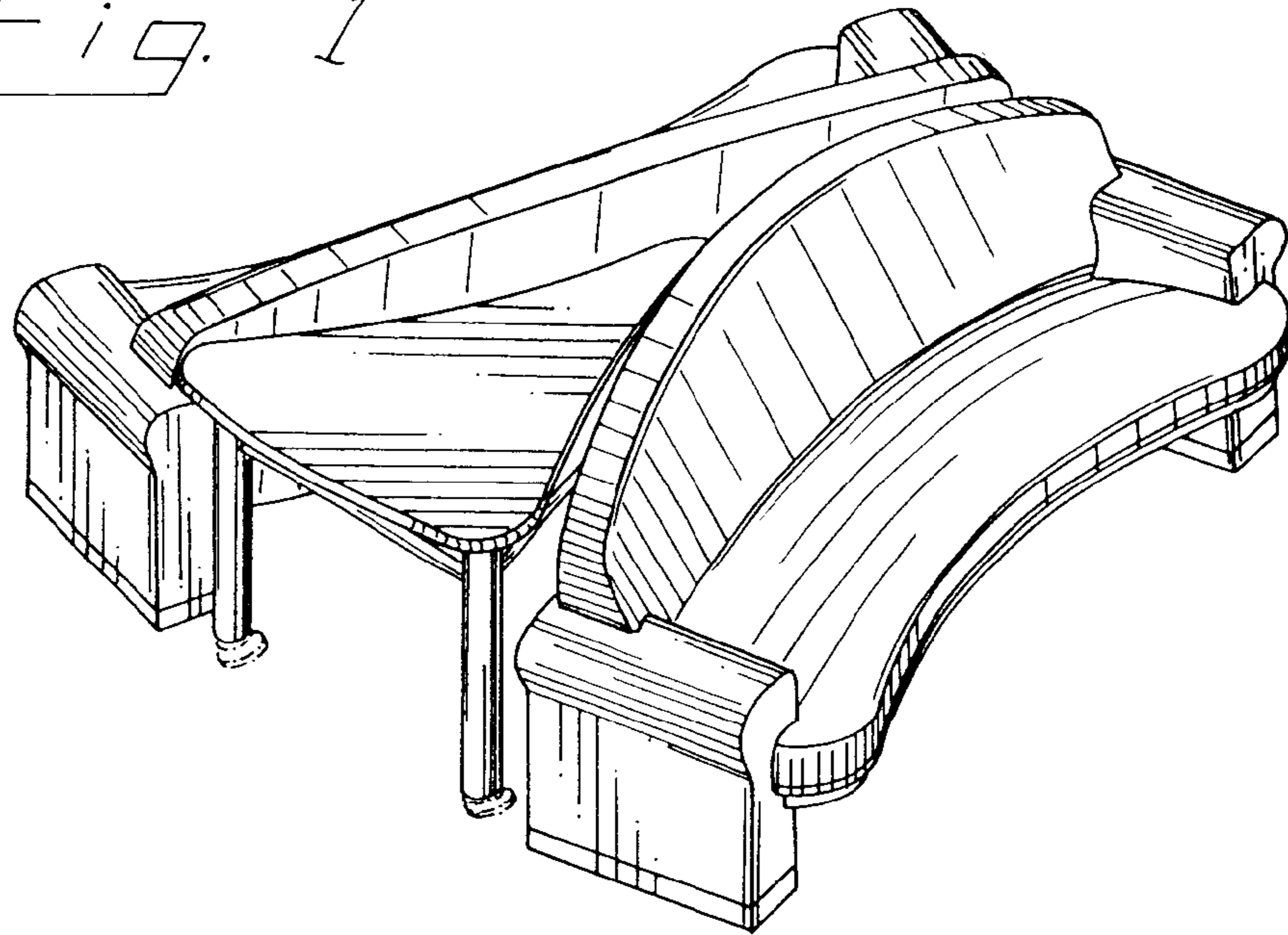
FIG. 7 is a front view thereof.

The broken line showing of the table and seat feet is for illustrative purposes only and forms no part of the claimed design.

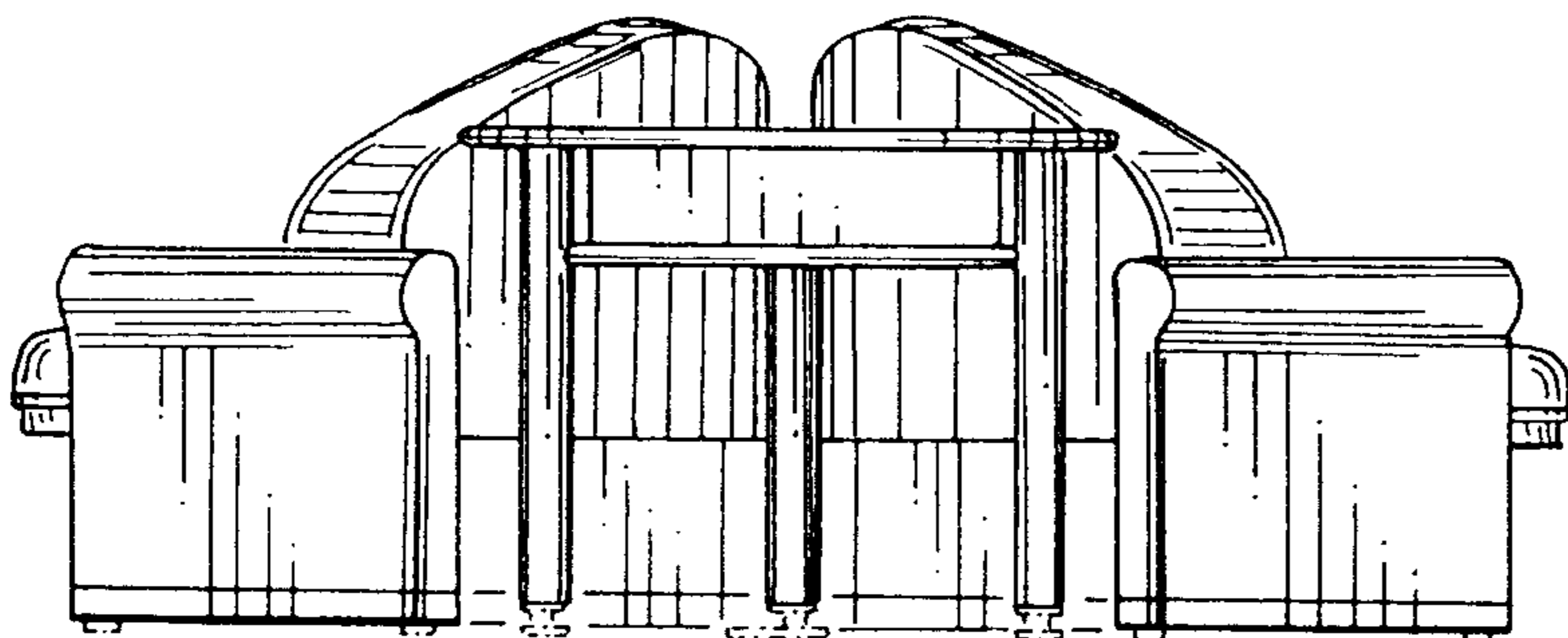
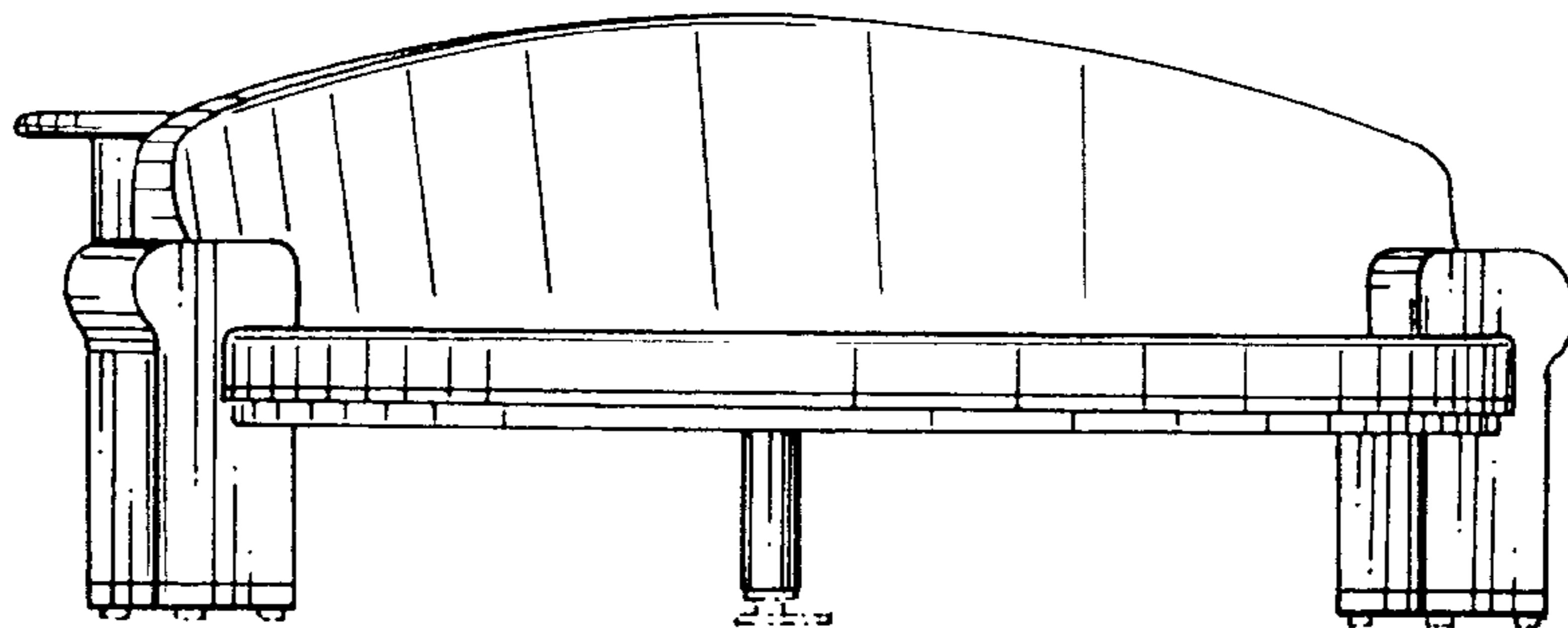

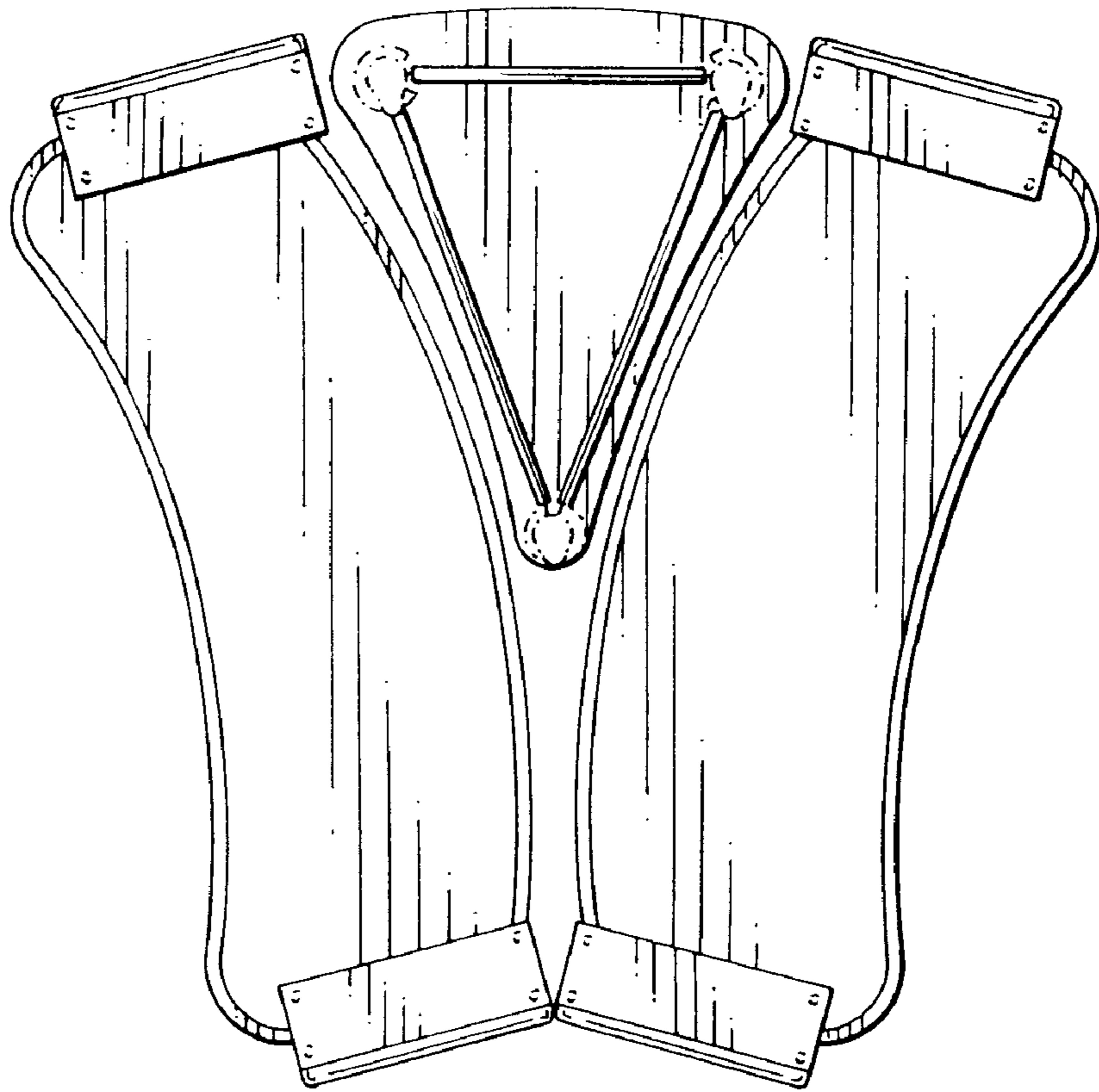

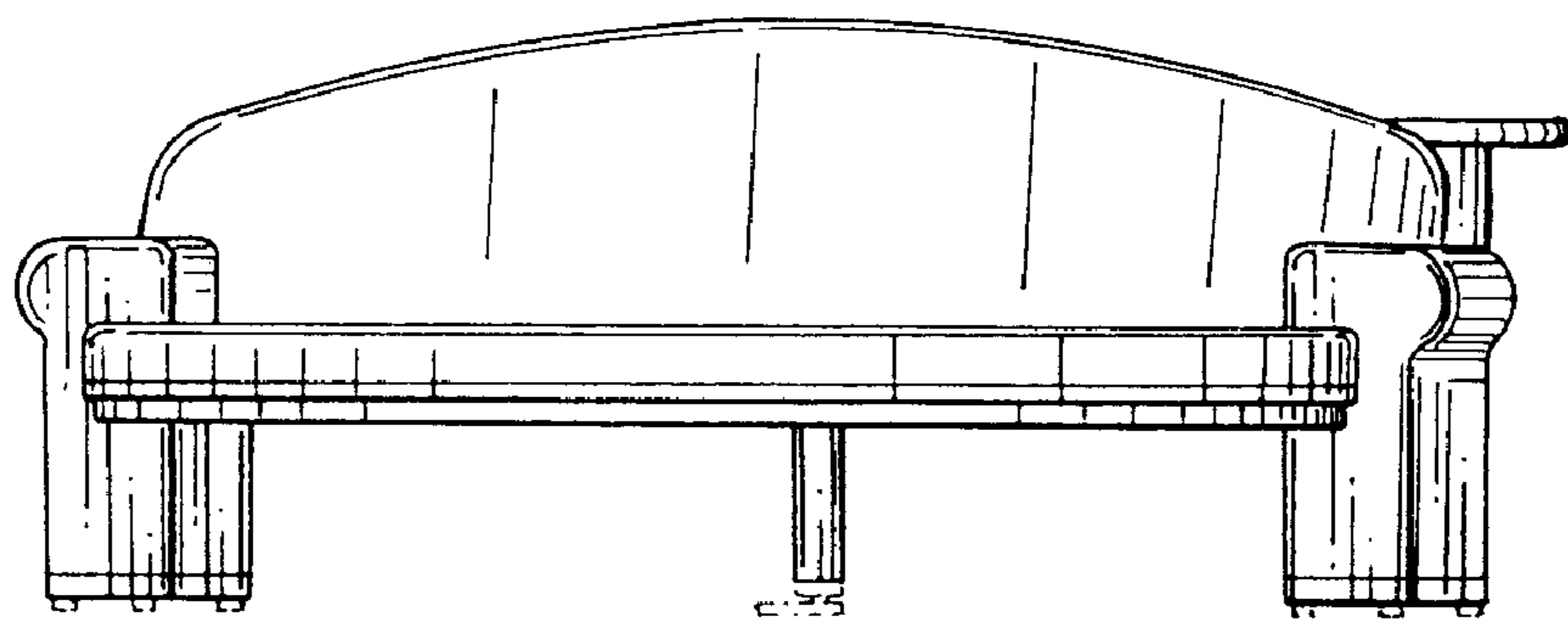

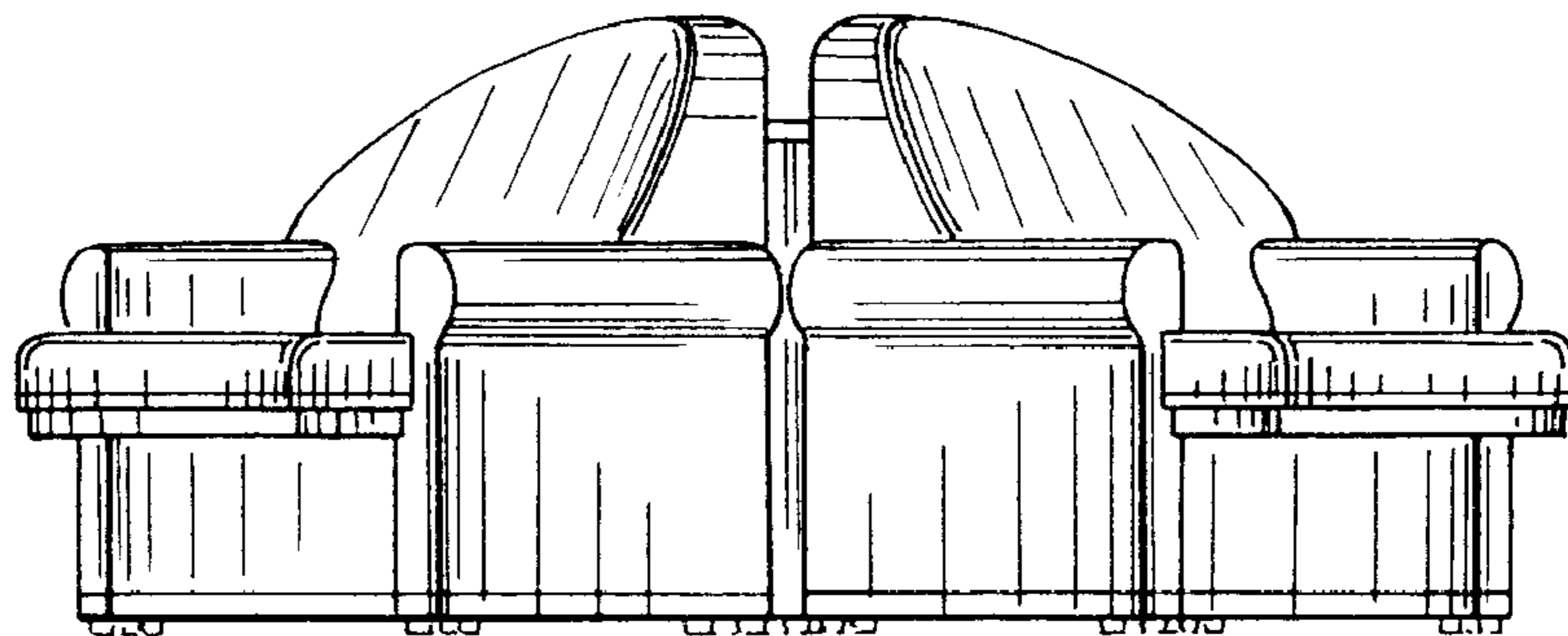
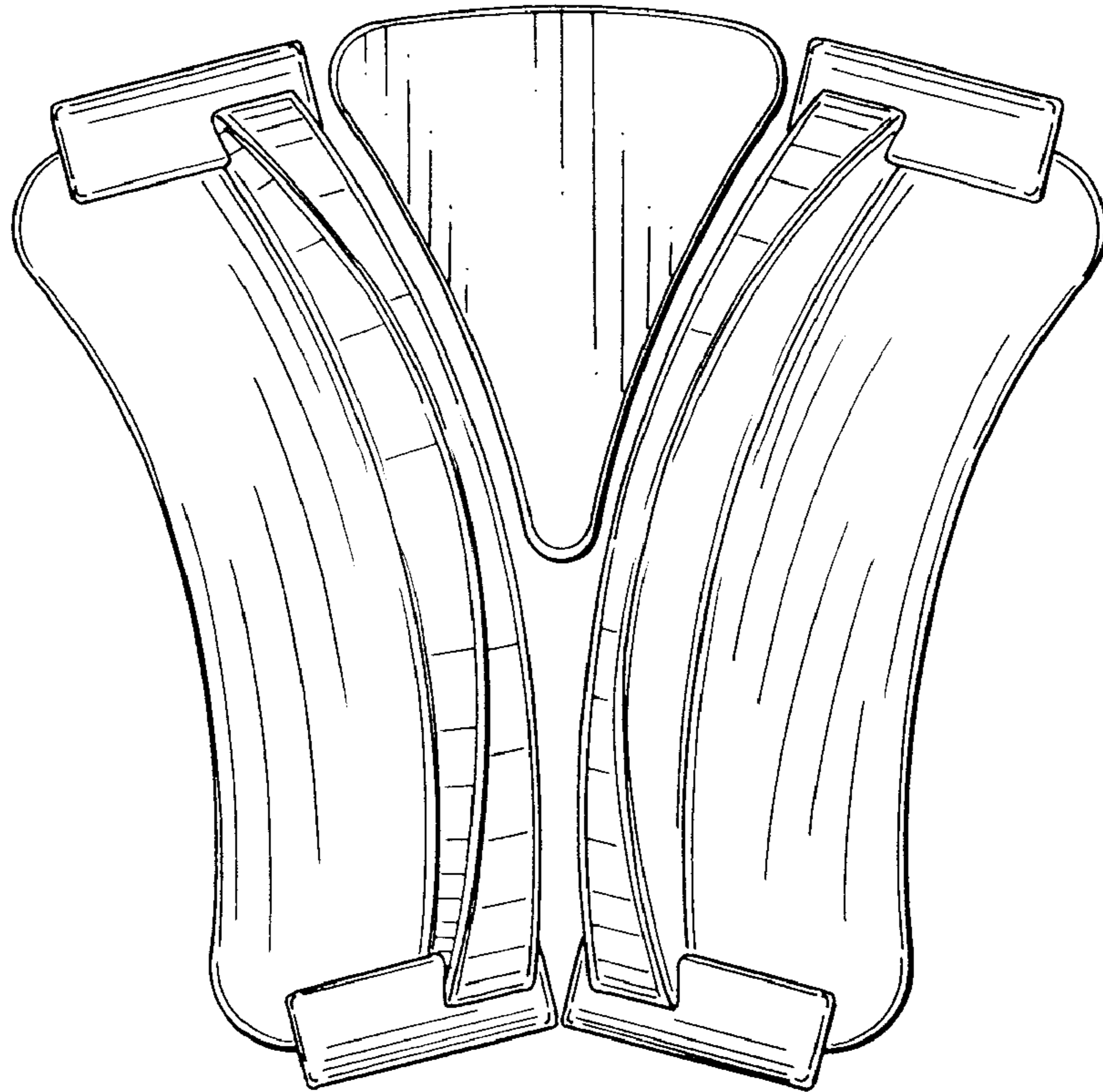
