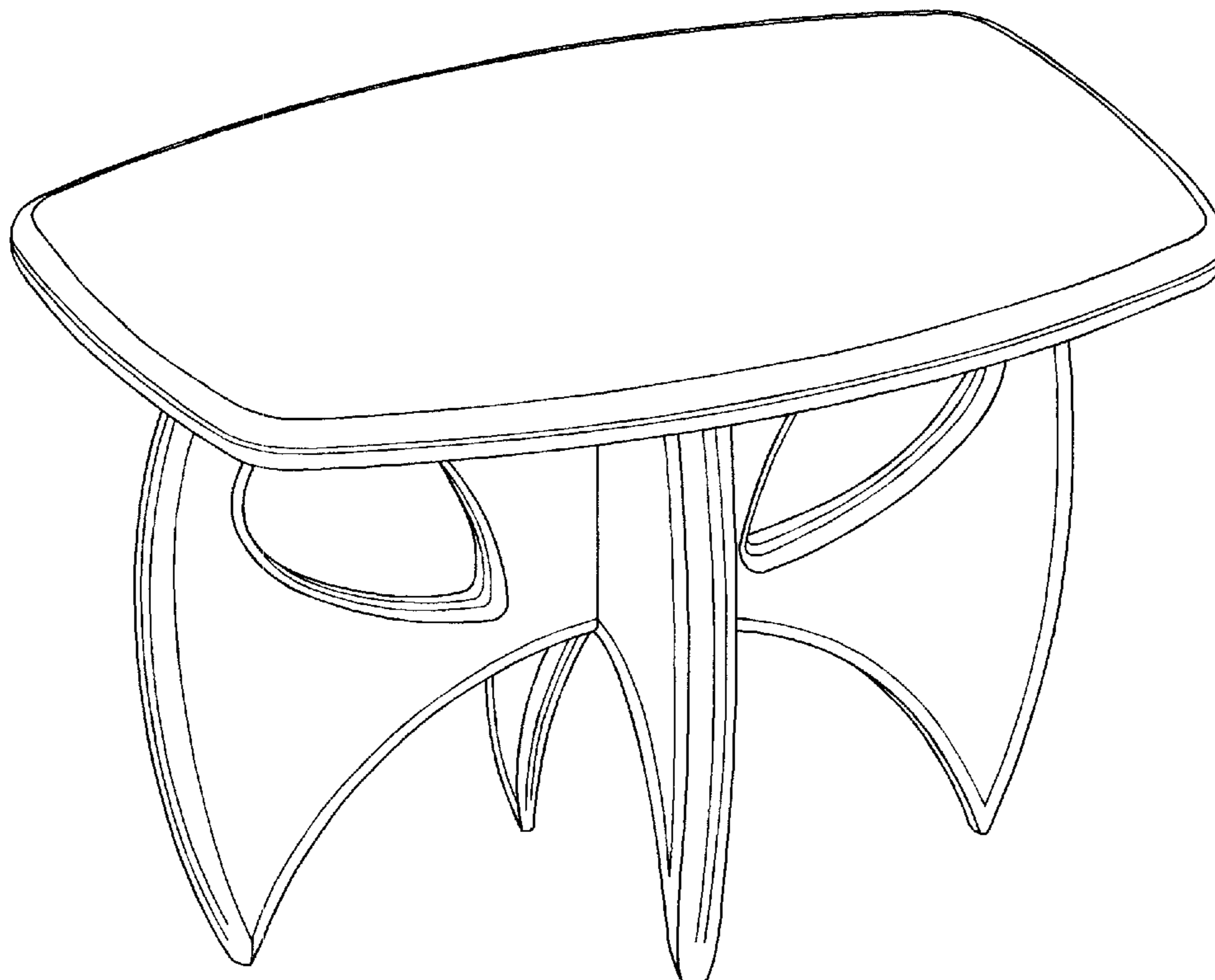
(57) **CLAIM**

The ornamental design for a stool, as shown and described.

**DESCRIPTION**

FIG. 1 is a top left perspective view of the stool showing the new design;  
 FIG. 2 is a front elevational view thereof on a reduced scale;  
 FIG. 3 is a right side elevational view thereof on a reduced scale;  
 FIG. 4 is a rear elevational view thereof on a reduced scale;  
 FIG. 5 is a left side elevational view thereof on a reduced scale;  
 FIG. 6 is a top plan view thereof on a reduced scale; and,  
 FIG. 7 is a bottom plan view thereof on a reduced scale.

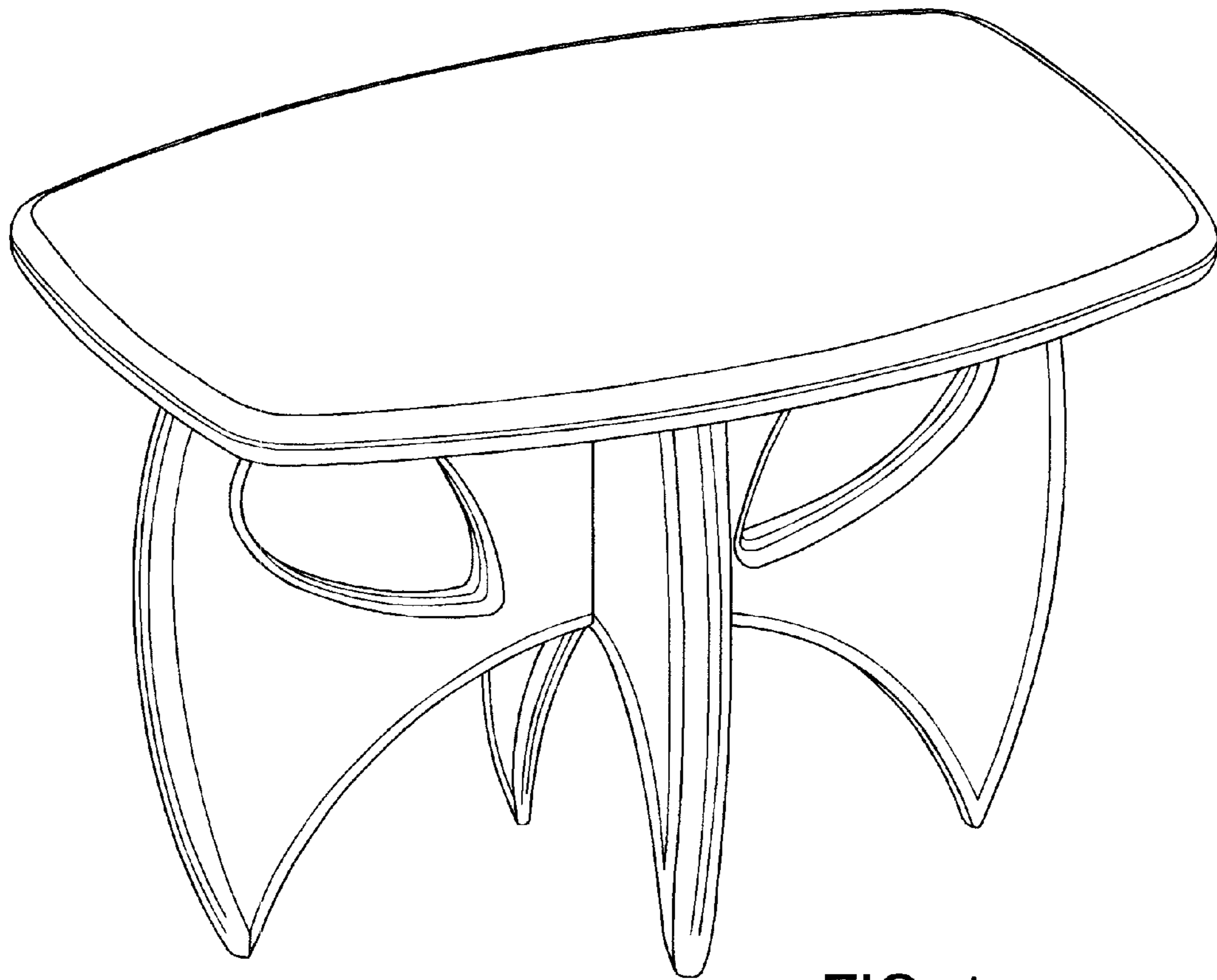

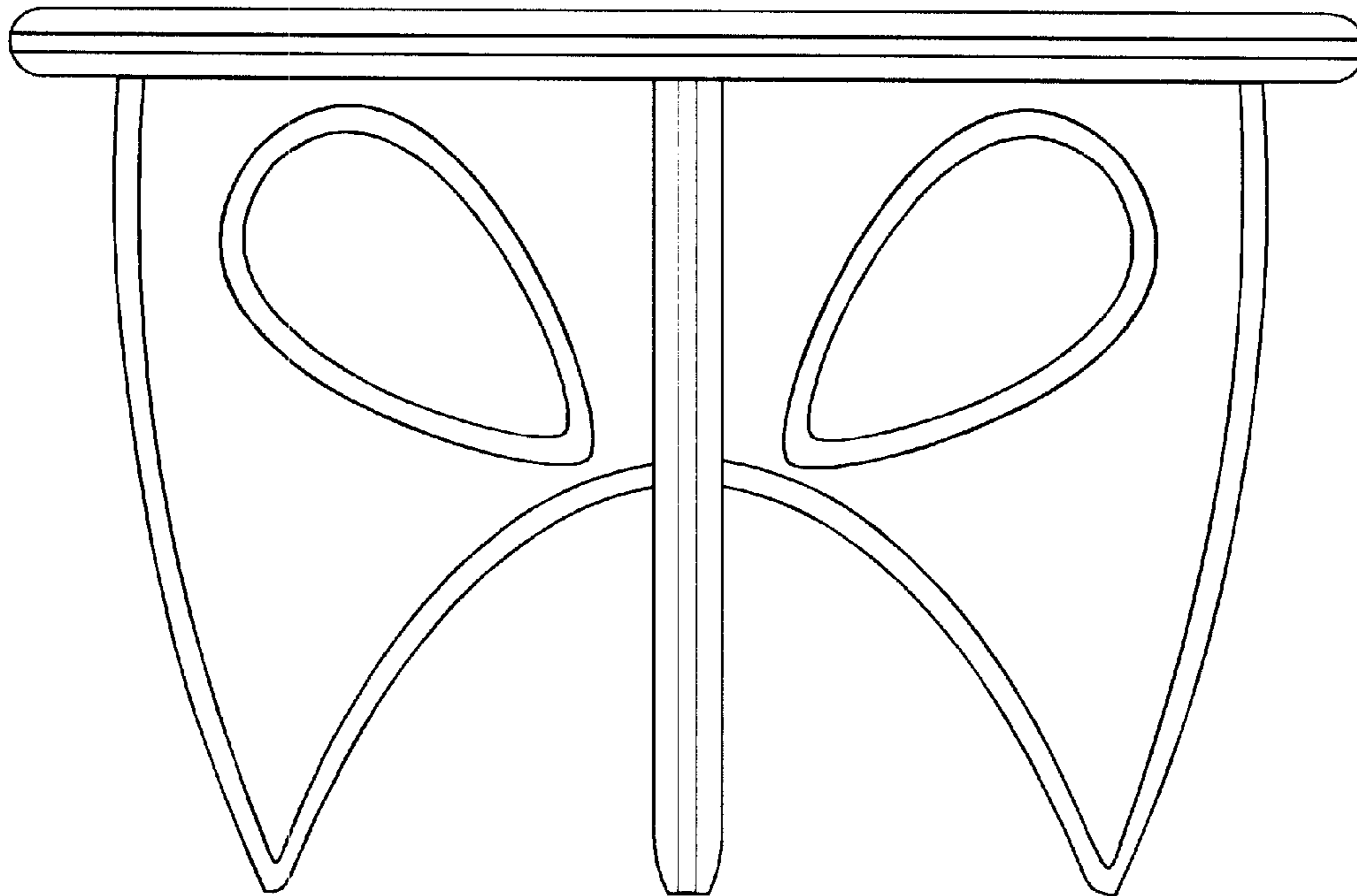

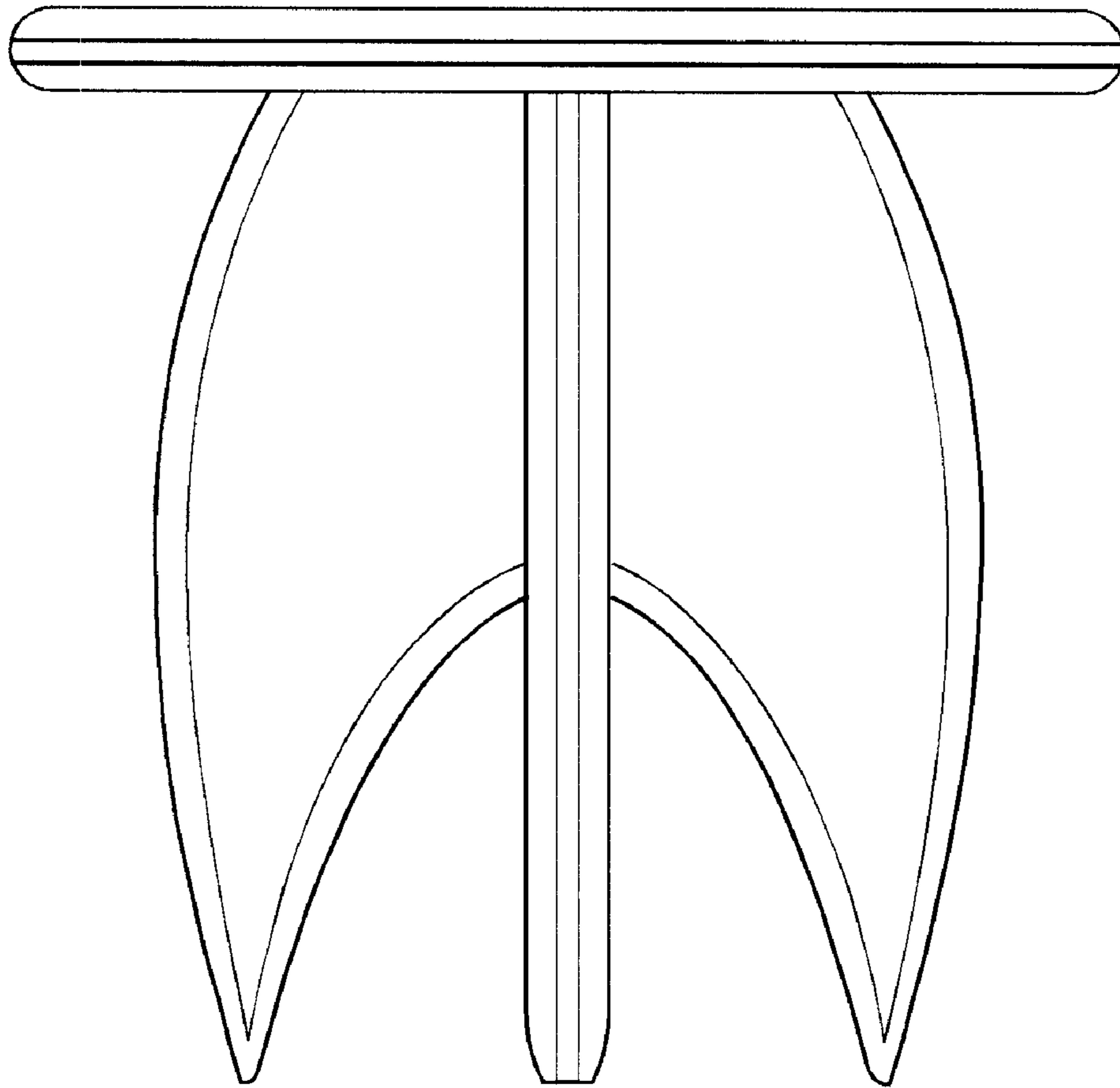

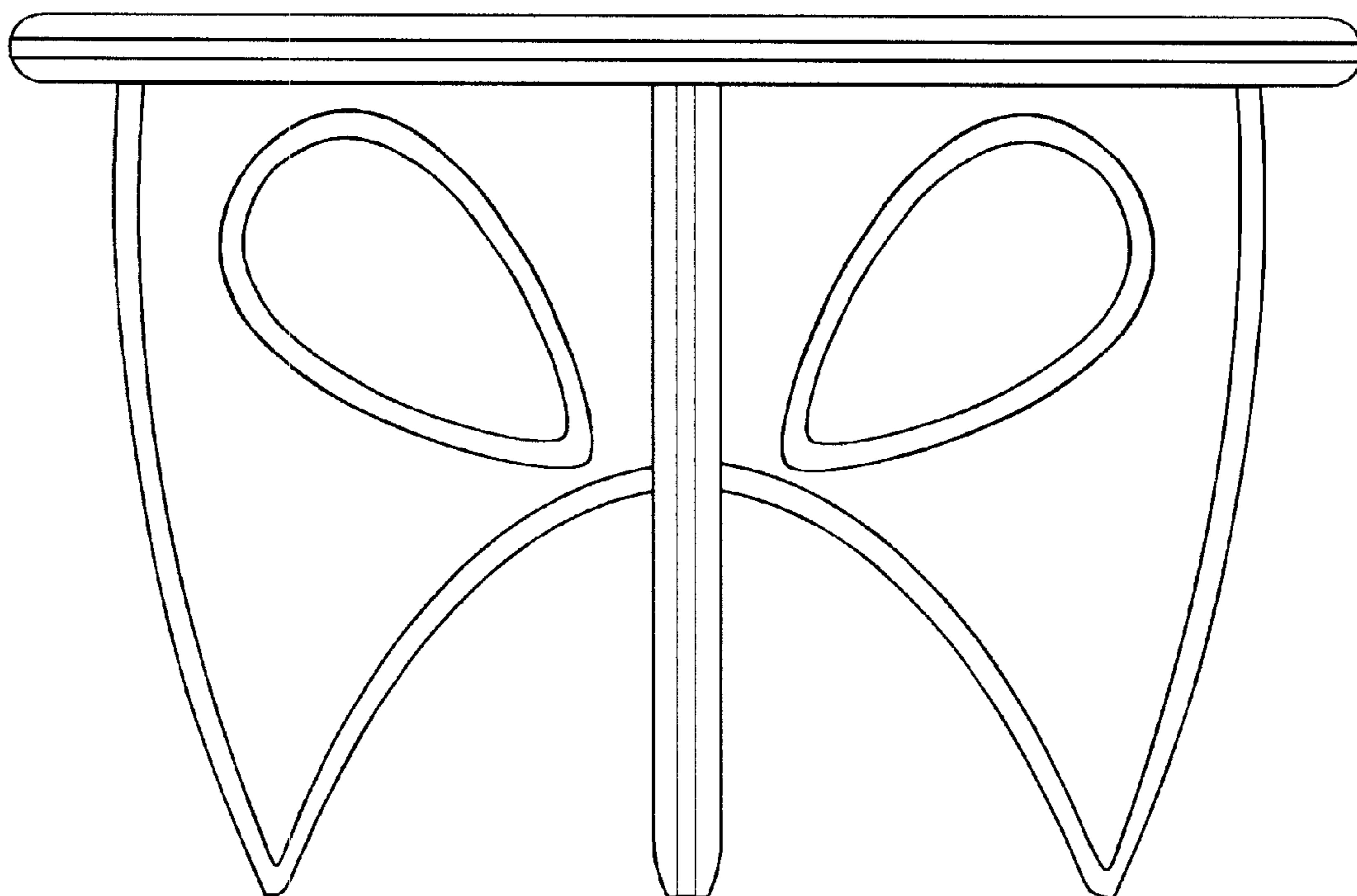

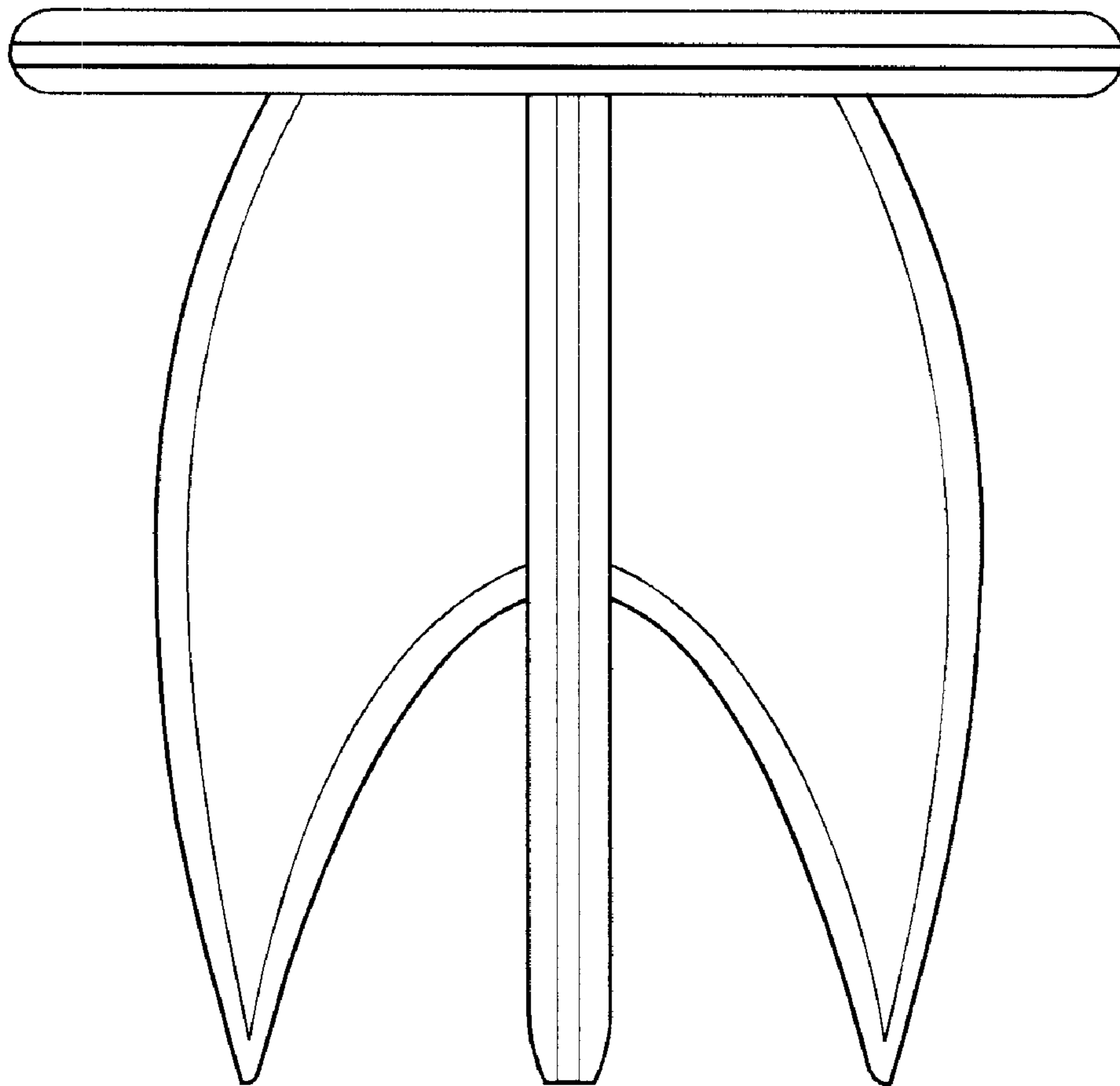

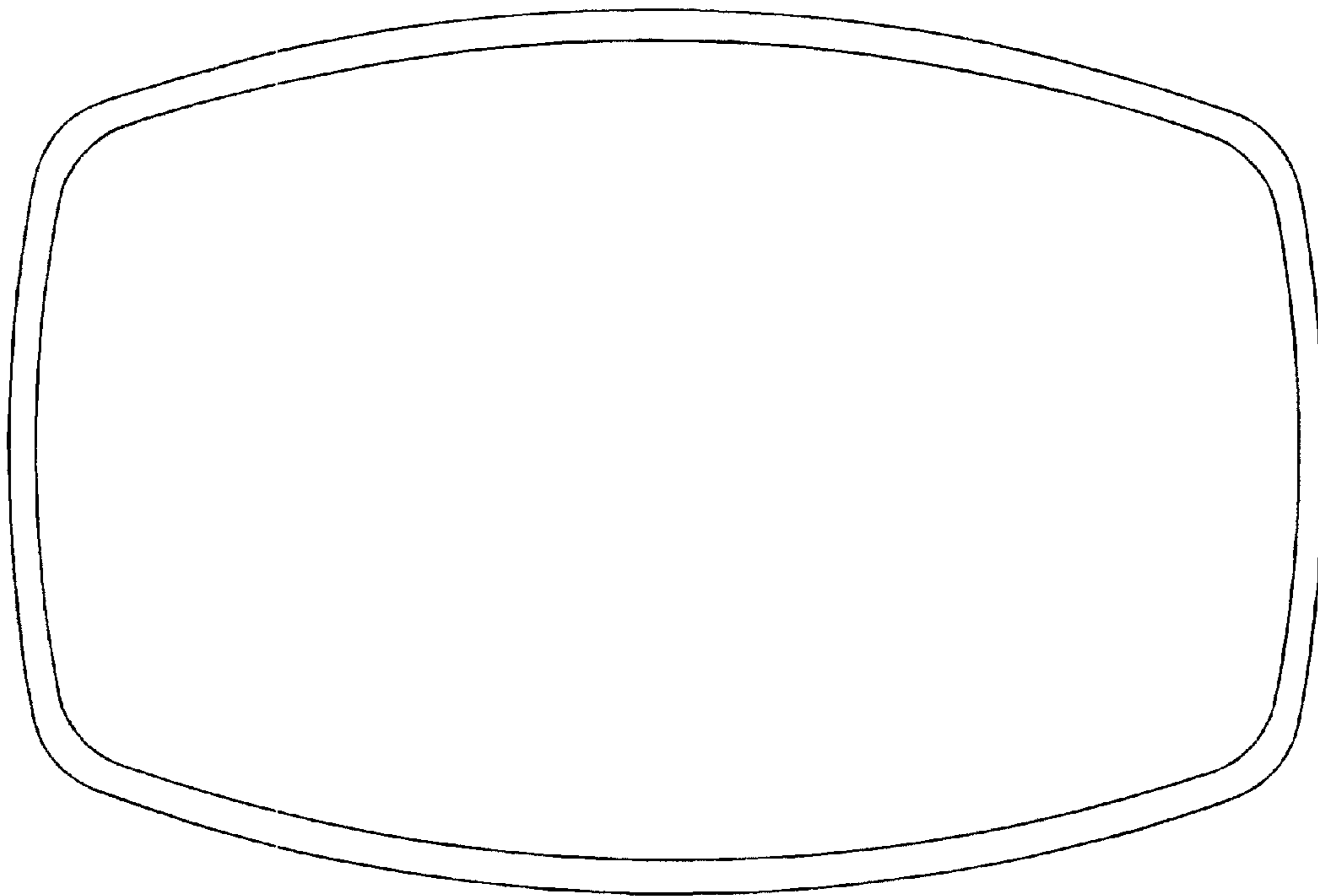

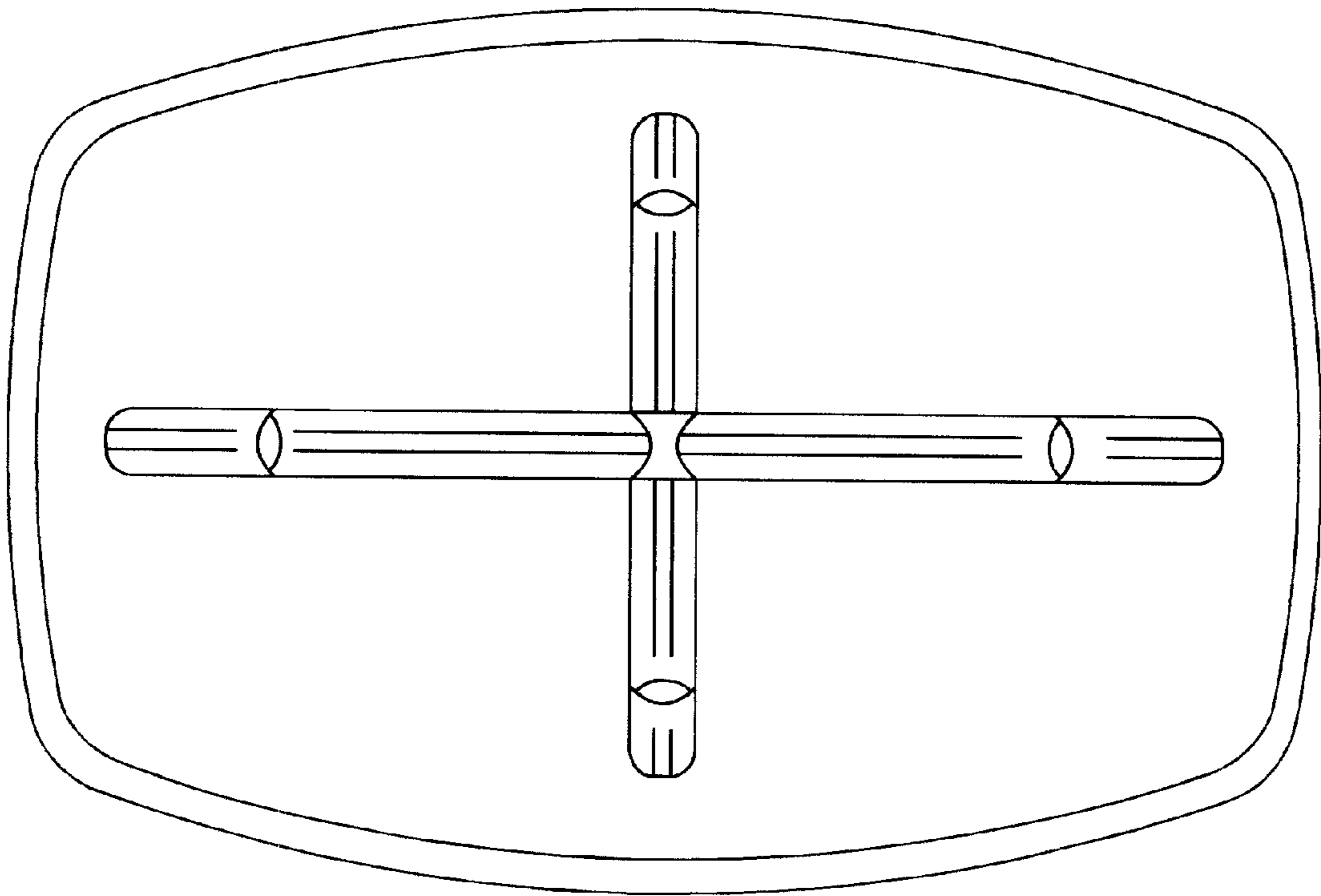
