(57) **CLAIM**

We claim the ornamental design for a end table, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an end table according to an embodiment of the invention.

FIG. 2 is a front elevational view of an end table according to an embodiment of the invention.

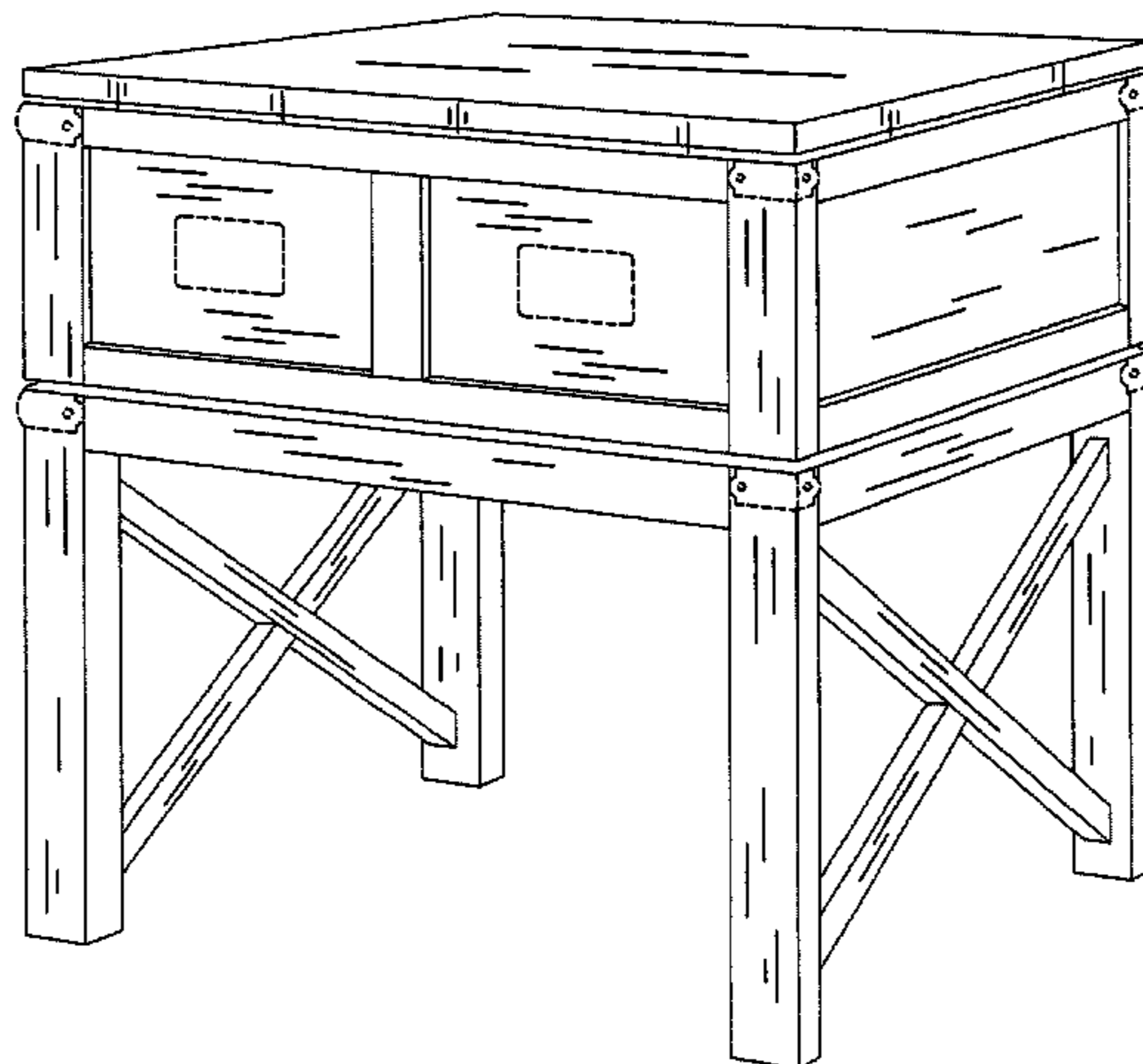
FIG. 3 is a side elevational view of an end table according to an embodiment of the invention. The elevational view of the opposite side being a mirror image thereof.

FIG. 4 is a top plan view of an end table according to an embodiment of the invention; and,

FIG. 5 is a back elevational view of an end table according to an embodiment of the invention.

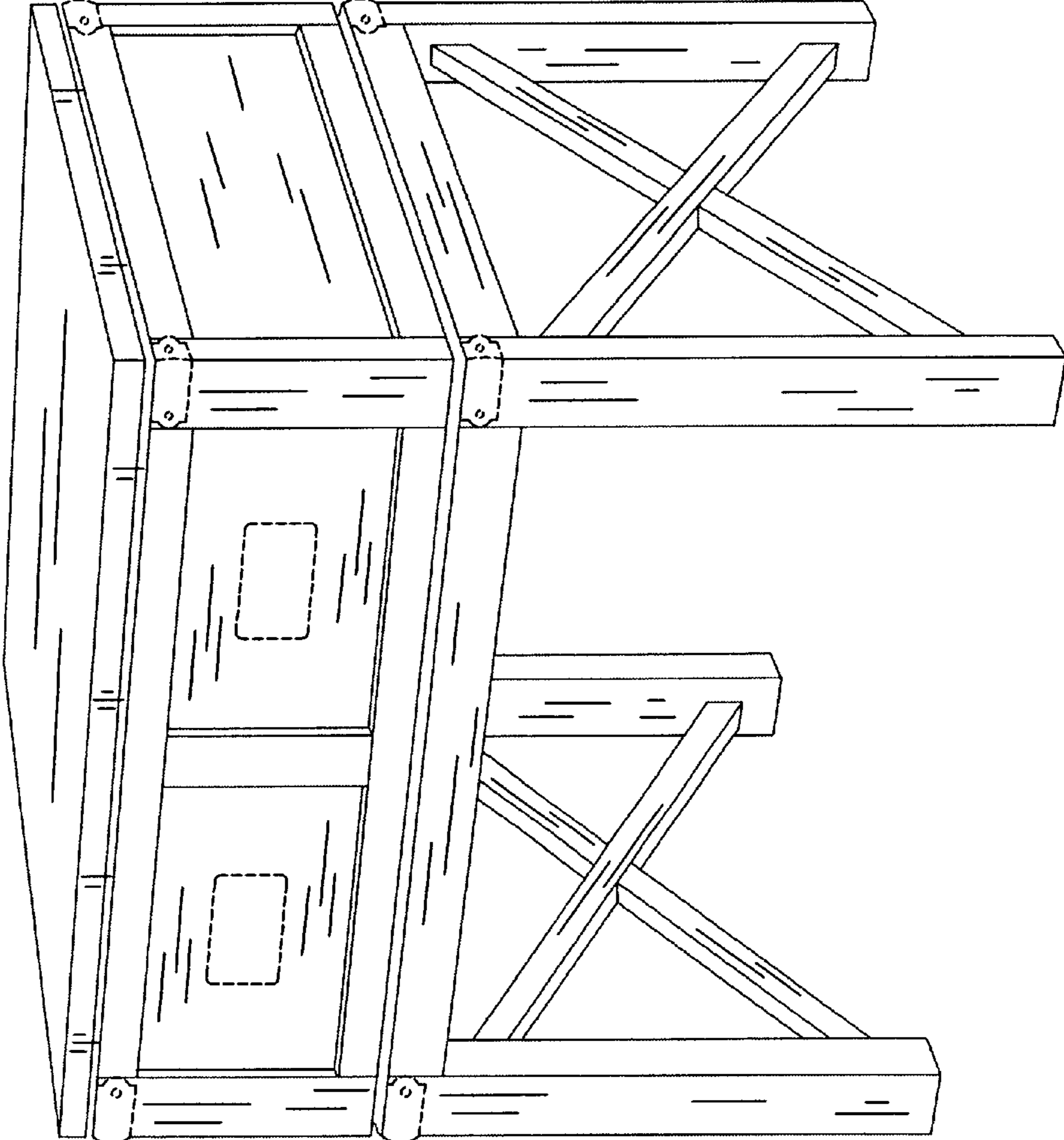

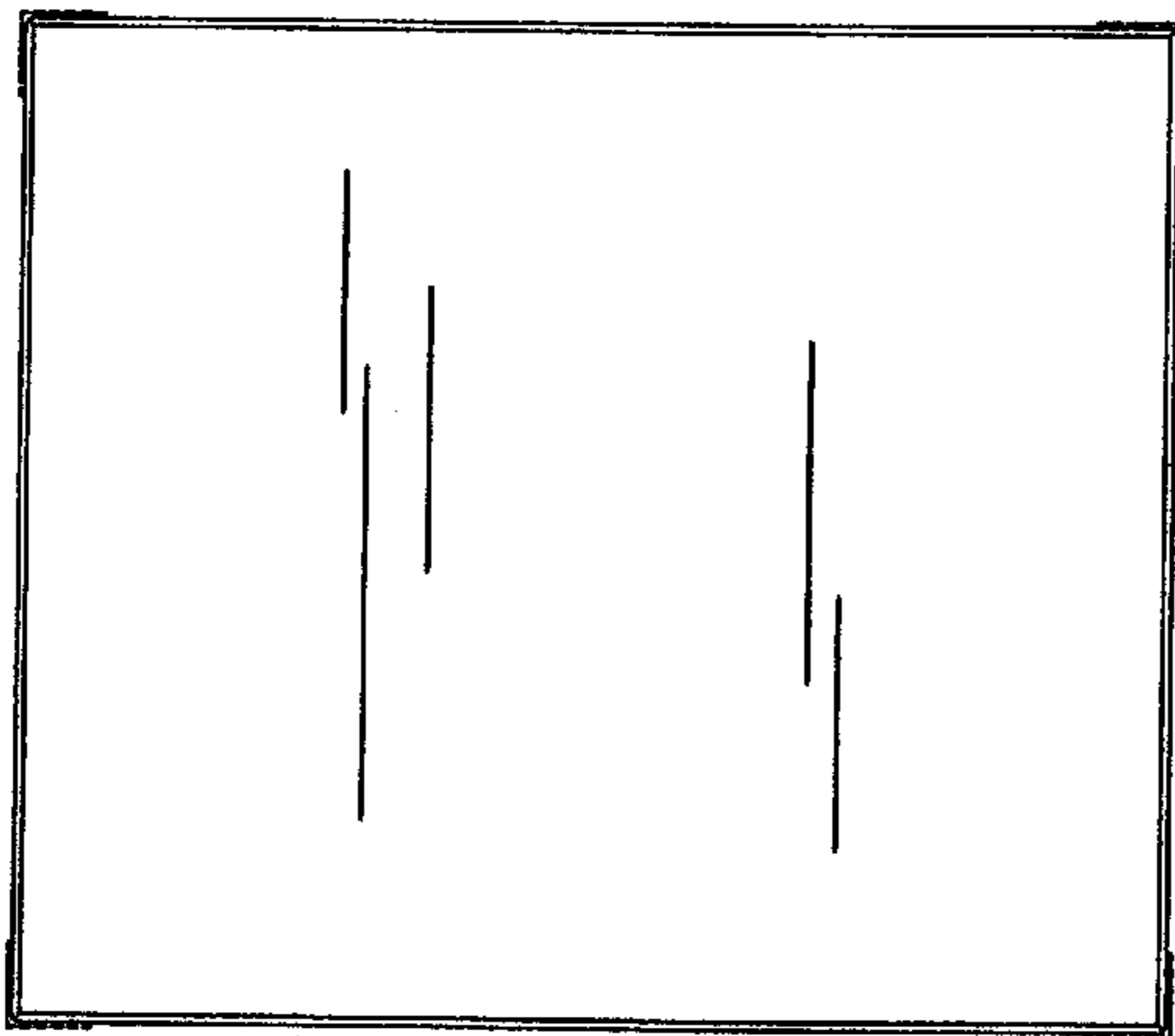

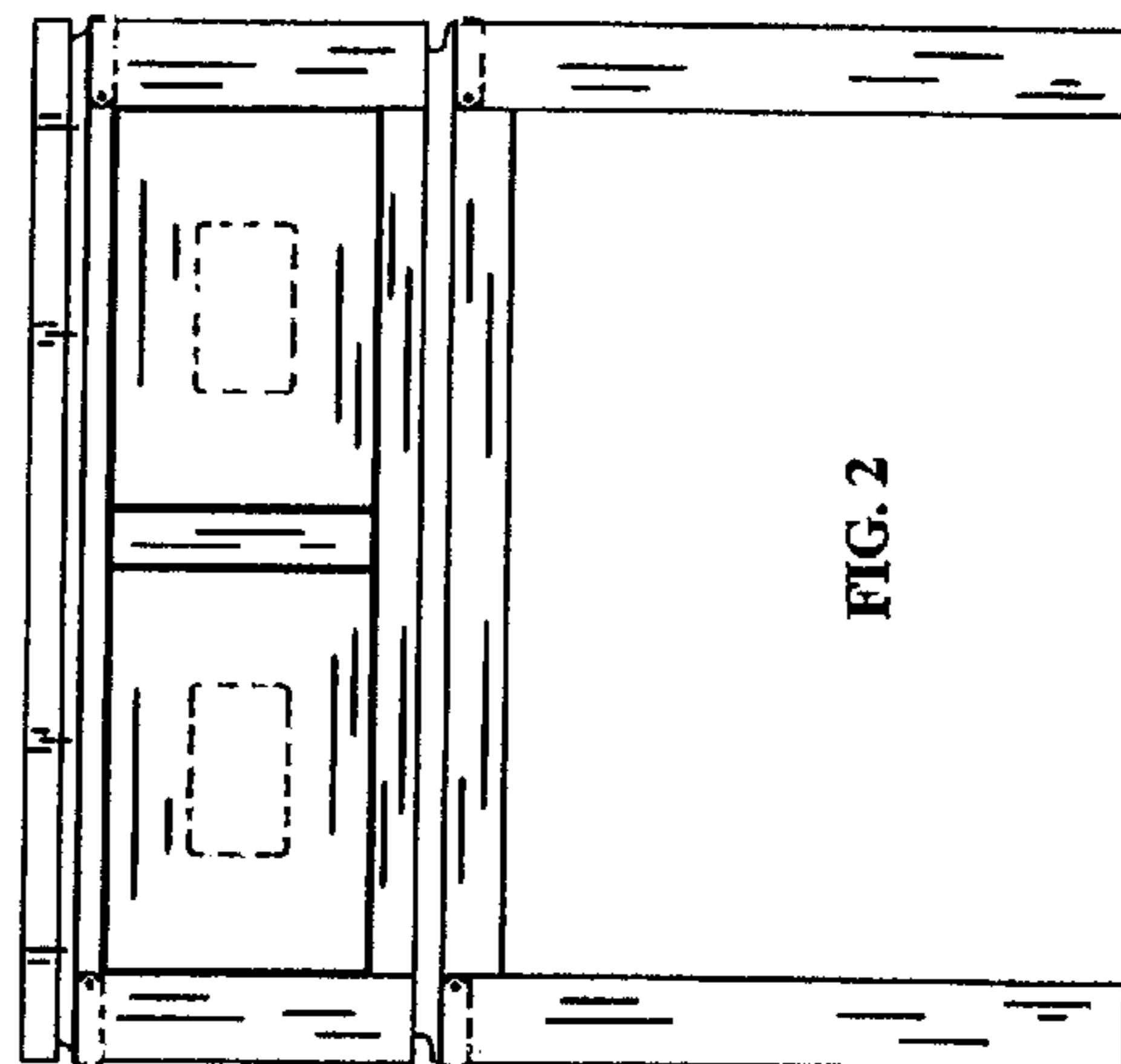

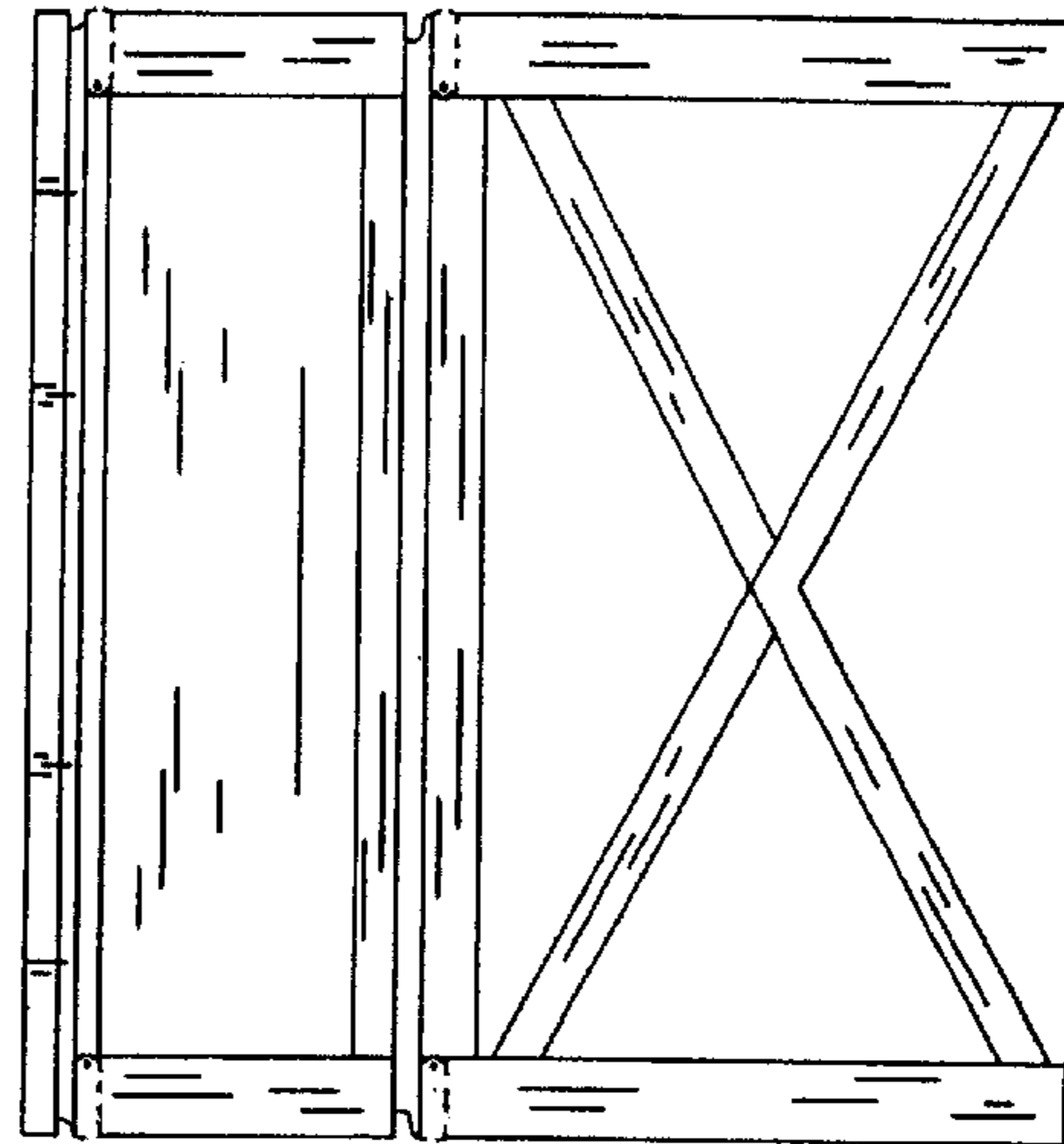

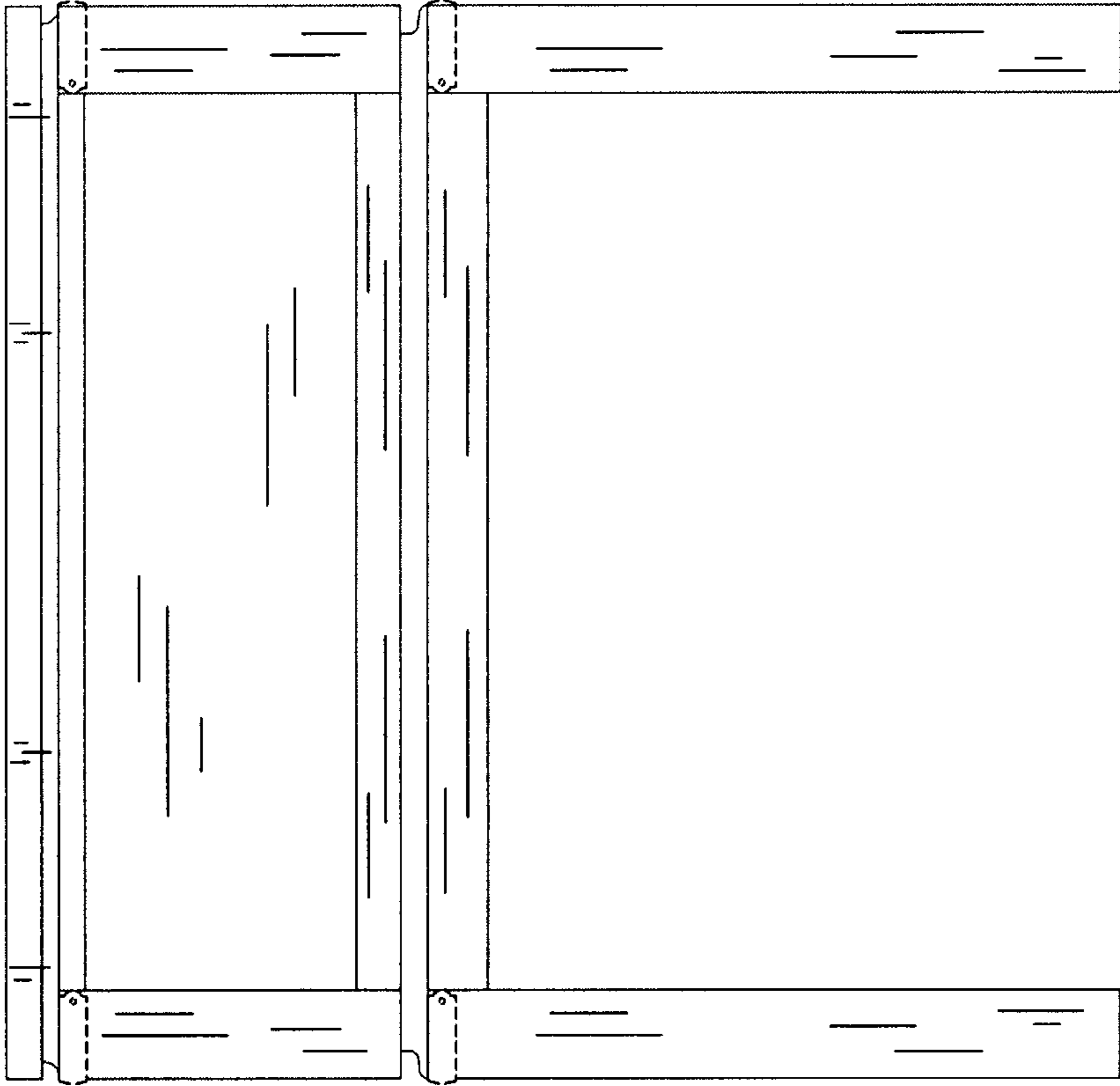
