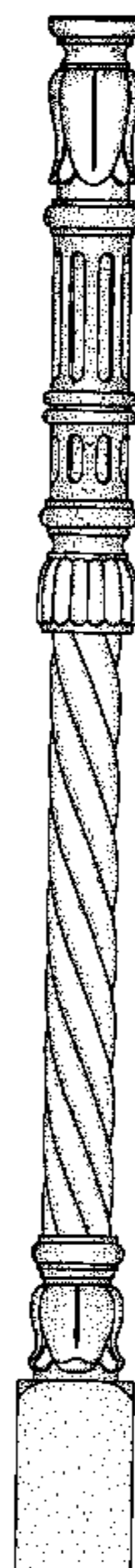

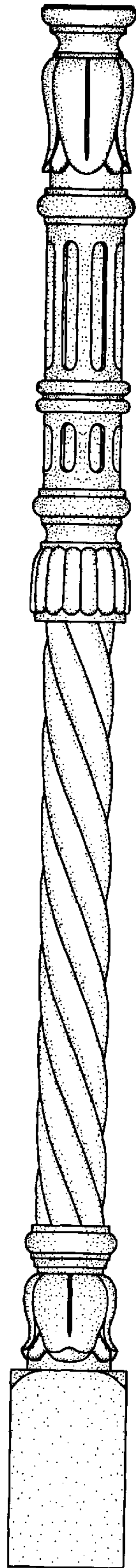
The ornamental design for a cabinet post, as shown and described.

**DESCRIPTION**

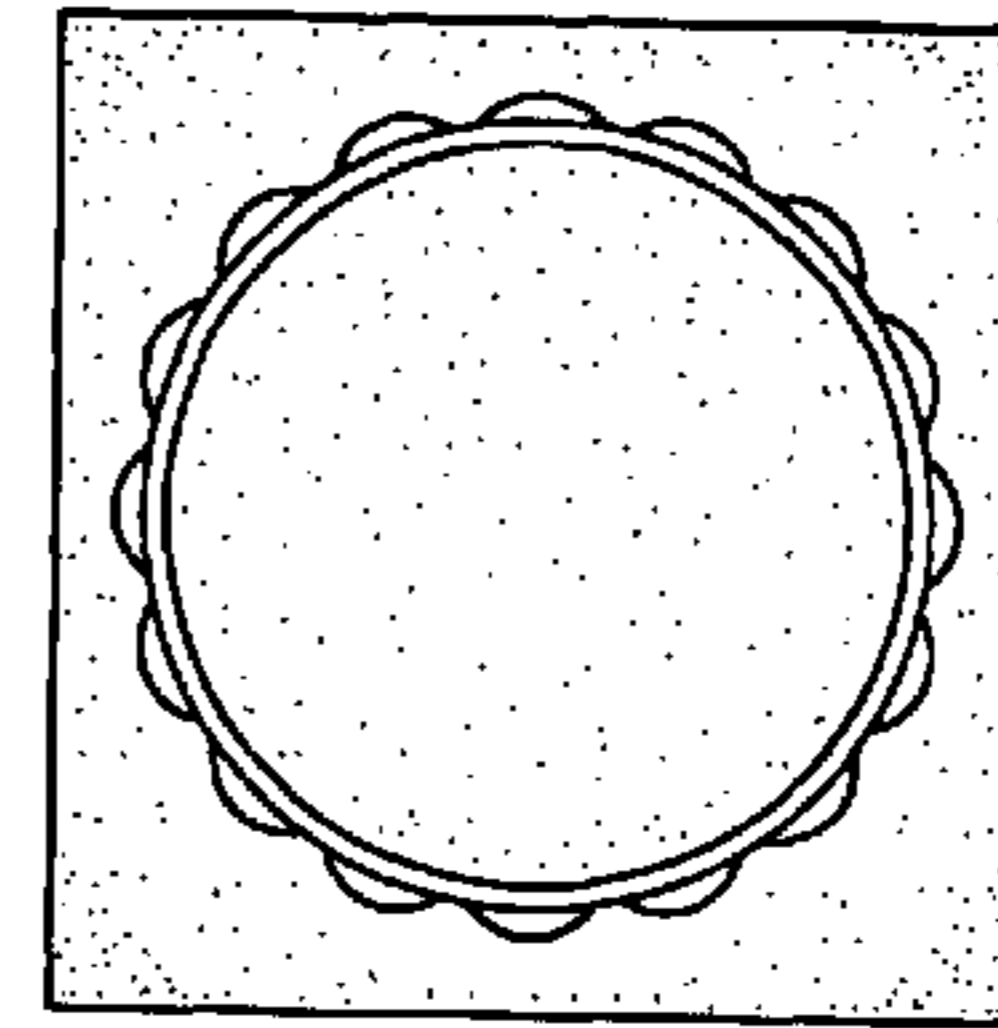
FIG. 1 is a front elevational view of the cabinet post of the present invention showing my new design;

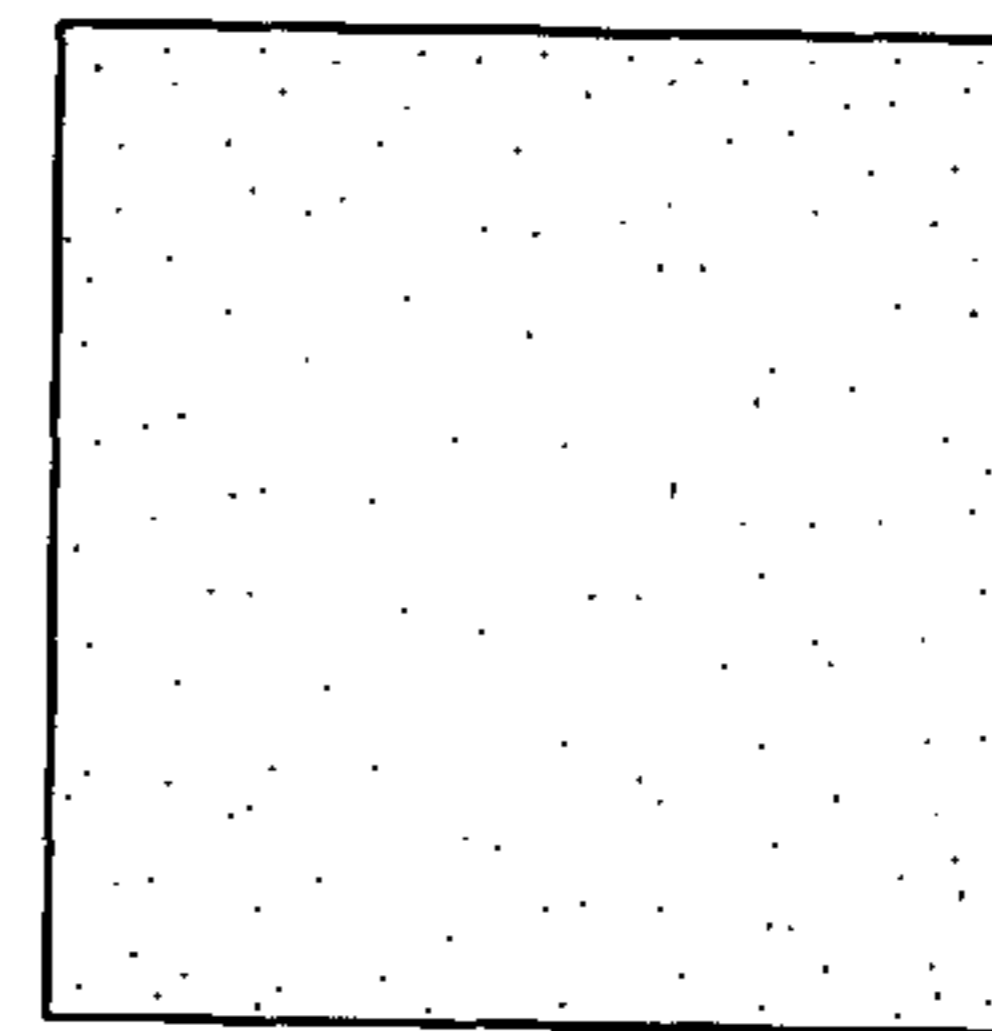
